## HARRIMAN TALKS WITH ISRAEL TO BE CONTINUED IN WASHINGTON, STATE DEPT. SAYS

WASHINGTON, March 3. (JTA) -- The talks opened in Israel by special envoy W. Averell Harriman with Israeli leaders will be continued through normal diplomatic channels, a State Department spokesman said today. He declined to comment on the issue of American supply of arms to Israel.

State Department spokesman Robert McCloskey confirmed that U.S. negotiations with Jordan were under way to supply that country with arms, but said that discussions were still "classified." They will remain classified until "we are in a position to make announcements," he declared.

The Department spokesman cited last weeks statement by Secretary of State Dean Rusk as the prevailing American policy on Israel's arms supply situation. Mr. Rusk then said the United States favored a regional balance of power but felt the United States should avoid direct involvement, and that Israel's arms should come from its past sources in Western Europe.

## ESHKOL WARNS JORDAN ON SABOTAGE BY INFILTRATORS; TALKS IN PARLIAMENT

JERUSALEM, March 3. (JTA) -- Prime Minister Levi Eshkol warned Jordan today against permitting any further sabotage infiltrations against Israel, originating in Jordanian territory. Three such attacks or attempts at sabotage have taken place in the last months by gangs of saboteurs who escaped across the border, back into Jordan. In the last attack, early Sunday morning, at Kfar Hess, an Israeli patrol wounded and caught one of the perpetrators.

Mr. Eshkol voiced his warning to Jordan in replying to a motion introduced in the Knesset, Parliament, by Herut, charging the Government with "inaction" in the face of sabotage attacks. "Surely, Israel would not tolerate such developments, "replied the Premier. He proposed that the issue be referred to the Knesset's Foreign Affairs and Security Committee, and Herut agreed to such a procedure.

Meanwhile, the United Nations Supervision Organization today completed its investigation into the Kfar Hess incident, Israel has charged that Jordan has refused to let the U.N. military observers use Jordanian tracking dogs which the U.N. wanted to employ for tracing the footprints of the Kfar Hess saboteurs. Those prints led directly from Kfar Hess to the nearby Jordanian border.

## ISRAELI JETS BATTLE EGYPTIAN FIGHTER PLANES; ALL CRAFTS RETURN SA FELY

TEL AVIV. March 3. (ITA) -- Israeli Mirage fighter jets today drove off a group of Egyptian Migs which penetrated Israeli airspace over in the Nitrama area in the Negev, the Army spokesman announced today. The air clash developes, the spokesman spokesman spokes are to the Egyptian planes, when it was learned that the latter entered Israeli airspace.

The Egyptian planes returned to their own territory after the Israeli jets fired a number of shots. All the Israeli planes returned safely to their base:

In an incident along the Syrian border, the second in two days at the same spot, Syrian gun positions attacked an Israeli tractor working at Korazim north of Lake Tiberias, damaging the venicle slightly. The fire, which was directed from three Syrian positions utilizing recoilless guns and automatic weapons, was silenced by return fire from the Israeli side before United Nations observers arranged a cease fire.

Today's exchange of fire began only a short time after the U.N. observers concluded their investigation of a similar attack yesterday in which the Syrian positions continued firing at an Israeli tractor in the same area for several hours until a cease fire was arranged. The Israelis returned the fire after the Syrian positions intensified their attack and two Syrian posts used machine guns. There were no casualties on the Israeli side.

## ISRAELI VESSEL BLACKLISTED BY U.S. FOR CALLING AT A PORT IN CUBA

WASHINGTON, March 3. (JTA) -- The Maritime Administration of the U.S. Commerce Department today announced the blacklisting by the United States of the Israeli vessel, "Daniela," because the ship called at a cuban port. The "Daniela," listed as a small vessel of 908 tons, called at a Cuban port early this year.

# ISRAEL TO HOLD MILITARY PARADE IN TEL AVIV; CANCELS JERUSALEM PLAN

JERUSALEM, March 3. (JTA) -- Israel's annual Independence Day military parade will be held in Tel Aviv this year, it was announced here today. Independence Day this year will be celebrated on May 6. The progress of Israel's army will be demonstrated through the parade.

Since this year will mark also the 20th anniversary of the end of World War II, the parade will also recall the contributions of the prewar and wartime Jewish settlements in Palestine to the Allied victory in the war against the Nazis and Fascists. Special emphasis will be laid on the aid to victory given by the Jewish units in the Allied forces, including the Jewish Brigade.

A motion for a debate in the Knesset, Parliament, of the Government's "cancelation of plans to hold the parade in Jerusalem" was filed today by the opposition Herut Party, At the same time, a Foreign Ministry spokesman termed "completely groundless" a report that there has been American pressure on Israel in this matter. (Jordan complained to the United Nations Security Council yesterday that an Israeli military parade in Jerusalem would be a violation of the armistice agreement between Jordan and Israel.)

An editorial today in Maariv, leading evening newspaper in Israel, protested against the Government's decision to shift the parade from Jorusalem to Tel Aviv. The newspaper said that the reasons given for the change wore 'unconvincing.' Those reasons, according to Maariv, were that a parade in Jerusalem would restrict the army's plans to exhibit certain heavy weapons, including the new, U.S. made, ground-to-air Hawk missiles. Deploring the Government's action, Maariv called it "a retreat,"

## ISRAEL'S EXPORT THIS YEAR TO REACH \$700,000,000, MINISTER REPORTS

JERUSALEM, March 3. (JTA) -- Israel's industrial exports in1965 will reach a total value of \$350,000,000, as compared with exports worth \$305,000,000 in 1964, Finance Minister Pinhas Sapir reported to the Knesset, Israel's Parliament, here today. Israel's total exports this year, he said, will reach a value of \$700,000,000.

Mr. Sapir made these predictions as he presented his ministry's budget for the next fiscal year, totaling 26,000,000 pounds (\$8,667,000). He told the Knesset also that the next five years will witness expansion of mechanization and automation in industrial enterprises in this country.

#### HISTADRUT ADOPTS BUDGET OF 50,000,000 ISRAELI POUNDS FOR FISCAL YEAR

TEL AVIV, March 3. (JTA) -- The executive of Histadrut, the Israeli federation of labor, today voted a budget of 50,000,000 pounds (\$16,667,000) for the next fiscal year. The sum was set after a six-hour debate that followed the annual report by Histadrut's treasurer, Y. Levi.

Representatives of the Mapai, Ahdut Avoda and the Religious workers' factions voted in favor of the budget, while Mapam and Liberal delegates abstained. The budget envisages the receipt of 6,500,000 pounds (\$2,167,000) from Histadrut campaigns abroad.

#### JAPANESE ELECTRIC CORPORATION IN U. S. DENIES YIELDING TO ARAB THREATS

NEW YORK, March 3., (JTA) -- The Mctsushita Electric Corporation today declared that under no circum stances would it permit any of its 40 companies to yield to the threats or pressures of the Arab boycott office. The announcement came in answer to a published report that the multi-million dollar Japanese complex had refused to engage in trade relations with Israel.

In a letter to the Anti-Defamation League of B'nai B'rith, K. Isomira, president of the Matsushita Corporation of America, said company policy is to "seil to anyone, anywhere in the world, regardless of any individual country's boycotting policies." This policy, he asserted, applies to each of Matsushita's 40 separate divisions. Furthermore, Mr. Isomura went on to say, Matsushita "will be pleased to negotiate directly with representatives of Israeli purchasers," He attributed the boycott report to "misunderstandings which arise from language barriers,

In regard to one special charge, that Matsushita had refused to sell its disawashers, he explained, they are not being experted to any country as yet, they are manufacturered only for domestic sale in Japan.

#### ATTORNEY GENERAL TESTIFIES IN FAVOR OF RELAXATION OF IMMIGRATION

WASHINGTON, March 3, [JTA) -- Attorney General Nicholas Katzenbach today testified before a House Judiciary Subcommittee that the Administration's immigration bill deserved support because of its "elemental humanity" and the good it would do America at home and abread.

#### JEWISH GROUPS AGREE ON UNIFIED APPROACH TO SOVIET PREMIER IN LONDON

LONDON, March 3. (JTA) -- The Board of Deputies of British Jews has agreed with the Anglo-Jewish Association on the plan to convene a conference of all Jewish organizations in this country to attempt to work out a unified Jewish approach to Soviet Premier Alexei N. Kosygin, during the latter's forthcoming visit to Britain, it was announced here today by Maurice Edclman, president of the A. J. A. The purpose of the unified approach would be to discuss with Mr. Kosygin the situation of Jews in the USSR.

Mr. Edelman expressed the hope that the conference of Jewish organizations on this subject would "prove fruitful" and that "in unity we can make constructive contributions to serve the cause of our distressed Soviet brethren,"

Addressing a regular meeting of the Association's Council, Mr. Edelman also said that latest reports from West Germany indicate that the Bonn Government would "very likely decide after all to prolong the statute of limitations" for prosecution of war criminals after the expiration of the present May 8 cut-off date.

#### EXTENTION OF STATUTE OF LIMITATIONS BY BONN PARLIAMENT HELD CERTAIN

BONN, March 3. (JTA) -- There was no longer any doubt here today among political observers that Parliament will extend the statute of limitations for prosecution of war criminals when it takes up the issue, as scheduled, in the Bundestag, the lower house, on March 10, and in the Bundesrat, the upper house, two days later.

That prediction was being made here freely today following issuance of the full report made on the issue to the Cabinet last week by Minister of Justice Ewald Bucher. Dr; Bucher himself, the report showed, has not yet abandoned his opposition to extension of the statute beyond the present cut-off date of May 8. But he had told the Cabinet that "even with further prosecution of Nazi crimes, a complete uncovering of all misdeeds and punishment exactly befitting the personal responsibility of the perpetrators cannot be guaranteed."

Emphasizing the proportion of Nazi war crimes already completely "dealt with" in tWest Germany, Dr. Bucher predicted that, if the cut-off date is lifted, "as time went on, the likelihood of acquittals and unsatisfactory verdicts would grow." He stressed his contention that West German efforts to bring a number of major Nazi war criminals to trial "have been frustrated by other countries."

Among the major criminals "protected" by other countries, he listed Dr. Josef Mengele, receiving refuge in South America; Dr. Hans Eiselde, the infamous Dachau camp physician, who enjoys asylum in Egypt; the Auschwitz "medical experiments" practitioner, Dr. Schumann, nowin Ghana; and others who have found havens in Italy, Chile and elsewhere.

#### CANADIAN GOVT, CHARGED WITH 'PUSSY FOOTING' ON OUTLAWING HATE PROPAGANDA

TORONTO, March 3. (JTA) -- Former Prime Minister John G. Diefenbaker today castigated the present Government, led by Premier Lester B. Pearson, for what he called "pussylooting" on the issue of enacting federal legislation to outlaw the dissemination of anti-Semitic and other hate propaganda. If the Government took the initiative toward outlawing such "massacres of the soul, "he said, the opposition would support such a move. He made the statements in an address at Congregation Bet Emeth-Beis Yehuda here.

At the same time, Dr. Daniel G. Hill, director of the Ontario Human Rights Commission, appeared before the House of Commons External Affairs Committee, and urged the federal government to convene a Dominion-wide conference to discuss means for combating hate propaganda directed against Jews and Negroes in this country.

Hate propaganda is being distributed on city property by a city employee, Lyman Gifford, the mayor of Oshawa, said today at a press conference. Oshawa is a small industrial city 30 miles from Toronto. The mayor said he has written Ganada's Justice Minister Guy Favreau naming the person he believes responsible for distributing an anti-Semitic pamphlet. "I am quite sure that he is an employee of this city," the mayor told reporters. The leaflets bore an imprint originating in Birmingham, Alabama.

#### ITALIAN JEW PROPOSES SUBSCRIPTION DRIVE FOR A MONUMENT FOR POPE PIUS XII

ROME, March 3. (JTA) -- The Rome daily, Il Tempo, accepted today a proposal from an unnamed Italian Jew and began a subscription campaign for a monument in memory of the late Pope Pius XII.

The anonymous Jew, in making the proposal in a letter to the newspaper, said he was one of "many Jews" who were saved by the late Pontiff. The role of Pius XII during the Nazi period has become an object of debate because of a widely performed play, "The Deputy," by a West German playwright, Rolf Hochhut. # PRESIDENT OF DOMINICAN REPUBLIC MEETS WITH EBAN; ASKS FOR ISRAEL'S AID

SANTO DOMINGO, Dominican Republic, March 3. (JTA) -- Assurances that the Dominican Republic's traditional friendship with Israel would continue in the future, and that the Government of the republic would continue to cooperate with Israel at the United Nations, were voiced here today by the President and Foreign Minister of this country when they conferred with Israel's Deputy Prime Mirister Abba Eban,

Mr. Eban, here on a four-day state visit, was given these assurances at a conference at the Presidential palace with President Donald Peid Cabral and Foreign Minister Ramon Caceres Troncoso. The Dominican leaders also asked that Israel continue its technical assistance to the country's development program.

After a luncheon in honor of Mr. and Mrs. Eban by Israel's Ambassador Benjamin Varon, attended by the President, the Foreign Minister and other high government officials, a state dinner reception was held in the national palace for Mr. and Mrs. Eban. More than 1,000 guests attended that event.

# U.S. IMMIGRATION OFFICE DROPS DEPORTATION PROCEEDINGS AGAINST ISRAELI

NEW YORK, March 3. (JTA) -- The United States Immigration and Naturalization Service has dropped its deportation proceedings against Haim Menachem Frenkel, the 25-year-old Israeli who was arrested Last November on charges of working in violation of his student visa.

The arrest followed an anonymous telephone tip to the Service that he had dropped out of school and was working, after it became known that he was planning to marry a non-Jewish girl. His mother had come here from Israel in a vain effort to dissuade him from the marriage. Frenkel and the girl, Dianne Brandon, from England, were married after the Israeli was released from jail. four days after his arrest when a New Jersey manufacturer posted a \$1,000 bond, They were married by a rabbi and Miss Brandon pledged that she would embrace Judaism and raise any children in the Jewish faith.

The Naturalization Service announced yesterday that it was adjusting Frenkel's status to the British quota as the husband of a British subject and opening the way for him to become an American citizen.

# ACTION AGAINST INTERMARRIAGE PROPOSED AT CHICAGO ORTHODOX CONFERENCE

CHICAGO, March 3. (JTA) -- Such drastic action as public condemnation of Jews who marry outside the faith was proposed at a Orthodox-sponsored conference as a means of deterring such intermarriages.

The proposal was offered at the 12th annual conference of the Council of Traditional Synagogues of Greater Chicago. Rabbi Moses Mescheloff said one form the condemnation could take would be refuse to "extend facilities of the synagogue or its membership for death, marriage and other occasions" in the lives of intermarried couples. He compared the proposal with Bar and Bas Mitzvah which "are helping to save our children for Judaism" and recital of the Kaddish which "has brought many men back to the synagogues."

Members of a panel on "Assimilation through Marriage" agreed that intensive Jewish education was necessary to prevent such intermarriage. Rabbi C. David Regensberg, presiding judge of the Rabbinical Court of the Chicago Rabbinical Council proposed that the sum of \$1,000,000 be raised in Chicago for Jewish education on all levels.

# SWEDISH KING REAPPOINTS BLAUSTEIN TO HAMMARSKJOLD FOUNDATION BOARD

NEW YORK, March 3. (JTA) -- The reappointment of three Americans for a second term of three years to the Board of Trustees of the Dag Hammarskjold International Foundation was announced in Stockholm today at a Trustees' meeting.

King Gustav Adolf designated Jacob Blaustein, of Baltimore, and Andrew W. Gordiand Ernest A. Gross, of New York, among fourteen Trustees appointed to manage the Dag Hammarskjold International Foundation, established in September 1961.

# RABBI MARSHALL MILLER, LEADING KANSAS CITY SPIRITUAL LEADER, DEAD

KANSAS CITY, M.o., March 3. (ITA) - Funeral services were held here for Rabbi Marshall Miller, spiritual leader of Congregation Ohev Sholom and former president of the Rabbinical Association of Greater Kansas, who died here at the age of 52,

Born in Chicago and a resident of Kansas City for nearly three decades, Rabbi Miller had also served as president of the local Jewish National Fund Council and was active in the B'nai B'rith. He was a brother of Rabbi Uri Miller, president of the Synagogue Council of America.
