### HOUSE TOLD OF DANGER FOR ISRAEL TO BE ATTACKED BY EGYPT SOON

WASHINGTON, Aug. 10; (JTA) -- Rep. James Roosevelt, California Democrat, today warned in a House speech that while America is preoccupied with Viet Nam, the Arab-Israel conflict is escalating with a growing danger that Egypt may launch war against Israel to divert attention from Egyptian economic difficulties and to rally the Arabs behind Nasser's waning leadership.

Rep. Roosevelt, a son of President Franklin D; Roosevelt, charged that the main reason there is no Arab-Israel peace after I7 years of friction is that "we have never been willing to commit our influence and prestige completely to challenge the warlike declarations of the Arab leaders and the plans which they continue to make to put these declarations into effect;" He cited renewed threats by Egyptian President Nasser to destroy Israel while the Administration authorizes and contemplates new aid programs benefiting Egypt;

"We have failed to use our influence to produce a settlement," he said, "We have condoned violations by the Arabs of the United Nations Charter;" Such failures, he charged, encouraged Arab violence and could lead to "new disaster;" He stressed that "appeasement of Nasser does not gain Arab friendship but only loses Arab respect;"

#### Data Cited on Soviet Shipments of Modern Arms to Egypt

Giving the House facts of continued heavy shipments of ultra-modern Soviet arms to Egypt, Rep. Roosevelt said that Egypt now has Soviet T-10 tanks, more powerful than any Israeli armored vehicles. He gave statistics showing that Egypt has more than twice as many and superior tanks to the Israeli armored force.

Rep. Roosevelt also stressed the danger of new Soviet jet fighters more advanced than the MIG-21 now delivered to Egypt; He told of Egyptian acquisition of Soviet air-to air missiles, comparable to the American "sidewinder" missile; He said Egyptian Atollequipped MIG's are nearly impossible to knock out with conventional fighters;

He stressed that Egypt has ground-to-ground missiles designed to blast Israel while Israel has no comparable weapons. He referred to reports of a so-called "Operation Cleopatra" to develop Hiroshima-type atomic bombs and "Operation Ibis" to develop radicactive rubbish devices to devastate areas of Israel.

## Termination of U.S. Aid to Egypt Demanded by Two Congressmen

He charged that the Administration has ignored the mounting Egyptian preparations and given aid despite the obvious preparations for war costing Egypt this year \$508,200,000,equal to the entire Egyptian budget of 1952. He demanded termination of U.S. aid to Egypt until she limits her military preparations. At the same time he nagged the bolstering of Israel's arsenal by selling arms to Israel "sta discount price, if necessary;" He also suggested impressing the Arabs with the proximity and power of the U.S. Sixth Fleet;

Rep. Seymour Halpern, New York Republican, similarly urged today in a House speech that the United States should cease consideration of further aid to Egypt until that country ceases its neavy acquisitions of Soviet arms, aggressive preparations, and intervention in the affairs of neighboring states;

#### ANTI-GERMAN DEMONSTRATIONS HELD THROUGHOUT ISRAEL; ARRESTS MADE

TEL AVIV, Aug. 10; (17A) -- An open-air rally against Israel's diplomatic relations with West Germany was attended last night by several thousand demonstrators at Dizengoff Square in Tel Aviv. A number of arrests took place:

In other parts in Israel, police also arrested demonstrators. In Ramat Gan, police arrested and later released on bail 15 members of Hasnomer Hatzair on suspicion of defacing public property. Six others were arrested in Haifa for demonstrations and for distributing leaflets against Dr. Rolf Pauls, West German Ambassador, due to arrive here this week. The yellow Star of David, with the letter "J" in the center, replicas of

the emblem the Nazis forced their Jewish captives to wear, was painted on streets and highways in Ramat Gan, Beersheta, Tiberias, Acre and western Galilee. Slogans protesting against the West German envoy were painted in Tiberias;

The rally in Tel Aviv, organized by the leftist Mapam Party, called on "Wenrmacht Officer Pauls" to "go home." Other sponsors were the Organization of Former Partisans; Hashomair Hatzair, the left-wing youth movement; the Mahnot Olim Youth Movement; and a number of members of Kibbutz Meuhad collectives.

There were no speeches in the brief program. Actress Batya Lanoet read a poem, "The Vow," by Avraham Shlonsky, proclaiming "We will not foret until the tenth generation" the Nazi genocide of European Jewry. The Song of the Partisans was played, and the demonstrators stood in silence for two minutes; The rally closed with the singing of Hatisvan.

The Israel Government meanwhile announced today that the Israel Embassy in West Germany will be situated in the Bonn suburb of Bad Godesberg. The intended Embassy building there is still under construction; The Israel Embassy offices will be housed temporarily at Cologne, where the consular staff end the economic division will be located; Israel Ambassdor-Designate Asner Ben-Nathan was expected to leave for West Germany at the end of this week;

#### ISRAEL PLEADS FOR MORE INTERNATIONAL AID TO UNDERDEVELOPED COUNTRIES

JERUSALEM, Aug. 10; (JTA) -- Prime Minister Levi Eshkol and David Horowitz, Governor of the Bank of Israel and author of a project being studied officially now by the United Nations to aid underdeveloped countries, called upon the world's affluent nations last night to aid the "have-nots" in the spirit of a rich individual helping his poorer neighor; They were the principal speakers at the third "Rehovcth Corference" being held at the Hebrew University for discussion of fiscal problems facing the developing countries of the world,

Forty-four countries are represented at the conference. The parley is the third of a series started several years ago at the Weizmann Institute of Science at Renovoth, but is being held here this time with the cos-sponsorship of the Hebrew University and the Bank of Israel. The representatives include 25 Cabinet ministers from 38 developing countries. Deputy Prime Minister Abba Eban, who originated the conference at Renovoth as president of the Weizmann Institute, is chairman of the world meeting, which is approved, among others, by the United Nations.

Mr. Horowitz spelled out the type of international aid by the wealthy nations for which Mr. Eshkol called; His "Horowitz Plan," proposed a year ago before the United Nations Economic and Social Council, has since been under study of the International Bank for Reconstruction and Development;

Under the "Horowitz Plan," which the Bank of Igrael chief reiterated here, the wealthier nations of the world would set aside between 1 percent and 2 percent of their gross national product, each year, to provide capital for the underdeveloped states. He noted that the gross transfer of capital to the underdeveloped nations, which had been expected to increase, has, instead, declined, Under his plan, he explained, the developing states would be certain of getting sufficient capital to trigger large-scale, domestic projects for the improvement of education and general standards of life.

Israel's initiative for aid to the developing countries was hailed in addresses at last night's session by Antoine Meatchi, vice-president of Togo, speaking on behalf of the 14 African countries that are members of the French Union; Finance Minister R.G. Kind, of Sierra Leone, who spoke on behalf of the English-speaking countries in Africa; and Cudong Souvanna, Governor of the Lactian National Bank, as representative of the under-developed nations of Asia, Dr. Eliahu Elath, president of the Hebrew University, and Prof. S. Lifson, of the Weizmann Institute, officially welcomed the delegates;

# COLLABORATION OF GERMAN JUDGES WITH NAZIS AGAINST JEWS CITED IN COURT

BONN, Aug. 10; (JTA) -- The defense attorney for a former SS officer on trial in Dusseldorf for the murder of hundreds of thousands of Jews in the Treblinka concentration camp during the war charged today that "countless German judges and prosecutors" now serving in the West German judiciary had collaborated with the Nazis in the crimes against the Jews;

The attorney, Hans Joachim Gohring, was pleading for acquittal of his client, Kurt Franz, formerly the deputy commandant of Treblinka. Pointing out to the court that Franz had had only a meager education, while judges and lawyers were highly-educated men, he said that many of these judicial officers, in the system now, had "cooperated closely with the Gestapo and the other Third Reich organizations for the crimes committed during those years,"
