U.N. CHIEF FINDS SYRIA ADAMANT; REPORTS TO ISRAEL ON HIS EFFORTS

JERUSALEM, Aug. 22. (JTA) -- With both sides armed to the hilt, each on its own side of the common frontier, Eyria and Israel continued today to face each other midst grave tensions along Lake Tiberias. The lake is entirely in Israel's jurisdiction, but Syria insists on probing its waters for recovery of a Syrian jet fighter and a Syrian pilot, both shot down by Israel last week.

Syria's continued insistence that it must be allowed to try to salvage its MIG-17 and to bring up the body of the pilot of that ship -- which Israel brought down into the lake -- was relayed to Israel's Foreign Ministry this morning by Lt. Gen. Odd Bull, chief of staff of the United Nations Truce Supervision Organization.

Gen. Bull had just returned today from a conference in Damascus with the chief of staff of Syria's army, and with other Syrian officials. Fe reported that they are adamant in their insistence that they have a "right" to try to salvage their own plane and pilot from the bottom of the lake. Failing to obtain from Israel recognition of that "right," Gen. Bull reported, Syria insists it will not allow Israel to salvage its Coast Guard cutter, stuck on a reef about 200 yards from the lake shore nearest to Syrian territory.

Israel Asks U.N. General to Continue His Talks with Syria

While asking Gen. Bull to continue his negotiations with Syria, Israel made it clear today that it will deny to Syria any rights whatever regarding sovereignty over Lake Tiberias. Israel pointed out once more that under a treaty between France and Britain following World War I, the entire lake was placed in Falestine under British jurisdiction. To make sure that there would be no disagreement about British jurisdiction over the entire lake, France and Britain had agreed that, near the northeastern corner of the lake, a narrow strip of land, between 35 and 40 yards in depth, would be demarcated on the Falestinian side of the border with Syria.

Israel insists now, as it always has, that Lake Tiberias is entirely within its sovereignty as it is the inheritor of the Franco-British agreement, which had been superseded by the Syrian-Israeli armistice pact of 1949.

Israel fears that, if it should permit Syria to try to salvage its own plane in the lake, a precedent would be established, under which Syria would, in the future, claim other rights in the lake. On the other hand, Israel reassured Gen. Bull again today that it is willing to turn back to the Syrians both their sunken MIG-17 and the body of their drowned pilot, after these are brought up by Israel,

Israel Advised by U.N. Not to Salvage Its Stranded Cutter

Meanwhile, Israel's Coast Guard cutter is still stranded on a sandbar, and Israel is not trying to put it back into service at the request of the United Nations, which fears a flare-up of Syrian-Israeli fighting.

Syria has installed big searchlights near its side of the Tiberias border, lighting the area by night to make sure Israel is not doing any salvage work. There are heavy concentrations of Syrian guns, tanks and infantry on the border near the lake, and Syrian planes are patroling the air on the Syrian side of the border. The same preparations, of a defensive character, are evident on Israel's side.

Israel is also on the alert against possible renewal of terrorist raids by members of the El Fatah organization which is directed from Syrian bases but which may attempt to infiltrate into Israel from nearby Jordan or Lebanon. The opinion prevailing in Israel is that the recent Syrian threats of warfare cannot be implemented by Syria by open attacks on Israeli territory, but only by guerrilla methods against which Israel is determined to retaliate as indicated yesterday by Prime Minister Levi Eshkol, following a session of the cabinet.

(In Washington, State Department officials said today that the United States is closely observing developments on the tense Israeli-Syrian frontier, and that the United States Government feels both sides should cooperate with the United Nations Truce Supervision Organization.)

BEN-GURION'S PARTY ANNOUNCES IT WILL NOT RETURN TO MAPAI RANKS

TEL AVIV, Aug. 22. (JTA) -- David Ben Gurion's new political grouping, Rafi, "has not intention of returning to Mapai, because there is no Mapai to return to, " Shimon Peres, secretary-general of the new party, declared here last night,

Mr. Peres, former Deputy Minister of Defense and Mr. Ben-Gurion's chief aide in the formation of the group, which had broken away from the Mapai Party, made that statement at a meeting of the Rafi central committee here. He said, however, that Rafi will not ban any "private" efforts to bring about a rapprochement with Mapai.

At the meeting last night, the Rafi central committee decided to elect a secretariat, to consist of 31 members. Of the 31, the leaders decided, the central committee would appoint 19, while the rest would be named by Rafi's regional branches. Mr. Peres had been elected secretary-general last May.

TWO FCREIGN STUDENTS HELD IN SYRIA FOR ILLEGAL CROSSING FROM ISRAEL

TEL AVIV, Aug. 22. (JTA) -- Two young foreign students who disappeared from their kibbutz near the Syrian border more than a week ago are being held by Syria for illegal crossing of the frontier, a United Nations observer reported today to the Syrian-Israeli Mixed Armistice Commission.

The students are Jeanette Archer, 19, of England, and Jules Hirschner, 21, of France. Members of their kibbutz, Shamir, reported them missing after they had started out on an afternoon walk in the direction of the adjacent Syrian border. They are believed to have wandered across the border without realizing they had gone outside Israel's frontier.

GERMAN TRADE UNION CONGRESS DEMANDS LAW BANNING HATE PROPAGANDA

BONN, Aug. 22. (JTA) -- The executive of the 6, 000, 000-member German Trades Union Congress sent a demand to the West German Government for action to implement a resolution approved by the Congress calling for a federal law to ban race hatred propaganda, it was disclosed today.

A letter to Chancellor Ludwig Erhard and leaders of the three Parliamentary parties from the labor organization pointed out that while Article 26 of the West German constitution forbids all activities which could disturb peaceful co-existence among the West German people, there was no precise law on the problem.

GHANA COURT TO DECIDE TODAY ON EXTRADITION OF AUSCHWITZ PHYSICIAN

BONN, Aug. 22. (JTA) -- Dr. Horst Schumann, the Auschwitz concentration camp physician for whose extradition West Germany is fighting at Accra, Ghana, is claiming that he is not subject to extradition because he is charged with a "political" violation instead of with a criminal act, according to a report received here today from a Ghanaian capital.

Dr. Schumann is being defended by a Ghanaian attorney, Harold Darko. The German Government's demand for extradition is being argued in the court at Accra by Josef Fabry, representing the State Prosecutor here. The extradition hearing for the former Auschwitz physician is scheduled to come to an end in the court at Accra tomorrow, when a decision is expected to be issued,

MAZI CHARGED WITH KILLING JEWS DISAPPEARS ON EVE OF TRIAL; SKIPS BAIL

BONN, Aug. 22. (JTA) -- Herbert Weyernd, a former SS officer charged with participation in the mass murder of Jews during World War II, has apparently skipped bail, and has disappeared on the eve of his trial, scheduled to have been held this week in Wuppertal, it was announced here today.

Weyernd has been free in \$2,000 bail, awaiting trial. It was pointed out here in juridical circles that, under German court practice, the ordinary suspect in the murder of a single victim would be refused any bail whatever, and certainly would not have been freed in bail as low as \$8,000 marks (\$2,000). German police authorities who announced the man's disappearance today said they were now instituting a search for the accused mass murderer.

DR. JAKOBOVITS, NEW YORK RABBI, ACCEPTS POST OF CHIEF RABBI OF BRITAIN

NEW YCRK, Aug. 22. (ITA) -- Dr. Immanuel Jakobovits, spiritual leader of the Fifth Avenue Synagogue, confirmed today to the Jewish Telegraphic Agency that while in London recently he accepted "in principle" the nomination as Chief Rabbi of the British Commonwealth. His nomination will be ratified on September 11, when 250 representatives of synagogues and organizations meet in London.

COVENTRY POLICE SEEK TO CHECK RASH OF NAZI AND ANTI-SEMITIC SLOGANS

COVENTRY, England, Aug. 22. (JTA) -- Police here today intensified their watch over Coventry Cathedral and over other public buildings, due to a rash of painted swastikas and anti-Semitic slogans that has broken out here, including desecration of the cathedral itself.

The walls and pillars of the cathedral were discovered last night to have been painted with large swastikas and slogans of a Nazi character. One three-foot high slogan proclaimed "End Jewish Control." Another demanded "Release Hess," and a third slogan was worded "Support Rhodesia." The Hess call related to Rudolf Hess, Hitler's close confidant, who flew to England in 1941 presumably to seek peace. He is serving a life sentence in Spandau Prison. in West Berlin.

Under the various daubings, including a swastika on the wall of the Police Training Center here, were the initials "N.S.M.," believed to stand for National Socialist Movement. Assistant Chief of Police Stanley Porter said today that "our inquiries will certainly be stepped up to find those responsible for the serious and dastardly defacement of the cathedral."

RIOTING IN MINNEAPOLIS STIMULATES MOVING OF JEWISH INSTITUTIONS

MINNEAPOLIS, Aug. 22. (JTA) -- Recent rioting on Plymouth Avenue, a section of the city once predominantly Jewish and now housing mostly Negro residents and Jewishowned stores, is bringing about moves of Jewish institutions and Jewishowned businesses from that area, it was noted here today.

The American Jewish World, the Jewish weekly published here, reported that two congregations in the city are planning to move to the suburbs. They are Beth I Congregation and Mikro Kodesh Congregation. In addition, it was learned that previous but vague plans for moving the Talmud Torah to the suburbs have been accelerated. Some parents of children attending the Talmud Torah have notified officials of the institution that they will no longer send their children to that Jewish school.

One important business establishment in the riotous area, an appliance store conducted by Ben Koval, has already moved out of the area. Mr. Koval reported that during the height of the rioting, 40 television sets were stolen from his store. He said that, due to previous thefts and smashing of windows, insurance has been canceled and "I have to absorb the entire loss myself,"

According to the American Jewish World, many stores in the area now display "for sale" signs, and owners are planning to move. In an editorial, the weekly called attention to the fact that, while everything possible is being done to aid the residents of the area, nothing is being done to help the victimized businessmen, nearly all of them Jewish.

TWO ACTIVE MEMBERS OF ANTI-SEMITIC GROUPS ARRESTED IN CHICAGO

CHICAGO, Aug. 22. (JTA) -- Two agitators belonging to racist and anti-semitic organizations were arrested here yesterday when they sought to hold rallies without police permits in an effort to exploit the growing racial tension in this city. George Lincoln Rockwell, leader of the American Nazi Party, was, however, granted a permit and spoke to a crowd of almost 1,000 persons for 40 minutes. He urged the organization of "white guard" to resist integration, and charged that "Jewish money" was financing Negro civil rights demonstrations.

Those arrested in Marquette Park, in the southwestern section of the city, were the Rev. Charles Lynch of the anti-Semitic and anti-Negro National States Rights Party; and Evan Lewis of Akron, Chio, who appeared in the white robe of the Ku Klux Klan. The Rockwell rally and the arrests took place at the same time as the civil rights leader, the Rev. Dr. Martin Luther King, Jr., was leading 500 Negroes in a protest march through all-white neighborhoods in other parts of the city. Dr. King and his followers were jeered by white youths, many of whom displayed swastikas.

SON OF GERMANY'S AMBASSADOR TO ISRAEL WORKS IN BEN-GURION'S KIBBUTZ

TEL AVIV, Aug. 22. (JTA) -- Christian Pauls, 22-year-old son of West Germany's first Ambassador to Israel, was disclosed today to be spending his summer vacation working at the 5de Boker kibbut, ct which former Premier David Ben-Gurion is a member.

The youth, a student at Freiburg University, spent two years in the West German army on compulsory duty and then volunteered for work in a kibbutz. His stay was arranged between Dr. Rolf Pauls, the envoy, and Mr. Ben-Gurion. The youth has said he was happy in his stay and that he had not encountered any animosity because he is a German.

FLORIDA GROUP CANCELS PLANS TO HOLD FUNCTION AT RESTRICTED CLUB

WASHINGTON, Aug. 22. (JTA) -- The Jewish War Veterans said today it had persaded the Orange Bowl committee to drop plans to hold its Orange Bowl tennis ball at a restricted Miami Beach Club.

Milton A. Waldor, JWV commander, said that the Crange Bowl committee changed its plans to hold the event in the Bath Club after the JWV Florida department lead an interfaith, inter-racial campaign against the proposal in Miami Beach. The effort was led by Florida JWV commander Irving Cooperman and past national commander Daniel Miller.

"It is indeed unfortunate," Mr. Waldor said, "that the Orange Bowl committee, which represents an important civic function in the state of Florida, involving people of all races, creeds and religions, and supported by public funds, saw fit to blemish such an undertaking by exposing it to a manifestation of bigotry." Fe complimented the committee, however, for agreeing to change the site for the December 17th function.

SPEAKERS OF PARLIAMENTS IN MANY COUNTRIES TO ATTEND KNESSET CEREMONY

JERUSALEM, Aug. 22. (JTA) -- Speakers and deputy speakers of Parliaments in 41 countries have already expressed readiness to attend the official opening of the new building of Israel's Parliament on August 30 and more confirmatory replies are expected, Moshe Rosetti, clerk of the Knesset reported today.

He also reported that representatives of Jewish communities, Zionist organizations and international Jewish groups also were planning to attend. The Parliamentary speakers who have accepted invitations include most American and West European countries, as well as some in Africa and in three Asian states, he said. No East European Parliament has as yet replied. The new building will be officially transferred from the public works department to the Knesset Speaker next Monday.

WORKS OF HEBREW POET BIALIK APPEAR IN ISRAEL IN ARABIC TRANSLATION

TEL AVIV, Aug. 22. (JTA) -- The first Arabic translations of several major works by the late Febrew poet Haim Nachman Bialik were published here today as the first step in a translation program that will make major Jewish works available to Israel's Arab citizens.

The Bialik translations are the work of Rashid Eussein, a prominent Israeli-Arab poet and journalist who undertook the assignment for the Febrew University's Institute of Asian and African Studies, sponsors of the translation project. The volume published today contains over 20 of Bialik's best known poems, several legends and extracts from the poet's autobiographical writings.

Themes emphasizing the poet's personal experiences, and his views on the national revival of the Jewish people were chosen for translation as it was felt that these subjects would afford the Arab reader an insight into the Zionist movement.

PAN-AMERICAN MACCABIAD CPENS TODAY WITH 700 ATHLETES FROM 13 LANDS

SAC PAULO, Brazil, Aug. 22. (JTA) -- Seven hundred athletes and sports organization delegates from 13 American countries, including the United States are expected to participate here in the Pan-American Maccabiad which will open tomorrow and last until next Sunday.

(In New York, Faskell Cohen, president of the United States Committee of Sports for Israei, announced today that 34 athletes will comprise the American team which will participate in the Pan-American Waccablad at Sao Paulo. The U.S. participates, he said, will include 23 basketball players, two tennis players, six swimmers, a diver and two judo players.)

DR. KALISKI DIES IN NEW YCRK; WAS GOVERNOR OF HEBREW UNIVERSITY

NEW YORK, Aug. 22. (JTA) -- Funeral services for Dr. David John Kaliski, former chief of the genito-urinary clinic and associate surgeon at Mount Sinai Hospital, will be held here tomorrow. Dr. Kaliski died Saturday at the age of 82.

Born in New York, he received his medical education at Columbia University and served as an Army surgeon during the first world war. He was active in Jewish causes and at one time served as the president of the Zionist Organization of America. He was a governor of the Febrew University and a founder of the American Friends of the Hebrew University. He was also a founder and leader of the American Jewish Physician Committee.

Dr. Kaliski received his medical degree from the College of Physicians and Surgeons of Columbia University in 1905. In World War I he was a contract surgeon for the Army. He was a member of the Academy of Medicine and the American Urological Association. Fewer many papers on his speciality for medical journals. In 1935 he was made a Chevalier of the Legion of Honor of France.
