Soviets Decide To Resume Trial Of Leningrad Nine, Trials in Riga, Kishinev

NEW YORK, Jan. 14 (JTA).—The Soviet government has decided to resume the trial of nine Jews which was recessed last week, and will proceed with two others in Kishinev and Riga it was learned here today from reliable sources. The Leningrad Irial, which was suddenly hatted ten minutes after it opened last week due, according to reports, to the illness of one of the defendants, will be held this month in the Leningrad Court, Fontanka No. 16. Informed sources have also identified the prosecutor as Karachkov and the Judge as Isakova. The first names of the prosecutor and Judge were not immediately availlable. The nine Jews, charged with having known about the alleged June 15th hijack plot and not reporting it to Soviet officials, have been identified as: Mikhali Korenblit, Lev Korenblit, Viktor Boguslavsky, Lev Yagman, Victor Shitlbans, Lasal Kaminsky, Hillel Butman, Solomon Dreizner and Vladimir Mogilever. The relatives of these men have reportedly not seen them since they were arrested six months ago. Incarcerated in the Kichinev Jall and scheduled to be tried within the first ten days of February are: Anatoly Goldfeld, David Chernoglaz and Hillel Shur. The third trial is scheduled to be held late January in Riga. The names of the defendants are not known. Informed sources also reported today that a gang of hooligans broke the windows of the Malachovka Synagogue in Moscow on New Year's Day and descorated the Sanctuary.

Epan Conters With Western Envoys To Forestall UAR Move To Convene Security Council

JERUSALEM, Jan. 14 (JTA).—Toreign Minister Abba Eban has met in the past two days with the ambassadors of Britain, France, Italy, Belgium and Switzerland to try to forestall Egyptian attempts to convene the United Nations Security Council before Feb. 5 to effect a reinterpretation of its Resolution 242 so as to stress Israeli withdrawal from the occupied Arab territories. Britain and France are permanent members of the Council, and Italy and Belgium became nonpermanent members on Jan. 1. Israel is also maintaining constant contact with the United States on the matter, and in addition is seeking the support of West Germany—even though it is not a UN member—because of its influence with the Arab states. Eban, it is understood; made it clear to the British, French and Belgian envoys that while Israel does not reject the French-endorsed Egyptian proposal for a Big Four guarantee in the Middle East, she wants it to be an addition to a veace agreement and not a substitute for one.

U.S. Views Israeli Plan As Constructive; Eban Says No Map Has Been Given To Jarring

Reliable sources reported today that the United States has informed Israel that it continues to view the Israel proposals as constructive and that a special Security Council session now would be harmful to the cause of peaces. The Jewish Telegraphic Agency learned today that in his talks with the foreign envoys, Eban retterated that the Egyptian desire for a special Security Council meeting was a to torped to torped the Jarring talks. In a speech last night to a student audience at Bar-llan University near Ramat Gan, Eban asserted that no secret map, "nor any other kind of map, for that matter," had been given to Dr. Jarring in Jerusalem, but that he had been given "extremely serious proposals" and "we expect serious answers from Egypt," Eban was pessimistic about Soviet President Podgorny's visit to Egypt, observing: "Two months after the Six-Day War there were Arab leaders who wanted peace, but Moscow oninced them that she would send the Arabs new arms 'and then you can negotiate with Isrdel from a position of strength." On the basis of past experience we would be dreaming if we expect Podgorny in his present visit to counsel Arabs to react favorably to our peace offers." The Israel diplomat noted that while there remained policy differences between Jerusalem and Washington, D.C., they were not increasing, and in fact the positive aspects of their relations have been heightened.

Egyption Aircraft Flies Over Israell Defense Positions; Second Time In Less Than A Week

TEL AVIV, Jan 14 (JTA)--For the second time in less than a week, Egyptian aircraft yesterday overflew Israell positions along the Suez Canal in violation of the cease-fire agreement, Israell military
authorities charged today. Two Soviet-made Mid 21 jets were said to have overflown Israell positions

in the southern sector of the Canal while two Soviet-made Sukhol 7a were violating Israeli air spacé in the central sector; presumaity to obtain direct views of Israeli defenses. The government has protested these overflights in its 30th complaint to the United Nations Truce Supervision Organization since the shooting truce began last Aug. 8. The most recent previous Egyptian overflights were reported by Israel on Jan. 7. Those incidents involved four Egyptian jets.

Israell Soldier Wounded; Arab On 'Wanted List' Captured; Curfew Violator Wounded

JERUSALEM, Jan. 14 (JTA)—An Ieraell soldier was injured this morning, east of Meve Hama in the southern part of the Golam Heights, when the vehicle in which he was riding activated some explosives concealed at the side of the road by terrorists who infiltrated from Jordanian territory. An Arab terrorist, on the Israeli Security Force's "Wanted List" for some time, was captured and wounded today by an Israel army patrol in Jobaltya in the Gaza Strip. The patrol fired several warning shots in the air when a suspictous looking man they had asked to halt for interrogation disobeyed their command and began to run. After he continued to disregard the warning shots, the patrol opened fire and wounded him. He had two hand grenades in his possession. In a related incident, a resident of Eiburj in the Gaza Strip, who violated the curfew, was shot and wounded yesterday by an Israel army patrol. A millitary spokesman announced today that the incident occurred when the patrol ordered the curfew violator to halt. When he falled to do so after several warning shots were fired hid the sirr the patrol opened fire and wounded him.

Arap Knesset Member Acke Mrs. Moir To Cancel His Appointment To Sub-Cabinet Post

JERUSALEM, Jan. 14 (JTA)—The attempt to appoint an Arab to a sub-Cabinet post for the first time has been temporarily stalled on the initiative of the prospective appointee. Self A-Din couble, a Nazareth Moslem who is a Deputy Speaker of the Knesset representing the four-seat Minorities Party, has asked Premier Golda Meir to cancel the move. Although he has felt himself deserving of the appointment in view of his long Knesset service, Zouabi acted to end the matter after all but one Cabineth Minister rejected him as an aide. Shimon Peres, Minister of Transport and Communications and of Posts, accepted Mrs. Meir's suggestion that Zouabi become Deputy Minister of Communications but Moslem MK said he would prefer to serve as deputy in a newly created Ministry of Israeli-Arab Affairs, a proposal Mrs. Meir is studying. The situation is complicated by the fact that Self A-Din Zouabi's cousin Mapam MK Abdel Aziz Zouabi of Nazareth, also claims a Deputy Ministership and is supported for it by his party. And the two Zouabis dislike each other intensely. Furthermore, when Mapan and the Labor Party reached agreement on a compromise whereby both cousins would be appointed to similar posts, leaders of the Druze community complained, asserting that they were more loyal to Israel than Arabs and that therefore they should not be deprived of a Deputy Ministership while Moslems got two.

WUJS Proclaims Jan. 27 International Solidarity Day With Jews In Arab Countries

LONDON, Jan. 14 (JTA).—The World Union of Jewish Students has proclaimed Wednesday, January 27th, as a "Day of International Solidarity with Jews in Arab Countries," to be observed by Jews in both Israel and the diaspora. No public demonstrations have been scheduled for that date. Activity will rather be centered on seminars on Jews in Arab countries.

Sovietish Heimland Editorial Charges Israel Spearheading Anti-Soviet Campaign

LONDON, Jan. 14 (JTA)—The January issue of Sovietish Heimland, which is published with the approval of and under the jurisdiction of the Soviet government as the only Yiddish magazine in the USSR, contains an editorial charge that the Israell government is spearheading a "shameful" ampian of anti-Soviet "siander," The magazine, edited by Aaron Vergelis, declares that "it is now clear that not only the Israell reactionary press, radio and television but also the government of Israel istelf have joined in the new anti-Soviet campaign." That, it continues, "means that anti-Sovietism is now the established policy of the government of Israel, and that the Israell Cabinet is the coordinating body or actions against the Soviet Union and the shameful activities of various commissions and committees set up for the express purpose of an anti-Sovietdrive." The editorial observes that "it is hard to believe that an unprecedented slander campaign against another state, a great power is run on the basis of hes and insinuations by the leaders of Israel." It further commented: "Mrs. (Golda) Meir has branded the Soviet Union as the enemy of the State of Israel and the Jewish people. The provocative Zionist is logan 'Let my people go' has become the keynote of anti-Soviet propagands." Vergelis was criticized by the World Jewish Congress earlier this week for his recent comments in Geneva that the publication of his magazine proved the existence of Jewish cultural freedom in the USSR and that anti-Semittem existed in the USSR "as it does anywhere in the world where Jewes Ilve." In addition, Jerry Goodman of the American Jewish Conmittee in New York said the publication of the magazine was "welcome" but that it was only a partial answer, a token.

Schumann, Ben-Nathan Confer On Mideast; France Favors Big Four Guarantee in Mideast
PARIS, Jan. 14 (JTA)--French Foreign Minister Maurice Schumann and Israel's ambassador to France

Asher Ben-Nathan, met this morning for 45 minutes to review the Middle East situation. The meeting, which was held at Schumann's request, was also attended by the Secretary General of the French Ministry of Foreign Affairs, Hervé Alphand. It was understood that the two main subjects discosed were the current peace talks under the auspices of United Nations special Mideast mediator Gunnar V, Jarring and the reported current Egyptian plan for stationing a peace keeping patrol belonging to the Big Four as a "guarantee for a lasting peace." Since last week's visit to Paris of the Egyptian Minister for Foreign Affairs, Mahmoud Riad, the French officials appear to be convinced that the solution the current crists lies with the establishing of this "peace keeping force." It was also understood that Schumann today raised once again, as the French ambassador in Israel, Francois Hure, had done yesterday in his meeting with Israel's Foreign Minister Abba Eban, the question of a four power "Implemented" guarantee. Israel's position on this matter, which was made clear yesterday in Jerusalem and today in Paris, is that such a guarantee, if implemented, can come as an addition to a peace treaty and not as a substitute. As to the Jarring talks, both sides reportedly agreed that they are the best possible path to a settlement and must be encouraged by all available means.

AZF Official Urges Jewish Community To Be Vigilant As Poace Talks Progress

NEW YORK, Jan. 14 (JTA).—An official of the American Zionist Federation called today for the vigilance of the American Jewish community as the Middle East peace talks progress. Rabbi Israel Miller, president of the AZF, said that while it is not possible to predict the outcome of the new round of talks under the auspices of Ambassador Gunar V. Jarring, "funch will depend on whether the Soviet Union feels that it has already achieved its zoals in the Middle East and whether the Arabs have finally reconciled themselves to Israel's existence and are prepared to live with a sovereign israel in which its Jewish character is assured." Rabbi Miller's views were contained in a memorandum sent by AZF to 3100 Zionist and Jewish community leaders in 315 communities throughout the country in which the AZF reviewed the three years of efforts by Israel to reach a negotiated peace with the Arabs under Dr. Jarring's auspices.

In an interview with the Jewish Telegraphic Agency covering a wide range of subjects, Rabbi Miller stated that, "While the U.S. has given Israel economic and milltary assistance, the political differences between the two countries are real and it will take time and patience to work out these differences satisfactorily." Questioned about what could be expected of President Nixon on the matter of political support for Israel to help her achieve the kind of peace she seeks, Rabbi Miller replied: "While there will be some problems with the administration for a while on the political issues, ultimately. Nixon will act in a positive fashion because he possesses a basic instinct for what is right." Rabbi Miller said that Nixon will "sense that an Israel living within secure and agreed upon boundaries at peace with her neighbors —the right objectiver its right for Israel, right for America, right for world peace, and in the best interests of the Arabs themselves." Although Rabbi Miller said he felt Nixon will "move accordingly when the chips are down," he stressed that it is "important that Nixon knows he has the backing of the American people on this issue." The AZF leader also priased Israel Premier Golda Meir and said that her qualities would serve Israel in good stead during the difficult weeks ahead.

Report Soviets Charge U.S. With Provocation For Interceding In Rigerman Case

WASHINGTON, Jan. 14 (JTA)--State Department spokesman John King said today that the Soylet Union had replied "recently" to the Department's charge of last December that the USSR had violated the consular treaty by attempting to block Leonid Rigerman from entering the American Embassy in Moscow to confirm American citizenship. But aside from saying that the Soviet reply was "under study." King declined to comment on the matter other than to note that Rigerman and his Brooklyn-born mother, Mrs. Esther Rigerman, had been granted American citizenship last Dec. 19 and had applied for a visa on Dec. 28. (In New York, the city's First Deputy Commissioner for Ports and Terminals, Daniel Greer, who has been representing the Rigermans' interests in the United States, told the Jewish Telegraphic Agency that the Soviet reply called the American charge a provocation and questioned the State Department's going to so much effort on behalf of only two individuals. Greer said also that Leonid Rigerman's uncle, Louis Michael of the Bronx, had written his nephew, as required, to make a formal request that he come to the U.S. Greer said no response had been received yet, and that "We trust that the Soviet mails have left it go through.")

Reform-Sponsored Jewish Communai Service School Has Alumni Group

LOS ANGELES, Jan. 14 (JTA)—An alumni association of the first graduates of the Hebrew Union Colege school of Jewish communal service has been formed by 12 communal workers from the United States and Canada who have completed the required attendance of the new school's first two summer sessions here. Edward Rosenthal, community relations associate of the Jewish Community Federation of Cleveland, is the first alumni president, according to Prof. Gerald Bubis, director of the school. The alumni group voted to set up a \$1,200 scholarship at the school, which is scheduled to open for its third eightweek session July 5 on the campus of the HUC here. Prof. Bubis said most of the students are already active in Jewish communal work but that they enroll both on their own and with the aid of scholarships to learn more about Judaism. The curriculum, he said, is based on the premise that Jewish communal work professionals can function more effectively if they know about the sociology and psychology of the Jews and are familiar with Jewish cultural, historical and traditional uniqueness. Grand Jury To Probe JDL; Aeroflot Hit Again; New England JDL Leader Resigns

NEW YORK, Jan. 14 (JTA).—The Manhattan District Attorney's office, it an apparent move to implement Mayor, John V. Lindsay's decision to "get tough" with the Jewish Defense League, has informed that organization that it is putting before a grand jury four criminal cases involving the JDL or its leader, Rabbi Meir Kahane. The cases, expected to be presented before the grand jury tomorrow, involve anti-Soviet and anti-Arab incidents allegedly perpetrated by members of the League during recent months, Meanwhile, despite increased surveillance at all Soviet offices here, a window of the Soviet Aerolfo-Intourist office was smashed early this morning when a bag of bricks was hurled at it by unidentified persons in a passing car, Shortly after the incident, the Dally News received two anonymous phone calls announcing the action, which were closed with the JDL slogan, "Never Again." But Robin Meir Kahane, national chairman of the Jewish Defense League, told the Jewish Telegraphic Agency that his group has "absolutely to knowledge of who did it and why it was done." Mayor Lindsay, briefed on the incident minutes after it happened, termed the rock-throwing a "disgusting act," At the same time, it was learned here today that the New England coordinator of the Jewish Defense League, Rabin Marvin, Antelman, has reetigned from both his post and membership, in the organization, stating that although he agrees with the atms of national JDL, he is disturbed by the means employed to achieve them.

Rabbi Antelman, who resigned along with the chairmen and chapters of JDL in Manchester, New Hampshire; Worcester, Mass; and Hartford, Connecticut, chated that, "He is indeed unfortunate that few today in this country could be identified as coming to the forefront of helping fight for the survival of "Soviet Jewry and for the Jewish underdog as Rabbi Kahane has done, despite the difference between us as to the methods for accomplishing our aims." Continuing, Rabbi Antelman said: "Those who have left felt that there was an increasing lawless situation and a credibility gap developing between National JDL and New England Culus."
