Thant Urges Extension Of Cease-Fire, 'Optimistic' On Jarring Talks 'Progress'
UNITED NATIONS, N.Y., Feb. 2 (JTA)--Secretary General Thant has formally called on Egypt,

Jordan and Israel "to withhold fire, to exercise military restraint, and to maintain the quiet which has prevailed in the (Middle East) area since August (8), 1970." In a statement dated yesterday and released today, Thant said that while the peace takes under Dr. Guman' V. Jarring were "still at an early stage" and "much further clarification is required," he nevertheless said he found "grounds for cautious collimiem in the fact that the parties have resumed the takes through Ambasdour Jarring in a serious manner and that there has been some progress in the definition of their positions." At a news conference here Jan. 18, Thant said he and Dr. Jarring were "cautiously optimistive," but he did

not at that time specifically urge a cease-fire extension beyond Feb. 5.

Its offer to decide the properties of the proposed by Jordan through Dr. Jarring, Israel was understood to insist that, in all provisions of a settlement concerning the rights of the various countries in the Middle East region, Israel must be mentioned specifically, rather than in the general terms used by Jordan in its statement to Dr. Jarring which reportedly does not mention israel directly at any point.

According to the sources, Israel did not say that the issue of Jerusalem as such would be negotiable but it did not expressly rule out that topic. Last week, it was reliably reported that, if peace could be reached with Jordan, Israel would be willing to yield part of its sovereignty over Jerusalem's Mount Templa, the area in the old city, part of which is now the site of the Dome of the Rock and the El Aksa Mosque, which together are the third holiest place of the Moslem faith. That plan has not been officially submitted through Dr. Jarring, the JTA was informed but it was presumed that the official offer made

to Jordan yesterday was based on that plan;

Meanwhile, Foreign Minister Abba Eban met the envoys of the United States and Japan yesterday and informed them of Israel's current position on the Jarring talks, it was learned from reliable sources in Jerusalem, and that he met today with the ambassadors of Belgium and Argentina. He reported by has scheduled meetings tomorrow with the ambassadors of Britain, Italy and France. Premier Golda Meir said in the Knesset today that it was not true that Israel had given Dr. Jarring details of new borders Israel may want. She also denied reports that the Government had taken any decision on negotiation on new frontiers at the current stage of the Jarring talks or had indicated any conditions for Israeli withdrawal from the occupied areas.

Israel Tension Mounts As Cease-Fire Nears End; Egyptian Overflights Charged

JERUSALEM, Feb. 2 (JTA)—Tension continued to build in Israel today as the end of the first extension of the cease-fire on the Suez Canal front neared without a specific commitment by Egypt to extend it. The general headquarters of the Armed Forces instructed all of its units to be on the alert in the event the Egyptians begin shooting on Friday when the cease-fire runs out. In a related development, Israel charged today that, for the second day in a row, Egyptian warplanes violated the stand-still phase of the cease-fire by overflights. Officials said that two Sukhoy-7 bombers flew over Israeli positions in the afternoon, and that two MIG-28 flew over Israeli positions later. Israel did not shoot at the intruding planes, the officials added. In a complaint filed with the United Nations Truce Supervisory team, Israel complained that MIG-21 interceptors flew over the canal twice yesterday. Israeli military officials reported that the massive buildup of Egyptian fortifications along the canal had apparently been completed and no such activity was reported today. The officials said that they were confident that the Israeli forces would have "the right nanewr" to any contingency that may develop Fridey.

The officials also reported that the Egyptians had concentrated seven armor and infantry divisions, totally some 80,000 troops, along the front line of the canal, which they called "a very dense elployment." They also reported that some 1,300 Russian-made tanks were in position along the canal, as

well as more than 1,000 artillery pieces ranging from the huge 203-mm guns to heavy mortars. Antiaircraft now in firing position consists of SAM-2s operated by Egyptian personnel and SAM-3s operated by Soviet personnel, the officials said. The missiles cover almost the entire canal area and in some places as deep as eight miles into the Israel side of the waterway.

They reported also substantial assemblies of canal crossing equipment at several points where, special sites had been prepared, cut into a high rampart that runs along the canal's west bank. There are special approach roads to those landing sites. Troops on the Israeli side reported seeing jeeps with senior Egyptian officers coming and going on the front line and for the first time Egyptian soil diers were observed wearing helmets and carrying arms. West Bank Food Hoarding Reported in Apparent Concern Over Cease-Fire End

JERUSALEM, Feb. 2 (JTA)—Israell officials reported today that there has been some hoarding by some residents of the West Bank, apparently in anticipation of possible shortages in the event the current cease—fire 1s not extended after its expiration on Friday. One report from East Jerusalem indicated heavy purchases in wheat, flour, rice and sugar during the past two days. A brisk business also has been reported in trade in Jordanian dinars with the black market price soaring. However, most-conservers were reported to believe that most West Bank Arabs are nor greatly worried about the nuture and that life appears to be going on normally in the main population centers in Judea and Samaria. They said Arab "intellectuals" in the West Bank consider Friday a kind of "turning point" in Israel—Arab relations, that it will either be a move toward peace or the beginning of a new chapter of conflict. Other sources suggested that the increase in purchase of foodstuffs by West Bank Arabs may have been done in connection with the Moslem holiday of Yif El Adha.

On the Israeli street, there appeared to be a general belief that there would not be a resumption of warfare. A public opinion poil published yesterday indicated that 45 percent of Israelis believe there will not be a resumption, 20 percent said they felt there would be more flighting and the rest expressed the hope there would not be a resumption of warfare. An East Jerusalem newspaper columnist, Mohammed Abu Shelbaya, writing in today's issue of "Al Quds," criticized the Jordanian Information Service for allowing the broadcast of songs calling for the extermination of Jews, He said this was a repetition of the pre-1967 activities of extremist Arab leaders; led by Ahmed Shukairy, the former lead of the Parletine Liberation Organization.

Agency Budget Seen Indicator That More Than 50,000 Will Come To Israel

JERUSALEM, Feb. 2 (JTA).—The Jewish Agency's \$573 million budget for the 1971-72 fiscal year is sheed on an expected immigration of 50,000 persons, according to an Agency statement. But according to some informed forecasts, immigration may turn out to be higher. That estimate is reflected in the allocations for immigrant absorption—\$386 million—and for immigrant housing—\$193 million. The latter is the largest single appropriation in the budget.

By far the largest slice of the housing budget—\$176 million—is earmarked for the construction of approximately 15,000 apartments for immigrants. The apartments will be bigger and better than in previous years because experience over the past two decades has shown that substandard housing tends to turn quickly into slums and that their occupants tend to migrate to the larger cities. Those tendencies would defeat the very purpose of the immigrant-housing policy, which is to disperse the population across the entire nation. Therefore, apartments that used to have only 105 square feet of floor space in the mass-immigration days of the early 1950s and were later calarged to 197 square feet will now measure 328 square feet—and in the cases of large families, 394 square feet.

These houses are not given to immigrants free of charge. They have to buy them, though on very easy payment and mortgage terms. A \$14 million fund has been set aside for rental subsidies to immigrants who have to live in areas where immigrant housing is unavailable. Such immigrants must have some means of their own, but can obtain subsidies of up to \$286 a year per family.

Druze Knesset Member Urges Arab States To End Threats Against Israel

JERUSALEM, Feb. 2 (JTA).—Shelkh Jaber Muadi, a Knesset member representing the Arab Parties, urged the Arab governments today to desist from saber-ratilling and threats against Israel. War, he said, had brought destruction and ruin to Arabs and might lead to their losing their soversignty to the Soviet Union. "We have been living in the State of Israel for almost 25 years." the 51-year-old Druze said at a reception hosted by President Zalman Shazar, "and we know that her leaders derire peace." Officials of Israel's Druze community attended the reception held to mark the Druze's annual Feast of the Sacrifice. "President Shazar re-emphasized the loyalty of the Druze to Israel by noting that 84 have died defending the country, seven of them in the last few months. The counterfeiting job has been described by officials as very poor and the discrepancies in the coins are easily detectable. An investigation has been undertaken by the police force to determine the origin of the coins.

Soylet Emigre Says 300,000 Russian Jews Seeking To Leave For Israel

WASHINGTON, Peb. 2 (JTA).—Dr. Esther Alsenstait, who gave up her professional career in Moscow to immigrate to Israel last November, said here yesterday that at least 300,000 Sorliet Jews were seeking to leave for Israel despite threats of arrest or loss of employment. The Kremlin, she said at a press conference arranged by B'nal B'rith, "never expected so many would want to leave," The 52-year-old linguist was joined at the press conference by her husband, Leizer Napomnyasty, 59, a Russian-English interpreter from Moscow; and Mrs. Alla Rusinek, a 21-year-old newlywed who left the Soviet Union last November a week after her marriage, although her husband remained behind pending approval of his emigration applications. The press conference was filmed by a West German television area.

Dr. Alsenstadt and her husband--who had signed the public "Letter of the 39" repudiating a Soviet press conference at which 52 lews denied Soviet anti-Semitism--said here yesterday that "every decent person--Jew and non-Jew--is ashamed of that press conference." She described it as an event at which "you put Jews under the press and stage a conference." and that those who believed it have it "on their conscience." Most of her fellow faculty members in Moscow sympathized with the plight of Soviet Jews, she observed, "but of course they can't speak out about it." Dr. Alsenstadt said she had been the last Jew in her department.

Mrs. Rusinek, noting that many Soviet Jewish parents were unaware of their Jewishness, declared that "the reversal of our feelings is a miracle." She elaborated: ""e now speak of thousands who go to the synagogue to express our feelings in songs. We study flebrew. It's very dangerous, subversive... Textbooks are confiscated when they are found by police." She said "the Six-Day War helped us understand our Jewishness, that there is some place for Jews," and added: "We didn't know what it is to be Jewish, but we knew what it is to be Jewish but we knew what it is to be Jewish but we knew what it is to be a Jew in Russia."

Youth Group Pickets Presidents Conference For More Aid To Soviet Jewry

NEW YORK, Feb. 2 (JTA).—Pitty college and high sohool students calling themselves the Ad Hoc Committee to Revitalize the American Jewish Conference on Soviet Jewry picketed for 90 minutes today outside the midtown building containing the offices of the Conference of President of Major American Jewish Organizations. They charged Dr. William A. Wexter and Yehuda Hellman, chairman and executive director of the Conference of Presidents, with debilitating the American Jewish Conference by denying it autonomy and the legal status required for fundraising. They added that after seven years of existence, the American Jewish Conference had only one full-time paid professional on its staff and was unable to demonstrate until Sept. 20 for the Leningrad Jews arrested June 15.

The student group charged Dr. Wexler and Hellman with being "more interested in the prestige of the Continuous of Providente than in a strong Soviet Jeway boty." which it described as an "Abstructionist and hour slighted policy." A situlent spackesman said. "The American Jewish Conference on Soviet Jewry has tremendous potential, but the Conference of Presidents is strangling it at its very sources." He added, without elaboration, that "If no policy changes are forthcoming from the Conference of Presidents, other actions will be planned." The spokesman stated that no Jewish Defense League members took part in the demonstration.

Svichinsky Leaves Moscow For Vienna And Israeli Settlement

LONDON, Feb. 2 (ITA).—Vitaly Syichinsky, the Soviet Jewish architect and activist whose scheduled Jan. 23 departure for Israel was delayed without official explanation, flew from Moscow to Vienna yesterday on his way to Israel, according to reports reaching here. Some sources had said lait week that his departure had been delayed by formalities following his wife's having a baby. Meanwhile, Grische Feigin, the Riga Jew released from forced incarceration in a mental home Jan. 7, has kelephoned Israeli friends from Riga to say he expected to arrive in their country by Feb. 15. He sixed that no fuss be made over him when he arrives. "I am a simple Jew," he said in Yidding

Wiesenthal Says He Knows Even Passport Number Of Mengele

TEL AVIV, Feb. 2 (JTA).—Simon Wiesenthal, the Nazi hunter told newsmen today that he knows the exact whereabouts of notorious Ausctothiz "selection doctor" Joseph Mengele and has he number of the Panamanian passport Mengele is holding. Wiesenthal, who came here to participate in a special television broadcast on "Nazi hunting," disclosed that Mengele is in Paraguay, residing in a closed military district known as "Tuarto Vincente" over which the police have no jurisdiction. Wiesenthal also revealed that his Nazi war orimes documentation center in Vienna knew all 11 pseudonyms Mengele is using. He said his center was now concentrating on Warsaw Ghetto Nazi Commander Loudwig Hahn, the man responsible for the murder of many Polish Jews. Hahn, Wiesenthal reported is living in Hamburg and maintains two villas. Wiesenthal's center has forwarded the pertinent information to West German authorities, but as of yet, he said, no steps towards Kahn's arrest have been taken by officials.

500 Jews Wreck Headquarters Of Australian Neo-Nazi Party

MELBOURNE, Feb. 2 (JTA).—Some 500 persons—many of them bearing concentration-camp numbers on their forearms and some wearing striped garments similar to those worr by camp immates—wrecked the headquarters here of Australia's neo-Nazi organization on Sunday. Two thousand demonstrators and massed to protest to the police over a parade and meeting scheduled by the neo-Nazis in a nearby park. But although the police persuaded the neo-Nazis to postpone their program, 500 of the demonstrators refused to disperse. Instead, they stormed the neo-Nazi headquarters, smashed windows, tordown Nazi embitems and flags and left the place a wreck. Six shots were fired from the building by neo-Nazis. The police moved into the building and confiscated the guns, but made no arrests. Two women among the 16 neo-Nazis in the building were rescued from the demonstrators by policemen who took them out by a back door. Four demonstrators were arrested and charged with unruly behavior. Some reports said the Australian branch of the dewish Defense League was involved.

First Of Planned 30 Jewish Clubs In NYC Public High Schools Formed

NEW YORK, Feb. 2 (37A).—The Association of Orthodox Jowish Teachers in New York Public Schools announced today the formatichn of the first of a planned 30 "Aktiva Clubs," a project in oity public high schools to help strengthen the Jewish student's identity as a Jew and his Jewish education. Under the sponsorship of the association, an agency representing some 6,000 Orthodox men and wenteachers in the New York City public school system, the clubs will seek to win altenated Jewish students back, "into the fold," and to counteract anti-Zionist and anti-Jewish propaganda being disseminated by radical groups on high school campuses, according to Philip Kipust, president. He said almost all of the public high schools have Afro-American and Newman clubs, while Jewish clubs are virtually non-existent.

The Akiva Club was established at Frankin Delano Rooseveir high school in Brooslyn and has an initial membership of about 25 students, he reported. He told the Jewish Telegraphic Agency that his organization hopes to eventually establish such clubs in all public high schools with a substantial Jewish student attendance. He said the clubs will offer members a variety of Jewish clutural programs, including speeches on major Jewish issues by Jewish leaders, showings of filmstrips on Israel, and field trips to places of Jewish interest in the city. The AOJT will finance the Akiva clubs and will also supply them with Jewish literature, filmstrips and speakers, Mr. Kipust said. Each club will be led by an Orthodox teacher. Max Lew, chairman of the organization's committee for student activities, is directing the Akiva club program, he added.

PEARL Right To Sue Over Granting Of Public Funds Upheld By Federal Judge

NEW YORK, Feb. 2 (JTA)—Leo Pfeffer, special counsel of the American Jewish Congress, said yesterday he was "deeply gratified" by a Federal Court decision late last week unholding the right of a civic organization to sue in its own name against the granting of public funds to private schools. In the decision, Judge Morris E, Lasker approved the motion of the Committee for Public Education and Religious Liberty (PEARL) for a three-judge Federal Court to hear FEARL's suit against the 1970 state law permitting \$28 million in such aid. PEARL had argued that the law violated the First Amendment of the United States Constitution and Art. XI, Sect. 3 of the New York State Constitution, the latter the so-called "Blaine Amendment." Attorney General Louis J, Lefkowitz had argued unsuccessfully, on behalf of the state, that PEARL had no standing as a taxpayer, that its suit should have been filled on the state level, and that the 1970 law was constitutional.

Pfeffer declared that "Should the U.S. Supreme Court uphold this (Lasker) decision, it will mark a major turning-point in American jurisprudence, one that recognizes the validity of 'associational jurisprudence.' "Issaed on the reality that unless the single individual can not in association with little middle nervous through civic organizations, many cortous violations of the Constitution will be free from judicial challenge and therefore immune to correction." The Lasker decision, he added, makes the individual's right to sue "not merely theoretical but practical." PEARL is composed of 29 civic and religious organizations including the AJCongress and the American Jewish Committee.

Trial Of Three Jewish Radicals In Synagogue Demonstrations Re-Set For April

NEW YORK, Feb. 2 (TA).—The trial of three members of the Radical Jewish Union of Columbia University on charges of disrupting a religious service at Temple Emanu-El here has been re-scheduled for April 13 in New York City criminal court. The defendants are Rabbi A, Bruce Goldman, rabbinical advisor to the RJU, Victor Levin, a graduate student at Columbia University, and Anne Rosen, a graduate fellow at New York University. The charges grew out of demonstrations by the RJU at Temple Emanu-El on May 15 and May 29. A hearing was held on the charges before Judge Morris Schwab in city criminal court on Jan. 12 at which a postponement was requested because the attorney for the defendants, Gerald Lefcourt, is now representing 12 Black Panthers being tried here on conspiracy charges. Rabbi Goldman has been charged on two counts, and the graduate students on one count each. Rabbi Goldman said a legel defense committee has raised about \$500 towards the estimated trial costs of \$5,000. He said that at the April 13 trial, a request will be made that the hearings be transferred to a Beth Din, a rabbinical court.

AZF Sets April 28 For Celebration Of Israel Independence Day

NEW YORK, Feb. 2 (JTA).—The American Zionist Federation has set the evening of Wednesday, April 28, for a celebration in Carnegie Hall of lareal's 287d anniversary. It expects a minimum of 17 parades in communities across the country, and is asking local AZF chapters to urge their Mayors and Governors to issue proclamations designating April 29 as Israel Independence Day or the week of April 25 as Israel Independence Week. (Because the anniversary this year falls on a Friday.—April 30; the fifth of Iyar—it will be celebrated on Thursday, April 29. Such a shift in dates is not unusual; in recent years it has occurred in 1965 and 1963.

First Zionism History Course In City University Offered At CCNY

The City University of New York will be offered this Spring term, Prof. Marrin Feinstein, director of the school's Jewish Studies Program, announced today. Prof. Teinstein, who is associate professor of Hebrew at The City College, and who will teach the new course, said enrollment for the new class had to be closed on the second day of registration when 45 students, the maximum permitted, enrolled for the class despite a lack of publicity or even a mention in the school bulletin listing courses available. He said another 45 students were turned away. A second new course, Archaeology of the Holy Land, will begin in the Fall 1971 semester. Both courses were approved by the University Administration shortly before me rail semester ended. The Jewish Studies Program consists of 20 Hebrew courses, two Yiddish courses, three comparative literature, two on Jewish history, one on the government and politics of Israel and a seminar on the Middle East. It was started last September.
