### Verdict in Riga Trial Due Thursday; Prosecution Asks I-4 Years For Defendants

NEW YCRK, May 26 (JTA)—A verdict will be handed down tomorrow in the trial of four Jews in Riga, Jewish sources reported today. The four, Ruth Aleksandrovich, Mikhail Shepshelovich, Arkady Shpilberg and Boris Maitsier, went on trial Monday on charges of anti-Soviet activities and face sentences of up to seven years. The trial had been expected to last for two weeks and there was no explanation for the sudden speed-up. Jewish sources here said that the prosecution in the trial asked today that Shpilberg be sentenced to 4 years in prison, Shepshelovich to 2 years, and Miss Alckandrovich and Maftsier to 1 year each. The defense responded that there was no proof of "anti-Soviet activities," which carry a maximum sentence of 15 years, and asked that the charges be reduced to dissemination of anti-Soviet literature with the knowledge that the action is illegal, which carries a maximum 3-year term. The sources said the prosecution asked for only 1-year sentences for Miss Aleksandrovich and Maftsier because the former suffers from an asthmatic condition and the latter asked for mercy.

Yesterday, according to reports, 22 witnesses testified, among them five Jews who were convicted and sentenced at the first and second Leningrad trials for allegedly plotting to hijack a Soviet airliner. According to Tass; the official Soviet news agency, the Leningrad defendants implicated the Riga defendants. Jewish sources denied today that this was so. The Jewish sources identified the Jews who testified yesterday as Silva Zalmanson; her brother, Israel; Mendel Bodnia and Anatoly. Altman, all convicted at the first Leningrad trial last December, and Vladimir Oeherovich Mogliever, one of the nine convicted at the second Leningrad trial which ended a week ago. The Riga trial was conducted in almost total secrecy in a special building on a heavily guarded peninsula outside the Riga city. Himits. The foreign press and spectators were barred, According to Jewish sources, the courtroom was filled with KGB (secret police) officials. Relatives of the accused have not been permitted in the court except to take the witness stand. The presiding judge was identified as Latka and the state prosecutor Tsiblsov. Their first names were not given. The only official news from the trial comes from Tass which Jewish sources say is not to be trusted. According to these sources, the defendants looked well and conducted themselves with signity. They reportedly refused to confess to any crimes against the Soviet state,

Evidence introduced but not produced in court included a suitcase said to have contained "pamphates, from Irreal" which was due on from the annd dunes near Riga. The defendants were accused of distributing the alleged pamphiets for subversive purposes. Miss Aleksandrovich reprietely told the court that she did not consider herself guilty of anti-Soviet activity in any form. Shpilberg reportedly testified that the only leaflet he distributed was one stitled "Our Native Tongue" which was an appeal as etuny the language of the Bible. He denied involvement in any kind of conspiracy against the Soviet state. He said he and the other differendants met only to celebrate Jewish holidays, the sources reported. Meanwhile, Miss Aleksandrovich's flance, Isalah Averbuch, and Misha Neuberger, who were jailed May 17 for 15 days, reportedly to prevent them from testifying at the Riga trial, have gone on a hunger strike, the sources said. They have threatened to continue their fast until the trial ends. As they are being held incommunicado, their only sources of news are the prison authorities.

### Zand Reported in Misery, Despair Over Possibility He May Not Get Exit Visa

DETROIT, May 26 (JTA)--Prof. Mikhail Zand is experiencing "despair and misery" over the possibility that he may not obtain permission to leave the Soviet Union for Israel, according to Prof. Herbert Paper-25 the University of Michigan in Ann Arbor, a firend of the Soviet Jewish scholar. Prof. Paper telephoned Prof. Zand in Moscow last night. He was told by Prof. Zand that after his application for an exit visa was again postponed last Friday for "an indefinite time," he went to the Dutch Embassy and asked it to intervene on his behalf. The Dutch Embassy acts as the intermediary for Israel in the Soviet Union. However, Prof. Zand said the Embassy was not too encouraging. "We now live in despair and misery," Prof. Paper reported his friend told him. Prof. Zand asid that he had applied for Israell citizenship under the amendment to Israell immigration laws which permit the Interior Minister to confer Israell citizenship in absolutio on any Jews abroad who want it and are prevented from coming to Israel. Prof. Zand said if citizenship is granted it might encourage the Dutch Embassy to act on his behalf to persuade the Soviet authorities to allow him to leave. Prof. Paper reported that Prof. Zand expressed the view that this kpeed-for intervention is his last chance to obtain an exit visa. Prof. Paper said that his conversation with his friend ended abruptly when their telephones were disconnected.

Amnesty International Appeals To Kosygin To Cancel Upcoming Trials

NEW YORK, May 26 (JTA)—The U.S. affiliate of Amnesty International appealed today to Soviet Premier Alexset Kosygin to cancel the trials of Jews in the Soviet Union and to exercise clemency in the cases of Jews already convicted in Leningrad. In a letter to Kosygin, Amnesty's U.S. chairman, Mark K. Benenson stated "Surely the USSR is strong enough to permit those who wish to leave to go." Amnesty International, with headquarters in London, is a private organization that assists non-violent political and religious prisoners throughout the world. Benenson's letter to Kosygin added: "We are saddened by reports of the newest convictions of Jews in Leningrad and the further trials in Kishinev and Riga. The censored press reports suggest that the trials represent gross violations of human rights. Just as Amnesty protests the oppression of socialists and communists imprised in other countries, so must we defend and ask justice for citizens of the USSR..." (Earlier this week it was reported that the Kishinev trial has been postponed. No new date or reason for postponement was given.)

#### Orthodox MK's Charge Non-Jews Being Registered As Jews

JERUSALEM, May 26 (dTA).—The question of who is a Jew was aired again in the Knesset yesterday by two Orthodox MKs who charged that the government was indiscriminately registering non-Jews as Jews in order to grant them all the rights of new immigrants. Rabbi Menachem Porush of Agudath Israel and Babbi Kalman Kahana of Pealed Agudath Israel charged that by condoning the "sutematic conversion" process being carried out in Vienna to expedite the admission of Soviet Jews into Israel, the government was destroying the achievements of generations of tradition. They claimed that the word "conversion" had been emptied of any real meaning and that Israel was in danger total assimilation. Rabbis Porush and Kahana urged the Knesset's various factions to unite in spite of their political differences to guarantee "the future of a Jewish Israel." Interior Minister Yose Burg of the National Religious Party, himself an Orthodox Rabbi, repited for the government and said it was not interested in registering non-lews as Jews. He agreed that incorrect registrations should be avoided at all costs, and suggested that the Porush-Kahana motion be sent to the Knesset's Interior Committee for study. His suggestion was approved by all factions except for the State List and part of Gahal, which voted to reject the motion.

#### Ben-Gurion Urges Youth To Prepare Themselves To Go On Aliyah

NEW YORK, May 26 (JTA).—Former Israell Premier David Ben-Gurion contends in a new magazine article that "All those American Jewish youths who have a ploneering spark within themselves should prepare themselves to go on aliyah to Israel," because "Prayer for aliyah is not enough." Writing in the 10th anniversary issue of "Olam Hadash," a periodical published by Hebrew Publications for Children, Inc., Ben-Gurion asserts: "The redemption of Israel can only be fulfilled by ali-yah. Israel needs a dig ploneering aliyah from the entire diaspora, but particularly from America where the greatest Jewish community is concentrated. "We need an aliyah of tens and hundreds of thousands so that they can make Israel fruitful and bring peace to our land and our neighbors." Ben-Gurion also urges American Jewish youth to "pursue a Hebrew education not only to bar mitzwah, but beyond; so that you will thoroughly understand Judaism and its historic mission for our people." That process, he adds, "is possible only through a knowledge of the Bible in its original form, the learning of Jewish history, and the reading of Hebrew literature in addition to the English literature."

#### Pincus Considering Resigning From Jewish Agency; Offered Bank Leumi Post

JERUSALEM, May 26 (JTA).—Jewish Agency Executive Chairman Louis Pincus is considering resigning after the next World Zionist Congress in January, it is unofficially learned. He has been tentatively offered the post of Chairman of the Board of Bank Leumi Leisrael, a key position in Israel's economy. The current Board Chairman Ernst Lehman wants to retire and is only waiting for a suitable successor. One of the candidates suggested for the post, to be vacated by Pincus is Artieh Eliav, at present Secretary General of the Labor Party and formerly Deputy Minister of Immigrant Absorption. The Labor Party in principle supports Pincus' candidacy for the Bank Leumi Job because until now it has been in the hands of Liberals whereas Pincus is a Labor man, but support for Eliav's candidacy for the Jewish Agency post is much weaker because his dovish ideas have estranged him from some sectors of his own party.

### Arab Federation Demands Sharpe Resign Because He Represents Jewish District

TORONTO, May 26 (JTA).—The Federation of Arab-Canadian Societies has demanded that Mitchell Sharpe, Minister of External Affairs, resign because he represents the Egilinto district in Toronto, Canada's second largest Jewish constituency. A Tesolution adopted by the group at its annual convention yesterday affirmed that Sharpe cannot be impartial, under the circumstances, in duties vital to the Arab-Israell conflict. The Federation also adopted a resolution calling on the federal government to end the outflow of tax-free dollars to the "expansionist State of Israel," and to protest Israel's "violation of basic human rights which endangers the physical and mental health of the Palestinian people," Palestinian-born Marie Claude Giguere, 35, of Quebec City and an employe of the Quebec Province Catholic School Commission, was elected president of the Federation.

### Eban Affirms No Power Can Change Status Of Jerusalem As Israel's Capital

JERUSALEM, May 26 (JTA) - Foreign Minister Abba Eban doclared in the Kneaset today that "no power in the world can ever change the status of Jerusalem as Israel's capital." That status, he said, "is rooted deep in Jewish history and in the Jewish people's faith, and has received tangible expression in the life of the State of Israel since its inception." Eban stressed that the government had never adopted the memorandum submitted three years ago by Moshe Benvenisti, now Jerusalem's city councilor, which noted the possibility of restoring some areas outside the municipal boundaries to Jordanian sovereignty,

### Israeli Arab Appointed Deputy Minister Of Health; Highest Post Held By Arab

JERUSALEM, May 26 (JTA)—Health Minister Victor Shemtov informed the Knesset officially yesterday that he has amonited Adol. Asis. Zushi, an Israeli Arab from Nazareth; the post of Deputy Minister of Health. Zushi, a Knesset member who served two terms as Nazareth's Deputy Mayor, is the first Arab to be elevated to semi-Cabinet rank in Israel. He and Shemtov are members of Mapam. Zushi has publicly declared his loyalty to Israel, though he also proclaims himself a logs on of the Arab nation, and has referred to the Arab-Israel conflict as "tragic." He has been a member of Mapam since 1950. The Cabinet approved Zushi's pending appointment last week after nearly year's delay. The delay was due to the Labor Party-s insistence on a similar post for one of its own Arab MKs. The Labor candidate was Seif Eddin el. Zushi, a cousin and bitter personal enemy of Abdel Aziz. The problem was resolved last month when Seif was elected Mayor of Nazareth as a result of a coalition agreement. As mayor he could not serve as a deputy minister. Abdel Aziz Zushi told the Jewish Telegraphic Agency last week that he didn't think the appointment of an Arab as deputy minister was premature. "In fact, I think the time has come for an Arab to serve as a minister with full Cabinet rank."

#### Yeshivas To Receive \$2 Million From New N.Y. State Bill

NEW YORK, May 26 (JTA) -- Jewish all-day elementary and high schools in New York State w neive more than \$2 million additional state aid from the new "Aid to Non-Public Schools" bill it duced today by Gov. Nelson A. Rockefeller, according to Rabbi Moshe Sherer, executive preside Agudath Israel of America, who has been involved in the development of the measure. Rabbi Sh said that with this sum added to the amount the yeshivas will receive from the 1970 Mandated Se Law, the Jewish all-day schools will receive \$4 million in state aid during the 1971-72 school ye The Rockefeller bill calls for \$33 million in grants to non-public schools as partial reimbursem for their expenses in providing secular services to children. The non-public schools will recei a year per child in each elementary school and \$72 a year per child in the high schools. Those recognized by the federal government as serving a high concentration of students from very low families will receive an additional \$54 per student. Rabbi Sherer declared that while he has "in up on the concept of a parent-aid bill as the most suitable vehicle for the state to help resolve t ancial problems of the non-public schools," the new bill "is a landmark move forward in the on process of the recognition by the government of its responsibility to share in the funding of the lar education of children attending non-public schools." The bill prevents an actual expansion private-school system. The Committee for Public Education and Religious Liberty (FSARL), it umbrella group for organizations opposing public aid to private schools, opposes the Rockefelle on both Constitutional and economic grounds. ### Education Ministry To Aid Black Panthers; Split Develops In Panther's Ranks

JERUSALEM, May 26 (JTA).—The Histadrut jointly with the Ministry of Education and the Jelem municipality is planning to open a seminar for leaders of the Black Panthers, it was disclose yesterday by Dr. Dan Romen, chief planning adviser of Education Minister Yigal Allon. He said Ministry and the municipality are also planning to open a new kindergarten in Musrara, one of Jalem's slum quarters and a hothed of Black Panther agitation. (The Ministry of Education itsel ever, is located in the heart of Musrara—not by choice but for want of a better location.) A gre of confusion has meanwhile set in with regard to who is a Black Panther and who is not. After tracas last week with the police, some of the Black Panther leaders agreed to join the Moroccan migrants Union, a self-help group. They were overruled by their rank and file, but some of the stayed within the Union nevertheless. Two rival groups, each of them calling themselves Black thers, have applied to the Registrar of Societies for official registration. Neither has been regifor the time being, pending clarification. Announcements to the press are being made by spokes of various Black Panther splinter groups, each of them claiming to speak for "the Black Panther Cone of the Panther leaders, Eddie Mor, announced last night that his organization had changed I mane to "Black Panthers—Blue and White." It is by no means clear whether all Black Panther agree to this.

UAHC Leader Says Turning Calley Into A National Hero is Appailing

NEW YORK, May 26 (JTA)—Rabbi Maurico N. Elsendrath, president of the Union of American Rebrew Congregations, declared in a report yesterday to the Reform organization's board of trustees that he was shocked at witnessing "a startling number of Americans spontaneously turn a self-concessed murderer of unarmed women, men and children into a national hero." Referring to Lt. William L. Calley, who was recently convicted for the murder of at least 22 Vietnamese civilians at My Lai in 1968. Rabbi Eisendrath stated. "It is had enough that we have turned God's good sarth and the fulless thereof into an open garbage pit, but when the larger part of a great nation no longer can or will distinguish between so clear-cut a case of good and evil; that is spiritual pollution in its terminal form."

Rabbl Elsendrath said he was ashamed "that the crimes committed by Lt. Calley were committed in the name of America." and criticated President Nixon for "intervention., in such a namer as to prejudice the appeal procedure." Nixon has announced that under his Presidential authority he will decide the final disposition of the Calley case. "What perversion of moral leadersing," Rabbl Elsendrath asked, "led to the speciacle of an American President playing to public opinion—while plously rejecting public opinion and the war itself—and degrading the legal process by personal intervention at a time and in such a manner as to surely prejudice justice." The Reform leader called on Nixon to appoint a committee to clarify ethical and legal guidelines in war, and he urged the military dutorities to punish other members of the Armed Forces who abrogate the military code justice, the Geneva Convention and the Nuremberg guidelines. Finally, Rabbl Elsendrath called for an end to "this morally cancerous war."

#### COLPA Hails Regulations Protecting Sabbath Observers in Federal Employment

NEW YORK, May 26 (JTA).—The National Jewish Commission on Law and Public Affairs (CoLPA), applauded the issuance by the United States Civil Service Commission of new regulations, requiring Federal agencies to reasonably accommodate the religious needs of Sabbath observing employees and applicants. Many Sabbath observers have in the past been denied employment by Federal agencies which refused to make even minimal and inconsequential adjustments in uniform work schedules to accommodate them, CoLPA stated. Such adjustments have been required in private employment since 1967 under the Guidelines issued by the Equal Employment Opportunities Commission (EEOC). The present action by the Civil Service Commission which went into effect Monday, is the culmination of an intensive two-year effort by CoLPA, which was successful in obtaining promulgation of the EEOC Guidelines, Julius Berman, president of CoLPA, applauded the action of the Civil Service Commission.—"The new regulations," he said, "eliminate the paradox of American citizens being afforded greater protection in employment in the private sector than in employment by his own government. We are hopeful that with this artificial barrier removed, Sabbath observers will be able to more fully participate in the economic life of the country and together with all Americans contribute to its continued growth."

Soviet Jewry Committee Sets Up Phone Service To Provide Latest News On Soviet Jews

BALTIMORE, May 26 (JTA)—In response to widespread concern for information regarding Jews in Soviet Russia, the Baltimore Committee for Soviet Jewry has established a new telephone service to provide up-to-the-minute news 24 hours a day, Louts J. Fox, committee chairman announced. Called Soviet Jewry Newsline, the service will draw on all public information media as well as private sources available to we Baltimore committee. "We are making every effort to provide fast, reliable news on the trials as well as on local activities in support of the Jews of Russia," Fox said. "Soviet Jewry Newsline, however, is planned as a long-range service for Baltimorean, not merely as a telephone to be installed during emergency periods." Mr. Fox emphasized. Barring a major shake-up, the Soviet goog-ment campaign of "outural genocide against its Jewich citizes will continue after the present einergency," Mr. Fox noted, "and our Baltimore committee is tooling up for a long-term operation." ## Trudeau Urged To Intercede For Leningrad 9; Trudeau Reports Kosygin Cool To His Efforts

KIAMESHA LAKE, N.Y., May 26 (JTA).—A regional convention of the Canadian members of B'nai B'rith cabled Prime Minister Pierre Elliott Trudeau, currently on a visit to the Soviet Union, urging his intercession with Soviet leaders in Sehalf of the nine Jews convicted last week. The delegates also asked that Trudeau make appropriate representations to the Soviet government for the freedom of other Jews arrested and awaiting trial, and for the right of Soviet Jews to emigrate, the making it was learned that Trudeau fold reporters in Tashkent that he made strong representations to Soviet Premier Alexsel Kosygin on behalf of Soviet Jews who wished to emigrate, to Israel. Trudeau indicated his plea was not received warmly. Kosygin replied he was free to make representations for Jews but that the Soviet Union is also free to follow its own policies. Kosygin stated that large numbers of Soviet Jews go to Israel but each case is ludged on its own merit.

# Knesset Crushes No-Confidence In Government Motion Over Police-Black Panther Clash

JERUSALEM, May 26 (JTA).—By an 84-4 vote the Knesset yesterday crushed a no-confidence motion scalnat the covernment introduced by the pro-moscow Rukker (Communical) faction over last week's street fighting in Jerusalem between police and israel's self-styled Black Panthers. The motion had the support of only Rakach, the pro-Israel Maki (Communist) faction and half of the two-man Haolam Hazeh faction. Police Minister Shiomo Hillel denied charges of police ordinity and alleged that the moving force behind the Panthers was "New Left extremists." He also accused foreign journalists of paying Panthers to demonstrate. The six hours of rioting erupted last Tuesday when police used force to prevent Panthers from spreading their demonstration beyond the limits approved in their police permit. The Black Egathers are stum youth, mainly of North African and Asian origin, who have been protesting alleged discrimination against Oriental Jews in housing, employment and education. Hillel claimed that a quarter of those arrested were neither Panthers nor of Oriental origin. He said that fact confirmed his belief that New Leftists were behind the demonstrations.
