Israel Awaiting U.S. Assessment Of Egypt-Soviet Friendship Pact

JERUSALEM, June 2 (JTA)—leraelt leaders are waiting for Washington's assessment of the new 15 year treaty of friendship and cooperation signed in Cairo last week by Fresident Anwar Sadat of Egypt and President Nikolai V, Podgorny of the Soviet Union. The officiel American view of the pact is expected to be conveyed to Jerusalem after U.S. officials complete their careful combing of the text for hidden meanings, trends and implications. It appears to some observers, however, that Israel intends to use the Egyptian-Soviet treaty to try to drive a wedge between Washington and Cairo which, up until last week, seemed on the verge of a diplomatic rapprochement. Israell circles believe the Egyptians are busy transmitting urgent messages to the Americans, through the U.S. Charges d'Affaires in Cairo, Donald Bergus, and through other channels, to assure them that Egypt remains wholly sovereign, that its foreign policies have not been changed by the treaty and that the pact itself only formalizes an existing relationship with Moscow. Israeli circles say that if Washington accepts this line it would encourage still closer links between Cairo and Moscow and disappoint Egyptian elements which Israelis believe were "shocked" by Sadat's swift acquiescence to a treaty dictated by Moscow.

The Israeli view, which is apparently being pressed on Washington, is that the Russians "grabbed Sadat by the throat" and forced him to very nearly mortgage Egypt to them for the next 15 years in return for the weapons and training needed by the Army, now Sadat's political mainstay, with the ultimate aim of pushing Israel back to its pre-June, 1967 borders. According to the Israells, the Egyptian-Soviet pact shatters the image, diligently cultivated by Cairo, that Sadat is a strong-willed, right-thinking moderate, eager above all to forge new ties with the U.S. and to reach an honorable peace agreement with Israel. Israel Gallii, a Minister-Without-Portfolio, claimed last night that the Cairo-Moscow pact was no mere formalization of an existing relationship, a line Premier Golda Meir seemed to take in her first reaction to the treaty from Stockholm where she was visiting last week. Gallii claimed that the treaty clause calling for Russian aid in Egyptian military excresses could serve to mask serious Soviet coordination with Egypt in actual military operations. Gallii told a Labor Party meeting at Nes Ziona that it would be an error for Israel to underestimate the significance of the new pact.

Kharkov Jew To Go On Trial June 10; Charged With Illegal Economic Activities

NEW YORK, June 2 (JTA)—Aleksander Gorbach, a 35-year-old Jewish resident of Kharkov, will go on trial around June 10 in Vinnitza, the Utraine, on charges of illegal economic activities under Article 150 of the Utrainian Criminal Code, Jewish sources reported here today. The sources add the real reason he was being tried was that he had applied for a visa to migrate to Israel. Gorbach was one of 39 Jows among them Prof. Mikhail 1, Zand, who were arrested in March in a demonstration in the Moscow offices of Prosecutor General Roman A, Rudenko. Like Zand he went on a hunger strike in prison.

Interfaith Group To Picket For Nixon Intervention On Behalf Of Soviet Jewish Prisoners

NEW YORK, June 2 (JTA) -- In direct defiance of a law which they denounced as "unconstitutional," an interfaith group of Jewish and non-Jewish clergy, including a minister and a nun, plan to picket tomorrow afternoon in front of the United States Mission to the United Nations. They will demand an American administration intervention in the series of trials of Jews currently under way in the USSR. The law, according to police officials, bans demonstrations along First Avenue at the United Nations, and includes the U.S. Mission which is opposite the world body. "We are prepared to be arrested, if necessary," declared Rabbi Steven Riskin, spiritual leader of the Lincoln Square Synagogue and a spokesman for the clergymen, "because we believe that we have both a moral obligation and constitutional right to demand, as American citizens, that our government act decisively when basic human rights are violated in the world. In 1903," Rabbi Riskin continued, "the United States government protested vigorously against the Czarist pogroms in Kishinev. Today, with anti-Semitic trials under the new Russian Czars, our government must act just as strongly." Rabbi Riskin characterized the State Department announcement issued last week on the Riga trials as "too vague." (See separate story) Part of the demands of the interfaith group is also for regular Voice of America radio broadcasts to Russian Jews in Hebrew and Yiddigh. Rabbi Riskin pointed out that much smaller ethnic groups than the Jews in the USSR -- Estonians and Latvians -- receive programing in their own languages. The VOA last week rejected a Congressman's request that it include a Yiddish-language segment because it would require new transmitting facilities that would cost some \$2.5 million.

Strike By Israel Bond Organization Employes in 20th Day; Mediation Continues

NEW YORK, June 2 (JTA)—The strike by 500 employes against the Israel Bond Organization entered its 20th day today with no signs of progress toward a settlement. The two sides continued to meet however under the aegis of the New York State Mediation Service. Meetings were held yesterday and last Friday. Another meeting is scheduled to be held tomorrow. A spekesman for Local 1707 of the Community and Social Agency Employes, AFL-Clo, told the Jewish Telegraphic Agency today that many unions which purchase Israel Bonds have cancelled participation in Bond functions and have threatened to withhold further purchases until the strike is settled. A spokesman for the Bond Organization conceded that it has received communications from some unions. "expressing interest in a settlement and asking for details and information" about negotiations. The spokesman told the JTA that he knew of only three union locals that indicated they would withhold Israel Bond purchases. On the other hand, he said, at least six unions, whose names he declined to identify, have made new purchases of Israel Bonds since the strike began on May 14.

The Bond Organization and the union spokesmen both referred to a May 27 letter from Emil Mazy, secretary-treasurer of the United Automobile Workers Union in Defroit, to Leo Bernstein, executive

vice-president of the Israel Bond Organization, indicating that the UAW was deeply disturbed by the lack of progress in negotiations. The letter noted that the UAW holds \$785,000 worth of Israel Bonds and purchases them because it supports Israel and has close relations with Histadrut, Israel's Inbor federation. The Israel Bond Organization spokesman said that receipts from Bond sales during the last two weeks of May were 50 percent higher than in the corresponding period last year. A spokesman for Local 1707 told the JTA reporter that he had letters and telegrams from more than a half occen unions and locals interatening to withhold Bond purchases or implying that they would take such action if the strike isn't settled, and read portions of these letters during his telephone interview with the JTA. The spokesman said Bond sales functions were cancelled by the Bakery Workers Union; the Laborers International Union of North America, District Council of Western Pennsylvania in Pittsburgh; the Cleveland AFL-Clo; the Dade County (Fla.) AFL-Clo Council; Fruithandlers Union Local 371 in Westport, Conn. and the International Jewelry Workers Union.

The union spokesman claimed there were "many other" unions that cancelled Bond sales functions. He said "hundrede" of letters and tolograms supporting the strike were sent by various unions all over the country to Bernstein. Meanwhile, the coordinating committee of the Labor Zionis Howement expressed "deep regret" over the apparent breakdown in negotiations. It urged both parties "to meet together around the negotiating table without further delay and to negotiate in good faith without leave together around the negotiating table without further delay and to negotiate in good faith without leave until agreement is reached on a new contract." The committee, representing the United Labor Zion-ists-Poale Zion, Farband-Labor Zionist Order, Ploneer Women and Habonim, stated, "We cannot look upon this as-'an ordinary labor-management dispute since the vital interests of Israel arrowlved."

An IBO spokesman said, following yesterday's mediation session that he was "hopeful" of a settlement but conceded that the mediation sessions so far have not gotten down to specific issues. He said "'progress" was visible but only "in a vague way." The union spokesman blaimed that there was "no movement" because the IBO was sticking to its "counter-demands" and was refusing to negotiate a new contract.

State Department Concerned Over Trials Of Jews In Soviet Union

WASHINGTON. June 2 (JTA).—The State Department has expressed concern with the continuing secret trials of Jews in the Soviet Union and deplored the three-previous secret trials - the two in Leningrad and the one in Riga - as deprivations of fundamental human rights. Charles Bray, Department spokesman, issued a statement several days ago declaring that "there is great interest among Americans in these trials which have not been opened to any impartial forum of observers." Referring to the Riga trial which ended last Thursday in which four Jews were given 1-3 year sentences at "strict labor," Bray stated that "it would appear that the defendants were tried for actions which are not even considered a crime in most countries. We trust that the Soviet government realizes that Americans of every political persuasion and religious belief deplore the persecution of people simply for studying a foreign language, in this case, Hebrew, and for running materials off on a minegraph machine." Bray termed these trials abhorrent for deuying the Soviet Jews the right "to freely leave any country and to travel or reside abroad in any country of their obstee," for the denial of any contrial, and persecution of people for their beliefs. "We deeply regret," Bray stated, "these deprivations of fundamental human rights, rights which should not be in question anywhere in the second half of the 20th century."

WIZO Supports Plea Of 12 Jewish Soviet Mothers To Let Their Children Go

TEL AVIV, June 2 (JTA).—The Women's International Zionist Organization (Wizo) has joined in support of 12 Jewish mothers in the Soviet Union who have petitioned Soviet authorities to allow their children to go to Israel even if they must remain behind. On the occasion of International Childrens Day, marked yesterday, Wizo's Executive President Raya Jagblum asked the Finnish Ambassador here to convey a message to the Soviet government. Finland handles Soviet affairs in Israel in the absence of diplomatic relations between Jerusalem and Moscow. The Finnish Ambassador, however, turned down a request to meet with a Wizo delegation. Mrs. Jagblum sent the message to him in a letter. It appeals to the Soviet government to permit 15 Jewish children and their families to emigrate to Israel "their homeland, according to the request of their mothers who are anxious about the future of their confidered who are brought up to hate Israel and their own people."

Measures Being Taken To Prevent Terrorist Activities On Anniversary Of Six-Day War

JERUSALEM, June 2. (ITA)—Israeli security forces are taking special precautionary measures to prevent Arab terrorist activities and sabotage on June 5, the fourth anniversary of the Six-Day War. The anniversary has been the occasion in past years for increased terrorist activity and agitation, although it has been declining in intensity from year to year. In past years, Israeli forces have successfully intercepted Arab gangs bent on sabotage and terror on the war anniversary. Some agitation has already been noted on the West Bank. Several dozen leaflets exhorting Palestinians to "stand firm in the face of the enemy" were found today in Nablus and Bethlehem. They were signed by the Jordanian Communist Party and the Popular Front for the Liberation of Palestine. Incidents have increased meanwhile along the Jordanian territory recently. Jordanian Army patrols wore seen in the area paperatly trying to prevent the guerrillas from acting against Israel. Israeli security forces are guarding against some attempted spectacular act along the borders or in Israel proper by which the terrorists may hope to regain some of their prestige with the Arab population, shattered by last September's civil war in Jordan.

Jewish Women's Group Strengthening Program To Aid Senior Citizens

NEW YORK, June 2 (JTA) -- The National Council of Jewish Women announced today that it would strengthen its existing senior citizen aid programs in anticipation of Federal budget cuts that threaten the funding of the Administration on Aging. Mrs. Earl Marvin, president of the service organization urged volunteer organizations to take up the lag between social need and legislative action.

Prayer Vigil For Soviet Jewry Slated For Washington

NEW YORK, June 2 (JTA) -- Prayer vigils for Soviet Jewry will be held in several cities in the United States from II a.m. to I p.m. on Thursday, it was announced today by Rabbi Solomon J. Sharfman, president of the Synagogue Council of America. Major attention will be focussed on a prayer vigil in the nation's capital, which will be attended by leading religious personalities of the Jewish, Protestant and Catholic faiths. The official call for the prayer vigil was issued by the Synagogue Council of America, in cooperation with the American Jewish Conference on Soviet Jewry. In issuing the call. Rabbi Sharfman said that it is the purpose of the vigils "to generate a mighty chorus by decent men overwhere demanding of the Soviet authorities 'stop the trials', release the prisoners."
The vigile will also serve to tell the Soviet authorities "that we will not rest nor will we be silent while their ruthless policy of repression continues." Rabbi Shariman stated. "It is also the purpose of these vigils to ask of our own government to raise the issue of the cultural and religious genocide taking place in the Soviet Union on a far more serious level than it has been raised thus far." Among the participants in the Washington vigil will be representatives of the National Council of Churches of Christ, the Bishops' Committee on Ecumenical Affairs of the National Conference of Catholic Bishops in the U.S., the National Committee of Black Churchmen and Rabbi Abraham Joshua Heschel. Professor of Jewish Ethics and Mysticism at the Jewish Theological Seminary and Rabbi Sharfman, In addition, a major speaker at the Washington vigil will be Rivka Aleksandrovich, who will bring a dramatic message from the Soviet Union about her daughter. Most Canadians Believe Mideast Peace Possible, According To Gallup Poll

MONTREAL, June 2 (JTA).—Most Canadians believe a Middle East peace is possible, but a substantial number have no opinion on the matter, according to the Gallup Poll of Canada. A new study by the organization indicates that 44 percent of the populace believes peace is possible, 30 percent does not and 26 percent cannot say. Asked what concessions, if any, Israel should make, 27 percent of the questioned said she should return most of the occupied Arab territories, retaining only Jerusalem and the Gaze-Strip; 18 percent said she should return only a small portion of the territories or none at all; 16 percent said she should give back all of the captured land, and 39 percent were undecided.

Maryland's Only Kosher Poultry Processing Plant To Remain Closed Pending Hearing

BALTIMORE, June 2 (JTA) -- Maryland's only kosher poultry slaughter and processing plant will remain closed pending a hearing on June 9. Pen-Mar Poultry, Inc. located in this city, was closed down last week because of what Dr. Robert J. I ee, chief of Maryland's meat and poultry inspection division, termed as "gross unsanitary operative conditions" in the plant. Dr. Lee said the products prepared were subjected to bacteria, with insect and vermin control almost completely lacking. Rabbi Leopold Fischer, the plant's ritual slaughterer and spiritual leader of Congregation Zera Israel here, denied the charges and attributed any shortcomings to the upkeep of outmoded machinery. He told the Jewish Telegraphic Agency that "Our chickens are clean," He further stated that the 1,500 families who normally get their poultry from Pen-Mar are now being forced to import chickens from New Jersey and New York. According to Dr. Lee, state inspectors have been working closely with the Pen-Mar management since the beginning of the year in an effort to upgrade the facilities, but have been met with "extreme verbal abuse" by the staff. He further stated that "Not once have they (Pen-Mar) asked to have inspection reinstated since its suspension on May 25." By law, state inspection is required to maintain operations. Rabbi Fischer confirmed that friction exists between management and State inspectors. 301-764-6781

Eban And Cameroons President Discuss Relations Between Two Nations

JERUSALEM, June 2 (JTA)—Foreign Minister Abba Eban, currently on a tour of eight African nations, had a frank talk with President Ahmadu Ahldjo of the Cameroons in the capital of that West African republic last night. According to the Israeli pool correspondent accompanying Eban, President Ahldjo suggested that Israel should not attach too much importance to the anti-Israel votes by his nation in the United Nations and at international conferences. Ahldjo said those votes were based on inter-African political considerations and were of no significance. He implied, however, that he would not be able to do much about. It in the future and expressed the hope that the issue wold not affect Israeli development projects in the Cameroons. Eban reportedly replied that Israel did not make its aid projects dependent on the recipient nation's politics. Mrs. Meir Accorded Enthusiastic Welcome During Helsinki Visit

LONDON, June 2 (JTA):—Finland's Jewish community, which numbers only 1,300, gave Premier Colda Mair for Israel an enthusiastic welcome when she visited Helsinki last week, according to S. Levenberg, British representative of the Jewish Agency and chairman of the World Jewish Congress' International affairs commission. Levenberg was in the Finnish capital as a Labor Zionist delegate to the conference of the Socialist International which was addressed by Mrs. Meir. He reported on his return here that the Israell leader was one of the "Centiers of attraction" at the conference and at various official functions. She addressed representatives of the Jewish community in Yiddish and English at a reception in her honor. Levenberg said the Finnish press devoted a great deal of space to Mrs. Meir's visit despite Finnad's "Special Position" vis-a-vis the Soviet Union.

West Bank Magazine To Deal With Topics Of Interest To Women

JERUSALEM, June 2 (JTA)— Women's Lib is coming to the occupied Jordanian West Bank—if only in print. A new bimonthly newspaper devoted mainly to social and educational matters of interest to women will make its first appearance near week's end. It will be-called "Fatata Falastin," or "The Palestinian Woman." Two other Arab newspapers are published regularly in the West Bank. The nearly-three-year-old El Kuds ("Jerusalem"), which is vehemently anti-lerzed and is also read by many Israeli Arabs, claims a circulation of 18,000. Al Bashir ("The Messenger") is published weekly.

Koch Assalls Vergolis As Soviet 'House Jew' For Denying Repression Of Jewish People WASHINGTON, Julie 2 (1713)—Rep. Edward I, Koch has attacked Aron Vergolis, Editor-in-Chief of Sovietisch Heimland, the only Yiddish publication in the Soviet Union, as the Soviet 'More Jew's For denying the existence of Soviet anti-Semitism and Soviet repression of Jewish cultural and religious life. In a letter sent to Vergelis at his Moscow home, the New-York Democrat wrote: "I was not astonished by your statement which appeared in the New York Times of May 21 defending Soviet follow toward the Jews. I can understand why you do what you do. It is without mallos that I say you are the house Jews." Vergelis, in his article which appeared in the Op-Ed page of the NJ: Times, also denied that the Soviet Union refused emigration visas to those who sought them; and stated that Jewlish authors published many books each year, that there were many Yiddish theatrical companies in Soviet cities, and that Yiddish songs were recorded and widely distributed among the Jewish people.

In his letter, sent May 27 and released publicly today, Koch recalled that on his recent trip to the Soviet Union, Vergelis had told him that Jewish youths were not permitted to attend all-day. Yiddish schools after the regular school day because "it would be divisive if Jewswent to Jewish schools." Yet, Koch noted, "it is apparently not divisive for Uzbeks to attend their own schools." The letter continued, "When) I asked you why the Soviet Union refuses to permit Jews who wish to emigrate to do so, your reply was that anyone can freely leave the Soviet Union. I said," Koch noted, "Mr. Vergelis, that is simply not true." Koch contrasted Vergelis' "complacent attitude" towards his fellow Jews with his experiences at the Moscow Synagogue where he attended services. When the congregants learned he was a visiting American Congressman, he wrote, they pleaded in Yiddish with tears streaming down their cheeks, "Help us, help us." All round me, he added, "people whispered, Yerushalayim, Yerushalayim, we want to go to Yerushalayim, help us." "Koch concluded by writing, "Mr. Vergelis, God will forgive you because the flesh is weak and He knows it." Many of your brethren whose lot you have made even more difficult, will not."

Racist Group Charges Jews With Ritual Murder Of Two Akron Girls

CLEVELAND, June 2 (JTA).—The National Socialist White Peoples' Party has charged Jews with "ritual murder" in the recent deaths of two little gris in Akron, Ohio, Bernice Green reported in the latest issue of the Cleveland Jewish News. The charge, which Robert Silverman, chairman of the Community Relations Committee of the Jewish Community Federation, termed the "most victous ever," is the latest in a month-long series of taged hate messages carried over a local phone line. Persons calling the number are usually bombarded with anti-Semitic, anti-Negro and anti-Catholic hate messages. This week's message, charging "ritual murder," states that "Jews must have the blood of Christian children for their rites?". It also denounces Ben Maidenburg, the publisher of Akron's daily mass circulation newspaper "Beacon Journal," and refers to it as the "Akron Beacon Jew Journal." (According to the authoritative Editor and Publisher Year Book for 1970, he Beacon Journal has a daily circulation of 175,917 and a Sunday circulation of 205,623 in a population area of some 300,000. The president of the newspaper is John S. Knight.) Listeners are asked to write to a post office aumber to receive literature on "Jewish ritual murders." Despite the victous and irrational attacks, Silverman said, "in the interest of free speech, authorities cannot move against the disseminators of the propaganda."

However, he added, the Community Relations Committee has been in touch with Federal authorities, local police, the Mayor's Community Relations Board and the Ohio Bell Telephone Co, and "we are continuing to pursue every means at our disposal to halt this recording," Miss Green quotes Robert K, Huston, attorney for the Ohio Bell Telephone Co, as saying the company's hands were tied, and it was unable to take action against the recordings because of restrictions of the Federal Communications Commission. 'Basically,' he said, 'four position is that we are in no position to censor what people use the telephone for.'' The company must provide automatic answering and playback devices for the public, with the understanding that all subscribers will state their name and address on the taped recording. Since the messages fulfill these requirements, Huston said, "iff we attempted to censor the messages, we would be putting ourselves above and beyond the courts," He told Miss Green that there were no "legal precedents" to go on and "this leaves us with a very sensitive area, and we recognize it." He added the police might act if there were a clear indication that there was incitement to rlot. The telephone company reported that word of the latest message had "gotten out" to the Jewish community and calls to the "hate" number kept the line continually busy.

Soviet Jewry Committee Launches Action Programs Including Ecumenical March For Freedom

HEMPSTEAD, L.I., June 2 (JTA)—The Long Island Committee for Soviet Jewry announced a series of new "action programs" for Russian Jews today. The group, which recently organized a mass motor-cade and other demonstrations demanding rights for Jews in the USSR, said the future program includes two "Mother's Marchies for Freedom;" the first in the latter part of June and the second next September between Rosh Hashana and Yom Kippur. According to Phillip Kates, president, the Soviet Jewry Committee will embark immediately on a massive petition campaign covering every community in Nassau County. The campaign will be under the chairmanship of Norman Feiden. Signatures will be solicited for a demand that the Soviet government "live up to the covenants incorporated in the Universal Declaration of Human Rights," that it permit observance at the trials of Jowen in Russic and allow Jewswho so wish to emigrate to Israel. Three Long Island Congressmen will deliver the petition personally to Secretary of State William P. Rogers, Kates said. The "Mother's March' will be organized by Mrs. Incz Weisman. Kates said Jewish and non-Jewish mothers "from the grass roots of Nassau County" will join in a demonstration of support for Mrs. Rifka Aleksandrovich whose daughter, Ruth, received a 1-year sentence at the Riga trial last week. "The Mother's March will be coumenical in character and will be led by women leaders of the three major/atiths;" Kates said.
