Jewish, Christian Clerics Urge U.S. To Intervene On Behalf Of Soviet Jews

WASHINGTON, June 3 (JTA).—Christian and Jewish clergymen called on President Nixon and the U.S. government today to intervene more actively with Soviet authorities on behalf of Russian Jews. The olergymen addressed about 500 persons attending a prayer vigil for Soviet Jews at a park three blocks from the White House. The vigil was organized by the Synagogue Council of America in cooperation with the American Jewish Conference on Soviet Jewry. Similar rallies and vigils also took place in Chicago and New York. (See separate New York story). At the Washington vigil, the Rev. Dean Louis, of the United Presbyterian Church, urged Christians in the Soviet Union become more concerned with the fate of their Jewish fellow citizens. He appealed to President Nixon to "use his good offices and intervene" for the release end restoration of full civil rights to Soviet Jews imprisened or facing trial. He also asked the World Council of Churches to "raise this concern with fellow Christians in the Soviet Union."

Rev. Metz Rollins, executive director of the National Committee of Black Churchmen declared that "Nixon has been strangely silent on this issue. He should speak out." Father John F. Hotchkin, executive director of the U.S. Bishops Committee for Ecumenical and Interreligious Affairs of the U.S. Catholic Conference, referred to fellow Christians when he said, "May they not cease to make their voices heard in increasing numbers, may they call for the liberation of their fellow men caught in this captivity." Rabbi Solomon J. Sharfman, president of the Synagogue Council, asked President Nixon to instruct the State Department to "Promptly take vigorous measures to convey to the Soviet authorities this government's outrage at the trials in Leningrad, Riga and Kishinev." Rabbi Sharfman said the issue "has not yet been raised by our government in its contacts with the Soviet Union with the seriousness it deserves." Jews in Chicago boday observed a Prayer Day for Soviet Jews proclaimed by the Chicago Board of Rabbis. They were asked by the rabbis to send messages to all responsible American and Russian officials expressing outrage at the trials of Jews in the USSR.

#### Interfaith Group Pickets U.S. Mission To UN To Demand Firm Aid For Soviet Jews

NEW YORK, June 3 (JTA).—Intervention by the U.S. State Department was credited with preventing the arrest of six rabbis, a Protestant Minister and a Catholic nun who picketed the U.S. Mission to the United Nations today demanding that the U.S. government take a stronger stand on behalf of Soviet Jews. The rabbis, represented by the N.Y. Civil Liberties Union, appeared at Federal Court here this morning to apply for an injunction against a ban on picketing directly in front of Mission headquarters which is adjacent to the U.N. They had been warned by police that they would be arrested if they violated the ban which, the police claimed, stemmed from an international treaty. The judge reserved his decision until next Tuesday. According to Gienn Richier, national coordinator of the Student Struggle for Soviet Jewry, the State Department, which was named in the injunction request, rushed a message to the court saying that it did not object to the close proximity of the pickets to the Mission building and that it recognized no ban. The pickets marched for two hours this afternoon carrying placards demanding "Freedom for the Kishinev 3" and "Why Doesn't The U.S. Speak Out." A large police contingent was present but did not interfere with the pickets.

According to Richter, a representative of Ambassador George Bush, the U.S. representative to the UN. appeared and accepted a document containing inree demands. They were; A firmly worded public statement by President Nixon condemning Soviet treatment of Jews; the inauguration of Yiddish or Hebrew broadcasts on Voice of America programs beamed to the Soviet Union; and government support for bills pending in both houses of Congress for 30,000 emergency visas for Soviet Jews. The pickets said they would return next. Tuesday if there was no response from the government, even if the Federal judge denies their injunction appeal. The eight were: Rev. #### Zand In Letter To-Thant, UN Rights Commission Writes Family In 'Critical Situation'

UNITED NATIONS, N.Y., June 3 (3TA)—Describing himself as "a former citizen of the USSR," Prof. Mikhail I, Zand of Moscow his advised Secretary General Thant and the Human Rights Commission, as well as the Soviet leadership, that he and the other six members of his family "are in a critical situation." Zand, whose attempts to migrate to Israel have been rebuffed by the Soviets since he gave up his Soviet citizenship May 13 and whose visa permit has been postponed for an "indefinite period," made his piea known in a letter delivered to "Sant today by Israeli Ambassador Yosef. Theeab. Zand registred his. "Gateoroical products at commercion with time shameriu and nitegal acids committed toward me and my family," who gave up their apartment and belongings and are being "forcibly detained" and "deprived of every means of subsistence." Zand called the Soviet policy "a crude mockey of elementary human rights and a manifestation of inhumanity on the part of the Ministry of Interior of the USSR, as it is known that I am an invalid and my wife and my mother are sick."

#### Lebanese Delegation Negotiating For Purchase Of Additional Arms From France

PARIS, June 3 (JTA).—A Lebanese delegation headed by the Defense Minister, has been negotiating here for the purchase of additional French arms and modern radar equipment; it was learned today. According to reliable sources, the negotiations have not been concluded and will be resumed in Beirut next mouth. The delegation attended the international Air Show at Le Bourget Airport.

#### Mrs. Meir Concerned 15-Year UAR-USSR Pact Endangers Mideast Arms Balance-

In her initial comment on the treaty in Stockholm last week, Mrs. Meir took the position that it contained nothing new and merely formalized an existing relationship between Egypt and the USSR. Political analysts is Israel however took a graver view of the pact and Mrs. Meir's remarks at the airportlast night indicated that she might now share that view. Asked about the Socialist International Conference in Helsinki which she addressed, Mrs. Meir said she was confident that world's Socialist leaders were, on the whole, Esching-israel. She added, however, "we must wait and sew that they do."

#### Eight Kishinev Jewish Students Ask For Israeli Citizenship Under New Law

JERUSALEM, June 3 (JTA).—Eight Jewish students from Kishinev, in Soviet Moldavia, have sent a leaver to President Zalman Shazar asking for Israell citizenship under a recently adopted amendment to the immigration law under which Jews prevented from coming to Israel can be granted citizenship in absentia. The signers said most of them had been expelled from Russian universities because of their Zionist convictions. "We have learned with great pleasure of the new law and wish to become Israell citizens," they wrote. Nine Jews.gre expected to go on trial in Kishinev on June 2.

#### ADL Delegation Urges Papal Intercession On Behalf Of Soviet Jews

ROME, June 3 (JTA).—Seymour Graubard, national chairman of the Anti-Defamation League of B'nai B'rith, at an audience yesterday with Pope Paul VI, urged papal intercession on behalf of Jews in the Soviet Union. Graubard, with Benjamin R, Epstein, national director of the Anti-Defamation League, headed a delegation of 80 American Jewish leaders, members of the League's Society of Fellows, returning from a "mission to Israel. Graubard expressed his gratitude for the Victana's earlier intervention on behalf of the nine Leningrad Jews sentenced in Dec. Noting that new trials are scheduled and harassment of Soviet Jews is continuing, Graubard told the Pope: "We take the liberty of asking for your continued interest and help. The spiritual prestige and authority of the Holy See will be of tremendous help to these innocent victims." In welcoming the ADL delegation, the Pope reterated the view of the Vatican Council to foster and recommend mutual understanding, respect and "brotherly dialogue." He noted that "we are especially sensitive to all forms of discrimination, which impede fraternal charity among men and offend human dignity."

The Pope also reaffirmed his position against "all discrimination based on race, origin, color, culture, sex or religion," and praised the ADL for its "efforts for creating that climate between Christians and Jews and among all men." The Pope, h wever, refrained from making any statement on the problem of the Soviet Jews and made no reference to the issue of Jerusalem. Last March the Vatican newspaper I/Osservators Romano endorsed e-Plan for the internationalization of Jerusalem which created great concern among many Jewish groups. Bringing greetings to Pope Paul from Jewish communities in America represented by the delegation, Graubard expressed grafification over the progress in the U.S. of the ecumenical efforts of Vatican II. "Interreligious cooperation," he said, "has always held a high priority in the program of the Anti-Defamation League. In the common goal for the brother-hood of mankind, we work closely with our Catholic brothers in the United States. We are greatly heartened by the establishment of the Vatican Office for Catholic-Jewish Relations and by the establishment in our country of a similar office of Catholic bishops." Graubard more that, in the spirit of ecumenism, the delegation had visited a number of Christian Holy Places in Israel, and had observed that these shrines received special, respectful care from Israeli authorities.

# Anti-Semitic, Anti-Zionist Tract Prepared By Novosti Distributed In East Germany

LONDON, June 3 (JTA).—German translations of an anti-Semitic, anti-Zionist pamphlet prepared by Novosti, the Soviet overseas news agency, are being circulated all over East Germany, it was reported here today. The pamphlet is part of a Novosti series dealing with ethnic minorities in the USSR. It includes Yevgeny Yevsayev's "Jewry.—A Tool Of Imperialism" which accuses Jews of aiding the Master in the murder of other Jews; including the Babl Yar massacre. It compares Israeli Premier Golda Meir to Hitler. Novosti, whose dispatches are circulated abroad but not inside the Soviet Union, recently dismissed charges of anti-Semitism in Russia as "ridiculous and grotesque."

# Moscow-Cairo Pact Will Neither Effect Nor Be Effected By Proposed Federation

JERUSALEM, June 3 (JTA).—Foreign Ministry analysts do not believe the new Soviet-Egyptian treaty will affect or be a affected by the projected federation of Egypt with Libya and Syria scheduled to be ratified next Sept. The analysts say the treaty applies only to Egypt and not to its defearation partners and note that the three countries will retain their individual sovereignty, capitals and armount of cross. The federation agreement is not a merger and provides only for consultations between member

countries on foreign policy. After the federation comes into effect in Sept. a treaty such as the one between Cairo and Moscow would require consultation and coordination among the three partners, but would not be precluded, Foreign Ministry sources said. The military aspects of the new pact were stressed yesterdily by President Anwar Sadat in an address to the Egyptian National Assembly. He said the pact, for the first time, provided a long-range basis for Soviet assistance to Egypt including training in the use of modern weapons. "This is what we must adhere to since we believe that the battle will be imposed on us," Sadat said. He added he would not agree to territorial concessions to Israel for the sake of a settlement but stressed that Egypt still hoped for a peaceful solution. Although there was no official reaction to President Nixon's remarks on the Soviet-Egyptian treaty during his Tuesday night press conference, some Israeli newspapers offered their assessments. Nixon had expressed U.S. readiness to rectify an imbalance of power in the Middle East that the new back might create.

The newspapers Davar and Haaretz expressed satisfaction with the President's warning against a new arms race in the Mideast and his commitment "to step up military aid to Israel to prevent the military balance from swinging to the Arabs." Davar remarked, however, that "the lukewarm American reaction to the new friendship treaty stems from an unwillingness to admit openly that it constitutes a diplomatic blow to Washington." Al Hamishmar said, "The two stresses--maintenance of the arms balance and efforts toward a settlement--are characteristic of President Nixon's general grasp of matters, striving for talks with the Soviet Union on a mutual limitation of forces in Europe and for a political settlement in the Middle East, paralleled by efforts to improve relations with China." Hatzofe, referring to rumors of Soviet contacts with Israeli officials, suggested that "The Soviet Union must have an interest in dialogue with Israel as a counter-measure to the United States dialogue with Egypt and other Arab states." The two leading Soviet newspapers, Pravda and Izvestia, sharply criticized U.S. efforts to promote a Mideast settlement and improve relations with Egypt. A front page editorial in Prayda, organ of the Soviet Communist Party, called the Moscow-Cairo pact "a new blow at the plans of international imperialism which is trying to drive a wedge in the relations of the two countries; undermine friendship between them and divide the progressive forces." Izvestia, the government organ, said the only Mideast settlement desired by the U.S. was one that met "its own imperialist ends."

#### U.S. Law Professor Says He Was Denied Right To Attend Trial Of Riga Four

LONDON, June 3 (JTA)—An American law professor with credentials as a civil rights activist, was denied permission by Soviet authorities to attend the trial of four Jews in Riga last week or to visit any of the defendants. Prof. Henry McGee Jr., who teaches criminal law at the University of California, Los Angeles, gave the Jewish Telegraphic Agency an account today of his visit to the Soviet Union between May 22-30 and his fruitless efforts to observe the Riga trial. With obvious disgust, Prof. McGee said "I was scheduled to stay in Riga six days but I stayed only three. After three days my Indourist, guides told me it, would be best for me to leave." McGee said the particularly wanted to see Ruth Aleksandrovich, a 23-year-old nurse who was one of the defendants at the Riga trial. It had a letter from her mother, Mrs. Rivka Aleksandrovich, pleading with him to visit her adughter. But the Soviet authorities were unin/oved, he said. #### Wife Of Prison Warden Kidnaped, Escapes: Police Searching For Kidnapers

TEL AVIV, June 3 (JTA).—Police are searching for the kidnapers of Mrs. Rachel Slonim, wife of the warden of the Tzofia women's prison, who was seized by three persons yesterday but escaped before her husband reported her missing. The kidnapers had demanded the release of five prostitutes held at Tzofia as ransom for Mrs. Slonim. According to the victim's account, she was kidnaped near her home. In Bani Braq white going to the grocery. She said she was taken to Halfa blindfolded and tied. But she managed to get away after her abductors untied her hands and removed the blindfold. #### Son Of Murdered Tunisian Rabbi Says Killer Was A Palestinian

TEL AVIV, June 3 (JTA)—The son of Tunisian Rabbi Matzliah Mazouz who was murdered last January, claimed today that Tunisian authorities concealed the true identity of the killer. Meir Maazouz, himself, a rabhi, who avrived here last night with his family, said he learned from a Jewish eyewitness to the murder that his father's killer was a Palestinian, not a Tunisian described by time surjectives are mentally deranged. The elder Mazouz was fatally shot on his way to the synagogue. His son said the photograph of the alleged murderer published by the authorities was not that of the actual killer. He also said that Tunisian authorities permitted only three of the 20 synagogues in Tunisia to be open during the High Holidays last year.

## Sapir Predicts 5 Million Population By 1980 And Three-Fold Rise in Output Of Goods

JERUSALEM, June 3 (JTA)—Finance Minister Pinhae Sapir predicted last night that Israel would have a population of five million by 1950 and amounced that he has set up a team to work out plans for industrial development that would raise Israel's output of goods to \$15.550 billion compared to the present \$4.550 billion. Addressing the Israel Manufacturers Association, Sapir also urged a moratorium on labor disputes.

### Brooklyn College Administration Seeking Ways To Reduce Jewish-Black Tensions

NEW YORK, June 3 (JTA) -- Dr. John W. Kneller, president of Brooklyn College, assured leaders of the American Jewish Congress this week that he would not hesitate to use an injunction against any militant group on the campus that engaged in violence. The American Jewish Congress group met with Dr. Kneller to express concern over the recent open conflict at Brooklyn College between black and Jewish students. In May several hundred Jewish and black students were involved in a melec shortly after Rubbi Moir Kahane chairman of the Jewish Defense League, delivered a speech at the Student Center on the plight of Soviet Jewry. Brooklyn College obtained an injunction barring Rabbi Kahane and JDL-non-student members from the college campus. Dr. Kneller disclosed that kosher kitchen facilities would be made available to serve the needs of the large Ortholox student body at the college, leaders of the AJCongress' Metropolitan Council reported. Of a total student body of some 28,000 in the day and evening sessions, some 18,000 are Jewish. Of these 18,000 some 5,000 are Orthodox. Dr. Kneller also said that a representative intergroup council would be created to reduce Negro-Jewish tensions on the campus. The AJCongress group expressed concern over the extent of "separatism" among the students on the campus. They were told by Dr. Kneller that Brooklyn College denied the right of any group to declare parts of the campus or student activity buildings offbounds to any other group. Dr. Kneller told the AJCongress leaders that the college sought to be responsive to the needs of all groups on campus and that it felt "a responsibility to the community as well as to its students to advance the goals of quality education for all."

#### Family Agency Reports Acute Shortage Of Jewish Infants For Adoption

PATERSON, N.J., June 3 (JTA)—The shortage of white Jewish infants available for adoption has become so acute that while the Jewish Family and Children's Service here continues to have an adoption service, it is virtually inoperative. But the number of childless couples seeking to adopt children remains substantial, according to Abraham Davis, executive director of the agency. Currently, he said, the JFCS has a waiting list of at least 20 such couples. He said that reports were correct that the overall lack of available white children for adoption was due to birth control, abortions and the growing determination of unwed mothers to keep their infants. According to the newsletter of the Jewish Federation of North Jersey, the problem for the JFCS is aggravated by the agency's policy of accepting for adoption only Jewish infants, those, that is, with a Jewish mother, regardless of the father's background.

In 1968, Davis said, ten infants were placed and seven last year. Indications are that the agency will place only two infants this year, he said. Discussing the fact that more unmarried mothers wan to keep their babies, he said there was now less stigma attached to an unmarried mother raising her child, with "a marked decrease in community and social pressure," which makes it "much easier for the mother to care for her child." At the same time, he pointed out, there is an ever-growing list of hard-to-place babies—those who are black, or interracial or handicapped. He cited an estimate by the federal Children's Bureau that 40,000 black children await adoption plus another 50,000 children, who are older and who have physical handicaps, and other problems.

## Palestinian Arab Leader, Banned From Travel In U.S., Admitted Officially In Canada

TORONTO, June 3 (JTA).—Dr. Ibrahim Aben, a leading member of the Palestine Liberation Front, who was banned from all travel in the United States, has received personal approval from Canada's Minister of External Affairs Mitchell Sharp, to visit this country, it was reliably learned here today. Dr. Aben's admission to Canada was sponsored by George Haggar, president of the Canadian-Arab-Federation who was deported from the U.S. two years ago. Dr. Aben was reportedly deel admission to the U.S. three weeks ago but, according to Haggar, "everybody in Ottawa was very cooperative." He said he was told that Sharp personally gave official permission for the admission. Last week Sharp was attacked by delegates attending the Federation's convention because they contended he represents a constituency in Toronto with a large Jewish population and, therefore, according to the delegates, cannot be objective in Arab affairs. They demanded Charp rosign. Dr. Aben, addressing a student meeting here yestorday, stated that any move by Egypt to reach a peace agreement with Israel will be viewed as an act of "capitulation" and will be fought by the PLF.

#### Arthur D. Morse, Author Of 'While Six Million Died.' Killed In Auto Accident

LONDON, June 3 (3TA)—Arthur D. Morse, author of the best-selling book "While Six Million Died?" was killed yesterday in an automobile accident in Yugoslavia. He was 50. Morse, who had homes in Scarsdale, N.Y. and in Italy, was executive director of the International Broadcast Institute. He was visiting Yugoslavia to attend an international television symposium. Morse was the author of several books on major American social issues and as a producer-writer for CBS produced television documentaries on those subjects. But his fame rested on "While Six Million Died," subtitled, "A Chronicle of American Apathy," published in 1967, which accused the Roosevial administration in World War II of failing to act when there was a possibility of rescuing substantial numbers of Jews from the Nazi holocaust.

One of the principle bases for the charges in Morse's book was a memorandum sent to President Beconcrolt in 1024 by Georetury of Une 'Ireasury Interna Morgenthan Ir. outletstage the Cheparturant for having delayed for five months a proposal to negotiate with the Nazis for the release of thousands of Jews in France and Rumania, Morse contended in his book that as early as August, 1942, a Geneva representative of the World Jewish Congress reported through the U.S. Consulate reliable information from a German source that Hiller had ordered the extermination of all Jews in Europe. The State Department in Washington did not transmit this message to American Jewish leaders. American officials were said to have regarded the report as "fantastic" and to have concluded that even if true the 'U.S. could not have assisted the victims, Morse, the son of Dr. and Mrs. Frank Moskowitz, was born 'an Brooklyn, N.Y., and was educated at the University of Virginia. He served as an officer in the U.S. Navy during World War II.
