Court Gives Government Another Week To Give JDL Copies Of Wiretop Transcript

NEW YORK, June 27 (JTA)—The government has been given another week—until next Friday—to comply with an order by the United States District Court, Brooklyn, to provide 10 Jewish Defense League leaders charged with gun conspiracy the transcripts of wiretaps made on their phones without a court order. Judge Jack Weinstein agreed to the government request last Friday after the court had given the government a week to produce the wiretap transcripts when the case was first heard on June 18. In an unusual move, U.S. Attorney Edward Neaher personally asked Judge Weinstein for the postponement. Neaher said Attorney General John N. Mitchell has been too busy with the controversy over the publication of the secret Pentagon report on the Victnam war to consider the transcripts and decide whether to comply with the original deadline. Sources close to the case said Neaher's personal appearance and request for a delay despite reports that the Justice Department would, consistent vith earlier policy, not turn over the transcripts, indicated a battle between the Justice Department's office in Washington and the U.S. Attorney's office in New York. The sources said that while the Justice Department does not want to turn over the transcripts and is willing to wait for the Supreme Court ruling next summer on the legality of "national security" wiretaps not authorized by court order, the U.S. Attorney is so anxious to prosecute the JUL it is willing to hand over the logs.

Sources close to the case said the seeming discrepancy between Neaher's requested delay and the anxiousness to prosecute was motivated by the feeling that a week's delay would provide Neaher with more forceful arguments against the Justice Department in Washington. The government has argued that "overriding considerations" of national security permit the President to "engage in intelligence-gathering operations which he deems necessary for the conduct of foreign affairs." Judge Weinstein agreed to the week's delay to "avoid a confrontation between the Judiciary and the Executive." According to the government brief the wire tap was not based on internal national security but that "such surveillance was deemed necessary and essential to protect the nation and its offices against hostile acts of a foreign power and to obtain information against foreign intelligence activities deemed essential to the security of the United States." There was no identification of the foreign power nor the nature of "hostile acts" in the government brief which was first presented to the U.S. District Court on June 18.

Foreign Ministry Denies Reports Israel, USSR Talk On Resumption Of Relations

JERUSALEM, June 27 (JTA).—The Foreign Ministry today emphatically denied press reports about talks between Israei and the Soviet Union on a possible resumption of diplomatic relations between the two countries. A senior official said there "have been no such talks and there are none now." On the other hand, the Foreign Ministry readily agrees that such relations would be most destrable. Foreign Minister Abba Eban said at a news conference on June 22 that the time was ripe for it. Israel would be anxious to have an ambassador in Moscow for a wide variety of reasons, not the least being a more tangible link with Soviet Jewry. But all hints Israel has so far made have been left unanswered, Foreign Ministry officials say. At today's Cabinet meeting 'the "publications around the Israeli donation of. food and blankets to the Organization of African Unity were mentioned," it was learned, but the subject as such was not discussed. Officials afterwards stated that the Israeli offer has not yet been withdrawn, nor has a deadline been set for its lapse in case the Africans persist in their refusal to take it up. "It is up to the government to decide whether the offer should be declared lapied," officials said. It is to be recalled, however, that the donation itself was decided by officials and not at Cabine level.

ADL Chairman Says Charge Of 'Informer' Relic Of Medieval Times

"ATLANTA, June 27 (JTA)—The chairman of the B'nai B'rith's Anti-Diefamation League repiled forcefully today to Jewish groups which criticized the defense agency recently for "informing" on members
of the militant Jewish Defense League to the FBI. Seymour Graubard, addressing the annual plenary
meeting of the National Jewish Community Relations Advisory Council of which the ADL is a constituent
said the charges of "informer" raised "serious questions of principle." He termed the precept that
Jews should not "inform" on other Jews a relic of medieval times wheil Jews "were universally the victimes of anti-Semitism" and "the State was the enemy of the Jew." Its epilication to a Jewish community in the U.S., he added "suggests there is a similarity" between the American government and medieval
regimes, a "comparison all of us reject out of hand." Graubard asked if the JDL's "vivolent activities"
had been the work of non-Jewish groups, "would there be any question of our responsibility to respond
to inquiries by a government agency about them? Are there separate criteria for Jews and non-Jews?"
Grubard said the ADL was criticized for having responded to an FBI request for information about the
JDL., He said the information it supplied was "inconsequential." It merely confirmed the idonity of
three local JDL leaders in the Philadelphia area who had already been so designated in newspaper stories.

Knesset Releases \$31.5 Million in Frozen Funds For War On Poverty

JERUSALEM, June 27 (JTA).—The Knesset Finance Committee took an Important step in the war on powerly today by authorizing the relaces of \$31.5 million in frozen development budget funds to be used mainly to help the poor in Israeli ottles and towns and to provide better housing for young couples with large families. The committee recommit ded further that the government find additional funds to apply toward solving the twin problems of poverty and the shoringe of housing. Absorption Minister Nathan Peled addressed himself to those problems in a radio interview and replied to critics who charged discrimination against finningrants of Ortental origin. Peled, a member of Mapam, said all immigrants

were entitled to the same assistance and benefits regardless of their countries of origin. He said the size of apartments allocated to newcomers was determined by the size of the families only and by no other criteria. Peled said that most housing aid to immigrants was in the form of mertgages which were repaid to the State after a number of years.

Peled conceded that there were serious social problems in Israel. "The Black Panthers have given expression to a problem that has always existed," he said, referring to the militant Jerusalem slum youths who have been demonstrating sealest proverty and squalid living conditions. Peled agreed that social problems deserved high priority and admitted that mistakes have been made in the past such as spending far foo much on public buildings while neglecting the housing needs of large families. Police meanwhile are investigating a fire in the Musrara slums last Thursday evening that destroyed a shack used by the Black Panthers for their headquarters. A police spokesman skid the investigation was searching for evidence of arson and promised a report "in the next few days." Zand in Israel Says it is A Dream Come True; Will Teach At Bar-lian University

TEL AVIV. June 27 (JTA)—A breathless Mikhail Zand arrived here by plane Thursday night with a group of other Russlan Jews from Vienna and said over and over again "I can hard!) believe ti—my dream has come true." He was accompanied by six members of his family—his wife and two children, his mother; his sister and his sister's daughter. The Russlan Jewish Orientalist scholar had undergone unusual mistreatment even for Soviet Jews seeking to leave for Israel, including a suspension of his visa on the eve of a scheduled departure. Academic groups in the United States and Europe had appealed to Soviet alundrities on his behalf and he was again given exit documents earlier in the week. Speaking to reporters in good Hebrew, Dr. Zand, who will be a lecturer at Bar-lan University, said: "Is it true? This morning I was still in Moscow and now I am at home, and allve." He told reporters of his experiences in Soviet jails, of Ill treatment, of his hunger strike and efforts by his Russlan jailers to feed him forcibly. After he was dismissed from his job, he said, he was benned from publishing any research studies, But, he added, "I am here and I feel good." He expressed the opinion that the best way to help Jews still in Russia was arousal of public opinion in their behalf.

Pincus Urges Jewish Communities To Give Top Priority To Jewish Education

JERUSALEM, June 27 (JTA).—Jewish Agency chairman Louis Pincus urged Jewish communities abroad to give top priority to Jewish education. Addressing a meeting of the Zionist General Council, Pincus said "Whereas previously the construction of hospitals or old-age homes may have occupied pride of place, today it belongs to Jewish education." He said that equal emphasis should be given to the content of Jewish education and how to maintain the unique status of Judalem in a multi-cultural society. Pincus said study of the Hebrew language was of major importance in this respect. However, he added, Jewish education must also place Israel in the center of the Jewish people and Jews must regard israel as the focus of Jewish historic continuity and part of their identity. Jewish education, he concluded, must be based on the eternal values of the Jewish people as well as all that is good and beautiful in the cultures of other nations.

Radoi Emanuel Rackman, a member of the Jewish Agency executive in New York, proposed that the World Zionist Organization establish a "think tank" to develop a four-point program of action. His points were: a reconstitution of Jewish life abroad, using among other things the mass communications media; subsidies for Jewish camps that are "truly Jewish in character" and for free Jewish universities and Jewish communes; Zionist leadership in Jewish day schools throughout the United States; the recasting of Jewish textbooks to free them from the East European heritage and adapt them to the real experience of the diaspora. The Board of Governors of the reconstituted Jewish Agency held its first meeting in Jerusalem Friday and decided to convene three times a year. The next meeting was scheduled for the end of August. It was also decided to convene the next session of the Jewish Agency's Assembly in Dec., 1972. The Jewish Agency Executive was authorized to handle all current issues between formal meetings of the Board of Governors and the General Assembly.

Roiza Palatnik Sentenced To Two Years in Detention Camp; Denies All Charges

NEW YORK, June 27 (JTA)—Jewish librarian Roiza Palatulk was sentenced Thursday to two years in a regular detention camp, Jewish sources here reported. They said the female prosecutor, surnamed Tipunova, summed up for an hour and a haif, calling Miss Palatulk a "traitor," influenced by "Zionist propaganda," who had engaged in "very dangerous" activities, having distributed "anti-Soviet materials" as a member of an "dieological front" that had made use of the nature of her bob to further its designs, in her 40-minute defense, Miss Palatulk, who was 38 last Wedneeday, denied the charges and said the trials of Soviet Jews were meant to intimidate Jews into relinquishing their attempts to migrate to Israel. She had not been influenced by "Zionist propaganda," she said, but by her own conscience, and would remain "strong and dignifiedd" so as no to be down her fellow Jews. "I subved myself the pleasure to think, which is still forbidden in the Soviet Union nowadays," she stated. The three judges deliberated five hours before rendering their decision. Relatives of Miss Palatulk called out; "We are with you, Roiza. All the Jewish people are with you. We will meet in Israel." Officers of the KGB (secret police) evicted the relatives from the courtroom for their outburst, the sources said.

Cabinet Approves National Five Year Sign Clearance Program

JERUSALEM, June 27 (57A)—Spurred by recent demonstrations by slum dwellers, the Cabinet today took steps to solve the problem of squalld living conditions in Israel's major cities and towns. It approved a five year national slum clearance program, the details of which will be argumed in the Knesset tomorrow by Housing Minister Zeev Sharef. It also approved a preliminary anjouncement by the Ministry to designate the run-down Nahlaot quarter of Jerusalem a slum rehabilitation area.

Kollek Charges Mrs. Meir, Pincus Appeasing Black Panthers

JERUSALEM, June 27 (JTA)—Mayor Teddy Kollek today accused Premier Golda Meir and Jewish Agency chairman Louis Pincus of, in effect, bending over backwards to oppease the militant Black Panters after having ignored for years the problems of poverty that gave rise to Panther agitation. Kollek specifically disapproved of the interviews Mrs. Meir and Pincus recently granted spokesmen for the disaffected Jerusalem slum youths. He sald that when Panther leader Eddie Malka was asked to come for a job interview, the latter checked his calendar and said he couldn't make it because he had to see several Knesset members and Cabinter ministers. Kollek assailed Pincus and the Jewish Agere leader-ship for allegedly ignoring Jerusalem's social problems until now. "Far. Pincus caudenly ulscovered that there are social problems in the city," he said. "Two-and-a-half years ago when I spoke at the Conference on Human Needs, I said that social problems in the cities are most acute because of the contrast between wealth and poverty. The great brains of the Jewish Agency argued me out of court. Now Mr. Pincus thiaks he will solve the problem by seeing a Panther;" Kollek said.

Jewish Anti-Poverty Official Charges Jews Excluded From Participation in Programs

NEW YORK, June 27 (JTA)—A Jewish anti-poverty official charged here that poor New York Jews were "systematically denied participation" in city poverty programs except in the Crown Heights section of Brooklyn. The charge was made Friday at a hearing by a House subcommittee on poverty and manpower by S. Elly Rosen, speaking for the New York Association of Jewish Community, Anti-Poverty and Municipal Employes., He also told the Congressmen that the city's anti-poverty agencies were formenting ethnic conflict between Blacks and Jews. He said poor Jews had been "forcibly prevented" from voting in elections for community corporations which, in 26 officially-designated poverty areas, serve as channels for allocating federal and city funds for anti-poverty projects. Asked who barred Jews from such voting, as well as allegedly beating and otherwise abusing them, Rosen replied that it was usually Blacks who, he said, controlled most of the anti-poverty programs in New York City. Asserting that 800,000 Jews in New York City live below the poverty line, he said that "the indignities suffered by the poor Jew in this city are somrous, horrendous and growing." Government To Withhold Funds From Black Group Until Anti-Semitism Disproved

WASHINGTON, June 27 (5TA)—The Blackman's Development Center, run by the Blackman's Volunteer Army of Liberation, will not get a \$197,847 government training grant until an administrative audit proves that its director, Col. Hassan Jeru-Ahmed, is not an anti-Semite and that the funds will not be used to breed bigotry. Charges to that effect have been leveled against the Center by the Anti-Defamation League of B'nal B'rith and by Rep. Robert M, Glaimo, Democrat of Connecticut. Gianno said last week that as a member of the District of Columbia Appropriations subcommittee, he planned to press for a General Accounting Office audit of the Center's operations and a "high-level review" of federal funding, Jeru-Ahmed responded with a \$10 million slander-and-libel suit, but said he welcomed an audit and has repudiated 1967 statements that led to the charges of anti-Semitism against him. Peace Committee Says Israel Fully Committed To Negotiate With Arabs

BRUSSELS, June 27 (JTA)—A 20-member delegation of the "Committee for a negotiated peace between Israel and the Arab states" returned from a visit to Israel today fully committed to Israel's position with regard to peace talks and the nature of a Middle East settlement. The delegation was headed by Henri Rolin, a Socialist Minister, and included ten leading members of Belgium's parliament. NCRAC Leaders Warn Jewish Community Net To Become Isolated From Social Issues

ATLANYA, June 27 (JTA).—Two leaders of the National Jewish Community Relations Advisory, Council warned the organized American Jewish community today not to allow the "priority concerns" of farned and Soviet Jewry to jeolate it from the grave social problems confronting America. The warning was contained in addressed by Albeit E. Arent of Washington, D.C., newly re-elected chairman of the NCRAC, and his immediate prolecesor, Jordan C. Band, to 250 representatives of the Council's 90 constituent organizations attending the NCRAC's annual pleanry meeting here. Both drew a distinction between combinating "top priority" a antegory in which each placed the issues of disc diddle East and Soviet Jewry—and treating them as "pre-emptive concerns" which Arent and Band said, tend to separate Jewish activity from the mainstream of American life. Arent deplored the fact that "too many Jews seem prepared to withdraw into an exclusive Jewish particularism." Community relations, he told the gathering, "His the recruitment of allies." He said "it would be arrogance" for the Jewish community "to imagine that we can effectively communicate with our fellow Americans" in seeking public support for Israel and Soviet Jews while remaining indifferent to "fercutal national problems."

Band similarly urged the NCRAC constituents to become more actively involved in the problems of urban decay, orime, drug abuse, poverty and ecology. The plenary meeting explored a number of such issues. A proposed policy statement calling for "immediate" American withdrawal from Mietaam—long a divisive issue among NCRAC agencies—produced a compromise resolution calling for withdrawal "at the earliest possible date, and pealing that time, immediate, sieps by our government in initiate a case—fire and sieps to ensure free elections in South Vietnam." In another action in which only the Union of Orthodox Jewish Congregations of America dissented, the plenary reaffirmed its opposition to tax-supported sectarian-sponsored education. A policy declaration on civil liberties condemned secret data gathering by government agencies on the personal habits and political views and activities of private citizano. The declaration warned of a threat of "dessier dictatorship" posed by the uncontrolled collection of such data and expressed strong opposition to the government's use of computerized data banks to store, information on private citizens, "unless they are severely limited as to purpose, content and use." The NCRAC Plenary opened Thursday and will close tonight.

ADL Leader Urges Congress To Pass Bills: Authorizing VOA To Broadcast in Yiddish

NEW YORK, June 27 (JTA).—Citing "the more than 3 million Jews in the Soviet Union who have been deprived of their cultural heritage and who would welcome support from abroad in their struggles to retain their ethnic identity," the chairman of the Anti-Delamation League of Pinal Pritti urged that Congress pass two pending bills to authorize the Voice of America to beam Yiddish and Hebrew broadcasts into the USSR. The official, Seymour Graubard, also asked the State Department to initiate two such weekly broadcasts—one in Yiddish, one in Hebrew—"for the culture-hungry Jewish audience in the USSR," Graubard rejectly the recent contention of Frank Snikespeare, director of the United States Information Agency, that while the U.S. has "deep concern" for Soviet Jews, it was "not prepared" to initiate such programming because "two would be shy effect, increasing our costs without materially increasing our audience." Said Graubard: "The United States of America has always stood for the rights of intellectual freedom and education which such broadcasts would represent. It is time that the Voice of America conscience" with regard to the agony of Soviet Jews. Bernard G. Richards, Jewish Leader, Founder Of AJCongress, Dies At 94

NEW YORK, June 27 (JTA)--Funeral services were held today for Bernard G. Richards, a Jewish leader whose career spanned more than 50 years, who died Friday at the age of 54. He was a founder of the American Jewish Congress and a member of the executive committee of the Joinst Organization of America and served as a member of the American Jewish delegation to the Peace Conference in Paris in 1919. Ten years ago he had been honored on the 25th anniversary of the Jewish Information Bureau, which he had created and headed almost until his death. He had worked as an editor and correspondent for a wide variety of general and Jewish periodicals. He was widely known for his fictional character, Keldansky, embodied in his first book, "Discourses of Keidansky," a wryly philosophical Jewish amateur philosopher. Born in Keidan, Lithuxdua, he followed his father, an earlier immigrant, to idaho Springs, Colo., where he worked in his/father's drygoods store. He was then 13. He then went to Boston and eventually settled in New York/City.
