GALILI: RESUMPTION OF U.S. DELIVERIES

JERUSALEM, Jan. 4 (JTA)--Israel Galili, Labor Minister-Without-Portfolio who is close to Premier Golda Meir, said last night that the resumption of American deliveries of Phantom jets to Israel is in no way linked to political con-

cessions by Israel. Galili is one of a number of high level Israeli figures who regard President Nixon's remarks on a US television interview Sunday night as a statement of his decision to supply the supersonic fighter-bombers to Israel. Speaking on a radio interview here, Galili said

the Israeli government rejected any link between arms deliveries and political concessions. He expressed hope that Nixon's statement would be put into practice soon and said it would have the effect of deterring the Arabs rather than provoking them into new hostilities

Nixon, interviewed by CBS White House correspondent Dan Rather said, when asked if the US has agreed in principle to sell more Phantoms to Israel, "We have made a decision of implementing a decision that I have long announced: that we will not allow the military balance in the Middle East to be shifted...we have had to consider the requests of Israel for planes in order to see that the balance does not shift. We have made a commitment in principle."

Galili said the Israel government was open to discussion on both an interim agreement to reopen the Suez Canal and an overall agreement, the sole condition being that these discussions are held without prior conditions. Regarding the return of UN mediator Gunnar V. Jarring to an active role in Mideast peace efforts, Galili said: "The Egyptians have decided on war but for the present refrain from opening fire and have declared their willingness to try the political course. Israel must therefore be ready for a new beginning." He added that Israel must remain on the alert for a possible renewal of hostilities which "makes it vital not to miss any political opportunities."

POMPIDOU WARNS MIDEAST FIGHTING MAY RESUME AT ANY MOMENT; SAYS LASTING PEACE NOWHERE IN SIGHT

PARIS, Jan. 4 (JTA) -- President Georges Pompidou told assembled foreign diplomats last night that "fighting in the Middle East may break out anew at any moment" and that "a just and lasting peace" in that region was nowhere in sight. Pompidou addressed the diplomats who had come to the Elysee Palace to present their good wishes for the New Year. Among them was the Israeli Ambassador, Asher Ben Natan with whom Pompidou will meet this Thursday to try to break the deadlock over Israel's 50 embargoed Mirage jet fighters.

Pompidou characterized the Middle East as one of the world's areas of tension and gave a somber appraisal of the situation. Walking among the ambassadors later, he spoke briefly to Ben Natan saying he wished Israel "peace" for 1972. He also talked at length to the Egyptian Ambassador and other Arab diplomats. Pompidou's meeting with Ben Natan later this week will be over reimbursement to Israel for the 50 Mirages embargoed since the Six-Day War. Israel agreed in principle last year to accept monetary reimbursement for the planes but after three months of negotiations on an ambassadorial level the two sides were reportedly

far apart as to terms.

French sources said Pompidou intends to use the talks with Ben Natan as an opportunity to normalize Franco-Israeli relations on a broader scale in all political fields. Their talk will be held in private. Sources said the issues to be raised include the European Common Market and the overall Middle East situation. Israel has asked to be included on the ECC's list of underdeveloped countries. France so far has balked. Israel would like France to abstain from any new diplomatic initiatives in the Middle East.

U.S. 'AVAILABLE' TO ASSIST ISRAEL EGYPT WORK OUT INTERIM AGREEMENT

WASHINGTON, Jan. 4 (JTA) -- The State Department said today that the US remains "available" to assist Israel and Egypt to work out an interim agreement on the Suez Canal but could not say when negotiations might begin. Department spokesman Charles Bray said in reply to questions at today's news briefing, "We remain available to the parties' wishes to make use of our services in their search for an interim agreement." He added, "As to when this process might be restarted, I cannot now predict." Bray declined to comment on a charge by Tass, the official Soviet news agency, that the US can no longer act impartially in Mideast negotiations.

He had no comment on another report that the senior Egyptian diplomatic representative in Washington, Ashraf Ghorbal, is back in Cairo with the latest US proposals for an interim settlement, Bray said that the likelihood of talks between Israel and Egypt was "a function of the desire of the parties themselves to which we will do our best to be responsive." Asked when more Phantom jets will be delivered to Israel, the State Department spokesman said President Nixon had covered that in his televised interview Sunday night.

New Project Evokes Sharp Debate: ASSURANCE GIVEN LOCAL HOUSING COUNCIL WILL HAVE ADVISORY ROLE IN TENANT SELECTION

NEW YORK, Jan. 4 (JTA) -- An Orthodox rabbi in the Rocksways in Queens, where a 712-unit lowincome housing project is scheduled to open in June, declared today that as a result of community pressure, assurances had been given by the City Housing Authority that a local Community Housing Council will have an advisory role in selection of tenants for the project.

The housing project has evoked sharp debates in the Arverne-Edgemere site, but on a far smaller scale than the protest actions of residents of Forest Hills against a proposed 840-unit low-income housing project there, now tied up in several court actions. The demand that the local Community Housing Council be given the right to screen tenants for the Arverne project was made by Rabbi Herschel Solnica of the Young Israel of the Rockaways at a meeting at a local high school last month attended by 700 residents.

The meeting was halted by police after fist fights and conflicting reports of clashes between members of the Jewish Defense League and the Black Panthers. The presence of the Black Panthers was attributed to a report by Capt. Victor Rowe of the 101st Precinct but local Black leaders said they doubted any Panthers had attended the

meeting.

Ernest Brown, chairman of the Arverne Urban
Renewal Area Advisory Council, opposed Rabbi
Solnica's demand to screen tenants. Brown said
that "the thought of the rabbi and his colleagues
sitting down and saying we don't want this or that
one is a dangerous precedent," He asserted there
were no Blacks or Puerto Ricans on the Commun-

## ity Housing Council. Seek Results, Not Fanfare

Rabbi Solnica conceded that he was using the crord "screen" as a device to force Simoon Colar, the Housing Authority chairman, into providing social services, crime control and other safety procedures before the low-income tenants, many of them welfare cases, move into the middle-income neighborhood. Rabbi Solnica told the Jewish Telegraphic Agency today that "We're beginning to see changes made. There has been a drop in area crime" and "a better quality of tenant" is being selected for the new project. He added that by "better quality" he did not mean white tenants, since most of the tenants are expected to be Black.

Arverne-Edgemere has not received the headlines Forest Hills has, Rabbi Solnica explained, because the Arverne residents have not engaged in demonstrations, picketing or other "fanfare," preferring to rely on "quiet diplomacy." Noting that he is just trying to obtain "humane treatment for a compunity," Rabbi Solnica said that the Anti-Defamation League of B'nai B'rith is "work-

ing closely with us."

In addition, he said he is seeking meetings with such other organizations as the Federation of Jewish Philanthropies of New York and the American Jewish Congress. Asked if the Jewish Defense League was playing a role in the situation, Rabbi Solnica said that it was but in a supplementary capacity. Its members are "very cooperative," he said, "They are assisting old ladies from Waldbaum's (supermarket) to the shopping center to the bank" or wherever else the residents want to go without fearing for their safety.

## NORTHERN IRELAND'S JEWISH COMMUNITY NOT AFFECTED BY CURRENT STRIFE

LONDON, Jan. 4 (JTA)—The bitter strife and bloodshed between Roman Catholics and Protesiants in Ulster has had no effect so far on Northern Ireland's tiny Jewish community which numbers less than 1,000. But according to reports from Belfast, some Jews have become innocent victims of explosions by virtue of owning shops in the central part of town where most bombings have occurred. Belfast Jews so far have maintained a low profile. Their position was summed up in the story of a Jewish woman doctor who was stopped by members of the Irish Republican Army after midnight. She told them "I am a Jewish doctor." They asked her, "Are you Roman Catholic Jewish or Protestant Jewish" you Roman Catholic Jewish or Protestant Jewish".

## BERNARD ULLMAN, FAMED JOURNALIST, NAMED KNIGHT OF FRENCH LEGION OF HONOR

PARIS, Jan. 4 (JTA).—Bernard Ullman, a prominent French journalist who has written for the Jewish Telegraphic Agency, was named a Knight of the French Legion of Honor on President Georgee Pompidou's New Year list. The 53-year-old Ullman was born a Jew but by his own account became personally interested in Jewish affairs only after the fix-Day, War which be covered for Agence France Presse, the French world-wide news agency.

Although in great demand, he offered to contrib-

ute his services to the JTA for which he covered last year's attempted coup against King Hassan II of Morocco. #### USSR BUILDING MILITARY AIRBASE NEAR ASWAN DAM FOR USE BY SOVIET AIR FORCE

LONDON, Jan. 4 (37A)—Bast European sources described as very reliable have confirmed reports that the Soviet Union is building a military airbase near the Aswan High Dam in Egypt for the exclusive use of the Soviet Air Force. According to the sources an agreement for construction of the base was signed by President Anwar Sadat when he visited Moscow hast Oct, and construction is proceeding very rapidly. The base is expected to be fully operational by next May, coincidental with President Nixon's summit visit to Moscow. It will be manned entirely by Russian personnel.

The immediate purpose of the airbase according to informed sources is to deter an Israeli retailatory strike against the dam in the likelihood of renewed hostilities in the Middle East. The Aswan High Dam was designed, built and financed by the Soviet Union, after the US withdrew from a similar project in the 1950s and is regarded as the single most important project that opened the door to Soviet influence in Egypt, leraeli Phantom jets have the range to reach the dam and Israel is believed to have developed

weapons capable of breaching it.

Destruction of the Aswan Dam, if permitted by the Russians, would subject Egypt to disastrous floods and constitute a major blow to Soriet prestige. The Israelis are not considered likely to attack the dam unless provoked by Egyptian attacks on Israeli civilian centers, such as an air raid on Tel Aviv.

#### JEWISH GROUPS TO HOLD EMERGENCY SESSION ON COURT SUIT CHALLENGING RITUAL SLAUGHTER OF LIVESTOCK

NEW YORK, Jan. 4 (JTA) -- Representatives of 12 national and 91 local Jewish organizations will hold an "emergency meeting" next Monday afternoon to decide how to "defend the constitutionality...of Jewish ritual slaughter of livestock" against a suit filed vesterday in Federal Court here. The suit was filed by Henry Mark Holzer, a local lawyer who contends that the "special" laws for Jewish ritual slaughter (shechita) violate the First Amendment's separation of church and state. Holzer is a Jewish-born atheist.

The Jewish organizations planning to oppose the suit are members of the National Jewish Community Relations Advisory Council and the Synagogue Council of America. Holzer's suit names the United States Secretary of Agriculture, the New York State Commissioner of Agriculture and Markets, and the latter's chief of kosher-law enforcement. It opposes the use of taxes to enforce what Holzer calls an un-

constitutional law.

Leo Pfeffer, special counsel to the American Jewish Congress and drafter -- on behalf of NJCRAC and the SCA -- of the section of the law under challenge, said in a statement that there was "no doubt" about its constitutionality. It is "universally acknowledged," he said, that sliechita is "as humane as, if nc: more humane than, any other method," Rabbi Moshe Sherer, executive president of Agudath Israel (Orthodox), predicted from Washington that Holzer's suit would meet with "instant defeat" because of the "proven humaneness" of shechita and the concept of "religious freedom."

Rabbi Sherer declared: "It is shameful that one who claims to be a Jew is attempting to accomplish that which professional anti-Semites have been un able to do for decades. His efforts will be as futile as theirs." He added that according to Congressional sources, Holzer's suit is an "extremist" measure.

## KEREN HAYESOD-UNITED ISRAEL APPEAL RAISED OVER \$100M IN 1971

JERUSALEM, Jan. 4 (JTA) -- The Keren Hayesod-United Israel Appeal raised over \$100 million in 1971. a 30 percent increase over the amount raised in 1970. it was disclosed today. The results of the campaign in 69 countries was contained in the summary of a report by Keren Hayesod chairman Ezra Shapiro to be submitted to the forthcoming World Zionist Congress. The report noted that the 1971 campaign raised the most funds since the Six-Day War. It also said that advance pledges for the 1972-73 campaign indicated a further increase in response to Israel's growing needs for immigrant absorption.

## PANTHERS THREATEN TO 'EXPLODE' CONGRESS IF DENIED FORUM

JERUSALEM, Jan. 4 (JTA)--Jerusalem's Black Panthers threatened today to "explode" the World Zionist Congress which opens here Jan. 17 unless the organization of slum dwellers is permitted to address the forum. The threat was made during a demonstration at Menorah Square which drew some 500 persons and was dispersed by the police after one Panther leader exhorted the crowd to riot.

The Panther leaders claimed that they represented the underprivileged classes of Israel and said they would demonstrate outside the Congress hall. The pretext for tonight's demonstration was the reduction in money allocated for education and welfare by the government.

## SWISS WEG SAVED JEWS REWARDED

BONN, Jan. 4 (JTA)--An 80-year-old former Swiss

police officer who lost his job for an act of mercy that saved 3,000 Austrian Jews from deportation and probable death at the hands of the Nazie during World War II, was honored by President Gustav Heinemann of the West German Federal Republic. President Heinemann disclosed today that he had written a letter to Paul Gruniger in recognition of his courage and sent him a television set as a gesture of appreciation. Gruniger was fired when, contrary to the instructions of the Swiss government, he admitted some 3,000 fleeing Austrian Jews into Switzerland. He was rehabilitated 33 years later.

#### BOOBY-TRAP PARCEL INJURES POLICE BOMB EXPERT

JERUSALEM, Jan. 4 (JTA) -- A police bomb disposal expert was seriously injured this morning while trying to dismantle a booby-trapped parcel presumably mailed by Arab terrorists abroad. The parcel was addressed to an address in the Tel Aviv area. The victim's name was not disclosed. He reportedly lost his eyesight and underwent surgery. His condition was reported serious but not grave.

An undisclosed number of bomb-parcels have arrived in Israel during the past few days. One was found yesterday in the Kiryah post office in Tel Aviv and others reportedly have turned up at the post offices in Jerusalem and Eilat. Except for today's incident, all were safely dismantled. Israeli police have approached Interpol, the international police organization, and have alerted the public to be wary of suspiciouslooking parcels.

The parcels appear to have been sent from Vienna. They resemble books or a box of chocclates and are usually wrapped in colorful paper, tied with colored ribbons and addressed in green ink on a white label, police said. The addresses were not disclosed but special warnings have been issued to security officers at large public institutions. All mails are being inspected for bomb parcels.

## MEDIATOR NAMED IN STRIKE

NEW YORK, Jan. 4 (JTA) -- Mayor John V. Lindsay has named a mediator in the strike of the 400 group-work personnel of the Federation of Jewish Philanthropies, which was in its 15th day today. The appointee is Harold G. Israelson, a veteran labor negotiator with offices on Fifth Avenue. He will hold his first meeting with the parties Thursday afternoon in the Roger Smith Hotel. Erik Strong, spokesman for Local 1707, Community and Social Agency Employes Union, told the Jewish Telegraphic Agency: got them to the hargaining table, anyway. That's something." A Federation spokesman could not be reached for comment.

#### PINCUS: DR. GOLDMANN MADE A POLITICAL BLUNDER

JERUSALEM, Jan. 4 (JTA)—The demand for equal rights for Soviet Jewry, which has been raised for many sears, has led nowhere while the demand that they be allowed to leave has brought results, the chairman of the Zioniet Executive, Louis Pincus, said in a special interview reacting to criticisms of Zionist and Jewish leaders over the Zionist Executive's decision not to let Dr. Nabura Goldmann make the central speech on 75 years of Zionism at the forthcoming Zionist Congress.

Pincus said that the World Jewish Congress which Dr. Goldmann heads, as well as other Jewish organtations, had expressed their considered opinion on Soviet Jewry at the Brussels conference last February. The relevant resolution called for the return of Soviet Jews to Israel and also for letting them

live a free Jewish life.

In his Lordon speech to the Board of Deputies which led to the cancellation of the invitation, Dr. Goldmann, Pincus noted, had emphasized the two demands in the exactly opposite order: he had demands first of all free cultural life for Soviet Jewry and also their being allowed to emigraie to Israel. In addition, he had belittled emigration saying that in any case only a small number would really leave for Israel if permitted to do so, Pincus said.

Saying these things at the present moment was a political blunder of the first order. Pincus observed. "To choose the moment when our efforts are being crowned with success—with thousands pouring into the country—diminishing the centrality of the demand for emigration is diluting our strength as the fight has begun to show results," he stated.

## Soviet Jews Demand Emigration

It had been the demand of Soviet Jows themselves that world Jewish bodies come to their aid, Pincus revealed. They themselves had come to the conclusion that no rights would be given to them. Therefore, they asked that world opinion be enlisted in their behalf for one purpose: their right to emigrate. The World Jewish Congress is a political body conducting a political fight. For its president to try and turn the clock back to two-pronged demands is inappropriate and uncilled for, Pincus said. "For a Zionist, allys is summum bonum," he stated.

"irp. Goldmann is too experienced a politician not to have realized what his statement would do. This is not the time for stating philosophies—there is no choice between living a Jewish life and emigrating. Dr. Goldmann surely knows this. It is not wrong to ask for Jewish rights. But is it practical? The Soviet authorities have closed schools, curtailed synagogues, suppressed community life until the Russian Jews themselves have come to the conclusion that the only salvation for them isy outside the Soviet Union. They have asked help in this de-

mand and not in the other."

Recounting conversations he recently had with olim from the Soviet Union, Pinous said that they certainly do not see things like Dr. Goldmann. All this made the Zionist Executive take the decision to cancel his appearance as the only speaker at an evening devoted to the history of Zionism, although Dr. Goldmann is free to come and speak on any subject he chooses, Pinous ztated.

#### Negated Primacy Of Aliya

He then recounted some of the history of the Goldmann invitation. Pincus said that when Dr. Goldmann first suggested it, he made it a condition

that the invitation be manimous. The Herut representative in the Executive voted against the invitation but Dr. Goldman had been prepared to accept this for practical purposes as unanimous. The proposal, however, had to go, according to the Zionist constitution, to the Zionist General Council. There it was opposed at the time by the Independent Liberals, Achdut Avoda, the World Union of General Zionists and of course Herut. This meeting took place before the London speech.

Dr. Goldmann himself had written Pincus several times that if the idea would meet any difficulty he would not have the slightest hesitation in stepping down. Pincus said. Then came the London speech to which the reaction in 1st acl was very strong. The fact that Dr. Goldmann was very strong. The fact that Dr. Goldmann was negating the primacy of aliya at this moment—a fact borne out by the full transcript of the London speech—was so sharply attacked that it was clear the unanimity required by Dr. Goldmann for his invitation to appear on the festive occasion of 75 years of Zionism no loner existed.

The Executive's decision, therefore, reflected not only the feeling among Russian immigrants and public opinion in Israel but was also in keeping with Dr. Goldmann's stipulations themselves, Pincus explained. "The highest solution to Jewish distress, of which reports abound from the Sowtet Union, is aliya to the Jewish State. The Zionist Congress must give expression to this clear opinion if it is to be true to itself. With all my personal distress over the inatter I could not recommend any other course than I did," Pincus concluded.

#### RAPID EXPANSION OF HILLEL PROGRAM

LOS ANGELES, Jan. 4 (JTA)—The need of young people to be involved in activities related to Jewish scotety, outlure and tradition is responsible for the rapid expansion here of an active Hillel program. In answer to that need Hillel oncampus chapters new number 33 in Los Angeles County and throughout most of Southern California. After a humble beginning two years ago with one staff director and three part-time workers, the Hillel expansion program now entails scores of rabbis, student coordinators and administrators who cover eight intercollegicate areas.

Mrs. Sylvis Simon, Los Angelee Hillel extension program administrator, said "The first extension campus proved a great success in terms of the numbers of Zewish students who were eager to participate in Jewisi-oriented activities, to meet each other and become part of a community feeling." She added that the initial efforts triggered development of the other Southern Califorinta Hillel chapters.

She explained that the students participating in the extension program have a wide range of interests, including a "deep commitment" to the plight of Soviet Jewry, and a genuine desire to stay abreast of the social, political, economic and other problems facing Israel today. Rabbi Henry Rabin is executive director of the Los Angeles Hillel Council, an agency of the Jewish Federation-Council and the B'nai B'rith Hillel Foundation.

Staff personnel come from varied backgrounds and contribute a myriad of individual talents while working from 25 to 30 hours a month planning and organizing Hillel programs.

PARIS, Jan. 4 (JTA) -- President Georges Pompidou told assembled foreign diplomats last night that "fighting in the Middle East may break out anew at any moment" and that "a just and lasting peace" in that region was nowhere in sight. Pompidou addressed the diplomats who had come to the Elysee Palace to present their good wishes for the New Year. Among them was the Israeli Ambassador, Asher Ben Natan with whom Pompidou will meet this Thursday to try to break the deadlock over Israel's 50 embargoed Mirage jet fighters.

Pompidou characterized the Middle East as one of the world's areas of tension and gave a somber appraisal of the situation. Walking among the ambassadors later, he spoke briefly to Ben Natan saying he wished Israel "peace" for 1972. He also talked at length to the Egyptian Ambassador and other Arab diplomats. Pompidou's meeting with Ben Natan later this week will be over reimbursement to Israel for the 50 Mirages embargoed since the Six-Day War. Israel agreed in principle last year to accept monetary reimbursement for the planes but after three months of negotiations on an ambassadorial level the two sides were reportedly

far apart as to terms.

French sources said Pompidou intends to use the talks with Ben Natan as an opportunity to normalize Franco-Israeli relations on a broader scale in all political fields. Their talk will be held in private. Sources said the issues to be raised include the European Common Market and the overall Middle East situation. Israel has asked to be included on the ECC's list of underdeveloped countries. France so far has balked. Israel would like France to abstain from any new diplomatic initiatives in the Middle East.

U.S. 'AVAILABLE' TO ASSIST ISRAEL EGYPT WORK OUT INTERIM AGREEMENT

WASHINGTON, Jan. 4 (JTA) -- The State Department said today that the US remains "available" to assist Israel and Egypt to work out an interim agreement on the Suez Canal but could not say when negotiations might begin. Department spokesman Charles Bray said in reply to questions at today's news briefing, "We remain available to the parties' wishes to make use of our services in their search for an interim agreement." He added, "As to when this process might be restarted, I cannot now predict." Bray declined to comment on a charge by Tass, the official Soviet news agency, that the US can no longer act impartially in Mideast negotiations.

He had no comment on another report that the senior Egyptian diplomatic representative in Washington, Ashraf Ghorbal, is back in Cairo with the latest US proposals for an interim settlement, Bray said that the likelihood of talks between Israel and Egypt was "a function of the desire of the parties themselves to which we will do our best to be responsive." Asked when more Phantom jets will be delivered to Israel, the State Department spokesman said President Nixon had covered that in his televised interview Sunday night.

New Project Evokes Sharp Debate: ASSURANCE GIVEN LOCAL HOUSING COUNCIL WILL HAVE ADVISORY ROLE IN TENANT SELECTION

NEW YORK, Jan. 4 (JTA) -- An Orthodox rabbi in the Rocksways in Queens, where a 712-unit lowincome housing project is scheduled to open in June, declared today that as a result of community pressure, assurances had been given by the City Housing Authority that a local Community Housing Council will have an advisory role in selection of tenants for the project.

The housing project has evoked sharp debates in the Arverne-Edgemere site, but on a far smaller scale than the protest actions of residents of Forest Hills against a proposed 840-unit low-income housing project there, now tied up in several court actions. The demand that the local Community Housing Council be given the right to screen tenants for the Arverne project was made by Rabbi Herschel Solnica of the Young Israel of the Rockaways at a meeting at a local high school last month attended by 700 residents.

The meeting was halted by police after fist fights and conflicting reports of clashes between members of the Jewish Defense League and the Black Panthers. The presence of the Black Panthers was attributed to a report by Capt. Victor Rowe of the 101st Precinct but local Black leaders said they doubted any Panthers had attended the

meeting.

Ernest Brown, chairman of the Arverne Urban
Renewal Area Advisory Council, opposed Rabbi
Solnica's demand to screen tenants. Brown said
that "the thought of the rabbi and his colleagues
sitting down and saying we don't want this or that
one is a dangerous precedent," He asserted there
were no Blacks or Puerto Ricans on the Commun-

## ity Housing Council. Seek Results, Not Fanfare

Rabbi Solnica conceded that he was using the crord "screen" as a device to force Simoon Colar, the Housing Authority chairman, into providing social services, crime control and other safety procedures before the low-income tenants, many of them welfare cases, move into the middle-income neighborhood. Rabbi Solnica told the Jewish Telegraphic Agency today that "We're beginning to see changes made. There has been a drop in area crime" and "a better quality of tenant" is being selected for the new project. He added that by "better quality" he did not mean white tenants, since most of the tenants are expected to be Black.

Arverne-Edgemere has not received the headlines Forest Hills has, Rabbi Solnica explained, because the Arverne residents have not engaged in demonstrations, picketing or other "fanfare," preferring to rely on "quiet diplomacy." Noting that he is just trying to obtain "humane treatment for a compunity," Rabbi Solnica said that the Anti-Defamation League of B'nai B'rith is "work-

ing closely with us."

In addition, he said he is seeking meetings with such other organizations as the Federation of Jewish Philanthropies of New York and the American Jewish Congress. Asked if the Jewish Defense League was playing a role in the situation, Rabbi Solnica said that it was but in a supplementary capacity. Its members are "very cooperative," he said, "They are assisting old ladies from Waldbaum's (supermarket) to the shopping center to the bank" or wherever else the residents want to go without fearing for their safety.

## NORTHERN IRELAND'S JEWISH COMMUNITY NOT AFFECTED BY CURRENT STRIFE

LONDON, Jan. 4 (JTA)—The bitter strife and bloodshed between Roman Catholics and Protesiants in Ulster has had no effect so far on Northern Ireland's tiny Jewish community which numbers less than 1,000. But according to reports from Belfast, some Jews have become innocent victims of explosions by virtue of owning shops in the central part of town where most bombings have occurred. Belfast Jews so far have maintained a low profile. Their position was summed up in the story of a Jewish woman doctor who was stopped by members of the Irish Republican Army after midnight. She told them "I am a Jewish doctor." They asked her, "Are you Roman Catholic Jewish or Protestant Jewish" you Roman Catholic Jewish or Protestant Jewish".

## BERNARD ULLMAN, FAMED JOURNALIST, NAMED KNIGHT OF FRENCH LEGION OF HONOR

PARIS, Jan. 4 (JTA).—Bernard Ullman, a prominent French journalist who has written for the Jewish Telegraphic Agency, was named a Knight of the French Legion of Honor on President Georgee Pompidou's New Year list. The 53-year-old Ullman was born a Jew but by his own account became personally interested in Jewish affairs only after the fix-Day, War which be covered for Agence France Presse, the French world-wide news agency.

Although in great demand, he offered to contrib-

ute his services to the JTA for which he covered last year's attempted coup against King Hassan II of Morocco. He wrote then under the pen hame of Francois Chabernet, Ullman holds the title of deputy chief editor of the AFP. He was formerly the AFP's bureau chief in Peking and Moscow. His journalistic career spans 25 years during which he has covered world events from wars to presidential elections. French television has described Ullman as "the ideal foreign correspondent,"

#### USSR BUILDING MILITARY AIRBASE NEAR ASWAN DAM FOR USE BY SOVIET AIR FORCE

LONDON, Jan. 4 (37A)—Bast European sources described as very reliable have confirmed reports that the Soviet Union is building a military airbase near the Aswan High Dam in Egypt for the exclusive use of the Soviet Air Force. According to the sources an agreement for construction of the base was signed by President Anwar Sadat when he visited Moscow hast Oct, and construction is proceeding very rapidly. The base is expected to be fully operational by next May, coincidental with President Nixon's summit visit to Moscow. It will be manned entirely by Russian personnel.

The immediate purpose of the airbase according to informed sources is to deter an Israeli retailatory strike against the dam in the likelihood of renewed hostilities in the Middle East. The Aswan High Dam was designed, built and financed by the Soviet Union, after the US withdrew from a similar project in the 1950s and is regarded as the single most important project that opened the door to Soviet influence in Egypt, leraeli Phantom jets have the range to reach the dam and Israel is believed to have developed

weapons capable of breaching it.

Destruction of the Aswan Dam, if permitted by the Russians, would subject Egypt to disastrous floods and constitute a major blow to Soriet prestige. The Israelis are not considered likely to attack the dam unless provoked by Egyptian attacks on Israeli civilian centers, such as an air raid on Tel Aviv.

#### Political, Military Implications

#### JEWISH GROUPS TO HOLD EMERGENCY SESSION ON COURT SUIT CHALLENGING RITUAL SLAUGHTER OF LIVESTOCK

NEW YORK, Jan. 4 (JTA) -- Representatives of 12 national and 91 local Jewish organizations will hold an "emergency meeting" next Monday afternoon to decide how to "defend the constitutionality...of Jewish ritual slaughter of livestock" against a suit filed vesterday in Federal Court here. The suit was filed by Henry Mark Holzer, a local lawyer who contends that the "special" laws for Jewish ritual slaughter (shechita) violate the First Amendment's separation of church and state. Holzer is a Jewish-born atheist.

The Jewish organizations planning to oppose the suit are members of the National Jewish Community Relations Advisory Council and the Synagogue Council of America. Holzer's suit names the United States Secretary of Agriculture, the New York State Commissioner of Agriculture and Markets, and the latter's chief of kosher-law enforcement. It opposes the use of taxes to enforce what Holzer calls an un-

constitutional law.

Leo Pfeffer, special counsel to the American Jewish Congress and drafter -- on behalf of NJCRAC and the SCA -- of the section of the law under challenge, said in a statement that there was "no doubt" about its constitutionality. It is "universally acknowledged," he said, that sliechita is "as humane as, if nc: more humane than, any other method," Rabbi Moshe Sherer, executive president of Agudath Israel (Orthodox), predicted from Washington that Holzer's suit would meet with "instant defeat" because of the "proven humaneness" of shechita and the concept of "religious freedom."

Rabbi Sherer declared: "It is shameful that one who claims to be a Jew is attempting to accomplish that which professional anti-Semites have been un able to do for decades. His efforts will be as futile as theirs." He added that according to Congressional sources, Holzer's suit is an "extremist" measure.

## KEREN HAYESOD-UNITED ISRAEL APPEAL RAISED OVER \$100M IN 1971

JERUSALEM, Jan. 4 (JTA) -- The Keren Hayesod-United Israel Appeal raised over \$100 million in 1971. a 30 percent increase over the amount raised in 1970. it was disclosed today. The results of the campaign in 69 countries was contained in the summary of a report by Keren Hayesod chairman Ezra Shapiro to be submitted to the forthcoming World Zionist Congress. The report noted that the 1971 campaign raised the most funds since the Six-Day War. It also said that advance pledges for the 1972-73 campaign indicated a further increase in response to Israel's growing needs for immigrant absorption.

## PANTHERS THREATEN TO 'EXPLODE' CONGRESS IF DENIED FORUM

JERUSALEM, Jan. 4 (JTA)--Jerusalem's Black Panthers threatened today to "explode" the World Zionist Congress which opens here Jan. 17 unless the organization of slum dwellers is permitted to address the forum. The threat was made during a demonstration at Menorah Square which drew some 500 persons and was dispersed by the police after one Panther leader exhorted the crowd to riot.

The Panther leaders claimed that they represented the underprivileged classes of Israel and said they would demonstrate outside the Congress hall. The pretext for tonight's demonstration was the reduction in money allocated for education and welfare by the government.

## SWISS WEG SAVED JEWS REWARDED

BONN, Jan. 4 (JTA)--An 80-year-old former Swiss

police officer who lost his job for an act of mercy that saved 3,000 Austrian Jews from deportation and probable death at the hands of the Nazie during World War II, was honored by President Gustav Heinemann of the West German Federal Republic. President Heinemann disclosed today that he had written a letter to Paul Gruniger in recognition of his courage and sent him a television set as a gesture of appreciation. Gruniger was fired when, contrary to the instructions of the Swiss government, he admitted some 3,000 fleeing Austrian Jews into Switzerland. He was rehabilitated 33 years later.

#### BOOBY-TRAP PARCEL INJURES POLICE BOMB EXPERT

JERUSALEM, Jan. 4 (JTA) -- A police bomb disposal expert was seriously injured this morning while trying to dismantle a booby-trapped parcel presumably mailed by Arab terrorists abroad. The parcel was addressed to an address in the Tel Aviv area. The victim's name was not disclosed. He reportedly lost his eyesight and underwent surgery. His condition was reported serious but not grave.

An undisclosed number of bomb-parcels have arrived in Israel during the past few days. One was found yesterday in the Kiryah post office in Tel Aviv and others reportedly have turned up at the post offices in Jerusalem and Eilat. Except for today's incident, all were safely dismantled. Israeli police have approached Interpol, the international police organization, and have alerted the public to be wary of suspiciouslooking parcels.

The parcels appear to have been sent from Vienna. They resemble books or a box of chocclates and are usually wrapped in colorful paper, tied with colored ribbons and addressed in green ink on a white label, police said. The addresses were not disclosed but special warnings have been issued to security officers at large public institutions. All mails are being inspected for bomb parcels.

## MEDIATOR NAMED IN STRIKE

NEW YORK, Jan. 4 (JTA) -- Mayor John V. Lindsay has named a mediator in the strike of the 400 group-work personnel of the Federation of Jewish Philanthropies, which was in its 15th day today. The appointee is Harold G. Israelson, a veteran labor negotiator with offices on Fifth Avenue. He will hold his first meeting with the parties Thursday afternoon in the Roger Smith Hotel. Erik Strong, spokesman for Local 1707, Community and Social Agency Employes Union, told the Jewish Telegraphic Agency: got them to the hargaining table, anyway. That's something." A Federation spokesman could not be reached for comment.

Also today, members of Federation's Golden Age Clubs converged on the organization's headquarters and sent a delegation of nine to meet with Graenum Berger, consultant on community centers. According to Strong there were 300 Golden Agers altogether; according to Berger, 80 to 90. Strong said they asked Federation officials to "use their influence" toward settling the group workers' contract grievances and cease using the "cop out" that they may not participate in the affairs of affiliated agencies. Berger told the JTA that because Federation had "no contract with the union," it had "no right" to "deal directly" in the matter. But Federation, he said, "has urged our agencies to do everything humanly possible to resolve this situation."

#### PINCUS: DR. GOLDMANN MADE A POLITICAL BLUNDER

JERUSALEM, Jan. 4 (JTA)—The demand for equal rights for Soviet Jewry, which has been raised for many sears, has led nowhere while the demand that they be allowed to leave has brought results, the chairman of the Zioniet Executive, Louis Pincus, said in a special interview reacting to criticisms of Zionist and Jewish leaders over the Zionist Executive's decision not to let Dr. Nabura Goldmann make the central speech on 75 years of Zionism at the forthcoming Zionist Congress.

Pincus said that the World Jewish Congress which Dr. Goldmann heads, as well as other Jewish organtations, had expressed their considered opinion on Soviet Jewry at the Brussels conference last February. The relevant resolution called for the return of Soviet Jews to Israel and also for letting them

live a free Jewish life.

In his Lordon speech to the Board of Deputies which led to the cancellation of the invitation, Dr. Goldmann, Pincus noted, had emphasized the two demands in the exactly opposite order: he had demands first of all free cultural life for Soviet Jewry and also their being allowed to emigraie to Israel. In addition, he had belittled emigration saying that in any case only a small number would really leave for Israel if permitted to do so, Pincus said.

Saying these things at the present moment was a political blunder of the first order. Pincus observed. "To choose the moment when our efforts are being crowned with success—with thousands pouring into the country—diminishing the centrality of the demand for emigration is diluting our strength as the fight has begun to show results," he stated.

## Soviet Jews Demand Emigration

It had been the demand of Soviet Jows themselves that world Jewish bodies come to their aid, Pincus revealed. They themselves had come to the conclusion that no rights would be given to them. Therefore, they asked that world opinion be enlisted in their behalf for one purpose: their right to emigrate. The World Jewish Congress is a political body conducting a political fight. For its president to try and turn the clock back to two-pronged demands is inappropriate and uncilled for, Pincus said. "For a Zionist, allys is summum bonum," he stated.

"irp. Goldmann is too experienced a politician not to have realized what his statement would do. This is not the time for stating philosophies—there is no choice between living a Jewish life and emigrating. Dr. Goldmann surely knows this. It is not wrong to ask for Jewish rights. But is it practical? The Soviet authorities have closed schools, curtailed synagogues, suppressed community life until the Russian Jews themselves have come to the conclusion that the only salvation for them isy outside the Soviet Union. They have asked help in this de-

mand and not in the other."

Recounting conversations he recently had with olim from the Soviet Union, Pinous said that they certainly do not see things like Dr. Goldmann. All this made the Zionist Executive take the decision to cancel his appearance as the only speaker at an evening devoted to the history of Zionism, although Dr. Goldmann is free to come and speak on any subject he chooses, Pinous ztated.

#### Negated Primacy Of Aliya

He then recounted some of the history of the Goldmann invitation. Pincus said that when Dr. Goldmann first suggested it, he made it a condition

that the invitation be manimous. The Herut representative in the Executive voted against the invitation but Dr. Goldman had been prepared to accept this for practical purposes as unanimous. The proposal, however, had to go, according to the Zionist constitution, to the Zionist General Council. There it was opposed at the time by the Independent Liberals, Achdut Avoda, the World Union of General Zionists and of course Herut. This meeting took place before the London speech.

Dr. Goldmann himself had written Pincus several times that if the idea would meet any difficulty he would not have the slightest hesitation in stepping down. Pincus said. Then came the London speech to which the reaction in 1st acl was very strong. The fact that Dr. Goldmann was very strong. The fact that Dr. Goldmann was negating the primacy of aliya at this moment—a fact borne out by the full transcript of the London speech—was so sharply attacked that it was clear the unanimity required by Dr. Goldmann for his invitation to appear on the festive occasion of 75 years of Zionism no loner existed.

The Executive's decision, therefore, reflected not only the feeling among Russian immigrants and public opinion in Israel but was also in keeping with Dr. Goldmann's stipulations themselves, Pincus explained. "The highest solution to Jewish distress, of which reports abound from the Sowtet Union, is aliya to the Jewish State. The Zionist Congress must give expression to this clear opinion if it is to be true to itself. With all my personal distress over the inatter I could not recommend any other course than I did," Pincus concluded.

#### RAPID EXPANSION OF HILLEL PROGRAM

LOS ANGELES, Jan. 4 (JTA)—The need of young people to be involved in activities related to Jewish scotety, outlure and tradition is responsible for the rapid expansion here of an active Hillel program. In answer to that need Hillel oncampus chapters new number 33 in Los Angeles County and throughout most of Southern California. After a humble beginning two years ago with one staff director and three part-time workers, the Hillel expansion program now entails scores of rabbis, student coordinators and administrators who cover eight intercollegicate areas.

Mrs. Sylvis Simon, Los Angelee Hillel extension program administrator, said "The first extension campus proved a great success in terms of the numbers of Zewish students who were eager to participate in Jewisi-oriented activities, to meet each other and become part of a community feeling." She added that the initial efforts triggered development of the other Southern Califorinta Hillel chapters.

She explained that the students participating in the extension program have a wide range of interests, including a "deep commitment" to the plight of Soviet Jewry, and a genuine desire to stay abreast of the social, political, economic and other problems facing Israel today. Rabbi Henry Rabin is executive director of the Los Angeles Hillel Council, an agency of the Jewish Federation-Council and the B'nai B'rith Hillel Foundation.

Staff personnel come from varied backgrounds and contribute a myriad of individual talents while working from 25 to 30 hours a month planning and organizing Hillel programs.
