U.S. TO DELIVER JETS TO ISRAEL A FEW AT A TIME WHILE PRESSURING ISRAEL TO SOFTEN POSITION IN TALKS WITH EGYPT Termed 'Blackmail On Installment Plan'

GENEVA, Jan. 6 (JTA).—Highly reliable American sources said here last night that Israel would get Phantom jet airoraft but only in small deliveries of two or three at a time while the US consisted to pressure Israel to soften its position in talks with Egypt. The sources said American officials referred cynically to this scheme as "blackmail on the installment plan."

They said that as the Phantoms are rationed cut, the State Department expects Israel to participate in so-called "hotel taiks," meaning indirect negotiations with Egypt at the same venue with the Americans acting as go-betweens. State Department officials assume that Israel can be made to bend a little from its position that an interim Suez agreement must not be linked to an Israeli withdrawal from the Sinai as part of an overall settlement, the sources said as

The sources stated that the State Department was anxious to get the talks moving because they believe that time is running out for P-estdent Anwar Sadat of Egypt who must produc; either a diplomatic victory or war if hie regime is to survive.

The sources said that the renewal of talks under United Nations mediator Cauriar V, Jarring was no obstacle to the "hotel talks." The State Department believes that the two sets of talks could doverteil and that Jarring could be helpful to the Americans in achieving negotiations according to their pattern, the sources said. They noted that the US concedes that Israel is not the only obstacle to the implementation of this plan as Egypt itself has not yet agreed.

ROGERS: U.S. WORKING TO GET NEGOTIATIONS GOING BETWEEN ISRAEL. EGYPT FOR OVERALL. ACCORD EITHER THROUGH JARRING OR U.S. U.S. TO Supply Defensive Military Arms

WASHINGTON, Jan. 6 (17A)—Secretary of State William P. Rogers said last night that the United States was trying to get negotiations going between Israel and Egypt and that it did not matter whether they were negotiations for an overall settlement under the auspices of Ambassador Gunnar V, Jarring or for an interim Suez agreement with the Us acting as mediator. "We are working in both ways," Rogers told

ABC newmen Howard K, Smith and Ted Koppel during a television interview. "We have had no fighting there (the Middle Early for about 18 months so that in itself is an encouraging fact. Now we hope that we will be able to get negotiations started," Regers said. (At the United Nations today it was announced that Dr. Jarring is expected back there Monday.)

No Indications Phantoms Included

Rogers said the US would supply arms to larsel to enable it to defend itself and deter the Arabs from attacking. "On the other hand, we do not want our support to Israel to sppear to be encouraging larsel, itself to start hostilities," he said. Asked about larsel's long standing request for more Pfinitom jets, Rogers repiled:

"We have followed the policy for some time of attempting to maintain a military balance in the Middle East. By that we mean that we will provide arms to Israel in order to make sure that they can defend thenselves. If that were not the case, it would be de-stabilizing. It would be incentive for the other side to start a conflict."

Rogers declined to state the type of arms going to Israel or the timetable of shipments. "We expect to supply arms to Israel to be sure the balance doesn't shift," considering the continued Soviet military shipments to Egypt, he said. State Department spokesman Charles Bray had "no comment" today when asked whether Phantom jets are included in the flow of arms to Israel which Rogers referred to last night. The Rogers interview was aired on the ABC television network but was not picked up by ABC affiliates in some cities including New York.

POMPIDOU, BEN NATAN CONFER Total Blackout On Discussion

PARIS, Jan. 6 (JTA)--President Georges Pompidou and Israeli Ambassador Ben Natan conferred for over an hour this evening in an attempt to break the deadlock in Franco-Israeli negotiations over reimbursement for 50 embargeed Israeli Mirage V jets. The Israeli envoy had no comment for newamen as he left the Elysee Palace. Questioned later by the Jewish Telegraphic Agency, he declined to say whether he was optimistic or pessimistic over the outcome of the negotiations.

A complete blackout prevailed on the subjects discussed by Pomidou and Ben Natan. They are believed to have covered the Middle East crists and other areas of mutual interest in addition to the Mirages. It was learned that despite the length of their meeting, the matier of Israel's status in the European Common Market was not raised due to "lack of time." Prior to the meeting, that subject was said to have been on the agenda. The lack of any news emanating from the meeting indicated to some observers here that no tangible results were achieved and that Pompidou probably gave non-committal replies.

TERRORISTS KILL, MUTILATE BODY OF DEFENSE MINISTRY EMPLOYE

TEL AVIV, Jah. 6 (JTA)—A 24-year-old Defense Ministry employe was murdered this morning by terrorists who multisted his body. The victim was Joseph Grubber of Haifa, who worked for the Ministry's construction department. He was killed while inspecting construction work near Alma vilage, close to the Syrian border. The terrorists dragged his body toward the border, mutilated it and severed his head.

Israeli security forces uncovered two large terrorist aims caches in the Caza Strip today, one of them yielding the biggest hau of hand grenades ever found in one place. Eighteen Bedouins in the area were arrested and charged, with membership in terrorist organizations and sabotage. They were also charged with attacks on Israeli Army patrols. Among the hidden arms discovered were 200 grenades, 105 explosive bricks, 41 mines, 117 detonators, seven automatic submachine gune, six Russian rif-les; one Israel-made Uzzi submachinegun and a large quantity of animunition.

ORTHODOX TEACHERS' GROUP SAYS 'ELIMINATION' OF COLLEGE DEP'T DISCRIMINATES AGAINST JEWS

NEW YORK, Jan. 6 (JTA).—The Association of Orthodox Jewish Teachers of the New York City Public Schools, which claims to represent 5,000 of the city's 70,000 public school teachers, has protested the "discrimination" against Jowish students in Brooklyn College's "elimination" of its School of General Studies (SGS). In a letter to the college's president, Dr. John W. Kneller, AOJT president Philip Kluyat asserted.

"While the plan may or may not result in the saving of money for the city, it would impose an impossible task on the \$,000 SGS students who for a variety of reasons cannot attend early classes. Many of the students, matriculated and non-matriculated, work during the day; others are housewives who can attend only after their families have been taken care of; still others take certain specialized courses offered during the day only and must take their academic work in the evening."

This last group, Kipust noted, "includes thousands of yeshiva students, boys and girls." Brooking College, part of the City University, has one of the largest percentages of Jewish students in the system—an estimated 18,000 of a total of 28,000, of whom some 5,000 are Orthodox. As a result, Kipust pointed out, the "elimination" of the SGS would affect Jewish students more than any others.

Other Options Open To College

Kipust, a teacher at Eastern District High School in Brooklyn, said that the SGS "fellmination" will "fin effect" be "distormination" against Jewish students, since the administration could have chosen to cut back on such programs as open enrollment and remedial teaching, which primarily aid non-white students. Kipust stressed, however, that ideality he favored full-scale continuation of all these programs. What he opposes, he explained is the "injustice" of "helping one minority at the expense of another." He warned that he could "foresee it happening at the other colleges (here) too," though with not as much effect on the Jewish studentry.

The AOJT leader said he would give Dr. Kneller two more weeks to reply to his protest, which was mailed at the turn of the New Year. If there is no reply by then, he said, he would publicize the issue in the AOJT Newsietter, with the next stage—if necessary—being a letter—writing campaign directed at municipal and community leaders. He drew the line, however, at demonstrations, picketing or harassment. "We're not a group that goes in for those tactics," he explained.

Discrimination Charge Unfounded

An administration spokesman said he did not know if Kipusi's letter had been received. But he said the term "School of General Studies" was merely an "administrative" label and that fears such as those expressed by Kipust were unfounded. There have been charges that evening classes will be cancelled, "but that is not true," the spokesman asserted; the set-up will be "just like nobling has happened." The alleged discrimination, as he said he has told protesters "more than 500 times" is a "misconception" fostered by the "small group of students"—representing various campus factions—who regularly attend and speak up at campus meetings.

Dr. Kneller has said repeatedly in public statements that evening classes will not be adversely affected by the new development. In addition, City University Chancellor Robert J. Kibbee said Dec. 22 that there was "no plan" to "reduce or eliminate" evening classes anywhere within the system: "(Inpoint

of fact, quite the contrary is true." Kibbee said the protests were based on "patently misleading information." BOOBY-TRAP PARCELS CONTINUE TO ARRIVE

TEL AVIV, Jan. 6 (JTA)—Booby-trap parcets mailed from various European countries continued to arrive in larael today. A large parcel containing explosives was detected in the main distribution center of the Tel Aviv post office this morning. It was postmarized in Yugoslavia and addressed to the owner of a small shop who has no connection with security or government. Other bomb parcels that have arrived this week were addressed to public figures and the heads of industries engaged in defense work.

Five small parcels suspected of containing explosives were turned over to police for investigation. Most of the booby-trapped mail has come from Vienna or Belgrade. Some were mailed from Norway and Switzerland, Deputy Premier Yigal Allon said last night that he did not think that the wave of booby-trapped mail marked a resurgence of terrorist activity against Israel.

He told students at the Haifa Technion that they seemed to be a one-time sporadic effort by the terrorists to remind the world of their existence. He said yesterday's grenade explosions which injured six persons in Natanya and Kfar Saba had the same intent. He said that Israel's security services have apprehended almost all terrorist bombers in the past and would undoubtedly catch the perpetrators of yesterday's incidents.

MRS, MEIR SAYS DIALOGUE BEST WAY TO RESOLVE DIFFERENCES BETWEEN JEWS

JERUSALEM, Jan. 6 (JTA)--Premier Golda Meir agreed last night with the leader of the Orthodox Rabbinical Council of America that dialogue is the best way to resolve differences between observant and non-observant Jews in Israel and to preserve national unity. Mrs. Meir addressed the mid-winter conference of the Rabbinical Council which claims to be the largest Orthodox rabbinical body in North America. "If we want to live together then we must discuss matters. We must achieve the miracle of unity though this is not simple, but Jewish life was never a simple matter." in Premier gaid.

Rabbi Bernard Berzon, president of the Rabbinical Council had called earlier for dialogue and persuaston and urged observant Jews to eschew the violence employed recently by religious zealots. JOSEPH GREENE TO REPLACE BERGUS

WASHINGTON, Jan. 6 (JTA).—Joseph Nathantel Greene Jr., the career diplomat who will succeed Donald C. Bergus as the chief American representative in Caixo, was described today by diplomatic sources here as a "tery highly experienced officer" who despite lack of direct Middle East "operience is "not unknowledgeable about the area."

Although it is too soon to know how Greene will approach his new duties, it was pointed out that he has adhered to Nixon administration policy and is "in no way connected" with the State Department "Arabists."! He does not speak Arabist on source said that was not a major requis-

ite for the job and that he "probably will forego the intense training in Arabic if he gets into it at all."

Asked if Jewish diplomats were automatically not named to major posts in Arab countries—Greene is believed to be non-Jewish—one source insisted that was "a consideration that to the best of my knowledge doesn't come up." Asked to azme any Jewish diplomats now serving in such posts, the official said he could not as he did not think of appointees in terms of religion.

Date Of Shift Not Disclosed

State Department spokesman Charles Bray, in confirming Greene's appointment yesterday, dented "categorically" that Bergus was being replaced at Egypt's insistence. Bergus, it will be recalled, stirred confroversy last summer when he delivered to Cairo leaders a proposal for a Suez Canal pact-immediately dubbed the "phantom memo"—that varied from Nixon administration policy. Although the State Department defended Bergus as an outstanding diplomat, it was not long before he was recalled for an as yet unspecified "reassignment." The first scheduled replacement for Bergus was Michael Sterner, the Arabist who heads the State Department's Egyptian affairs desk and is a personalified of Egyptian President Anway Sadat.

Greene, SI, a native New Yorker, has held diplomatic posts over the past 30 years in countries around the world. Last fall he was named diplomat-in-residence at Brandels University. The specific date of Greene's shift to Catro has not yet been disclosed. He could not be reached for

comment.

GOLDMANN: PINCUS DISTORTED FACTS Challenges Pincus' Authority To Speak For 3 Million Soviet Jews

LONDON, Jan. 6 (3TA)—Dr. Nahum Goldmann, presidest of the World sewals Congress, replied sharply today to recent remarks by World Zionich Organization Executive chairman Louis Pincus justifying the WZO Executive's withdrawal of its invitation to Dr. Goldmann to address a festive session of the forthcoming World Zionist Congress In Jerusalem. Dr. Goldmann said that Pincus' references to his remarks on Soviet Jewry in a speech to the Board of Deputies of Spittleh Jews here Dec. 19 "distorted the facts."

He denied vigorously that he had "initied" alilys. (Immigration) of Soviet Jews, as Pincus charged or had given it a lower priority than the struggle for the rights of Jews who remain behind in the Soviet Union. He challenged Pincus' zuthority to speak for three million Soviet Jews and his right to proclaim a Zionist policy without the auth-

ority of a Zionist Congress.

Asserting that he had "no desire to enter into any polemics with Mr. Louis A. Pincus," Dr. Goldmann said "I cannot leave unanswered the statements made by him both on the personal level... and much more important on the level of principles in regard to policies on Soviet Jewry." Dr. Goldmann deolared; "In his reference to my address to the Board of Deputies of British Jews, Mr. Pincus distorted the facts. I never belittled the emigration of Soviet Jews to Israel and I never add that only a small number would leave."

Adhere: To Classic Position

Continuing, Dr. Goldmann stated: "I said that the majority would remain. I do not assume that Mr. Pincus expects the majority of three million Jews to come to Israel in the forceseable future. Nor did I try to diminish the centrality of the demand for emigration. I stressed again and again that I hoped that allya would increase, and that we must flight for it. But taking these demands for granted and accepted by all fewish organizations without exception, I criticized the position of those extremists, to whom it seems Mr. Pincus now belongs, who think that we have to stress only emigration and forget like fight for the rights of Jews who will remain in the Soylet Union."

In ortitoizing Dr. Goldmann, Pincus stated that it was not possible to conduct a struggle on two levels at the same time--namely the struggle for the right of aliya and the struggle for the right of Soviet Jews to a Jewish life, Pincus added that Dr. Goldmann reversed the priority and added that Soviet Jews themselves had chosen to fight

for aliya.

Referring to this, Dr. Goldmann said "There is no difference of opinion that at this moment priority should be given to the struggle for the right of aliya and it is absolutely incorrect that in my speech to the Board of Deputies I was reversing the order of priorities in the Jewish demands," he said. "But to go as far as to say that we should drop, or not press, the demand for the right to live as Jews for those who will not emigrate, is a serious departure from the classic Zionist position the world over."

Dr. Goldmann said he accepted the original invitation to address the Congress exestion voted to an appraisal of 75 years of Zionist history "only after pressure on the part of members of the Zionist Executive, including Mr. Pincus himself," He said that he had "informed Mr. Pincus that if there should be any danger of demonstrations against me at the festive session I would rather withdraw my acceptance.... Therefore, had Mr. Pincus been a little more considerate, he could easily have solved the problem by informing me that he could not guarantee that their would be no demonstrations, whereupon I should immediately have withdrawn."

NON-SMOKERS WIN REDUCED PREMIUMS

JERUSALEM, Jan. 6 (JTA)--The Uval Life Insurance Co, here has announced reduced premiums for non-smokers. Policy-holders regardless of age will pay premiums on the rates for persons two years younger, if they don't smoke, the company said. The discount is based on actuarial data which shows that persons smoking 20 or more cigarettes daily have a life expectancy five years less than a non-smoker.

Beth Din Decision:

FATHERHOOD THROUGH ARTIFICIAL INSEMINATION INVOLVES OBLIGATIONS

TEL AVIV, Jan. 6 (JTA)—The rabbinical Beth Din in Haifa issued today a decision said to have no precedent in Jewish jurisprudence—that fatherhood through artificial insemination is equivalent to natural fatherhood, and involves the same paternal obligations. The decision was handed down in the case of a man whose wife gave birth to triplets—two girls and a boy—after artificial insemination with the busband's own sperm following years of childlessness. Soon afterward, the husband sued for divorce. The wife, now 28, agreed, provided he paid for the children's support. He refused on grounds that he was not the legal father. The Beth Din decided otherwise, advising the man that if he wanted a divorce he must pay for the children's supringing.

NIXON HAS NAMED NO JEWS TO CABINET, HIGH COURT, DURING YEARS IN OFFICE Impressive Array In White House,

Executive Branch Staffs, Report Shows

WASHINGTON, Jan. 6 (JTA).—President Nixon, in his three years of office, has named no Jews to either of the two "show-places" of the federal government—the Cabinet and the Supreme Court. But there is an impressive array of Jews on the White House and Executive Branch staffs, some of them appointees of Nixon and others hold-overs from previous administrations, according to Hyman Bookbinder, Washington representative of the American Jewish Committee.

Writing in the AJCommittee's Washington Newsletter, Bookbinder noted that appointments to the Supreme Court and the Cabinet have in the past been symbolic of important breakthroughs for members of minority groups in America. But none of the 17 Cabinet members named by Nixon or the 15 individuals nominated by him or suggested to the American Bar Association for the Supreme Court, were Jews.

On the other hand, he wrote, "the record of Nixon appointments on other high levels is perhaps not generally appreciated." On the White House level, these include Dr. Henry Kissinger, "perhaps the most important Presidential appointment of all"; Leonard Garment, "with a broad portfolio that includes civil rights, arts and humanities, long term planning and much more"; William Saffre, the President's Chief speech drafter; Edward David, Special Advisor for Science and Technology; and Jerome Jafee, Special Consultant for Narcotics and Dangerous Drugs.

In the Executive Office, Bookbinder pointed out, are Herbert Stein, Chairman of the Council of Economic Advisors; Ezra Solomon, member of the Council; Arnold Weber, Executive Director of the Council and Romald Berman; Chairman of the National Endowment for the Humanities. In addition, Bookbinder noted, there is Arthur Burns, Chairman of the Federal Reserve Board and Jesse Steinfeld, Surgeon General of the US, At the sub-Cabinet level, Jews fill the posts of Undersecretary of Labor and assistant secretaries of Treasury; Defense; Health, Education and Welfare; Housing and Urban Development, and the Office of Management

SOVIET JEWISH FAMILY BEGIN PERIOD OF ADJUSTMENT

and Budget.

NEW YORK, Jan. 6 (JTA).—The Soviet Jewish family which arrived here yesterday under the Attorney General's "parole authority" is beginning the difficult task of adjusting to a new way of life. But even before they have a chance to find a permanent home or arrange for the two children's education, they will fly to Washington tomorrow morning to meet their legal benefactor, Attorney General John Mitchell.

Simeon Feldman, 36, his 34-year-old wife, Emma, and their children, Dina, 10, and Igor, 7, were the first Soviet Jews to emigrate to the US under the special "parole authority." They will be presented to Mitchell at the Justice Department by officials of the United Hiss Service, the world-wide Jewish migration service which helped arrange the Feldmans' emigration.

The Feldmans are living temporarily at the private single-story Broax home of Feldman's uncle, Cherles Miller, Miller, a hotel owner, had provided the "visov," (the request for emigration from relatives shorad) that is a prerequistic for obtaining a Soviet exit visa. Miller told the Jewish Telegraphio Agency today that he had not expected the Feldmans to arrive here for another few weeks and that he had not yet been able to arrange for an aparti-

ment for them.

Miller flew up from Miami Beach, Ploride, where he and his wife have a winter apartment, to greet his relatives upon their arrival. He said they would remain in his home until they found a place to live, perhaps in the Pelham Parkway area where he lives. Miller also said he would temporarily aid them financially. "They have nothing," he said, expressing concern over the prospects of finding a job for his nephew. Feldman had at one time worked as a locksmith and his last job in the Soviet Union was as a

supervisor in a plant that makes costume jewelry Feldman and his wife speak Yiddish, but the children do not, Miller said he hopes to place the youngsters in a public achool, but if that is not possible, he will explore the possibilities of having them attend a Hebrew day school.

NEW YORK, Jan. 6 (JTA)—Rabbi David Pollah, president of the Central Conference of American Rabbis, has called for an immediate reinstatement of Dr. Nahum Goldmann as speaker at the festive seasion at the forthcoming Zionist Congress in Jerusalem, regardless of explanations offered by Louis Pincus, chairman of the World Zionist Organization Executive. Rabbi Polish said that he agreed with Pincus' view presented in the Jewish Telegraphic Agency's News Bulletin yesterday that Soviet Jewish aliya must be given top priority in the campaign for the rights of the three million Russian Jews.

But, Rabbi Polish said, "One need not agree with Dr. Goldmann to take exception to the withdrawal. The chief issue is not Dr. Goldmann but the democratic process." He termed the Zionist scotton, "an act of moral and political folly," and observed that "at a time when the Zionist movement should be pulling fogether, its leadership seems determined to pursue a self-destructive course."

Rabbi Polish added: "This obstructionist venture is particularly objectionable because nothing in Dr. Goldmann's address which triggered the violent reactions warrants the blind and bureaucratic course taken by some Zionist leaders... The Zionist movement with which I have been identified throughout my life once thrived and rose to heroic heights in the areas of controversy and passionate debate. There is still need for such a movement, but if its officials persist in stifling free expression, they will have lost the future in their dibbous triumph" (over Dr. Goldmann).

SHAZAR PRAISES CONTRIBUTIONS TO KH-UIA

JERUSALEM, Jan. 6 (JTA)—President Zalman Shazar praised Israell contributions to the Keren Hayesod-United Israel Appeal here last night. ABC newmen Howard K, Smith and Ted Koppel during a television interview. "We have had no fighting there (the Middle Early for about 18 months so that in itself is an encouraging fact. Now we hope that we will be able to get negotiations started," Regers said. (At the United Nations today it was announced that Dr. Jarring is expected back there Monday.)

No Indications Phantoms Included

Rogers said the US would supply arms to larsel to enable it to defend itself and deter the Arabs from attacking. "On the other hand, we do not want our support to Israel to sppear to be encouraging larsel, itself to start hostilities," he said. Asked about larsel's long standing request for more Pfinitom jets, Rogers repiled:

"We have followed the policy for some time of attempting to maintain a military balance in the Middle East. By that we mean that we will provide arms to Israel in order to make sure that they can defend thenselves. If that were not the case, it would be de-stabilizing. It would be incentive for the other side to start a conflict."

Rogers declined to state the type of arms going to Israel or the timetable of shipments. "We expect to supply arms to Israel to be sure the balance doesn't shift," considering the continued Soviet military shipments to Egypt, he said. State Department spokesman Charles Bray had "no comment" today when asked whether Phantom jets are included in the flow of arms to Israel which Rogers referred to last night. The Rogers interview was aired on the ABC television network but was not picked up by ABC affiliates in some cities including New York.

POMPIDOU, BEN NATAN CONFER Total Blackout On Discussion

PARIS, Jan. 6 (JTA)--President Georges Pompidou and Israeli Ambassador Ben Natan conferred for over an hour this evening in an attempt to break the deadlock in Franco-Israeli negotiations over reimbursement for 50 embargeed Israeli Mirage V jets. The Israeli envoy had no comment for newamen as he left the Elysee Palace. Questioned later by the Jewish Telegraphic Agency, he declined to say whether he was optimistic or pessimistic over the outcome of the negotiations.

A complete blackout prevailed on the subjects discussed by Pomidou and Ben Natan. They are believed to have covered the Middle East crists and other areas of mutual interest in addition to the Mirages. It was learned that despite the length of their meeting, the matier of Israel's status in the European Common Market was not raised due to "lack of time." Prior to the meeting, that subject was said to have been on the agenda. The lack of any news emanating from the meeting indicated to some observers here that no tangible results were achieved and that Pompidou probably gave non-committal replies.

TERRORISTS KILL, MUTILATE BODY OF DEFENSE MINISTRY EMPLOYE

TEL AVIV, Jah. 6 (JTA)—A 24-year-old Defense Ministry employe was murdered this morning by terrorists who multisted his body. The victim was Joseph Grubber of Haifa, who worked for the Ministry's construction department. He was killed while inspecting construction work near Alma vilage, close to the Syrian border. The terrorists dragged his body toward the border, mutilated it and severed his head.

Israeli security forces uncovered two large terrorist aims caches in the Caza Strip today, one of them yielding the biggest hau of hand grenades ever found in one place. Eighteen Bedouins in the area were arrested and charged, with membership in terrorist organizations and sabotage. They were also charged with attacks on Israeli Army patrols. Among the hidden arms discovered were 200 grenades, 105 explosive bricks, 41 mines, 117 detonators, seven automatic submachine gune, six Russian rif-les; one Israel-made Uzzi submachinegun and a large quantity of animunition.

ORTHODOX TEACHERS' GROUP SAYS 'ELIMINATION' OF COLLEGE DEP'T DISCRIMINATES AGAINST JEWS

NEW YORK, Jan. 6 (JTA).—The Association of Orthodox Jewish Teachers of the New York City Public Schools, which claims to represent 5,000 of the city's 70,000 public school teachers, has protested the "discrimination" against Jowish students in Brooklyn College's "elimination" of its School of General Studies (SGS). In a letter to the college's president, Dr. John W. Kneller, AOJT president Philip Kluyat asserted.

"While the plan may or may not result in the saving of money for the city, it would impose an impossible task on the \$,000 SGS students who for a variety of reasons cannot attend early classes. Many of the students, matriculated and non-matriculated, work during the day; others are housewives who can attend only after their families have been taken care of; still others take certain specialized courses offered during the day only and must take their academic work in the evening."

This last group, Kipust noted, "includes thousands of yeshiva students, boys and girls." Brooking College, part of the City University, has one of the largest percentages of Jewish students in the system—an estimated 18,000 of a total of 28,000, of whom some 5,000 are Orthodox. As a result, Kipust pointed out, the "elimination" of the SGS would affect Jewish students more than any others.

Other Options Open To College

Kipust, a teacher at Eastern District High School in Brooklyn, said that the SGS "fellmination" will "fin effect" be "distormination" against Jewish students, since the administration could have chosen to cut back on such programs as open enrollment and remedial teaching, which primarily aid non-white students. Kipust stressed, however, that ideality he favored full-scale continuation of all these programs. What he opposes, he explained is the "injustice" of "helping one minority at the expense of another." He warned that he could "foresee it happening at the other colleges (here) too," though with not as much effect on the Jewish studentry.

The AOJT leader said he would give Dr. Kneller two more weeks to reply to his protest, which was mailed at the turn of the New Year. If there is no reply by then, he said, he would publicize the issue in the AOJT Newsietter, with the next stage—if necessary—being a letter—writing campaign directed at municipal and community leaders. He drew the line, however, at demonstrations, picketing or harassment. "We're not a group that goes in for those tactics," he explained.

Discrimination Charge Unfounded

An administration spokesman said he did not know if Kipusi's letter had been received. But he said the term "School of General Studies" was merely an "administrative" label and that fears such as those expressed by Kipust were unfounded. There have been charges that evening classes will be cancelled, "but that is not true," the spokesman asserted; the set-up will be "just like nobling has happened." The alleged discrimination, as he said he has told protesters "more than 500 times" is a "misconception" fostered by the "small group of students"—representing various campus factions—who regularly attend and speak up at campus meetings.

Dr. Kneller has said repeatedly in public statements that evening classes will not be adversely affected by the new development. In addition, City University Chancellor Robert J. Kibbee said Dec. 22 that there was "no plan" to "reduce or eliminate" evening classes anywhere within the system: "(Inpoint

of fact, quite the contrary is true." Kibbee said the protests were based on "patently misleading information." BOOBY-TRAP PARCELS CONTINUE TO ARRIVE

TEL AVIV, Jan. 6 (JTA)—Booby-trap parcets mailed from various European countries continued to arrive in larael today. A large parcel containing explosives was detected in the main distribution center of the Tel Aviv post office this morning. It was postmarized in Yugoslavia and addressed to the owner of a small shop who has no connection with security or government. Other bomb parcels that have arrived this week were addressed to public figures and the heads of industries engaged in defense work.

Five small parcels suspected of containing explosives were turned over to police for investigation. Most of the booby-trapped mail has come from Vienna or Belgrade. Some were mailed from Norway and Switzerland, Deputy Premier Yigal Allon said last night that he did not think that the wave of booby-trapped mail marked a resurgence of terrorist activity against Israel.

He told students at the Haifa Technion that they seemed to be a one-time sporadic effort by the terrorists to remind the world of their existence. He said yesterday's grenade explosions which injured six persons in Natanya and Kfar Saba had the same intent. He said that Israel's security services have apprehended almost all terrorist bombers in the past and would undoubtedly catch the perpetrators of yesterday's incidents.

MRS, MEIR SAYS DIALOGUE BEST WAY TO RESOLVE DIFFERENCES BETWEEN JEWS

JERUSALEM, Jan. 6 (JTA)--Premier Golda Meir agreed last night with the leader of the Orthodox Rabbinical Council of America that dialogue is the best way to resolve differences between observant and non-observant Jews in Israel and to preserve national unity. Mrs. Meir addressed the mid-winter conference of the Rabbinical Council which claims to be the largest Orthodox rabbinical body in North America. "If we want to live together then we must discuss matters. We must achieve the miracle of unity though this is not simple, but Jewish life was never a simple matter." in Premier gaid.

Rabbi Bernard Berzon, president of the Rabbinical Council had called earlier for dialogue and persuaston and urged observant Jews to eschew the violence employed recently by religious zealots. Other speakers hast night included Minister for Religious Affairs Zerach Warhaftly who urged Mrs. Metr to agree to change the Law of Reiturn so that it complies with the halachic (religious law) definition of who is a Jew

JOSEPH GREENE TO REPLACE BERGUS

WASHINGTON, Jan. 6 (JTA).—Joseph Nathantel Greene Jr., the career diplomat who will succeed Donald C. Bergus as the chief American representative in Caixo, was described today by diplomatic sources here as a "tery highly experienced officer" who despite lack of direct Middle East "operience is "not unknowledgeable about the area."

Although it is too soon to know how Greene will approach his new duties, it was pointed out that he has adhered to Nixon administration policy and is "in no way connected" with the State Department "Arabists."! He does not speak Arabist on source said that was not a major requis-

ite for the job and that he "probably will forego the intense training in Arabic if he gets into it at all."

Asked if Jewish diplomats were automatically not named to major posts in Arab countries—Greene is believed to be non-Jewish—one source insisted that was "a consideration that to the best of my knowledge doesn't come up." Asked to azme any Jewish diplomats now serving in such posts, the official said he could not as he did not think of appointees in terms of religion.

Date Of Shift Not Disclosed

State Department spokesman Charles Bray, in confirming Greene's appointment yesterday, dented "categorically" that Bergus was being replaced at Egypt's insistence. Bergus, it will be recalled, stirred confroversy last summer when he delivered to Cairo leaders a proposal for a Suez Canal pact-immediately dubbed the "phantom memo"—that varied from Nixon administration policy. Although the State Department defended Bergus as an outstanding diplomat, it was not long before he was recalled for an as yet unspecified "reassignment." The first scheduled replacement for Bergus was Michael Sterner, the Arabist who heads the State Department's Egyptian affairs desk and is a personalified of Egyptian President Anway Sadat.

Greene, SI, a native New Yorker, has held diplomatic posts over the past 30 years in countries around the world. Last fall he was named diplomat-in-residence at Brandels University. The specific date of Greene's shift to Catro has not yet been disclosed. He could not be reached for

comment.

GOLDMANN: PINCUS DISTORTED FACTS Challenges Pincus' Authority To Speak For 3 Million Soviet Jews

LONDON, Jan. 6 (3TA)—Dr. Nahum Goldmann, presidest of the World sewals Congress, replied sharply today to recent remarks by World Zionich Organization Executive chairman Louis Pincus justifying the WZO Executive's withdrawal of its invitation to Dr. Goldmann to address a festive session of the forthcoming World Zionist Congress In Jerusalem. Dr. Goldmann said that Pincus' references to his remarks on Soviet Jewry in a speech to the Board of Deputies of Spittleh Jews here Dec. 19 "distorted the facts."

He denied vigorously that he had "initied" alilys. (Immigration) of Soviet Jews, as Pincus charged or had given it a lower priority than the struggle for the rights of Jews who remain behind in the Soviet Union. He challenged Pincus' zuthority to speak for three million Soviet Jews and his right to proclaim a Zionist policy without the auth-

ority of a Zionist Congress.

Asserting that he had "no desire to enter into any polemics with Mr. Louis A. Pincus," Dr. Goldmann said "I cannot leave unanswered the statements made by him both on the personal level... and much more important on the level of principles in regard to policies on Soviet Jewry." Dr. Goldmann deolared; "In his reference to my address to the Board of Deputies of British Jews, Mr. Pincus distorted the facts. I never belittled the emigration of Soviet Jews to Israel and I never add that only a small number would leave."

Adhere: To Classic Position

Continuing, Dr. Goldmann stated: "I said that the majority would remain. I do not assume that Mr. Pincus expects the majority of three million Jews to come to Israel in the forceseable future. Nor did I try to diminish the centrality of the demand for emigration. I stressed again and again that I hoped that allya would increase, and that we must flight for it. But taking these demands for granted and accepted by all fewish organizations without exception, I criticized the position of those extremists, to whom it seems Mr. Pincus now belongs, who think that we have to stress only emigration and forget like fight for the rights of Jews who will remain in the Soylet Union."

In ortitoizing Dr. Goldmann, Pincus stated that it was not possible to conduct a struggle on two levels at the same time--namely the struggle for the right of aliya and the struggle for the right of Soviet Jews to a Jewish life, Pincus added that Dr. Goldmann reversed the priority and added that Soviet Jews themselves had chosen to fight

for aliya.

Referring to this, Dr. Goldmann said "There is no difference of opinion that at this moment priority should be given to the struggle for the right of aliya and it is absolutely incorrect that in my speech to the Board of Deputies I was reversing the order of priorities in the Jewish demands," he said. "But to go as far as to say that we should drop, or not press, the demand for the right to live as Jews for those who will not emigrate, is a serious departure from the classic Zionist position the world over."

Dr. Goldmann said he accepted the original invitation to address the Congress exestion voted to an appraisal of 75 years of Zionist history "only after pressure on the part of members of the Zionist Executive, including Mr. Pincus himself," He said that he had "informed Mr. Pincus that if there should be any danger of demonstrations against me at the festive session I would rather withdraw my acceptance.... Therefore, had Mr. Pincus been a little more considerate, he could easily have solved the problem by informing me that he could not guarantee that their would be no demonstrations, whereupon I should immediately have withdrawn."

NON-SMOKERS WIN REDUCED PREMIUMS

JERUSALEM, Jan. 6 (JTA)--The Uval Life Insurance Co, here has announced reduced premiums for non-smokers. Policy-holders regardless of age will pay premiums on the rates for persons two years younger, if they don't smoke, the company said. The discount is based on actuarial data which shows that persons smoking 20 or more cigarettes daily have a life expectancy five years less than a non-smoker.

Beth Din Decision:

FATHERHOOD THROUGH ARTIFICIAL INSEMINATION INVOLVES OBLIGATIONS

TEL AVIV, Jan. 6 (JTA)—The rabbinical Beth Din in Haifa issued today a decision said to have no precedent in Jewish jurisprudence—that fatherhood through artificial insemination is equivalent to natural fatherhood, and involves the same paternal obligations. The decision was handed down in the case of a man whose wife gave birth to triplets—two girls and a boy—after artificial insemination with the busband's own sperm following years of childlessness. Soon afterward, the husband sued for divorce. The wife, now 28, agreed, provided he paid for the children's support. He refused on grounds that he was not the legal father. The Beth Din decided otherwise, advising the man that if he wanted a divorce he must pay for the children's supringing.

NIXON HAS NAMED NO JEWS TO CABINET, HIGH COURT, DURING YEARS IN OFFICE Impressive Array In White House,

Executive Branch Staffs, Report Shows

WASHINGTON, Jan. 6 (JTA).—President Nixon, in his three years of office, has named no Jews to either of the two "show-places" of the federal government—the Cabinet and the Supreme Court. But there is an impressive array of Jews on the White House and Executive Branch staffs, some of them appointees of Nixon and others hold-overs from previous administrations, according to Hyman Bookbinder, Washington representative of the American Jewish Committee.

Writing in the AJCommittee's Washington Newsletter, Bookbinder noted that appointments to the Supreme Court and the Cabinet have in the past been symbolic of important breakthroughs for members of minority groups in America. But none of the 17 Cabinet members named by Nixon or the 15 individuals nominated by him or suggested to the American Bar Association for the Supreme Court, were Jews.

On the other hand, he wrote, "the record of Nixon appointments on other high levels is perhaps not generally appreciated." On the White House level, these include Dr. Henry Kissinger, "perhaps the most important Presidential appointment of all"; Leonard Garment, "with a broad portfolio that includes civil rights, arts and humanities, long term planning and much more"; William Saffre, the President's Chief speech drafter; Edward David, Special Advisor for Science and Technology; and Jerome Jafee, Special Consultant for Narcotics and Dangerous Drugs.

In the Executive Office, Bookbinder pointed out, are Herbert Stein, Chairman of the Council of Economic Advisors; Ezra Solomon, member of the Council; Arnold Weber, Executive Director of the Council and Romald Berman; Chairman of the National Endowment for the Humanities. In addition, Bookbinder noted, there is Arthur Burns, Chairman of the Federal Reserve Board and Jesse Steinfeld, Surgeon General of the US, At the sub-Cabinet level, Jews fill the posts of Undersecretary of Labor and assistant secretaries of Treasury; Defense; Health, Education and Welfare; Housing and Urban Development, and the Office of Management

SOVIET JEWISH FAMILY BEGIN PERIOD OF ADJUSTMENT

and Budget.

NEW YORK, Jan. 6 (JTA).—The Soviet Jewish family which arrived here yesterday under the Attorney General's "parole authority" is beginning the difficult task of adjusting to a new way of life. But even before they have a chance to find a permanent home or arrange for the two children's education, they will fly to Washington tomorrow morning to meet their legal benefactor, Attorney General John Mitchell.

Simeon Feldman, 36, his 34-year-old wife, Emma, and their children, Dina, 10, and Igor, 7, were the first Soviet Jews to emigrate to the US under the special "parole authority." They will be presented to Mitchell at the Justice Department by officials of the United Hiss Service, the world-wide Jewish migration service which helped arrange the Feldmans' emigration.

The Feldmans are living temporarily at the private single-story Broax home of Feldman's uncle, Cherles Miller, Miller, a hotel owner, had provided the "visov," (the request for emigration from relatives shorad) that is a prerequistic for obtaining a Soviet exit visa. Miller told the Jewish Telegraphio Agency today that he had not expected the Feldmans to arrive here for another few weeks and that he had not yet been able to arrange for an aparti-

ment for them.

Miller flew up from Miami Beach, Ploride, where he and his wife have a winter apartment, to greet his relatives upon their arrival. He said they would remain in his home until they found a place to live, perhaps in the Pelham Parkway area where he lives. Miller also said he would temporarily aid them financially. "They have nothing," he said, expressing concern over the prospects of finding a job for his nephew. Feldman had at one time worked as a locksmith and his last job in the Soviet Union was as a

supervisor in a plant that makes costume jewelry Feldman and his wife speak Yiddish, but the children do not, Miller said he hopes to place the youngsters in a public achool, but if that is not possible, he will explore the possibilities of having them attend a Hebrew day school.

NEW YORK, Jan. 6 (JTA)—Rabbi David Pollah, president of the Central Conference of American Rabbis, has called for an immediate reinstatement of Dr. Nahum Goldmann as speaker at the festive seasion at the forthcoming Zionist Congress in Jerusalem, regardless of explanations offered by Louis Pincus, chairman of the World Zionist Organization Executive. Rabbi Polish said that he agreed with Pincus' view presented in the Jewish Telegraphic Agency's News Bulletin yesterday that Soviet Jewish aliya must be given top priority in the campaign for the rights of the three million Russian Jews.

But, Rabbi Polish said, "One need not agree with Dr. Goldmann to take exception to the withdrawal. The chief issue is not Dr. Goldmann but the democratic process." He termed the Zionist scotton, "an act of moral and political folly," and observed that "at a time when the Zionist movement should be pulling fogether, its leadership seems determined to pursue a self-destructive course."

Rabbi Polish added: "This obstructionist venture is particularly objectionable because nothing in Dr. Goldmann's address which triggered the violent reactions warrants the blind and bureaucratic course taken by some Zionist leaders... The Zionist movement with which I have been identified throughout my life once thrived and rose to heroic heights in the areas of controversy and passionate debate. There is still need for such a movement, but if its officials persist in stifling free expression, they will have lost the future in their dibbous triumph" (over Dr. Goldmann).

SHAZAR PRAISES CONTRIBUTIONS TO KH-UIA

JERUSALEM, Jan. 6 (JTA)—President Zalman Shazar praised Israell contributions to the Keren Hayesod-United Israel Appeal here last night. Addressing a meeting of UIA workers in his home he said the Keren Hayesod-United Israel Appeal and the Jewish National Fund hadraised sufficient funds in Israel since the Six-Day War to establish ten border settlements despite the heavy taxation imposed on the country's citisens and the Army reserve duty to which they are called every year. Chazar said almost half of Israel's labor force are regular monthly contributors to the UIA.
