THREE KIEV JEWS ARRESTED ON WAY TO SYNAGOGUE; CHARGED WITH HOOLIGANISM

TEL'AVIV, March 5 (JTA).—Three Jews were arrested yesterday on their way to the synagogue in Kiev and sentenced to 15-day jail terms for alleged "hooliganism," the Jewish Telegraphic Agency learned today in a telephone conversation with Jewish sources in Kiev. The three were identified as igor Mendel, Alexander Feldman and Yuri Soroka. A fourth Jew, unidentified, was arrested at the same time but was released after paying a fine.

According to the sources, the four were surrounded by KGB (secret police) agents while walking to the local synagogue and after brief questioning were pushed into a car and taken to the police station. They were charged with hooliganism and interfering with policemen in performan e of their duties. This was the third consecutive weekend marked by arrests of Jews at the synagogue. The sources claim that the arrests are part of the KGB efforts to prevent Jews seeking exit visas from meeting in the synagogue.

SOVIET-LIBYAN OIL PACT VIEWED
AS MARRIAGE OF CONVENIENCE
Pact Breaks Western Oil Monopoly
But USSR Unlikely To Play Maior Role

JERUSALEM, March 5 (JTA)—The disclosure in Moscow last night of a Soviet agreement with Libya to jointly develop that country's oil resources was viewed here today as primarily a marriage of convenience for both parties. Although the agreement breaks the Western oil monopoly in Libya, it is not considered likely that Russia will play a major role in the Libyan oil industry nor is it expected to alter the strong internal anti-Communist stand of Libya's ruling military junta headed by Col. Muammar ei-Qaddafi. According to Tass, the pact was signed Feb. 29.

According to a report in Tass, the Soviet press agency, the pact which was reached with a Libyan delegation in Moscow, includes prospecting for mineral deposits and gas, training Libyan national cadres, provides for cooperation in prospecting, extracting and refining oil, and in developing power generation and other branches of Libya's national economy.

Qaddafi, who has likened Soviet imperialism to Western imperialism, has been uncomfortable in relation to his partners in the loose federation he entered into last Sept, with Egypt and Syris, both courties with strong ties to Moscow. But he regards the agreement with Moscow as political leverage in dealing with the West which he mistrusts no less than the Soviet Union.

USSR Desperate For Allies

Observers here said the main reason the Soviet Union signed the pact was its inability to develop its own oil resources fast enough to keep pace with its industrial expansion. The USSR is said to be lagging by as much as 10 years in this endeavor. The Soviet Union once an oil exporting nation, has in recent years become an importer of oil.

The Soviet-Libyan deal confirmed what political observers have known for years—that boviet relations with any country has little to do with that country's regime or ideology. This is the case in Egypt where the Communist Party is Illegal. It is most evident in Russia's brisk trade with Spain whose reg-

ime under Gen. Franco is regarded as Fascist by the USSR. Observers here said that Russia's need for Middle East oil may eventually lead it to deals with Saudi Arabia which is vehemently anti-Communist.

THREE NAZI WAR CRIMINALS WILL NOT BE RELEASED -- FOR TIME BEING

AMSTERDAM, March 5 (JTA)—The Netherlands government announced last night that it has decided not to release, for the time being, the last three Nazi war criminals serving sentences in Breda prison. But the television announcement by Premier Barend Blesheuvel and Justice Minister Andries Van Agt did not preclude the eventual release of the prisoners on an individual basis. The government leaders said the decision took serious account of last Wednesday's 85-61 vote by the Dutch Parliament against pardons.

However, the government plans to examine the mental and physical condition of each prisoner by a committee of experts who have the confidence of various groups opposed to a pardon. The prisoners are Franz Fischer, 70, Joseph Kotaella, 65 and Ferdinand Aus Den Fuenten, 73, All have been imprisoned since 1945.

The local Jewish community continued to be split over the issue. Rabbi Abraham Soetendorp, 29, of the Amsterdam Liberal Congregation, who is considered the main spokesman for the Jewish community following his father's retirement last week, expressed regret that the government has not definitely rejected clemency for the ex-Nazis. But Prof. August Belinfante, a former Rector of Amsterdam University and a Jewish spokesman, sharply condemned the anti-pardon demonstrations while Parliament was debating last week, and the attacks on the Justice Minister.

Jews Must Abandon Cemetery JEWISH COMMUNITY SHOCKED; CASE TO BE HEARD BY FRENCH SUPREME COURT

MARSEILLES, March' 5 (3TA)—Members of the Jewish community of Marseilles have expressed shock over a court decision requiring the community to abandon the Jewish cemetery of Trois Lucs just outside this city, and to empty the graves of the cemetery. In the mid-60s, when a large part of North African Jewys settled in southern France, North African Jewish leaders decided, in accordance with tradition, not to bury their dead together with non-Jews. Most cemeteries in France are mixed in that respect, including the Saint Pierre cemetery in Marseilles.

Accordingly, the new Jewish community here acquired a lot in the middle of Marseilles but municipal officials, opposing the proposed Jewish cemetery as conflicting with town planning projects, proposed an exchange of lands. The Jewish community accepted the ground on which the Trois Lucs cemetery was set up. But the Jewish Chevrah Kadishah (burial society) of the Israelite Cultural Association of Marseilles, failed to comply with French regulations for creation of a new cemetery.

The owners of neighboring plots, contending the presence of the new graveyard caused a decline in the prices of their plots, went into court to stop the Jewish cometery. A Marsetlles'court is sued a series of injunctions to the Chevrah Kadishah
to stop burials in the Trois Lucs cemetery and to
empty existing graves by March 10. The Jewish community appealed the court orders but the higher Aix
En Provence court ruled against the community,
finding that it had not met the regulations for a new
cemetery. Jewish religious law bars disinterment
of Jewish dead.

Observant families of Jewish deceased buried at Trois Lucs are protesting bitterly both against the Jewish community and French authorities. The Chevrah Kadishah has been warned by the court it will have to pay a fine for each day after March 10 that the court injunction has not been compiled with The case will be heard by the French Supreme Court but the Aix court decision, under French law, must meanwhile be obeyed.

An association for the defense of the Trois Lucs cemetery has been formed. Both the French Jewish Consistory and the French rabbinate have expressed their opposition to any transfer of dead burled at Trois Luce as a violation of Jewish religious law.

ISRAEL'S SYRIA-LEBANON BORDERS QUIET Dayan, Elazar Warn Of Swift Reprisals Against Any New Terrorist Activities

TELAVIV, March 5 (TA)—Israel's borders with Syria and Lebanon, scenes of ground and air fighting last week, remained peaceful today. But Defense Minister Moshe Dayan and Chief of Staff Gen. David Elizar have both warned that any new terrorist activities against Israel from either country would be dealt with swiftly and decisively.

Today, the roads of northern Israel were packed with traffic and visitors who came to view the scene of last week's Israeli thrust into "Fatahland" in southeast Lebanon. Lebanese farmers were back working their fields and many waved to Israelis driving along the border. The ski runs on the slopes of Mt. Hermon drew today an estimated 5,000 people. But Israeli military leaders conceded that the scene could change back to one of battle

Speaking on television Friday night, Dayan said larnell forces were prepared to cross the Lebanese border again if necessary. He said the entry of the Lebanese Army into "Fratahland" after Israell forces cleared parts of it of terrorists indicated a fundamental change of policy in Betrut which previously had yielded virtual control of the region to the terrorists. However, he warned, this may not be enough to ensure peace.

Syrians Hit And Ran

Dayan said israel would be satisfied only when the Lebanese authorities and their army adopt and carry out a vigorous, decisive stand against terrorist gangs. He said he thought the Lebanese government "will try at least to restrict, perhaps to control immediately, the area and not to allow the Fatah to act either from Lebanon or to cross the border." But he was less certain that Syria would make any effort to curtail the activities of terrorists on their soil who, unlike those in Lebanon, function under the direct control of the Syrian Army.

Syrian planes attacked Israeli settlements in the Golan Heights last week following Israeli air strikes and shelling of terrorist bases in Syria. The attacks caused no casualities and minimal damago. Speaking yesterday on Kol Israel radio, Elazar described them as "fult and run," observing that "they hit very little and ran very fast."

But, he said, the Syrian attack confirmed that Syrian armed forces actively support the terrorists. "That was one reason why our counter-strike could not make an absolute distinction between the Syrian Army and terrorist bases and we were compelled occasionally to hit out at both," he said. According to Elazar, the terrorists suffered dozens of casualties in the latest Israeli

BRANDT TO USE INFLUENCE IN MOSCOW TO HELP CAUSE OF SOVIET JEWRY

BONN, March 5 (JTA).—Chancellor Willy Brandt promised a visiting B'nat B'rith delegation from the United States that he would use his newly won contacts and influence in Moscow to help the cause of Soviet Jews. The West German leader said he fully understood the need for West Germany to participate in international efforts to help ease the plight of Jews in Eastern Europe, particularly those in the Soviet Union.

Brandt met for an hour last Friday with the delegation headed by Rabbi Benjamin Kahn, executive vice-president of B'nati B'rith and Herman Edelsberg, director of its international council. Brandt told the delegation that its fears that West Germany's improved ties with the Arab states would be at the excense of its rela-

tions with Israel were unfounded.

He said his government intended to strengthen and broaden its ties with Israel and believes that German-Israel trade, German investments in Israel and joint German-Israel investments in Israel and joint German-Israel investments in third countries should be expanded. Brandt told the visitors that he hoped to accept Premier Golda Meir's invitation to visit Israel after the parilamentary summer recess. He said he expected to discuss details of the visit with Mrs. Meir when they meet in June at the Socialist International convention in Vienna.

BANZER: FATE OF BARBIE-ALTMANN IS UP TO THE BOLIVIAN COURTS

PARIS, March 5 (JTA).—The exchange of letters between President Georges Pompidou and Col. Hugo Banzer, President of Bolivia, over the extradition of wanted Nazi war criminal Klaus Barbie, was published here yesterday for the first time. According to Banzer, the matter is one for the Bolivian courts to decide.

France has asked for the extradition of Klaus Altmann, a Bolivian citizen of German extraction who is identified as Barble according to a mass of evidence recently unearthed. Barble is wanted for the murder of a French resistance leader and the deportation of countless French Jews in Lyons where he was gestape obtied during World War II.

Pompidou wrote to Banzer that Barble is "a war oriminal and torturer of many Frenchmen....
Time crases many things but not everything,"
The French people, Pompidou noted, cannot accept war orimes being "forgotten in indifference."
Banzer replied that France must trust the "nobility of my country" and the "Glear moral tradition of Bolivian justice" in deciding Altmann's
fate.

Barble-Altmann was tracked down by Mrs. Beate Klarsfeld, an anti-Nazi German married to a French Jew. Primarily through her efforts, French military judges last month obtained documents from the West German Attorney General which are said to confirm that Altmann is Barble. One obstacle to the French extradition request is Bolivia's 20-year statute of limitations on crimes. Another is Bolivia's policy not to extradite its citizens.

EGYPT'S RULING CIRCLES DIFFER ON SOLUTION TO CONFLICT WITH ISRAEL Heikal; Egypt Should Abandon Demand That Israel Commit Itself A Priori To Withdrawal; Draws Arabs' Wrath

JERUSALEM, March 5 (JTA)—Major differences within Egypt's ruling circles over a solution to the conflict with Israel Emerged over the week-end, Mohammed Hassanein Heikal, editor-in-chief of the influential Cairo daily, Al Ahram, hinted in his signed column Friday that Egypt would do well to abandon its insistence on a prior Israell commitment to withdrawal from the occupied territories as the price of peace necotiations.

But the official government newspaper, Al Gumhurlya, today criticized Helkal, but without menticring him by name, for suggesting to the Egyptian people that they have any alternative but force in dealing with Israel. Helkal, nevertheless, is considered a close confidant of President Anwar Sadat, a relationship that he also enjoyed with the late President Nasser, and his column in Al Ahram has frequently reflected government views. Observers here said it was unlikely that his latest article was published without the prior approval of Sadat or someone acting on Sadat's behalf.

In the column, which was promptly blasted by Arab news media in Amman, Bertut and Algiers, Heikal dismissed as "childish" a political solution "which is based on insisting on the last step even before the first step has begun," The phraseology was seen as a hint that Egypt may be willing to drop its demand for an Israeli withdrawal commitment as a prerequisite for either an overall settlement under the aegis of United Nations mediator Dr. Gunnar V, Jarring or an American-sponsored interim accord to reopen the Suez Canal.

Seen As Trial Balloon

Some observers believe Heikal's suggestion represented a trial balloon and Al Gumhurtya's criticism of it a way out for the government should public reaction be unfavorable. Al Gumhurtya referred obliquely-to "persons who might spread confusing ideas among the Egyptian people" and warned that such persons who are obvicusly not sufficiently familiar with events should refrain from leading the Egyptian people into believing that there are several alternatives.

According to the government newspaper, there is only one solution to the Middle East conflict which has already been laid down: "What has been taken by force can only be retrieved by force. There is no difference of opinion about this." the paper said.

Heikal, on the other hand, discarded military solutions or diplomatic efforts through international law and UN resclutions, He wrote that a "revolutionary solentific solution is the only acceptable solution." He defined a "revolutionary solentific solution." as one which employs "all available means—diplomatic, economic, armed forces in accordance with modern calculations, and enlightened propaganda which gains the maximum amount of support for this conflict, and stands hased on principles which guarantee the broadest front of friends and allies to prevent the enemy from imposing his will."

No Surrender To 'Zionist Enemy'

Heikal claimed that such methods were being utilized by China to regain sovereignty over Taiwan and by the Vietnamese revolution to achieve the complete withdrawal of US troops from the whole of Indochina, According to Heikal, achievement of a political solution has failed in the Middle East conflict "because we have forgotten--I will not say have

neglected -- to utilize the other methods."

His remarks appeared at a time when the Egyptian government appeared to be resting high hopes on the reactivation of the Jarring peace mission while at the same time intensitying tep reparations for war. The Amman newspaper, A Destour, denounced the Egyptian editor for advocating an Arab surrender to a political solution not based on the Security Council's Resolution 242.

The Daily Star, Beirut's English-language newspaper, urged Egypt to dissociate itself of-ficially from Heikal's views. The pro-Iraqi Lebanese newspaper, Beirut, sald a close examination of Heikal's article would lead to popular support of the Cairo students' recent demands that the Al Ahram editor stand trial. The paper accused Heikal of hostility towards the Arab masses and "advocation of surrender to the US and the Zionist enemy." The official Algerian news agency criticized Heikal for "defeatism."

Meanwhile, it was reported that Sadat is scheduled to tour several Arab countries this week to discuss means of strengthening the Arab position against Israel in the wake of Israel's actions against Lebanon and Svria.

ANTI-SEMITIC PAMPHLET SPREADING RAPIDLY IN ARGENTINA AMONG WORKERS

BUENCS AIRES, March 5 (JTA)—A rightwing politican's anti-Semitic pamphlet in the style of the Protocols of the Elders of Zion, is spreading rapidly in Argentina, particularly in the southern region of the country and among factory workers. The Jewish community, through its representative body, the DAIA, has expressed growing concern, especially as the newspaper, Noticias, in the provincial city of Tucuman, has accepted the allegations against Jews as fact and continues in its editorials to demand a full-scale investigation by all government agencies.

The charge, that Jews are plotting to dismember Argentina and create a Jewish State in Patagonia, the country's southernmost province, was first made two months ago by Dr. Beveraggi Allende, a political science professor, in an open letter to Jose Rucci, secretary-general of the powerful Peronista General Confederation of Labor. Allende claimed that virtually all facets of life in Argentina were controlled by Jews.

Noticias gave the Allende letter front page prominence. Yesterday, it urged in an editorial that "The enemies of the country must be fought energetically" and demanded rigorous punishment for the alleged conspirators. The newspaper castigated government authorities for "not having intervened in this matter notwithstanding the gravity of the purposes attributed to the Jewish community in Argentina." According to Noticias, this encourages "speculation with our economic needs and political divisions."

JORDAN'S NEW CHIEF OF STAFF ARCH FOE OF PALESTINIAN TERRORISTS

JERUSALEM, March 5 (JTA)--Maj. Gen.Zeid Ben Shaker, appointed last night by King Hussein as Chief of Staff of Jordan's armed forces, is an arch foe of the Palestinian terrorists, it was stated here today. Ben Shaker is believed to have master-minded the anti-terrorist sweep in Jordan last July in which the King's troops sent thousands of terrorists fleeling into Syria and Lebanca and many more into lerael where they surrendered rather than fall into the hands of the royal army. He has now officially replaced Gen. Mohammed Khalil Addu Dayem.

ADL SAYS BILLING'S RESPONSE TO CHARGE OF ANTI-SEMITISM IS EMPTY DISCLAIMER

NEW YORK, March 5 (JTA)—The Anti-Defamation Lesque of Brais B'rith has termed David Billing III's published response to the ADL's charge of anti-Semitism an "empty, unresponsive disclaimer" which is "botally inadequate and unconvincing." The ADL charged last week that Billings, chairman of the New York City Council Against Poverty, made anti-Semitic remarks last Tuesday on the WNYC radio program "Action Interview," a program on the city-owned station, and asked Mayor John V. Lindsay to remove him from office.

Billings told the radio audience that opponents of the controversial \$40-unit low-income project in Forest Hills "happens to be an influential group religiously." He added that "many of them control the school system of that religious origin; many of them control the press and the mass media of that

religious origin,"

Billings was privately reprimanded by Lindsay who told the CAP official that many of his radio remarks were "plainly offensive to members of the Jewish community of the city and indeed to many of our citizens, including me." Lindsay's private reprimand came just before the Mayor swore in Billings to his third one-year term as CAP Chairman, After Billings was reprimanded, the CAP official said he was not referring "to the Jewish community" and that he did not consider the housing project dispute a "ijewish-Black groups thing,"

Milton A. Seymour, chairman of the ADL's New York Board, asked for a meeting with Walter Rothschild, chairman of the N.Y. Urban Coalition, Billings is the Coalition's representative to the Council Against Poverty. Noting that Billings had disclaimed any anti-Semitic intent, Seymour said that the CAP chairman has "not seen fit to actually retract any of his outrageous charges that the Jewish community exercises a tentacle-like control on the life of our city," "Worse still," said Seymour, "its Billings' transparent denial that he was attacking the Jewish community in the charges he made in the radio interview."

HADASSAH TO ESTABLISH CLINICAL
PHARMACOLOGY DEPARTMENT, BLOOD BANK
Board Votes \$1 M Above Regular
Quota For New Projects

NEW YORK, March 5 (JTA)—The National Board of Badassah, meeting at its annual Mid-Winter Conference in New York, announced that it has voted the funds to establish a Department of Clinical Pharmacology at the Hadassah-Hebrew University Medical Center in Ein Karem, Jerusalem. Mrs. Faye L, Schenk, president of Hadassah, said that the National Board has voted \$\frac{1}{2}\$ million above this year's annual Hadassah Medical Organization quota to launch this new department and to meet the additional needs of the Hadassah-Hebrew University Medical Center.

Mrs. Charlotte Jacobson, chairman of the Hadassah Medical Organization ead that daily, emergency cases are brought into hospitals suffering from the side-effects of new drugs such as L-dopa, the birth control pill. "Frequently, the patients are in a coma, and treatment must be delayed until a series of tests have been performed, before the doctors can treat the patient. While medical students are taught how to presorthe drugs." Mrs. Jacobson continued, "their training concerning the side-effects is deficient." She explained that this new department will centralize testing, teaching and research on humans, which is different from the School of Pharmacology, where the researchers work with animals.

FOREIGN AID LEGISLATION AWAITS NIXON'S SIGNATURE; \$50M IN ECONOMIC SUPPORT TO ISRAEL, UP TO \$300M IN MILITARY CREDIT

WASHINGTON, March 5 (JTA) -- The Senate has approved the last step in the foreign aid legislation by a vote of 45 to 36 and has sent the measure to the White House to be signed into law by President Nixon. The House had previously approved the measure by 213 to 167. The Senate action took place Thursday afternoon, The legislation, which calls for appropriations totaling \$3,189,437,000, carries a grant of \$50 million in economic support to Israel and also authorizes the President to provide Israel with military sales credits of up to \$300 million for this fiscal year which ends June 30. In addition, Israel will share in a fund of \$20 million for American-authorized schools and hospitals abroad.

NAACP LEADER RECIPIENT OF HONORARY HEBREW U FELLOWSHIP

JERUSALEM, March 5 (JTA)—An honorary Horew University fellowship was conferred on Roy Wilkins, since 1955 executive director of the National Association for the Advancement of Colored People, in the US, Taking part in the dinner-and-presentation ceremonies Thursday night at the university's Belgium House was US Ambassador Walworth Barbour. The fellowship was presented in tribute to Wilkins' "foutstanding work on behalf of civil rights and in the interests of interracial understanding." TWO MATZPEN MEMBERS GIVEN 35 DAYS

JERUSALEM, March 5 (JTA)--Glora Neumann, a member of Matzpen, a splinter Marxist anti-Zionist organization, has been given a third 35-day sentence for refusing Army service in the administered territories. His claim to conscientious objection was rejected. Another Matzpen member, Arye Buber, also received a 35-day term for a similar refusal to serve. Matzpen has been canvassing public opinion through advertisements and handbills, but so far with no results. Matzpen identifies closely with the views of Nayef Hawwatmeh, leader of the extremist Popular Democratic Front for the Liberation of Palestine.

According to a report in Tass, the Soviet press agency, the pact which was reached with a Libyan delegation in Moscow, includes prospecting for mineral deposits and gas, training Libyan national cadres, provides for cooperation in prospecting, extracting and refining oil, and in developing power generation and other branches of Libya's national economy.

Qaddafi, who has likened Soviet imperialism to Western imperialism, has been uncomfortable in relation to his partners in the loose federation he entered into last Sept, with Egypt and Syris, both courties with strong ties to Moscow. But he regards the agreement with Moscow as political leverage in dealing with the West which he mistrusts no less than the Soviet Union.

USSR Desperate For Allies

Observers here said the main reason the Soviet Union signed the pact was its inability to develop its own oil resources fast enough to keep pace with its industrial expansion. The USSR is said to be lagging by as much as 10 years in this endeavor. The Soviet Union once an oil exporting nation, has in recent years become an importer of oil.

The Soviet-Libyan deal confirmed what political observers have known for years—that boviet relations with any country has little to do with that country's regime or ideology. This is the case in Egypt where the Communist Party is Illegal. It is most evident in Russia's brisk trade with Spain whose reg-

ime under Gen. Franco is regarded as Fascist by the USSR. Observers here said that Russia's need for Middle East oil may eventually lead it to deals with Saudi Arabia which is vehemently anti-Communist.

THREE NAZI WAR CRIMINALS WILL NOT BE RELEASED -- FOR TIME BEING

AMSTERDAM, March 5 (JTA)—The Netherlands government announced last night that it has decided not to release, for the time being, the last three Nazi war criminals serving sentences in Breda prison. But the television announcement by Premier Barend Blesheuvel and Justice Minister Andries Van Agt did not preclude the eventual release of the prisoners on an individual basis. The government leaders said the decision took serious account of last Wednesday's 85-61 vote by the Dutch Parliament against pardons.

However, the government plans to examine the mental and physical condition of each prisoner by a committee of experts who have the confidence of various groups opposed to a pardon. The prisoners are Franz Fischer, 70, Joseph Kotaella, 65 and Ferdinand Aus Den Fuenten, 73, All have been imprisoned since 1945.

The local Jewish community continued to be split over the issue. Rabbi Abraham Soetendorp, 29, of the Amsterdam Liberal Congregation, who is considered the main spokesman for the Jewish community following his father's retirement last week, expressed regret that the government has not definitely rejected clemency for the ex-Nazis. But Prof. August Belinfante, a former Rector of Amsterdam University and a Jewish spokesman, sharply condemned the anti-pardon demonstrations while Parliament was debating last week, and the attacks on the Justice Minister.

Jews Must Abandon Cemetery JEWISH COMMUNITY SHOCKED; CASE TO BE HEARD BY FRENCH SUPREME COURT

MARSEILLES, March' 5 (3TA)—Members of the Jewish community of Marseilles have expressed shock over a court decision requiring the community to abandon the Jewish cemetery of Trois Lucs just outside this city, and to empty the graves of the cemetery. In the mid-60s, when a large part of North African Jewys settled in southern France, North African Jewish leaders decided, in accordance with tradition, not to bury their dead together with non-Jews. Most cemeteries in France are mixed in that respect, including the Saint Pierre cemetery in Marseilles.

Accordingly, the new Jewish community here acquired a lot in the middle of Marseilles but municipal officials, opposing the proposed Jewish cemetery as conflicting with town planning projects, proposed an exchange of lands. The Jewish community accepted the ground on which the Trois Lucs cemetery was set up. But the Jewish Chevrah Kadishah (burial society) of the Israelite Cultural Association of Marseilles, failed to comply with French regulations for creation of a new cemetery.

The owners of neighboring plots, contending the presence of the new graveyard caused a decline in the prices of their plots, went into court to stop the Jewish cometery. A Marsetlles'court is sued a series of injunctions to the Chevrah Kadishah
to stop burials in the Trois Lucs cemetery and to
empty existing graves by March 10. The Jewish community appealed the court orders but the higher Aix
En Provence court ruled against the community,
finding that it had not met the regulations for a new
cemetery. Jewish religious law bars disinterment
of Jewish dead.

Observant families of Jewish deceased buried at Trois Lucs are protesting bitterly both against the Jewish community and French authorities. The Chevrah Kadishah has been warned by the court it will have to pay a fine for each day after March 10 that the court injunction has not been compiled with The case will be heard by the French Supreme Court but the Aix court decision, under French law, must meanwhile be obeyed.

An association for the defense of the Trois Lucs cemetery has been formed. Both the French Jewish Consistory and the French rabbinate have expressed their opposition to any transfer of dead burled at Trois Luce as a violation of Jewish religious law.

ISRAEL'S SYRIA-LEBANON BORDERS QUIET Dayan, Elazar Warn Of Swift Reprisals Against Any New Terrorist Activities

TELAVIV, March 5 (TA)—Israel's borders with Syria and Lebanon, scenes of ground and air fighting last week, remained peaceful today. But Defense Minister Moshe Dayan and Chief of Staff Gen. David Elizar have both warned that any new terrorist activities against Israel from either country would be dealt with swiftly and decisively.

Today, the roads of northern Israel were packed with traffic and visitors who came to view the scene of last week's Israeli thrust into "Fatahland" in southeast Lebanon. Lebanese farmers were back working their fields and many waved to Israelis driving along the border. The ski runs on the slopes of Mt. Hermon drew today an estimated 5,000 people. But Israeli military leaders conceded that the scene could change back to one of battle

Speaking on television Friday night, Dayan said larnell forces were prepared to cross the Lebanese border again if necessary. He said the entry of the Lebanese Army into "Fratahland" after Israell forces cleared parts of it of terrorists indicated a fundamental change of policy in Betrut which previously had yielded virtual control of the region to the terrorists. However, he warned, this may not be enough to ensure peace.

Syrians Hit And Ran

Dayan said israel would be satisfied only when the Lebanese authorities and their army adopt and carry out a vigorous, decisive stand against terrorist gangs. He said he thought the Lebanese government "will try at least to restrict, perhaps to control immediately, the area and not to allow the Fatah to act either from Lebanon or to cross the border." But he was less certain that Syria would make any effort to curtail the activities of terrorists on their soil who, unlike those in Lebanon, function under the direct control of the Syrian Army.

Syrian planes attacked Israeli settlements in the Golan Heights last week following Israeli air strikes and shelling of terrorist bases in Syria. The attacks caused no casualities and minimal damago. Speaking yesterday on Kol Israel radio, Elazar described them as "fult and run," observing that "they hit very little and ran very fast."

But, he said, the Syrian attack confirmed that Syrian armed forces actively support the terrorists. "That was one reason why our counter-strike could not make an absolute distinction between the Syrian Army and terrorist bases and we were compelled occasionally to hit out at both," he said. According to Elazar, the terrorists suffered dozens of casualties in the latest Israeli

BRANDT TO USE INFLUENCE IN MOSCOW TO HELP CAUSE OF SOVIET JEWRY

BONN, March 5 (JTA).—Chancellor Willy Brandt promised a visiting B'nat B'rith delegation from the United States that he would use his newly won contacts and influence in Moscow to help the cause of Soviet Jews. The West German leader said he fully understood the need for West Germany to participate in international efforts to help ease the plight of Jews in Eastern Europe, particularly those in the Soviet Union.

Brandt met for an hour last Friday with the delegation headed by Rabbi Benjamin Kahn, executive vice-president of B'nati B'rith and Herman Edelsberg, director of its international council. Brandt told the delegation that its fears that West Germany's improved ties with the Arab states would be at the excense of its rela-

tions with Israel were unfounded.

He said his government intended to strengthen and broaden its ties with Israel and believes that German-Israel trade, German investments in Israel and joint German-Israel investments in Israel and joint German-Israel investments in third countries should be expanded. Brandt told the visitors that he hoped to accept Premier Golda Meir's invitation to visit Israel after the parilamentary summer recess. He said he expected to discuss details of the visit with Mrs. Meir when they meet in June at the Socialist International convention in Vienna.

BANZER: FATE OF BARBIE-ALTMANN IS UP TO THE BOLIVIAN COURTS

PARIS, March 5 (JTA).—The exchange of letters between President Georges Pompidou and Col. Hugo Banzer, President of Bolivia, over the extradition of wanted Nazi war criminal Klaus Barbie, was published here yesterday for the first time. According to Banzer, the matter is one for the Bolivian courts to decide.

France has asked for the extradition of Klaus Altmann, a Bolivian citizen of German extraction who is identified as Barble according to a mass of evidence recently unearthed. Barble is wanted for the murder of a French resistance leader and the deportation of countless French Jews in Lyons where he was gestape obtied during World War II.

Pompidou wrote to Banzer that Barble is "a war oriminal and torturer of many Frenchmen....
Time crases many things but not everything,"
The French people, Pompidou noted, cannot accept war orimes being "forgotten in indifference."
Banzer replied that France must trust the "nobility of my country" and the "Glear moral tradition of Bolivian justice" in deciding Altmann's
fate.

Barble-Altmann was tracked down by Mrs. Beate Klarsfeld, an anti-Nazi German married to a French Jew. Primarily through her efforts, French military judges last month obtained documents from the West German Attorney General which are said to confirm that Altmann is Barble. One obstacle to the French extradition request is Bolivia's 20-year statute of limitations on crimes. Another is Bolivia's policy not to extradite its citizens.

EGYPT'S RULING CIRCLES DIFFER ON SOLUTION TO CONFLICT WITH ISRAEL Heikal; Egypt Should Abandon Demand That Israel Commit Itself A Priori To Withdrawal; Draws Arabs' Wrath

JERUSALEM, March 5 (JTA)—Major differences within Egypt's ruling circles over a solution to the conflict with Israel Emerged over the week-end, Mohammed Hassanein Heikal, editor-in-chief of the influential Cairo daily, Al Ahram, hinted in his signed column Friday that Egypt would do well to abandon its insistence on a prior Israell commitment to withdrawal from the occupied territories as the price of peace necotiations.

But the official government newspaper, Al Gumhurlya, today criticized Helkal, but without menticring him by name, for suggesting to the Egyptian people that they have any alternative but force in dealing with Israel. Helkal, nevertheless, is considered a close confidant of President Anwar Sadat, a relationship that he also enjoyed with the late President Nasser, and his column in Al Ahram has frequently reflected government views. Observers here said it was unlikely that his latest article was published without the prior approval of Sadat or someone acting on Sadat's behalf.

In the column, which was promptly blasted by Arab news media in Amman, Bertut and Algiers, Heikal dismissed as "childish" a political solution "which is based on insisting on the last step even before the first step has begun," The phraseology was seen as a hint that Egypt may be willing to drop its demand for an Israeli withdrawal commitment as a prerequisite for either an overall settlement under the aegis of United Nations mediator Dr. Gunnar V, Jarring or an American-sponsored interim accord to reopen the Suez Canal.

Seen As Trial Balloon

Some observers believe Heikal's suggestion represented a trial balloon and Al Gumhurtya's criticism of it a way out for the government should public reaction be unfavorable. Al Gumhurtya referred obliquely-to "persons who might spread confusing ideas among the Egyptian people" and warned that such persons who are obvicusly not sufficiently familiar with events should refrain from leading the Egyptian people into believing that there are several alternatives.

According to the government newspaper, there is only one solution to the Middle East conflict which has already been laid down: "What has been taken by force can only be retrieved by force. There is no difference of opinion about this." the paper said.

Heikal, on the other hand, discarded military solutions or diplomatic efforts through international law and UN resclutions, He wrote that a "revolutionary solentific solution is the only acceptable solution." He defined a "revolutionary solentific solution." as one which employs "all available means—diplomatic, economic, armed forces in accordance with modern calculations, and enlightened propaganda which gains the maximum amount of support for this conflict, and stands hased on principles which guarantee the broadest front of friends and allies to prevent the enemy from imposing his will."

No Surrender To 'Zionist Enemy'

Heikal claimed that such methods were being utilized by China to regain sovereignty over Taiwan and by the Vietnamese revolution to achieve the complete withdrawal of US troops from the whole of Indochina, According to Heikal, achievement of a political solution has failed in the Middle East conflict "because we have forgotten--I will not say have

neglected -- to utilize the other methods."

His remarks appeared at a time when the Egyptian government appeared to be resting high hopes on the reactivation of the Jarring peace mission while at the same time intensitying tep reparations for war. The Amman newspaper, A Destour, denounced the Egyptian editor for advocating an Arab surrender to a political solution not based on the Security Council's Resolution 242.

The Daily Star, Beirut's English-language newspaper, urged Egypt to dissociate itself of-ficially from Heikal's views. The pro-Iraqi Lebanese newspaper, Beirut, sald a close examination of Heikal's article would lead to popular support of the Cairo students' recent demands that the Al Ahram editor stand trial. The paper accused Heikal of hostility towards the Arab masses and "advocation of surrender to the US and the Zionist enemy." The official Algerian news agency criticized Heikal for "defeatism."

Meanwhile, it was reported that Sadat is scheduled to tour several Arab countries this week to discuss means of strengthening the Arab position against Israel in the wake of Israel's actions against Lebanon and Svria.

ANTI-SEMITIC PAMPHLET SPREADING RAPIDLY IN ARGENTINA AMONG WORKERS

BUENCS AIRES, March 5 (JTA)—A rightwing politican's anti-Semitic pamphlet in the style of the Protocols of the Elders of Zion, is spreading rapidly in Argentina, particularly in the southern region of the country and among factory workers. The Jewish community, through its representative body, the DAIA, has expressed growing concern, especially as the newspaper, Noticias, in the provincial city of Tucuman, has accepted the allegations against Jews as fact and continues in its editorials to demand a full-scale investigation by all government agencies.

The charge, that Jews are plotting to dismember Argentina and create a Jewish State in Patagonia, the country's southernmost province, was first made two months ago by Dr. Beveraggi Allende, a political science professor, in an open letter to Jose Rucci, secretary-general of the powerful Peronista General Confederation of Labor. Allende claimed that virtually all facets of life in Argentina were controlled by Jews.

Noticias gave the Allende letter front page prominence. Yesterday, it urged in an editorial that "The enemies of the country must be fought energetically" and demanded rigorous punishment for the alleged conspirators. The newspaper castigated government authorities for "not having intervened in this matter notwithstanding the gravity of the purposes attributed to the Jewish community in Argentina." According to Noticias, this encourages "speculation with our economic needs and political divisions."

JORDAN'S NEW CHIEF OF STAFF ARCH FOE OF PALESTINIAN TERRORISTS

JERUSALEM, March 5 (JTA)--Maj. Gen.Zeid Ben Shaker, appointed last night by King Hussein as Chief of Staff of Jordan's armed forces, is an arch foe of the Palestinian terrorists, it was stated here today. Ben Shaker is believed to have master-minded the anti-terrorist sweep in Jordan last July in which the King's troops sent thousands of terrorists fleeling into Syria and Lebanca and many more into lerael where they surrendered rather than fall into the hands of the royal army. He has now officially replaced Gen. Mohammed Khalil Addu Dayem.

ADL SAYS BILLING'S RESPONSE TO CHARGE OF ANTI-SEMITISM IS EMPTY DISCLAIMER

NEW YORK, March 5 (JTA)—The Anti-Defamation Lesque of Brais B'rith has termed David Billing III's published response to the ADL's charge of anti-Semitism an "empty, unresponsive disclaimer" which is "botally inadequate and unconvincing." The ADL charged last week that Billings, chairman of the New York City Council Against Poverty, made anti-Semitic remarks last Tuesday on the WNYC radio program "Action Interview," a program on the city-owned station, and asked Mayor John V. Lindsay to remove him from office.

Billings told the radio audience that opponents of the controversial \$40-unit low-income project in Forest Hills "happens to be an influential group religiously." He added that "many of them control the school system of that religious origin; many of them control the press and the mass media of that

religious origin,"

Billings was privately reprimanded by Lindsay who told the CAP official that many of his radio remarks were "plainly offensive to members of the Jewish community of the city and indeed to many of our citizens, including me." Lindsay's private reprimand came just before the Mayor swore in Billings to his third one-year term as CAP Chairman, After Billings was reprimanded, the CAP official said he was not referring "to the Jewish community" and that he did not consider the housing project dispute a "ijewish-Black groups thing,"

Milton A. Seymour, chairman of the ADL's New York Board, asked for a meeting with Walter Rothschild, chairman of the N.Y. Urban Coalition, Billings is the Coalition's representative to the Council Against Poverty. Noting that Billings had disclaimed any anti-Semitic intent, Seymour said that the CAP chairman has "not seen fit to actually retract any of his outrageous charges that the Jewish community exercises a tentacle-like control on the life of our city," "Worse still," said Seymour, "its Billings' transparent denial that he was attacking the Jewish community in the charges he made in the radio interview."

HADASSAH TO ESTABLISH CLINICAL
PHARMACOLOGY DEPARTMENT, BLOOD BANK
Board Votes \$1 M Above Regular
Quota For New Projects

NEW YORK, March 5 (JTA)—The National Board of Badassah, meeting at its annual Mid-Winter Conference in New York, announced that it has voted the funds to establish a Department of Clinical Pharmacology at the Hadassah-Hebrew University Medical Center in Ein Karem, Jerusalem. Mrs. Faye L, Schenk, president of Hadassah, said that the National Board has voted \$\frac{1}{2}\$ million above this year's annual Hadassah Medical Organization quota to launch this new department and to meet the additional needs of the Hadassah-Hebrew University Medical Center.

Mrs. Charlotte Jacobson, chairman of the Hadassah Medical Organization ead that daily, emergency cases are brought into hospitals suffering from the side-effects of new drugs such as L-dopa, the birth control pill. "Frequently, the patients are in a coma, and treatment must be delayed until a series of tests have been performed, before the doctors can treat the patient. While medical students are taught how to presorthe drugs." Mrs. Jacobson continued, "their training concerning the side-effects is deficient." She explained that this new department will centralize testing, teaching and research on humans, which is different from the School of Pharmacology, where the researchers work with animals.

The National Board also voted funds to set up a blood bank at Hadassah to provide fractions (i.e.,

just red or white cells) as well as whole blood, which is often wasteful. When blood is fractionized one pint can often serve three or four patients. The blood bank will also be responsible for the sophisticated tissue-typing needed in tissue and organ transplants and in immunological testing, and will serve the entire country and will cooperate with the Israel Ministry of Health

FOREIGN AID LEGISLATION AWAITS NIXON'S SIGNATURE; \$50M IN ECONOMIC SUPPORT TO ISRAEL, UP TO \$300M IN MILITARY CREDIT

WASHINGTON, March 5 (JTA) -- The Senate has approved the last step in the foreign aid legislation by a vote of 45 to 36 and has sent the measure to the White House to be signed into law by President Nixon. The House had previously approved the measure by 213 to 167. The Senate action took place Thursday afternoon, The legislation, which calls for appropriations totaling \$3,189,437,000, carries a grant of \$50 million in economic support to Israel and also authorizes the President to provide Israel with military sales credits of up to \$300 million for this fiscal year which ends June 30. In addition, Israel will share in a fund of \$20 million for American-authorized schools and hospitals abroad.

NAACP LEADER RECIPIENT OF HONORARY HEBREW U FELLOWSHIP

JERUSALEM, March 5 (JTA)—An honorary Horew University fellowship was conferred on Roy Wilkins, since 1955 executive director of the National Association for the Advancement of Colored People, in the US, Taking part in the dinner-and-presentation ceremonies Thursday night at the university's Belgium House was US Ambassador Walworth Barbour. The fellowship was presented in tribute to Wilkins' "foutstanding work on behalf of civil rights and in the interests of interracial understanding." Wilkins, who was 70 last Aug. 30, received the citation from Hebrew U, president Ayraham Harman,

NO CHALLAH? LET 'EM EAT PITTAH

TEL AVIV, March 5 (JTA)--Thousands of families in Tel Aviv and its surroundings had no challah this Sabbath because of labor troubles at the bakeries. The workers and distributors are demanding higher wages. Negotiations were scheduled to begin today. Housewives stormed the stores for non-Passover matzot, but even this was scarce because the matzot factories are in full-swing preparations for that holiday. It is thus boom time for pittah, the oriental bread.

TWO MATZPEN MEMBERS GIVEN 35 DAYS

JERUSALEM, March 5 (JTA)--Glora Neumann, a member of Matzpen, a splinter Marxist anti-Zionist organization, has been given a third 35-day sentence for refusing Army service in the administered territories. His claim to conscientious objection was rejected. Another Matzpen member, Arye Buber, also received a 35-day term for a similar refusal to serve. Matzpen has been canvassing public opinion through advertisements and handbills, but so far with no results. Matzpen identifies closely with the views of Nayef Hawwatmeh, leader of the extremist Popular Democratic Front for the Liberation of Palestine.
