ISRAELI FORCES HIT TERRORIST BASES IN 'FATAHLAND'; CAPTURE 5 SYRIAN, I LEBANESE OFFICERS ON JOINT MISSION

TEL AVIV, June 21 (JTA)—An Israeli patrol captured five high-ranking Syrian Army officers and a Lebanese Army officer in a clash inside Fatahland today as Israeli planes and artiliery pounded terrorist bases in the area. The ground action occurred near the village of Ramiyah where the Israeli patrol came across a convoy in which the Syrian officers were riding under a Lebanese Army escort. Two Israeli soldiers were slightly wounded. One Syrian officer was wounded and hospitalized and several Lebanese soldiers and border police were wounded.

The renewed Israeli actions against terrorist bases followed yesterday's bazooka attack on a tourist bus in which two Israelis were wounded. Two Israelis soldiers were injured by an anti-personnel mine in the same region yesterday and it was disclosed today that two others were wounded by sniper fire from Fatahland Monday. (Israel lodged a formal protest with the UN Security Council yesterday over the upsurge of terrorist scitivity from Lebanon.)

Israell officers admitted they were surprised to find Syrian officers traveling under Lebanese escort in the border region on what was apparently a joint Syrian-Lebanese recomnatisance mission against Israel. All of the Syrian officers belong to the operations section of Syrian General Headquarters and Airforce intelligence. The captured Lebanese is also an intelligence officer.

The Syrians were identified as Cols. Adham Alouani, Radwan Aloush and Nazir Jerrakh and Li.
Cols. Rafiq Surbajii and Walid Abassi. The Lebanese officer is Capt. George Nassif of the Lebanese
General Staff intelligence branch. Israeli sources
satd the capture of the Syrians might improve chances for an eventual prisoner exchange with Damascus. Israel has been trying to arrange an exchange
of 39 Syrian soldiers held in an Israeli POW camp
for three Israeli pilots in Syrian hands since April
and June, 1970. The Syrians so far have refused.

Is raei Air Force pianes attacked terrorist bases and concentrations in the Hasbayeh area today and returned safely to their bases. Is raeli artillery shelled terrorist strongoints near Djebel Binil, about five miles inside Lebaness territory. The Lebanese border had been relatively quiet since Feb. 25 when Israeli air and ground forces carried out a series of attacks on terrorist bases over a period of three days.

Civil Marriages Bill Postponed
MEIR WARNS CABINET WOULD RESIGN IF
ALIGNMENT DISCIPLINE IS VIOLATED

JERUSALEM, June 21 (JTA)—A series of complicated maneuvers among partners of Premier Golda Meir's coalition government put to an end today the threat of a government crisis over Liberal Party efforts to introduce a limited bill for civil marriages, which are not permitted now in Israel.

Gldeon Hausner introduced in the Knesset today a private members bill on behalf of his Independent Liberal Party with the announced support of Mapam, the Labor alignment's partner. Hausner, in introducing the measure, insisted he was not seeking a change in the status quo, in which the state-recog-

nized Orthodox rabbinate controls all such matters of personal status. Rather, he said, he was seeking to "alleviate the misery" of such categories of Jews as mamzerim (children considered illegitimate by the Orthodox rabbinate), divorcees and kohanim who are barred from marriage to divorcees in Israel by the rabbinate. Since, he contended, his bill did not interfere with the status quo, there was no reason why the independent Liberals should be evicted from the Cabinet on that issue.

Mrs. Meir replied that the bill was a "clear violation" of the status quo. She said she agreed that the situation was a "sorry one" for the Jews for whom the measure was designed. However, she added, the Independent Liberals had been aware of that situation when they signed the coalition contract and could not renege on it,

That issue became moot when Mrs. Meir said that if the Mapam supported the Hausner bill, she and her Cabinet would resign. Thereupon the vote on the bill was postponed at the request of Mapam.

Observers said that all this meant that since the Knesset goes into recess in less than a month, the issue will be discussed among coalition party leaders informally until some acceptable formula is found and then brought to the House, again at some unspecified later date. They remarked, however, that the postponement was not a solution. The issue will have to be faced, they said, unless Mapam can find some way of withdrawing its support or touch off a Cabinet collapse by voting for it when it comes up again in the Knes-

ILLINOIS SENATOR SAID TO HAVE BEEN
TOLD BY WHITE HOUSE THAT JEWISH ISSUE
WAS 'DISCUSSED IN DETAIL' AT
MOSCOW SUMMIT

WASHINGTON, June 21 (JTA)--Capitol Hill sources said today that Sen, Charles Percy (R, Ill.) is informing Jewish leaders among his constituents that the matter of Soviet Jewi'was discussed in detail at the highest levels' at the Moscow summit conference last month. Sources close to the Senator told the Jewish Telegraphic Agency that Percy was so informed by the White House. This could only be interpreted as meaning that Precident Nixon took up the matter with Soviet Communist Party Secretary General Leonid Breshnev in their talks in Moscow.

The sources said the discussions took place "in the context that the United States government and people are deeply concerned about the infringement of the human rights of minorities in the Soviet Union." Questioned on this aspect, the sources said the President's presentation included all peoples in the Soviet Union regarded as minorities such as those in the Baltic states where there have been reports of ferment against the Soviet government.

However, the Jewish issue was emphasized, the sources said. They did not deny, when asked by the JTA, that Sen. Percy was making this information known to his constituents in view of a statement two weeks ago by Sen. John Tunney (D, Calif.) that cast doubts on assertions that the

President actually took up the matter of Soviet Jewry with the Soviet leadership.

There was also a report by an American Jew ish writer for sections of the American Jewish press that Soviet diplomats in Moscow said the issue was never part of the summit conference agenda. Both in Moscow and during a press conference in Kiev afterwards, Presidential adviser Henry Kissinger told newsmen that the issue of Soviet Jewry was "mentioned" but refused to give details as to the context or the Soviet reaction,

#### 'Reverse Discrimination Against Jews' RABBI BERKOWITZ ASSAILS FEDERAL ORDER TO CITY U. TO DISCLOSE ETHNIC DATA

NEW YORK, June 21 (JTA) -- The federal government's order to the City University yesterday to report personal information relating to the sex and racial origin of its personnel or risk cancellation of \$13 million in government research contracts "is a quota system and reverse discrimination against Jews and other minority groups," the pres ident of the New York Board of Rabbis charged today. In a statement on his own behalf to the Jewish Telegraphic Agency, Rabbi William Berkowitz declared that "federal regulations saying that the 'affirmative action' program 'is not intended and should not be used to discriminate against any applicant because of race, color, religion, sex and national origin' in effect is now used to designate one group, Blacks and Puerto Ricans, as the only minorities discriminated against."

"Affirmative action," Rabbi Berkowits claimed, "would substitute ethnicity, color or sex instead of competence or performance for appointment and tenure. In seeking to redress past inequities and injustices we thus have a pattern of new injustice and discrimination." The City University was given its ultimatum yesterday by the Office of Civil Rights of the Department of Health, Education and Welfare, which wants to increase the percentage of women and minority personnel,

The rabbinical board met today for two and a half hours, Rabbi Berkowitz said, but did not dis-cuss the City University case because of "other items on the agenda."

The University's director of university relations, Henry D. Paley, said the order "appears to be deliberately provocative procedural conduct" and asserted that the University "will not respond precipitously or emotionally to charges it is failing to take proper action" in regard to the hiring of women and minorities.

A spokesman for Mayor John V. Lindsay told the JTA that he considered the development to be a federal matter and "will not take an active part" in it. On May 29, Mayor Lindsay issued an amendment to the city's executive order on the annual census of city employes which provided that "no thing in this order shall be construed to require or allow the imposition of quotas in recruitment, assignment, hiring or promotion in contravention of the requirements of law." City Hall sources said at the time that the Mayor's office intended to resist whatever pressures may arise from the Department of Health, Education and Welfare or other federal agencies for personnel treatment that may require the establishment of quotas.

## ARAB RESPONSE WILL BE TEST OF SECURITY COUNCIL'S ANTI-SKYJACK RESOLUTION, SAYS TEKOAH

last night that the Security Council's "watered down" resolution on skyjacking will have its effec-tiveness "tested to a large extent by the reaction of the Arab governments and their willingness to terminate the criminal activities of the Arab terror organizations which are responsible for the most dastardly and sanguinary of the attacks on international civil aviation." These organizations, Tekoah charged, "have been established by Arab States, operate from Arab territory and are supported politically, financially and militarily by Arab governments."

The 15-member Council voted yesterday to condemn skyjacking and to ask governments to "take all appropriate measures within their jurisdiction" to "deter and prevent" air terrorism. The Council said it was "gravely concerned at the threat to the lives of passengers and crews arising from the hijacking of aircraft and other unlawful interference with international civil aviation." The resolution deliberately avoided specific mention of the Middle East situation and political asylum.

"It is clear," Tekoah said, "that if a further deterioration of the grave situation created by international terror operations is to be prevented, it is essential that the Arab governments change their policy and take stringent measures to suppress the terror organizations and their activities." Failing this, he went on, "the security of international aviation will remain imperiled" and the Arab governments "must be considered as working against a peaceful settlement of the Mid-dle East conflict."

#### STATE DEPT, HINTS IT IS IN ACCORD WITH TITO'S VIEW LINKING MIDEAST PROBLEM TO EUROPE

WASHINGTON, June 21 (JTA) -- The State Department cautiously indicated a measure of support today for Yugoslavian President Tito's view that the Middle East's problems are connected with European matters which are to be aired at a prospective European Security Conference.

Tito had said June 19 at a dinner in Warsaw given in his honor by Polish Communist Party leader Eduard G'erek that "more determined steps should be taken to bring about detente and to remove all causes of tension and alarm in the region of the Mediterranean."

"These problems are linked." the 80-yearold marshal said, "and should be directed towards detente spreading over increasingly large areas." This was understood to mean the movements for closer relations by Washington with Moscow and Peking.

Tito made the statements in context of the "great successes" he said have been made in the Baltic Sea area and Central Europe. When asked by the Jewish Telegraphic Agency for the State Department's views on the Tito statements, spokes man Charles Bray said that "We hope progress on one front in pursuit of peaceful cooperation might have spill-over benefits in other parts of the world. Time will be the test." Bray cautioned that the European Security Conference discussions are far off saying, "We won't even get into the exploratory phases before late fall."

NEW YORK, June 21 (JTA)—Bertram L, Zweibon, executive director of the Jewish Defense League, told the Jewish Telegraphic Agency today that he expects the three JDL members indicted Monday for the Jan. 26 fire-bombing of impressario Sol Hurok's office to be released on ball by tonight.

Zweibon who is serving as defense counsel for the trio, would not say specifically whether the JDL has succeeded in raising the \$75,000 bail--\$25,000 for each of the accused--but he hinted that

the money has been found,

The three youthe, Stuart Carl Cohen, Sheldon Siegel and Sheldon Davis, pleaded not gullty in Federal Court yesterday to charges of using incendiary bombs that caused one death and several injuries in Hurok's office.

#### YESHIVA STUDENTS ARRESTED IN 'SEX SHOP' BOMBING

TEL AVIV, June 21 (JTA, --Two yeshiva students from Jerusalem were arrested early this morning following the fire-bombing of Eros, a "sex boutique" that markets erotic photographs and "sexual aids." The youths were selzed following a car chase in which shots were fired. Two other occupants of the car escaped, The names of the two men arrested were not immediately disclosed.

The Eros shop which does its business by mail order rather than over the counter, has been under attack by Orthodox elements since it opened two years ago. A recently opened branch in Jerusalem has been picketed by religious zealots. Police who have been guarding the Tel Aviv shop said they saw two men hurl bombs and kerosene into the shop early this morning from a car occupied by four and the chase ensued. The car was identified as a rented vehicle.

#### REPORT GAVRIEL GOES ON TRIAL NEXT WEEK; CHARGES UNKNOWN

NEW YORK, June 21 (JTA)—Jewish activist Gavriel Shapiro will go on trial next week in Moscow on as yet unspecified charges, Jewish sources reported today. Judy Silver Shapiro, who married the activist in a religious ceremony in Moscow June 8 but was denied a civil marriage or a vise extension, reported from Cincinnati that her father—in-law, Jacob Shapiro, had been refused permission to see his son. The elder Shapiro, who wanted to give the 2"-year-old prisoner a Bible, told his daughter—in-law by telephone that the authorities had told him: "This is a prison, not a church. You cannot see your son until after the trial."

### W. BANKERS MAY BE ABLE TO VISIT JORDAN WITHOUT PERMITS, DAYAN SAYS

JERUSALEM, June 21 (JTA).—Defense Minister Moshe Dayan said today that West Bank residents may no longer need special permits to vieit Jordan. He said a proposal to eliminate the permits was under study but noted that even if the permits are abolished, West Bankers crossing into Jordan would have to show a special israell identity card or Jordanian pasport.

Gen. Dayan disclosed that about 30,000 of the 200,000 West Bankers who fled to Jordan during the 1967 Six-Day War have been permitted to return to re-

Join their families. He said there were many more who wished to return but that problem could only be solved when broader arrangements are made. He did not indicate what arrangements he had in mind.

#### WEIZMANN INSTITUTE HONORS WEILL FOR AID TO MEDICAL RESEARCH

TEL AVIV, June 21 (JTA)—Gen. Haim Bar Lev, the Minister of Commerce and industry, said last night that Israeli industry will employ 8000 academically trained people in the next four years, almost double the number it employs at present. He stressed that the future of Israel's industry depends on its ability to utilize scientific research.

Bar Lev spoke at the Weizmann Institute of Science in Rehovoth where an honorary fellowship was conferred on the American jurist and philanthropist, Harold Weill. Chancellor Meyer Weisgal of the Weizmann Institute and Abraham Feinberg, chairman of its board, spoke of Weill's role in adding medical and scientific research. Weill has helped sponsor research almed at eliminating leukemia, sickle cell anemia and Cooley Disease.

#### ISRAEL'S EXPORTS TO AFRICA RISING

JERUSALEM, June 21 (JTA)--Israel's exports to the African continent doubled during the past five years. They presently amount to \$47 million annually compared to \$23 million in 1967, according to the latest bulletin of the Ministry of Trade and Industry published today.

The bulletin noted thet trade possibilities with African nations, particularly those of East Africa, improved considerably since 1967. Progress was also reported in trade with West Africa but legislation curbing imports by Ghana and Nigeria had an adverse effect on Israeli exports to those countries.

Dr. Y. Shachar, the Ministry official in charge of trade with Africa, Asia and Latin America, reported that Africa was a particularly good market for equipment and capital goods related to agriculture, electricity and electronics. He said the steadily rising standard of living in many African countries has opened new markets for Israeli consumer goods.

#### GREEK EXPATRIATE WILL CONDUCT AT ISRAELI MUSIC FESTIVAL

TEL AVIV, June 21 (JTA)—The Greek expatriate composer, Mikis Theodorakis and his mustcal ensemble will participate in the 1972 Israeli Festival for Music and Drama which opens in Jerusalem July 15, it was reported here today. The Festival performances will be given in Jerusalem and in the Roman amphitheater in Caesarea, as in past years. The Israel Philharmonic will perform Samson and Delilah at Caesarea with Zubin Mehta conducting. The Bat Sheva and Bat Dor dance groups will also perform.

#### SYRIAN BEARS SEEK MATES IN ISRAEL

JERUSALEM, June 21 (JTA)—Two aging female Syrian bears from Washington, D.C. have arrived at the Jerusalem Biblical Zoo where they will be mated with the zoo's two male Syrian bears, the zoo's director Prof. Aharon Shulov of the Hebrew University reported this week.

The bears are a gift of the National Zoological Park in Washington. Zoo officials there who had waited in vain for over 29 years for an offspring of this rare animal discovered only recently that the two bears were both females.

#### COLLEGE PRESIDENT ASSAILS ETHNIC QUOTAS, OPEN ENROLLMENT IN NY COLLEGES

FALLSBURG, N.Y., June 21 (JTA) -- Employment "quotas" based on sex, race or any other standard but merit constitute "a danger stalking the Jewish community," because under them Jews would be "reduced to second-class citizens." a rabbinical sociologist declared today. Rabbi Bernard Lander, president of Touro College, New York, and a faculty member at Hunter College, addressed the 36th annual convention of the Rabbinical Council of America. He urged Jews to "shift" their career goals from academe to the business world, where, he said, merit and ability still prevail as employment criteria

Rabbi Lander also assailed "open enrollment." under which city high school graduates are automatically entitled to college entrance. Forty percent of high school graduates, he charged, do not have a junior high school knowledge of English, and thus open enrollment "is destroying the very fiber and content of American colleges, producing education that is not education, degrees that are not degrees. and increasing frustration among those involved,"

#### Had Second Thoughts QUEENS JCC SAYS JEWISH FEDERATION RENEGES ON LOAN PROMISES TO HOME BUYERS

NEW YORK, June 21 (JTA) -- An official of the Federation of Jewish Philanthropies conceded today that one of its agencies had had second thoughts about providing no-interest down-payment loans to Jewish familles seeking homes in integrated neighborhoods in the southeastern section of the Borough of Queens, The official, Rabbi Isaac Trainin, religious affairs advisor to Federation, responded to a criticism of Federation by the Queens Jewish Community Council which protested the "calling off" of a "firm and public commitment,"

"In an 'off again, on again' spree," the Council said, "this urgent matter is being reconsidered at the highest echelon of Federation. A definite program and/or answers are promised late this month. We shall see." The four communities involved -- Cambria Heights, Laurelton, Queens Village and Rosedale-"after seven months of delay and hassle...look in the direction of Federation and ask--when?" the JCC said.

Rabbi Trainin said the proposed program actually involved not Federation per se but one of its agencies. Hebrew Free Loan, which was not mentioned in the complaint, "The only sin you can accuse them of," he told the Jewish Telegraphic Agency, "is making a promise they didn't think through enough. Everyone makes mistakes."

He said Hebrew Free Loan had issued similar loans, on a smaller scale, in the past, but realized it "just didn't have" the huge funds required for the Queens project -- possibly "millions of dollars," Federation's Committee on Communal Planning has been studying the matter, he said, and will meet again next Wednesday,

#### IEWS WIN AGAINST JEWS, LOSE TO NON-JEWS IN NY DEM, PRIMARY

NEW YORK, June 21 (JTA) -- The next Congress may have at least two fewer Jewish members than the present one as a result of New York's Democratic primaries yesterday. Rep. Bella Abzug lost to Rep. William Ryan in Manhattan's 20th Congressional Dis-

trict and Rep. James Scheuer was defeated by Rep. Jonathan Bingham in the 22nd District in the Bronx. Abzug and Scheuer are Jewish,

Both contests were held in districts newly created by reapportionment and the race in each case was between staunch liberals. In the Bronx. where Bingham defeated Scheuer by a margin of about 5000 votes, appeals to Jowish voters who make up 60 percent of the district highlighted the campaign. Scheuer received national prominence when he was ordered to leave the Soviet Union after meetings with Russian Jews during a visit to the USSR. Bingham's campaign literature showed him photographed with Foreign Minister Abba Eban and Jerusalem's Mayor. Teddy Kollek,

In Brooklyn's heavily Jewish 16th Congressional District, Rep. Emanuel Celler, 84, a veteran of 50 years in Congress--he came in with the Harding administration--was upset by an attractive 30-year-old woman lawyer, Elizabeth Holtzman, also Jewish. ## NIXON, KOSYGIN ASKED TO

## INTERCEDE FOR GAVRIEL SHAPIRO

NEW YORK, June 21 (JTA) -- An Orthodox leader called on President Nixon and Soviet Premier Alexei Kosygin today to intercede for the release of Gavriel Shapiro so that he may re-join his American bride. Rabbi Joseph Karasick, president of the Union of Orthodox Jewish Congregations, sent identical telegrams to the White House and the Kremlin. He also sent the telegram to Secretary of State William P. Rogers and to Soviet Ambassador Anatoly Dobrynin in Washington,

Shapiro, a Jewish activist, has been held in jail since June 12 when he was arrested for evading military service. Four days earlier. he was wed to Judy Silver, a Cincinnati social worker in a religious ceremony at his Moscow home. Mrs. Shapiro, back in the US, has already asked President Nixon to intervene on behalf of her husband.

Rabbi Karasick's telegram said, "On behalf of over 3 million worshippers in 3000 Orthodox synagoguges throughout the US, we strongly urge immediate personal intercession for permission for Gavriel Shapiro of Moscow to join his bride, Judy, in America. Over-riding humanitarian concern demands their reunification in lov and happiness."

#### ISRAELI MINISTRY ORDERS CEMENT MONOP-OLY TO ALLEVIATE SHORTAGE WITH IMPORTS

JERUSALEM, June 21 (JTA) -- The Ministry of Commerce and Industry ordered the Nesher Cement Co. yesterday to import more cement in order to relieve a shortage of the product which is selling on the black market here for double the normal price.

Nesher has a monopoly on the domestic cement market but is required by its terms to import cement if the output of its own plants cannot keep pace with demands, as is the case at present. The firm is required to sell the imported cement at the same price as the domestic product even though the former is more expensive. Building contractors have complained recently that Nesher was circumventing its obligation by delaying imports.

Civil Marriages Bill Postponed
MEIR WARNS CABINET WOULD RESIGN IF
ALIGNMENT DISCIPLINE IS VIOLATED

JERUSALEM, June 21 (JTA)—A series of complicated maneuvers among partners of Premier Golda Meir's coalition government put to an end today the threat of a government crisis over Liberal Party efforts to introduce a limited bill for civil marriages, which are not permitted now in Israel.

Gldeon Hausner introduced in the Knesset today a private members bill on behalf of his Independent Liberal Party with the announced support of Mapam, the Labor alignment's partner. Hausner, in introducing the measure, insisted he was not seeking a change in the status quo, in which the state-recog-

nized Orthodox rabbinate controls all such matters of personal status. Rather, he said, he was seeking to "alleviate the misery" of such categories of Jews as mamzerim (children considered illegitimate by the Orthodox rabbinate), divorcees and kohanim who are barred from marriage to divorcees in Israel by the rabbinate. Since, he contended, his bill did not interfere with the status quo, there was no reason why the independent Liberals should be evicted from the Cabinet on that issue.

Mrs. Meir replied that the bill was a "clear violation" of the status quo. She said she agreed that the situation was a "sorry one" for the Jews for whom the measure was designed. However, she added, the Independent Liberals had been aware of that situation when they signed the coalition contract and could not renege on it,

That issue became moot when Mrs. Meir said that if the Mapam supported the Hausner bill, she and her Cabinet would resign. Thereupon the vote on the bill was postponed at the request of Mapam.

Observers said that all this meant that since the Knesset goes into recess in less than a month, the issue will be discussed among coalition party leaders informally until some acceptable formula is found and then brought to the House, again at some unspecified later date. They remarked, however, that the postponement was not a solution. The issue will have to be faced, they said, unless Mapam can find some way of withdrawing its support or touch off a Cabinet collapse by voting for it when it comes up again in the Knes-

ILLINOIS SENATOR SAID TO HAVE BEEN
TOLD BY WHITE HOUSE THAT JEWISH ISSUE
WAS 'DISCUSSED IN DETAIL' AT
MOSCOW SUMMIT

WASHINGTON, June 21 (JTA)--Capitol Hill sources said today that Sen, Charles Percy (R, Ill.) is informing Jewish leaders among his constituents that the matter of Soviet Jewi'was discussed in detail at the highest levels' at the Moscow summit conference last month. Sources close to the Senator told the Jewish Telegraphic Agency that Percy was so informed by the White House. This could only be interpreted as meaning that Precident Nixon took up the matter with Soviet Communist Party Secretary General Leonid Breshnev in their talks in Moscow.

The sources said the discussions took place "in the context that the United States government and people are deeply concerned about the infringement of the human rights of minorities in the Soviet Union." Questioned on this aspect, the sources said the President's presentation included all peoples in the Soviet Union regarded as minorities such as those in the Baltic states where there have been reports of ferment against the Soviet government.

However, the Jewish issue was emphasized, the sources said. They did not deny, when asked by the JTA, that Sen. Percy was making this information known to his constituents in view of a statement two weeks ago by Sen. John Tunney (D, Calif.) that cast doubts on assertions that the

President actually took up the matter of Soviet Jewry with the Soviet leadership.

There was also a report by an American Jew ish writer for sections of the American Jewish press that Soviet diplomats in Moscow said the issue was never part of the summit conference agenda. Both in Moscow and during a press conference in Kiev afterwards, Presidential adviser Henry Kissinger told newsmen that the issue of Soviet Jewry was "mentioned" but refused to give details as to the context or the Soviet reaction,

#### 'Reverse Discrimination Against Jews' RABBI BERKOWITZ ASSAILS FEDERAL ORDER TO CITY U. TO DISCLOSE ETHNIC DATA

NEW YORK, June 21 (JTA) -- The federal government's order to the City University yesterday to report personal information relating to the sex and racial origin of its personnel or risk cancellation of \$13 million in government research contracts "is a quota system and reverse discrimination against Jews and other minority groups," the pres ident of the New York Board of Rabbis charged today. In a statement on his own behalf to the Jewish Telegraphic Agency, Rabbi William Berkowitz declared that "federal regulations saying that the 'affirmative action' program 'is not intended and should not be used to discriminate against any applicant because of race, color, religion, sex and national origin' in effect is now used to designate one group, Blacks and Puerto Ricans, as the only minorities discriminated against."

"Affirmative action," Rabbi Berkowits claimed, "would substitute ethnicity, color or sex instead of competence or performance for appointment and tenure. In seeking to redress past inequities and injustices we thus have a pattern of new injustice and discrimination." The City University was given its ultimatum yesterday by the Office of Civil Rights of the Department of Health, Education and Welfare, which wants to increase the percentage of women and minority personnel,

The rabbinical board met today for two and a half hours, Rabbi Berkowitz said, but did not dis-cuss the City University case because of "other items on the agenda."

The University's director of university relations, Henry D. Paley, said the order "appears to be deliberately provocative procedural conduct" and asserted that the University "will not respond precipitously or emotionally to charges it is failing to take proper action" in regard to the hiring of women and minorities.

A spokesman for Mayor John V. Lindsay told the JTA that he considered the development to be a federal matter and "will not take an active part" in it. On May 29, Mayor Lindsay issued an amendment to the city's executive order on the annual census of city employes which provided that "no thing in this order shall be construed to require or allow the imposition of quotas in recruitment, assignment, hiring or promotion in contravention of the requirements of law." City Hall sources said at the time that the Mayor's office intended to resist whatever pressures may arise from the Department of Health, Education and Welfare or other federal agencies for personnel treatment that may require the establishment of quotas.

## ARAB RESPONSE WILL BE TEST OF SECURITY COUNCIL'S ANTI-SKYJACK RESOLUTION, SAYS TEKOAH

last night that the Security Council's "watered down" resolution on skyjacking will have its effec-tiveness "tested to a large extent by the reaction of the Arab governments and their willingness to terminate the criminal activities of the Arab terror organizations which are responsible for the most dastardly and sanguinary of the attacks on international civil aviation." These organizations, Tekoah charged, "have been established by Arab States, operate from Arab territory and are supported politically, financially and militarily by Arab governments."

The 15-member Council voted yesterday to condemn skyjacking and to ask governments to "take all appropriate measures within their jurisdiction" to "deter and prevent" air terrorism. The Council said it was "gravely concerned at the threat to the lives of passengers and crews arising from the hijacking of aircraft and other unlawful interference with international civil aviation." The resolution deliberately avoided specific mention of the Middle East situation and political asylum.

"It is clear," Tekoah said, "that if a further deterioration of the grave situation created by international terror operations is to be prevented, it is essential that the Arab governments change their policy and take stringent measures to suppress the terror organizations and their activities." Failing this, he went on, "the security of international aviation will remain imperiled" and the Arab governments "must be considered as working against a peaceful settlement of the Mid-dle East conflict."

#### STATE DEPT, HINTS IT IS IN ACCORD WITH TITO'S VIEW LINKING MIDEAST PROBLEM TO EUROPE

WASHINGTON, June 21 (JTA) -- The State Department cautiously indicated a measure of support today for Yugoslavian President Tito's view that the Middle East's problems are connected with European matters which are to be aired at a prospective European Security Conference.

Tito had said June 19 at a dinner in Warsaw given in his honor by Polish Communist Party leader Eduard G'erek that "more determined steps should be taken to bring about detente and to remove all causes of tension and alarm in the region of the Mediterranean."

"These problems are linked." the 80-yearold marshal said, "and should be directed towards detente spreading over increasingly large areas." This was understood to mean the movements for closer relations by Washington with Moscow and Peking.

Tito made the statements in context of the "great successes" he said have been made in the Baltic Sea area and Central Europe. When asked by the Jewish Telegraphic Agency for the State Department's views on the Tito statements, spokes man Charles Bray said that "We hope progress on one front in pursuit of peaceful cooperation might have spill-over benefits in other parts of the world. Time will be the test." Bray cautioned that the European Security Conference discussions are far off saying, "We won't even get into the exploratory phases before late fall."

Zweibon who is serving as defense counsel for the trio, would not say specifically whether the JDL has succeeded in raising the \$75,000 bail--\$25,000 for each of the accused--but he hinted that

The three youthe, Stuart Carl Cohen, Sheldon Siegel and Sheldon Davis, pleaded not gullty in Federal Court yesterday to charges of using incendiary bombs that caused one death and several injuries in Hurok's office.

#### YESHIVA STUDENTS ARRESTED IN 'SEX SHOP' BOMBING

TEL AVIV, June 21 (JTA, --Two yeshiva students from Jerusalem were arrested early this morning following the fire-bombing of Eros, a "sex boutique" that markets erotic photographs and "sexual aids." The youths were selzed following a car chase in which shots were fired. Two other occupants of the car escaped, The names of the two men arrested were not immediately disclosed.

The Eros shop which does its business by mail order rather than over the counter, has been under attack by Orthodox elements since it opened two years ago. A recently opened branch in Jerusalem has been picketed by religious zealots. Police who have been guarding the Tel Aviv shop said they saw two men hurl bombs and kerosene into the shop early this morning from a car occupied by four and the chase ensued. The car was identified as a rented vehicle.

#### REPORT GAVRIEL GOES ON TRIAL NEXT WEEK; CHARGES UNKNOWN

NEW YORK, June 21 (JTA)—Jewish activist Gavriel Shapiro will go on trial next week in Moscow on as yet unspecified charges, Jewish sources reported today. Judy Silver Shapiro, who married the activist in a religious ceremony in Moscow June 8 but was denied a civil marriage or a vise extension, reported from Cincinnati that her father—in-law, Jacob Shapiro, had been refused permission to see his son. The elder Shapiro, who wanted to give the 2"-year-old prisoner a Bible, told his daughter—in-law by telephone that the authorities had told him: "This is a prison, not a church. You cannot see your son until after the trial."

### W. BANKERS MAY BE ABLE TO VISIT JORDAN WITHOUT PERMITS, DAYAN SAYS

JERUSALEM, June 21 (JTA).—Defense Minister Moshe Dayan said today that West Bank residents may no longer need special permits to vieit Jordan. He said a proposal to eliminate the permits was under study but noted that even if the permits are abolished, West Bankers crossing into Jordan would have to show a special israell identity card or Jordanian pasport.

Gen. Dayan disolosed that about 30,000 of the

Gen. Dayan disclosed that about 30,000 of the 200,000 West Bankers who fled to Jordan during the 1967 Six-Day War have been permitted to return to re-

Join their families. He said there were many more who wished to return but that problem could only be solved when broader arrangements are made. He did not indicate what arrangements he had in mind.

#### WEIZMANN INSTITUTE HONORS WEILL FOR AID TO MEDICAL RESEARCH

TEL AVIV, June 21 (JTA)—Gen. Haim Bar Lev, the Minister of Commerce and industry, said last night that Israeli industry will employ 8000 academically trained people in the next four years, almost double the number it employs at present. He stressed that the future of Israel's industry depends on its ability to utilize scientific research.

Bar Lev spoke at the Weizmann Institute of Science in Rehovoth where an honorary fellowship was conferred on the American jurist and philanthropist, Harold Weill. Chancellor Meyer Weisgal of the Weizmann Institute and Abraham Feinberg, chairman of its board, spoke of Weill's role in adding medical and scientific research. Weill has helped sponsor research almed at eliminating leukemia, sickle cell anemia and Cooley Disease.

#### ISRAEL'S EXPORTS TO AFRICA RISING

JERUSALEM, June 21 (JTA)--Israel's exports to the African continent doubled during the past five years. They presently amount to \$47 million annually compared to \$23 million in 1967, according to the latest bulletin of the Ministry of Trade and Industry published today.

The bulletin noted thet trade possibilities with African nations, particularly those of East Africa, improved considerably since 1967. Progress was also reported in trade with West Africa but legislation curbing imports by Ghana and Nigeria had an adverse effect on Israeli exports to those countries.

Dr. Y. Shachar, the Ministry official in charge of trade with Africa, Asia and Latin America, reported that Africa was a particularly good market for equipment and capital goods related to agriculture, electricity and electronics. He said the steadily rising standard of living in many African countries has opened new markets for Israeli consumer goods.

#### GREEK EXPATRIATE WILL CONDUCT AT ISRAELI MUSIC FESTIVAL

TEL AVIV, June 21 (JTA)—The Greek expatriate composer, Mikis Theodorakis and his mustcal ensemble will participate in the 1972 Israeli Festival for Music and Drama which opens in Jerusalem July 15, it was reported here today. The Festival performances will be given in Jerusalem and in the Roman amphitheater in Caesarea, as in past years. The Israel Philharmonic will perform Samson and Delilah at Caesarea with Zubin Mehta conducting. The Bat Sheva and Bat Dor dance groups will also perform.

#### SYRIAN BEARS SEEK MATES IN ISRAEL

JERUSALEM, June 21 (JTA)—Two aging female Syrian bears from Washington, D.C. have arrived at the Jerusalem Biblical Zoo where they will be mated with the zoo's two male Syrian bears, the zoo's director Prof. Aharon Shulov of the Hebrew University reported this week.

The bears are a gift of the National Zoological Park in Washington. Zoo officials there who had waited in vain for over 29 years for an offspring of this rare animal discovered only recently that the two bears were both females.

#### COLLEGE PRESIDENT ASSAILS ETHNIC QUOTAS, OPEN ENROLLMENT IN NY COLLEGES

FALLSBURG, N.Y., June 21 (JTA) -- Employment "quotas" based on sex, race or any other standard but merit constitute "a danger stalking the Jewish community," because under them Jews would be "reduced to second-class citizens." a rabbinical sociologist declared today. Rabbi Bernard Lander, president of Touro College, New York, and a faculty member at Hunter College, addressed the 36th annual convention of the Rabbinical Council of America. He urged Jews to "shift" their career goals from academe to the business world, where, he said, merit and ability still prevail as employment criteria

Rabbi Lander also assailed "open enrollment." under which city high school graduates are automatically entitled to college entrance. Forty percent of high school graduates, he charged, do not have a junior high school knowledge of English, and thus open enrollment "is destroying the very fiber and content of American colleges, producing education that is not education, degrees that are not degrees. and increasing frustration among those involved,"

#### Had Second Thoughts QUEENS JCC SAYS JEWISH FEDERATION RENEGES ON LOAN PROMISES TO HOME BUYERS

NEW YORK, June 21 (JTA) -- An official of the Federation of Jewish Philanthropies conceded today that one of its agencies had had second thoughts about providing no-interest down-payment loans to Jewish familles seeking homes in integrated neighborhoods in the southeastern section of the Borough of Queens, The official, Rabbi Isaac Trainin, religious affairs advisor to Federation, responded to a criticism of Federation by the Queens Jewish Community Council which protested the "calling off" of a "firm and public commitment,"

"In an 'off again, on again' spree," the Council said, "this urgent matter is being reconsidered at the highest echelon of Federation. A definite program and/or answers are promised late this month. We shall see." The four communities involved -- Cambria Heights, Laurelton, Queens Village and Rosedale-"after seven months of delay and hassle...look in the direction of Federation and ask--when?" the JCC said.

Rabbi Trainin said the proposed program actually involved not Federation per se but one of its agencies. Hebrew Free Loan, which was not mentioned in the complaint, "The only sin you can accuse them of," he told the Jewish Telegraphic Agency, "is making a promise they didn't think through enough. Everyone makes mistakes."

He said Hebrew Free Loan had issued similar loans, on a smaller scale, in the past, but realized it "just didn't have" the huge funds required for the Queens project -- possibly "millions of dollars," Federation's Committee on Communal Planning has been studying the matter, he said, and will meet again next Wednesday,

#### IEWS WIN AGAINST JEWS, LOSE TO NON-JEWS IN NY DEM, PRIMARY

NEW YORK, June 21 (JTA) -- The next Congress may have at least two fewer Jewish members than the present one as a result of New York's Democratic primaries yesterday. Rep. Bella Abzug lost to Rep. William Ryan in Manhattan's 20th Congressional Dis-

trict and Rep. James Scheuer was defeated by Rep. Jonathan Bingham in the 22nd District in the Bronx. Abzug and Scheuer are Jewish,

Both contests were held in districts newly created by reapportionment and the race in each case was between staunch liberals. In the Bronx. where Bingham defeated Scheuer by a margin of about 5000 votes, appeals to Jowish voters who make up 60 percent of the district highlighted the campaign. Scheuer received national prominence when he was ordered to leave the Soviet Union after meetings with Russian Jews during a visit to the USSR. Bingham's campaign literature showed him photographed with Foreign Minister Abba Eban and Jerusalem's Mayor. Teddy Kollek,

In Brooklyn's heavily Jewish 16th Congressional District, Rep. Emanuel Celler, 84, a veteran of 50 years in Congress--he came in with the Harding administration--was upset by an attractive 30-year-old woman lawyer, Elizabeth Holtzman, also Jewish. But in the 14th District, a Jewish challenger, former Rep. Allard K. Lowenstein, was beaten by incumbent Congressman John J. Rooney. Rep. Bertram Podell won handily over his challenger, State Assemblyman Leonard Simon in Brooklyn's 13th District, Both are Jews

## NIXON, KOSYGIN ASKED TO

## INTERCEDE FOR GAVRIEL SHAPIRO

NEW YORK, June 21 (JTA) -- An Orthodox leader called on President Nixon and Soviet Premier Alexei Kosygin today to intercede for the release of Gavriel Shapiro so that he may re-join his American bride. Rabbi Joseph Karasick, president of the Union of Orthodox Jewish Congregations, sent identical telegrams to the White House and the Kremlin. He also sent the telegram to Secretary of State William P. Rogers and to Soviet Ambassador Anatoly Dobrynin in Washington,

Shapiro, a Jewish activist, has been held in jail since June 12 when he was arrested for evading military service. Four days earlier. he was wed to Judy Silver, a Cincinnati social worker in a religious ceremony at his Moscow home. Mrs. Shapiro, back in the US, has already asked President Nixon to intervene on behalf of her husband.

Rabbi Karasick's telegram said, "On behalf of over 3 million worshippers in 3000 Orthodox synagoguges throughout the US, we strongly urge immediate personal intercession for permission for Gavriel Shapiro of Moscow to join his bride, Judy, in America. Over-riding humanitarian concern demands their reunification in lov and happiness."

#### ISRAELI MINISTRY ORDERS CEMENT MONOP-OLY TO ALLEVIATE SHORTAGE WITH IMPORTS

JERUSALEM, June 21 (JTA) -- The Ministry of Commerce and Industry ordered the Nesher Cement Co. yesterday to import more cement in order to relieve a shortage of the product which is selling on the black market here for double the normal price.

Nesher has a monopoly on the domestic cement market but is required by its terms to import cement if the output of its own plants cannot keep pace with demands, as is the case at present. The firm is required to sell the imported cement at the same price as the domestic product even though the former is more expensive. Building contractors have complained recently that Nesher was circumventing its obligation by delaying imports.
