May Vote On Resolution SECURITY COUNCIL RESUMES EMERGENCY SESSION TODAY ON LEBANESE-ISRAELI CHARGES

UNITED NATIONS, N.Y., June 25 (JTA)—The Security Council will resume its emergency session on Lebanon's latest complaints against israel at ten o'clock tomorrow morning, presumably prepared to act on resolutions framed since it adjourned late last night. Lebanon is seeking "a very strong condemnation" of Israel for "persistent acts of aggression" and has the support of the Soviet Union, China and France among the Council's permanent members and of Yugoslavia, Somalia and Sudan. The United States indicated however that it would oppose any one-slided condemnation of Israel.

The Security Council met at the urgent request of Lebanon Friday, debated for three hours then and again for five hours Saturday. Ambassador George Bush, the US Ambassador to the UN, made it plain that he wanted any resolution to be fair and balanced and to look beyond the immediate incidents and at least give some hope of direction toward peace. He said the Security Council should indicate concern for the terrorists acts, as well as acts by Israel and compassion for the dead and wounded on both sides. He said the US would ofter a draft resolution to accomplish those ends.

Attack Follows Many Incidents

Lebanon's complaint against Israel stemmed from Israeli incursions three times last week against terrorist strongholds in the so-called "Fatahland" region of southeastern Lebanon where terrorist activity flared up last week for the first time since Feb. 25. Israeli forces raided "Fatahland" Tuesday following a bazooka attack on an Israeli tourist bus, a mining incident in which two Israeli soldiers were injured and a sniper attack that wounded two other Israeli soldiers. Israeli air, ground and artillery forces struck at "Ratahland" again Wednesday when an Israeli patrol captured five high ranking Syrian intelligence officers and one Lebanese officer apparently on a joint reconnaisance mission. The Israeli immigrant township of Kiryat Shemona near the Lebanese border, came under Katyusha rocket attack Thursday, causing damage but no casualties. Israel! warplanes and artillery attacked terrorist positions again the same day, Beirut claimed 18 civilians were killed and 12 wounded,

During the lengthy debate in the Security

Tekoah Charges Double Standard

Tekoah accused the Security Council of applying a "double standard," taking action not when Jewish blood was spilled but only when Israel, as a last resort, struck back. He said the Israeli Air Force and artillery had "reacted in self defense" against the main concentrations of Arab terrorists in "Fatahland." He called on Lebanon to abide by its international obligations and put an end to the "orininal activities" by terrorists on its soil thus making it unnecessary for Israel to act.

Tekoah accused the Soviet Union of playing a negative role in the Middle East, "supporting Arab aggression" and providing the Arabs with unlimited supplies of arms. But the Israeli envoy made an unusual bid for China to understand Israel's position. "In the dawn of recorded history there had been two nations in Asia—China in the East and Israel in the West," Tekoah said. "China knows that history did not begin with Arab efforts to oust the Israelis from the Middle East. The people of China will recognize Israel's fundamental rights of peace and co-existence," he said:

Earlier in the debate, Lebanon demanded that Israel return the five Syrian officers captured on its territory. Tekoah said the five officers had been on a reconnaisance mission organized jointly with the Lebanese Army "to collect military data and work on guidelines for future operations" against Israel. He said the nature of their mission was disclosed in papers found on the prisoners. The Syrian Ambassador, George Tomeh, claimed the five officers were not POWs since they were not on a military mission

(Foreign Minister Abba Eban told the regular weekly Cabinet session in Jerusalem today that Israel regards as "one-sided" a proposed draft he indicated was now under consideration by the United Nations Security Council, a resolution which purportedly condemns Israel for its weekend attacks on Lebanon while deploring all violent activities. The Foreign Minister, reporting on Israell efforts at the Unit of "balance" whatever resolution the Council approves, ascribed authorship of the "one-sided" draft resolution to several European countries. He said such a resolution would encourage the Arabs to continue their aggression against Israel.

The second part of the purported draft deals will exchange of prisoners, expressing "satisfaction" about the contacts already established between the parties but it reportedly expresses the hope that the five Syrtan officers captured by the Israell force that moved into Fatahiand on Wednesday will be released promptly. It was indicated that Israel's UN efforts are concentrated on persuading the Security Council to leave the matter of prisoner exchanges to the International Red Cross.)

SEIZED SYRIAN OFFICERS ADMIT THEY WERE ON JOINT MILITARY MISSION

TEL AVIV. June 25 (JTA).—Five high ranking Syrian intelligence officers captured by an Israeli patrol inside Lebanon near the Israeli border Wednesday have admitted they were on a joint military mission with Lebanese officers, Chief of Staff Gen. David Elazar disclosed today. He said the admissions belied claims from Betrut and Damasous that the JTA Daily News Bulletin

officers were merely sight-seeing and were "kidnapped" by the Israelis.

He said the officers revealed that they were on a joint reconnaisance mission aimed at pinpointing targets in Israel. Gen. Elazar coupled his disclosure with a warning to Lebanon to block further terrorist activities against Israe' from Lebanese soil. He said that unless the Beirut authorities take drastic action Israel w. .. continue to take whatever measures it deemed

On Friday night an Israeli naval patrol encountered and sank a boatload of terrorists off the Lebanese town of Tzor. Gen. Elazar dismissed claims by the Lebanese authorities that they were unaware of the existence of terrorist training camps in Lebanon, He said Lebanon is an eager host to the terrorists. Their headquarters are located in Lebanon and conditions still exist in that country which allow the terrorists to train for their missions, he said. Referring to the three Japanese "kamikaze" gunmen who killed 26 and wounded more than 70 in the Lydda Airport massacre May 30, Gen. Elazar said he knew exactly where they had "trained, ate and slept" in Lebanon prior to embarking on their assassination mission.

(Reports from London yesterday said Lebanca might try to avert further retaliatory action by Israel by modifying its Cairo agreement with the Palestinian guerrillas. The agreement gave the terrorists leave to use Lebanon as a staging area for incursions against Israel but not to fire at Israeli targets from Lebanese soil. The agreement is not likely to be abrogated, given the internal political conditions in Lebanon, but there is strong pressure on the Beirut authorities to get the terrorists to leave Lebanon for another Arab country once they have completed their training, the re-

Foreign Policy Section To Be Ready For Discussion Today PLATFORM UNIT HEARS DIFFERING VIEWS ON MIDEAST FROM THREE DEMOCRATIC PRESIDENTIAL BIDDERS

WASHINGTON, June 25 (JTA) -- Three contenders for the Democratic Presidential nomination expressed sharply divergent views on the Middle East conflict in hearings before the Democratic Platform Committee here yesterday, Sen. Hubert H. Humphrey (D.Minn.) and Sen. Edmund S. Muskie (D.Me.) urged the committee drafting their party's platform to write in a strong statement of comprehensive US support for Israel and advocated that the US recognize Jerusalem as Israel's capital, Rep. Shirley Chisholm (D.NY), the only Black and the only woman campaigning for the nomination, accused her opponents of using "rhetoric designed to attract the votes of the Jewish people" and claimed

they ignored the Palestinians whom "you cannot

sweep under the rug.

Mrs. Chisholm contended that the refugee problem was the "root cause of the problem of the Middle East. Former Sen, Eugene McCarthy of Minnesota, who was a Presidential contender in 1968 and again this year, called for an endorsement of Israeli security on "moral and legal grounds." Sen. George McGovern (D.SD), currently the front runner in the Democratic nomination sweepstakes urged a strong pro-Israel plank when he appeared before a Platform Committee panel in New York Thursday. 'Threatening Powder Keg'

Sen. Humphrey described the Middle East as the "world's most threatening powder keg, ready to ig-nite at any moment." He said the Soviet Union continues to supply Arab countries with "provocative weapons," military technicians and diplomatic

support "which only serve to bolster their intransigence towards reaching a comprehensive agreement with Israel." The former Vice President declared that the US "must convince the Soviet Union to assume a stand-off position in the Middle East and reach an agreement whereby neither country attempts to obstruct negotiations. Sen. Muskie likewise urged the US to maintain

strong support for Israel and stressed the need for "direct negotiations between the parties involved" in the Mideast conflict and "preservation of the unity of Jerusalem with free access to the holy places, backed by US recognition of Jerusalem as the capital of Israel." Muskie also urged the Platform Committee to support "freedom of navigation through the Suez Canal and the Straits of Tiran; resettlement and compensation of refugees, Arab and Jewish; effective controls to end terrorism and hijacking; the end of economic warfare, boycotts and blockades; and de-escalation of the arms race."

Mrs. Chisholm's Program Mrs. Chisholm's remarks on the Middle East were contained in her "Presidential campaign position paper no. 2" in which she outlined a five-point program for the stability and territorial integrity of all states in the region, guaranteed by the United Nations. Her paper made no reference to Security Counci resolution 242 of Nov. 22, 1967 which is generally accepted by all parties as the framework for a future Mideast peace settlement. Nor did it refer to any of the Israeli or American viewpoints regarding settlement of the refugee problem or any

other factor in the Middle East. Her charge that her opponents were trying to woo the Jewish vote was made when she was asked pointedly why she does not oppose the resolution of the National Black Political Convention in Gary, Ind. on March 12, that, in effect, called for the dismantling of Israel. Mrs. Chisholm said, "The creation of the State of Israel in Palestine was meant to be a form of ultimate moral redress by the West for the atrocities committed against Jews throughout their long history." But, she went on, "in the midst of rejoicing at the creation of a national homeland for the Jews, the world overlooked the hardship and misery created for the Palestinians." Mrs. Chisholm's proposals to the Platform

Committee included a recommendation that the US resume diplomatic relations with all Mideast governments; increased economic aid to the lessdeveloped nations of the region; a limitation of arms shipments to the region and full representation for the Palestinians in all negotiations concerning the return or compensation for Palestinian Arab property, Observers at the committee hearings throught that Mrs. Chisholm's remarks on the Middle East constituted a bid for attention from elements in the Democratic Party, who, like certain elements in the Republican Party, have been questioning US support for Israel.

FOREIGN POLICY SECTION

NEARING DISCUSSION STAGE

WASHINGTON, June 25 (JTA) -- The foreign policy section of the 1972 Democratic Party platform-the part that will contain the party's position on the Middle East and Soviet Jewry among other things-will be worked on tonight and will be in the hands of the full Platform Committee for discussion by nine o'clock tomorrow morning, the Jewish Telegraphic Agency was told today by Mayor Ken-neth Gibson of Newark, chairman of the 15-member sub-committee assigned the task of drafting the platform. Asked if there was a concensus in his sub-committee on the Israel plank, Mayor Gibson replied, "No, not yet. We haven't discussed foreign policy at all as a group.

\$50 Million Approved Before SENATE VOTES EXTRA \$35 MILLION IN MILITARY AID TO ISRAEL

WASHINGTON, June 25 (JTA)—The Senate, in sharp debate over a \$1.7 billion foreign military aid authorization bill, voted Friday to approve an additional \$35 million in military aid to Israel. The sum is in addition to \$50 million in security supporting assistance and \$300 million in military sales credits already ear-marked for Israel in the measure. The Senate has yet to complete debate on the aid bill and must adopt an appropriations bill to fund it. Israel benefited from a tug-of-war between Administration and Democratic forces over the restoretion of \$245 million slashed from the Administration's request for worldwide millitary aid.

Senate Minority Leader Hugh Scott (R.Pa.), in an apparent appeal to pro-Israel sentiments in the Senate, proposed \$20 million in military ald for Israel beyond the original \$50 million. Sen. Frank Church (D. Idaho) countered with another \$15 million for Israel, Both added sums were approved but the remainder of the \$245 million package was rejected by a \$7.25 vote. The total for Israel now stands at \$85 million in addition to the \$300 sales credits. The amount could be reduced when the Senate votes an appropriations bill to fund the foreign aid authorizations.

DRIVE STARTED IN CALIFORNIA TO PERSUADE NIXON TO REPORT ON SOVIET JEWISH MOSCOW TALKS

LOS ANGELES, June 25 (JTA)—Leaders of two Los Angeles Soviet Jewry groups, expressing "bitter disappointment" with the results of President Nixon's talks with Soviet leaders during his May Moscow visit, said today that they had started a "grass roots" effort to persuade the Nixon Administration to release details of the President's conversations with the Russian leaders on behalf of Soviet Jews in general and some 40 Jewish political prisoners in particular.

The White House has refused to release details of the President's Moscow talks, declaring that the formal reports had been made classified documents by both governments. Dr. Henry Kissinger, the President's national security adviser, who was present at the Moscow talks, said later in Kiev that the question of Soviet Jews had been discussed but declined to give details. After Sen. John Tunney, (D. Calif.) expressed skepticism that such talks had been held, Sen, Charles Percy (R. III.) was quoted on June 22 by Capitol Hill sources as informing Jewish constituents that the Soviet Jewish issue was discussed at the highest levels" at the Moscow conference and that he had been so informed by the White House, Sen. Henry M. Jackson, (D. Wash.) told the National Press Club last Thursday that the nation's news media should demand from the President at a press conference what he said in Moscow on the issue and what response the Soviet leadership made.

SI Frumkin, chairman of the Southern California Council for Soviet Jews, and Zev Yaroslavsky, chairman of the California Students for Soviet Jews, cited the nation-wide campaign, in advance of the Moscow summit, which resulted in more than 50,000 letters, postcards, and telegrams to the White House asking the President to discuss the problem with the Soviet leaders and more than one million signatures collected on petitions.

They said legislatures of all 50 states passes similar resolutions and that the House of Representatives, by a 359-2 vote approved a resoluting asking top priority on the issue during the Moscow talks, as did "hundreds of mayors and city councils."

Asserting that the White House "was aware of the importance" of the issue felt by "millions of Americans of every race, creed and color," the White House "refused to commit itself before the trip and there has been only silence and evasion since."

The two officials cited reports from Jews in Russia that Soviet authorities had been intensifying repressive measures against Jewish dissidents since the Moscow summit. They said that Russian Jews "had very high hopes for the Nixon visit." They asserted that "the actual results will go far to demoralize the Jewish resistance fighters." They said the two organizations are urging that letters and telegrams be sent to the President asking him to report to the American people on the issue. They said the President "was asked to speak for all of us and we have the right to know whether he did."

SOURCES REPORT TRIAL OF SHAPIRO TO START JULY 1

LONDON, June 25 (JTA) -- Jewish sources in the Soviet Union reported today that Gavriel Shapiro, who married an American girl, Judy Silver of Cincinnati, in Moscow but was not allowed to leave the Soviet Union, has been informed his trial will start July 1. He is being charged with violation of Art, 198 of the Soviet penal code which concerns evasion of military duty. Shapiro was arrested at the Moscow airport when he saw his new bride off. He went into hiding with other Jewish activists during the Nixon visit to Moscow but emerged for his wedding on June 12. He is a reserve officer who has served his military duty. (An appeal to Mrs. Richard Nixon and Mrs. Leonid Brezhnev to intercede for Shapiro's release was cabled by Mrs. Jacqueline Levine, president of the Women's Division of the American Jewish Congress, Mrs. Levine also wrote to women members of the US Congress to intercede "as women and legislators" for the couple.)

PINCUS PREDICTS CURRENT UJA DRIVE WILL TOP '67 RECORD

TEL AVIV, June 25 (JTA)—Louis A. Pincus, chairman of the Jewish Agency Executive, predicted today that the results of the current United Jewish Appeal campaign in the US may exceed the all-time record set in 1967, the year of the Six Day War. Pincus returned Friday from a visit to the US. While there he was involved in establishing a priority list for the funds available in view of the needs of Israel's institutions of higher learning. He conferred on that subject with Zionist leaders in the US and Britain.

WEILL ANNOUNCES \$850 MILLION GRANT TO WEIZMANN INSTITUTE FOR CANCER RESEARCH

TEL AVIV, June 25 (JTA).—Harold Welll, president of the Talisman Foundation of New York, announced here today research grants totalling \$850,000 to the Weizmann Institute of Science in Rehovoth to finance cancer studies. Last week Welll was made an honorary fellow of the Weizmann Institute in recognition of his aid in research aimed at eliminating leukemia, sickle cell anemia and Cooley's Disease.

W. GERMANY WILL PAY COMPENSATION TO NAZI VICTIMS WHO MISSED REPARATIONS DEADLINE

TEL AVIV, June 25 (JTA).—West German Ambassador, Jesco Von Puttkamer, said today that his government would pay compensation to Nazi victims who arrived in Israel after 1965 and were therefore ineligible to share in the reparations paid to Israel under the 1952 agreement which expired before their arrival.

Columnist Challenged On Lydda BOSTON JEWISH COUNCIL SAYS WILL COMPLAIN TO FCC ON ALLEGED TV STATION UNFAIRNESS

BOSTON, June 25 (JTA)—An announcement by the Jewish Community Council of Metropolitan Boston that it would complain to the Federal Communications Commission about alleged unfairness by WBZ-TV was described by the television station's program manager as "premature," since, he said, the Council had agreed to meet with the station on the matter Monday or Tuesday.

The Council is protesting the station's refusal to allow an editorial commentary to rebut a June 4 statement by Erwin D. Canham, 68-year-old editor of the Caristian Science Monitor. Canham, in one of a regular series of personal commentaries by various news analysts disseminated by Group W. (Westinghouse Broadcasting), said of the "swful tragedy" at Tel Aviv's Lydda Airport May 30 that "terror cannot be ended by terror." An "israeli reprisal by force," he said, could "lead to continuing escalation of terror."

Says Canham Distorted Issues

The JCC was angered, it said in its announcement, because Canham equated the massacre by Arab-paid terrorists. . . with efforts by Israeli soldiers to free a plane and its passengers held hostage by Arab terrorists two weeks earlier." "At no time." said Albert Schlossberg, chairman of the JCC's Media Committee, edid Mr. Canham refer to the true culprits in the case, to Arab terrorists and to the governments of Lebanon, Egypt and Syria which harbor and encourage them. But, in his mild and effective way. Mr. Canham seemed to leave the impression that the Israelis were actually responsible for the massacre because they failed to yield to the Arab hijackers and release imprisoned terrorists demanded by the hijackers when they took over a Sabena Airline plane earlier in May."

WBZ-TV program managor Paul D. Cosstold a JCC delegation and inter the Jewish Telegraphic Agency that he did not feel a rebuttal "was necessary," since he felt that the station's news coverage of the Lydda shootout and its aftermath emphasized the points the JCC thought important. The JCC complaint arrived at his office, he said, "at the very moment Moshe Dayan was on our atrtalking about that incident." Coss' added, however, that he considered the delegation to be "very sincere" and that a "very agreeable" solution should be forthcoming.

Joining Schlossberg in the group were Philip Krup of the Anti-Defamation League of Brais Brith and JCC counsel Stephen R. Morse, They said the FCC's so-called fairness doctrine "requires opposing viewpoints to be aired on radio and television stations." More accurately, the doctrine applies to "controversial issues of public importance."

Joins Black Labor Group JEWISH LABOR COMMITTEE BACKS STRIKE AGAINST CLOTHING MAKER ACCUSED OF ANTI-UNION ACTIONS

PHILADELPHIA, June 25 (JTA)--The Jewish Labor Committee joined with a Black labor group here today in support of a strike by the Amalgamated Clobing Workers Union against the Farah Manufacturing Company, one of the world's largest manufacturers of men's slacks and sportswear. A joint statement issued by Albert Atcovits, chairman of the JLC, and James H. Jones, president of the Negro Trade Union Leadership, urged a boycott of Farah products until its employees *are treated with dignity and receive decent wages and working conditions."

Farsh operates plants in Texas and New Mexico employing thousands of workers, a majority of whom are Mexican-Americans, According to the joint statement the firm has fired employes engaged in lawful union activities; has refused to comply with a National Labor Relations Board recommendation to reinstate 19 workers illegally dismissed from the El Paso plant; and has refused to bargain with the Amalgamated Clothing Workers after the union won an election at one plant unit."

The statement accused Farah of attempting *to break the spirit and determination of the union pickets through intimidation*. It charged further that despite orderly picketing, union members have been arrested at their homes in the middle of the night and held on \$400 ball whereas ball for similar charges unrelated to the union dispute was set at \$25.

Reform Colleagues Join Charge RABBINICAL GROUP DENOUNCES OFFICIATING AT MIXED MARRIAGES

EDISON, NEW JERSEY, June 25 JTA).—The Resource of the Raritata Valley Rabbinical Association have joined their Orthodox and Conservative colleagues on the association in denouncing the practice among some Reform rabbis of officiating at mixed marriages, the Association disclosed today. The joint statement of the 13 rabbis followed a report last week at the 83rd Annual Convention of the Central Conference of American Rabbis that as many as 41 percent of the Reform rabbis perform marriages of Jewish and non-Jewish partners. The figure, much larger than generally believed, was greeted with shock by leaders of the Jewish community.

In what he called the first such joint statement, Rabbi David Leiter, Chairman of the Raritan Valley Rabbinical Association, announced the group's unantmous condemnation of mixed marriages. The resolution declared that "when a rabbi officiates at a mixed marriage, he is using the Jewish wedding ceremony dishonestly and without respect for the integrity of the Jewish people and its faith." "Mixed marriages," the resolution asserted, "are contrary to the tradition of the Jewish religion. Out of the Integrity of our position, we will not officiate at the marriage of a Jew and a non-Jew, nor a purely civil ceremony, nor allow our respective synaogugues or temples to be used for such marriages."

MORE JEWISH GROUPS ASSAIL HEW ORDER TO CITY UNIVERSITY ON PERSONNEL RACE, SEX DATA

NEW YORK, June 25 (JTA) -- New York State Supreme Court Justice Abraham J. Multer challenged today an order from the Civil Rights office of the De-partment of Health, Education and Welfare to City University of New York to supply it with data relating to the race and sex of its faculty and employes. Speaking as president of the Brooklyn Jewish Community Council, which re-elected him to a second one-year term, Judge Multer declared that the Council "will not countenance any discriminatory or unfair hiring practices or admission policies in our system of higher education." The United Zionists-Revisionists of America disclosed meanwhile that it had protested directly to Secretary of HEW Elliot Richardson against the order to CUNY, Professor Howard L. Adelson, president of UZRA, described the order as an "ultimatum" in a letter to Richardson.

Israeli forces raided "Fatahland" Tuesday following a bazooka attack on an Israeli tourist bus, a mining incident in which two Israeli soldiers were injured and a sniper attack that wounded two other Israeli soldiers. Israeli air, ground and artillery forces struck at "Ratahland" again Wednesday when an Israeli patrol captured five high ranking Syrian intelligence officers and one Lebanese officer apparently on a joint reconnaisance mission. The Israeli immigrant township of Kiryat Shemona near the Lebanese border, came under Katyusha rocket attack Thursday, causing damage but no casualties. Israel! warplanes and artillery attacked terrorist positions again the same day, Beirut claimed 18 civilians were killed and 12 wounded,

During the lengthy debate in the Security

Tekoah Charges Double Standard

Tekoah accused the Security Council of applying a "double standard," taking action not when Jewish blood was spilled but only when Israel, as a last resort, struck back. He said the Israeli Air Force and artillery had "reacted in self defense" against the main concentrations of Arab terrorists in "Fatahland." He called on Lebanon to abide by its international obligations and put an end to the "orininal activities" by terrorists on its soil thus making it unnecessary for Israel to act.

Tekoah accused the Soviet Union of playing a negative role in the Middle East, "supporting Arab aggression" and providing the Arabs with unlimited supplies of arms. But the Israeli envoy made an unusual bid for China to understand Israel's position. "In the dawn of recorded history there had been two nations in Asia—China in the East and Israel in the West," Tekoah said. "China knows that history did not begin with Arab efforts to oust the Israelis from the Middle East. The people of China will recognize Israel's fundamental rights of peace and co-existence," he said:

Earlier in the debate, Lebanon demanded that Israel return the five Syrian officers captured on its territory. Tekoah said the five officers had been on a reconnaisance mission organized jointly with the Lebanese Army "to collect military data and work on guidelines for future operations" against Israel. He said the nature of their mission was disclosed in papers found on the prisoners. The Syrian Ambassador, George Tomeh, claimed the five officers were not POWs since they were not on a military mission

(Foreign Minister Abba Eban told the regular weekly Cabinet session in Jerusalem today that Israel regards as "one-sided" a proposed draft he indicated was now under consideration by the United Nations Security Council, a resolution which purportedly condemns Israel for its weekend attacks on Lebanon while deploring all violent activities. The Foreign Minister, reporting on Israell efforts at the Unit of "balance" whatever resolution the Council approves, ascribed authorship of the "one-sided" draft resolution to several European countries. He said such a resolution would encourage the Arabs to continue their aggression against Israel.

The second part of the purported draft deals will exchange of prisoners, expressing "satisfaction" about the contacts already established between the parties but it reportedly expresses the hope that the five Syrtan officers captured by the Israell force that moved into Fatahiand on Wednesday will be released promptly. It was indicated that Israel's UN efforts are concentrated on persuading the Security Council to leave the matter of prisoner exchanges to the International Red Cross.)

SEIZED SYRIAN OFFICERS ADMIT THEY WERE ON JOINT MILITARY MISSION

TEL AVIV. June 25 (JTA).—Five high ranking Syrian intelligence officers captured by an Israeli patrol inside Lebanon near the Israeli border Wednesday have admitted they were on a joint military mission with Lebanese officers, Chief of Staff Gen. David Elazar disclosed today. He said the admissions belied claims from Betrut and Damasous that the JTA Daily News Bulletin

officers were merely sight-seeing and were "kidnapped" by the Israelis.

He said the officers revealed that they were on a joint reconnaisance mission aimed at pinpointing targets in Israel. Gen. Elazar coupled his disclosure with a warning to Lebanon to block further terrorist activities against Israe' from Lebanese soil. He said that unless the Beirut authorities take drastic action Israel w. .. continue to take whatever measures it deemed

On Friday night an Israeli naval patrol encountered and sank a boatload of terrorists off the Lebanese town of Tzor. Gen. Elazar dismissed claims by the Lebanese authorities that they were unaware of the existence of terrorist training camps in Lebanon, He said Lebanon is an eager host to the terrorists. Their headquarters are located in Lebanon and conditions still exist in that country which allow the terrorists to train for their missions, he said. Referring to the three Japanese "kamikaze" gunmen who killed 26 and wounded more than 70 in the Lydda Airport massacre May 30, Gen. Elazar said he knew exactly where they had "trained, ate and slept" in Lebanon prior to embarking on their assassination mission.

(Reports from London yesterday said Lebanca might try to avert further retaliatory action by Israel by modifying its Cairo agreement with the Palestinian guerrillas. The agreement gave the terrorists leave to use Lebanon as a staging area for incursions against Israel but not to fire at Israeli targets from Lebanese soil. The agreement is not likely to be abrogated, given the internal political conditions in Lebanon, but there is strong pressure on the Beirut authorities to get the terrorists to leave Lebanon for another Arab country once they have completed their training, the re-

ports said.)

Foreign Policy Section To Be Ready For Discussion Today PLATFORM UNIT HEARS DIFFERING VIEWS ON MIDEAST FROM THREE DEMOCRATIC PRESIDENTIAL BIDDERS

WASHINGTON, June 25 (JTA) -- Three contenders for the Democratic Presidential nomination expressed sharply divergent views on the Middle East conflict in hearings before the Democratic Platform Committee here yesterday, Sen. Hubert H. Humphrey (D.Minn.) and Sen. Edmund S. Muskie (D.Me.) urged the committee drafting their party's platform to write in a strong statement of comprehensive US support for Israel and advocated that the US recognize Jerusalem as Israel's capital, Rep. Shirley Chisholm (D.NY), the only Black and the only woman campaigning for the nomination, accused her opponents of using "rhetoric designed to attract the votes of the Jewish people" and claimed

they ignored the Palestinians whom "you cannot

sweep under the rug.

Mrs. Chisholm contended that the refugee problem was the "root cause of the problem of the Middle East. Former Sen, Eugene McCarthy of Minnesota, who was a Presidential contender in 1968 and again this year, called for an endorsement of Israeli security on "moral and legal grounds." Sen. George McGovern (D.SD), currently the front runner in the Democratic nomination sweepstakes urged a strong pro-Israel plank when he appeared before a Platform Committee panel in New York Thursday. 'Threatening Powder Keg'

Sen. Humphrey described the Middle East as the "world's most threatening powder keg, ready to ig-nite at any moment." He said the Soviet Union continues to supply Arab countries with "provocative weapons," military technicians and diplomatic

support "which only serve to bolster their intransigence towards reaching a comprehensive agreement with Israel." The former Vice President declared that the US "must convince the Soviet Union to assume a stand-off position in the Middle East and reach an agreement whereby neither country attempts to obstruct negotiations. Sen. Muskie likewise urged the US to maintain

strong support for Israel and stressed the need for "direct negotiations between the parties involved" in the Mideast conflict and "preservation of the unity of Jerusalem with free access to the holy places, backed by US recognition of Jerusalem as the capital of Israel." Muskie also urged the Platform Committee to support "freedom of navigation through the Suez Canal and the Straits of Tiran; resettlement and compensation of refugees, Arab and Jewish; effective controls to end terrorism and hijacking; the end of economic warfare, boycotts and blockades; and de-escalation of the arms race."

Mrs. Chisholm's Program Mrs. Chisholm's remarks on the Middle East were contained in her "Presidential campaign position paper no. 2" in which she outlined a five-point program for the stability and territorial integrity of all states in the region, guaranteed by the United Nations. Her paper made no reference to Security Counci resolution 242 of Nov. 22, 1967 which is generally accepted by all parties as the framework for a future Mideast peace settlement. Nor did it refer to any of the Israeli or American viewpoints regarding settlement of the refugee problem or any

other factor in the Middle East. Her charge that her opponents were trying to woo the Jewish vote was made when she was asked pointedly why she does not oppose the resolution of the National Black Political Convention in Gary, Ind. on March 12, that, in effect, called for the dismantling of Israel. Mrs. Chisholm said, "The creation of the State of Israel in Palestine was meant to be a form of ultimate moral redress by the West for the atrocities committed against Jews throughout their long history." But, she went on, "in the midst of rejoicing at the creation of a national homeland for the Jews, the world overlooked the hardship and misery created for the Palestinians." Mrs. Chisholm's proposals to the Platform

Committee included a recommendation that the US resume diplomatic relations with all Mideast governments; increased economic aid to the lessdeveloped nations of the region; a limitation of arms shipments to the region and full representation for the Palestinians in all negotiations concerning the return or compensation for Palestinian Arab property, Observers at the committee hearings throught that Mrs. Chisholm's remarks on the Middle East constituted a bid for attention from elements in the Democratic Party, who, like certain elements in the Republican Party, have been questioning US support for Israel.

FOREIGN POLICY SECTION

NEARING DISCUSSION STAGE

WASHINGTON, June 25 (JTA) -- The foreign policy section of the 1972 Democratic Party platform-the part that will contain the party's position on the Middle East and Soviet Jewry among other things-will be worked on tonight and will be in the hands of the full Platform Committee for discussion by nine o'clock tomorrow morning, the Jewish Telegraphic Agency was told today by Mayor Ken-neth Gibson of Newark, chairman of the 15-member sub-committee assigned the task of drafting the platform. Asked if there was a concensus in his sub-committee on the Israel plank, Mayor Gibson replied, "No, not yet. We haven't discussed foreign policy at all as a group.

\$50 Million Approved Before SENATE VOTES EXTRA \$35 MILLION IN MILITARY AID TO ISRAEL

WASHINGTON, June 25 (JTA)—The Senate, in sharp debate over a \$1.7 billion foreign military aid authorization bill, voted Friday to approve an additional \$35 million in military aid to Israel. The sum is in addition to \$50 million in security supporting assistance and \$300 million in military sales credits already ear-marked for Israel in the measure. The Senate has yet to complete debate on the aid bill and must adopt an appropriations bill to fund it. Israel benefited from a tug-of-war between Administration and Democratic forces over the restoretion of \$245 million slashed from the Administration's request for worldwide millitary aid.

Senate Minority Leader Hugh Scott (R.Pa.), in an apparent appeal to pro-Israel sentiments in the Senate, proposed \$20 million in military ald for Israel beyond the original \$50 million. Sen. Frank Church (D. Idaho) countered with another \$15 million for Israel, Both added sums were approved but the remainder of the \$245 million package was rejected by a \$7.25 vote. The total for Israel now stands at \$85 million in addition to the \$300 sales credits. The amount could be reduced when the Senate votes an appropriations bill to fund the foreign aid authorizations.

DRIVE STARTED IN CALIFORNIA TO PERSUADE NIXON TO REPORT ON SOVIET JEWISH MOSCOW TALKS

LOS ANGELES, June 25 (JTA)—Leaders of two Los Angeles Soviet Jewry groups, expressing "bitter disappointment" with the results of President Nixon's talks with Soviet leaders during his May Moscow visit, said today that they had started a "grass roots" effort to persuade the Nixon Administration to release details of the President's conversations with the Russian leaders on behalf of Soviet Jews in general and some 40 Jewish political prisoners in particular.

The White House has refused to release details of the President's Moscow talks, declaring that the formal reports had been made classified documents by both governments. Dr. Henry Kissinger, the President's national security adviser, who was present at the Moscow talks, said later in Kiev that the question of Soviet Jews had been discussed but declined to give details. After Sen. John Tunney, (D. Calif.) expressed skepticism that such talks had been held, Sen, Charles Percy (R. III.) was quoted on June 22 by Capitol Hill sources as informing Jewish constituents that the Soviet Jewish issue was discussed at the highest levels" at the Moscow conference and that he had been so informed by the White House, Sen. Henry M. Jackson, (D. Wash.) told the National Press Club last Thursday that the nation's news media should demand from the President at a press conference what he said in Moscow on the issue and what response the Soviet leadership made.

SI Frumkin, chairman of the Southern California Council for Soviet Jews, and Zev Yaroslavsky, chairman of the California Students for Soviet Jews, cited the nation-wide campaign, in advance of the Moscow summit, which resulted in more than 50,000 letters, postcards, and telegrams to the White House asking the President to discuss the problem with the Soviet leaders and more than one million signatures collected on petitions.

They said legislatures of all 50 states passes similar resolutions and that the House of Representatives, by a 359-2 vote approved a resoluting asking top priority on the issue during the Moscow talks, as did "hundreds of mayors and city councils."

Asserting that the White House "was aware of the importance" of the issue felt by "millions of Americans of every race, creed and color," the White House "refused to commit itself before the trip and there has been only silence and evasion since."

The two officials cited reports from Jews in Russia that Soviet authorities had been intensifying repressive measures against Jewish dissidents since the Moscow summit. They said that Russian Jews "had very high hopes for the Nixon visit." They asserted that "the actual results will go far to demoralize the Jewish resistance fighters." They said the two organizations are urging that letters and telegrams be sent to the President asking him to report to the American people on the issue. They said the President "was asked to speak for all of us and we have the right to know whether he did."

SOURCES REPORT TRIAL OF SHAPIRO TO START JULY 1

LONDON, June 25 (JTA) -- Jewish sources in the Soviet Union reported today that Gavriel Shapiro, who married an American girl, Judy Silver of Cincinnati, in Moscow but was not allowed to leave the Soviet Union, has been informed his trial will start July 1. He is being charged with violation of Art, 198 of the Soviet penal code which concerns evasion of military duty. Shapiro was arrested at the Moscow airport when he saw his new bride off. He went into hiding with other Jewish activists during the Nixon visit to Moscow but emerged for his wedding on June 12. He is a reserve officer who has served his military duty. (An appeal to Mrs. Richard Nixon and Mrs. Leonid Brezhnev to intercede for Shapiro's release was cabled by Mrs. Jacqueline Levine, president of the Women's Division of the American Jewish Congress, Mrs. Levine also wrote to women members of the US Congress to intercede "as women and legislators" for the couple.)

PINCUS PREDICTS CURRENT UJA DRIVE WILL TOP '67 RECORD

TEL AVIV, June 25 (JTA)—Louis A. Pincus, chairman of the Jewish Agency Executive, predicted today that the results of the current United Jewish Appeal campaign in the US may exceed the all-time record set in 1967, the year of the Six Day War. Pincus returned Friday from a visit to the US. While there he was involved in establishing a priority list for the funds available in view of the needs of Israel's institutions of higher learning. He conferred on that subject with Zionist leaders in the US and Britain.

WEILL ANNOUNCES \$850 MILLION GRANT TO WEIZMANN INSTITUTE FOR CANCER RESEARCH

TEL AVIV, June 25 (JTA).—Harold Welll, president of the Talisman Foundation of New York, announced here today research grants totalling \$850,000 to the Weizmann Institute of Science in Rehovoth to finance cancer studies. Last week Welll was made an honorary fellow of the Weizmann Institute in recognition of his aid in research aimed at eliminating leukemia, sickle cell anemia and Cooley's Disease.

W. GERMANY WILL PAY COMPENSATION TO NAZI VICTIMS WHO MISSED REPARATIONS DEADLINE

TEL AVIV, June 25 (JTA).—West German Ambassador, Jesco Von Puttkamer, said today that his government would pay compensation to Nazi victims who arrived in Israel after 1965 and were therefore ineligible to share in the reparations paid to Israel under the 1952 agreement which expired before their arrival.

Columnist Challenged On Lydda BOSTON JEWISH COUNCIL SAYS WILL COMPLAIN TO FCC ON ALLEGED TV STATION UNFAIRNESS

BOSTON, June 25 (JTA)—An announcement by the Jewish Community Council of Metropolitan Boston that it would complain to the Federal Communications Commission about alleged unfairness by WBZ-TV was described by the television station's program manager as "premature," since, he said, the Council had agreed to meet with the station on the matter Monday or Tuesday.

The Council is protesting the station's refusal to allow an editorial commentary to rebut a June 4 statement by Erwin D. Canham, 68-year-old editor of the Caristian Science Monitor. Canham, in one of a regular series of personal commentaries by various news analysts disseminated by Group W. (Westinghouse Broadcasting), said of the "swful tragedy" at Tel Aviv's Lydda Airport May 30 that "terror cannot be ended by terror." An "israeli reprisal by force," he said, could "lead to continuing escalation of terror."

Says Canham Distorted Issues

The JCC was angered, it said in its announcement, because Canham equated the massacre by Arab-paid terrorists. . . with efforts by Israeli soldiers to free a plane and its passengers held hostage by Arab terrorists two weeks earlier." "At no time." said Albert Schlossberg, chairman of the JCC's Media Committee, edid Mr. Canham refer to the true culprits in the case, to Arab terrorists and to the governments of Lebanon, Egypt and Syria which harbor and encourage them. But, in his mild and effective way. Mr. Canham seemed to leave the impression that the Israelis were actually responsible for the massacre because they failed to yield to the Arab hijackers and release imprisoned terrorists demanded by the hijackers when they took over a Sabena Airline plane earlier in May."

WBZ-TV program managor Paul D. Cosstold a JCC delegation and inter the Jewish Telegraphic Agency that he did not feel a rebuttal "was necessary," since he felt that the station's news coverage of the Lydda shootout and its aftermath emphasized the points the JCC thought important. The JCC complaint arrived at his office, he said, "at the very moment Moshe Dayan was on our atrtalking about that incident." Coss' added, however, that he considered the delegation to be "very sincere" and that a "very agreeable" solution should be forthcoming.

Joining Schlossberg in the group were Philip Krup of the Anti-Defamation League of Brais Brith and JCC counsel Stephen R. Morse, They said the FCC's so-called fairness doctrine "requires opposing viewpoints to be aired on radio and television stations." More accurately, the doctrine applies to "controversial issues of public importance."

Joins Black Labor Group JEWISH LABOR COMMITTEE BACKS STRIKE AGAINST CLOTHING MAKER ACCUSED OF ANTI-UNION ACTIONS

PHILADELPHIA, June 25 (JTA)--The Jewish Labor Committee joined with a Black labor group here today in support of a strike by the Amalgamated Clobing Workers Union against the Farah Manufacturing Company, one of the world's largest manufacturers of men's slacks and sportswear. A joint statement issued by Albert Atcovits, chairman of the JLC, and James H. Jones, president of the Negro Trade Union Leadership, urged a boycott of Farah products until its employees *are treated with dignity and receive decent wages and working conditions."

Farsh operates plants in Texas and New Mexico employing thousands of workers, a majority of whom are Mexican-Americans, According to the joint statement the firm has fired employes engaged in lawful union activities; has refused to comply with a National Labor Relations Board recommendation to reinstate 19 workers illegally dismissed from the El Paso plant; and has refused to bargain with the Amalgamated Clothing Workers after the union won an election at one plant unit."

The statement accused Farah of attempting *to break the spirit and determination of the union pickets through intimidation*. It charged further that despite orderly picketing, union members have been arrested at their homes in the middle of the night and held on \$400 ball whereas ball for similar charges unrelated to the union dispute was set at \$25.

Reform Colleagues Join Charge RABBINICAL GROUP DENOUNCES OFFICIATING AT MIXED MARRIAGES

EDISON, NEW JERSEY, June 25 JTA).—The Resource of the Raritata Valley Rabbinical Association have joined their Orthodox and Conservative colleagues on the association in denouncing the practice among some Reform rabbis of officiating at mixed marriages, the Association disclosed today. The joint statement of the 13 rabbis followed a report last week at the 83rd Annual Convention of the Central Conference of American Rabbis that as many as 41 percent of the Reform rabbis perform marriages of Jewish and non-Jewish partners. The figure, much larger than generally believed, was greeted with shock by leaders of the Jewish community.

In what he called the first such joint statement, Rabbi David Leiter, Chairman of the Raritan Valley Rabbinical Association, announced the group's unantmous condemnation of mixed marriages. The resolution declared that "when a rabbi officiates at a mixed marriage, he is using the Jewish wedding ceremony dishonestly and without respect for the integrity of the Jewish people and its faith." "Mixed marriages," the resolution asserted, "are contrary to the tradition of the Jewish religion. Out of the Integrity of our position, we will not officiate at the marriage of a Jew and a non-Jew, nor a purely civil ceremony, nor allow our respective synaogugues or temples to be used for such marriages."

MORE JEWISH GROUPS ASSAIL HEW ORDER TO CITY UNIVERSITY ON PERSONNEL RACE, SEX DATA

NEW YORK, June 25 (JTA) -- New York State Supreme Court Justice Abraham J. Multer challenged today an order from the Civil Rights office of the De-partment of Health, Education and Welfare to City University of New York to supply it with data relating to the race and sex of its faculty and employes. Speaking as president of the Brooklyn Jewish Community Council, which re-elected him to a second one-year term, Judge Multer declared that the Council "will not countenance any discriminatory or unfair hiring practices or admission policies in our system of higher education." The United Zionists-Revisionists of America disclosed meanwhile that it had protested directly to Secretary of HEW Elliot Richardson against the order to CUNY, Professor Howard L. Adelson, president of UZRA, described the order as an "ultimatum" in a letter to Richardson.
