Platform Unit Recommendations

DEMOCRATIC COMMITTEE URGES

STRONG U.S. SUPPORT FOR ISRAEL

AND FOR AID TO SOVIET JEWS

WASHINGTON, June 26 (JTA)--Platform writers for the Democratic party's forthcoming presidential nominating convention recommended here today that the United States recognize Jerusalem as Israel's capital and move the US Embassy from Tel Aviv to Jerusalem.

The 15-member Democratic platform subcommittee made the recommendation in its draft of the proposed platform after working through most of the night. It also recommended that the United States "be unequivocally committed to support Israel's right to exist within secure and defensible boundarless" and that the US government "mobilize world opinion" on behalf of Soviet Jews.

These and other subcommittee recommendations on domestic and international issues take up 84 single-spaced typewritten pages slated for debate later by the full 150-member platform committee. The full committee is not expected to reach the foreign policy sections until possibly tomorrow. However, the feeling among the delegates was that the Israel and Soviet Jewry sections are not likely to be buffeted by disputes expected over other recommendations, particularly in domestic areas.

'U.S. Should Mobilize Opinion'

The subcommittee declared it welcomed "every improvement" between the US and the Soviet Union but added that "America cannot afford to be blind to the continued existence of serious differences between us." In particular, the passage said, "the United States should, by diplomatic contacts, seek to mobilize world opinion to express concern at the denial to Soviet Jews of the right to practice their religion and culture and to leave the Soviet Union."

Some observers suggested that the passage was deficient in that it made no specific mention that the US should take up the Soviet Jewish issue in blateral activities planned or underway on such maters as trade and cultural exchanges. Some surprise was expressed that the section made no reference to other Soviet minorities.

In the Middle East section, the subcommittee recommended "a firm, long-term public commitment to provide Israel with aircraft and other military equipment," to "preserve her deterrent strength in the face of Soviet arsenaling of Arab threats of renewed war." Another recommendation called for efforts to bring "the parties into direct negotiations" for a "permanent political solution," But the section did not mention Security Council Resolution 242 of 1967 which has been considered the basis for peace-making efforts since the Six-Day War. One specialist on the Middle East indicated he felt the omission was in effect urging the US to go beyond the 242 Resolution's provisions to safeguard Israel's security.

Commitment Needed To Deter USSR

The subcommittee also recommended that the US maintain "a political commitment and a military force" in the Middle East "amply sufficient to deter the Soviet Union from using military force in the area." In the fifth and final point, the subcommittee said the US should "recognize the responsibility of the world community for a just solu-

tion of the problems of the Arab refugees." Kenneth Gibson, Mayor of Newark and subcommittee chairman, represents, with other Black members, a fifth of the subcommittee's membership. They were understood to have approved without dissent the language of the recommendations on Soviet Jewry and Israel. The other Blacks include the Rev. Walter Fauntroy, D.C. representative, and Mrs. Massey Eberhardt, also from New Jersey. The Rev. Fauntroy is a member of the Congressional Black Caucus which issued a strong pro-Israel statement after the Black National Political Convention adopted last March in Gary, Ind., a resolution which in effect called for dismantling of Israel. Rep. Bella Ab zug (D.N.Y.), a member of the subcommittee told the Jewish Telegraphic Agency that the Israel and Soviet Jewry recommendations were "overwhelmingly" voted by the subcommittee. She said that perhaps "one or two" members were opposed but she did not name them.

BRAEL SEEKS CHANGE IN A DRAFT
TERMING SYRIAN SEIZURE 'ABDUCTION'

JERUSALEM, June 26 (J7A).—The Israeli delegation to the United Nations is making efforts to eliminate a paragraph in a draft resolution for the Security Council which terms the capture of five high ranking Syrian officers by an Israeli patrol in Lebanon last Wednesday an "abduction," it was learned here today. Israel insists that the five who range in rank from Lt. Col. to Brig. Gen, are legitimate prisoners of war captured on a military mission.

Foreign Ministry officials said today that the draft resolution prepared by several Western European nations was not entirely negative from European nations was not entirely negative from Israel's tiewpoint because it condemns all acts of violence, including those by terrorists against Israel (A United Nations spokesman in New York reported late this afternoon that the members were still "consulting" over a draft resolution. The Council did not resume its session his morning as scheduled. A UN spokesman said it might not reconvene before tonight or tomorrow morning to consider a draft resolution arising from Lebanon's complaint.)

The draft resolution is said to certain a request for the release of the Syrian prisoners. Israei says such a request should be made through the regular channels of the International Red Cros. According to Israeli sources, their release without a prisoner of war exchange would only prejudice the position of Israeli prisoners held by Arab countries.

Is raell positions on the Golan Heights came under shell fire from Syrian territory twice this morning, a military spokesman reported today. He said the first attack occurred in the Houshartyeh region at one am. local time and the second at six am. Israelf forces returned the fire after the first attack only. No casualties or damage was reported. The Lebanese border remained quiet through the night. Lebanese Army units were seen patrolling the region, presumably to prevent terrorist activities.

Deputy Premier Yigal Allon and Minister-Without-Portfolio Israel Gailli warned last night that if Lebanon did not rid itself of terrorists, it could face further retaliatory action from Israel. They spoke at a memorial meeting at Kibbutz Eln Harod.

Gets Pledge From Soviet Official
JUDY SHAPIRO SAYS SHE HAS PERMISSION
TO ATTEND GAVRIEL'S MOSCOW
TRIAL AND TO BRING AN ATTORNEY

NEW YORK, June 26 (JTA)—Judy Silver Shapiro said today that the Soviet official investigating the case of her husband, Gavriel, informed her that she could come to Moscow to attend his trial and bring a lawyer. Mrs. Shapiro made the disclosure at a press conference here. She read the transcript of a telephone conversation she said she had at 3 a.m. today with the official in Moscow, Yury Nikoloy-ovitch Gorbunov. She said Gorbunov would not tell her what the charges against her husband are or when his trial would begin. Mrs. Shapiro said he would probably go on trial this Friday, June 30.

The 23-year-old Cincinnati rocial worker was married to the Russian-Jewish activist in a religious ceremony at his Moscow home June 8 but was forced to leave the Soviet Union four days later when her visa expired, She said today that the State Department promised to help her procure another visa but gave her no assurances that she would get one. Her husband was arrested June 12, the day she left Russia and has been imprisoned since then. Jewish sources reported yesterday that he was being charged with violation of Art. 98 of the Soviet penal code which concerns evasion of millitary duty.

Mra. Shapiro disclosed today that she has sent four telegrams to President Nixon since returning to the US, asking for his personal intervention in the case. She sent a fifth today, "President Nixon has never acknowledged my telegrams," she said. She said she had asked that a member of the US Consular Staff in Moscow be present at her husband's trial but had no responses from the State Department. Mrs. Shapiro also disclosed that teading American attorneys were organizing a committee to look into the legal aspects of the Shapiro case and that she has been in contact with former US Attorney General Ramsay Clark, who will be a member of the committee.

Mrs, Shapiro stated that her husband's only crimes were to be a Jewish activist and to have said publicly that he wanted to see President Nixon when the President visited Moscow on his summit trip last month. "His third crime was to marry me," she said. She said that in addition to telegraphing President Nixon she has been in contact with numerous Senators and Representatives and has sent cables to Soviet Communist Party Secretary General Leonid Brezhnev, Roman Rudenko, the chief Soviet prosecutor, and Anatoly F. Dobrynin, the Soviet Ambassador in Washington.

Rabbi Henry Siegman, executive vice-president of the Synagogue Council of America disclosed today that he had cabled Soviet Premier Koeggin protesting the denial of Shapiro's civil rights as guaranteed by the Soviet Constitution.

According to the transcript of her telephone conversation with Gorbunov Mrs, Shapiro asked "Can his (Shapiro's) parents see him?" The answer was "No, no one can see him." Mrs, Shapiro told the Soviet official, "The whole world will know. There is no more time for Stalinist trials." Gorbunov answered, "Yes, I know. A lawyer can come to Moscow. Pm inviting a lawyer." At that point she asked, "Can I attend the trial?" The answer was "Yes." Mrs. Shapiro asked. "Is Gavriel well?" The reply was, "Gavriel is alive and healthy.

26TH VICTIM OF LYDDA MASSACRE DIES

TEL AVIV, June 26 (JTA) -- The 26th victim of the

Lydda Airport massacre—Tzvi Guttman, 69, of Ramat Gan—died of his injuries Friday night at the ichilov Hospital here. He had suffered severe head injuries. His wife, who was also wound ed by machinegun fire and grenades in the airport terminal, was reported to be improving

The death toll in the May 30 massacre now stands at 28, including the two Japanese gumen slain. (The Jewish National Fund of America announced in New York last weck that a woodland would be planted in Israel in memory of the air travellers gunned down in the massacre. Meyer Pesin, president of the JNF of America said it would be located in the John F. Kennedy Memorial and Peace Forest which the JNF established in 1966.)

Western Aliya Dipping
PINCUS CITES NEGATIVE VIEWS
TOWARD NEWCOMERS; SAYS BETTER
UNDERSTANDING NEEDED BY PUBLIC

JERUSALEM, June 26 (JTA)—Louis A, Pincus, chairman of the Jewish Agency Executive, expressed concern today over the decline in immigration from Western countries. He said the rate of decline—about ten percent—was no more than last year but that the reasons behind the drop were cause for alarm. He attributed it in part to the negative attitude toward immigrants reflected by sections of the Israeli population and press. He said the facts must be brought home to Israelis that the costs of immigrant absorption are borne entirely by diaspora Jewry and that many Israeli individuals and institutions benefit directly from the contributions by the overseas fund-raising arms.

Pincus told newsmen that immigration generally was on the increase this year. He said 28,000 arrived between Jan.—June 1972 compared to 18,000 in the same period last year. He said a total of 60-65,000 for the full year was likely. He did not say what percentage of the total would be represented by emigres from the Soviet Union but indicated that Jewish immigration from the USSR has come up to expectations so far.

Except for South America, immigration from most Western countries showed a decline, he said. The drop from the US is about ten percent and from France six percent. According to Pincus, American immigrants feel neglected and unwanted here because of the large immigration from Russia which occupies everyone's attention. In addition, he said, some Americans come to Israel to escape from a social system they do not like only to find the same system in Israel and are further aggravated because the system is run by Jews.

Pincus said prospective immigrants from France are mainly of North African origin. They have large families and they hear about the lack of suitable housing in Israel and receive reports of discrimination against North Africans and preferential treatment of Western emigres. He noted that 60 percent of all funds raised in the diaspora for Israel go toward bettering the social standards of Oriental Jews. He pointed out that, among other things, the Jewish Agency bears almost the entire operating costs of Israeli institutions of higher learning from which many Israelis as well as immigrants benefit.

The Jerusalem municipality issued yesterday a 30-day closure order against the "Eros" sex boutique, which has been the target of almost daily demonstrations during the two weeks it has been in operation. The official reason for the shutdown was operation without a proper license.

ISRAEL PLANS OLD-AGE PAYMENTS, OTHER BENEFITS TO E, JERUSALEM RESIDENTS STARTING IN JULY

JERUSALEM, June 26 (JTA).—The Israel National Insurance Institute has announced that, starting in July, it will begin paying old-age allowances to Arab and other minority residents in East Jerusalem. Under the national insurance law, insured persons become entitled to such allowances after completing a minimum of five years of consecutive payments to the institute.

Many elderly East Jerusalem residents are now beginning to qualify since they were added to the list of the institute's insured beneficiaries immediately after the 1967 Six-Day War. Institute officials added that most recipients of such allowances will also receive benefits paid in addition to the old-age allowances to all elderly persons who have no sources of income of any kind,

The monthly amounts payable to such aged persons will be 160 pounds and 250 pounds, respectively, for single persons and for couples. Officials said widows and divorcees in East Jerusalem have been receiving institute allowances for some time from the institute, since no qualifying period is required for such payments.

The officials also reported that East Jerusalem residents have been receiving for some time large family allowances and birth grants. Residents who are victims of work accidents and of "hostile actions" receive the maximum benefits provided by the institute for such cases, including rehabilitation services. The officials noted that under the Hashemite regime which controlled Old Jerusalem from the 1948 war to the Six-Day War, there was no comprehensive social insurance program for residents of Old Jerusalem.

NCEJ SAYS MOSCOW OFFICIALS TRYING TO CONTROL ULPANIM

NEW YORK, June 26 (JTA)—The National Conference on Soviet Jewry said here today it had learned about an apparent continuing effort to conrol the number of ulpanim—Hebrew language courses—in Moscow, Officials said Soviet authorities refused to allow Vladimir Prestin and Boris Einbinder to register in the tax department to serve as ulpanim teachers. The NCSJ said the two men, both private Hebrew teachers, met with an official identified as Chairman Pristakvin, who told them they were not qualified, that there was insufficient demand and that it was not necessary that Soviet citizens study Hebrew.

The NCSJ also reported that Benjamin Lavich, a Moscow scientist, who recently applied for an exit visa, was told by the Moscow ovir office last week that he would not get the visa and that appeals against the decision would be useless. He was warned he might face trial under Art, 190 of the Soviet Criminal Code for publicizing his case abroad,

S. AFRICAN RABBIS GIVE GUARDED BACKING TO STUDENT DEMONSTRATORS

JOHANNESBURG, June 26 (JTA).—Two South African rabbis have made guarded expressions of sympathy for university students—Jews among them.—who recently clashed with police on campuses here and in Cape Town. Chief Rabbi Bernard. Casper of Johannesburg said he hoped the Jewish students involved might show an equal interest in and understanding of Judalsm and the fortunes of the Jewish people. Failure to 60 so indicated a confusion of priorities, he said.

But he also observed that much wisdom and patience was needed in dealing with the student outbursts which, for all their inconvenience and harassment, stem basically from idealistic motivations. Rabbi A, H. Lapin, Chief Minister of the Cape Town Hebrew Congregation observed in a statement to the press that peaceful protest was part of the citizen's right to disagree. He said those who protested were obliged to remain within the law but at the same time were entitled to protection from violence. "The exercise of restraint by authority is as necessary for its successful function as obedience to it," Rabbi Lapin declared.

POLES SEIZE TREPPER FILES FROM LEOPOLD'S LAWYER IN WARSAW

PARIS, June 26 (JTA)—Leopold Trepper's lawyer reported today that Polish authorities confiscated his files relating to the Trepper case at Warsaw Airport this morning in gross violation of the "privileged communications" between lawyer and client, Daniel Souliez—Lariviere, the French attorney engaged by the World War II master spy to handle his libel suit against the head of French counter-intelligence, returned from Warsaw this afternoon after three days of consultation with Trepper. He told the Jewish Telegraphic Agency that Trepper was "a very sick man who rarely, if ever, leaves his home."

He said he was seriously concerned because he could not reach Trepper by phone since his return to Paris and expressed fear that he might have been arrested. Lariviere said that Trepper saw him off at Warsaw Airport this morning. While waiting for his plane to depart, the lawyer said, Polish officials detained him for three hours, forced him to strip and confiscated all files and focuments in his possession. He said he had warned the officials that their action could provoke a diplomatic and furificial incident,

Trepper, who headed the Soviet spy network in Nazi occupied Western Europe during World War II, has filed suit against Jean Rochet of the French counter-espicnage agency for alleging, in an article in Le Monde on April 14, that Trepper collaborated with the Gestapo during the war and had worked against France on behalf of the Soviet Union before its outbreak. Trepper's suit will be given a preliminary hearing in a Paris criminal court on July 18 but the case is not expected to be tried until after the summer recess next Oct.

Trepper and his wife Elisabeth have been trying without success to obtain exit visas to leave Poland to join a son in Israel, Mrs. Trepper left Poland two months ago on a temporary visa. Polish authorities claim Trepper "knows too much" to be permitted to leave.

WEST BANK TOWN LINK PLANNED TO ISRAEL'S NATIONAL GRID

TEL AVIV, June 26 (JTA)--Defense Minister

Moshe Dayan approved today a request by the newly elected Township Council of Qalqilya that the West Bank town be connected to the National Electric Network of Israel. Qalqilya faces Kfar Saba on the other side of the pre-1967 demarcation line between Israel and the West Bank.

The introduction of electricity to Galqilya may been a major impetus to its industrial development, especially in the smalloraft industry and in the industrialization of its citrus packing houses, which has hitherto been operated on a manual basis.

EXPERT SEES HOPE FOR U.S. JEWISH FUTURE IN YOUTH EXPERIMENTATION

NASHVILLE, Tenn., June 26 (JTA) -- The identity crisis has erupted with special severity in the American Jewish community because of its acculturation on one hand and its attempts to maintain its distinctiveness on the other, according to Dr. Mervin F. Verbit, assistant professor of sociology at Brooklyn College. Dr. Verbit spoke on the American Jewish community during the Graduate Summer Institute of Judaism just concluded at the Vanderbilt University Divinity School here.

He explained that Jews saw their Jewishness in terms of the white, Anglo-Saxon Protestant and secular culture around them. They adapted to this culture, but they have maintained their own community and were not totally assimilated, he said. Prof. Verbit observed that "the primary distinctiveness of the Jewish community is that its existence as a community is part of its ideological definition. The Jewish people is not a collection of people who share the same faith so much as it is the instrumentality for the fulfillment of Judaism's purpose, at least according to Jewish tradition," he said.

According to Dr. Verbit. "The role of theology in Judaism is different from its role in Christianity. Logically, theism is prior for Jews, but more important is the basic commitment to a particular collective goal in history." Prof. Verbit said that most young Jews respond to religion in patterns similar to other religious groups by participating partially but not with real intensity or regularity. He noted, however, that some young Jews are expen imenting with forms of communal life, frequently combining study with social action and religious sensitivity and several are moving into positions of leadership in Jewish organizations. He said he thought that young professionals are becoming increasingly aware of their Jewishness and are exploring its meaning.

Include Some Reform Rabbis 'CITY KIBBUTZ' PLANNED IN ISRAEL BY U.S. YOUTH

NEW YORK, June 26 (JTA) -- Most of the American Jewish young people who have been reported planning to create an "irvutz," a city kibbutz in the Jerusalem corridor are affiliated with the Hebrew Union College in Cincinnati, the Reform seminary and many are Reform rabbis, Jewish Agency aliya officials said here today.

Members of the group, which calls itself "Halom," hope to pursue their vocations while living as a group, the Agency's aliya desk here reported. The officials added that the 30 members of the group have "a strong bias toward Reform Judaism" and will try to create a "progressive Jewish community" in the development town of Bet Shemesh, site of the proposed city kibbutz.

The officials said that the American Jews are seeking employment in Bet Shemesh as teachers. social workers and developers of the arts. Once the group has settled in Israel and achieved economic stability, members hope to initiate a variety of community projects. So far, according to the officials, nine of the young American Jews nave made a commitment to settle in Israel by the summer of 1975

SLOGAN ON T SHIRTS RULED NO REASON TO BAR YOUTH FROM MUSEUM EXHIBITIN CHICAGO

CHICAGO, June 26 (JTA) -- The American Jew ish Congress and the American Civil Liberties Union today hailed as a victory for free speech a denic cision by the Federal District Court allowing young people to enter the Field Museum here wearing T shirts bearing the words "Save Soviet Jews. Federal Judge Hubert L. Will issued an order restraining the Field Museum of Natural History from denying admission to the plaintiffs to any public part of the museum, specifically including the exhibit titled "Soviet Union: Arts and Crafts in Ancient Times and Today,"

Earlier two different groups of synagogue youths were turned away on the claim that their T shirts "constituted a form of political protest and the exhibit was non-political." In issuing the order, the court upheld the constitutional right of the individuals to wear articles of clothing publicizing messages with which the museum and exhibiters may disagree. Officials said a permanent injunction may be sought.

Assisted By Hias TEN JEWISH EMIGRE FAMILIES ARRIVE IN U.S.

NEW YORK, June 26 (JTA) -- United Hias Service reported today that gale winds and heavy rains failed to dampen the spirits of relatives waiting at Kennedy Airport Thursday night for a TWA jetliner overdue by several hours because of the storm whose passengers included 28 Jewish immigrants, comprising 10 families. Another Soviet Jewish family arrived Friday, Hias officials reported.

The newcomers, all assisted by Hias, the worldwide Jewish migration agency, came from five different countries of origin: Russia, Rumania, Poland, Hungary and Libya. Seven of the families are to be resettled in New York, some with the help of the New York Association for New Americans. The others were flown to Cleveland, Cincinnati and Atlanta, where they will be helped in resettlement by local Jewish communal agencies, Hias officials said. Some of the Soviet arrivals entered the United States under the parole authority of the US Attorney General, the migration agency said.

ZIONISTS URGED TO PONDER SOCIAL PROBLEMS IN ISRAEL

HIGHLAND MILLS, N.Y., June 26 (JTA) -- Dr. Judah J. Shapiro, president of the Labor Zionist Alliance, warned fellow Zionists yesterday not to overlook problems relating to social conditions inside Israel and the relationship between Israel and diaspora Jewry. "There cannot be a double truth, saying what is appropriate at a particular time and withholding what is strategically regarded as (best) left unsaid," Dr. Shapiro declared at a meeting here of the LZA's National Executive Committee.

"The long, old-time allegiance of Zionists to the creation of the State of Israel may not be the same that is necessary to deal with an existing Jewish State," Dr. Shapiro said. He warned against the tendency to regard danger to Israel "as threats only from outside the Jewish community." The Zionist movement, he continued, "Must adapt itself to recognize jeopardy from within. The success of Zionism must not be permitted to cause its decay, brought about by a failure to be completely informed and to relate to the existing situation," he said. Dr. Shapiro contended that the relationship between diaspora Jewry and Israel depends on a sympathetic sharing of all problems within Israel and within the Jewish community in America.

The Jewish Agency in Jerusalem has announced that Ohio, Michigan and Ontario will soon have a new Jawish Agency aliya office in Detroit, directed by Gershon Biram, an attorney. The aliya office in Chicago has been overwhelmed by service requests, Agency officials reported.

One specialist on the Middle East indicated he felt the omission was in effect urging the US to go beyond the 242 Resolution's provisions to safeguard Israel's security.

Commitment Needed To Deter USSR

The subcommittee also recommended that the US maintain "a political commitment and a military force" in the Middle East "amply sufficient to deter the Soviet Union from using military force in the area." In the fifth and final point, the subcommittee said the US should "recognize the responsibility of the world community for a just solu-

tion of the problems of the Arab refugees." Kenneth Gibson, Mayor of Newark and subcommittee chairman, represents, with other Black members, a fifth of the subcommittee's membership. They were understood to have approved without dissent the language of the recommendations on Soviet Jewry and Israel. The other Blacks include the Rev. Walter Fauntroy, D.C. representative, and Mrs. Massey Eberhardt, also from New Jersey. The Rev. Fauntroy is a member of the Congressional Black Caucus which issued a strong pro-Israel statement after the Black National Political Convention adopted last March in Gary, Ind., a resolution which in effect called for dismantling of Israel. Rep. Bella Ab zug (D.N.Y.), a member of the subcommittee told the Jewish Telegraphic Agency that the Israel and Soviet Jewry recommendations were "overwhelmingly" voted by the subcommittee. She said that perhaps "one or two" members were opposed but she did not name them.

BRAEL SEEKS CHANGE IN A DRAFT
TERMING SYRIAN SEIZURE 'ABDUCTION'

JERUSALEM, June 26 (J7A).—The Israeli delegation to the United Nations is making efforts to eliminate a paragraph in a draft resolution for the Security Council which terms the capture of five high ranking Syrian officers by an Israeli patrol in Lebanon last Wednesday an "abduction," it was learned here today. Israel insists that the five who range in rank from Lt. Col. to Brig. Gen, are legitimate prisoners of war captured on a military mission.

Foreign Ministry officials said today that the draft resolution prepared by several Western European nations was not entirely negative from European nations was not entirely negative from Israel's tiewpoint because it condemns all acts of violence, including those by terrorists against Israel (A United Nations spokesman in New York reported late this afternoon that the members were still "consulting" over a draft resolution. The Council did not resume its session his morning as scheduled. A UN spokesman said it might not reconvene before tonight or tomorrow morning to consider a draft resolution arising from Lebanon's complaint.)

The draft resolution is said to certain a request for the release of the Syrian prisoners. Israei says such a request should be made through the regular channels of the International Red Cros. According to Israeli sources, their release without a prisoner of war exchange would only prejudice the position of Israeli prisoners held by Arab countries.

Is raell positions on the Golan Heights came under shell fire from Syrian territory twice this morning, a military spokesman reported today. He said the first attack occurred in the Houshartyeh region at one am. local time and the second at six am. Israelf forces returned the fire after the first attack only. No casualties or damage was reported. The Lebanese border remained quiet through the night. Lebanese Army units were seen patrolling the region, presumably to prevent terrorist activities.

Deputy Premier Yigal Allon and Minister-Without-Portfolio Israel Gailli warned last night that if Lebanon did not rid itself of terrorists, it could face further retaliatory action from Israel. They spoke at a memorial meeting at Kibbutz Eln Harod.

Gets Pledge From Soviet Official
JUDY SHAPIRO SAYS SHE HAS PERMISSION
TO ATTEND GAVRIEL'S MOSCOW
TRIAL AND TO BRING AN ATTORNEY

NEW YORK, June 26 (JTA)—Judy Silver Shapiro said today that the Soviet official investigating the case of her husband, Gavriel, informed her that she could come to Moscow to attend his trial and bring a lawyer. Mrs. Shapiro made the disclosure at a press conference here. She read the transcript of a telephone conversation she said she had at 3 a.m. today with the official in Moscow, Yury Nikoloy-ovitch Gorbunov. She said Gorbunov would not tell her what the charges against her husband are or when his trial would begin. Mrs. Shapiro said he would probably go on trial this Friday, June 30.

The 23-year-old Cincinnati rocial worker was married to the Russian-Jewish activist in a religious ceremony at his Moscow home June 8 but was forced to leave the Soviet Union four days later when her visa expired, She said today that the State Department promised to help her procure another visa but gave her no assurances that she would get one. Her husband was arrested June 12, the day she left Russia and has been imprisoned since then. Jewish sources reported yesterday that he was being charged with violation of Art. 98 of the Soviet penal code which concerns evasion of millitary duty.

Mra. Shapiro disclosed today that she has sent four telegrams to President Nixon since returning to the US, asking for his personal intervention in the case. She sent a fifth today, "President Nixon has never acknowledged my telegrams," she said. She said she had asked that a member of the US Consular Staff in Moscow be present at her husband's trial but had no responses from the State Department. Mrs. Shapiro also disclosed that teading American attorneys were organizing a committee to look into the legal aspects of the Shapiro case and that she has been in contact with former US Attorney General Ramsay Clark, who will be a member of the committee.

Mrs, Shapiro stated that her husband's only crimes were to be a Jewish activist and to have said publicly that he wanted to see President Nixon when the President visited Moscow on his summit trip last month. "His third crime was to marry me," she said. She said that in addition to telegraphing President Nixon she has been in contact with numerous Senators and Representatives and has sent cables to Soviet Communist Party Secretary General Leonid Brezhnev, Roman Rudenko, the chief Soviet prosecutor, and Anatoly F. Dobrynin, the Soviet Ambassador in Washington.

Rabbi Henry Siegman, executive vice-president of the Synagogue Council of America disclosed today that he had cabled Soviet Premier Koeggin protesting the denial of Shapiro's civil rights as guaranteed by the Soviet Constitution.

According to the transcript of her telephone conversation with Gorbunov Mrs, Shapiro asked "Can his (Shapiro's) parents see him?" The answer was "No, no one can see him." Mrs, Shapiro told the Soviet official, "The whole world will know. There is no more time for Stalinist trials." Gorbunov answered, "Yes, I know. A lawyer can come to Moscow. Pm inviting a lawyer." At that point she asked, "Can I attend the trial?" The answer was "Yes." Mrs. Shapiro asked. "Is Gavriel well?" The reply was, "Gavriel is alive and healthy.

26TH VICTIM OF LYDDA MASSACRE DIES

TEL AVIV, June 26 (JTA) -- The 26th victim of the

Lydda Airport massacre—Tzvi Guttman, 69, of Ramat Gan—died of his injuries Friday night at the ichilov Hospital here. He had suffered severe head injuries. His wife, who was also wound ed by machinegun fire and grenades in the airport terminal, was reported to be improving

The death toll in the May 30 massacre now stands at 28, including the two Japanese gumen slain. (The Jewish National Fund of America announced in New York last weck that a woodland would be planted in Israel in memory of the air travellers gunned down in the massacre. Meyer Pesin, president of the JNF of America said it would be located in the John F. Kennedy Memorial and Peace Forest which the JNF established in 1966.)

Western Aliya Dipping
PINCUS CITES NEGATIVE VIEWS
TOWARD NEWCOMERS; SAYS BETTER
UNDERSTANDING NEEDED BY PUBLIC

JERUSALEM, June 26 (JTA)—Louis A, Pincus, chairman of the Jewish Agency Executive, expressed concern today over the decline in immigration from Western countries. He said the rate of decline—about ten percent—was no more than last year but that the reasons behind the drop were cause for alarm. He attributed it in part to the negative attitude toward immigrants reflected by sections of the Israeli population and press. He said the facts must be brought home to Israelis that the costs of immigrant absorption are borne entirely by diaspora Jewry and that many Israeli individuals and institutions benefit directly from the contributions by the overseas fund-raising arms.

Pincus told newsmen that immigration generally was on the increase this year. He said 28,000 arrived between Jan.—June 1972 compared to 18,000 in the same period last year. He said a total of 60-65,000 for the full year was likely. He did not say what percentage of the total would be represented by emigres from the Soviet Union but indicated that Jewish immigration from the USSR has come up to expectations so far.

Except for South America, immigration from most Western countries showed a decline, he said. The drop from the US is about ten percent and from France six percent. According to Pincus, American immigrants feel neglected and unwanted here because of the large immigration from Russia which occupies everyone's attention. In addition, he said, some Americans come to Israel to escape from a social system they do not like only to find the same system in Israel and are further aggravated because the system is run by Jews.

Pincus said prospective immigrants from France are mainly of North African origin. They have large families and they hear about the lack of suitable housing in Israel and receive reports of discrimination against North Africans and preferential treatment of Western emigres. He noted that 60 percent of all funds raised in the diaspora for Israel go toward bettering the social standards of Oriental Jews. He pointed out that, among other things, the Jewish Agency bears almost the entire operating costs of Israeli institutions of higher learning from which many Israelis as well as immigrants benefit.

The Jerusalem municipality issued yesterday a 30-day closure order against the "Eros" sex boutique, which has been the target of almost daily demonstrations during the two weeks it has been in operation. The official reason for the shutdown was operation without a proper license.

ISRAEL PLANS OLD-AGE PAYMENTS, OTHER BENEFITS TO E, JERUSALEM RESIDENTS STARTING IN JULY

JERUSALEM, June 26 (JTA).—The Israel National Insurance Institute has announced that, starting in July, it will begin paying old-age allowances to Arab and other minority residents in East Jerusalem. Under the national insurance law, insured persons become entitled to such allowances after completing a minimum of five years of consecutive payments to the institute.

Many elderly East Jerusalem residents are now beginning to qualify since they were added to the list of the institute's insured beneficiaries immediately after the 1967 Six-Day War. Institute officials added that most recipients of such allowances will also receive benefits paid in addition to the old-age allowances to all elderly persons who have no sources of income of any kind,

The monthly amounts payable to such aged persons will be 160 pounds and 250 pounds, respectively, for single persons and for couples. Officials said widows and divorcees in East Jerusalem have been receiving institute allowances for some time from the institute, since no qualifying period is required for such payments.

The officials also reported that East Jerusalem residents have been receiving for some time large family allowances and birth grants. Residents who are victims of work accidents and of "hostile actions" receive the maximum benefits provided by the institute for such cases, including rehabilitation services. The officials noted that under the Hashemite regime which controlled Old Jerusalem from the 1948 war to the Six-Day War, there was no comprehensive social insurance program for residents of Old Jerusalem.

NCEJ SAYS MOSCOW OFFICIALS TRYING TO CONTROL ULPANIM

NEW YORK, June 26 (JTA)—The National Conference on Soviet Jewry said here today it had learned about an apparent continuing effort to conrol the number of ulpanim—Hebrew language courses—in Moscow, Officials said Soviet authorities refused to allow Vladimir Prestin and Boris Einbinder to register in the tax department to serve as ulpanim teachers. The NCSJ said the two men, both private Hebrew teachers, met with an official identified as Chairman Pristakvin, who told them they were not qualified, that there was insufficient demand and that it was not necessary that Soviet citizens study Hebrew.

The NCSJ also reported that Benjamin Lavich, a Moscow scientist, who recently applied for an exit visa, was told by the Moscow ovir office last week that he would not get the visa and that appeals against the decision would be useless. He was warned he might face trial under Art, 190 of the Soviet Criminal Code for publicizing his case abroad,

S. AFRICAN RABBIS GIVE GUARDED BACKING TO STUDENT DEMONSTRATORS

JOHANNESBURG, June 26 (JTA).—Two South African rabbis have made guarded expressions of sympathy for university students—Jews among them.—who recently clashed with police on campuses here and in Cape Town. Chief Rabbi Bernard. Casper of Johannesburg said he hoped the Jewish students involved might show an equal interest in and understanding of Judalsm and the fortunes of the Jewish people. Failure to 60 so indicated a confusion of priorities, he said.

But he also observed that much wisdom and patience was needed in dealing with the student outbursts which, for all their inconvenience and harassment, stem basically from idealistic motivations. Rabbi A, H. Lapin, Chief Minister of the Cape Town Hebrew Congregation observed in a statement to the press that peaceful protest was part of the citizen's right to disagree. He said those who protested were obliged to remain within the law but at the same time were entitled to protection from violence. "The exercise of restraint by authority is as necessary for its successful function as obedience to it," Rabbi Lapin declared.

POLES SEIZE TREPPER FILES FROM LEOPOLD'S LAWYER IN WARSAW

PARIS, June 26 (JTA)—Leopold Trepper's lawyer reported today that Polish authorities confiscated his files relating to the Trepper case at Warsaw Airport this morning in gross violation of the "privileged communications" between lawyer and client, Daniel Souliez—Lariviere, the French attorney engaged by the World War II master spy to handle his libel suit against the head of French counter-intelligence, returned from Warsaw this afternoon after three days of consultation with Trepper. He told the Jewish Telegraphic Agency that Trepper was "a very sick man who rarely, if ever, leaves his home."

He said he was seriously concerned because he could not reach Trepper by phone since his return to Paris and expressed fear that he might have been arrested. Lariviere said that Trepper saw him off at Warsaw Airport this morning. While waiting for his plane to depart, the lawyer said, Polish officials detained him for three hours, forced him to strip and confiscated all files and focuments in his possession. He said he had warned the officials that their action could provoke a diplomatic and furificial incident,

Trepper, who headed the Soviet spy network in Nazi occupied Western Europe during World War II, has filed suit against Jean Rochet of the French counter-espicnage agency for alleging, in an article in Le Monde on April 14, that Trepper collaborated with the Gestapo during the war and had worked against France on behalf of the Soviet Union before its outbreak. Trepper's suit will be given a preliminary hearing in a Paris criminal court on July 18 but the case is not expected to be tried until after the summer recess next Oct.

Trepper and his wife Elisabeth have been trying without success to obtain exit visas to leave Poland to join a son in Israel, Mrs. Trepper left Poland two months ago on a temporary visa. Polish authorities claim Trepper "knows too much" to be permitted to leave.

WEST BANK TOWN LINK PLANNED TO ISRAEL'S NATIONAL GRID

TEL AVIV, June 26 (JTA)--Defense Minister

Moshe Dayan approved today a request by the newly elected Township Council of Qalqilya that the West Bank town be connected to the National Electric Network of Israel. Qalqilya faces Kfar Saba on the other side of the pre-1967 demarcation line between Israel and the West Bank.

The introduction of electricity to Galqilya may been a major impetus to its industrial development, especially in the smalloraft industry and in the industrialization of its citrus packing houses, which has hitherto been operated on a manual basis.

Only 35,000 registered Jews live in Italy according to a survey prepared and just published in Rome by the Council of Italian Jewish communities. About half live in Rome.

EXPERT SEES HOPE FOR U.S. JEWISH FUTURE IN YOUTH EXPERIMENTATION

NASHVILLE, Tenn., June 26 (JTA) -- The identity crisis has erupted with special severity in the American Jewish community because of its acculturation on one hand and its attempts to maintain its distinctiveness on the other, according to Dr. Mervin F. Verbit, assistant professor of sociology at Brooklyn College. Dr. Verbit spoke on the American Jewish community during the Graduate Summer Institute of Judaism just concluded at the Vanderbilt University Divinity School here.

He explained that Jews saw their Jewishness in terms of the white, Anglo-Saxon Protestant and secular culture around them. They adapted to this culture, but they have maintained their own community and were not totally assimilated, he said. Prof. Verbit observed that "the primary distinctiveness of the Jewish community is that its existence as a community is part of its ideological definition. The Jewish people is not a collection of people who share the same faith so much as it is the instrumentality for the fulfillment of Judaism's purpose, at least according to Jewish tradition," he said.

According to Dr. Verbit. "The role of theology in Judaism is different from its role in Christianity. Logically, theism is prior for Jews, but more important is the basic commitment to a particular collective goal in history." Prof. Verbit said that most young Jews respond to religion in patterns similar to other religious groups by participating partially but not with real intensity or regularity. He noted, however, that some young Jews are expen imenting with forms of communal life, frequently combining study with social action and religious sensitivity and several are moving into positions of leadership in Jewish organizations. He said he thought that young professionals are becoming increasingly aware of their Jewishness and are exploring its meaning.

Include Some Reform Rabbis 'CITY KIBBUTZ' PLANNED IN ISRAEL BY U.S. YOUTH

NEW YORK, June 26 (JTA) -- Most of the American Jewish young people who have been reported planning to create an "irvutz," a city kibbutz in the Jerusalem corridor are affiliated with the Hebrew Union College in Cincinnati, the Reform seminary and many are Reform rabbis, Jewish Agency aliya officials said here today.

Members of the group, which calls itself "Halom," hope to pursue their vocations while living as a group, the Agency's aliya desk here reported. The officials added that the 30 members of the group have "a strong bias toward Reform Judaism" and will try to create a "progressive Jewish community" in the development town of Bet Shemesh, site of the proposed city kibbutz.

The officials said that the American Jews are seeking employment in Bet Shemesh as teachers. social workers and developers of the arts. Once the group has settled in Israel and achieved economic stability, members hope to initiate a variety of community projects. So far, according to the officials, nine of the young American Jews nave made a commitment to settle in Israel by the summer of 1975

Save Soviet Jews'

SLOGAN ON T SHIRTS RULED NO REASON TO BAR YOUTH FROM MUSEUM EXHIBITIN CHICAGO

CHICAGO, June 26 (JTA) -- The American Jew ish Congress and the American Civil Liberties Union today hailed as a victory for free speech a denic cision by the Federal District Court allowing young people to enter the Field Museum here wearing T shirts bearing the words "Save Soviet Jews. Federal Judge Hubert L. Will issued an order restraining the Field Museum of Natural History from denying admission to the plaintiffs to any public part of the museum, specifically including the exhibit titled "Soviet Union: Arts and Crafts in Ancient Times and Today,"

Earlier two different groups of synagogue youths were turned away on the claim that their T shirts "constituted a form of political protest and the exhibit was non-political." In issuing the order, the court upheld the constitutional right of the individuals to wear articles of clothing publicizing messages with which the museum and exhibiters may disagree. Officials said a permanent injunction may be sought.

Assisted By Hias TEN JEWISH EMIGRE FAMILIES ARRIVE IN U.S.

NEW YORK, June 26 (JTA) -- United Hias Service reported today that gale winds and heavy rains failed to dampen the spirits of relatives waiting at Kennedy Airport Thursday night for a TWA jetliner overdue by several hours because of the storm whose passengers included 28 Jewish immigrants, comprising 10 families. Another Soviet Jewish family arrived Friday, Hias officials reported.

The newcomers, all assisted by Hias, the worldwide Jewish migration agency, came from five different countries of origin: Russia, Rumania, Poland, Hungary and Libya. Seven of the families are to be resettled in New York, some with the help of the New York Association for New Americans. The others were flown to Cleveland, Cincinnati and Atlanta, where they will be helped in resettlement by local Jewish communal agencies, Hias officials said. Some of the Soviet arrivals entered the United States under the parole authority of the US Attorney General, the migration agency said.

ZIONISTS URGED TO PONDER SOCIAL PROBLEMS IN ISRAEL

HIGHLAND MILLS, N.Y., June 26 (JTA) -- Dr. Judah J. Shapiro, president of the Labor Zionist Alliance, warned fellow Zionists yesterday not to overlook problems relating to social conditions inside Israel and the relationship between Israel and diaspora Jewry. "There cannot be a double truth, saying what is appropriate at a particular time and withholding what is strategically regarded as (best) left unsaid," Dr. Shapiro declared at a meeting here of the LZA's National Executive Committee.

"The long, old-time allegiance of Zionists to the creation of the State of Israel may not be the same that is necessary to deal with an existing Jewish State," Dr. Shapiro said. He warned against the tendency to regard danger to Israel "as threats only from outside the Jewish community." The Zionist movement, he continued, "Must adapt itself to recognize jeopardy from within. The success of Zionism must not be permitted to cause its decay, brought about by a failure to be completely informed and to relate to the existing situation," he said. Dr. Shapiro contended that the relationship between diaspora Jewry and Israel depends on a sympathetic sharing of all problems within Israel and within the Jewish community in America.

The Jewish Agency in Jerusalem has announced that Ohio, Michigan and Ontario will soon have a new Jawish Agency aliya office in Detroit, directed by Gershon Biram, an attorney. The aliya office in Chicago has been overwhelmed by service requests, Agency officials reported.
