Peace Prospects: Differing Views
ALLON FEELS CEASE-FIRE STABLE;
YOST PESSIMISTIC: DUTCH NEWSMAN
SAYS EGYPT UNREADY FOR NEW WAR

TEL AVIV, June 29 (JTA)—Acting Premier Yigal Allon, noting that the second anniversary of the August, 1970 Mideast cease-fire would occur in about six weeks, said yesterday Israel was doing everything in its power to extend the cease-fire both to keep the guns silent and in the hope that it might serve as a transition to a Middle. Bast settlement, He spoke at a Technion degree-awarding ceremony.

Remarking that there were individuals "both in Israel and abroad" who are "already guessing" when the cease-fire would come to an end, Allon said he was advising them "not to prophesy." He said that "though we know that fire may be resumed as long as there is no political progress," there was "nevertheless no reason why political progress should not be possible." He said that if warfare is resumed, "it will not solve any problems and when it ends, re will be in the same situation as we are now." He urged the Arab leaders "to give peace a chance before the guns are allowed to speak again."

(Charles W. Yost, the former US ambassador to the United Nations told newmen in Jorusalem last night, after a meeting with Foreign Minister Abba Eban, that he found it difficult to be optimistic about the possibilities for a settlement in the Middle East in the near future, but that he also doubted a resumption of full-scale warfare. Prior to his visit to Israel, he visited Egypt and met with Egyptian leaders in Catro.

#### 'We Tried Hard To Be Helpful'

Discussing his role as US ambassador, he told the newsmen that "we tried very hard to be helpful over a period of two or three years and we were not very successful." He said he doubted the US would try again "in the immediate future unless we were asked to do so." Yost has been touring some of the occupied Arab territories, talking with Arab leaders and officers of the military government. He represented the US at the UN during the Six-Day War in 1967,)

(Joseph J. Sisco, the US Assistant Secretary of State for Near Eastern Affairs, disclosed in an interview published in London today that discussion of the Middle East at the Moscow summit meeting last month was "thorough and detailed," He noted, however, that "because the Middle East conflict can only be resolved by agreement between the parties involved, it would have been unrealistic to expect that the summit could have effected dramatic changes in the situation," Sisco's interview appears in the July, 1972 issue of "The New Middle East." The American diplomat conceded that "The Soviets have a substantial and direct interest in the Middle East." He disclosed, however, that in President Nixon's talks in Peking early, this year, "The Middle East was marginal.")

(A Dutch journalist who spent three weeks in the Middle East as guest of the Arab League, reported today that Egypt is not prepared for another war and that most Egyptians have lost faith in President Anwar Sadat. #### MRS, MEIR SEES NO HOPE FOR M.E. IN EUROPEAN SECURITY CONCLAVE

AMSTERDAM, June 29 (JTA).—Premiter Golda Meir of Israel, attending a meeting of the Socialist International in Vienna this week, said on a Dutch television interview last night that the projected European Security Conference "cannot bring about a solution to the Middle East conflict."

Mrs. Meir insisted that the Middle Eastern countries must work out their problems by themselves. She observed that many of the countries that would attend such a conference, ardently sought by the Soviet Union, have no contact with israel and some even supply arms to Egypt. Replying to a question, Mrs. Meir demied emphatically that she had any contacts with Soviet diplomate during or after her visit to Finland last year.

#### 25,000 NYC SYRIAN JEWS PRAY FOR THOSE IN SYRIA; TEKOAH GIVES ISRAEL AID PLEDGE IN UN

NEW YORK, June 29 (JTA)—The 25,000Jews of the Syrian community in New York City marked the fast day of Shiv'ah Asar b'Tammuz today with special prayers on behalf of the estimated 400Jews of Syria who are barred from leaving Syria, it was reported by the Committee for the Rescue of Syrian Jewry.

A proclamation issued by the Rabbinical Council of the Syrian-Sephardic Community of America urged international action to free the Syrian Jews to emigrate and rejoin their families in various parts of the world. The proclamation was issued by Rabbis Abraham Raful, Joseph Hariri and Haim Benoliel. (The 17th day of Tammuz commemorates the breaching of the Jerusalem wall by the Babylonian invaders in 586 B.C.)

Senators George McGovern (D.S.D.) and Hubert Humphrey (D. Minn.) both issued appeals on behalf of Syrit's remnant Jewish community. Sen. McGovern, in a statement issued to mark the special fast day, reiterated an earlier plea to the Syrian government to permit the emigration of that country's Jewish resident.

Sen. Humphrey called upon President Nixon to have the issue of Syrian Jewry brought before the United Nations. Sen. Humphrey, who is honorary chairman of the committee, reportedly asked Nixon "to pursue actively the other diplomatic channels at his disposal to help procure the right for Syrian and Soviet Jews to emigrate,"

(Ambassador Yosef Tekoah, Israel's representative to the United Nations, informed the Security Council yesterday hat his country will continue to "pursue its efforts to free the Jews of Syria from oppression," Ambassador Tekoah made that statement in a letter to Lazar Mojsov, of Yugoslavia, this month's President of the Security Council.

The letter was in response to one sent to the Security Council by the Syrian Ambassador June 13 complaining about mounting international indignation at Syria's treatment of its Jewish min-

Hadassah, McGovern Ask Activist Be Freed JUDY AND GAVRIEL SHAPIRO MARRIED BY PROXY IN WASHINGTON

WASHINGTON, June 29 (JTA)—Judy Silver Shapiro, the 27-year-old Cincinnati social worker, and Gavriel Shapiro, the jailed 27-year-old Moscow activist, were married today by proxy in a civil ceremony by Chief Judge Harold Greene of District of Columbia Civil Court, Judge Greene married the couple after hearing testimony on the religious ceremony they underwent in Moscow June 8, Mrs. Shapiro's visa expired and she was unable to remain, in Russia for a civil ceremony.

"This doesn't seem to be very civilized to me," Judge Greene said of the Russian authorities' refusal to extend the bride's visa. "On the basis of legal principles," he continued, "I am convinced this court has the authority to perform a proxy marriage. On the basis of the testimony, a proxy marriage is appropriate under these circumstances." The testimony heard by him included the report that Shapiro has been harred from seeing family, friends or legal counsel since his arrest June 12 on charges

of draft evasion,

Mrs. Shapiro, asked by Judge Greene if she accepted the activist as her husband, replied, "I do." Rabbi Harry Kranz of Silver Spring, Md., who conducted the Moscow service, said the proxy ceremony "will hopefully be accepted by the Soviet authorities as a valid marriage." Rabbi Marc H. Tanenbaum, Interreligious Affairs director of the American Jewish Committee, voiced "appreciation" for the "humanitarian interest and role of President Nixon's administration, the State Department, numerous members of the Senate and House and hundreds of Americans, Christian and Jewish alike, who have taken an active part in the effort to assure justice and the realization of the fundamental human right of Gavriel Shapiro to leave his country, a right established by the United Nations Declaration of Human Rights."

A protest was made by letter today by Sen George McGovern to Soviet Ambassador Anatoly Dobrynin over Shapiro's arrest and imprisonment. The Senator urged that the Soviet government free Shapiro immediately and allow him to emigrate, calling Shapiro's forthcoming trial 'a source of profound concern' to him and to many other Americans. He wrote that Shapiro's release and permission to emigrate would be "universally welcomed as a vital contribution" to improving US-

Soviet relations.

On New York, Mrs. Max Schenk, president of Hedensah, sent telegram appeals to Communist Party Chairman Leonid Brezhney and to President Nixon, for intervention on Shapiro's behalf. She said, in both telegrams, that Shapiro's behalf. She added Shapiro had not previously been scheduled for a military call-up. #### FEINBERG FLATLY DENIES REPORT SABIN OUSTED AS WEIZMANN PRESIDENT

NEW YORK, June 29 (JTA)—Abraham Feinberg, chairman of the Board of Governors of the Weizmann institute of Science denied, in a statement issued here today; a published report in Israel that Dr. Albert B. Sabin, president of the Institute, had been fired as president.

"There is not a sointilla of truth in the published reports," Feinberg said here. "Dr. Sabin enjoys the full confidence and friendship of myself, members of the Board of Governors and the scientific staff of the Welzmann Institute." The chairman added that Dr. Sabin was returning to Rehovot. "to resume his duties as president on July 16," a post Dr. Sabin has held since January, 1870, under a five-year contract "which does not expire until the end of 1974. This year he underwent open heart surgery which has necessitated a protracted period of convalescence."

"Dr. Sabh alone will determine whether the state of his health will permit him to carry out the heavy responsibilities of the presidency over a long period," Feinberg said. "The decision is his and his alone to make. His prestige and dedication have proved an important asset in enhancing the distinguished reputation the Weizmann Institute enjoys in the international scientific community and elsewhere in the world."

#### Tells N.Y. UJA Volunteers HARRIMAN URGES LEND-LEASE ARMS ARRANGEMENTS WITH ISRAEL

NEW YORK, June 29 (JTA)--Elder statesman W, Averell Harriman said today that in the current election year, aid to Israel should be "a national question," and not a "political, partisan"; one. He spoke to 200 key volunteers at the United Jewish Appeal of Greater New York headquarters here participating in a summerlong person-to-person telephone drive to reach 100,000 members of the New York Jewish community.

"The issue of Israel is very much on the minds of those of us who have anything to do with the policies of the Democratic party." Harriman said, adding the hope that "if the Democrats set a good course in the platform adopted" at their July convention, "the Republicans will do the same." He applicated the Nixon administration for making it possible for Israel to buy weapons in the US but asked, "Why not lend-lease" such arms to Israel? He said if Israel was burdened "by a very large debt" because of US weapons sales policies, "it does seem to me we are not fulfitting our obligations."

"He said what the volunteers were doing was "absolutely essential"; because what the US was doing "is only a plus. In no sense do I suggest that it will relieve American Jews of the responsibilities which they have throughout the years so

fully met."

Still Hoping To Leave Poland
TREPPER SEES POLISH-FRENCH
PLOT TO KILL HIS LIBEL SUIT

COPENRAGEN, June 29 (ITA) -- Leopold Trepper charged today that the Pollish and French secret services were working in collusion to prevent him from bringing a libel suit against Jean Rochet, head of the French counter-intelligence service. The World War II master spy, who has not been permitted to leave Poland, made the charge in a telephone interview with the Jewish Telegraphic Agency.

He said that collusion was indicated when Folish police confiscated all the documents relating to the case from Trepper's French lawyer, Daniel Soulzez-Lariviere at Warsaw Airport last Friday. Lariviere spent three days in Warsaw conferring with his client and was handed the documents by Trepper just before his intended departure. But Polish police detained him for three hours and selzed the papers, the attorney reported on his return to Paris.

"I now fear the worst," Trepper told the JTA.

"Those documents could have brought about the
conviction of Jean Rochet for slander. I think there
is some kind of cooperation between the Polish and
French secret services," he said. Trepper, who
headed the Soviet spy network known as the "Red
Orchestra" in Western Europe during World War
II, was accused by Rochet in a Le Monde article
last month of having collaborated with the Gestapo.

Pollsh authorities have refused to permit him to leave the country on grounds that he 'finows too much.' Trepper said that if he does get a visa his first order of business will be to appear at the preliminary hearing of the Rochet case scheduled to be held in Paris, July 13. Afterwards, he said, he would go to London for medical treatment and then probably visit Brussels to address the Association of Former Underground Fighrers which has invited him; Trepper said his wife Ellasbeth is remaining in Copenhagen for the time being to await the outcome of his appearance before the Central Committee.

## Due In Moscow July 17 MOSCOW JEWS ASK WALDHEIM TO ACT FOR THEM DURING VISIT

LONDON, June 29 (JTA) -- United Nations Secretary General Kurt Waldheim has been asked to intervene with Soviet authorities on behalf of the human rights of Russian Jews when he visits Moscow next month. Jewish sources in the Soviet Union reported today that 40 Moscow Jews sent a message to Waldheim requesting an audience to discuss the problem of human rights as they relate to Soviet Jews who want to go to Israel. Earlier, 41 Jews from Minsk, Vilna and Kovno petitioned the Secretary General to investigate the curtailment of Jewish rights in contravention of Soviet law and international conventions to which the Soviet Union is a signatory. Dr. Waldheim is scheduled to arrive in Moscow July 17 on an official visit at the invitation of the Soviet government.

Jewish sources reported today that Mark Nashpitz has appealed from his prison cell in Moscow to Jews all over the world to work for his release. "I am to face a trial for a crime I never committed. I appeal for your help," the message said. Nashpitz was arrested last month for alleged evasion of military duty. He is a friend of Gavriel Shapiro, another Jewish activist arrested June 12, apparently on the same charges.

Nashpitz claimed in his appeal that he has been subjected to constant harassment by Soviet authorities since he applied for a visa to go to Israel six months ago. His parents and the parents of Shapiro have appealed to the international Committee of Jurists to investigate the cases of both men who, they say, are being brought to trial without having committed a crime."

Hits Busing 'Rhetoric'

NJCRAC OK'S 'AFFIRMATIVE ACTION'
BUT OPPOSES 'PREFERENTIAL QUOTAS'

LOS ANGELES, June 29 (#1A)—The annual plenary of the National Jewish Community Relations Advisory Council strongly endorsed today government-administered "affirmative action" guidelines to equalize employment and educational opportunities for racial and ethnic minorities. But it also, following a floor debate of almost four hours, condemned the use of "preferential quotas" in anti-discrimination programs.

The NJCRAC policy declaration also endored the setting of "specific target goals and timetables, not determined by population percentages" as acceptable forms of "affirmative action" so long as the goal and timetables are used "to evaluate good-faith efforts and not as

rigid requirements."

The action reflected, in large measure, an effort by the Jewish groups to balance their traditional advocacy of anti-discrimination policies against what many of the 300 delegates here regard as serious threats of "reverse discrimination" affecting Jews. The NJCRAC declaration supported such government-financed action as compensatory education, training and re-training, apprenticeship job counseling and placement, welfare assistance and other forms of help to the disadvantaged. "The sole criterion of eligibility for such special services must be individual need; the services must not be limited or offered preferentially" on a racial, religious or ethnic basis.

The NJCRAC, which represents nine national Jewish organizations and 92 community relations councils, took no position on the issue of busing per se. But the delegates chiede the anti-busing forces for engaging in "exaggerated political rhetoric" that "tended to distort the facts, inflame passions and impede rational analysis,"

They noted that the "exaggerations" included the claim that busing for desegregation would result in "massive" transportation costs whereas only one percent of the \$200 million spent on busing during the past school year went for desegregation. The delegates indicated that they backed busing "when it is the most effective peaceable way to attain desirable educational ends, including desegregation." But the plenary sympathized with the "reluctance" of some Jew ish parents "to see their children transferred to schools that are substandard" under desegregation plans. "It is not enough," the plenary concluded. "to say that children should not be transferred to bad schools. Children who are in bad schools now should not be left there either."

#### STUDENT ACTIVIST UMBRELLA GROUP SETS PLANS FOR SIX REGIONAL MEETS.

CONCLAVE ON WOMEN'S RIGHTS

NEW YORK, Juine 29 (JTA)—An official of the North American Jewish Students Network, which claims to represent more than 300 student activist groups, said today the unbrella group will sponsor six regional conference this year and was planning also to organize a national conference on the problems of Jewish women.

Martin Salowitz, secretary general of the umbrella agency, said the decisions were made at a meeting of the Network steering committee convened to implement resolutions adopted at the second annual convention of Network June 8-12 at Indian Orchard, Pa,

Salowitz said the regional conclaves were being organized to provide "programmatic and educational assistance" to Jewish students who might otherwise not have access to such help "in developing their Jewish identity and knowledge." He also reported that the Steering Committee was investigating possibilities for influencing Jewish Federations and community councils "to adopt a more positive attitude toward Jewish education and Jewish poverty, among other issues."

The official also reported that Network had hired a field worker who will travel to various campuses to aid Jewish student groups and newspapers and help them maintain contact with each other. He said plans were being made to create a "Jewish Association for Life Studies," which will seek to exchange materials and publish social research relevant to the needs of the Jewish community.

Salowitz discounted the walkout of some "dissidents" from the Indian Orchard convention. They included members of the Jewish Defense League, Betar and other militant factions, who contended that Network did "almost nothing" for Soviet and Arab Jewry, Jewish education, the Jewish poor, Israel and aliya. Salowitz told the Jewish Poor, Israel and aliya. Salowitz told the Jewish Telegraphic Agency that members of the dissident groups had emphasized they were walking out of the convention and not out of the organization.

## Seeks \$500,000 Damages BALTIMORE RABBI FILES SUIT IN NEWARK FEDERAL COURT; SAYS BEATEN BY POLICEMEN

NEWARK, June 29 (JTA)—Rabbi Norbert Liner, 39, chairman of the Rabbincal Alumni of Ner Israel Rabbincal College in Baltimore, filed suit today in federal court in Newark, seeking \$500,000 in damages for alleged violation of his civil rights by six Jersey City policemen.

Rabbi Liner said in his complaint, filed against the six policemen and the city of Jersey City, that he was allegedly arreated while trying to fix his car on a Jersey City street. He charged also that he was taken to a station house where he was searched and where anti-Semitic remarks were allegedly shouted at him. He charged also that his ritual items were taken from him and that this made it impossible to carry out his daily religious exercises while he was in jail. He also charged that he was handouffed and incarcerated without being told of any charges against him.

The complaint also charged that one of the police officers took him from his cell, "grabbed the plaintiff and dragged him to a dark corner of the jail where he continued cursing him and victously struck him on the neck, body, legs and arms," He contended further that "false charges" of obstructing traffic and failure to give "a good account of himself" were later dismissed in municipal court, "

### COLPA FILES SUIT ON JOB BIAS NEW YORK, June 29 (JTA) -- The National Jewish

Commission on Law and Public Affairs. (COLPA) announced today it would represent an Orthodox Jew who charges that he was forced to resign as a Transit Authority bus driver-trainee because he refused to work on Saturdays and on Shavuot. The employe, whose name was not disclosed, has filed a complaint with the New York State Division on Human Rights, which will hold a hearing July 7. The complaint asserts that the employe was "denied equal terms and conditions... because of my religious observance," in violation of state law.

The law permits Sabbath observance by employes except when hardship to the employer would result. The TA has maintained that it is exempt from the law because it is engaged in an essential service for which employes must always be ready to work. Howard Rhine, president of COLPA, said: "This is not the first time that an incident of this nature involving the New York City Transit Authority has occurred and we have determined to make it the last. It is incredible that at a time when private employers are increasingly recognizing their responsibilities and are making the required accommodations to one of the basic needs of their employes, a public agency should continually refuse to comply with the law."

### BOSTON TV STATION AGREES TO AIR JEWISH VIEWS ON TERRORISM AND AIR PIRACY

BOSTON. June 29 (JTA) -- In an attempt to be "responsive to an aggrieved segment of the community that has a right to have a voice." WBZ-TV has agreed to schedule four minutes of interviews on culpability for terrorism, methods of combating air piracy, and the effect of terrorism on Israeli tourism. The television station reached the compromise with the Jewish Community Council of Metropolitan Boston, which had unsuccessfully challenged the station's refusal to air a rebuttal to a one-minute, 48-second commentary by Erwin D. Canham, editor of the Christian Science Monitor. Canham, a regular commentator on the Group W (Westinghouse Broadcasting) service, had warned June 4 against both Arab and Israeli "terror." The JCC had protested that Canham equated the Tel Aviv massacre by Arab-inspired Japanese with Israel's liberation of an Arab-hijacked let.

WBZ-TV program manager Paul D, Coss called the scheduled interviews—with a JCC representative and a member of the Israel Tourist Board—"a meaningful solution to the problem" that "won't violate the journalistic integrity of our newscast." He said the JCC's threat to protest to the Federal Communications Commission would have failed, and "our victory would leave a bad taste in an important community is mouth." (The JCC wanted to charge WBZ-TV with violation of the so-called fairness doctrine, which requires the airing of opposing opinion in "controversial issues of public importance;"). "If don't care to allenate people who are important to us," added Coss.

AMSTERDAM, June 29 (JTA).—Premiter Golda Meir of Israel, attending a meeting of the Socialist International in Vienna this week, said on a Dutch television interview last night that the projected European Security Conference "cannot bring about a solution to the Middle East conflict."

Mrs. Meir insisted that the Middle Eastern countries must work out their problems by themselves. She observed that many of the countries that would attend such a conference, ardently sought by the Soviet Union, have no contact with israel and some even supply arms to Egypt. Replying to a question, Mrs. Meir demied emphatically that she had any contacts with Soviet diplomate during or after her visit to Finland last year.

#### 25,000 NYC SYRIAN JEWS PRAY FOR THOSE IN SYRIA; TEKOAH GIVES ISRAEL AID PLEDGE IN UN

NEW YORK, June 29 (JTA)—The 25,000Jews of the Syrian community in New York City marked the fast day of Shiv'ah Asar b'Tammuz today with special prayers on behalf of the estimated 400Jews of Syria who are barred from leaving Syria, it was reported by the Committee for the Rescue of Syrian Jewry.

A proclamation issued by the Rabbinical Council of the Syrian-Sephardic Community of America urged international action to free the Syrian Jews to emigrate and rejoin their families in various parts of the world. The proclamation was issued by Rabbis Abraham Raful, Joseph Hariri and Haim Benoliel. (The 17th day of Tammuz commemorates the breaching of the Jerusalem wall by the Babylonian invaders in 586 B.C.)

Senators George McGovern (D.S.D.) and Hubert Humphrey (D. Minn.) both issued appeals on behalf of Syrit's remnant Jewish community. Sen. McGovern, in a statement issued to mark the special fast day, reiterated an earlier plea to the Syrian government to permit the emigration of that country's Jewish resident.

Sen. Humphrey called upon President Nixon to have the issue of Syrian Jewry brought before the United Nations. Sen. Humphrey, who is honorary chairman of the committee, reportedly asked Nixon "to pursue actively the other diplomatic channels at his disposal to help procure the right for Syrian and Soviet Jews to emigrate,"

(Ambassador Yosef Tekoah, Israel's representative to the United Nations, informed the Security Council yesterday hat his country will continue to "pursue its efforts to free the Jews of Syria from oppression," Ambassador Tekoah made that statement in a letter to Lazar Mojsov, of Yugoslavia, this month's President of the Security Council.

The letter was in response to one sent to the Security Council by the Syrian Ambassador June 13 complaining about mounting international indignation at Syria's treatment of its Jewish min-

Hadassah, McGovern Ask Activist Be Freed JUDY AND GAVRIEL SHAPIRO MARRIED BY PROXY IN WASHINGTON

WASHINGTON, June 29 (JTA)—Judy Silver Shapiro, the 27-year-old Cincinnati social worker, and Gavriel Shapiro, the jailed 27-year-old Moscow activist, were married today by proxy in a civil ceremony by Chief Judge Harold Greene of District of Columbia Civil Court, Judge Greene married the couple after hearing testimony on the religious ceremony they underwent in Moscow June 8, Mrs. Shapiro's visa expired and she was unable to remain, in Russia for a civil ceremony.

"This doesn't seem to be very civilized to me," Judge Greene said of the Russian authorities' refusal to extend the bride's visa. "On the basis of legal principles," he continued, "I am convinced this court has the authority to perform a proxy marriage. On the basis of the testimony, a proxy marriage is appropriate under these circumstances." The testimony heard by him included the report that Shapiro has been harred from seeing family, friends or legal counsel since his arrest June 12 on charges

of draft evasion,

Mrs. Shapiro, asked by Judge Greene if she accepted the activist as her husband, replied, "I do." Rabbi Harry Kranz of Silver Spring, Md., who conducted the Moscow service, said the proxy ceremony "will hopefully be accepted by the Soviet authorities as a valid marriage." Rabbi Marc H. Tanenbaum, Interreligious Affairs director of the American Jewish Committee, voiced "appreciation" for the "humanitarian interest and role of President Nixon's administration, the State Department, numerous members of the Senate and House and hundreds of Americans, Christian and Jewish alike, who have taken an active part in the effort to assure justice and the realization of the fundamental human right of Gavriel Shapiro to leave his country, a right established by the United Nations Declaration of Human Rights."

A protest was made by letter today by Sen George McGovern to Soviet Ambassador Anatoly Dobrynin over Shapiro's arrest and imprisonment. The Senator urged that the Soviet government free Shapiro immediately and allow him to emigrate, calling Shapiro's forthcoming trial 'a source of profound concern' to him and to many other Americans. He wrote that Shapiro's release and permission to emigrate would be "universally welcomed as a vital contribution" to improving US-

Soviet relations.

On New York, Mrs. Max Schenk, president of Hedensah, sent telegram appeals to Communist Party Chairman Leonid Brezhney and to President Nixon, for intervention on Shapiro's behalf. She said, in both telegrams, that Shapiro's behalf. She said, in both telegrams, that Shapiro and other Jewish activists were called for military service as a political maneuver on the eve of President Nixon's visit to Moscow. She added Shapiro had not previously been scheduled for a military call-up. She asked Brezhnev to recommend dismissal of charges against Shapiro on "moral grounds" and allow him to emigrate on "moral grounds" and allow him to emigrate on "munitarina grounds".

#### FEINBERG FLATLY DENIES REPORT SABIN OUSTED AS WEIZMANN PRESIDENT

NEW YORK, June 29 (JTA)—Abraham Feinberg, chairman of the Board of Governors of the Weizmann institute of Science denied, in a statement issued here today; a published report in Israel that Dr. Albert B. Sabin, president of the Institute, had been fired as president.

"There is not a sointilla of truth in the published reports," Feinberg said here. "Dr. Sabin enjoys the full confidence and friendship of myself, members of the Board of Governors and the scientific staff of the Welzmann Institute." The chairman added that Dr. Sabin was returning to Rehovot. "to resume his duties as president on July 16," a post Dr. Sabin has held since January, 1870, under a five-year contract "which does not expire until the end of 1974. This year he underwent open heart surgery which has necessitated a protracted period of convalescence."

"Dr. Sabh alone will determine whether the state of his health will permit him to carry out the heavy responsibilities of the presidency over a long period," Feinberg said. "The decision is his and his alone to make. His prestige and dedication have proved an important asset in enhancing the distinguished reputation the Weizmann Institute enjoys in the international scientific community and elsewhere in the world."

#### Tells N.Y. UJA Volunteers HARRIMAN URGES LEND-LEASE ARMS ARRANGEMENTS WITH ISRAEL

NEW YORK, June 29 (JTA)--Elder statesman W, Averell Harriman said today that in the current election year, aid to Israel should be "a national question," and not a "political, partisan"; one. He spoke to 200 key volunteers at the United Jewish Appeal of Greater New York headquarters here participating in a summerlong person-to-person telephone drive to reach 100,000 members of the New York Jewish community.

"The issue of Israel is very much on the minds of those of us who have anything to do with the policies of the Democratic party." Harriman said, adding the hope that "if the Democrats set a good course in the platform adopted" at their July convention, "the Republicans will do the same." He applicated the Nixon administration for making it possible for Israel to buy weapons in the US but asked, "Why not lend-lease" such arms to Israel? He said if Israel was burdened "by a very large debt" because of US weapons sales policies, "it does seem to me we are not fulfitting our obligations."

"He said what the volunteers were doing was "absolutely essential"; because what the US was doing "is only a plus. In no sense do I suggest that it will relieve American Jews of the responsibilities which they have throughout the years so

fully met."

Still Hoping To Leave Poland
TREPPER SEES POLISH-FRENCH
PLOT TO KILL HIS LIBEL SUIT

COPENRAGEN, June 29 (ITA) -- Leopold Trepper charged today that the Pollish and French secret services were working in collusion to prevent him from bringing a libel suit against Jean Rochet, head of the French counter-intelligence service. The World War II master spy, who has not been permitted to leave Poland, made the charge in a telephone interview with the Jewish Telegraphic Agency.

He said that collusion was indicated when Folish police confiscated all the documents relating to the case from Trepper's French lawyer, Daniel Soulzez-Lariviere at Warsaw Airport last Friday. Lariviere spent three days in Warsaw conferring with his client and was handed the documents by Trepper just before his intended departure. But Polish police detained him for three hours and selzed the papers, the attorney reported on his return to Paris.

"I now fear the worst," Trepper told the JTA.

"Those documents could have brought about the
conviction of Jean Rochet for slander. I think there
is some kind of cooperation between the Polish and
French secret services," he said. Trepper, who
headed the Soviet spy network known as the "Red
Orchestra" in Western Europe during World War
II, was accused by Rochet in a Le Monde article
last month of having collaborated with the Gestapo.

Pollsh authorities have refused to permit him to leave the country on grounds that he 'finows too much.' Trepper said that if he does get a visa his first order of business will be to appear at the preliminary hearing of the Rochet case scheduled to be held in Paris, July 13. Afterwards, he said, he would go to London for medical treatment and then probably visit Brussels to address the Association of Former Underground Fighrers which has invited him; Trepper said his wife Ellasbeth is remaining in Copenhagen for the time being to await the outcome of his appearance before the Central Committee.

## Due In Moscow July 17 MOSCOW JEWS ASK WALDHEIM TO ACT FOR THEM DURING VISIT

LONDON, June 29 (JTA) -- United Nations Secretary General Kurt Waldheim has been asked to intervene with Soviet authorities on behalf of the human rights of Russian Jews when he visits Moscow next month. Jewish sources in the Soviet Union reported today that 40 Moscow Jews sent a message to Waldheim requesting an audience to discuss the problem of human rights as they relate to Soviet Jews who want to go to Israel. Earlier, 41 Jews from Minsk, Vilna and Kovno petitioned the Secretary General to investigate the curtailment of Jewish rights in contravention of Soviet law and international conventions to which the Soviet Union is a signatory. Dr. Waldheim is scheduled to arrive in Moscow July 17 on an official visit at the invitation of the Soviet government.

Jewish sources reported today that Mark Nashpitz has appealed from his prison cell in Moscow to Jews all over the world to work for his release. "I am to face a trial for a crime I never committed. I appeal for your help," the message said. Nashpitz was arrested last month for alleged evasion of military duty. He is a friend of Gavriel Shapiro, another Jewish activist arrested June 12, apparently on the same charges.

Nashpitz claimed in his appeal that he has been subjected to constant harassment by Soviet authorities since he applied for a visa to go to Israel six months ago. His parents and the parents of Shapiro have appealed to the international Committee of Jurists to investigate the cases of both men who, they say, are being brought to trial without having committed a crime."

Hits Busing 'Rhetoric'

NJCRAC OK'S 'AFFIRMATIVE ACTION'
BUT OPPOSES 'PREFERENTIAL QUOTAS'

LOS ANGELES, June 29 (#1A)—The annual plenary of the National Jewish Community Relations Advisory Council strongly endorsed today government-administered "affirmative action" guidelines to equalize employment and educational opportunities for racial and ethnic minorities. But it also, following a floor debate of almost four hours, condemned the use of "preferential quotas" in anti-discrimination programs.

The NJCRAC policy declaration also endored the setting of "specific target goals and timetables, not determined by population percentages" as acceptable forms of "affirmative action" so long as the goal and timetables are used "to evaluate good-faith efforts and not as

rigid requirements."

The action reflected, in large measure, an effort by the Jewish groups to balance their traditional advocacy of anti-discrimination policies against what many of the 300 delegates here regard as serious threats of "reverse discrimination" affecting Jews. The NJCRAC declaration supported such government-financed action as compensatory education, training and re-training, apprenticeship job counseling and placement, welfare assistance and other forms of help to the disadvantaged. "The sole criterion of eligibility for such special services must be individual need; the services must not be limited or offered preferentially" on a racial, religious or ethnic basis.

The NJCRAC, which represents nine national Jewish organizations and 92 community relations councils, took no position on the issue of busing per se. But the delegates chiede the anti-busing forces for engaging in "exaggerated political rhetoric" that "tended to distort the facts, inflame passions and impede rational analysis,"

They noted that the "exaggerations" included the claim that busing for desegregation would result in "massive" transportation costs whereas only one percent of the \$200 million spent on busing during the past school year went for desegregation. The delegates indicated that they backed busing "when it is the most effective peaceable way to attain desirable educational ends, including desegregation." But the plenary sympathized with the "reluctance" of some Jew ish parents "to see their children transferred to schools that are substandard" under desegregation plans. "It is not enough," the plenary concluded. "to say that children should not be transferred to bad schools. Children who are in bad schools now should not be left there either."

President Salvador Allende received two Chiesa Jewish community leaders in Santiago Wednesday and heard their ples for his intervention on behalf of persecuted Syrian Jewis. The leaders; Gil Sinay, president of the Jewish Central Committee of Chile and Leon Tichimino, president of the Chilena Zionist Federation, described the meeting afterwards as "very cordial."

#### STUDENT ACTIVIST UMBRELLA GROUP SETS PLANS FOR SIX REGIONAL MEETS.

CONCLAVE ON WOMEN'S RIGHTS

NEW YORK, Juine 29 (JTA)—An official of the North American Jewish Students Network, which claims to represent more than 300 student activist groups, said today the unbrella group will sponsor six regional conference this year and was planning also to organize a national conference on the problems of Jewish women.

Martin Salowitz, secretary general of the umbrella agency, said the decisions were made at a meeting of the Network steering committee convened to implement resolutions adopted at the second annual convention of Network June 8-12 at Indian Orchard, Pa,

Salowitz said the regional conclaves were being organized to provide "programmatic and educational assistance" to Jewish students who might otherwise not have access to such help "in developing their Jewish identity and knowledge." He also reported that the Steering Committee was investigating possibilities for influencing Jewish Federations and community councils "to adopt a more positive attitude toward Jewish education and Jewish poverty, among other issues."

The official also reported that Network had hired a field worker who will travel to various campuses to aid Jewish student groups and newspapers and help them maintain contact with each other. He said plans were being made to create a "Jewish Association for Life Studies," which will seek to exchange materials and publish social research relevant to the needs of the Jewish community.

Salowitz discounted the walkout of some "dissidents" from the Indian Orchard convention. They included members of the Jewish Defense League, Betar and other militant factions, who contended that Network did "almost nothing" for Soviet and Arab Jewry, Jewish education, the Jewish poor, Israel and aliya. Salowitz told the Jewish Poor, Israel and aliya. Salowitz told the Jewish Telegraphic Agency that members of the dissident groups had emphasized they were walking out of the convention and not out of the organization.

## Seeks \$500,000 Damages BALTIMORE RABBI FILES SUIT IN NEWARK FEDERAL COURT; SAYS BEATEN BY POLICEMEN

NEWARK, June 29 (JTA)—Rabbi Norbert Liner, 39, chairman of the Rabbincal Alumni of Ner Israel Rabbincal College in Baltimore, filed suit today in federal court in Newark, seeking \$500,000 in damages for alleged violation of his civil rights by six Jersey City policemen.

Rabbi Liner said in his complaint, filed against the six policemen and the city of Jersey City, that he was allegedly arreated while trying to fix his car on a Jersey City street. He charged also that he was taken to a station house where he was searched and where anti-Semitic remarks were allegedly shouted at him. He charged also that his ritual items were taken from him and that this made it impossible to carry out his daily religious exercises while he was in jail. He also charged that he was handouffed and incarcerated without being told of any charges against him.

The complaint also charged that one of the police officers took him from his cell, "grabbed the plaintiff and dragged him to a dark corner of the jail where he continued cursing him and victously struck him on the neck, body, legs and arms," He contended further that "false charges" of obstructing traffic and failure to give "a good account of himself" were later dismissed in municipal court, "

### COLPA FILES SUIT ON JOB BIAS NEW YORK, June 29 (JTA) -- The National Jewish

Commission on Law and Public Affairs. (COLPA) announced today it would represent an Orthodox Jew who charges that he was forced to resign as a Transit Authority bus driver-trainee because he refused to work on Saturdays and on Shavuot. The employe, whose name was not disclosed, has filed a complaint with the New York State Division on Human Rights, which will hold a hearing July 7. The complaint asserts that the employe was "denied equal terms and conditions... because of my religious observance," in violation of state law.

The law permits Sabbath observance by employes except when hardship to the employer would result. The TA has maintained that it is exempt from the law because it is engaged in an essential service for which employes must always be ready to work. Howard Rhine, president of COLPA, said: "This is not the first time that an incident of this nature involving the New York City Transit Authority has occurred and we have determined to make it the last. It is incredible that at a time when private employers are increasingly recognizing their responsibilities and are making the required accommodations to one of the basic needs of their employes, a public agency should continually refuse to comply with the law."

### BOSTON TV STATION AGREES TO AIR JEWISH VIEWS ON TERRORISM AND AIR PIRACY

BOSTON. June 29 (JTA) -- In an attempt to be "responsive to an aggrieved segment of the community that has a right to have a voice." WBZ-TV has agreed to schedule four minutes of interviews on culpability for terrorism, methods of combating air piracy, and the effect of terrorism on Israeli tourism. The television station reached the compromise with the Jewish Community Council of Metropolitan Boston, which had unsuccessfully challenged the station's refusal to air a rebuttal to a one-minute, 48-second commentary by Erwin D. Canham, editor of the Christian Science Monitor. Canham, a regular commentator on the Group W (Westinghouse Broadcasting) service, had warned June 4 against both Arab and Israeli "terror." The JCC had protested that Canham equated the Tel Aviv massacre by Arab-inspired Japanese with Israel's liberation of an Arab-hijacked let.

WBZ-TV program manager Paul D, Coss called the scheduled interviews—with a JCC representative and a member of the Israel Tourist Board—"a meaningful solution to the problem" that "won't violate the journalistic integrity of our newscast." He said the JCC's threat to protest to the Federal Communications Commission would have failed, and "our victory would leave a bad taste in an important community is mouth." (The JCC wanted to charge WBZ-TV with violation of the so-called fairness doctrine, which requires the airing of opposing opinion in "controversial issues of public importance;"). "If don't care to allenate people who are important to us," added Coss.
