Premier Back From Vienna
MRS, MEIR IN CRISIS CONFERENCES AS
KNESSET A CTION LOOMS ON BILLS
ALTERING RELIGIOUS STATUS QUO

JERUSALEM, July 4 (JTA)—Premier Golda Metr, who returned late last night from the Socialist International conference in Vienna, is working virtually around the clock to avert a political crisis that could topple her government. Within hours after landing at Lydda Airport, Mrs. Metr was in conference with leaders of her Labor Alignment to try to find a way out of the seeming impasse created by the imminent debate in the Knesset on two bills which would have the effect of altering the religious status quo that has prevailed in Israel since its independence 25 years ago.

The Premier heard a long report today from Asher Yadlin, the Labor Party Secretary General who had accompanied her to Vienna but rushed home several days in advance of the official party because of the crisis, She conferred with Deputy Premier Yigal Allon, Finance Minister Pinhas Sapir and Israel Galili, the Minister-Without-Portfolic who represent the top echelon of her Labor Party, She is scheduled to meet tomorrow with the heads of the National Religious Party, the Independent Liberals and Mapam in the hope of persuading them to change their positions, which Mrs. Meir has warned, will topple the coalition government and necessitate new elections this fall, a year ahead of schedule.

At issue are two legislative measures introduced as private members bills which the Knesset has been asked to place on its docket next week. One of them, submitted by Gideon Hausner of the Independent Liberal Party, provides for civil marriage, presently prohibited in Israel, in limited cases where a couple is denied marriage rites by the rabbinate for religious reasons. The second bill, which its adherents seem to view as a counter-attack against the Hausner bill. though the two are not related, would amend Israel's Law of Return to specify that conversions to Judaism of prospective immigrants must be made in accordance with halacha, Jewish religious law. The law as it stands does not make that distinction and as such has been bitterly attacked by Orthodox elements.

The amendment measure was introduced by Shlomo Lorinoz of the Orthodox Agudat Israel, Lorinoz told the Jewish Telegraphic Agency yesterday that he first submitted his bill last Jan, and did not press hard for action but with the Knesset recess approaching he could wait no longer. He insisted that the Knesset must recognize his bill as "urgent" to counter-balance the Hausner bill.

Mrs. Meir is opposed to both bills on grounds that they would destroy the religious status quo. She threatened to evict the Independent Liberals from the coalition if they brought their measure to a vote. But she apparently did not realize at the time that a majority of the Mapam faction, partners in her Labor. Alignment, would support the limited civil marriage measure. The Mapam position however is still not definite,

Similarly, Mrs. Meir has sought to persuade the National Religious Party to support the government against the Lorincz measure. Dr. Zerach Warhaftig, the Minister for Religious Affairs and an NRP leader, said on a television interview last night that his party would either abstain or leave the chamber when the Knesset votes on the Lorinoz bill but could not possibly vote against it.

Defections by three coalition partners on the issue would seem to leave the Premier no choice but to resign. The Labor Party's policy-making political bureau is due to convene Thursday to decide on the party's final position. The decision will be conveyed to Mapam at a meeting of the Alignment executive next week and to the ILP and NRP as well. Most israeli leaders are opposed to the prospect of new elections which could be held within three months if necessary. But Menachem Beigin, leader of the opposition Gahaf faction, has come out as a strong advocate of early elections. He announced today that he would submit a bill to dissolve the present Knesset and hold elections.

ISRAEL DISMAYED BY ONE-SIDED RESOLUTION; EBAN TELLS ENVOYS OF SECURITY COUNCIL MEMBERS WHO VOTED FOR IT Reiterates Position On POWs

JERUSALEM, July 4 (JTA) -- Foreign Minister Abba Eban yesterday summoned the representatives of four members of the United Nations Security Council to relate Israel's dismay at the Council's June 26 resolution and to reiterate Israel's position on a possible prisoner exchange. He met later with the French ambassador on the same matter. Observers saw Eban's move as keyed to another Council meeting, which Syria is known to be pressing for. The June 26 resolution, which condemned Israel for retaliatory raids into Lebanon but not the terrorist raids from Lebanon that engendered them, said the Council would meet again unless the Syrian officers captured by Israel in the June 21 foray into Lebanon were not promptly repatriated.

Eban told the amhassadors of Argentina, Belgium and Japan and the British charge d'affaires that Israel insists on an exchange of all prisoners held by itself, Syria and Egypt and will not give the captured Syrians priority. In Israel's view, he said, they are prisoners of war. Syria has claimed they were kidnaped,

Bban told the envoys of Israel's dismay at the one-sidedness of the resolution, which passed by 13-0 with the United States and Panama abstaining. He complained that the Council has never sympathized with Israel! victims of Arab attacks,

The Foreign Minister told the Cabinet Sunday that the Syrians seemed to be hardening their position in ongoing negotiations with the International Red Cross on an exchange of prisoners with Israel, The Security Council resolution expressed hope for a speedy return of the officers.

The talks through the Red Cross reportedly were at a standstill, some sources said. They suggested that the Syrians may feel their officers have been in Israeli control long enough to have divulged whatever useful intelligence they had.

ONE INJURED IN BOMB BLAST AT NATANYA BUS STATION

TEL AVIV, July 4 (JTA).—One person was injured when an improvised bomb exploded and set fire to the public lavatories in the Natanya central bus teminal at noon today. The victim, not identified, was taken to a nearby hospital for treatment. The damage was reported to be slight. Police detained several suspects at the scene of the bombing.

Syrian gunners shelled Israeli positions in the southern Golan Heights last night. A military spokesman reported that a number of mortar shells were fired from the region where the Israeli. Syrian and Jordanian borders converge. The fire was returned. No Israeli casualties were reported.

Crime Wave In Israel KNESSET TO STIFFEN PENALTIES FOR ILLEGAL GUN CARRIERS

JERUSALEM, July 4 (JTA)--Illegal of a gun will be punishable by up to ten years imprisonment and possession of a gun by up to seven years under new legislation submitted to the Cabinet vesterday and scheduled for adoption by the Knesset later this month. The present law provides for a maximum term of up to four years for such violations.

Attorney General Meir Shamgar told the Cabinet that there has been an increase in violent crime in Israeli urban life. He said bank raids by robbers carrying and often firing submachine guns have been an almost daily occurence in recent months. When the new law becomes effective. he said, people illegally in possession of such weapons will have a two-week amnesty period to hand the weapons over to authorities. Most illega! weapons in Israel are held as trophies of the 1967 Six-Day War, rather than with intent to commit crime. However, the Attorney General pointed out, these weapons can be and are stolen and wind up in the possession of criminals. Under a specific provision of the new law, Israelis turning in weapons will not have to give their identities.

REPORT TREPPER URGES FAMILY TO ABANDON CAMPAIGN, SAYS HE ALONE WILL TAKE RISKS

PARIS, July 4 (JTA) -- Leopold Trepper, the World War II master spy, has asked his wife and sons to stop campaigning for his release from Pol-and because there are "other, more important causes than mine." the weekly Nouvel Observateur reported today. According to Bernard Guetta, the journalist who interviewed Trepper, the former chief of the "Red Orchestra," the Soviet espionage network in Western Europe during the German occupation, told him "Now is not the time to struggle for me."

Trepper has been seeking an exit visa in order to join a son in Israel but Polish authorities have withheld it on grounds that Trepper, who is nearing 70, still possesses vital secrets. His wife Elisabeth and two of his sons are presently in Copenhagen. They have been seeking for months to arouse world opinion to bring pressure to bear on the Polish government to allow Trepper to leave.

According to Nouvel Observateur, Trepper said he didn't want members of his family to take risks. "If anybody has to fight and take risks it will be me," he was quoted as saying, "I know from experience that no one fully recovers after a hunger

strike," he told Guetta,

The French weekly reported that Trepper stressed that he had no quarrel with Edward Gierek, Secretary of the Polish Communist Party's Central Committee, but with the bureaucracy, He said Gierek was not responsible for his treatment or for the wave of official anti-Semitism in Poland several years ago. He charged, however, that the Party bureaucracy opposed his going to Israel because "it may be too humiliating for them."

TRIESTE SYNAGOGUE DESECRATED: NEO-FASCISTS BLAMED

ROME, July 4 (JTA) -- The synagogue in the port city of Trieste was vandalized over the weekend, it was learned here today. Jewish community spokesmen attributed the vandalism to neo-Fascist and anti-Semitic gangs that have profaned synagogues throughout Italy recently. The synagogue at Gorizia was vandalized on April 25. Tombstones of Jews in many Trieste area cemeteries have been smeared or toppled.

Sergio Piperno, president of the Italian Jewish Communities Association, cabled a sharp protest today to Premier Giulio Andreotti. Piperno denounced the "vile and criminal aggression against the Trieste synagogue" and asked "energetic government action" to apprehend the culprits. He said the government must protect "holy sites which are the patrimony of the Italian people as a whole," and he denounced the current rash of anti-Semitic publications across the country.

JEWISH CEMETERY VANDALIZED IN UKRAINE TOWN

Authorities Promise Repairs If Jews Keep Quiet

TEL AVIV, July 4 (JTA) -- The Jewish cemetery in Zamrinka, in the Ukraine, has been desecrated. Most of its tombstones were toppled and broken, according to reports reaching here today. According to the reports, local authorities promised to help repair the damage if the Jewish community does not make "a big fuss about it."

Soviet immigrants from the Ukrainian city of Kharkov have appealed to President Zalman Shazar, Premier Golda Meir and the Dutch Embassy to help Solomon Greenberg obtain an exit visa. The immigrants said Greenberg was arrested in Kharkov last week with another Jew. Constantin Skoblinsky and that both were interrogated for three days about allegedly passing information to foreigners. The two were released on condition they remain in Kharkov while the investigation continues. The petitioners noted that Israeli citizenship was conferred on Greenberg recently at his request. The Dutch Embassy here represents Israeli interests in Moscow.

DUTCH FOREIGN MINISTER IN CAIRO: SAYS EGYPT WANTS PEACEFUL SETTLEMENT

AMSTERDAM, July 4 (JTA) -- Norbert Schmeltzer, the Netherlands Foreign Minister, says he is personally convinced after meeting with Egyptian leaders, that Egypt wants a peaceful solution to the Middle East conflict. Schmeltzer, currently in Cairo, made that assessment in an interview with Dutch journalists who accompanied him on his trip. "The Egyptian position toward a solution of the Middle East conflict is cooperative," the Foreign Minister said, according to the interview published here today.

He said the Egyptians envisaged a solution based on the Security Council's Resolution 242 arrived at through the good offices of the United Nations special mediator, Gunnar V. Jarring "or another intermediary." He described his talks with Egyptian Foreign Minister Murad Ghaleeb as "most cordial, open and fruitful," He said that he had conveyed to the Egyptian leaders his own and all of Western Europe's growing concern over the widering Soviet influence in the Middle East region and his government's interest in the prompt reopening of the Suez Canal.

The Dutch journalist reported that the two ministers accompanied by their wives emerged from the conference calling each other by their

first names.

9 EX-NAZIS ON TRIAL FOR MASS MURDERS OF JEWS; 10TH GETS ADJOURNMENT FOR MEDICAL REASONS

BONN, July 4 (JTA)—Nine former Nazis have gone on trial in Dusseldorf and Munich on charges of murder, and the trial of a tenth has been adjourned until July II. The six Dusseldorf defendants are Wilhelm Ahrens, 65, former police chief of Cologne; Ruprecht Mueller, 56, and Wilhelm Stephany, 57, former police officers; Willy Kaffenberg, 57; Gerhard Hurtig, 55, and Robert Ross, a 58-year-old businessman.

All belonged to police units in the Ukraine in World War II. According to the indictment, Ahrens was ordered in the spring of 1942, to shoot all old and III Jews in the ghetto of Krynki in Bialystok, because they were "useless." The charge says he killed at least 15 Jewish men and women "in a cruel manner" while 20 others escaped to a synagogue into which Ahrens, obeying orders, threw hand grenades, killing all.

Ahrens and the other five defendants pleaded not guilty. Three ex-Nazis who allegedly specialized in the murder of women and children, meanwhile, are in the dock in Munich. They are Dr. Heinrich Goerts, 74; Kurt Trimborn, 68, and Kurt Severin, 66, all charged with the murder of Jews near the Russian city of Taganrog in 1941.

According to the indictment, Trimborn and Severin hunted down Jewish women and children, forced them to undress in freezing weather, and shot them when they started suffering frost pains. Trimborn is further accused of killing 250 children near Jesk, with Goerts' assistance. The defense attorneys and the jury visited Russia several months ago to inspect the sites of the purported crimes. The Munich Attorney General has asked for life imprisonment for the three defendants. The trial is expected to last two weeks.

In Essen, the trial of Horst Wagner, 66, a former Nazi colonel charged with killing 350,000 Jews, was adjourned to July II to allow for a medical examination to determine his fitness to stand trial. When the proceeding opened this morning, the defense contended Wagner was suffering from severe sotatic pains. The accused was a liaison officer between Nazi Foreign Minister Joachim von Ribbentrop and SS chief Heinrich Himmler.

DIASPORA, ISRAEL PARTNERSHIP MUST BE ON BASIS OF EQUALITY, GOLDMANN SAYS

GENEVA, July 4 (JTA).—Dr. Nahum Goldmann, president of the World Jewish Congress, made a strong plea today for a partnership of equality between diaspora Jewry and Israel. "The dispersion of today is the third in Jewish history and as a whole, the Jewish people has spent more time in the diaspora than it has in its own state," Dr. Goldmann said in an address at the closing session of the conference of the World Union for Progressity Judaism here,

"The negation of the disspora, the attempt to forget it or to denigrate it as an anomaly, is defenseless and distorts the character of Jewish existence in the past and in the present," he said. "It is essential to find a constructive relationship between Israel and the disspora," Dr. Goldmann added

He said the solution would have to be based on the principles of full solidarity and responsibility of both parts of the Jewish people for one another and for the people as a whole. "The diaspora will have to respect Israel as a sovereign state and Israel must respect the autonomy of the golah; while both will have the right and the duty to advise one another and to discuss common problems, they will have to leave the decisions to each of the two parts," Dr. Goldmann said.

Dr. Maurice Eisendrath was elected president of the World Union for Progressive Judatsin. Rabbi Richard Hirsch is the new executive divector of the organization that plans to move its headouarters to Jerusalem.

The annual meeting of the Memorial Foundation for Jewish Culture opened here last night. It will continue through Thursday evening. The Memorial Foundation meeting was preceded by the annual meeting of the Conference on Jewish Material Claims Against Germany of which Dr. Goldmann is chairman. He reviewed the Claims Conference's activities over the past 20 years. A report was submitted by Dr. Joseph J. Schwartz, treasurer.

WON'T BE INTIMIDATED BY THREATS TO AIRLINE, PERES INSISTS

JERUSALEM, July 4 (JTA).—Transport Minister Shimon Peres said today that "Israel will not be intimidated by threats" to its air communications, "Anyone frightneed by one anonymous threat is just asking for more of the same," Peres declared. He referred to an anonymous warning to EI Al today, threatening its planes unless Kozo Okamoto, the Japanese gunman captured in the May 30 Lydda Airport massacre is freed.

The warning was sent to the International Air Transport Association (IATA) which conveyed it to El Al. But Israell airline officials said they were taking no special security measures beyond those aiready in effect. "We are doing all that is necessary aiready." an El Al spokesman said. Officials of other airlines said anonymous threats could harm tourism to Israel. There was no vistling change in the routine at Lydda Airport today where strict security measures have been maintained since the measures.

A Month After The Massacre LYDDA AIRPORT TRAFFIC BOOMS

TEL AVIV, July 4 (JTA)--Lydda Airport officials reported yesterday, little more than a month after the airport massacre, that traffic was booming. They said that some 7000 passengers landed in 37 planes, including five jumbo jets Sunday. Traffic was particularly heavy in the afternoon when three of the jumbo jets and one Boeing 707 landed one after another.

Despite the pressure of the huge inflow of arrivals and Israel's tight airport security measures, all of the passengers were able to leave the airport without undue delay, the officials reported. Average incoming total of passengers at the airport daily is about 6000. The peak was reached last Passover when 10,000 persons arrived. The outgoing passenger total also was a little higher than usual, partly because the summer school vacation has started and the summer excursions that accompany it.

POSTPONEMENT ASKED FOR CHIEF RABBINATE ELECTIONS

JERUSALEM, July 4 (JTA)--The Chief Rabbinate elections, scheduled to be held Aug. II, will have to be postponed for at least one or two months beyond that date. The elections committee established last mont to prepare for the balloting and to establish a 150-man electoral college, said today that it needed the extra time to complete its tasks. The committee is expected to ask the government to extend the terms of the incumbent chief rabbis for the required period. The only candidates for the post of Ashkenazic Chief Rabbi are the incumbent, Rabbi Yehuda Isser Uniterman and Chief Rabbi Shlomo Goren of Tel Aviy.

PANELISTS DIFFER OVER WHETHER JEWISH SELF-INTEREST LEADS TO ISOLATION

LOS ANGELES, July 4 (JTA) -- Panelists looking into the attitudes of the American Jewish community agreed here that American Jews are "turning inward" but differed sharply over whether this meant a trend toward Jewish self-isolation. The discussion took place during the annual plenary of the National Jewish Community Relations Advisory Council (NJCRAC) which closed over the week-

end, Rabbi Balfour Brickner, directer of inter-faith activities for the Union of American Hebrew Congregations, decried the "withdrawal mentality" which, he said, "concentrates only on Israel, Soviet Jews, Jewish education and similar issues which are considered survivalistic interests." He warned that this can push American Jewry "into an uncharacteristic posture of social and political conservatism." The Reform rabbi expressed concern that the Jewish community could "lose our youth" if an "hysterical approach" is left unchallenged to threaten Jewish life with "suicide by assimilation or introversion."

But Sidney Z. Vincent, executive director of the Jewish Community Federation of Cleveland, contended that by "turning inward," Jews are acting with enlightened self-interest. He claimed that becoming more Jewish does not mean a turn toward isolationism. "The best of our Jewishly committed young people have not resigned one whit of social vision," he declared,

He said that a consequence of the new trend is that Jewish institutions -- community centers, social service agencies and others -- "are being increasingly examined not only on technical excellence, but on their Jewish credentials."

Judge Jacob T. Zuckerman, president of the Jewish Labor Committee, saw the Jewish community "confused" and its leadership divided by a polarization between two versions of liberalism. One interprets liberalism in traditional terms of "equal treatment for all" while the new liberalism has relaxed the standard in favor of "preferential treatment" for disadvantaged groups, Judge Zuckerman said. He warned that "many Jews are part of Middle America" and would abandon the liberal movement "if we abandon our advocacy of equal justice."

CONGRESS URGED TO INVESTIGATE AFFIRMATIVE ACTION PROGRAM

Jewish Group Claims HEW Guidelines Result In Discrimination

NEW YORK, July 4 (JTA) -- The Jewish Rights Council is urging Congress to investigate whether the operation of the Affirmative Action program, under guidelines from the Department of Health Education and Welfare and other government bodies, is leading to quotas and discriminatory hiring and promotion policies in schools, civil service and corporate enterprises that benefit from government contracts.

The Council, which describes itself as "a national organization formed to defend the equality of rights for all persons under our laws," claimed that the program "has already led to policies in several universities and public school systems which have done harm to the merit system." At a meeting in the House of Representatives in Washington last week, spokesmen for the group detailed its concerns before an audience that included the entire Congressional delegation from New York City. The meeting was arranged with the assistance of Rep. Benjamin Rosenthal (D. NY).

A statement issued in behalf of the Council by

Profs. Seymour Siegel, president, and Edward M. Gershfield and Fritz A. Rothschild, member of the executive council, expressed the anxiety felt by the Jewish community over the threat of imposed racial and religious considerations in hiring. It said that Affirmative Action, as pursued by HEW "although sincerely motivated, cannot but lead to injustice" because "in favoring one group or individual, one necessarily harms an-

"A commitment to hire 15 percent of a certain minority as professors, might imply discrimination against other qualified applicants," the statement said, "As Jews, we remember only too well the tendency to favor white Protestants in admissions to colleges and universities and to tenured positions on university faculties. This unfairness is compounded by the fact that those who are bound to suffer are least responsible for the injustices that have hist rically been visited upon various minorities in our countries."

The statement noted that "Jews have traditionally fought for the merit system of hiring and promotion" and warned that "any attempt to tamper with that impartial system is de facto directed against the Jewish community, though it may not be so intended."

'YORDIM' IN CANADA DON'T PROSPER, REPORT SAYS

JERUSALEM, July 4 (JTA) -- Israelis who emigrated to Canada, mainly to improve their economic condition, by and large have failed to prosper, according to a report on "yordim" living in Canada, published in the current issue of the World Zionist Organization's quarterly magazine, "Batfutsot Hagola," According to Adam Ackerman, author of the report, 64 percent of the nearly 22,000 Israelis who settled in Canada have required Canadian government assistance and 16 percent have gone on welfare.

The report states that by 1964, 12,000 Israelis had emigrated to Canada and were followed by another 7000 during the two succeeding years which saw an economic recession in Israel. Since 1967, another 2500 Israelis have gone to live in Canada, But of the total now living in Canada, only ten percent were born in Israel, Ackerman reported. He said 52 percent cited economic reasons for their emigration and 56 percent said they did not contemplate returning to Israel. But 34 percent said they would go back if the government offered them the same incentives it offers new immigrants, Ackerman said.

JEWISH GROUPS HAIL DEATH PENALTY BAN BY U.S. SUPREME COURT

NEW YORK, July 4 (JTA) -- The American Jewish Congress and the Synagogue Council of America--which filed a joint friend-of-the-court brief in the case--have hailed the US Supreme Court's decision barring capital punishment as "consistent with Jewish tradition" and "a clear triumph for the standards of civilization and humaneness" inherent in the US Constitution.

In a joint statement, the Congress and the Synagogue Council -- which represents the major Orthodox, Conservative and Reform rabbinical and congregational bodies in the US--declared: "We have long and consistently believed, as Americans and as Jews, that capital punishment represented a violation of the Eighth Amendment's prohibition against 'cruel and unusual punishment.... The Supreme Court has expressed its agreement with that view. Moreover, in so doing, it has supported the Talmudic concern with human fallibility and the irreversible nature of capital punishment."

He insisted that the Knesset must recognize his bill as "urgent" to counter-balance the Hausner bill.

Mrs. Meir is opposed to both bills on grounds that they would destroy the religious status quo. She threatened to evict the Independent Liberals from the coalition if they brought their measure to a vote. But she apparently did not realize at the time that a majority of the Mapam faction, partners in her Labor. Alignment, would support the limited civil marriage measure. The Mapam position however is still not definite,

Similarly, Mrs. Meir has sought to persuade the National Religious Party to support the government against the Lorincz measure. Dr. Zerach Warhaftig, the Minister for Religious Affairs and an NRP leader, said on a television interview last night that his party would either abstain or leave the chamber when the Knesset votes on the Lorinoz bill but could not possibly vote against it.

Defections by three coalition partners on the issue would seem to leave the Premier no choice but to resign. The Labor Party's policy-making political bureau is due to convene Thursday to decide on the party's final position. The decision will be conveyed to Mapam at a meeting of the Alignment executive next week and to the ILP and NRP as well. Most israeli leaders are opposed to the prospect of new elections which could be held within three months if necessary. But Menachem Beigin, leader of the opposition Gahaf faction, has come out as a strong advocate of early elections. He announced today that he would submit a bill to dissolve the present Knesset and hold elections.

ISRAEL DISMAYED BY ONE-SIDED RESOLUTION; EBAN TELLS ENVOYS OF SECURITY COUNCIL MEMBERS WHO VOTED FOR IT Reiterates Position On POWs

JERUSALEM, July 4 (JTA) -- Foreign Minister Abba Eban yesterday summoned the representatives of four members of the United Nations Security Council to relate Israel's dismay at the Council's June 26 resolution and to reiterate Israel's position on a possible prisoner exchange. He met later with the French ambassador on the same matter. Observers saw Eban's move as keyed to another Council meeting, which Syria is known to be pressing for. The June 26 resolution, which condemned Israel for retaliatory raids into Lebanon but not the terrorist raids from Lebanon that engendered them, said the Council would meet again unless the Syrian officers captured by Israel in the June 21 foray into Lebanon were not promptly repatriated.

Eban told the amhassadors of Argentina, Belgium and Japan and the British charge d'affaires that Israel insists on an exchange of all prisoners held by itself, Syria and Egypt and will not give the captured Syrians priority. In Israel's view, he said, they are prisoners of war. Syria has claimed they were kidnaped,

Bban told the envoys of Israel's dismay at the one-sidedness of the resolution, which passed by 13-0 with the United States and Panama abstaining. He complained that the Council has never sympathized with Israel! victims of Arab attacks,

The Foreign Minister told the Cabinet Sunday that the Syrians seemed to be hardening their position in ongoing negotiations with the International Red Cross on an exchange of prisoners with Israel, The Security Council resolution expressed hope for a speedy return of the officers.

The talks through the Red Cross reportedly were at a standstill, some sources said. They suggested that the Syrians may feel their officers have been in Israeli control long enough to have divulged whatever useful intelligence they had.

ONE INJURED IN BOMB BLAST AT NATANYA BUS STATION

TEL AVIV, July 4 (JTA).—One person was injured when an improvised bomb exploded and set fire to the public lavatories in the Natanya central bus teminal at noon today. The victim, not identified, was taken to a nearby hospital for treatment. The damage was reported to be slight. Police detained several suspects at the scene of the bombing.

Syrian gunners shelled Israeli positions in the southern Golan Heights last night. A military spokesman reported that a number of mortar shells were fired from the region where the Israeli. Syrian and Jordanian borders converge. The fire was returned. No Israeli casualties were reported.

Crime Wave In Israel KNESSET TO STIFFEN PENALTIES FOR ILLEGAL GUN CARRIERS

JERUSALEM, July 4 (JTA)--Illegal of a gun will be punishable by up to ten years imprisonment and possession of a gun by up to seven years under new legislation submitted to the Cabinet vesterday and scheduled for adoption by the Knesset later this month. The present law provides for a maximum term of up to four years for such violations.

Attorney General Meir Shamgar told the Cabinet that there has been an increase in violent crime in Israeli urban life. He said bank raids by robbers carrying and often firing submachine guns have been an almost daily occurence in recent months. When the new law becomes effective. he said, people illegally in possession of such weapons will have a two-week amnesty period to hand the weapons over to authorities. Most illega! weapons in Israel are held as trophies of the 1967 Six-Day War, rather than with intent to commit crime. However, the Attorney General pointed out, these weapons can be and are stolen and wind up in the possession of criminals. Under a specific provision of the new law, Israelis turning in weapons will not have to give their identities.

REPORT TREPPER URGES FAMILY TO ABANDON CAMPAIGN, SAYS HE ALONE WILL TAKE RISKS

PARIS, July 4 (JTA) -- Leopold Trepper, the World War II master spy, has asked his wife and sons to stop campaigning for his release from Pol-and because there are "other, more important causes than mine." the weekly Nouvel Observateur reported today. According to Bernard Guetta, the journalist who interviewed Trepper, the former chief of the "Red Orchestra," the Soviet espionage network in Western Europe during the German occupation, told him "Now is not the time to struggle for me."

Trepper has been seeking an exit visa in order to join a son in Israel but Polish authorities have withheld it on grounds that Trepper, who is nearing 70, still possesses vital secrets. His wife Elisabeth and two of his sons are presently in Copenhagen. They have been seeking for months to arouse world opinion to bring pressure to bear on the Polish government to allow Trepper to leave.

According to Nouvel Observateur, Trepper said he didn't want members of his family to take risks. "If anybody has to fight and take risks it will be me," he was quoted as saying, "I know from experience that no one fully recovers after a hunger

strike," he told Guetta,

The French weekly reported that Trepper stressed that he had no quarrel with Edward Gierek, Secretary of the Polish Communist Party's Central Committee, but with the bureaucracy, He said Gierek was not responsible for his treatment or for the wave of official anti-Semitism in Poland several years ago. He charged, however, that the Party bureaucracy opposed his going to Israel because "it may be too humiliating for them."

TRIESTE SYNAGOGUE DESECRATED: NEO-FASCISTS BLAMED

ROME, July 4 (JTA) -- The synagogue in the port city of Trieste was vandalized over the weekend, it was learned here today. Jewish community spokesmen attributed the vandalism to neo-Fascist and anti-Semitic gangs that have profaned synagogues throughout Italy recently. The synagogue at Gorizia was vandalized on April 25. Tombstones of Jews in many Trieste area cemeteries have been smeared or toppled.

Sergio Piperno, president of the Italian Jewish Communities Association, cabled a sharp protest today to Premier Giulio Andreotti. Piperno denounced the "vile and criminal aggression against the Trieste synagogue" and asked "energetic government action" to apprehend the culprits. He said the government must protect "holy sites which are the patrimony of the Italian people as a whole," and he denounced the current rash of anti-Semitic publications across the country.

JEWISH CEMETERY VANDALIZED IN UKRAINE TOWN

Authorities Promise Repairs If Jews Keep Quiet

TEL AVIV, July 4 (JTA) -- The Jewish cemetery in Zamrinka, in the Ukraine, has been desecrated. Most of its tombstones were toppled and broken, according to reports reaching here today. According to the reports, local authorities promised to help repair the damage if the Jewish community does not make "a big fuss about it."

Soviet immigrants from the Ukrainian city of Kharkov have appealed to President Zalman Shazar, Premier Golda Meir and the Dutch Embassy to help Solomon Greenberg obtain an exit visa. The immigrants said Greenberg was arrested in Kharkov last week with another Jew. Constantin Skoblinsky and that both were interrogated for three days about allegedly passing information to foreigners. The two were released on condition they remain in Kharkov while the investigation continues. The petitioners noted that Israeli citizenship was conferred on Greenberg recently at his request. The Dutch Embassy here represents Israeli interests in Moscow.

DUTCH FOREIGN MINISTER IN CAIRO: SAYS EGYPT WANTS PEACEFUL SETTLEMENT

AMSTERDAM, July 4 (JTA) -- Norbert Schmeltzer, the Netherlands Foreign Minister, says he is personally convinced after meeting with Egyptian leaders, that Egypt wants a peaceful solution to the Middle East conflict. Schmeltzer, currently in Cairo, made that assessment in an interview with Dutch journalists who accompanied him on his trip. "The Egyptian position toward a solution of the Middle East conflict is cooperative," the Foreign Minister said, according to the interview published here today.

He said the Egyptians envisaged a solution based on the Security Council's Resolution 242 arrived at through the good offices of the United Nations special mediator, Gunnar V. Jarring "or another intermediary." He described his talks with Egyptian Foreign Minister Murad Ghaleeb as "most cordial, open and fruitful," He said that he had conveyed to the Egyptian leaders his own and all of Western Europe's growing concern over the widering Soviet influence in the Middle East region and his government's interest in the prompt reopening of the Suez Canal.

The Dutch journalist reported that the two ministers accompanied by their wives emerged from the conference calling each other by their

first names.

9 EX-NAZIS ON TRIAL FOR MASS MURDERS OF JEWS; 10TH GETS ADJOURNMENT FOR MEDICAL REASONS

BONN, July 4 (JTA)—Nine former Nazis have gone on trial in Dusseldorf and Munich on charges of murder, and the trial of a tenth has been adjourned until July II. The six Dusseldorf defendants are Wilhelm Ahrens, 65, former police chief of Cologne; Ruprecht Mueller, 56, and Wilhelm Stephany, 57, former police officers; Willy Kaffenberg, 57; Gerhard Hurtig, 55, and Robert Ross, a 58-year-old businessman.

All belonged to police units in the Ukraine in World War II. According to the indictment, Ahrens was ordered in the spring of 1942, to shoot all old and III Jews in the ghetto of Krynki in Bialystok, because they were "useless." The charge says he killed at least 15 Jewish men and women "in a cruel manner" while 20 others escaped to a synagogue into which Ahrens, obeying orders, threw hand grenades, killing all.

Ahrens and the other five defendants pleaded not guilty. Three ex-Nazis who allegedly specialized in the murder of women and children, meanwhile, are in the dock in Munich. They are Dr. Heinrich Goerts, 74; Kurt Trimborn, 68, and Kurt Severin, 66, all charged with the murder of Jews near the Russian city of Taganrog in 1941.

According to the indictment, Trimborn and Severin hunted down Jewish women and children, forced them to undress in freezing weather, and shot them when they started suffering frost pains. Trimborn is further accused of killing 250 children near Jesk, with Goerts' assistance. The defense attorneys and the jury visited Russia several months ago to inspect the sites of the purported crimes. The Munich Attorney General has asked for life imprisonment for the three defendants. The trial is expected to last two weeks.

In Essen, the trial of Horst Wagner, 66, a former Nazi colonel charged with killing 350,000 Jews, was adjourned to July II to allow for a medical examination to determine his fitness to stand trial. When the proceeding opened this morning, the defense contended Wagner was suffering from severe sotatic pains. The accused was a liaison officer between Nazi Foreign Minister Joachim von Ribbentrop and SS chief Heinrich Himmler.

DIASPORA, ISRAEL PARTNERSHIP MUST BE ON BASIS OF EQUALITY, GOLDMANN SAYS

GENEVA, July 4 (JTA).—Dr. Nahum Goldmann, president of the World Jewish Congress, made a strong plea today for a partnership of equality between diaspora Jewry and Israel. "The dispersion of today is the third in Jewish history and as a whole, the Jewish people has spent more time in the diaspora than it has in its own state," Dr. Goldmann said in an address at the closing session of the conference of the World Union for Progressity Judaism here,

"The negation of the disspora, the attempt to forget it or to denigrate it as an anomaly, is defenseless and distorts the character of Jewish existence in the past and in the present," he said. "It is essential to find a constructive relationship between Israel and the disspora," Dr. Goldmann added

He said the solution would have to be based on the principles of full solidarity and responsibility of both parts of the Jewish people for one another and for the people as a whole. "The diaspora will have to respect Israel as a sovereign state and Israel must respect the autonomy of the golah; while both will have the right and the duty to advise one another and to discuss common problems, they will have to leave the decisions to each of the two parts," Dr. Goldmann said.

Dr. Maurice Eisendrath was elected president of the World Union for Progressive Judatsin. Rabbi Richard Hirsch is the new executive divector of the organization that plans to move its headouarters to Jerusalem.

The annual meeting of the Memorial Foundation for Jewish Culture opened here last night. It will continue through Thursday evening. The Memorial Foundation meeting was preceded by the annual meeting of the Conference on Jewish Material Claims Against Germany of which Dr. Goldmann is chairman. He reviewed the Claims Conference's activities over the past 20 years. A report was submitted by Dr. Joseph J. Schwartz, treasurer.

WON'T BE INTIMIDATED BY THREATS TO AIRLINE, PERES INSISTS

JERUSALEM, July 4 (JTA).—Transport Minister Shimon Peres said today that "Israel will not be intimidated by threats" to its air communications, "Anyone frightneed by one anonymous threat is just asking for more of the same," Peres declared. He referred to an anonymous warning to EI Al today, threatening its planes unless Kozo Okamoto, the Japanese gunman captured in the May 30 Lydda Airport massacre is freed.

The warning was sent to the International Air Transport Association (IATA) which conveyed it to El Al. But Israell airline officials said they were taking no special security measures beyond those aiready in effect. "We are doing all that is necessary aiready." an El Al spokesman said. Officials of other airlines said anonymous threats could harm tourism to Israel. There was no vistling change in the routine at Lydda Airport today where strict security measures have been maintained since the measures.

A Month After The Massacre LYDDA AIRPORT TRAFFIC BOOMS

TEL AVIV, July 4 (JTA)--Lydda Airport officials reported yesterday, little more than a month after the airport massacre, that traffic was booming. They said that some 7000 passengers landed in 37 planes, including five jumbo jets Sunday. Traffic was particularly heavy in the afternoon when three of the jumbo jets and one Boeing 707 landed one after another.

Despite the pressure of the huge inflow of arrivals and Israel's tight airport security measures, all of the passengers were able to leave the airport without undue delay, the officials reported. Average incoming total of passengers at the airport daily is about 6000. The peak was reached last Passover when 10,000 persons arrived. The outgoing passenger total also was a little higher than usual, partly because the summer school vacation has started and the summer excursions that accompany it.

POSTPONEMENT ASKED FOR CHIEF RABBINATE ELECTIONS

JERUSALEM, July 4 (JTA)--The Chief Rabbinate elections, scheduled to be held Aug. II, will have to be postponed for at least one or two months beyond that date. The elections committee established last mont to prepare for the balloting and to establish a 150-man electoral college, said today that it needed the extra time to complete its tasks. The committee is expected to ask the government to extend the terms of the incumbent chief rabbis for the required period. The only candidates for the post of Ashkenazic Chief Rabbi are the incumbent, Rabbi Yehuda Isser Uniterman and Chief Rabbi Shlomo Goren of Tel Aviy.

PANELISTS DIFFER OVER WHETHER JEWISH SELF-INTEREST LEADS TO ISOLATION

LOS ANGELES, July 4 (JTA) -- Panelists looking into the attitudes of the American Jewish community agreed here that American Jews are "turning inward" but differed sharply over whether this meant a trend toward Jewish self-isolation. The discussion took place during the annual plenary of the National Jewish Community Relations Advisory Council (NJCRAC) which closed over the week-

end, Rabbi Balfour Brickner, directer of inter-faith activities for the Union of American Hebrew Congregations, decried the "withdrawal mentality" which, he said, "concentrates only on Israel, Soviet Jews, Jewish education and similar issues which are considered survivalistic interests." He warned that this can push American Jewry "into an uncharacteristic posture of social and political conservatism." The Reform rabbi expressed concern that the Jewish community could "lose our youth" if an "hysterical approach" is left unchallenged to threaten Jewish life with "suicide by assimilation or introversion."

But Sidney Z. Vincent, executive director of the Jewish Community Federation of Cleveland, contended that by "turning inward," Jews are acting with enlightened self-interest. He claimed that becoming more Jewish does not mean a turn toward isolationism. "The best of our Jewishly committed young people have not resigned one whit of social vision," he declared,

He said that a consequence of the new trend is that Jewish institutions -- community centers, social service agencies and others -- "are being increasingly examined not only on technical excellence, but on their Jewish credentials."

Judge Jacob T. Zuckerman, president of the Jewish Labor Committee, saw the Jewish community "confused" and its leadership divided by a polarization between two versions of liberalism. One interprets liberalism in traditional terms of "equal treatment for all" while the new liberalism has relaxed the standard in favor of "preferential treatment" for disadvantaged groups, Judge Zuckerman said. He warned that "many Jews are part of Middle America" and would abandon the liberal movement "if we abandon our advocacy of equal justice."

CONGRESS URGED TO INVESTIGATE AFFIRMATIVE ACTION PROGRAM

Jewish Group Claims HEW Guidelines Result In Discrimination

NEW YORK, July 4 (JTA) -- The Jewish Rights Council is urging Congress to investigate whether the operation of the Affirmative Action program, under guidelines from the Department of Health Education and Welfare and other government bodies, is leading to quotas and discriminatory hiring and promotion policies in schools, civil service and corporate enterprises that benefit from government contracts.

The Council, which describes itself as "a national organization formed to defend the equality of rights for all persons under our laws," claimed that the program "has already led to policies in several universities and public school systems which have done harm to the merit system." At a meeting in the House of Representatives in Washington last week, spokesmen for the group detailed its concerns before an audience that included the entire Congressional delegation from New York City. The meeting was arranged with the assistance of Rep. Benjamin Rosenthal (D. NY).

A statement issued in behalf of the Council by

Profs. Seymour Siegel, president, and Edward M. Gershfield and Fritz A. Rothschild, member of the executive council, expressed the anxiety felt by the Jewish community over the threat of imposed racial and religious considerations in hiring. It said that Affirmative Action, as pursued by HEW "although sincerely motivated, cannot but lead to injustice" because "in favoring one group or individual, one necessarily harms an-

"A commitment to hire 15 percent of a certain minority as professors, might imply discrimination against other qualified applicants," the statement said, "As Jews, we remember only too well the tendency to favor white Protestants in admissions to colleges and universities and to tenured positions on university faculties. This unfairness is compounded by the fact that those who are bound to suffer are least responsible for the injustices that have hist rically been visited upon various minorities in our countries."

The statement noted that "Jews have traditionally fought for the merit system of hiring and promotion" and warned that "any attempt to tamper with that impartial system is de facto directed against the Jewish community, though it may not be so intended."

'YORDIM' IN CANADA DON'T PROSPER, REPORT SAYS

JERUSALEM, July 4 (JTA) -- Israelis who emigrated to Canada, mainly to improve their economic condition, by and large have failed to prosper, according to a report on "yordim" living in Canada, published in the current issue of the World Zionist Organization's quarterly magazine, "Batfutsot Hagola," According to Adam Ackerman, author of the report, 64 percent of the nearly 22,000 Israelis who settled in Canada have required Canadian government assistance and 16 percent have gone on welfare.

The report states that by 1964, 12,000 Israelis had emigrated to Canada and were followed by another 7000 during the two succeeding years which saw an economic recession in Israel. Since 1967, another 2500 Israelis have gone to live in Canada, But of the total now living in Canada, only ten percent were born in Israel, Ackerman reported. He said 52 percent cited economic reasons for their emigration and 56 percent said they did not contemplate returning to Israel. But 34 percent said they would go back if the government offered them the same incentives it offers new immigrants, Ackerman said.

JEWISH GROUPS HAIL DEATH PENALTY BAN BY U.S. SUPREME COURT

NEW YORK, July 4 (JTA) -- The American Jewish Congress and the Synagogue Council of America--which filed a joint friend-of-the-court brief in the case--have hailed the US Supreme Court's decision barring capital punishment as "consistent with Jewish tradition" and "a clear triumph for the standards of civilization and humaneness" inherent in the US Constitution.

In a joint statement, the Congress and the Synagogue Council -- which represents the major Orthodox, Conservative and Reform rabbinical and congregational bodies in the US--declared: "We have long and consistently believed, as Americans and as Jews, that capital punishment represented a violation of the Eighth Amendment's prohibition against 'cruel and unusual punishment.... The Supreme Court has expressed its agreement with that view. Moreover, in so doing, it has supported the Talmudic concern with human fallibility and the irreversible nature of capital punishment."
