8 MAJOR JEWISH GROUPS DEPLORE PARTISAN POLITICAL APPEALS TO JEWS BASED ON SINGLE ISSUE OF U.S. SUPPORT OF ISRAEL

NEW YORK, Aug. 31 (JTA).—The selection of American support for Israel as the predominent issue to win Jewish votes in the presidential election campaign was deplored by eight major Jewish organizations in a statement issued here today. Appeals "stating or suggesting that the votes of all or most Jews for parties or candidates will or should be determined by this consideration alone are a disservice to the nation and to Jewish voters," the statement declared.

Directed at both major political parties, the statement was released as the election campaign gained momentum with candidates laying their heaviest stress on Israel in addressing Jewish voters. It emphasized that Jews vote as individual Americans "on controversial and complex issues that are at stake in any election" and that Jewish interests influence Jewish voters just as other group interests influence members of other groups.

The organizations that signed the statement were the American Jewish Committee, American Jewish Committee, American Jewish Congress, Bran Brith Anti-Defamation League, Jewish Labor Committee, Jewish War Veterans, National Council of Jewish Women, Union of American Hebrew Congregations and the United Synagogue of America.

Jews Interested In Many Issues

They said "it is an error to assume that political endorsements by individuals identified as officers or members of an organization reflect the views of that organization or membership." The statement noted that US Middle East policy rests on "fundamental national interests of the US" and "has had bl-partisan support throughout Israel's history as a nation." The records of both major parties, it continued, "strongly support the expectation that, whatever the outcome of the election, the next administration will continue ... pursue that policy."

Acknowledging that "substantial unanimity exists" among Jews and Jewish organizations on the issue of US military, economic and political support for the security of the State of Israel, the statement noted that American Jews also "have a deep interest in the broad range of domestic and foreign politicies involved in the present campaign and, by the intensity of their participation, have demonstrated their concern for the entire spectrum of issues in American political life,"

The statement said some of the issues in which Jews demonstrate a vital interest are world peace, disarmament, economic distress, urban tension and anti-discrimination programs in housing, employment and education.

MOROCCAN JEWISH OIL EXECUTIVE WILLING TO GO BEFORE MOROCCAN COURT TO ANSWER CHARGES OF CORRUPTION

PARIS, Aug. 31 (JTA)—A Moroccan Jewish of accountive said today that he would appear voluntarily before a Moroccan court to answer charges of "foorruption and missppropriation of public funds." The charges were leveled against Paul Chana, director of the Moroccan-Italian oil

refining company, Samir, in Nov. 1971. Ohana has been living in Paris for the past few months. Accused along with him were his brother

Henri, and David Amar, former president of the Moroccan Jewish Community. Five former Moroccan government ministers implicated in the alleged scandal are being held in preventive detention in Morocco. All the persons involved except Ohana have already been heard by a Moroccan Judge.

Ohana has asked his lawyer, Jacques Sultan, to advise the Moroccan judicial authorities of his intention to appear. It was not known whether the judge would interrogate him personally or designate a commission for the tesk.

FAMILY OF SOVIET JEWS WHO PAID 'RANSOM' ARRIVE IN ISRAEL

TEL AVIV, Aug. 31 (JTA).—The first family of Russian Jews to pay the new fees levied on immigrants educated at the expense of the Soviet State arrived here today. Turia Goldberg of Vilna, said he paid 3100 rubles, the equivalent of \$3534, for a visa for his son Jacob, a second year engineering student at the university. Coldberg told reporters that the Russians gave him no receipt for the "ransom." "They take the money and hand over the visa and that's that," he said,

According to Goldberg, many Jewish academicians are paying the exhorbitant "diploma tax." He said a neighbor who is an engineer paid \$11,400 for his visa. He is expected in Israel in a few days. Frank Gordon, a journalist who travelled on the plane with the immigrants from Vienna, said at least 15 families in Riga have already paid thousands of rubles for their visas.

Mirs. Rivka Kagan of Czernowitz said that 30-50 Jewish academicians and their families there had received permission to leave Russia but their visas were withheld pending payment of the fees. Meanwhile, they have lost their jobs and "they are penniless and sit in their valiese with no hope of raising the huge sum of money demanded from them." she said.

The desperation of some Jews was illustrated by Chaim Lipkin a 79-year-old shoemaker who arrived here from Leningrad earlier this month, He declared today that he was prepared to go to London to donate one of his kidneys to raise the \$13,167 demanded by Soviet authorities for a visa for his son Vladimir, a construction engineer in Moscow, and his daughter-in-law, a bibliographer. Lipkin sald his son has no money.

A First In Canadian History JEWISH CANDIDATE DEFEATS OPPONENT TO BECOME PROVINCIAL PREMIER

VANCOUVER, B.C., Aug. 31 (JTA).—David Barrett, a 42-year-old former social worker, won a stunning victory here yesterday to become the new Premier of British Columbia. He is the first Jew in Canadian history to become a provincial premier.

Running on the New Democratic Party ticket,

Ruming on the New Democratic Party ticket, Barrett copped the election by a majority of 10,000 votes over his opponent in the Social Credit Party. The latter party had been in power for the last 20 years. Former executive director of Vancouver's Jewish Community Center and a contributor to Jewish causes, Barrett is fondly referred to as a barrel-chested, beer-drinking social reformist who speaks his mind. Het entered politics in 1960 after he was fired from his job at the Haney Correctional Institute here for criticizing Social Creditor correction policy. In September of that year Barrett won a seat in the B.C. Legislative Assembly and was subsequently re-elected in 1963, 1966 and 1969, when he became the Leader of the Oroposition.

Barrett, who received his bachelors degree from Seattle University and Masters of Social Work from St. Louis University, promised to "move British Columbia into a people's century." His victory was accompanied by a major shift of the majority of seats in the Assembly from the Social Credit Party to the New Democratic Party, which now has 39 percent of the seats in the legislative house.

ISRABLI MILITARY OFFICIALS DO NOT REGARD U.S. BASES IN GREECE AS VITAL TO NATION'S SECURITY, CHURCH SAYS

WASHINGTON, Aug. 31 J/TA)—Sen. Frank Church (D. Idaho) said today that Israeli military officers do not regard American naval bases in Greece "as vital to the security of Israel so long as the Sixth Fleet remains in the Mediterranean." Church, a member of the Senate Foreign Relations Committee, made that disclosure on his return from a five-day visit to Israel.

He said that Israel was "fully aware" that both President Nixon and his Democratic challenger, Sen. George McGovern "have pledged to keep the Sixth Fleet there" (in the Mediterranean).

The juxtaposition of Israel's security with US naval bases in Greece was injected into the Presidential campaign last month when Nixon stated at a press conference that without US aid to the regimes of Greece and Turkey "you have no viable policy to save Israel." The President made the remark in the context of plans to use Greece as the home port for destroyers of the US Sixth Fleet.

But Greece's Deputy Foreign Minister, Christian Xanthoplous-Palanas, promptly rejected any implication that Greece would serve as a basefor military aid to Israel. "Greece's friendly relations with the Arab world rule out any direct or indirect participation in any acts aimed at our Arab friends," he said.

McGovern contended last week that the planned US destroyer base in Greece was "jeopardizing our commitment to Israel" because of the Athens regime's friendship with Arab nations. Church said today that in his discussions with the Israeli military leaders "no anxiety was expressed over the retention" of American bases in Greece." He did not name the officers he spoke to.

ZIONISTS URGED TO MOBILIZE MASSIVE CAMPAIGN AGAINST SOVIET 'RANSOM' FEES

NEW YORK, Aug. 31 (JTA)—The Zionist Movement in the United States has been called upon by the American Zionist Federation to respond to the challenge posed by the recently stepped up exit fees demanded by the Soviet government for the emigration of educated Soviet Jews. The AZF urged an "immediate, massive campaigu" which will "demonstrate to the Soviet rulers in the Kremlin that this challenge will not so unmet."

In a directive sent to 500 Zionist leaders,
Rabbi Israel Miller, president of the AFF, called
upon them to launch an action program designed
to impress upon the Soviet leadership that there
will be no surrender to such acts of "blackmail."

The Zionist community leaders were instructed to organize a campaign involving all segments of the community and to work through city-wide Soviet Jewry committees where such groups exist. Where they do not exist, they were instructed to seek the participation of all Jewish groups in the community as well as Christian organizations and prominent Christian personalities.

Rabbi Miller, a member of the World Zionist Executive, also revealed that the Executive has called upon Zionist Federations in 40 countries to mount similar campaigns. The appeal sent by the World Movement called for Zionists everywhere "to give the struggle for the abolition of the ranson money imposed on Soviet Jews and their right for free aliya a central position in the activity of the Zionist Movement and Jewish organizations" in the weeks ahead.

KUNSTLER SEEKING TO GO TO USSR TO HELP GAVRIEL SHAPIRO TO GET OUT

NEW YORK, Aug. 31 (JTA)—William M, Kunster, the lawyer who defended the Chicago Seven and is identified with left-wing causes, announced today that he was seeking to travel to the Soviet Union to help Judy Shapiro in her effort to get her husband, Gavriel, out of that country.

Speaking at a news conference in his New York office, Kunstler said, "4 hope he influence I have in the Soviet Union will be brought to bear in this case." He said he plans to accompany Mrs. Shapiro to Moscow late October to attend her civil marriage ceremony to Gavriel and to help get him out.

Kunstler said he was taking up Mrs. Shapiro's cause because of its "humane appeal" and because he is against travel restrictions. Professing great admiration for socialist countries and left-wing tendencies, the lawyer said he had no specific contacts in the Soviet Union but: expressed hope that the authortities "will listen to me." He added, however, that he did not plan to take up the cause of Soviet Jewry in general. "Even though I'm Jewish, I'm not a professional Jew and I don't intend to spend time in that vein," he said.

Will Appeal To Angela Davis

Kunstler, who met Judy on a New York-California flight in early August, has sent a letter to Soviet Ambassador Anatoly Dobrynin asking him for permission to accompany Judy to Moscow. The letter, dated August 15, has not yet been answered, Nettuer has he received an affirmative reply for a visa application.

Released on his own cognizance pending trial in Chicago for charges against him as defense attorney in the Chicago Seven conspiracy trial, Kunstler was granted permission to travel to the Soviet Union by the US Court of Appeals.

"I hope that the Soviet Union will look favorably on Mr. Kunstler," said Mrs. Shapiro at the conference, "because he is on the right side." She said she was planning to send a telegram tonight to Angela Davis, presently in Moscow, asking her "as one woman to another" to assist her in freeing "my husband, who is a political prisoner."

A threatened teachers strike in Israel was averted today when the teachers' union agreed to a proposal by Deputy Premier and Education Minister Yigai Alion to set up a special committee to deal with their major outstanding grievance-overcrowded classrooms. Removal of the strike threat assured that Israell primary and secondary schools would open on schedule tomorrow for the fall term.

3 JEWISH GROUPS FILE PETITION CALLING FOR PROBE OF PUERTO RICAN EDUCATOR

NEW YORK, Aug. 31 (JTA)—Three national Jewish organizations, which have accused Luis Fuentes, a Puerto Rican educator, with anti-Semitic and other racist views, filed today a formal petition asking New York School Chancellor Harvey B, Scribner to investigate the appointment of Fuentes as community superintendent of School District One in Manhattan and his removal if the charges are substantiated.

The petition was filed by the Anti-Defamation League of B'nai B'rith, the American Jewish Congress and the Jewish Labor Committee. The American Jewish Committee, which had joined with the other three agencies last July 26 in protesting the Fuentes appointment to the decentralized school district on the Lower East Side, did not join in the petition to Sorthner.

The petition also accused the community school board in District One of "dereliction of duty" in the Fuentes appointment. The petition charged that the community school board had failed to investigate Fuentes' background and had discriminated on racial grounds against other applicants for the community superintendent's post.

The petition asked the removal of the local school board if an investigation substantiated these charges. The organizations had scoused Fuentes of openly blased remarks while he was an acting principal in the Ocean Hill-Brownsville demonstration school district in Brooklyn.

Clear Responsibility To Conduct Probe

Arnold Forster, ADL general counsel, speaking for the three agencies, said that after an evaluation of the state-approved school decentralization law for the city school system, the agencies were convinced that Sorthner had both the authority and the "clear responsibility" to make the investigation and to act against the local school board if the charges were found to be true.

The petition reiterated earlier charges that Fuentes had made public and private anti-Semitic statements, including one on May 2, 1970 at a Board of Education meeting. The petition charged that 56 educators had applied for the post; 33 white, II Black, 10 Puerto Rican, one Chinese and one of unknown ethnic background. It added that the board interviewed six of the applicants, none of them white, offering the post first to one of the Puerto Rican applicants who "for reasons unknown," declined it and Fuentes was then offered the \$37,000 a year post and accepted it on Jul 12.

The petition said that one Black applicant 'had outstanding qualifications for the position,' and asked Sorthner to determine why 'he and other well-qualified applicants were passed over and Fuentes selected.' Representatives of the Jewlah groups met with Sorthner on the issue and later were in touch with New York State Education Commissioner Ewald Nyquist, who told them he would investigate it city officials failed to take satisfactory action.

BRIDGE NAMED AFTER JEW WHO FOUGHT NAZI OCCUPATION OF HOLLAND

AMSTERDAM, Aug. 31 (JTA)—A bridge in the old Jewish quarter was named yesterday in honor of Walter Suesskind, a Dutoh Jew who saved hundred and adults from the Nazis, Suesskind, born of Dutoh-Jewish parents, settled in Berlin but returned to Amsterdam in 1938, During the German occupation of Holland he was able to rescue Jews who had been rounded up for deportation, with the help of Dutoh resistance groups. Suesskind's own wife and children died at Auschwitz.

FISH, 19 OTHER LAWMAKERS, TO SPONSOR RESOLUTION CONDEMNING EXIT VISA FEES

NEW YORK, Aug. 31 (JTA)—Rep. Hamilton Fish, 3r. (R.NY) said today he will introduce a sense-of-Congress resolution next Thursday, two days after the fall season begins, asserting that the Soviet Union and its leaders should be "condemned for creating a class of slaves in the 20th century" through imposition of high fees on educated emigrants,

In a telephone conversation with the Jewish Telegraphic Agency from his home in Millbrook upstate, Pish said the resolution "deplores this action" by the Soviets, which he called "ransom." The measure has 19 other co-sponsors.

Fish added that his "first order of business" on returning to Washington will be to "reevaluate our trade policy in the light of this action by the Soviet Union," with a view to possible American "reprisals." Asked to elaborate, he said that at this point his intention was just to "take a good hard look" at this country's trade agreements with the USSR.

The Congressman was scheduled to attend a meeting this afternoon in Harrison-routside his district—at the home of Ernest Goldblum, chairman of the Westchester Conference on South Jewry. He was to be formally commended there for participating in the April 30 Solidarity Dayrally in New York, for which support he has already received a plaque from the Greater New York Conference on Soviet Jewry.

700 SCIENTISTS APPEAL TO SOVIET FOR VISAS FOR TWO JEWISH SCIENTISTS.

LONDON, Aug. 31 (JTA)—Seven hundred prominent scientists of the United Kingdom, US and Western Europe have signed an appeal to the Soviet government for emigration visas for Prof. Benjamin Levich of Moscow and his son, Dr. Yevgeny Levich who wish to go to Israel with their families. The appeal was disclosed today at a press conference held at the Imperial College of Science by seven British scientists. They drew attention to Levich's plight since he applied for an exit visa and to his poor health. They said that 186 of the appeal's signatories are Fellows of the Royal Society.

MRS, KORENBLIT APPEALS FOR HUSBAND

WASHINGTON, Aug. 31 (JTA)—Mrs. Paulina Koreinblit, wife of Imprisoned Russian Jowish dentist Mikhail Korenblit, appealed on his behalf today to Dr. Irving Rothstein, president of the District of Columbia Dental Society. Dr. Rothstein said he would ask the Society to ask the American Dental Association to intercede with the International Red Cross and the United Nations Human Rights Commission. Korenblit is serving a seven-year term imposed in Leningrad,

Another hand grenade - the fourth in a week - was thrown early this morning in the Gaza Strip. It was aimed at a passing car near Dier el Nalah. The hand grenade missed. There were no caswalities. Police and security forces launched a search for the perpetrators.

JEWISH JOURNALIST ARRESTED, RELEASED

LONDON, Aug. 31 (JTA) -- Viktor Perelman, a Russian-Jewish journalist who was fired from the editorial staff of Moscow's Literaturnaya Gazeta after he applied for a visa to emigrate to Israel. was arrested in a Moscow street but released after a few hours when he refused to answer questions,

Jewish sources in the Soviet Union reported today. Perelman recently advised Jewish academicians not to pay the excessive visa fees recently levied on educated Jews seeking visas to emigrate. The sources reported that he was picked up in the street by police and taken to headquarters. They said he refused to sign a document that was incriminating or to answer questions of a personal nature which, he insisted, the police had no right to ask.

JEWISH GROUPS LAUNCH \$700,000 DRIVE TO AID JEWISH SCHOOL SYSTEM

BUENOS AIRES, Aug. 31 (JTA) -- The financial distress of Argentina's Jewish school system has led major Jewish organizations convening here to launch a drive to collect \$700,000. The system has lost more than 2000 pupils, despite a loan from an Israeli bank and grants from the Joint Distribution Committee and the Jewish Agency.

According to the JDC's 1971 annual report, the Jewish school situation "deteriorated" last year and "faced a financial crisis" -- largely from the "collapse of the community cooperatives," which contributed \$2 million a year to the system. At the time of the report there were 18,000 pupils in 45 Jewish schools in Argentina, which has 500,000 Jews, 80 percent of them in Buenos Aires.

The organizations meeting here were the Buenos Aires Kehilla, the Argentine Central Council for Jewish Education, the Argentine Zionist Organization and Horim, the association of parents of Jewish-school children. The new funds committee is co-chaired by Naum Katzowicz, Marcos Korenhendler and Miguel Wetstein,

MRS, SHAZAR'S CONDITION WORSENS

JERUSALEM, Aug. 31 (JTA) -- The condition of Mrs. Rachel Shazar, wife of President Zalman Shazar, worsened today according to information from Hadassah Hospital. A hospital spokesman reported that Mrs. Shazar was admitted July 28 after fracturing her hip in a fall while she and President Shazar were vacationing. The spokesman said her condition improved following surgery but took a turn for the worse several days ago.

HEINEMANN BELIEVES USSR TAKING POSITIVE STEPS TOWARD JEWISH EMIGRATION

BONN, Aug. 31 (JTA) -- West Germany's President Gustav Heinemann believes that the Soviet Union has taken a "positive attitude" toward Jewish emigration and that separated families will soon be re-united. Those sentiments were expressed on President Heinemann's behalf in a letter written by an aide, Prof. Fritz Caspari, to Mrs. Esther Markish. Prof. Caspari, who is deputy director of the President's office, assured Mrs. Markish of the President's concern for the fate of her family.

Mrs. Markish is the widow of the Jewish poet Peretz Markish who was murdered during the 1950s. She and her son, David, have been trying without success to emigrate to Israel where they have relatives. Their application for exit visas

Stalin purge of Jewish intellectuals in the early have been rejected repeatedly by Soviet author-Ities.

Prof. Caspari said in his letter the Dr. Heinemann "noted with deep concern the tragic fate of the Markish family but that the Soviet Union's recent positive attitude toward emigration has allowed many Jews to leave the country" and "all signs point to the fact that this positive development will continue."

SOLDIER WITH SIDELOCKS, UPBRAIDED Gets 10 Days In Brig. Apology

TEL AVIV. Aug. 31 (JTA) -- When the Israeli Army makes a mistake, the injured party receives an apology in writing. Such was the case of one soldier who was sentenced to 10 days in the brig for wearing sidelocks, according to the Army newspaper Bamachaneh. The soldier claimed he was religious. His commanding officer thought he was faking in order to evade regulations. After sentencing the man, it was discovered that he was Orthodox. The soldier was Promptly released and got a letter of apology from the CO.

RALLY HELD TO PROTEST USSR DISCRIMINATION AGAINST JEWS

LIMA, Aug. 31 (JTA) -- Some 100 Jewish Peruvians, mostly young persons and leaders of the Jewish community, staged a demonstration here today in front of the Soviet Embassy protesting Jewish discrimination in Russia and demanding to see the Soviet ambassador, Yuri Lebedev. But their efforts were thwarted as Embassy personnel closed the doors in their faces.

The demonstrators heard both the Sephardic and Ashkenazic rabbis pronounce prayers of liberation for Russian Jews. Youngsters sang "Hatikva" as they held up signs reading "No Enslavement of Intellectuals," "Human Rights for All" and "Wake Up Lenin, Russians Have Gone Crazy." They then threw leaflets reading "Let My People Go" plus their protest letters to the ambassador into the Embassy garden,

SPITZ ACCUSED OF HOLDING WRONG SHOES

LONDON, Aug. 31 (JTA) -- Mark Spitz, the American-Jewish swimming gold medalist, had no time to put on his shoes before last night's victory ceremonies at the Olympic Games in Munich. As a result, Soviet Olympic officials may file a protest. They claim that the shoes Spitz held before tv and news cameras were clearly identifiable as the product of a West German sporting goods firm." Their implication was that the swimming champ was promoting the brand. Officials in Munich were said to be certain that Spitz acted in all innocence.

Kenneth Treadway, manager of the US swimming team, said Spitz was "caught up in the rush" and had no time to put on his shoes. But the International Olympics Committee is particularly sensitive to the possibility of commercialism by Olympic athletes. Dr. Harold Henning, secretary of the International Swimming Federation, issued a memorandum forbidding the carrying of shoes to the victory podium.

Spitz has so far won three gold medals with record-setting performances in the 200-meter butterfly, 200-meter free style and the anchor leg on a world record 400-meter free style relay.

The National Insurance Institute in Jerusalem announced today that it has extended its coverage to compensate Arab workers from the administered territories who are injured by accidents or through terrorist activities on their way to jobs in Israel. MOROCCAN JEWISH OIL EXECUTIVE WILLING TO GO BEFORE MOROCCAN COURT TO ANSWER CHARGES OF CORRUPTION

PARIS, Aug. 31 (JTA)—A Moroccan Jewish of accountive said today that he would appear voluntarily before a Moroccan court to answer charges of "foorruption and missppropriation of public funds." The charges were leveled against Paul Chana, director of the Moroccan-Italian oil

refining company, Samir, in Nov. 1971. Ohana has been living in Paris for the past few months. Accused along with him were his brother

Henri, and David Amar, former president of the Moroccan Jewish Community. Five former Moroccan government ministers implicated in the alleged scandal are being held in preventive detention in Morocco. All the persons involved except Ohana have already been heard by a Moroccan Judge.

Ohana has asked his lawyer, Jacques Sultan, to advise the Moroccan judicial authorities of his intention to appear. It was not known whether the judge would interrogate him personally or designate a commission for the tesk.

FAMILY OF SOVIET JEWS WHO PAID 'RANSOM' ARRIVE IN ISRAEL

TEL AVIV, Aug. 31 (JTA).—The first family of Russian Jews to pay the new fees levied on immigrants educated at the expense of the Soviet State arrived here today. Turia Goldberg of Vilna, said he paid 3100 rubles, the equivalent of \$3534, for a visa for his son Jacob, a second year engineering student at the university. Coldberg told reporters that the Russians gave him no receipt for the "ransom." "They take the money and hand over the visa and that's that," he said,

According to Goldberg, many Jewish academicians are paying the exhorbitant "diploma tax." He said a neighbor who is an engineer paid \$11,400 for his visa. He is expected in Israel in a few days. Frank Gordon, a journalist who travelled on the plane with the immigrants from Vienna, said at least 15 families in Riga have already paid thousands of rubles for their visas.

Mirs. Rivka Kagan of Czernowitz said that 30-50 Jewish academicians and their families there had received permission to leave Russia but their visas were withheld pending payment of the fees. Meanwhile, they have lost their jobs and "they are penniless and sit in their valiese with no hope of raising the huge sum of money demanded from them." she said.

The desperation of some Jews was illustrated by Chaim Lipkin a 79-year-old shoemaker who arrived here from Leningrad earlier this month, He declared today that he was prepared to go to London to donate one of his kidneys to raise the \$13,167 demanded by Soviet authorities for a visa for his son Vladimir, a construction engineer in Moscow, and his daughter-in-law, a bibliographer. Lipkin sald his son has no money.

A First In Canadian History JEWISH CANDIDATE DEFEATS OPPONENT TO BECOME PROVINCIAL PREMIER

VANCOUVER, B.C., Aug. 31 (JTA).—David Barrett, a 42-year-old former social worker, won a stunning victory here yesterday to become the new Premier of British Columbia. He is the first Jew in Canadian history to become a provincial premier.

Running on the New Democratic Party ticket,

Ruming on the New Democratic Party ticket, Barrett copped the election by a majority of 10,000 votes over his opponent in the Social Credit Party. The latter party had been in power for the last 20 years. Former executive director of Vancouver's Jewish Community Center and a contributor to Jewish causes, Barrett is fondly referred to as a barrel-chested, beer-drinking social reformist who speaks his mind. Het entered politics in 1960 after he was fired from his job at the Haney Correctional Institute here for criticizing Social Creditor correction policy. In September of that year Barrett won a seat in the B.C. Legislative Assembly and was subsequently re-elected in 1963, 1966 and 1969, when he became the Leader of the Oroposition.

Barrett, who received his bachelors degree from Seattle University and Masters of Social Work from St. Louis University, promised to "move British Columbia into a people's century." His victory was accompanied by a major shift of the majority of seats in the Assembly from the Social Credit Party to the New Democratic Party, which now has 39 percent of the seats in the legislative house.

ISRABLI MILITARY OFFICIALS DO NOT REGARD U.S. BASES IN GREECE AS VITAL TO NATION'S SECURITY, CHURCH SAYS

WASHINGTON, Aug. 31 J/TA)—Sen. Frank Church (D. Idaho) said today that Israeli military officers do not regard American naval bases in Greece "as vital to the security of Israel so long as the Sixth Fleet remains in the Mediterranean." Church, a member of the Senate Foreign Relations Committee, made that disclosure on his return from a five-day visit to Israel.

He said that Israel was "fully aware" that both President Nixon and his Democratic challenger, Sen. George McGovern "have pledged to keep the Sixth Fleet there" (in the Mediterranean).

The juxtaposition of Israel's security with US naval bases in Greece was injected into the Presidential campaign last month when Nixon stated at a press conference that without US aid to the regimes of Greece and Turkey "you have no viable policy to save Israel." The President made the remark in the context of plans to use Greece as the home port for destroyers of the US Sixth Fleet.

But Greece's Deputy Foreign Minister, Christian Xanthoplous-Palanas, promptly rejected any implication that Greece would serve as a basefor military aid to Israel. "Greece's friendly relations with the Arab world rule out any direct or indirect participation in any acts aimed at our Arab friends," he said.

McGovern contended last week that the planned US destroyer base in Greece was "jeopardizing our commitment to Israel" because of the Athens regime's friendship with Arab nations. Church said today that in his discussions with the Israeli military leaders "no anxiety was expressed over the retention" of American bases in Greece." He did not name the officers he spoke to.

ZIONISTS URGED TO MOBILIZE MASSIVE CAMPAIGN AGAINST SOVIET 'RANSOM' FEES

NEW YORK, Aug. 31 (JTA)—The Zionist Movement in the United States has been called upon by the American Zionist Federation to respond to the challenge posed by the recently stepped up exit fees demanded by the Soviet government for the emigration of educated Soviet Jews. The AZF urged an "immediate, massive campaigu" which will "demonstrate to the Soviet rulers in the Kremlin that this challenge will not so unmet."

Kremlin that this challenge will not go unmet."
In a directive sent to 500 Zionist leaders,
Rabbi Israel Miller, president of the AFF, called
upon them to launch an action program designed
to impress upon the Soviet leadership that there
will be no surrender to such acts of "blackmail."

The Zionist community leaders were instructed to organize a campaign involving all segments of the community and to work through city-wide Soviet Jewry committees where such groups exist. Where they do not exist, they were instructed to seek the participation of all Jewish groups in the community as well as Christian organizations and prominent Christian personalities.

Rabbi Miller, a member of the World Zionist Executive, also revealed that the Executive has called upon Zionist Federations in 40 countries to mount similar campaigns. The appeal sent by the World Movement called for Zionists everywhere "to give the struggle for the abolition of the ranson money imposed on Soviet Jews and their right for free aliya a central position in the activity of the Zionist Movement and Jewish organizations" in the weeks ahead.

KUNSTLER SEEKING TO GO TO USSR TO HELP GAVRIEL SHAPIRO TO GET OUT

NEW YORK, Aug. 31 (JTA)—William M, Kunster, the lawyer who defended the Chicago Seven and is identified with left-wing causes, announced today that he was seeking to travel to the Soviet Union to help Judy Shapiro in her effort to get her husband, Gavriel, out of that country.

Speaking at a news conference in his New York office, Kunstler said, "4 hope he influence I have in the Soviet Union will be brought to bear in this case." He said he plans to accompany Mrs. Shapiro to Moscow late October to attend her civil marriage ceremony to Gavriel and to help get him out.

Kunstler said he was taking up Mrs. Shapiro's cause because of its "humane appeal" and because he is against travel restrictions. Professing great admiration for socialist countries and left-wing tendencies, the lawyer said he had no specific contacts in the Soviet Union but: expressed hope that the authortities "will listen to me." He added, however, that he did not plan to take up the cause of Soviet Jewry in general. "Even though I'm Jewish, I'm not a professional Jew and I don't intend to spend time in that vein," he said.

Will Appeal To Angela Davis

Kunstler, who met Judy on a New York-California flight in early August, has sent a letter to Soviet Ambassador Anatoly Dobrynin asking him for permission to accompany Judy to Moscow. The letter, dated August 15, has not yet been answered, Nettuer has he received an affirmative reply for a visa application.

Released on his own cognizance pending trial in Chicago for charges against him as defense attorney in the Chicago Seven conspiracy trial, Kunstler was granted permission to travel to the Soviet Union by the US Court of Appeals.

"I hope that the Soviet Union will look favorably on Mr. Kunstler," said Mrs. Shapiro at the conference, "because he is on the right side." She said she was planning to send a telegram tonight to Angela Davis, presently in Moscow, asking her "as one woman to another" to assist her in freeing "my husband, who is a political prisoner."

A threatened teachers strike in Israel was averted today when the teachers' union agreed to a proposal by Deputy Premier and Education Minister Yigai Alion to set up a special committee to deal with their major outstanding grievance-overcrowded classrooms. Removal of the strike threat assured that Israell primary and secondary schools would open on schedule tomorrow for the fall term.

3 JEWISH GROUPS FILE PETITION CALLING FOR PROBE OF PUERTO RICAN EDUCATOR

NEW YORK, Aug. 31 (JTA)—Three national Jewish organizations, which have accused Luis Fuentes, a Puerto Rican educator, with anti-Semitic and other racist views, filed today a formal petition asking New York School Chancellor Harvey B, Scribner to investigate the appointment of Fuentes as community superintendent of School District One in Manhattan and his removal if the charges are substantiated.

The petition was filed by the Anti-Defamation League of B'nai B'rith, the American Jewish Congress and the Jewish Labor Committee. The American Jewish Committee, which had joined with the other three agencies last July 26 in protesting the Fuentes appointment to the decentralized school district on the Lower East Side, did not join in the petition to Sorthner.

The petition also accused the community school board in District One of "dereliction of duty" in the Fuentes appointment. The petition charged that the community school board had failed to investigate Fuentes' background and had discriminated on racial grounds against other applicants for the community superintendent's post.

The petition asked the removal of the local school board if an investigation substantiated these charges. The organizations had scoused Fuentes of openly blased remarks while he was an acting principal in the Ocean Hill-Brownsville demonstration school district in Brooklyn.

Clear Responsibility To Conduct Probe

Arnold Forster, ADL general counsel, speaking for the three agencies, said that after an evaluation of the state-approved school decentralization law for the city school system, the agencies were convinced that Sorthner had both the authority and the "clear responsibility" to make the investigation and to act against the local school board if the charges were found to be true.

The petition reiterated earlier charges that Fuentes had made public and private anti-Semitic statements, including one on May 2, 1970 at a Board of Education meeting. The petition charged that 56 educators had applied for the post; 33 white, II Black, 10 Puerto Rican, one Chinese and one of unknown ethnic background. It added that the board interviewed six of the applicants, none of them white, offering the post first to one of the Puerto Rican applicants who "for reasons unknown," declined it and Fuentes was then offered the \$37,000 a year post and accepted it on Jul 12.

The petition said that one Black applicant 'had outstanding qualifications for the position,' and asked Sorthner to determine why 'he and other well-qualified applicants were passed over and Fuentes selected.' Representatives of the Jewlah groups met with Sorthner on the issue and later were in touch with New York State Education Commissioner Ewald Nyquist, who told them he would investigate it city officials failed to take satisfactory action.

BRIDGE NAMED AFTER JEW WHO FOUGHT NAZI OCCUPATION OF HOLLAND

AMSTERDAM, Aug. 31 (JTA)—A bridge in the old Jewish quarter was named yesterday in honor of Walter Suesskind, a Dutoh Jew who saved hundred and adults from the Nazis, Suesskind, born of Dutoh-Jewish parents, settled in Berlin but returned to Amsterdam in 1938, During the German occupation of Holland he was able to rescue Jews who had been rounded up for deportation, with the help of Dutoh resistance groups. Suesskind's own wife and children died at Auschwitz.

FISH, 19 OTHER LAWMAKERS, TO SPONSOR RESOLUTION CONDEMNING EXIT VISA FEES

NEW YORK, Aug. 31 (JTA)—Rep. Hamilton Fish, 3r. (R.NY) said today he will introduce a sense-of-Congress resolution next Thursday, two days after the fall season begins, asserting that the Soviet Union and its leaders should be "condemned for creating a class of slaves in the 20th century" through imposition of high fees on educated emigrants,

In a telephone conversation with the Jewish Telegraphic Agency from his home in Millbrook upstate, Pish said the resolution "deplores this action" by the Soviets, which he called "ransom." The measure has 19 other co-sponsors.

Fish added that his "first order of business" on returning to Washington will be to "reevaluate our trade policy in the light of this action by the Soviet Union," with a view to possible American "reprisals." Asked to elaborate, he said that at this point his intention was just to "take a good hard look" at this country's trade agreements with the USSR.

The Congressman was scheduled to attend a meeting this afternoon in Harrison-routside his district—at the home of Ernest Goldblum, chairman of the Westchester Conference on South Jewry. He was to be formally commended there for participating in the April 30 Solidarity Dayrally in New York, for which support he has already received a plaque from the Greater New York Conference on Soviet Jewry.

700 SCIENTISTS APPEAL TO SOVIET FOR VISAS FOR TWO JEWISH SCIENTISTS.

LONDON, Aug. 31 (JTA)—Seven hundred prominent scientists of the United Kingdom, US and Western Europe have signed an appeal to the Soviet government for emigration visas for Prof. Benjamin Levich of Moscow and his son, Dr. Yevgeny Levich who wish to go to Israel with their families. The appeal was disclosed today at a press conference held at the Imperial College of Science by seven British scientists. They drew attention to Levich's plight since he applied for an exit visa and to his poor health. They said that 186 of the appeal's signatories are Fellows of the Royal Society.

MRS, KORENBLIT APPEALS FOR HUSBAND

WASHINGTON, Aug. 31 (JTA)—Mrs. Paulina Koreinblit, wife of Imprisoned Russian Jowish dentist Mikhail Korenblit, appealed on his behalf today to Dr. Irving Rothstein, president of the District of Columbia Dental Society. Dr. Rothstein said he would ask the Society to ask the American Dental Association to intercede with the International Red Cross and the United Nations Human Rights Commission. Korenblit is serving a seven-year term imposed in Leningrad,

Another hand grenade - the fourth in a week - was thrown early this morning in the Gaza Strip. It was aimed at a passing car near Dier el Nalah. The hand grenade missed. There were no caswalities. Police and security forces launched a search for the perpetrators.

Defense Minister Moshe Dayan predicted last night that President Sadat would try to muster pressure on Israel from Europe and said he did not see the possibility of an early peace settlement with Arab states. Addressing 200 UJA leaders from the US, Dayan said Sadat would also try to generate pressure on Israel from the US. but would wait until after the Presidential elections.

JEWISH JOURNALIST ARRESTED, RELEASED

LONDON, Aug. 31 (JTA) -- Viktor Perelman, a Russian-Jewish journalist who was fired from the editorial staff of Moscow's Literaturnaya Gazeta after he applied for a visa to emigrate to Israel. was arrested in a Moscow street but released after a few hours when he refused to answer questions,

Jewish sources in the Soviet Union reported today. Perelman recently advised Jewish academicians not to pay the excessive visa fees recently levied on educated Jews seeking visas to emigrate. The sources reported that he was picked up in the street by police and taken to headquarters. They said he refused to sign a document that was incriminating or to answer questions of a personal nature which, he insisted, the police had no right to ask.

JEWISH GROUPS LAUNCH \$700,000 DRIVE TO AID JEWISH SCHOOL SYSTEM

BUENOS AIRES, Aug. 31 (JTA) -- The financial distress of Argentina's Jewish school system has led major Jewish organizations convening here to launch a drive to collect \$700,000. The system has lost more than 2000 pupils, despite a loan from an Israeli bank and grants from the Joint Distribution Committee and the Jewish Agency.

According to the JDC's 1971 annual report, the Jewish school situation "deteriorated" last year and "faced a financial crisis" -- largely from the "collapse of the community cooperatives," which contributed \$2 million a year to the system. At the time of the report there were 18,000 pupils in 45 Jewish schools in Argentina, which has 500,000 Jews, 80 percent of them in Buenos Aires.

The organizations meeting here were the Buenos Aires Kehilla, the Argentine Central Council for Jewish Education, the Argentine Zionist Organization and Horim, the association of parents of Jewish-school children. The new funds committee is co-chaired by Naum Katzowicz, Marcos Korenhendler and Miguel Wetstein,

MRS, SHAZAR'S CONDITION WORSENS

JERUSALEM, Aug. 31 (JTA) -- The condition of Mrs. Rachel Shazar, wife of President Zalman Shazar, worsened today according to information from Hadassah Hospital. A hospital spokesman reported that Mrs. Shazar was admitted July 28 after fracturing her hip in a fall while she and President Shazar were vacationing. The spokesman said her condition improved following surgery but took a turn for the worse several days ago.

HEINEMANN BELIEVES USSR TAKING POSITIVE STEPS TOWARD JEWISH EMIGRATION

BONN, Aug. 31 (JTA) -- West Germany's President Gustav Heinemann believes that the Soviet Union has taken a "positive attitude" toward Jewish emigration and that separated families will soon be re-united. Those sentiments were expressed on President Heinemann's behalf in a letter written by an aide, Prof. Fritz Caspari, to Mrs. Esther Markish. Prof. Caspari, who is deputy director of the President's office, assured Mrs. Markish of the President's concern for the fate of her family.

Mrs. Markish is the widow of the Jewish poet Peretz Markish who was murdered during the 1950s. She and her son, David, have been trying without success to emigrate to Israel where they have relatives. Their application for exit visas

Stalin purge of Jewish intellectuals in the early have been rejected repeatedly by Soviet author-Ities.

Prof. Caspari said in his letter the Dr. Heinemann "noted with deep concern the tragic fate of the Markish family but that the Soviet Union's recent positive attitude toward emigration has allowed many Jews to leave the country" and "all signs point to the fact that this positive development will continue."

SOLDIER WITH SIDELOCKS, UPBRAIDED Gets 10 Days In Brig. Apology

TEL AVIV. Aug. 31 (JTA) -- When the Israeli Army makes a mistake, the injured party receives an apology in writing. Such was the case of one soldier who was sentenced to 10 days in the brig for wearing sidelocks, according to the Army newspaper Bamachaneh. The soldier claimed he was religious. His commanding officer thought he was faking in order to evade regulations. After sentencing the man, it was discovered that he was Orthodox. The soldier was Promptly released and got a letter of apology from the CO.

RALLY HELD TO PROTEST USSR DISCRIMINATION AGAINST JEWS

LIMA, Aug. 31 (JTA) -- Some 100 Jewish Peruvians, mostly young persons and leaders of the Jewish community, staged a demonstration here today in front of the Soviet Embassy protesting Jewish discrimination in Russia and demanding to see the Soviet ambassador, Yuri Lebedev. But their efforts were thwarted as Embassy personnel closed the doors in their faces.

The demonstrators heard both the Sephardic and Ashkenazic rabbis pronounce prayers of liberation for Russian Jews. Youngsters sang "Hatikva" as they held up signs reading "No Enslavement of Intellectuals," "Human Rights for All" and "Wake Up Lenin, Russians Have Gone Crazy." They then threw leaflets reading "Let My People Go" plus their protest letters to the ambassador into the Embassy garden,

SPITZ ACCUSED OF HOLDING WRONG SHOES

LONDON, Aug. 31 (JTA) -- Mark Spitz, the American-Jewish swimming gold medalist, had no time to put on his shoes before last night's victory ceremonies at the Olympic Games in Munich. As a result, Soviet Olympic officials may file a protest. They claim that the shoes Spitz held before tv and news cameras were clearly identifiable as the product of a West German sporting goods firm." Their implication was that the swimming champ was promoting the brand. Officials in Munich were said to be certain that Spitz acted in all innocence.

Kenneth Treadway, manager of the US swimming team, said Spitz was "caught up in the rush" and had no time to put on his shoes. But the International Olympics Committee is particularly sensitive to the possibility of commercialism by Olympic athletes. Dr. Harold Henning, secretary of the International Swimming Federation, issued a memorandum forbidding the carrying of shoes to the victory podium.

Spitz has so far won three gold medals with record-setting performances in the 200-meter butterfly, 200-meter free style and the anchor leg on a world record 400-meter free style relay.

The National Insurance Institute in Jerusalem announced today that it has extended its coverage to compensate Arab workers from the administered territories who are injured by accidents or through terrorist activities on their way to jobs in Israel. Currently only workers inside Israel proper are entitled to compensation for injuries suffered on their way to work,
