ISRAELI TEAM TO INVESTIGATE SECURITY LAPSES IN MUNICH

JERUSALEM, Sept. 13 (JTA)--Premier Golda Meir will set up an investigating team this week to examine the whole Munich episode and decide whether there were Israeli security lapses. The team will also make recommendations to the Cabinet.

Mrs. Meir rejected the opposition's demand for an I-party inquiry commission, and also rejected a suggestion from a Cabinet minister that a commission of inquiry, manned by laymen with a judge as chairman, should be set up. The majority of the Cabinet felt, according to high placed sources, that only people with experience in the security field: would get to the bottom of the events.

The problem, however, is to ensure that an inquiry commissioned by the government and staffed by government employes will feel free to criticize the government itself, or any governmental bodies, if it sees the need to do so. Mrs. Melr is reportedly taking her time over appointing the inquiry to make sure this problem is solved. She is expected to make the appointment before the week's end.

TUNISIAN JEW, ACCUSED OF ZIONIST ESPIONAGE, FACES TRIAL

PARIS, Sept. 13 (JTA)--A 25-year-old Tunisian Jew, Rene Marzouk, accused of Zionist espionage, spreading Zionist propaganda, and belonging to an illegal group, is to appear Sept. 16 before a special Tunisian court dealing with acts against the State. It is the first time in Tunisia that a Jew has been officially accused of espionage and Zionist activities.

The 8000 Jews presently living there view this new attitude with concern, especially since Marzouk, far from being a Zionist, belongs to the "Marxist Circle," one of the four underground opposition groups operating against the government,

Marzouk, an English teacher in a southern Tunisian high school, was arrested on Feb. 12 during a protest movement which erupted in the school following the arrest for subversive activities and the subsequent expulsion to France of Mrs. Simone Lellouch, a Jewish woman married to Ben Othman, an Arab. An anti-Zionist campaign was begun and supported by certain government ministers including Communications Minister Mohamed Savah.

ed Sayah. SECURITY MEASURES BEEFED UP TO GUARD JEWISH, ISRAELI INSTITUTIONS, JTA

PARIS, Sept. 13 (JTA).—French police have imposed top security measures to guard Jewish and Israeli institutions in France against possible Arabatacks. Special precautions have been taken in the vicinity of synagogues and public halls used now for High Holiday services. Jewish schools and cultural and communal centers are also granted special police protection.

Two policemes: have been assigned to guard the building in which the Jewish Telegraphic Agency European bureau in Paris is located. This building also houses the Fonds Social Juff Unifie (FSJU, United Jewish Social Service Fund) and the French United Jewish Appeal. It is understood that none of the Jewish organizations asked for these measures which were taken at the initiative

of the local authorities. Israeli Embassy and Israeli institutions are also guarded on a 24hour basis. DAYAN: TERROR NOT MILITARY THREAT

MONTREAL, Sept. 13 (JTA)--Israel's Defense Minister Moshe Dayan declared last night that Arab governments have resorted to terrorism because they are unwilling to make peace and unable to make war. He added that the use of Arab terror is not a military threat to Israel and will achieve no results. Dayan made a one-day visit to Montreal to inaugurate the 1972 combined Jewish Appeal and Israel Emergency Fund. He addressed two meetings during the course of the day and answered questions on the Middle East situation.

In his view, the Russian withdrawal from Egypt was the result of a basic Soviet decision to avoid getting more deeply involved in the Middle East war and to avoid a possible clash with the United States. He said Israel was happy with this development because it meant the removal of the risk of clashing with Soviet combat units.

Dayan described Israel's present strength as resulting from three factors; her faith in her cause, the practical implementation of that faith in building the country and absorbing immigrants, and her ability to defend herself while maintaining a normal existence. Part of this faith, he concluded, stemmed from the support extended to Israel by Jewish communities abroad and their identification with her progress and security.

ISRAELI ENVOYS TO PROTEST VOTE FOR 3-POWER RESOLUTION IN SECURITY COUNCIL

JERUSALEM, Sept. 13 (JTA)--Officials disclosed here today that Israeli ambassadors in all Western states which are members of the United Nations Security Council have been instructed to protest to the governments for their support of the three-power resolution introduced in the Security Council last Sunday. The United States vetoed the Somalia-Guinea-Yugoslavia resolution because it failed to mention the slayings of the II Israeli athletes at Munich in calling on all Middle East states to halt immediately all military action.

Michael Comay, the Israell envoy to Britain, will meet tomorrow with Sir Aleo Douglas Home, the British Foreign Scoretary in London. Israeli envoys in Paris, Rome, Brussels, Tokyo and Buenos Aires also have been ordered to raise the issue with those governments. Comay has been instructed to discuss with Sir Aleo his "clearing" of Egypt from any responsibility for the Munich slayings, the officials here said.

100 JEWS RENOUNCE SOVIET CITIZENSHIP

LONDON, Sept. 18 (17A)—Jewish sources in the Soviet Union reported today that 100 Jews have publicly renounced their citizenship as a protest against what they termed "the failure of the Soviet government to denounce or even condemn the Munich outrage."

BELGIUM PROTESTS USSR EXIT FEES

BRUSSELS, Sept. 13 (JTA).-The Belgian government has officially protested the Soviet exit charges for Jewish scientists as "a direct attack

against the fundamental liberty of man to choose for himself." The protest was included in a message from Prime Minister Gaston Eyskens to the Belgian section of the World Jewish Congress which met here last night to protest the exit fee increases.

The Prime Minister declared that "the Belgian government joins in the protests arising throughout the world against the new dispositions of the Soviet government in regard to Jewish university graduates who wish to emigrate." He also declared that the Belgian government had raised the issue with Soviet authorities and intended to "examine with its European partners the opportunity of bringing up this question during the United Nations General Assembly discussions."

(Officials in Jerusalem expressed deep satisfaction today with Eyskens' statement. The Israeli officials had been concerned about the danger that the protests against the Soviet high fees would lose momentum because of the slaying of the II Israeli athletes at Munich. They said they felt the Belgian Prime Minister's stand indicated that the issue was still the object of condemnation by world leaders.)

Speakers at the meeting, including Jean Rey. Minister of State, and Baron Pierre Wigny, former Foreign Affairs Minister, branded the new situation for Soviet emigrants as creating "a slave market" which violated the Soviet Constitution. The speakers stressed that it was racism and not the Soviet Union they were condemning.

Before the meeting, some 5000 persons demonstrated in the streets, chanting such slogans as "USSR, Free the Soviet Jews." About 100 security guards were assigned to protect the demonstrators but there were no incidents. The demonstration was organized by the Coordinating Committee of Belgian Jewish Organizations.

MITTERAND PLANNING SOVIET VISIT

COPENHAGEN, Sept. 13 (JTA)--French Socialist Party leader Francois Mitterand told the Jewish Telegraphic Agency today that he planned to go to the Soviet Union even though his presence was unwanted there because of his support for Soviet Jews seeking emigration visas. Mitterand, who is visiting Deumark for Common Market talks with Premier Gens Otto Krag, addressed a press conference here. He refused to comment further on his position regarding the exorbitant visa fees Soviet authorities demand from educated Jews sceking to emigrate.

He said his position was made plain in his open letter to Piotr Abrasimov, the Soviet Ambassador to France. As a result of that letter supporting Soviet Jews, Moscow called off Mitterand's visit in November as the head of a delegation of French Socialists and Communists.

The Socialist leader said his party opposed the French government's policy of continuing to arms embargy against israel while continuing to sell arms to Arab countries such as Libya, "if France is going to sell weapons, it should sell them to both sides in the conflict," he said. He noted that France was not friendly to Israeli attempts to strengthen its ties with the Common Market.

TAX CUTS FOR 40,000 ISRAELIS

JERUSALEM, Sept. 13 (JTA)—Treasury officials said today that about 40,000 Israelis will be removed from the income tax rolls as a result of changes scheduled next year in Israel's income tax law. They said the revisions, planned to take effect as early as next April, will benefit hundred of tho)sands of taxpayers by increasing their take-home pay by smaller tax deductions.

The officials said the main beneficiaries would

be low-income Israelis who now pay a minimum tax and wage earners in the IL 1500-2000 category in annual earnings. Under the revisions, a worker with two children will start paying taxes on monthly earnings over IL 574 instead of IL 483 monthly as at present. A worker with four ocildren would not pay taxes unless his earnings were at least IL 805 a month. He currently pays no taxes if his income is less than IL 686 a month

Finance Ministry economists said the changes would cost IL 400 million in revenue annually but that revenue from remaining taxpayers would grow as the tax base was broadened and collection of overdue tax payments stepped up. Finance Minister Pinhas Sapir reportedly strongly supports the revisions because they will ease the burden on low-income workers and encourage middle-income earners to work overtime, a practice which they feel is not worth the effort under the present tax structure.

U.S. WILL NOT PRESS FOR LANSKY'S EXTRADITION

WASHINGTON, Sept. 13 (JTA)—The US government wants to put Meyer Lansky on trial for tax evasion and contempt of court but apparently will not press Israel to extradite the 70-year-old reputed gangland boss. This was indicated yesterday by State Department spokesman Charles Bray who said the US could not do much formally to bring about Lansky's extradition. He said the charges against Lansky are not an extraditable offense under the US-israel treaty of 1962.

Bray discussed the issue following a ruling by the israell Supreme Court in Jerusalem Monday upholding the government's decision to expel Lansky. The Israel government, however, promised Lansky a laissez passer that would allow him to go to any country willing to receive him.

His US passport was revoked.

(In Jerusalem today, Lansky told reporters that he was "at a lose" about what to do or to go as a result of the Supreme Court ruling. He said he did not know how long he would be permitted to remain in Israel and could think of no country to go to. "A Jew has a slim chance in the world," he said.)

HIGH VISA FEES WILL PREVENT 70% OF JEWISH COLLEGE GRADUATES FROM LEAVING

JERUSALEM, Sept. 12 (JTA)--Three Jewish families who arrived from the Soviet Union this week said that 70 percent of the Jewish college graduates who want to emigrate to Israel will be prevented from doing so because of the exorbitant visa fees demanded from Jews who received a higher education in the USSR. The families, Feidman, Moseson and Spiers, said they each paid 5000 rubies, the equivalent of \$5500, for their visas. The fees were relatively low because the family heads did their studying at a night school.

A Dutch member of Amnesty International who recently visited the Soviet Union claimed that the high visa fees are in fact encouraging more Russian Jews to emigrate. In a letter to Mrs. Bella Ravdin, the Israeli representative of the Londonbased organization that aids political prisoners. the Dutch member reported that even Jews who had not contemplated emigration are now considering it.

He said Jews who are completing their studies in Russia find it difficult to get jobs because prospective employers ask "Why should I engage you? You will emigrate after a short time," the Dutch official wrote.

U.S. PRAISES WEST EUROPEAN POWERS' EFFORTS IN SECURITY COUNCIL VOTE

WASHINGTON, Sept. 13 (JTA).—A State Department spokesman officially dissociated the department from a statement made by a senior department official, which called the British and French support Sunday of the UN Security Council Resolution "unconscionable." "That is not a word I would use here," department spokesman Charles Bray said today. "Their votes were cast in light of the judgments of their governments." The US, casting its second veto in UN history, voted against the resolution, which called for an immediate halt in Middle East military activities, but did not mention the killing of II Israeli (Jumpio athletes.

Bray explained that the US had worked with the Council's Western European members—Eritain, France, Italy and Belgium—to amend "what we regarded as a one-sided resolution that failed to draw a clear link between Munich and the events in the (Middle East) area." Britain had attempted to introduce an amendment to the three-power resolution which deplored "deeply all acts of terrorism and violence and all breaches of the cease-fire in the Middle East." The three other Western European powers supported this amendment, but did not receive a majority vote. The amendment effort, Bray stated, was "a constructive effort on the part of Western Europe."

General Assembly To Discuss Terrorism

In New York, a spokesman for the British Mission to the UN called reports that the US was dissatisfied with the British vote on the resolution "surprising and uncalled for." He retierated the statement made at the Security Council by British Ambassador Sir Colin Crowe, that while the amendment would have made the resolution more "realistic," his delegation could not fail to support a call for an end to military operations and for restraint.

Meanwhile, UN Secretary General Kurt Waldheim said that on his own initiative he has introduced the issue of terrorism for discussion at the General Assembly session, which opens next week. Waldheim also said he believed "we have to do everything possible to find a solution to the Middle East problem" and added that UN Middle East mediator, Dr. Gunnar V. Jarring would be present at the General Assembly session "to be available, as he has done in the past,"

A UN spokesman announced today that tight security measures will be initiated in readiness for the opening session of the General Assembly. Additional security guards will be deployed to check all people entering the United Nations grounds.

AMIN'S STATEMENT ASSAILED

WASHINGTON, Sept. 13 (JTA).—State Department spokesman Charles Bray said today that if the statement of President Idi Amin of Uganda praising Ritler for having murdered six million Jews and calling for all Jews to be removed from the Middle East had been correctly reported, "obviously one has to deplore them." He added he could not comment on a question as to whether Uganda was receiving eccnomic aid from the United States.

In New York, a United Nations spokesman said that Secretary General Kurt Waldheim had not received any communication from Amin. The 'Iganda President had reportedly handed his vitriolic statement to a UN official in Uganda for delivery to Waldheim.

Meanwhile, Jewish leaders urged the US and

UN to condemn Amin's statement. The Anti-Defamation League of B'nai B'rith called upon President Nixon "to direct the United States ambassador to the United Nations to seek immediately a revolution censuring Uganda for its President's outrageously obscene statement."

In a telegram to Nixon, Seymour Graubard, national ADL chairman, sata: "The United Nations came into being as a result of World War II. For Uganda, a member nation, to now praise Hitler and the genocide of six million Jews is a ludicrous perversion of the founding principles of the United Nations which call for peace and the elimination of haired, bigotry and prejudice."

The president of B'nai B'rith District 1 called on the UN Human Rights Commission to condemn that "immoral and reprehensible statement" by Amin. In a telegram to the Human Rights Commission, Dr. Elliot N. Rosenberg, District 1 President, called upon the UN Commission on Human Rights "to take whatever steps are within its power to condemn such despicable fullminations which are in violation of the fundamental principles upon which the UN rests and which are an insult to all humanity."

The Jewish Labor Committee and the Workmen's Circle also blasted Annin's statement. In
a message to Waldheim, Jacob T. Zuckerman,
president of the Jewish Labor Committee, called
on the UN to "take action against terrorism throughout the world--the moment for temporizing has
past." Harold Ostroff, president of the Workmen's Circle, in a telegram to Scoretary of State
William P. Rogers, called on the US to protest
the Amin statement.

600 AT CAMPUS MEMORIAL SERVICE FOR 11 OLYMPIANS

WEST LAFAYETTE, Ind., Sept. 13 (JTA)--Some 600 students, faculty members and residents of West Lafayette attended a campus-wide memorial service at Purdue University for the slain II Israeli athletes. A portion of the service was held outdoors. It was addressed by Arthur Hansen, university president, who expressed grief over the "senseless act." Bob Ford, a former Purdue basketball star, was one of the 150 members of the university's athletic department who attended. He said, "I feel defeat tonight. We were here and could do nothing."

Rain began to fall, ruining efforts to kindle ll candles for the dead athletes. The service was then moved to a university building where the candle lighting ceremony was completed. Rabbi Gerald Engel, Purdue Hillel director, led the planning for the event, which also included a letter to President Nixon and a petition to the Senate. The letters urged that United States officials apearhead an international effort to persuade all governments to take official action against any nation providing asylum for terrorists.

An American demand for British cooperation in combatting terrorism will be discussed in talks between Dr. Henry Kissinger and British Prime Minister Edward Heath, it was reliably learned in London today. Dr. Kissinger arrives in London tomorrow from Moscow.

Yaacov Shimshon Shapiro was sworn in by the Knesset as Minister of Justice yesterday three months after he resigned that portfolio smid a controversy over allegedly excessive legal fees approved by his ministry. Two motions of non-confidence introduced by opposition factions that opposed Shapiro's reappointment were decisively defeated by the Knesset.

BEHIND THE HEADLINES

PROPAGANDA OFFENSIVE AGAINST TERRORISM By ROBERT SLATER.

JERUSALEM, Sept. 13 (JTA) -- While Israeli jets pounded terrorist bases in Syria and Lebanon last weekend, the Israeli government was quietly mounting an information offensive designed to point out the depth of Arab terrorism. Lengthy pamphlets have quickly been put together and background briefings for foreign newsmen have been arranged, all atming to bring into sharp focus the methods that the terrorists employ. The single common theme that runs through the thousands of words now being written and spoken by Israeli information specialists is that the Arab governments are directly linked to the terrorist groups.

Foreign Ministry sources place a large measure of blame on the Egyptian government for the endurance of Arab terrorist organizations. These stores are convinced that Egypt could, if it wished to, place a vise on terrorist operations at a moment's notice. The murder of the Il Israelis at the Olympic Games in Munich last Tuesday revived Israeli anger at the new international face of Arab terrorism. The most potent force is a relatively new international organization called Black September.

As far as Israel is concerned, it is both naive and a mistake to think of Black September as a separate entity apart from the El Fatah terrorist organization, spearheaded by Yasser Arafat. Arafat has placed great hopes on legitimizing his El Fatah group by broadening its ties with national governments outside the Arab world. Israelis theorize that Black September was created to perform the heimous deeds of El Fatah without besmirching El Fatah's name within the international community.

Terrorist Concentration In Syria

The Lebanese government, according to Foreign Ministry sources, continues to give succor to the 5000 terrorists residing in its territory under terms of the 1986 "Cairo agreement." According to these sources, Lebanon once tried to limit the scope of terrorism within its borders, but the Egyptians would have none of this and forced the agreement on her. Syria, with 9000 terrorists, has the largest terrorist concentration among the Arab states. According to Israeli sources, the terrorist groups have grown increasingly more dependent upon Syria, especially after they were thrown out of Jordan two years ago.

The question of financing the terrorist organizations has been hazy, but Foreign Ministry sources say that much of the backing comes from Kuwatt, Saudi Arabia and lately Libya. Israeli sources say they are reasonably convinced that the Popular Front for the Liberation of Palestine, headquartered in Beirut, has been living off all or a large part of the \$5 million ransom which they reportedly received from the West German government to free a hilacked Luthansa siriliner.

With the need to go "international" clearly spelled out for them, the members of the Black September have been busy recruiting non-terror-ist personnel to assist them in their cause. Thus, say Israell sources, the new thrust of Israell policy must be to convince foreign governments, especially in Western Europe, to force the terrorists out of their countries. Foreign Ministry sources point to Turkey and Switzerland as the two countries that have thus far shown some signs of oracking down on foreign terrorists.

MASTERMIND OF TERRORISM IDENTIFIED

TEL AVIV, Sept. 18 (JTA).—Salah Halaf Abu Ayyad, a 42-year-old Jaffa-born teacher, reputedly the No. 2 man in El Fatah, was identified by informed sources here today as the "master-mind" of the terrorist atrocities committed by the Black September group, an El Fatah offshoot. The Black Septembrists were responsible for the murder of 11 Iaraeli Olympic athletes in Munich

last week and other recent outrages.

The Israeli sources said he worked for some time as a teacher in Kuwait and later joined Yasser Arafat in organizing El Fatah, the largest of the Palestinian terrorist organizations. During the Sept. 1970 clashes in Jordan, Ayyad was captured by the Jordanian Army but released after he signed a terrorist cease-fire order. He then went to Betrut where he resumed his activities. The sources said his name has not appeared in terrorist news bulletins recently, indicating that he has gone underground for conspiracy purposes.

LINK TUNISIA WITH MUNICH TERRORISTS

TEL AVIV, Sept. 13 (JTA).—Israeli political circles claimed today that there were indications of a link between Tunisia and the Arab terrorists who murdered II Israeli Olympians in Munich. The circles also said there was evidence of a change in Tunisia's hitherto moderate position on the Middle East conflict.

They referred to reports that the terrorists who invaded the Israeli compound in Olympic Village used walky-talky radios to communicate with an unidentified Tunisian "colonel." They also noted that Tunisia offered to receive the terrorists and their Israeli hostages and was later ready to accept the bodies of the five terrorists slain by German police. The circles noted that the Tunisian delegation led the funeral procession for the terrorists.

SYNAGOGUE VANDALISM HOOLIGAN ACT

LONDON, Sept. 13 (JTA).—An incident of vandalism at an East End synapogue yesterday was dismissed as "a minor act of hooliganism" by a spokesman for the Federation of Synapogues today. The spokesman told the Jewish Telegraphic Agency that it was "probably the act of a drunk who tossed a stone through a window."

The broken window pane was discovered at the Great Synagoue on Fieldgate Street in Stepney several hours after memorial services were conducted for the II Israeli Olympic athletes slain in Munich. The spokesman indicated, however, that there was no apparent link between the vandalism and the services. "The police as well as ourselves, assume that it was what is known as a minor act of hooliganism," he said.

PARATROOPERS MASSED AT AIRPORT

BRUSSELS, Sept. 18 (JTA).—The Ministry of Defense has ordered a company of 150 paratroopers to Brussels International Airport to Insure against possible terrorist attacks, the Defense Ministry announced yesterday. It said it ordered the commando unit to be permanently stationed at the airport, in addition to the 150 sual security guards, at the request of the Ministry of the Interior. The Minister of Interior is due to appear before a Senate commission tomorrow and explain some of the security measures which Belgium intends to impose throughout the country.

A Gaza military tribunal passed life sentences today on two 23-year-old terrorists convicted of murdering members of a rival terrorist group.

MONTREAL, Sept. 13 (JTA)--Israel's Defense Minister Moshe Dayan declared last night that Arab governments have resorted to terrorism because they are unwilling to make peace and unable to make war. He added that the use of Arab terror is not a military threat to Israel and will achieve no results. Dayan made a one-day visit to Montreal to inaugurate the 1972 combined Jewish Appeal and Israel Emergency Fund. He addressed two meetings during the course of the day and answered questions on the Middle East situation.

In his view, the Russian withdrawal from Egypt was the result of a basic Soviet decision to avoid getting more deeply involved in the Middle East war and to avoid a possible clash with the United States. He said Israel was happy with this development because it meant the removal of the risk of clashing with Soviet combat units.

Dayan described Israel's present strength as resulting from three factors; her faith in her cause, the practical implementation of that faith in building the country and absorbing immigrants, and her ability to defend herself while maintaining a normal existence. Part of this faith, he concluded, stemmed from the support extended to Israel by Jewish communities abroad and their identification with her progress and security.

ISRAELI ENVOYS TO PROTEST VOTE FOR 3-POWER RESOLUTION IN SECURITY COUNCIL

JERUSALEM, Sept. 13 (JTA)--Officials disclosed here today that Israeli ambassadors in all Western states which are members of the United Nations Security Council have been instructed to protest to the governments for their support of the three-power resolution introduced in the Security Council last Sunday. The United States vetoed the Somalia-Guinea-Yugoslavia resolution because it failed to mention the slayings of the II Israeli athletes at Munich in calling on all Middle East states to halt immediately all military action.

Michael Comay, the Israell envoy to Britain, will meet tomorrow with Sir Aleo Douglas Home, the British Foreign Scoretary in London. Israeli envoys in Paris, Rome, Brussels, Tokyo and Buenos Aires also have been ordered to raise the issue with those governments. Comay has been instructed to discuss with Sir Aleo his "clearing" of Egypt from any responsibility for the Munich slayings, the officials here said.

100 JEWS RENOUNCE SOVIET CITIZENSHIP

LONDON, Sept. 18 (17A)—Jewish sources in the Soviet Union reported today that 100 Jews have publicly renounced their citizenship as a protest against what they termed "the failure of the Soviet government to denounce or even condemn the Munich outrage."

BELGIUM PROTESTS USSR EXIT FEES

BRUSSELS, Sept. 13 (JTA).-The Belgian government has officially protested the Soviet exit charges for Jewish scientists as "a direct attack

against the fundamental liberty of man to choose for himself." The protest was included in a message from Prime Minister Gaston Eyskens to the Belgian section of the World Jewish Congress which met here last night to protest the exit fee increases.

The Prime Minister declared that "the Belgian government joins in the protests arising throughout the world against the new dispositions of the Soviet government in regard to Jewish university graduates who wish to emigrate." He also declared that the Belgian government had raised the issue with Soviet authorities and intended to "examine with its European partners the opportunity of bringing up this question during the United Nations General Assembly discussions."

(Officials in Jerusalem expressed deep satisfaction today with Eyskens' statement. The Israeli officials had been concerned about the danger that the protests against the Soviet high fees would lose momentum because of the slaying of the II Israeli athletes at Munich. They said they felt the Belgian Prime Minister's stand indicated that the issue was still the object of condemnation by world leaders.)

Speakers at the meeting, including Jean Rey. Minister of State, and Baron Pierre Wigny, former Foreign Affairs Minister, branded the new situation for Soviet emigrants as creating "a slave market" which violated the Soviet Constitution. The speakers stressed that it was racism and not the Soviet Union they were condemning.

Before the meeting, some 5000 persons demonstrated in the streets, chanting such slogans as "USSR, Free the Soviet Jews." About 100 security guards were assigned to protect the demonstrators but there were no incidents. The demonstration was organized by the Coordinating Committee of Belgian Jewish Organizations.

MITTERAND PLANNING SOVIET VISIT

COPENHAGEN, Sept. 13 (JTA)--French Socialist Party leader Francois Mitterand told the Jewish Telegraphic Agency today that he planned to go to the Soviet Union even though his presence was unwanted there because of his support for Soviet Jews seeking emigration visas. Mitterand, who is visiting Deumark for Common Market talks with Premier Gens Otto Krag, addressed a press conference here. He refused to comment further on his position regarding the exorbitant visa fees Soviet authorities demand from educated Jews sceking to emigrate.

He said his position was made plain in his open letter to Piotr Abrasimov, the Soviet Ambassador to France. As a result of that letter supporting Soviet Jews, Moscow called off Mitterand's visit in November as the head of a delegation of French Socialists and Communists.

The Socialist leader said his party opposed the French government's policy of continuing to arms embargy against israel while continuing to sell arms to Arab countries such as Libya, "if France is going to sell weapons, it should sell them to both sides in the conflict," he said. He noted that France was not friendly to Israeli attempts to strengthen its ties with the Common Market.

TAX CUTS FOR 40,000 ISRAELIS

JERUSALEM, Sept. 13 (JTA)—Treasury officials said today that about 40,000 Israelis will be removed from the income tax rolls as a result of changes scheduled next year in Israel's income tax law. They said the revisions, planned to take effect as early as next April, will benefit hundred of tho)sands of taxpayers by increasing their take-home pay by smaller tax deductions.

The officials said the main beneficiaries would

be low-income Israelis who now pay a minimum tax and wage earners in the IL 1500-2000 category in annual earnings. Under the revisions, a worker with two children will start paying taxes on monthly earnings over IL 574 instead of IL 483 monthly as at present. A worker with four ocildren would not pay taxes unless his earnings were at least IL 805 a month. He currently pays no taxes if his income is less than IL 686 a month

Finance Ministry economists said the changes would cost IL 400 million in revenue annually but that revenue from remaining taxpayers would grow as the tax base was broadened and collection of overdue tax payments stepped up. Finance Minister Pinhas Sapir reportedly strongly supports the revisions because they will ease the burden on low-income workers and encourage middle-income earners to work overtime, a practice which they feel is not worth the effort under the present tax structure.

U.S. WILL NOT PRESS FOR LANSKY'S EXTRADITION

WASHINGTON, Sept. 13 (JTA)—The US government wants to put Meyer Lansky on trial for tax evasion and contempt of court but apparently will not press Israel to extradite the 70-year-old reputed gangland boss. This was indicated yesterday by State Department spokesman Charles Bray who said the US could not do much formally to bring about Lansky's extradition. He said the charges against Lansky are not an extraditable offense under the US-israel treaty of 1962.

Bray discussed the issue following a ruling by the israell Supreme Court in Jerusalem Monday upholding the government's decision to expel Lansky. The Israel government, however, promised Lansky a laissez passer that would allow him to go to any country willing to receive him.

His US passport was revoked.

(In Jerusalem today, Lansky told reporters that he was "at a lose" about what to do or to go as a result of the Supreme Court ruling. He said he did not know how long he would be permitted to remain in Israel and could think of no country to go to. "A Jew has a slim chance in the world," he said.)

HIGH VISA FEES WILL PREVENT 70% OF JEWISH COLLEGE GRADUATES FROM LEAVING

JERUSALEM, Sept. 12 (JTA)--Three Jewish families who arrived from the Soviet Union this week said that 70 percent of the Jewish college graduates who want to emigrate to Israel will be prevented from doing so because of the exorbitant visa fees demanded from Jews who received a higher education in the USSR. The families, Feidman, Moseson and Spiers, said they each paid 5000 rubies, the equivalent of \$5500, for their visas. The fees were relatively low because the family heads did their studying at a night school.

A Dutch member of Amnesty International who recently visited the Soviet Union claimed that the high visa fees are in fact encouraging more Russian Jews to emigrate. In a letter to Mrs. Bella Ravdin, the Israeli representative of the Londonbased organization that aids political prisoners. the Dutch member reported that even Jews who had not contemplated emigration are now considering it.

He said Jews who are completing their studies in Russia find it difficult to get jobs because prospective employers ask "Why should I engage you? You will emigrate after a short time," the Dutch official wrote.

U.S. PRAISES WEST EUROPEAN POWERS' EFFORTS IN SECURITY COUNCIL VOTE

WASHINGTON, Sept. 13 (JTA).—A State Department spokesman officially dissociated the department from a statement made by a senior department official, which called the British and French support Sunday of the UN Security Council Resolution "unconscionable." "That is not a word I would use here," department spokesman Charles Bray said today. "Their votes were cast in light of the judgments of their governments." The US, casting its second veto in UN history, voted against the resolution, which called for an immediate halt in Middle East military activities, but did not mention the killing of II Israeli (Jumpio athletes.

Bray explained that the US had worked with the Council's Western European members—Eritain, France, Italy and Belgium—to amend "what we regarded as a one-sided resolution that failed to draw a clear link between Munich and the events in the (Middle East) area." Britain had attempted to introduce an amendment to the three-power resolution which deplored "deeply all acts of terrorism and violence and all breaches of the cease-fire in the Middle East." The three other Western European powers supported this amendment, but did not receive a majority vote. The amendment effort, Bray stated, was "a constructive effort on the part of Western Europe."

General Assembly To Discuss Terrorism

In New York, a spokesman for the British Mission to the UN called reports that the US was dissatisfied with the British vote on the resolution "surprising and uncalled for." He retierated the statement made at the Security Council by British Ambassador Sir Colin Crowe, that while the amendment would have made the resolution more "realistic," his delegation could not fail to support a call for an end to military operations and for restraint.

Meanwhile, UN Secretary General Kurt Waldheim said that on his own initiative he has introduced the issue of terrorism for discussion at the General Assembly session, which opens next week. Waldheim also said he believed "we have to do everything possible to find a solution to the Middle East problem" and added that UN Middle East mediator, Dr. Gunnar V. Jarring would be present at the General Assembly session "to be available, as he has done in the past,"

A UN spokesman announced today that tight security measures will be initiated in readiness for the opening session of the General Assembly. Additional security guards will be deployed to check all people entering the United Nations grounds.

AMIN'S STATEMENT ASSAILED

WASHINGTON, Sept. 13 (JTA).—State Department spokesman Charles Bray said today that if the statement of President Idi Amin of Uganda praising Ritler for having murdered six million Jews and calling for all Jews to be removed from the Middle East had been correctly reported, "obviously one has to deplore them." He added he could not comment on a question as to whether Uganda was receiving eccnomic aid from the United States.

In New York, a United Nations spokesman said that Secretary General Kurt Waldheim had not received any communication from Amin. The 'Iganda President had reportedly handed his vitriolic statement to a UN official in Uganda for delivery to Waldheim.

Meanwhile, Jewish leaders urged the US and

UN to condemn Amin's statement. The Anti-Defamation League of B'nai B'rith called upon President Nixon "to direct the United States ambassador to the United Nations to seek immediately a revolution censuring Uganda for its President's outrageously obscene statement."

In a telegram to Nixon, Seymour Graubard, national ADL chairman, sata: "The United Nations came into being as a result of World War II. For Uganda, a member nation, to now praise Hitler and the genocide of six million Jews is a ludicrous perversion of the founding principles of the United Nations which call for peace and the elimination of haired, bigotry and prejudice."

The president of B'nai B'rith District 1 called on the UN Human Rights Commission to condemn that "immoral and reprehensible statement" by Amin. In a telegram to the Human Rights Commission, Dr. Elliot N. Rosenberg, District 1 President, called upon the UN Commission on Human Rights "to take whatever steps are within its power to condemn such despicable fullminations which are in violation of the fundamental principles upon which the UN rests and which are an insult to all humanity."

The Jewish Labor Committee and the Workmen's Circle also blasted Annin's statement. In
a message to Waldheim, Jacob T. Zuckerman,
president of the Jewish Labor Committee, called
on the UN to "take action against terrorism throughout the world--the moment for temporizing has
past." Harold Ostroff, president of the Workmen's Circle, in a telegram to Scoretary of State
William P. Rogers, called on the US to protest
the Amin statement.

600 AT CAMPUS MEMORIAL SERVICE FOR 11 OLYMPIANS

WEST LAFAYETTE, Ind., Sept. 13 (JTA)--Some 600 students, faculty members and residents of West Lafayette attended a campus-wide memorial service at Purdue University for the slain II Israeli athletes. A portion of the service was held outdoors. It was addressed by Arthur Hansen, university president, who expressed grief over the "senseless act." Bob Ford, a former Purdue basketball star, was one of the 150 members of the university's athletic department who attended. He said, "I feel defeat tonight. We were here and could do nothing."

Rain began to fall, ruining efforts to kindle ll candles for the dead athletes. The service was then moved to a university building where the candle lighting ceremony was completed. Rabbi Gerald Engel, Purdue Hillel director, led the planning for the event, which also included a letter to President Nixon and a petition to the Senate. The letters urged that United States officials apearhead an international effort to persuade all governments to take official action against any nation providing asylum for terrorists.

An American demand for British cooperation in combatting terrorism will be discussed in talks between Dr. Henry Kissinger and British Prime Minister Edward Heath, it was reliably learned in London today. Dr. Kissinger arrives in London tomorrow from Moscow.

Yaacov Shimshon Shapiro was sworn in by the Knesset as Minister of Justice yesterday three months after he resigned that portfolio smid a controversy over allegedly excessive legal fees approved by his ministry. Two motions of non-confidence introduced by opposition factions that opposed Shapiro's reappointment were decisively defeated by the Knesset.

BEHIND THE HEADLINES

PROPAGANDA OFFENSIVE AGAINST TERRORISM By ROBERT SLATER.

JERUSALEM, Sept. 13 (JTA) -- While Israeli jets pounded terrorist bases in Syria and Lebanon last weekend, the Israeli government was quietly mounting an information offensive designed to point out the depth of Arab terrorism. Lengthy pamphlets have quickly been put together and background briefings for foreign newsmen have been arranged, all atming to bring into sharp focus the methods that the terrorists employ. The single common theme that runs through the thousands of words now being written and spoken by Israeli information specialists is that the Arab governments are directly linked to the terrorist groups.

Foreign Ministry sources place a large measure of blame on the Egyptian government for the endurance of Arab terrorist organizations. These stores are convinced that Egypt could, if it wished to, place a vise on terrorist operations at a moment's notice. The murder of the Il Israelis at the Olympic Games in Munich last Tuesday revived Israeli anger at the new international face of Arab terrorism. The most potent force is a relatively new international organization called Black September.

As far as Israel is concerned, it is both naive and a mistake to think of Black September as a separate entity apart from the El Fatah terrorist organization, spearheaded by Yasser Arafat. Arafat has placed great hopes on legitimizing his El Fatah group by broadening its ties with national governments outside the Arab world. Israelis theorize that Black September was created to perform the heimous deeds of El Fatah without besmirching El Fatah's name within the international community.

Terrorist Concentration In Syria

The Lebanese government, according to Foreign Ministry sources, continues to give succor to the 5000 terrorists residing in its territory under terms of the 1986 "Cairo agreement." According to these sources, Lebanon once tried to limit the scope of terrorism within its borders, but the Egyptians would have none of this and forced the agreement on her. Syria, with 9000 terrorists, has the largest terrorist concentration among the Arab states. According to Israeli sources, the terrorist groups have grown increasingly more dependent upon Syria, especially after they were thrown out of Jordan two years ago.

The question of financing the terrorist organizations has been hazy, but Foreign Ministry sources say that much of the backing comes from Kuwatt, Saudi Arabia and lately Libya. Israeli sources say they are reasonably convinced that the Popular Front for the Liberation of Palestine, headquartered in Beirut, has been living off all or a large part of the \$5 million ransom which they reportedly received from the West German government to free a hilacked Luthansa siriliner.

With the need to go "international" clearly spelled out for them, the members of the Black September have been busy recruiting non-terror-ist personnel to assist them in their cause. Thus, say Israell sources, the new thrust of Israell policy must be to convince foreign governments, especially in Western Europe, to force the terrorists out of their countries. Foreign Ministry sources point to Turkey and Switzerland as the two countries that have thus far shown some signs of oracking down on foreign terrorists.

MASTERMIND OF TERRORISM IDENTIFIED

TEL AVIV, Sept. 18 (JTA).—Salah Halaf Abu Ayyad, a 42-year-old Jaffa-born teacher, reputedly the No. 2 man in El Fatah, was identified by informed sources here today as the "master-mind" of the terrorist atrocities committed by the Black September group, an El Fatah offshoot. The Black Septembrists were responsible for the murder of 11 Iaraeli Olympic athletes in Munich

last week and other recent outrages.

The Israeli sources said he worked for some time as a teacher in Kuwait and later joined Yasser Arafat in organizing El Fatah, the largest of the Palestinian terrorist organizations. During the Sept. 1970 clashes in Jordan, Ayyad was captured by the Jordanian Army but released after he signed a terrorist cease-fire order. He then went to Betrut where he resumed his activities. The sources said his name has not appeared in terrorist news bulletins recently, indicating that he has gone underground for conspiracy purposes.

LINK TUNISIA WITH MUNICH TERRORISTS

TEL AVIV, Sept. 13 (JTA).—Israeli political circles claimed today that there were indications of a link between Tunisia and the Arab terrorists who murdered II Israeli Olympians in Munich. The circles also said there was evidence of a change in Tunisia's hitherto moderate position on the Middle East conflict.

They referred to reports that the terrorists who invaded the Israeli compound in Olympic Village used walky-talky radios to communicate with an unidentified Tunisian "colonel." They also noted that Tunisia offered to receive the terrorists and their Israeli hostages and was later ready to accept the bodies of the five terrorists slain by German police. The circles noted that the Tunisian delegation led the funeral procession for the terrorists.

SYNAGOGUE VANDALISM HOOLIGAN ACT

LONDON, Sept. 13 (JTA).—An incident of vandalism at an East End synapogue yesterday was dismissed as "a minor act of hooliganism" by a spokesman for the Federation of Synapogues today. The spokesman told the Jewish Telegraphic Agency that it was "probably the act of a drunk who tossed a stone through a window."

The broken window pane was discovered at the Great Synagoue on Fieldgate Street in Stepney several hours after memorial services were conducted for the II Israeli Olympic athletes slain in Munich. The spokesman indicated, however, that there was no apparent link between the vandalism and the services. "The police as well as ourselves, assume that it was what is known as a minor act of hooliganism," he said.

PARATROOPERS MASSED AT AIRPORT

BRUSSELS, Sept. 18 (JTA).—The Ministry of Defense has ordered a company of 150 paratroopers to Brussels International Airport to Insure against possible terrorist attacks, the Defense Ministry announced yesterday. It said it ordered the commando unit to be permanently stationed at the airport, in addition to the 150 sual security guards, at the request of the Ministry of the Interior. The Minister of Interior is due to appear before a Senate commission tomorrow and explain some of the security measures which Belgium intends to impose throughout the country.

A Gaza military tribunal passed life sentences today on two 23-year-old terrorists convicted of murdering members of a rival terrorist group.
