JEWISH LEADERS, MEETING WITH NIXON EXPRESS CONFIDENCE IN PRESIDENT'S HANDLING OF SOVIET JEWISH EMIGRATION. Nixon Says Diplomatic Channels, Not Demagoguery, Is Correct Way To Deal With This Issue

NEW YORK, Sept. 27 (JTA)--President Nixon met yesterday for 45 minutes with 32 American Jowish leaders to tell them that he was working through diplomatic channels over the plight of Soviet Jews who have been denied exit visas. According to Presidential press secretary Ronald L. Ziegler, Nixon informed the Jewish leaders, all of whom have publicly identified themselves as his supporters for re-election, that he does not want to "politicize" or "demagogue about" the matter or "inject it into public debate" or "engage in harsh confrontation," with either the Soviet leaders or Presidential campaign rivals.

Ziegler told newmen at a press conference at the Commodore Hotel shortly after Nixon met with the Jewish leaders at the Waldorf-Astoria that an extensive public debate on the issue of exit visas would "only serve to be counterproductive." He added, in response to a question, that he meant counterproductive to Soviet Jewish interests. Asked if diplomatic channels were in fact being used, he replied; "The Soviet Union is aware of the United States view in this matter and I don't

want to go any further."

The Presidential press secretary said that the Jewish leaders "expressed concern" about the imposition of heavy exit fees on educated Soviet Jews seeking emigration, but voiced "nothing but confidence" in Nixon's handling of the matter. Ziegler reported that Nixon prefers to deal with the exit tax matter through "diplomatic channels," and the Soviet leadership has been "aware of our views for some time," Ziegler continued.

No Imposed Settlement In Mideast

At the meeting with the Jewish leaders, Nixon "understood the deep feelings about the (emigration) matter and indeed shared the human concern involved," Ziegler reported. He said in response to questions that neither Nixon nor the Jewish leaders raised the question of the amendment proposed by Sen. Abraham A. Riblooff (D. Conn.), making the projected US-USSR trade deal contingent on elimination of the exit fees.

Ziegler said Nixon also assured the Jewish leaders that the US would "under no circumstances impose a settlement in the Middle East"; that the administration was "committed to the survival of the State of Israel (and) the strength of Israel'; that the US would continue to "make available the assistance to Israel (necessary to) maintain her strength," and that the "strong US presence in the Mediterranean" would be maintained.

The Jewish leaders attending included, Max Fisher, Dr. William Wexler, Samuel Rothberg, Mrs. Rita Hauser, Leonard Goldine, Lawrence Goldberg, Jacques Torczyner, Rabbi Herschel Schacter, Rabbi Seymour Siegel, Meshulem Riklis, Rabbi Gollbert Klaperman, Herman Weisman, Rabbi Ronald Greenwald, Melvin Dubinsky, and Rabbi Solomon Sharfman. Six other leaders who were invited to attend the meeting with Nixon in addition to the 35 who did, were reported out of the country or unavailable. They included Joseph Meyerhoff, Louis Boyar and Tatt Schreiber.

Jewish Leaders Impressed With Nixon

Fisher told the JTA from Detroit today that "the President made it clear that he's not going to use this (Soviet Jewy issue) for political capital, and I think this is quite correct." Calling Nixon "very forthright" on the matter, Fisher said he was "convinced" the President was trying to "help" Soviet Jews. On the question of anti-Semitism in the USSR, Fisher noted that this has existed for many more years than Nixon has been President.

Rothberg, chairman of Israel Bond Organization, said that he was deeply impressed by the President's statement of his commitment to support israel. "Nixon was very, very serious," he said. Rabbi Schacter said "I was very impressed. Everything he (Nixon) had to say on Israel was very firm and unequivocal. On Soviet Jewry he was equally forceful." Nixon, Rabbi Schacter said, told the Jewish leaders that he did not want to make a political issue of this because the Soviet Union would slam the door on emigration.

Rabbi Siegel, professor at the Jewish Theological Seminary, seid he was "very impressed" with Nixon's stance, including the caution that the Soviets would "lock the door" on Jews seeking to emigrate if the US government pressured the Kremiin publicly. Rabbi Siegel said Nixon deplored the Munich massacre, and spoke "extremely warmly" of Israel and its courage and of his personal commitment to Israel's security.

McGovern Aide Rapped For Position On Israel

Prior to the press conference, a representative from the New York Committee to Re-Elect the President, distributed a copy of an article that appeared in a newspaper, "Hatchet," a publication of a student society at George Washington University in Washington, D.C., which carried a headline, "Gary Hart: Israeli Raids Wrong." The article, signed by Mark Nadler, editor-in-chief, stated that Hart, Sen, George McGovern's campaign manager, in response to a question, told a crowd of 500 students at the university on Sept. 19 that McGovern should condemn Israel for its recent retaliatory raids on Lebanon. "I don't know whether he (MeGovern) has or not, but he should have condemned Israel," Nadler reported Hart said.

Hart, in a letter to the editor which appeared in "Hatchet" a week later, stated that in response to a question concerning the failure of the political community to condemn "the killings of a large number of Lebanese civilians during those raids... I suggested that Senator McGovern has condemned and would continue to condemn, any military action which resulted in the killing of innocent, unarmed non-combatants. The question of whether the raids themselves, directed against guerrilla camps on the Lebanese border, were justified was never raised, and therefore never responded to,"

An unsigned editorial in the student newspaper, defended its treatment of Hart's speech and noted that his letter "clarified but did not alter the substance of his original remarks." The editorial stated further that Hart "made an unfortunate statement of great news value and that's the way we treated it."

SENATE COMMITTEE CUTS AID TO SOVIE EMIGRES: NO MENTION OF LIMITING TRADE

WASHINGTON, Sept. 27 (JTA) -- The Senate Appropriations Committee today reported out a foreign aid bill that makes no mention of limiting trade relations with the Soviet Union over the Soviet Jewry issue and also reduced the amount of federal government aid for the resettlement of Soviet emigres to \$50 million

The Committee, headed by Sen. John McClelland (D., Ark.) was reported to have accepted the subcommittee's recommendations to eliminate the provision of trade limitation that was made part of the House legislation last Thursday, on the initiative of Rep. Charles E. Vanik (D. Ohio). That provision would bar Export-Import Bank assistance or federal government insurance on private investments for any country which charged more than \$50 for a person to emigrate.

The Appropriations Committee, however, approved the House bill's figure of \$50 million for use by the State Department to help countries giving haven to Soviet emigrants. In practical terms this would be mainly for Israel which is taking virtually all Soviet emigrants, the vast majority of whom are Jewish. The Senate Committee accepted the House version on aid to American schools and hospitals abroad which is understood to mean a contribution of about \$3-4 million to institutions in Israel.

Since the Senate authorization bill on foreign aid has not yet been signed into law, the Appropriations Committee "deferred" action on appropriating funds for military assistance. In this instance, however, it is understood that no bar will be put against credit sales of up to \$300 million for Israel along with a grant of \$50 million to Israel in economic supporting assistance. These figures were included in the House bill. In overall funding, the Senate measure is slightly in excess of the \$4.2 billion voted by the House for the fiscal year which began last July 1.

ISRAELIS SATISFIED WITH ROGERS. GROMYKO STATEMENTS IN UN

JERUSALEM, Sept. 27 (JTA) -- Israeli diplomatic circles expressed satisfaction today with the speeches of both US Secretary of State William P. Rogers and Soviet Foreign Minister Andrei A. Gromyko before the 27th session of the United Nations General Assembly in New York this week. In the case of Gromyko's speech, the satisfaction was accompanied by welcome surprise over the Soviet diplomat's strong condemnation of Arab terrorism and his specific reference to the Munich tragedy.

But in commenting on Gromyko's words, Israeli observers cautioned that it remained to be seen whether the Soviet bloc would now throw its support behind Rogers' urgent call for international conventions against terrorism including provisions for the extradition and punishment of perpetrators and sanctions against countries aiding them. Israel, for its part, strongly supports Rogers' proposals and is making every effort to publicize that fact.

Observers here felt that Gromyko's statements, the strongest condemnation of terrorism to date by a top ranking Soviet official, reflected the extent to which the outrages by the Black September group has alienated segments of world opinion hitherto sympathetic to their cause. Other circles felt that the surprise Soviet shift on terrorism was another signal that Moscow wanted to improve relations with Israel

Rogers' speech was praised here as much for what it omitted as for what it contained, Israeli sources pointed out that the Secretary of State did not mention his six-point proposals for a Middle

East solution which he had brought up in his Assembly speech last year. Israel at the time expressed strong reservations over Rogers' detailed initiative. In his speech Monday, Rogers concentrated on the need to crack down on terrorists and on an interim Suez agreement, views which Israel shares.

NEW EFFORTS TO AID TREPPER

PARIS, Sept. 27 (JTA) -- New efforts in support of World War II master spy Leopold Trepper's attempts to get an exit visa from Polish authorities so that he can settle in Israel will be made here next month when Edward Gierek, chief of Poland's Communist Party, visits Paris. Soulez Lariviere, Trepper's French attorney, said yesterday that the local Trepper Committee would organize a hunger strike to coincide with Gierek's visit Oct. 2-6.

Gilles Perrault, a French writer, disclosed at a press conference yesterday that he met Trepper in East Berlin last month where he reaffirmed his wish to live in Israel. Perrault said that Trepper, who lives in Warsaw, was invited to the East German capital to help prepare ceremonies honoring members of Trepper's spy ring, the "Red Orchestra," who were executed by the Nazis. The ceremonies are scheduled for Nov.-Dec.

Trepper was received in East Berlin with "all the honors of a visiting dignitary," Perrault said, He said the invitation by East German authorities originated in Moscow where there is a desire to find some solution to the embarrassing Trepper affair. Meanwhile, Trepper has filed a libel suit against Jean Rochet, chief of French counter-intelligence, who accused him publicly of collaborating with the Gestapo during the war. The trial opens here Oct. 26.

SIR ALEC BRANDS TERRORISM A DISEASE; WELCOMES ROGERS INITIATIVE ON ISSUE

UNITED NATIONS, Sept. 27 (JTA) -- Britain's Foreign Secretary, Sir Alec Douglas-Home told the General Assembly today that terrorism of innocents "in the name of some hideously distorted interpretation of justice" was a "disease" that "must be stopped unless law and order for world society is to be totally undermined." Eradication of terrorism must be "vigorously pursued," Str Alec declared, adding: "We in Britain will support drastic measures to stop this rot, and we welcome the initiative taken on Monday by Mr. Rogers (US Secretary of State William P. Rogers)." The Briton did not elaborate on his reference to "drastic measures."

While praising Rogers' anti-terrorism proposals, Sir Alec did not specifically mention, as the American did, the massacre of Israelis and others at Lydda Airport in Tel Aviv and at the Olympic Games in Munich, the murder-bymail program of Palestinian terrorists and other terrorist acts against Israel and Israelis. Yesterday, the Munich killings and other acts of Palestinian terrorism were unexpectedly condemned by Soviet Foreign Minister Andrei A. Gromyko. The only specific terrorism cited by Sir Alec was that in Northern Ireland.

The British Foreign Secretary urged States to endorse the Hague and Montreal anti-hijacking conventions "with all possible speed"; called for the effecting of "further measures to close every haven to the hijacker and saboteur," and asked States to extradite and prosecute terrorists, prevent international travel by them and coordinate

police activities against them.

On the Middle East, Sir Aleo welcomed the "dramatic change" resulting from Egypt's having "dispensed with Soviet military support." This "step towards de-polarization is an opportunity to resume the quest for a penceful settlement," and "should be selzed," he said, adding: "We should not be deflected from this aim by the cycle of violence and reprisal which has been given fresh impetus in recent weeks." He recommended that the UN "stick to" Security Council Resolution 242 and endorsed again the Jarrian peace mission.

LETTER TO NIXON DEMANDS U.S. USE ECONOMIC POWER TO CHANGE SOVIET JEWS' SITUATION

WASHINGTON, Sept. 27 (JTA)--Two spokesmen for American Jewry made public today a letter to President Nixon demanding that the United States use its economic power to bring about changes in the Soviet Union's treatment of its Jewish citizens who wish to emigrate. The letter asked the President "to make known to Soviet leaders our country's inability to enter into new and close trade relationships" unless the Soviet measures against would-be emigrants "are stopped."

The letter, signed by Richard Maass, chairman of the National Conference on Soviet Jewry, and Jacob Stein, chairman of the Conference of Presidents of Major American Jewish Organizations, was made public following an "emergency meeting" at Bhail Brith headquarters here last night at which the deteriorating situation of Jews in the Soviet Union was discussed. It followed hard on statements made in New York yesterday by Presidential press secretary Ronald Ziegler that President Nixon told a group of Jewish leaders that he was working through "diplomatic chamele" to help Soviet Jews.

The letter to Nixon urged the President "to make known to us, to all American people and to the Soviet leadership your determination not to recommend most favored nation treatment for the Soviet Union nor to qualify the Soviet Union for large-scale loans or credits so long as it continues its unconscionable demands upon a defenseless minority." The letter stated that the situation of Soviet Jewry had "worsened" since the President's summit visit to Moscow last May.

Jackson Offers Trade Act Amendment

In a related development today, Sen. Henry M. Jackson (D. Wash.) offered an amendment to the East-West trade relations act in the Senate which would bar any country from receiving most favored nation treatment or to participate in US credit and investment guarantee programs "unless that country permits its citizens the opportunity to emigrate to the country of their choice."

Jackson's office told the Jewish Telegraphic Agency that Sen. Abraham Riblcoff (D. Conn.) was a cosponsor of the amendment but declined to name other co-sponsors at this time. Jackson said his measure "arises out of, and is rooted in, our traditional commitment to the cause of individual liberty."

It was disclosed, meanwhile, that Maass and several other leaders of the National Conference on Soviet Jewry went to the White House today but it was not announced with whom they met. Maass announced earlier that he, Max Fisher of Detroit, and Stein will meet with Secretary of State William P. Rogers at the White House.

In response to questions at a press conference; Maass, Jerry Goodman, the NCSJ executive director, and Dr. William Korey, head of the B'nai B'rith United Nations office, observed that the US has already raised the issue in various forms, including the UN, and called attention to former Attorney General John Mitchell's action toward admitting Soviet Jews to the US, However, Goodman noted, "there is no

question" that since the Soviet-American summit conference the Jewish situation in the Soviet Union has "drastically" worsened and "Soviet propaganda has increased for whatever reason."

3 JDLers ADMIT INVOLVEMENT IN ILLEGAL POSSESSION OF EXPLOSIVES

NEW YORK, Sept. 27 (JTA).—Three Jewish Defense Leaguers were continued in \$10,000 bail each yesterday after admitting in Brooklyn Federal Court that they had been involved in the Ilegal possession of explosives. Sheldon Seigel of Brooklyn, 26, admitted conspiring to plant two bombs at the Soviet Union's Amtong Trading Corporation in Manhattan last year, one of which caused considerable damage.

Jacob Weisel. 25, and Elleen Garfinkle. 21, also of Brooklyn, admitted illegal possession of dynamite that the government claims they planted at the USSR's estate in Glen Cove, Long Island. Seigel faces up to five years' imprisonment and a \$10,000 fine; Weisel and Miss Garfinkle, up to one year and \$1000 each. Yesterday afternoon, 18 JDLers were arrested after staging a sit-down in the street when the police barred a demonstration outside the Soviet Mission.

CONGRESS COMMENDS OLYMPIC TEAM, SPITZ

WASHINGTON, Sept. 27 (JTA)-- Both Houses of Congress have unanimously adopted identical resolutions commending the 1972 American Olympic team and swimmer Mark Andrew Spitz in particular for their performances at the 20th Olympiad in Munich. The resolutions devote the first of their two paragraphs to Spitz who is "commended for the individual excellence, skill and perseverance" in becoming the first Olympic contestant ever to win seven gold medals in one Olympiad and earned the "recognition of being the outstanding Olympian of modern times."

RABBI IN 10TH DAY OF FAST TO PROTEST VIETNAM WAR, SOVIET HEAD TAX

WAYNE, N.J., Sept. 27 (JTA)--Rabbi Israel S. Dresner, president of the New Jersey region of the American Jewish Congress, entered his tenth day of fasting today to protest the Soviet government's head tax on Russian Jews applying for exit visas and the American military participation in Vietnam. Rabbi Dresner, spiritual leader of Temple Beth Tikvah, began his fast Sept. 17 on the eve of Yom Kippur. He announced to his congregation that he would continue his fast until "at least" the end of the Jewish holiday season at sundown Sunday.

Rabbi Dresner called it "downright obscenefor American grain dealers, exporters, international grain operators and inside dopesters to be reaping windfall profits of more than \$100 million at a time when the Soviet government has placed thousands of educated Jews on the slave block for exorbitant ransom fees." Also fasting for "the good name and good conscience of my country, the United States of America." he condemned the slaughter of Vietnamese, Cambodians, and Laotians by what he called the "heaviest aerial bombing and naval shelling in human history."

The Bronfman family, in accordance with the will of the late Samuel Bronfman who died in Montreal last year, has decided to set up a foundation to be known as the Samuel and Saidye Bronfman's Family Foundation, It will be located in Montreal. The Foundation, although not yet chartered, will include Jewish charities and donations to the State of Israel, Dr. Peter Swann, former director of the Royal Ontario Museum of Arts, was appointed director general of the Foundation.

POLICE CONDUCT WIDESPREAD SEARCH OF JDLers HOMES Report JDL To Run In Elections

TEL AVIV, Sept. 27 (JTA) -- Police carried out a widespread search of the homes of Jewish Defense League members last night in their continuing investigation of the JDL's attempts to smuggle arms out of the country for a private war against Arab terrorists abroad. Apparently as a result of a tipoff, police found many of the flats locked and their occupants gone. The JDL accused the police of planting an informer in its ranks who allegedly provided the names and addresses of members,

Meanwhile, a reputed "deal" between JDL leader Rabbi Meir Kahane and Justice Minister Yaacov Shimshon Shapiro reportedly collapsed yesterday when the government made it clear that it would not drop charges against JDL members and others accused of arms smuggling. Rabbi Kahane had reportedly promised to reveal information to government authorities if the charges were quashed Circles close to the JDL said last night that it

would establish a political party headed by Rabbi Kahane to run in the next general elections. The circles said that would be the JDL's response to alleged attempts by the Israeli authorities to eliminate the JDL and stifle its activities. The JDL claims to have 500 active members in Israel.

Meanwhile, police sources pressing the investigation of arms smuggling said today that they had evidence that at least two Israeli soldiers were involved. The soldiers allegedly stole weapons from arsenals which JDL members tried to smuggle abroad, police said.

YARIV: TERRORISM CAN BE MINIMIZED BUT NOT ELIMINATED

TEL AVIV, Sept. 27 (JTA) -- Maj. Gen. Aharon Yariv, the retiring chief of military intelligence, said today that there was no way of eliminating Arab terrorism entirely but that it could be reduced to a minimum by counter-terrorist acts on a wide front geographically, employing a wide range of methods and means. He said Israel's recent attacks on terrorist strongholds in Lebanon were intended to force the Lebanese authorities to crack down on terrorists operating from their territory.

Meanwhile, Al Ahram, the influential Cairo daily, reported today that Palestinian terrorists in Lebanon agreed to suspend actions against Israel from Lebanese territory. According to the report the terrorists made this agreement with the Lebanese government to adhere to the 1969 Cairo accord. The provisions of that accord are not known.

Ziegler reported that Nixon prefers to deal with the exit tax matter through "diplomatic channels," and the Soviet leadership has been "aware of our views for some time," Ziegler continued.

No Imposed Settlement In Mideast

At the meeting with the Jewish leaders, Nixon "understood the deep feelings about the (emigration) matter and indeed shared the human concern involved," Ziegler reported. He said in response to questions that neither Nixon nor the Jewish leaders raised the question of the amendment proposed by Sen. Abraham A. Riblooff (D. Conn.), making the projected US-USSR trade deal contingent on elimination of the exit fees.

Ziegler said Nixon also assured the Jewish leaders that the US would "under no circumstances impose a settlement in the Middle East"; that the administration was "committed to the survival of the State of Israel (and) the strength of Israel'; that the US would continue to "make available the assistance to Israel (necessary to) maintain her strength," and that the "strong US presence in the Mediterranean" would be maintained.

The Jewish leaders attending included, Max Fisher, Dr. William Wexler, Samuel Rothberg, Mrs. Rita Hauser, Leonard Goldine, Lawrence Goldberg, Jacques Torczyner, Rabbi Herschel Schacter, Rabbi Seymour Siegel, Meshulem Riklis, Rabbi Gollbert Klaperman, Herman Weisman, Rabbi Ronald Greenwald, Melvin Dubinsky, and Rabbi Solomon Sharfman. Six other leaders who were invited to attend the meeting with Nixon in addition to the 35 who did, were reported out of the country or unavailable. They included Joseph Meyerhoff, Louis Boyar and Tatt Schreiber.

Jewish Leaders Impressed With Nixon

Fisher told the JTA from Detroit today that "the President made it clear that he's not going to use this (Soviet Jewy issue) for political capital, and I think this is quite correct." Calling Nixon "very forthright" on the matter, Fisher said he was "convinced" the President was trying to "help" Soviet Jews. On the question of anti-Semitism in the USSR, Fisher noted that this has existed for many more years than Nixon has been President.

Rothberg, chairman of Israel Bond Organization, said that he was deeply impressed by the President's statement of his commitment to support israel. "Nixon was very, very serious," he said. Rabbi Schacter said "I was very impressed. Everything he (Nixon) had to say on Israel was very firm and unequivocal. On Soviet Jewry he was equally forceful." Nixon, Rabbi Schacter said, told the Jewish leaders that he did not want to make a political issue of this because the Soviet Union would slam the door on emigration.

Rabbi Siegel, professor at the Jewish Theological Seminary, seid he was "very impressed" with Nixon's stance, including the caution that the Soviets would "lock the door" on Jews seeking to emigrate if the US government pressured the Kremiin publicly. Rabbi Siegel said Nixon deplored the Munich massacre, and spoke "extremely warmly" of Israel and its courage and of his personal commitment to Israel's security.

McGovern Aide Rapped For Position On Israel

Prior to the press conference, a representative from the New York Committee to Re-Elect the President, distributed a copy of an article that appeared in a newspaper, "Hatchet," a publication of a student society at George Washington University in Washington, D.C., which carried a headline, "Gary Hart: Israeli Raids Wrong." The article, signed by Mark Nadler, editor-in-chief, stated that Hart, Sen, George McGovern's campaign manager, in response to a question, told a crowd of 500 students at the university on Sept. 19 that McGovern should condemn Israel for its recent retaliatory raids on Lebanon. "I don't know whether he (MeGovern) has or not, but he should have condemned Israel," Nadler reported Hart said.

Hart, in a letter to the editor which appeared in "Hatchet" a week later, stated that in response to a question concerning the failure of the political community to condemn "the killings of a large number of Lebanese civilians during those raids... I suggested that Senator McGovern has condemned and would continue to condemn, any military action which resulted in the killing of innocent, unarmed non-combatants. The question of whether the raids themselves, directed against guerrilla camps on the Lebanese border, were justified was never raised, and therefore never responded to,"

An unsigned editorial in the student newspaper, defended its treatment of Hart's speech and noted that his letter "clarified but did not alter the substance of his original remarks." The editorial stated further that Hart "made an unfortunate statement of great news value and that's the way we treated it."

SENATE COMMITTEE CUTS AID TO SOVIE EMIGRES: NO MENTION OF LIMITING TRADE

WASHINGTON, Sept. 27 (JTA) -- The Senate Appropriations Committee today reported out a foreign aid bill that makes no mention of limiting trade relations with the Soviet Union over the Soviet Jewry issue and also reduced the amount of federal government aid for the resettlement of Soviet emigres to \$50 million

The Committee, headed by Sen. John McClelland (D., Ark.) was reported to have accepted the subcommittee's recommendations to eliminate the provision of trade limitation that was made part of the House legislation last Thursday, on the initiative of Rep. Charles E. Vanik (D. Ohio). That provision would bar Export-Import Bank assistance or federal government insurance on private investments for any country which charged more than \$50 for a person to emigrate.

The Appropriations Committee, however, approved the House bill's figure of \$50 million for use by the State Department to help countries giving haven to Soviet emigrants. In practical terms this would be mainly for Israel which is taking virtually all Soviet emigrants, the vast majority of whom are Jewish. The Senate Committee accepted the House version on aid to American schools and hospitals abroad which is understood to mean a contribution of about \$3-4 million to institutions in Israel.

Since the Senate authorization bill on foreign aid has not yet been signed into law, the Appropriations Committee "deferred" action on appropriating funds for military assistance. In this instance, however, it is understood that no bar will be put against credit sales of up to \$300 million for Israel along with a grant of \$50 million to Israel in economic supporting assistance. These figures were included in the House bill. In overall funding, the Senate measure is slightly in excess of the \$4.2 billion voted by the House for the fiscal year which began last July 1.

ISRAELIS SATISFIED WITH ROGERS. GROMYKO STATEMENTS IN UN

JERUSALEM, Sept. 27 (JTA) -- Israeli diplomatic circles expressed satisfaction today with the speeches of both US Secretary of State William P. Rogers and Soviet Foreign Minister Andrei A. Gromyko before the 27th session of the United Nations General Assembly in New York this week. In the case of Gromyko's speech, the satisfaction was accompanied by welcome surprise over the Soviet diplomat's strong condemnation of Arab terrorism and his specific reference to the Munich tragedy.

But in commenting on Gromyko's words, Israeli observers cautioned that it remained to be seen whether the Soviet bloc would now throw its support behind Rogers' urgent call for international conventions against terrorism including provisions for the extradition and punishment of perpetrators and sanctions against countries aiding them. Israel, for its part, strongly supports Rogers' proposals and is making every effort to publicize that fact.

Observers here felt that Gromyko's statements, the strongest condemnation of terrorism to date by a top ranking Soviet official, reflected the extent to which the outrages by the Black September group has alienated segments of world opinion hitherto sympathetic to their cause. Other circles felt that the surprise Soviet shift on terrorism was another signal that Moscow wanted to improve relations with Israel

Rogers' speech was praised here as much for what it omitted as for what it contained, Israeli sources pointed out that the Secretary of State did not mention his six-point proposals for a Middle

East solution which he had brought up in his Assembly speech last year. Israel at the time expressed strong reservations over Rogers' detailed initiative. In his speech Monday, Rogers concentrated on the need to crack down on terrorists and on an interim Suez agreement, views which Israel shares.

NEW EFFORTS TO AID TREPPER

PARIS, Sept. 27 (JTA) -- New efforts in support of World War II master spy Leopold Trepper's attempts to get an exit visa from Polish authorities so that he can settle in Israel will be made here next month when Edward Gierek, chief of Poland's Communist Party, visits Paris. Soulez Lariviere, Trepper's French attorney, said yesterday that the local Trepper Committee would organize a hunger strike to coincide with Gierek's visit Oct. 2-6.

Gilles Perrault, a French writer, disclosed at a press conference yesterday that he met Trepper in East Berlin last month where he reaffirmed his wish to live in Israel. Perrault said that Trepper, who lives in Warsaw, was invited to the East German capital to help prepare ceremonies honoring members of Trepper's spy ring, the "Red Orchestra," who were executed by the Nazis. The ceremonies are scheduled for Nov.-Dec.

Trepper was received in East Berlin with "all the honors of a visiting dignitary," Perrault said, He said the invitation by East German authorities originated in Moscow where there is a desire to find some solution to the embarrassing Trepper affair. Meanwhile, Trepper has filed a libel suit against Jean Rochet, chief of French counter-intelligence, who accused him publicly of collaborating with the Gestapo during the war. The trial opens here Oct. 26.

SIR ALEC BRANDS TERRORISM A DISEASE; WELCOMES ROGERS INITIATIVE ON ISSUE

UNITED NATIONS, Sept. 27 (JTA) -- Britain's Foreign Secretary, Sir Alec Douglas-Home told the General Assembly today that terrorism of innocents "in the name of some hideously distorted interpretation of justice" was a "disease" that "must be stopped unless law and order for world society is to be totally undermined." Eradication of terrorism must be "vigorously pursued," Str Alec declared, adding: "We in Britain will support drastic measures to stop this rot, and we welcome the initiative taken on Monday by Mr. Rogers (US Secretary of State William P. Rogers)." The Briton did not elaborate on his reference to "drastic measures."

While praising Rogers' anti-terrorism proposals, Sir Alec did not specifically mention, as the American did, the massacre of Israelis and others at Lydda Airport in Tel Aviv and at the Olympic Games in Munich, the murder-bymail program of Palestinian terrorists and other terrorist acts against Israel and Israelis. Yesterday, the Munich killings and other acts of Palestinian terrorism were unexpectedly condemned by Soviet Foreign Minister Andrei A. Gromyko. The only specific terrorism cited by Sir Alec was that in Northern Ireland.

The British Foreign Secretary urged States to endorse the Hague and Montreal anti-hijacking conventions "with all possible speed"; called for the effecting of "further measures to close every haven to the hijacker and saboteur," and asked States to extradite and prosecute terrorists, prevent international travel by them and coordinate

police activities against them.

On the Middle East, Sir Aleo welcomed the "dramatic change" resulting from Egypt's having "dispensed with Soviet military support." This "step towards de-polarization is an opportunity to resume the quest for a penceful settlement," and "should be selzed," he said, adding: "We should not be deflected from this aim by the cycle of violence and reprisal which has been given fresh impetus in recent weeks." He recommended that the UN "stick to" Security Council Resolution 242 and endorsed again the Jarrian peace mission.

LETTER TO NIXON DEMANDS U.S. USE ECONOMIC POWER TO CHANGE SOVIET JEWS' SITUATION

WASHINGTON, Sept. 27 (JTA)--Two spokesmen for American Jewry made public today a letter to President Nixon demanding that the United States use its economic power to bring about changes in the Soviet Union's treatment of its Jewish citizens who wish to emigrate. The letter asked the President "to make known to Soviet leaders our country's inability to enter into new and close trade relationships" unless the Soviet measures against would-be emigrants "are stopped."

The letter, signed by Richard Maass, chairman of the National Conference on Soviet Jewry, and Jacob Stein, chairman of the Conference of Presidents of Major American Jewish Organizations, was made public following an "emergency meeting" at Bhail Brith headquarters here last night at which the deteriorating situation of Jews in the Soviet Union was discussed. It followed hard on statements made in New York yesterday by Presidential press secretary Ronald Ziegler that President Nixon told a group of Jewish leaders that he was working through "diplomatic chamele" to help Soviet Jews.

The letter to Nixon urged the President "to make known to us, to all American people and to the Soviet leadership your determination not to recommend most favored nation treatment for the Soviet Union nor to qualify the Soviet Union for large-scale loans or credits so long as it continues its unconscionable demands upon a defenseless minority." The letter stated that the situation of Soviet Jewry had "worsened" since the President's summit visit to Moscow last May.

Jackson Offers Trade Act Amendment

In a related development today, Sen. Henry M. Jackson (D. Wash.) offered an amendment to the East-West trade relations act in the Senate which would bar any country from receiving most favored nation treatment or to participate in US credit and investment guarantee programs "unless that country permits its citizens the opportunity to emigrate to the country of their choice."

Jackson's office told the Jewish Telegraphic Agency that Sen. Abraham Riblcoff (D. Conn.) was a cosponsor of the amendment but declined to name other co-sponsors at this time. Jackson said his measure "arises out of, and is rooted in, our traditional commitment to the cause of individual liberty."

It was disclosed, meanwhile, that Maass and several other leaders of the National Conference on Soviet Jewry went to the White House today but it was not announced with whom they met. Maass announced earlier that he, Max Fisher of Detroit, and Stein will meet with Secretary of State William P. Rogers at the White House.

In response to questions at a press conference; Maass, Jerry Goodman, the NCSJ executive director, and Dr. William Korey, head of the B'nai B'rith United Nations office, observed that the US has already raised the issue in various forms, including the UN, and called attention to former Attorney General John Mitchell's action toward admitting Soviet Jews to the US, However, Goodman noted, "there is no

question" that since the Soviet-American summit conference the Jewish situation in the Soviet Union has "drastically" worsened and "Soviet propaganda has increased for whatever reason."

3 JDLers ADMIT INVOLVEMENT IN ILLEGAL POSSESSION OF EXPLOSIVES

NEW YORK, Sept. 27 (JTA).—Three Jewish Defense Leaguers were continued in \$10,000 bail each yesterday after admitting in Brooklyn Federal Court that they had been involved in the Ilegal possession of explosives. Sheldon Seigel of Brooklyn, 26, admitted conspiring to plant two bombs at the Soviet Union's Amtong Trading Corporation in Manhattan last year, one of which caused considerable damage.

Jacob Weisel. 25, and Elleen Garfinkle. 21, also of Brooklyn, admitted illegal possession of dynamite that the government claims they planted at the USSR's estate in Glen Cove, Long Island. Seigel faces up to five years' imprisonment and a \$10,000 fine; Weisel and Miss Garfinkle, up to one year and \$1000 each. Yesterday afternoon, 18 JDLers were arrested after staging a sit-down in the street when the police barred a demonstration outside the Soviet Mission.

CONGRESS COMMENDS OLYMPIC TEAM, SPITZ

WASHINGTON, Sept. 27 (JTA)-- Both Houses of Congress have unanimously adopted identical resolutions commending the 1972 American Olympic team and swimmer Mark Andrew Spitz in particular for their performances at the 20th Olympiad in Munich. The resolutions devote the first of their two paragraphs to Spitz who is "commended for the individual excellence, skill and perseverance" in becoming the first Olympic contestant ever to win seven gold medals in one Olympiad and earned the "recognition of being the outstanding Olympian of modern times."

RABBI IN 10TH DAY OF FAST TO PROTEST VIETNAM WAR, SOVIET HEAD TAX

WAYNE, N.J., Sept. 27 (JTA)--Rabbi Israel S. Dresner, president of the New Jersey region of the American Jewish Congress, entered his tenth day of fasting today to protest the Soviet government's head tax on Russian Jews applying for exit visas and the American military participation in Vietnam. Rabbi Dresner, spiritual leader of Temple Beth Tikvah, began his fast Sept. 17 on the eve of Yom Kippur. He announced to his congregation that he would continue his fast until "at least" the end of the Jewish holiday season at sundown Sunday.

Rabbi Dresner called it "downright obscenefor American grain dealers, exporters, international grain operators and inside dopesters to be reaping windfall profits of more than \$100 million at a time when the Soviet government has placed thousands of educated Jews on the slave block for exorbitant ransom fees." Also fasting for "the good name and good conscience of my country, the United States of America." he condemned the slaughter of Vietnamese, Cambodians, and Laotians by what he called the "heaviest aerial bombing and naval shelling in human history."

The Bronfman family, in accordance with the will of the late Samuel Bronfman who died in Montreal last year, has decided to set up a foundation to be known as the Samuel and Saidye Bronfman's Family Foundation, It will be located in Montreal. The Foundation, although not yet chartered, will include Jewish charities and donations to the State of Israel, Dr. Peter Swann, former director of the Royal Ontario Museum of Arts, was appointed director general of the Foundation.

POLICE CONDUCT WIDESPREAD SEARCH OF JDLers HOMES Report JDL To Run In Elections

TEL AVIV, Sept. 27 (JTA) -- Police carried out a widespread search of the homes of Jewish Defense League members last night in their continuing investigation of the JDL's attempts to smuggle arms out of the country for a private war against Arab terrorists abroad. Apparently as a result of a tipoff, police found many of the flats locked and their occupants gone. The JDL accused the police of planting an informer in its ranks who allegedly provided the names and addresses of members,

Meanwhile, a reputed "deal" between JDL leader Rabbi Meir Kahane and Justice Minister Yaacov Shimshon Shapiro reportedly collapsed yesterday when the government made it clear that it would not drop charges against JDL members and others accused of arms smuggling. Rabbi Kahane had reportedly promised to reveal information to government authorities if the charges were quashed Circles close to the JDL said last night that it

would establish a political party headed by Rabbi Kahane to run in the next general elections. The circles said that would be the JDL's response to alleged attempts by the Israeli authorities to eliminate the JDL and stifle its activities. The JDL claims to have 500 active members in Israel.

Meanwhile, police sources pressing the investigation of arms smuggling said today that they had evidence that at least two Israeli soldiers were involved. The soldiers allegedly stole weapons from arsenals which JDL members tried to smuggle abroad, police said.

YARIV: TERRORISM CAN BE MINIMIZED BUT NOT ELIMINATED

TEL AVIV, Sept. 27 (JTA) -- Maj. Gen. Aharon Yariv, the retiring chief of military intelligence, said today that there was no way of eliminating Arab terrorism entirely but that it could be reduced to a minimum by counter-terrorist acts on a wide front geographically, employing a wide range of methods and means. He said Israel's recent attacks on terrorist strongholds in Lebanon were intended to force the Lebanese authorities to crack down on terrorists operating from their territory.

Meanwhile, Al Ahram, the influential Cairo daily, reported today that Palestinian terrorists in Lebanon agreed to suspend actions against Israel from Lebanese territory. According to the report the terrorists made this agreement with the Lebanese government to adhere to the 1969 Cairo accord. The provisions of that accord are not known.

NEW YORK, Sept. 27 (JTA) -- The United Hias Service reported today that 24 Jewish emigrants comprising 13 family units from the Soviet Union Hungary, Rumania and Poland arrived here on separate flights. The emigrants will be resettled in Greater New York; Teaneck, N.J.; Los Angeles; Philadelphia; Atlanta, Ga.; and Montres Four of the arrivals from the USSR entered this country through the parole authority of the US Attorney General. The families settling in the NY area are being assisted by the NY Association for New Americans. Families in other cities are being assisted by the local Jewish communities.
