JACKSON SAYS HIS AMENDMENT ON U.S.-USSR TRADE RELATIONS IS A 'CLEAR SIGNAL' TO RUSSIA THAT HEAD TAX MUST GO

Amendment Has 66 Bi-Partisan Co-Sponsors

WASHINGTON, Oct. 4 (JTA)—Sen. Henry M. Jackson (D. Wash.) served notice today to the Soviet government, the Nixon administration and all parties involved in negotiating new trade relations between the US and USSR that they will have Congress to deal with on the issue of the Soviet education head tax imposed on Jews seeking to emigrate from Russia.

Jackson stressed that point at a press conference here this afternoon just before he presented on the Senate floor his amendment to the 1971 East-West Trade Act that would in effect force the Soviets to

rescind their visa fees.

The Jackson amendment has 66 bi-partisan cosponsors, nearly 2/3 of the Senate, and is expected to pick up more before the end of the day. Missing from the list of co-sponsors, however, were Sen. Mike Mansfield (D. Mont.) the Senate Majority Leader, and Sen. Hugh Scott (R.Pa.) the Minority Leader. The Jackson measure will not be voted on before Congress adjourns its current session Oct. 15, but is certain to come up after Congress reconvenes next Jan.

Vanik Amendment Snowballing In House

An equivalent of the Jackson amendment was introduced in the House today by Rep. Charles Vanik (D,Ohlo) who said he had 73 co-sponsors and expected at least 25 more. Rep. Benjamin S, Rosenthal (D,NY) at the same time introduced a joint resolution that would suspend the expansion of trade with the Soviet Union until there are assurances that measures restricting emigration from that country will be withdrawn.

Jackson indicated in reply to questions at his press conference that the administration was not actively opposing his amendment despite statements from the State Department last week that it did not favor such measures. While there have been no affirmative statements of support for his bill from the administration, "I understand the administration is not opposing this," Jackson sald. He asserted no one in the administration had asked him to "hold off" on his mendment.

The Jackson amendment provides that after Oct. 15, 1972, no country shall be eligible to receive most favored nation treatment, or to participate in any US government programs for credit or investment guarantees directly or indirectly if it denies its citizens the right or opportunity to emigrate or imposes more than a nominal tax on emigration or on other documents required to emigrate "for any purpose or cause whatsoever."

29 Senators Denounce Head Tax

Just before Jackson's press conference, a statement signed by 29 of the co-sponsoring Senators denouncing the Soviet visa fees was distributed by Sen. Jacob K, Javits (R,NY) and Sen. Hubert H, Humphrey (D. Minn.). The statement note, "The Jewish community of the Soviet Union has already suffered more than other elements of the Soviet population from discrimination."

Continuing, the statement observed: "It should be completely unacceptable to the US and the world that the survivors of the Nazi holocaust and their children again should be singled out for discriminatory treatment and be subjected to notorious ransom requirements impeding their natural desire to join with relatives and co-religionists in other lands."

At his press conference, Jackson brushed aside suggestions that the visa fees were an internal matter of the Soviet Union or that the UN, rather than the US, should raise the issue. "Il hope that our foreign policy is based on the central theme not only for the preservation of human freedom but for an extension of it," Jackson said, adding that "if we depend on the UN we'll all be in trouble."

According to Jackson, his amendment is a "clear signal" to the Soviet Union of the attitude of Congress toward legislation the Russians are interested in, and also to the administration and the people involved in trade relations with the Soviet Union. "We're not cramming it down anybody's throat," he stated. The administration will have ample time to tell the Russians what Congress wants, Jackson asserted. He said that at this time, when the USSR wants trade relations with the US and is asking for special credit and most favored nation treatment, the Soviet Union should be made to "adhere to certain specific conditions."

In a joint statement issued by Richard Maass, chairman of the National Conference on Soviet Jewry, and Jacob Stein, chairman of the Conference of Presidents of Major American Jewist Organizations, the two Jewish leaders, who last week issued a letter to Nixon urging the US to use its economic power to bring about changes in the Soviet Union's treatment of Jewish emigrants, stated today:

"The amendment to the East-West Trade Bill is a welcome bi-partisan initiative. It will serve to alert the Soviet Union that the American people will not sit tidly by while the Soviet Union exploits its citizens who wish to emigrate. Clearly the United States cannot offer economic concessions to the Soviet Union while Russia holds educated

Jews for ransom."

THE RUSSIANS ARE ARRIVING

WASHINGTON, Oct. 4 (JTA).—The White House confirmed today that arrangements were underway in connection with the invitations extended to Soviet leaders by President Nixon at last May's Moscow summit conference to visit the US. The leaders invited were President Nikolai V. Podgorny, Premier Aleksei N. Kosygin and Communist Party Secretary Leonid I. Brezhnev. The Washington Star said tonight that Brezhnev would visit the US next year and that the date of his visit and Itinerary would be announced by the White House after the elections.

JEWISH GROUP CLAIMS CREDIT FOR BOMBING OF PALESTINIAN OFFICE

PARIS, Oct. 4 (JTA).—An Arab library believed to serve as a front for most Palestinan organizations in France was blown up early this morning by an explosive charge. A Jewish organization calling itself "Massads," claimed responsibility for the explosion at the Palestine Library in norther Paris. The front window was shattered and part of the furniture destroyed. No one was injured in the blast. Books were still scattered

this morning all along the sidewalk.

Police investigators believe that the explosion was caused by a small bomb with a delaying mechsnism which had been placed in front of the main entrance several hours earlier. No arrests have been reported yet. Several minutes after the explosion, the French news agency, Agence France Presse, received a phone call from a spokesman claiming to represent the Massada group.

The spokesman told AFP "Massada has undertaken its first operation in response to the anti-Israeli and anti-Jewish terrorist campaign now in progress. An explosive charge was set off at the Palestine Library. Jewish terror will reply to anti-Semitic terror. This is our first warning." Massada is listed in the French Jewish Directory as "an ideological group with Jabotinsky tendencies" and is listed under the French Herut-Betar organization.

However, a Herut spokesman, Gerard Lelouche. told the Jewish Telegraphic Agency, that neither Herut nor Betar "had ever met anyone who is a member of the group and had not believed in its actual existence." He emphatically denied that his organization had anything to do with the explosion. Though the Jewish Defense League has some 50 members in France, none of them were available for comment.

Circles close to the Jewish community in France issued "an energetic condemnation" of the explosion, stressing that "the Jewish community condemns and abhors all forms of violence whoever their authors may be and whatever their objects." The community stressed that it had never heard about the Massada group and has no connection with it. The French information media devoted considerable space to the incident, seen by many observers here as the first instance of Jewish "anti-terrorism."

SOVIET ACTIVIST SENTENCED

NEW YORK, Oct. 4 (JTA) -- Yankel Khantsis, who went on trial last Thursday in Kirov, on charges of "anti-Soviet slander," has been sen tenced to 18 months in prison, Jewish sources reported today. They said Khantsis, who was subjected before the trial to "psychiatric treatment," had to be carried into court Saturday when he began exclaiming that he wanted to die. The defendant, who is in his 40s, was exiled for a time several years ago for "hooliganism" in connection with his attempt to enter the Dutch Embassy.

EXIT FEES ALTER CHARACTER BUT NOT VOLUME OF EMIGRATION

JERUSALEM, Oct. 4 (JTA) -- A Jewish Agency official reported today that the Soviet visa head tax on educated Jews seeking to leave Russia has altered the character of immigration from that country but has not affected its volume. Yehuda Dominitz, deputy director of the Agency's immigration department, said that 55,000 newcomers are expected in Israel by the end of this year, the highest number since 1963. He said the increase was due largely to the influx of Soviet Jews whose numbers are expected to be double last year's.

Jewish Agency Treasurer Leon Dultzin told members of the United Jewish Appeal Study Mission in Tel Aviv last night that the Soviet visa fees affected no more than 20 percent of the potential emigrants. "We expect some 50,000 Russian Jews to come to Israel," he said, adding that the absorption cost of each family would amount to about \$35,000.

Dominitz said that a total of 41,000 immigrants arrived in Israel between Jan.-Sept. of this year. He said that if anything, the visa fees spurred the

departure of Jews from the USSR. People not subjected to the fees for holders of academic degrees are advancing their departures for fear that if they delay, the fees might be extended to them, the official said.

Dominitz reported that immigration from North America has not picked up as was anticipated. The peak year was 1970 when 9472 immigrants arrived from North America. That figure has not been matched since, he said. The North American olim numbered 8122 last year and a similar number is expected this year, he said.

Dominitz said the biggest decline was from France, He said 5000 immigrants arrived from there in 1970, 3300 last year and barely 2500 are expected this year. Immigration from Asia and Africa has reached a new low--7000 last year and a probable 6000 this year, he said. But 5000 Jews are expected from South America this year compared to 4500 last year.

JORDANIAN ENVOY CRITICAL OF VIOLENCE AGAINST INNOCENT PEOPLE; BLASTS ISRAEL

UNITED NATIONS, Oct. 4 (JTA) -- Foreign Minister Salah Abu Zeid of Jordan, declaring his government "opposed to violence whatever its source or methods," told the General Assembly today that Jordan was "ready to participate effectively in any international measures to protect innocent civilians against violence." But, he added, Jordan also supports "the right of an occupied people, every occupied people, to effectively resist occupation and colonialism,"

Israel's policy of "bondage and enslavement," he said, poses "a mortal threat to the very survival of Jordan as a state and as a people." He assailed Israel for opposing the "constructive" idea of a Jordanian-Palestinian United Arab Kingdom with Arab Jerusalem as its capital.

Following Abu Zeid's speech, the Israeli Mission issued a one-sentence assertion that "the Jordanian Foreign Minister's acrimonious statement has again demonstrated that public polemics cannot contribute to the search for understanding between the parties to the Middle East conflict and that quiet, reticent dialogue is the only way to a peaceful agreement."

DAYAN DISMISSES IDEA OF PALESTINIAN GOVERNMENT-IN-EXILE

JERUSALEM, Oct. 4 (JTA) -- Defense Minister Moshe Dayan indicated on a television interview last night that he attaches little importance to Egyptian President Anwar Sadat's recent call to the Palestinians to set up a government-in-exile that Egypt would recognize. "The Palestinian government is in Amman and if they are not satisfied with that regime they should try to change it," Dayan said. His remark was the first public comment on the Sadat proposal by any Israeli government leader.

Dayan, addressing himself to the problem of terrorism, said that Israel must step up its war against the terrorists by employing the proper methods to counter the changing mode of terror ist operations. He did not elaborate but he is believed to have been referring to the extension of terrorist acts from the Middle East to European countries. Dayan praised the recent appointment of retired Gen. Aharon Yariv, former chief of military intelligence, to the newly, created post of special advisor to the Prime Minister. He refused to comment when asked if Yariv's appointment had anything to do with the campaign against terrorists

The Jordanian government, meanwhile, was reported today to be strengthening its armed forces on its northern border following reports that several hundred terrorists have been shifted from Lebanon to southern Syria. Jordan has reportedly warned Syria that it would not hesitate to cross the border and strike at terrorist bases inside Syrian territory. According to some reports, Jordan has received modern. American military equipment by sea and airlift.

DEFAULT IS NOT IN THE STARS, BUT IN ORDERS FROM ABOVE

TEL AVIV, Oct. 4 (JTA).—The Israeli chess team has won a 4-0 victory by default over Albania at the world championship chess tournament in Skopje, Yugoslavia. The Israeli team was credited with the win after the Albanian team informed the tournament management that it was forbidden by their government to play the Israelis The tournament management said the Albanian players were not to blame because they had "their orders from above." But other competing teams protested against awarding the victory to Israel because it puts the Israelis ahead of them on unearned points.

BITTER CONTEST EXPECTED IN RABBINATE ELECTIONS

JERUSALEM, Oct. 4 (JTA)—The Chief Rabbinate elections to be held Oct. 15 was shaping up today as a bitter contest in which die-hard conservatives will be opposed by candidates considered relatively liberal within the Orthodox religious spectrum. The 150-man electoral college that will vote for the candidates for Ashkenazi and Sephardi chief rabbis and for members of the Chief Rabbinate Council, was finally completed today after weeks of haggling.

Dr. Zerach Warhaftig, the Minister for Religious Affairs, announced today the appointment of the 10 rabbis which, according to Israeli law, are the appointment of the religious ministry, subject to Cabinet approval. Dr. Warhaftig reportedly sat up until late last night with Justice Minister Yaacov Shimshon Shapiro to complete the list. Shapiro, designated to represent the Cabinet on the matter, reportedly insisted on the inclusion of the Histadrut and Labor Party Rabbi Menachem Hacohen. An agreement was finally reached through the intercession of Premier Golda Meir and the final list was rushed to the printers to be officially gazetted,

Of the 10 rabbis appointed by Dr. Warhaftig, seven are said to be confirmed supporters of Tel Aviv's Chief Rabbi Shlomo Goren, regarded as a moderate. None are committed to the incumbent Ashkenazic Chief Rabbi Isser Yehuda Unterman who has the support of conservative elements. But of 24 rabbis named by an electoral assembly of their colleagues from small townships, 12 are for Rabbi Unterman, eight for Rabbi Goren and four are uncommitted,

The election picture was complicated yester-day when Tel Aviv's Sephardic Chief Rabbi Ovad-lah Yosef, announced his candidacy in opposition to the incumbent Sephardic Chief Rabbi Yitzhak Nissim who was hitherto unchallenged. Rabbi Yosef, like Rabbi Goren, is regarded as one of Israel's more "enlightened" rabbis. His enlightenment is measured by his *ecent ruling that slacks tailored for women are more permissable than mini-skirts according to halacha, religious law. Most other rabbis solidly oppose women wearing pants.

The rabbinate electoral college consists of 70 rabbis and religious lay leaders, 70 mayors, heads of district councils and local religious councils and the 10 rabbis named by the government. The Unferman camp was reportedly unhappy over Dr. Warhaftig's appointments which it considers stacked

in favor of Rabbi Goren whose candidacy is supported by the Labor Party and the National Religious Party. Some Unterman supporters have called for a rabbinical boycott of the elections on grounds that the electoral college was rigged by the government.

TWO SOVIET JEWISH PRISONERS DESCRIBE CONDITIONS IN LABOR CAMPS

TEL AVIV, Oct. 4 J/TA)--Arkady Voloshin and Lazar Abramovich Trakhtenberg, arriving here early this morning after serving prison terms decreed in Kishinev, confirmed that Sylva Zalmanson Kuznetsov, the 28-year-old engineer serving a ten-year term ending in June, 1980, was transferred from Potma prison two weeks ago to solitary confinement for six months for aiding another Jewish woman prisoner. Convicted of complicity in a skyjacking plot, she has long been reported in worsening health.

Voloshin, 27, and Trakhtenberg, 26, went on trial in Kishinev in June, 1971. They were convicted on "anti-Soviet propaganda" and sentenced to two-year terms dating to their arrest in Aug. 1970. Arriving here with a large group of Soviet emigrants, they reported that the situation of the Jewish prisoners in Potma, in Soviet Mordovia, is deteriorating because of the authorities' persistent "anti-Semitism." They said "clashes with the camp's management" over adequate medical care and normal routines "are a daily occurrence."

Trakhtenberg and Voloshin told how they and two other Jewish prisoners conducted a Hebrew ulpan without books in that language, as the five books allowed each of them contained no Hebrew. They said the ulpan was conducted from memory. They stated that Soviet Jews' desire for allya had reached massive proportions, commenting: "Since our release we have visited some friends and seen in the various cities long queues near the Ovir (visa) offices of Jews desiring to come to Israel." Among those welcoming the two ex-immates were Trakhtenberg's wife and Voloshin's fiance; the latter came to Israel only a few months ago.

3 GROUPS REJECT INVITATION TO ATTEND MEETING ON FUENTES APPOINTMENT

NEW YORK, Oct. 4 (JTA)—Three Jewish organizations today rejected the invitation of Community School Board No. 1, Manhattan, to attend an executive meeting of the Board on the appointment of Luis Fuentes as District Superintendent. Instead they invited the Board to join them in requesting Chancellor Harvey B, Scribner to review the case of Fuentes who, they charged, is unqualified for the post because of anti-Semitic slurs made by him as a Brooklyn principal.

They said that since the local board itself was accused of "dereliction of duty" in the matter, it could not "sit in judgment" upon itself. If Dr. Scribner continues to refuse to hear the case, the organizations said, the local board should join them in requesting that State Education Commissioner Ewald B, Nyquist take jurisdiction.

The American Jewish Congress, Anti-Defamation League of B'nai B'rith and Jewish Labor Committee, which have protested the Fuentes appointment, charged the local school board with dereliction of duty in not assessing Fuentes' past record and judging him unfit for the new post. The letter today, in response to the invitation of Mrs. Georgina Hoggard, chairwoman of School Board No. I, was sent by Victor Herwitz, special counsel for the three organizations.

GROUP ESTABLISHES MEMORIAL FUND FOR THE 11 SLAIN ISRAELI ATHLETES

MINNEAPOLIS, Oct. 4 (JTA)—A sports center mororializing the Il Israeli athletes murdered in Munich during the Summer Olympics will be built at an Israeli kibbuts if a newly formed organization here can raise \$150,000. A Minneapolis Israel Olympic Memorial Fund has been created by Mayor Charles Stenvig, who visited Israel two years ago and said he was impressed with Israelis' energy, dedication and determination.

The complex would include facilities for track and field, basketball, volleyball, gymnastics and other activities, and would be known as the Minneapolls Sports Center in Honor of the 11 Martyred Olympic Team Members. The fund drive, headquartered at Midwest Federal Savings and Loan, is chaired by Harold Greenwood, Jr., of the bank, with Mayor Stenvig as bonorary chairman. The large majority of the civic leaders, businessmen and athlets participating in the fund drive are non-Jewish, according to the Minneapolis Federation for Jewish Service.

SENIOR CITIZENS, MANY JEWS, MAY BE HURT BY NEW SOCIAL SECURITY MEASURE

NEW YORK, Oct. 4 (JTA).—The American Jewish Congress to danct special emergency legislation that would protect the nation's elderly by requiring state officials to disregard the new Social Security increase in computing eligib.:ity for other federally-funded health and welfare henefits

A 20 percent increase in Social Security benefits to the elderly went into effect yesterday but is likely to have "a negative impact on many senior citizens nationwide who will now be above eligible income levels for other aid programs," the AJCongress asserted.

Howard M. Squadron, chairman of the Congress' national governing council, said passage of emergency legislation would "offer immediate protection to those persons whose participation in special programs is threatened by the Social Security increase." Two-thirds of the nation's estimated 800,000 Jewish poor are reported to be over 65 years of age and currently benefitting from Social Security and other federal programs,

"The new and welcome Social Security increase will be a bitter hoax to many if instead of delivering the help it promises, it actually results in deprivation," Squadron stated. "Tens of thousands of Social Security recipients throughout the country now find themselves, as a result of the increase, ineligible to receive other benefits, such as food stamps and Medicaid. For these and many others, the Social Security increase may also be wiped out by decreased Old Age Assistance payments."

Squadron noted that the AJCongress had written last Wednesday to Secretary of Health, Education and Welfare Elliot L, Richardson outlining the deprivation the 20 percent Social Security increase would impose on many and calling for a general policy dealing with the "interrelatedness of federal and stateald programs." No reply has been received as yet from Richardson, the AJCongress reported.

NEW DIFFICULTIES FOR SOVIET JEWISH EMIGRATION

WASHINGTON, Oct. 4 (JTA) -- The Soviet government announced yesterday now mee sures which will make the obtainment of an exit viss more difficult, David Korn, chairman of the Soviet Jewry Committee of the Jewish Community Council of Greater Washington, reported. Korn said that principal among these is the need for additional documents in order to obtain a visa.

Korn also reported that a group of 20 Jews attempted to meet yesterday with a member of the Politbureau in reference to a letter of protest it had sent to the Presidium of the Supreme Sowiet a month ago. The group watted the entire day and then was told that it would not be allowed, now or in the future, to discuss the demands made in the letter, Korn said. The letter had dealt with the right of Jewish emigration from the Soviet Union and Soriet persecution of Jews.

EBAN ASSAILS JDL:

NEW YORK, Oct. 4 (JTA).—Israelt Foreign Minister Abba Eban yesterday assalled the Jew-lah Defense League. "We don't need JDL people coming into Israel to interfere with a good relation growing for example between Israellis and the Arabs in Hebron," he said before viewers of the NBC-TVI's "The Today Show."

Ehan made this remark in response to a question posed by the program's moderator, Frank McGee, concerning the detainment in Israel of Rabbi Meir Kahane, leader of the JDL, on charges of allegedly shipping arms abroad to conduct terrorist activities. Eban refused to comment on the Kahane case but said, "...on the movement itself, our position is that we really do not need these organizations coming from abroad to tell us how to live with each other or with our Arab population."

In response to other questions from both Mc-Gee and Pauline Frederick, an NBC correspondent, Eban reiterated Israel's right to retaliate for terrorist actions, and called upon all nations to act against terrorist groups. Eban called the terrorist movement an "urgent obstacle" that needed to be removed "in order to create the basic atmosphere in which peaceful discussion can go forward."

Eban also hit the United Nations for being "wedded to the technique of public debate and rhetoric" and said that it's not "the most congenial arena in which private conciliation can so forward."

TIGHT SECURITY FOR ISRAEL ORCHESTRA

EAST LANSING, Mich., Oct. 4 (JTA) -- Tight security measures were in effect here last night during the performance of the Israel Philiarmonic Orchestra, More than 3500 persons attended the concert while several dozen Arab students from Michigan State University picketed outside the concert hall. The Arabs carried banners and chanted, "We are homeless Arabs." There were no incidents and the orchestra members were not aware of the picket line. The security measures taken last night were similar to that Sunday night when the orchestra performed at the Kennedy Center in Washington. Similar measures will be taken when the orchestra performs in Detroit, Flint and Ann Arbor in Michigan and other cities during the national tour celebrating Israel's 25th anniversary.

United Hias Service reported today that il Jewish emigrants, constituting three family units from the Soviet Union, arrived at Kennedy Airport on a flight from Rome. They will be reunited with relatives in Miami, Chicago and Oklahoma City. The new arrivals included Mr. and Mrs. Leib Spector and their son Shulim from Lyov, who will be joined with another son, Moshe, in Miami after a separation of 25 years. Leib Spector was a renowned cantor in the USSR and Shulim was both an electrical engineer and a music teacher.

The Jackson amendment provides that after Oct. 15, 1972, no country shall be eligible to receive most favored nation treatment, or to participate in any US government programs for credit or investment guarantees directly or indirectly if it denies its citizens the right or opportunity to emigrate or imposes more than a nominal tax on emigration or on other documents required to emigrate "for any purpose or cause whatsoever."

29 Senators Denounce Head Tax

Just before Jackson's press conference, a statement signed by 29 of the co-sponsoring Senators denouncing the Soviet visa fees was distributed by Sen. Jacob K, Javits (R,NY) and Sen. Hubert H, Humphrey (D. Minn.). The statement note, "The Jewish community of the Soviet Union has already suffered more than other elements of the Soviet population from discrimination."

Continuing, the statement observed: "It should be completely unacceptable to the US and the world that the survivors of the Nazi holocaust and their children again should be singled out for discriminatory treatment and be subjected to notorious ransom requirements impeding their natural desire to join with relatives and co-religionists in other lands."

At his press conference, Jackson brushed aside suggestions that the visa fees were an internal matter of the Soviet Union or that the UN, rather than the US, should raise the issue. "Il hope that our foreign policy is based on the central theme not only for the preservation of human freedom but for an extension of it," Jackson said, adding that "if we depend on the UN we'll all be in trouble."

According to Jackson, his amendment is a "clear signal" to the Soviet Union of the attitude of Congress toward legislation the Russians are interested in, and also to the administration and the people involved in trade relations with the Soviet Union. "We're not cramming it down anybody's throat," he stated. The administration will have ample time to tell the Russians what Congress wants, Jackson asserted. He said that at this time, when the USSR wants trade relations with the US and is asking for special credit and most favored nation treatment, the Soviet Union should be made to "adhere to certain specific conditions."

In a joint statement issued by Richard Maass, chairman of the National Conference on Soviet Jewry, and Jacob Stein, chairman of the Conference of Presidents of Major American Jewist Organizations, the two Jewish leaders, who last week issued a letter to Nixon urging the US to use its economic power to bring about changes in the Soviet Union's treatment of Jewish emigrants, stated today:

"The amendment to the East-West Trade Bill is a welcome bi-partisan initiative. It will serve to alert the Soviet Union that the American people will not sit tidly by while the Soviet Union exploits its citizens who wish to emigrate. Clearly the United States cannot offer economic concessions to the Soviet Union while Russia holds educated

Jews for ransom."

THE RUSSIANS ARE ARRIVING

WASHINGTON, Oct. 4 (JTA).—The White House confirmed today that arrangements were underway in connection with the invitations extended to Soviet leaders by President Nixon at last May's Moscow summit conference to visit the US. The leaders invited were President Nikolai V. Podgorny, Premier Aleksei N. Kosygin and Communist Party Secretary Leonid I. Brezhnev. The Washington Star said tonight that Brezhnev would visit the US next year and that the date of his visit and Itinerary would be announced by the White House after the elections.

JEWISH GROUP CLAIMS CREDIT FOR BOMBING OF PALESTINIAN OFFICE

PARIS, Oct. 4 (JTA).—An Arab library believed to serve as a front for most Palestinan organizations in France was blown up early this morning by an explosive charge. A Jewish organization calling itself "Massads," claimed responsibility for the explosion at the Palestine Library in norther Paris. The front window was shattered and part of the furniture destroyed. No one was injured in the blast. Books were still scattered

this morning all along the sidewalk.

Police investigators believe that the explosion was caused by a small bomb with a delaying mechsnism which had been placed in front of the main entrance several hours earlier. No arrests have been reported yet. Several minutes after the explosion, the French news agency, Agence France Presse, received a phone call from a spokesman claiming to represent the Massada group.

The spokesman told AFP "Massada has undertaken its first operation in response to the anti-Israeli and anti-Jewish terrorist campaign now in progress. An explosive charge was set off at the Palestine Library. Jewish terror will reply to anti-Semitic terror. This is our first warning." Massada is listed in the French Jewish Directory as "an ideological group with Jabotinsky tendencies" and is listed under the French Herut-Betar organization.

However, a Herut spokesman, Gerard Lelouche. told the Jewish Telegraphic Agency, that neither Herut nor Betar "had ever met anyone who is a member of the group and had not believed in its actual existence." He emphatically denied that his organization had anything to do with the explosion. Though the Jewish Defense League has some 50 members in France, none of them were available for comment.

Circles close to the Jewish community in France issued "an energetic condemnation" of the explosion, stressing that "the Jewish community condemns and abhors all forms of violence whoever their authors may be and whatever their objects." The community stressed that it had never heard about the Massada group and has no connection with it. The French information media devoted considerable space to the incident, seen by many observers here as the first instance of Jewish "anti-terrorism."

SOVIET ACTIVIST SENTENCED

NEW YORK, Oct. 4 (JTA) -- Yankel Khantsis, who went on trial last Thursday in Kirov, on charges of "anti-Soviet slander," has been sen tenced to 18 months in prison, Jewish sources reported today. They said Khantsis, who was subjected before the trial to "psychiatric treatment," had to be carried into court Saturday when he began exclaiming that he wanted to die. The defendant, who is in his 40s, was exiled for a time several years ago for "hooliganism" in connection with his attempt to enter the Dutch Embassy.

EXIT FEES ALTER CHARACTER BUT NOT VOLUME OF EMIGRATION

JERUSALEM, Oct. 4 (JTA) -- A Jewish Agency official reported today that the Soviet visa head tax on educated Jews seeking to leave Russia has altered the character of immigration from that country but has not affected its volume. Yehuda Dominitz, deputy director of the Agency's immigration department, said that 55,000 newcomers are expected in Israel by the end of this year, the highest number since 1963. He said the increase was due largely to the influx of Soviet Jews whose numbers are expected to be double last year's.

Jewish Agency Treasurer Leon Dultzin told members of the United Jewish Appeal Study Mission in Tel Aviv last night that the Soviet visa fees affected no more than 20 percent of the potential emigrants. "We expect some 50,000 Russian Jews to come to Israel," he said, adding that the absorption cost of each family would amount to about \$35,000.

Dominitz said that a total of 41,000 immigrants arrived in Israel between Jan.-Sept. of this year. He said that if anything, the visa fees spurred the

departure of Jews from the USSR. People not subjected to the fees for holders of academic degrees are advancing their departures for fear that if they delay, the fees might be extended to them, the official said.

Dominitz reported that immigration from North America has not picked up as was anticipated. The peak year was 1970 when 9472 immigrants arrived from North America. That figure has not been matched since, he said. The North American olim numbered 8122 last year and a similar number is expected this year, he said.

Dominitz said the biggest decline was from France, He said 5000 immigrants arrived from there in 1970, 3300 last year and barely 2500 are expected this year. Immigration from Asia and Africa has reached a new low--7000 last year and a probable 6000 this year, he said. But 5000 Jews are expected from South America this year compared to 4500 last year.

JORDANIAN ENVOY CRITICAL OF VIOLENCE AGAINST INNOCENT PEOPLE; BLASTS ISRAEL

UNITED NATIONS, Oct. 4 (JTA) -- Foreign Minister Salah Abu Zeid of Jordan, declaring his government "opposed to violence whatever its source or methods," told the General Assembly today that Jordan was "ready to participate effectively in any international measures to protect innocent civilians against violence." But, he added, Jordan also supports "the right of an occupied people, every occupied people, to effectively resist occupation and colonialism,"

Israel's policy of "bondage and enslavement," he said, poses "a mortal threat to the very survival of Jordan as a state and as a people." He assailed Israel for opposing the "constructive" idea of a Jordanian-Palestinian United Arab Kingdom with Arab Jerusalem as its capital.

Following Abu Zeid's speech, the Israeli Mission issued a one-sentence assertion that "the Jordanian Foreign Minister's acrimonious statement has again demonstrated that public polemics cannot contribute to the search for understanding between the parties to the Middle East conflict and that quiet, reticent dialogue is the only way to a peaceful agreement."

DAYAN DISMISSES IDEA OF PALESTINIAN GOVERNMENT-IN-EXILE

JERUSALEM, Oct. 4 (JTA) -- Defense Minister Moshe Dayan indicated on a television interview last night that he attaches little importance to Egyptian President Anwar Sadat's recent call to the Palestinians to set up a government-in-exile that Egypt would recognize. "The Palestinian government is in Amman and if they are not satisfied with that regime they should try to change it," Dayan said. His remark was the first public comment on the Sadat proposal by any Israeli government leader.

Dayan, addressing himself to the problem of terrorism, said that Israel must step up its war against the terrorists by employing the proper methods to counter the changing mode of terror ist operations. He did not elaborate but he is believed to have been referring to the extension of terrorist acts from the Middle East to European countries. Dayan praised the recent appointment of retired Gen. Aharon Yariv, former chief of military intelligence, to the newly, created post of special advisor to the Prime Minister. He refused to comment when asked if Yariv's appointment had anything to do with the campaign against terrorists

The Jordanian government, meanwhile, was reported today to be strengthening its armed forces on its northern border following reports that several hundred terrorists have been shifted from Lebanon to southern Syria. Jordan has reportedly warned Syria that it would not hesitate to cross the border and strike at terrorist bases inside Syrian territory. According to some reports, Jordan has received modern. American military equipment by sea and airlift.

DEFAULT IS NOT IN THE STARS, BUT IN ORDERS FROM ABOVE

TEL AVIV, Oct. 4 (JTA).—The Israeli chess team has won a 4-0 victory by default over Albania at the world championship chess tournament in Skopje, Yugoslavia. The Israeli team was credited with the win after the Albanian team informed the tournament management that it was forbidden by their government to play the Israelis The tournament management said the Albanian players were not to blame because they had "their orders from above." But other competing teams protested against awarding the victory to Israel because it puts the Israelis ahead of them on unearned points.

BITTER CONTEST EXPECTED IN RABBINATE ELECTIONS

JERUSALEM, Oct. 4 (JTA)—The Chief Rabbinate elections to be held Oct. 15 was shaping up today as a bitter contest in which die-hard conservatives will be opposed by candidates considered relatively liberal within the Orthodox religious spectrum. The 150-man electoral college that will vote for the candidates for Ashkenazi and Sephardi chief rabbis and for members of the Chief Rabbinate Council, was finally completed today after weeks of haggling.

Dr. Zerach Warhaftig, the Minister for Religious Affairs, announced today the appointment of the 10 rabbis which, according to Israeli law, are the appointment of the religious ministry, subject to Cabinet approval. Dr. Warhaftig reportedly sat up until late last night with Justice Minister Yaacov Shimshon Shapiro to complete the list. Shapiro, designated to represent the Cabinet on the matter, reportedly insisted on the inclusion of the Histadrut and Labor Party Rabbi Menachem Hacohen. An agreement was finally reached through the intercession of Premier Golda Meir and the final list was rushed to the printers to be officially gazetted,

Of the 10 rabbis appointed by Dr. Warhaftig, seven are said to be confirmed supporters of Tel Aviv's Chief Rabbi Shlomo Goren, regarded as a moderate. None are committed to the incumbent Ashkenazic Chief Rabbi Isser Yehuda Unterman who has the support of conservative elements. But of 24 rabbis named by an electoral assembly of their colleagues from small townships, 12 are for Rabbi Unterman, eight for Rabbi Goren and four are uncommitted,

The election picture was complicated yester-day when Tel Aviv's Sephardic Chief Rabbi Ovad-lah Yosef, announced his candidacy in opposition to the incumbent Sephardic Chief Rabbi Yitzhak Nissim who was hitherto unchallenged. Rabbi Yosef, like Rabbi Goren, is regarded as one of Israel's more "enlightened" rabbis. His enlightenment is measured by his *ecent ruling that slacks tailored for women are more permissable than mini-skirts according to halacha, religious law. Most other rabbis solidly oppose women wearing pants.

The rabbinate electoral college consists of 70 rabbis and religious lay leaders, 70 mayors, heads of district councils and local religious councils and the 10 rabbis named by the government. The Unferman camp was reportedly unhappy over Dr. Warhaftig's appointments which it considers stacked

in favor of Rabbi Goren whose candidacy is supported by the Labor Party and the National Religious Party. Some Unterman supporters have called for a rabbinical boycott of the elections on grounds that the electoral college was rigged by the government.

TWO SOVIET JEWISH PRISONERS DESCRIBE CONDITIONS IN LABOR CAMPS

TEL AVIV, Oct. 4 J/TA)--Arkady Voloshin and Lazar Abramovich Trakhtenberg, arriving here early this morning after serving prison terms decreed in Kishinev, confirmed that Sylva Zalmanson Kuznetsov, the 28-year-old engineer serving a ten-year term ending in June, 1980, was transferred from Potma prison two weeks ago to solitary confinement for six months for aiding another Jewish woman prisoner. Convicted of complicity in a skyjacking plot, she has long been reported in worsening health.

Voloshin, 27, and Trakhtenberg, 26, went on trial in Kishinev in June, 1971. They were convicted on "anti-Soviet propaganda" and sentenced to two-year terms dating to their arrest in Aug. 1970. Arriving here with a large group of Soviet emigrants, they reported that the situation of the Jewish prisoners in Potma, in Soviet Mordovia, is deteriorating because of the authorities' persistent "anti-Semitism." They said "clashes with the camp's management" over adequate medical care and normal routines "are a daily occurrence."

Trakhtenberg and Voloshin told how they and two other Jewish prisoners conducted a Hebrew ulpan without books in that language, as the five books allowed each of them contained no Hebrew. They said the ulpan was conducted from memory. They stated that Soviet Jews' desire for allya had reached massive proportions, commenting: "Since our release we have visited some friends and seen in the various cities long queues near the Ovir (visa) offices of Jews desiring to come to Israel." Among those welcoming the two ex-immates were Trakhtenberg's wife and Voloshin's fiance; the latter came to Israel only a few months ago.

3 GROUPS REJECT INVITATION TO ATTEND MEETING ON FUENTES APPOINTMENT

NEW YORK, Oct. 4 (JTA)—Three Jewish organizations today rejected the invitation of Community School Board No. 1, Manhattan, to attend an executive meeting of the Board on the appointment of Luis Fuentes as District Superintendent. Instead they invited the Board to join them in requesting Chancellor Harvey B, Scribner to review the case of Fuentes who, they charged, is unqualified for the post because of anti-Semitic slurs made by him as a Brooklyn principal.

They said that since the local board itself was accused of "dereliction of duty" in the matter, it could not "sit in judgment" upon itself. If Dr. Scribner continues to refuse to hear the case, the organizations said, the local board should join them in requesting that State Education Commissioner Ewald B, Nyquist take jurisdiction.

The American Jewish Congress, Anti-Defamation League of B'nai B'rith and Jewish Labor Committee, which have protested the Fuentes appointment, charged the local school board with dereliction of duty in not assessing Fuentes' past record and judging him unfit for the new post. The letter today, in response to the invitation of Mrs. Georgina Hoggard, chairwoman of School Board No. I, was sent by Victor Herwitz, special counsel for the three organizations.

GROUP ESTABLISHES MEMORIAL FUND FOR THE 11 SLAIN ISRAELI ATHLETES

MINNEAPOLIS, Oct. 4 (JTA)—A sports center mororializing the Il Israeli athletes murdered in Munich during the Summer Olympics will be built at an Israeli kibbuts if a newly formed organization here can raise \$150,000. A Minneapolis Israel Olympic Memorial Fund has been created by Mayor Charles Stenvig, who visited Israel two years ago and said he was impressed with Israelis' energy, dedication and determination.

The complex would include facilities for track and field, basketball, volleyball, gymnastics and other activities, and would be known as the Minneapolls Sports Center in Honor of the 11 Martyred Olympic Team Members. The fund drive, headquartered at Midwest Federal Savings and Loan, is chaired by Harold Greenwood, Jr., of the bank, with Mayor Stenvig as bonorary chairman. The large majority of the civic leaders, businessmen and athlets participating in the fund drive are non-Jewish, according to the Minneapolis Federation for Jewish Service.

SENIOR CITIZENS, MANY JEWS, MAY BE HURT BY NEW SOCIAL SECURITY MEASURE

NEW YORK, Oct. 4 (JTA).—The American Jewish Congress to danct special emergency legislation that would protect the nation's elderly by requiring state officials to disregard the new Social Security increase in computing eligib.:ity for other federally-funded health and welfare henefits

A 20 percent increase in Social Security benefits to the elderly went into effect yesterday but is likely to have "a negative impact on many senior citizens nationwide who will now be above eligible income levels for other aid programs," the AJCongress asserted.

Howard M. Squadron, chairman of the Congress' national governing council, said passage of emergency legislation would "offer immediate protection to those persons whose participation in special programs is threatened by the Social Security increase." Two-thirds of the nation's estimated 800,000 Jewish poor are reported to be over 65 years of age and currently benefitting from Social Security and other federal programs,

"The new and welcome Social Security increase will be a bitter hoax to many if instead of delivering the help it promises, it actually results in deprivation," Squadron stated. "Tens of thousands of Social Security recipients throughout the country now find themselves, as a result of the increase, ineligible to receive other benefits, such as food stamps and Medicaid. For these and many others, the Social Security increase may also be wiped out by decreased Old Age Assistance payments."

Squadron noted that the AJCongress had written last Wednesday to Secretary of Health, Education and Welfare Elliot L, Richardson outlining the deprivation the 20 percent Social Security increase would impose on many and calling for a general policy dealing with the "interrelatedness of federal and stateald programs." No reply has been received as yet from Richardson, the AJCongress reported.

NEW DIFFICULTIES FOR SOVIET JEWISH EMIGRATION

WASHINGTON, Oct. 4 (JTA) -- The Soviet government announced yesterday now mee sures which will make the obtainment of an exit viss more difficult, David Korn, chairman of the Soviet Jewry Committee of the Jewish Community Council of Greater Washington, reported. Korn said that principal among these is the need for additional documents in order to obtain a visa.

Korn also reported that a group of 20 Jews attempted to meet yesterday with a member of the Politbureau in reference to a letter of protest it had sent to the Presidium of the Supreme Sowiet a month ago. The group watted the entire day and then was told that it would not be allowed, now or in the future, to discuss the demands made in the letter, Korn said. The letter had dealt with the right of Jewish emigration from the Soviet Union and Soriet persecution of Jews.

EBAN ASSAILS JDL:

NEW YORK, Oct. 4 (JTA).—Israelt Foreign Minister Abba Eban yesterday assalled the Jew-lah Defense League. "We don't need JDL people coming into Israel to interfere with a good relation growing for example between Israellis and the Arabs in Hebron," he said before viewers of the NBC-TVI's "The Today Show."

Ehan made this remark in response to a question posed by the program's moderator, Frank McGee, concerning the detainment in Israel of Rabbi Meir Kahane, leader of the JDL, on charges of allegedly shipping arms abroad to conduct terrorist activities. Eban refused to comment on the Kahane case but said, "...on the movement itself, our position is that we really do not need these organizations coming from abroad to tell us how to live with each other or with our Arab population."

In response to other questions from both Mc-Gee and Pauline Frederick, an NBC correspondent, Eban reiterated Israel's right to retaliate for terrorist actions, and called upon all nations to act against terrorist groups. Eban called the terrorist movement an "urgent obstacle" that needed to be removed "in order to create the basic atmosphere in which peaceful discussion can go forward."

Eban also hit the United Nations for being "wedded to the technique of public debate and rhetoric" and said that it's not "the most congenial arena in which private conciliation can so forward."

TIGHT SECURITY FOR ISRAEL ORCHESTRA

EAST LANSING, Mich., Oct. 4 (JTA) -- Tight security measures were in effect here last night during the performance of the Israel Philiarmonic Orchestra, More than 3500 persons attended the concert while several dozen Arab students from Michigan State University picketed outside the concert hall. The Arabs carried banners and chanted, "We are homeless Arabs." There were no incidents and the orchestra members were not aware of the picket line. The security measures taken last night were similar to that Sunday night when the orchestra performed at the Kennedy Center in Washington. Similar measures will be taken when the orchestra performs in Detroit, Flint and Ann Arbor in Michigan and other cities during the national tour celebrating Israel's 25th anniversary.

United Hias Service reported today that il Jewish emigrants, constituting three family units from the Soviet Union, arrived at Kennedy Airport on a flight from Rome. They will be reunited with relatives in Miami, Chicago and Oklahoma City. The new arrivals included Mr. and Mrs. Leib Spector and their son Shulim from Lyov, who will be joined with another son, Moshe, in Miami after a separation of 25 years. Leib Spector was a renowned cantor in the USSR and Shulim was both an electrical engineer and a music teacher.
