DAYAN, ALLON SAY THERE WILL BE NO

NEW MIDEAST WAR IN NEAR FUTURE

TEL AVIV, Oct. 5 (JTA) -- Two leading Cabinet ministers expressed the belief last night that there will be no new war in the Middle East in the immediate future. Defense Minister Moshe Dayan told 300 members of the United Jewish Appeal Study Mission, "I think the Arabs will not renew total war against us." Yigal Allon, Deputy Prime Minister and Minister of Education and Culture, addressing a Labor Party rally in Netanya, said that Egypt would not start a war against Israel because it kn such an adventure would end in defeat. The Egyptians instead are concentrating on trying to bring international pressure to bear on Israel to make concessions, he said.

Dayan, replying to questions from the visiting UJA leaders at a reception in the garden of his home here, stated: "I believe the Russians did not withdraw from this area completely, but they learned a lesson and drew the conclusion that it was not worth while to enter into active war with Israel. Under those circumstances, I think the Arabs will not renew total war against us." He added that Israel must continue to fight Arab terrorism and at the same time learn to live with it because the terrorists might now and then succeed in inflicting

Dayan discussed the Russian presence in Syria earlier in the day at a meeting with the Moetzet Hapoalot (Pioneer Women), the women's section of the Labor movement. He said that in his opinion the Russians were not likely to protect the skies over Syria in the event of war with Israel to the extent that they set up air defenses over Egypt.

Not Indifferent To Jordan's Peace Signals

He said the Russians have increased their penetration into Syria by means of arms supplies and political support, but they have not committed themselves to take an active part if war broke out. Dayan said that Russian aid to Syria has taken the form of material aid so far rather than personnel but, he added, "that might also come."

Dayan said Israel was not indifferent to "peace" signals from Jordan, but warned that there was a large gap between the positions of both countries. For that reason, he noted, peace was not imminent. He said Jordan was prepared to accept only minor border adjustment whereas in Israel even the minimalists insist on substantial boundary changes. In addition, Dayan stated, there was the question of Jerusalem's status and of the Arab refugees.

Transport Minister Shimon Peres, addressing a Labor Party rally in Petach Tikva, said Egypt may have dissociated itself from the Russians but was allied with the most extreme elements in the Arab world--El Fatah and the regime of Col. Muammar el-Qaddafi of Libya. He said the regime in Damascus appeared stable but might be undermined if it enters into an alliance with the Russians. He predicted that the Russians would eventually depart from Syria as they had from Egypt.

VISAS FEES 'FIRST STAGE OF A HORRIBLE TRAP,' SAYS MRS, MEIR

TEL AVIV, Oct. 5 (JTA) -- Premier Golda Meir charged today that the exorbitant visa fees demanded by Soviet authorities from educated Jews seeking to emigrate represent only "the first stage of a hor-

rible trap the Russians are preparing for Jews there." According to Mrs. Meir. "The ransom money plan is not only aimed at Jewish academicians but is part of a plan aimed at all Russian Jews. If the ransom plan succeeds no one can say or even imagine what horrible things the Russians plan for the future," she said.

The Premier spoke at a special meeting of the Histadrut Council on Russian Jews and Jews in Arab lands. The Council unanimously adopted a resolution calling on the International Labor Organization to safeguard the rights of Jewish scientists and workers in Russia. The resolution was based on a request signed by 31 Russian Jews who appealed to the Histadrut for help. They said they lost their jobs after asking for visas to emigrate to Israel. The visas were not granted and they remain unemployed.

INTELLECTUALS FOR TREPPER

PARIS, Oct. 5 (JTA) -- Four leading members of France's intellectual community have addressed a petition to visiting Polish Communist Party Secretary Edward Gierek on behalf of Leopold Trepper, the World War II master spy who has been denied a visa to leave Poland. The petition was in support of Trepper's request to come to Paris for the libel trial he instituted against Jean Rochet, head of the French espionage organization, who had accused Trepper of collaboration with the Gestapo during the war.

The signers were Simone de Beauvoir, Jean-Paul Sartre, Simone Signoret and Yves Montand. Mme de Beauvoir today visited four members of the Leopold Trepper Defense Committee who began a hunger strike Monday to coincide with Gierek's visit to Paris. She encouraged them to continue their fast as long as Gierek is here. Gilles Perrault, head of the committee, and author of a book about Trepper and the "Red Orchestra, predicted success. "Even if Poland forbids Trepper from coming to Paris, they will sooner or later let him emigrate to Israel." he said.

FORMER CATHOLIC TEACHER HONORED FOR SAVING 2000 JEWISH CHILDREN FROM NAZIS

NEW YORK, Oct. 5 (JTA) -- A Catholic exteacher who helped save 2000 Jewish children from the Nazis was honored by the Israeli Consulate here today and presented with the Medal of the Righteous People on behalf of Yad Vashem. Ambassador David Rivlin, Israeli Consul General, noted in his remarks that the silver medal bore the inscription, in Hebrew: "He who saves one soul is likened to he who saves the entire world."

Mrs. Jeanne Daman-Scaglione, now of Chapel Hill, North Carolina, told the Jewish Telegraphic Agency after the ceremony that she had decided to help persecuted Jews in her native Belgium for "rational" and "moral" reasons because of the "political" situation and for "emotional" reasons because of her "compassion" for the

Her family had been "very anti-Fascist," she said, and "my sense of responsibility became so strong that I would have felt guilty if I had not done what I did." She added in this connection that she felt Pope Pius XII bore a heavy responsibility for not speaking out against the persecution of Jews by the Nazis. The former underground fight-

er declared that although she is nominally a Catholic, she has "more empathy for the Jewish vision of life than for any other vision."

Mrs. Daman-Scaglione, now 50, was in her early 20s when she helped Jewish children escape death. Her uncle was killed in Mauthausen, and her cousin was incarcerated in Rayensbrueck. Her husband, Prof. Aldo Scaglione, teaches European literature at the University of North Carolina. Mrs. Daman-Scaglione, now a member of the United Jewish Appeal's Speakers' Bureau, helped rehabilitate saved children after the war and often visits survivors-now adults and parents-in Israel.

In presenting the medal, Rivlin--"representing the entire State of Israel and indeed the entire Jewish people"-offered "heartfelt gratitude" for Mrs. Daman-Scagitone's achievement of "so many great things in hours of darkness and stress for the Jewish people...victims of the most horrible cruelities in history. "She had "restored our faith" in the non-Jewish community, he said. The recipient responded with praise for the "courage and tenacity" of Jews in their effort to "rise above disaster and build anew in the noblest potential of the human spirit."

NIXON ASKED TO PROVIDE VISAS FOR SYRIAN JEWS WISHING TO ENTER U.S.

NEW YORK, Oct. 5 (JTA).—President Nixon was asked by the Conference of Presidents of Major American Jewish Organizations to make "a personal appeal to the Syrian authorities to permit Syrian Jews who wish to emigrate to the United States to do so." The request was made in a letter to the President from Jacob Stein, chairman of the Presidents Conference.

Pointing cut that Syria's 4500 Jews "are suffering harsh terms of living, restricted employment and forbidden emigration," Stein said that the membership of the 25 national organizations comprising the Presidents Conference "feel a deep sense of anxiety and anguish" over the fate of the Syrian Jews. Nixon was asked to make "a statement that our government, under the (Attorney General's) parole authority provisions, would grant visas to all Syrian Jews who wish to emigrate to the United States." Presently, Jews from the Soviet Union are entering the US under the parole authority.

REPORT JEWISH STUDENT TRIED IN SECRET BY DAMASCUS MILITARY COURT U.S. Investigating Case

WASHINGTON, Oct. 5 (1TA)—The State Department salt today that it was investigating the case of Jonathan Bates, a NY graduate student being secretly trited by a military court in Damascus for alleged espionage. Bates is reportedly of Jewish origin and reportedly spent some months in Israel before he was arrested in Syria last Feb. 9.

State Department spokesman John King said the Department learned only in recent days of Bates' arrest and trial. The US has no diplomatic relations with Syria. American interests are handled by the Italian Embassy in Damascous. King said Bates is the son of Prof. Ralph Bates of New York, whom he desortbed as a British subject.

The Bates case was linked to the arrest by Syrian authorities a month ago of Maj. Robert H. Barrett, assistant military attache of the US Embassy in Amman. Maj. Barrett was setzed by Syrian police while in transit from Jordan to Leb-

King disclosed today that Deya Fattel, an official of the Syrian Mission to the United Nations, has been served notice that his US visa has been revoked as of Oct. 2. The Department spokesman refused to disclose the reason for revocation of the visa. He said the notice was served on Fattel either in Rome or Damascus.

It was reported meanwhile that US authorities acting on the administration's promise to protect Israeli citizens from terrorist attacks after the Munich massacre of Il Israeli athletes, has begun a major effort to identify possible terrorists among Arabs residing in this country and to screen travelers from Arab lands. The State Department estimates there are about 6300 Arab students in the US.

KLARSFELDS DISCOVER ANOTHER NAZI

PARIS, Oct. 5 (JTA).—Beate and Serge Klarsfeld, the Nazi hunters who last year located Klaus Barble, the "butcher of Lyons," have tracked down the former head of the Paris Gestapo, Heinrich Illers. At a press conference here, Mr. and Mrs. Klarsfeld accused Illers of the death of 116 wartime hostages, shot in Bordeaux and Paris on Sept. 21, 1942. They also blamed him for the "death train" which deported 2166 persons from France to Germany on July 2, 1944.

Mrs. Klarsfeld turned over to French millitary courts her documentation concerning illers, who, by coincidence, resigned several days ago from his post as Senate President of the State Social Court in Celle, Germany. At a press conference Tuesday in Bonn, the Klarsfelds disclosed a list of 250 war criminals whose extradition they seek under the Franco-German agreement of Feb. 2, 1971. At that press conference, Serge Klarsfeld was arrested by Cologne police for his participation in an alleged kidnapping attempt last year of an ex-Nazi. Klarsfeld was released a few hours later on \$5000 bail.

BANK OWNED JOINTLY BY U.S.-ISRAEL INTERESTS OPENS IN ISRAEL

TEL AVIV, Oct. 5 (JTA).—The First International Bank of Israel, the first bank owned jointly by American and Israell interests, opened for business this week. It has assets of IL 1.5 billion and employs 900 persons in 34 branches here and abroad. The new venture is expected to pave the way for expanded participation by US firms and individuals in Israell business and industrial enterprises.

The principal stockholder is the First Pennsylvania Corp. which acquired 41.6 percent of the First international Bank's shares for \$16 million. Other stockholders are the Israel government, the Triumph Investment Trust of Great Britain, the Baldwin Securities Corp. of the US, the Israel Investors Corp., Samuel Rothberg of Peoria, Ill., and the Mayer Investment Corp. of Tel Aviv.

UN AFRICAN ENVOYS CONDEMN MUNICH MASSACRE

NEW YORK, Oct. 5 (JTA)--Israeli Foreign Minister Abba Eban, meeting here in recent days with leaders of African delegations to the United Nations General Assembly, was advised by them that they all condemned the Munich massacre of Il Israeli sthletes but were afraid to support blanket condemnation of terrorism for fear it would hurt legitimate national-liberation movements in Africa.

Concurrently, Israell sources said, the African delegates indicated that there was no reason to fear that Uganda's policy of expelling Asians and praising Hitler would be echoed by other African states. Regarding the Arab bloo; the African delegates indicated that little or no change can be expected in its attitude apart from such far-reaching matters as attempts to exclude Israel from UN bodies and institutions.

AJCOMMITTEE MOVES ON FUENTES CASE

NEW YORK, Oct. 5 (JTA).—The American Jewish Committee announced today that it would formally join Mrs. Antoinette Di Mauro, a member of Community School Board No. 1, in her request that State Education Commissioner Ewald Nyquist review without delay the fitness of Luis Fuentes to serve as Superintendent of School District 1. Fuentes' fitness and his appointment by the community school board, have been called into question because of anti-Semitic and other racial slurs he allegedly made while a principal in the former Ocean Hill-Brownsville school district in Brooklyn.

Daniel S. Shapiro, president of the NY chapter of the AICommittee, said it would petition Nyquist for leave to join Mrs. Di Mauro in her request. Mrs. Di Mauro's lawyer, Manhattan Assemblyman Antonio G. Olivieri, said yesterday that he would submit a request shortly to Nyquist to look into Fuentes' fitness to hold a state certificate as school superintendent. Mrs. Di Mauro also charges that she was unlawfully excluded by her fellow school board members from the selection process that resulted in Fuentes' appointment.

Robert D. Stone, counsel to the State Education Department, said the Commissioner would look into the matter if he is "presented with a request to annul Mr. Fuentes' certificate." Stone confirmed that "moral character was relevent to the continued possession" of a certificate.

Meanwhile, Victor J, Herwitz, the attorney representing three other Jewish organizations in the Fuentes case, told the Jewish Telegraphic Agency today that if Nyquist intends to hold a hearing they would ask to participate. The organizations—the American Jewish Congress, the Anti-Defamation League of B'nai B'rith and the Jewish Labor Committee-filed charges with city school Chancelor Harvey Scribner last Aug, accusing Fuentes of racist slurs and the community school board of "dereliction of duty" in appointing him superintendent

Herwitz said the action Nyquist may take against Fuentes would not necessarily affect their complaint against the school board which demands his dismissal. The Jewish groups have been joined by Italian community groups in their complaints of alleged racist remarks by the Puerto Rican school official.

B'NAI B'RITH URGES AFFILIATES TO CAMPAIGN FOR UN TREATY ON TERRORISM

WASHINGTON, Oct. 5 (JTA) -- A campaign of encouraging their respective governments to support a United Nations Convention against terrorism is being initiated by its affiliates throughout the world, B'nai B'rith reported. David M. Blumberg, B'nai B'rith president, in a telegram to Secretary of State William P. Rogers, expressed his organization's endorsement of the draft of an international treaty to prevent and punish terrorism which Rogers presented in his address Sept. 25 to the UN General Assembly. Blumberg commended the US effort as a "vigorous and worthy challenge" to the UN to act against terrorism. "International support is basic if the initiatives against terrorism taken by the United States are to be effective," he said. B'nai B'rith has units in 40 countries.

DEMONSTRATION AT BULGARIAN MISSION

NEW YORK, Oct. 5 (JTA).—Representatives of major Jewish organizations in the New York area demonstrated last night for almost three hours outside the Bulgarian Mission to the United Nations where top level Soviet officials were meeting at an official reception. The Greater New York Conference on Soviet Jewry coordinated the demonstration.

Other organizations represented on the picket line included the American Jewish Congress, B'nai B'rith, and the Student Struggle for Soviet

Glenn Richter, national coordinator of the SSSI, reported that Gavriel Shapitu, who was sentenced in July to one year at corrective labor, yesterday began to work in an automobile plant in Moscow. He is required to carry heavy car parts, Richter said, and has to turn over 20 percent of his income to the government.

17 SOVIET JEWS ARRIVE IN U.S.

NEW YORK, Oct. 5 (JTA).—Seventeen more Soviet Jews arrived at Kennedy Airport today to be reunited with relatives, United Hias Service reported. Eleven of them: entered under the parole authority of the US Attorney General; they included five members of the Berkovitch family, three members of the Spiegel family, two members of the Vizel family and one member of the Herskovic family. The Berkovitch, Vizel and Herskovic families were reunited with relatives of Youngstown, Ohlo, who came here today to welcome them. The Spiegel and Gross families will stay with relations in the Greater New York area. The home cities of the new arrivals were not available.

EBAN: ARABS' HOPE FOR ISRAEL'S ECONOMIC COLLAPSE HAS BEEN DENIED THEM

NEW YORK, Oct. 5 (JTA).—Foreign Minister Abba Eban told more than 200 Israel Bond leaders yesterday that the Arabs hope for an economic collapse of Israel to give them the victory that has been denied them on the military and political fronts. Addressing a luncheon meeting which produced a more than \$5 million sale of Israel Bonds for the strengthening of Israel's economy, Eban said:

"The Arabs know they cannot have military vitcory; they cannot have political victory. Therefore they are atming for economic victory over Israel, hoping that Israel's economy will fall beneath the sheer weight of the burdens she must carry." He assured his audience that "all of us together have the means of winning this battle," adding that growth is the essence of Israel and that is where "our partnership with you comes in."

LATIN AMERICAN JEWISH CONGRESS, WZO, TO HOLD CONFERENCE IN LIMA

BUENOS AIRES, Oct. 5 (JTA)--The sixth community conference convened by the Latin American Jewish Congress and the World Zionist Organization will be held in Lima, Peru Oct. 28-Nov. 2, it was announced today. About 250 delegates representing Jewish communities and Zionist federations in Latin America will attend.

The conference will be addressed by Louis A. Pincus, chairman of the World Zionist Executive, Dr. Nahum Goldmann, president of the World Jewish Congress, Gerhard Riegner, secretary general of the WJC, and Avraham Shenkar, head of the WJC/9 organization department. Yosef Kerler, the eminent Jewish poet who emigrated from the Soviet Union, and distinguished Peruvian personalities will participate in a mass meeting devoted to the problems of Soviet Jewry. The conference will also deal with such topics as Jewish community life, education, youth, the Middle East and the Zionist program.

Some 350,000 Jews have passed through Vienna since the Six-Day War on their way to relocation, mostly in Israel, according to Theodore D, Feder, associate director general of the JDC.

BEHIND THE HEADLINES

KAHANE'S FATE IN THE BALANCE

JERUSALEM, Oct. 5 (JTA)—Rabbi Meir Kahane's future hands in the balance. Strangely though, it does not lie in his hands to mould that future, to tip the scales. His future depends on the actions of the Arab terrorists on the one hand, and on the government of israel on the other. Rabbi Kahane is at present in Jail on remand, and the police have announced that he and his senior lieutenants are to be prosecuted—along with the former Irgun chief of operations, Amitai Paglix—on charges of attempting to smuggle arms out of the country. Rabbi Kahane and his Jewish Defense League have already publicly acknowledged responsibility for the arms smuggling attempt.

During the investigation, the JDL leader announced that he intended to set up his own political party, based on the JDL, for which he apparently hoped all those Israelis sympathetic towards his activities would vote. The new party would fight for the Knesset elections and Rabbi Kahane anticipated it would win "several" seats. Each Knesset seat needs some 12,000 votes.

It is the future actions of the Arab terrorists and the Israel government which will determine in the final analysis how many seats, if any, the JDL party will get. Their actions will also determine what sort trial Rabbi Kahané's will be: a regular criminal proceeding, or a full-dress political trial, with the government in effect indicted and defending its policies and the defendants in the trial in effect the prosecutors.

At the moment, some Israelis are by no means unsympathetic to what Rabbi Kahane attempted to do. And if there are more terrorist attacks abroad, more Israeli diplomats or visitors killed, or more installations subotaged, then this sympathy will inevitably grow, and the defense lawyers will be able to claim—as Paglin's lawyer, Knesseter Shmuel Tamir, has already claimed—that the accused acted out of frustration and the need to avenge Jewish blood.

The truth is that renewed terrorist attacks abroad are almost expected by Israeli officials. Ministers repeatedly warn that it will be a "long, drawn out and difficult struggle," and that every battle involves casualties. The question is whether Israel will find the means to fight back effectively, and to defeat the terrorists broad as they have been almost either destroyed or paralyzed within Israel and the occupied territories and along Jarael's borders.

Israel Does Not Need Private Armies

The question has of course a much broader significance than its effect on Rabbi Kahane's future; but for Rabbi Kahane it is crucial. If the current wave of Arab terrorism continues unchecked, and Israel does not effectively protect its citizens and installations abroad, then Rabbi Kahane and his lik will become not criminals but heros in the eyes of a great many Israelis. Already, now, there is vociferous criticism of alleged failures of the security services which heretofore had been the unimpeachable pride and glory of the whole country.

To still public disquiet, while the government thinks of ways to hit back at the terrorists, Premier Golda Meir speaks of Israel's long arm and of hitting at the terrorists wherever they are found. The appointment of Gen. Aheron Yarlv as "special advisor" was intended to fulfill both purposess to soothe public nerves and to help find effective means of combat against terrorism. Yigal Allon, Deputy Prime Minister and Minister of Education and Culture, has repeatedly ruled out the use of force on foreign soil. Others, like the military comentator

Haim Herzog, rule out nothing, but say sensibly enough that whatever is to be done must be done must be

Reprisal raids on terrorist bases across the northern borders make people feel better, but obviously do not solve the problem of terrorism in Europe. There had been a vigorous diplomatic offensive aimed at persuading foreign governments to tighten their own security, but only the US and West Germany have so far responded with similar vigor. And there is a limit to how strongly larsel can press; no European country wishes to turn its cities into armed camps and subject to turn its cities into armed camps and subject its citizens to a regime normally reserved for wartime in order to protect foreign nationals.

By the same token, no European government will contemplate with equalimity the prospect of Israel taking its own measures to protect its people, with Israell and Arab agents shooting it out on Oxford Street or the Via Veneto.

This is the measure of the Israel government's dilemma. The public here is aware of it, but is nevertheless impatient for effective action. For the present, the vast majority are ready to accept the government's position that security of Israeli citizens is the government's business, not that of private armies. But if nothing is done and the violence continues such private armies will increasingly gain sympathy or even admiration.

JEWISH FEDERATION CALLS ON NY JEWISH COMMUNITY FOR \$30 MILLION

NEW YORK, Oct. 5 (JTA)--The Federation of Jewish Philanthropies of New York is calling upon the Jewish community of Greater New York for \$30 million, it was announced by Lawrence B, Butteawleser, Federation president, as the 1972 Maintenance Campaign officially began tonight at an opening dinner at the Plaza Hotel, attended by more than 300 business and communal leaders. The Federation campaign will continue to Jan. Jl, 1973. More than 300 fund-raising and educational events will be conducted by the organization's Trades, Boroughs & Communities, Women's and New Leadership Divisions.

Alan V. Tishman, chairman of the current drive, said the campaign, which has as its theme "You Have A Right To Be Proud," seeks to raise \$5 1/2 million more than was raised by Federation last year, when it recorded the highest sum ever attained. Buttenwieser stated that the record amount requested in 1972 is needed to finance a wide variety of new and expanded services.

He explained that, in April, Federation voted an emergency grain of \$1.2 million to aid the inner-city Jewish poor and the "invitable" Jewish poor in such areas as Co-op City and West-chester, and to establish five Neighborhood Service Centers in various New York areas. For the current year's operations, Buttenwieser continued, Federation has increased its grants to member agencies by \$1 million.

Menachem Beigin will be the principal speaker at a State of Israel Bond dinner Oct. 12 in the New York Hilton, it was announced today by Samuel Neaman, chairman of the Greater New York Committee for State of Israel Bonds. The dinner, which will inaugurate the fall campaign for Israel Bonds in the New York metropolitan area, also marks Israel's 25th anniversary.

Jewish sources in New York reported that 20 Jews staged a silent vigil outside the Supreme Soviet in Moscow yesterday to protest the exit fees. There were no arrests.

Dayan said that Russian aid to Syria has taken the form of material aid so far rather than personnel but, he added, "that might also come."

Dayan said Israel was not indifferent to "peace" signals from Jordan, but warned that there was a large gap between the positions of both countries. For that reason, he noted, peace was not imminent. He said Jordan was prepared to accept only minor border adjustment whereas in Israel even the minimalists insist on substantial boundary changes. In addition, Dayan stated, there was the question of Jerusalem's status and of the Arab refugees.

Transport Minister Shimon Peres, addressing a Labor Party rally in Petach Tikva, said Egypt may have dissociated itself from the Russians but was allied with the most extreme elements in the Arab world--El Fatah and the regime of Col. Muammar el-Qaddafi of Libya. He said the regime in Damascus appeared stable but might be undermined if it enters into an alliance with the Russians. He predicted that the Russians would eventually depart from Syria as they had from Egypt.

VISAS FEES 'FIRST STAGE OF A HORRIBLE TRAP,' SAYS MRS, MEIR

TEL AVIV, Oct. 5 (JTA) -- Premier Golda Meir charged today that the exorbitant visa fees demanded by Soviet authorities from educated Jews seeking to emigrate represent only "the first stage of a hor-

rible trap the Russians are preparing for Jews there." According to Mrs. Meir. "The ransom money plan is not only aimed at Jewish academicians but is part of a plan aimed at all Russian Jews. If the ransom plan succeeds no one can say or even imagine what horrible things the Russians plan for the future," she said.

The Premier spoke at a special meeting of the Histadrut Council on Russian Jews and Jews in Arab lands. The Council unanimously adopted a resolution calling on the International Labor Organization to safeguard the rights of Jewish scientists and workers in Russia. The resolution was based on a request signed by 31 Russian Jews who appealed to the Histadrut for help. They said they lost their jobs after asking for visas to emigrate to Israel. The visas were not granted and they remain unemployed.

INTELLECTUALS FOR TREPPER

PARIS, Oct. 5 (JTA) -- Four leading members of France's intellectual community have addressed a petition to visiting Polish Communist Party Secretary Edward Gierek on behalf of Leopold Trepper, the World War II master spy who has been denied a visa to leave Poland. The petition was in support of Trepper's request to come to Paris for the libel trial he instituted against Jean Rochet, head of the French espionage organization, who had accused Trepper of collaboration with the Gestapo during the war.

The signers were Simone de Beauvoir, Jean-Paul Sartre, Simone Signoret and Yves Montand. Mme de Beauvoir today visited four members of the Leopold Trepper Defense Committee who began a hunger strike Monday to coincide with Gierek's visit to Paris. She encouraged them to continue their fast as long as Gierek is here. Gilles Perrault, head of the committee, and author of a book about Trepper and the "Red Orchestra, predicted success. "Even if Poland forbids Trepper from coming to Paris, they will sooner or later let him emigrate to Israel." he said.

FORMER CATHOLIC TEACHER HONORED FOR SAVING 2000 JEWISH CHILDREN FROM NAZIS

NEW YORK, Oct. 5 (JTA) -- A Catholic exteacher who helped save 2000 Jewish children from the Nazis was honored by the Israeli Consulate here today and presented with the Medal of the Righteous People on behalf of Yad Vashem. Ambassador David Rivlin, Israeli Consul General, noted in his remarks that the silver medal bore the inscription, in Hebrew: "He who saves one soul is likened to he who saves the entire world."

Mrs. Jeanne Daman-Scaglione, now of Chapel Hill, North Carolina, told the Jewish Telegraphic Agency after the ceremony that she had decided to help persecuted Jews in her native Belgium for "rational" and "moral" reasons because of the "political" situation and for "emotional" reasons because of her "compassion" for the

Her family had been "very anti-Fascist," she said, and "my sense of responsibility became so strong that I would have felt guilty if I had not done what I did." She added in this connection that she felt Pope Pius XII bore a heavy responsibility for not speaking out against the persecution of Jews by the Nazis. The former underground fight-

.

er declared that although she is nominally a Catholic, she has "more empathy for the Jewish vision of life than for any other vision."

Mrs. Daman-Scaglione, now 50, was in her early 20s when she helped Jewish children escape death. Her uncle was killed in Mauthausen, and her cousin was incarcerated in Rayensbrueck. Her husband, Prof. Aldo Scaglione, teaches European literature at the University of North Carolina. Mrs. Daman-Scaglione, now a member of the United Jewish Appeal's Speakers' Bureau, helped rehabilitate saved children after the war and often visits survivors-now adults and parents-in Israel.

In presenting the medal, Rivlin--"representing the entire State of Israel and indeed the entire Jewish people"-offered "heartfelt gratitude" for Mrs. Daman-Scagitone's achievement of "so many great things in hours of darkness and stress for the Jewish people...victims of the most horrible cruelities in history. "She had "restored our faith" in the non-Jewish community, he said. The recipient responded with praise for the "courage and tenacity" of Jews in their effort to "rise above disaster and build anew in the noblest potential of the human spirit."

NIXON ASKED TO PROVIDE VISAS FOR SYRIAN JEWS WISHING TO ENTER U.S.

NEW YORK, Oct. 5 (JTA).—President Nixon was asked by the Conference of Presidents of Major American Jewish Organizations to make "a personal appeal to the Syrian authorities to permit Syrian Jews who wish to emigrate to the United States to do so." The request was made in a letter to the President from Jacob Stein, chairman of the Presidents Conference.

Pointing cut that Syria's 4500 Jews "are suffering harsh terms of living, restricted employment and forbidden emigration," Stein said that the membership of the 25 national organizations comprising the Presidents Conference "feel a deep sense of anxiety and anguish" over the fate of the Syrian Jews. Nixon was asked to make "a statement that our government, under the (Attorney General's) parole authority provisions, would grant visas to all Syrian Jews who wish to emigrate to the United States." Presently, Jews from the Soviet Union are entering the US under the parole authority.

REPORT JEWISH STUDENT TRIED IN SECRET BY DAMASCUS MILITARY COURT U.S. Investigating Case

WASHINGTON, Oct. 5 (1TA)—The State Department salt today that it was investigating the case of Jonathan Bates, a NY graduate student being secretly trited by a military court in Damascus for alleged espionage. Bates is reportedly of Jewish origin and reportedly spent some months in Israel before he was arrested in Syria last Feb. 9.

State Department spokesman John King said the Department learned only in recent days of Bates' arrest and trial. The US has no diplomatic relations with Syria. American interests are handled by the Italian Embassy in Damascous. King said Bates is the son of Prof. Ralph Bates of New York, whom he desortbed as a British subject.

The Bates case was linked to the arrest by Syrian authorities a month ago of Maj. Robert H. Barrett, assistant military attache of the US Embassy in Amman. Maj. Barrett was setzed by Syrian police while in transit from Jordan to Leb-

King disclosed today that Deya Fattel, an official of the Syrian Mission to the United Nations, has been served notice that his US visa has been revoked as of Oct. 2. The Department spokesman refused to disclose the reason for revocation of the visa. He said the notice was served on Fattel either in Rome or Damascus.

It was reported meanwhile that US authorities acting on the administration's promise to protect Israeli citizens from terrorist attacks after the Munich massacre of Il Israeli athletes, has begun a major effort to identify possible terrorists among Arabs residing in this country and to screen travelers from Arab lands. The State Department estimates there are about 6300 Arab students in the US.

KLARSFELDS DISCOVER ANOTHER NAZI

PARIS, Oct. 5 (JTA).—Beate and Serge Klarsfeld, the Nazi hunters who last year located Klaus Barble, the "butcher of Lyons," have tracked down the former head of the Paris Gestapo, Heinrich Illers. At a press conference here, Mr. and Mrs. Klarsfeld accused Illers of the death of 116 wartime hostages, shot in Bordeaux and Paris on Sept. 21, 1942. They also blamed him for the "death train" which deported 2166 persons from France to Germany on July 2, 1944.

Mrs. Klarsfeld turned over to French millitary courts her documentation concerning illers, who, by coincidence, resigned several days ago from his post as Senate President of the State Social Court in Celle, Germany. At a press conference Tuesday in Bonn, the Klarsfelds disclosed a list of 250 war criminals whose extradition they seek under the Franco-German agreement of Feb. 2, 1971. At that press conference, Serge Klarsfeld was arrested by Cologne police for his participation in an alleged kidnapping attempt last year of an ex-Nazi. Klarsfeld was released a few hours later on \$5000 bail.

BANK OWNED JOINTLY BY U.S.-ISRAEL INTERESTS OPENS IN ISRAEL

TEL AVIV, Oct. 5 (JTA).—The First International Bank of Israel, the first bank owned jointly by American and Israell interests, opened for business this week. It has assets of IL 1.5 billion and employs 900 persons in 34 branches here and abroad. The new venture is expected to pave the way for expanded participation by US firms and individuals in Israell business and industrial enterprises.

The principal stockholder is the First Pennsylvania Corp. which acquired 41.6 percent of the First international Bank's shares for \$16 million. Other stockholders are the Israel government, the Triumph Investment Trust of Great Britain, the Baldwin Securities Corp. of the US, the Israel Investors Corp., Samuel Rothberg of Peoria, Ill., and the Mayer Investment Corp. of Tel Aviv.

UN AFRICAN ENVOYS CONDEMN MUNICH MASSACRE

NEW YORK, Oct. 5 (JTA)--Israeli Foreign Minister Abba Eban, meeting here in recent days with leaders of African delegations to the United Nations General Assembly, was advised by them that they all condemned the Munich massacre of Il Israeli sthletes but were afraid to support blanket condemnation of terrorism for fear it would hurt legitimate national-liberation movements in Africa.

Concurrently, Israell sources said, the African delegates indicated that there was no reason to fear that Uganda's policy of expelling Asians and praising Hitler would be echoed by other African states. Regarding the Arab bloo; the African delegates indicated that little or no change can be expected in its attitude apart from such far-reaching matters as attempts to exclude Israel from UN bodies and institutions.

AJCOMMITTEE MOVES ON FUENTES CASE

NEW YORK, Oct. 5 (JTA).—The American Jewish Committee announced today that it would formally join Mrs. Antoinette Di Mauro, a member of Community School Board No. 1, in her request that State Education Commissioner Ewald Nyquist review without delay the fitness of Luis Fuentes to serve as Superintendent of School District 1. Fuentes' fitness and his appointment by the community school board, have been called into question because of anti-Semitic and other racial slurs he allegedly made while a principal in the former Ocean Hill-Brownsville school district in Brooklyn.

Daniel S. Shapiro, president of the NY chapter of the AICommittee, said it would petition Nyquist for leave to join Mrs. Di Mauro in her request. Mrs. Di Mauro's lawyer, Manhattan Assemblyman Antonio G. Olivieri, said yesterday that he would submit a request shortly to Nyquist to look into Fuentes' fitness to hold a state certificate as school superintendent. Mrs. Di Mauro also charges that she was unlawfully excluded by her fellow school board members from the selection process that resulted in Fuentes' appointment.

Robert D. Stone, counsel to the State Education Department, said the Commissioner would look into the matter if he is "presented with a request to annul Mr. Fuentes' certificate." Stone confirmed that "moral character was relevent to the continued possession" of a certificate.

Meanwhile, Victor J, Herwitz, the attorney representing three other Jewish organizations in the Fuentes case, told the Jewish Telegraphic Agency today that if Nyquist intends to hold a hearing they would ask to participate. The organizations—the American Jewish Congress, the Anti-Defamation League of B'nai B'rith and the Jewish Labor Committee-filed charges with city school Chancelor Harvey Scribner last Aug, accusing Fuentes of racist slurs and the community school board of "dereliction of duty" in appointing him superintendent

Herwitz said the action Nyquist may take against Fuentes would not necessarily affect their complaint against the school board which demands his dismissal. The Jewish groups have been joined by Italian community groups in their complaints of alleged racist remarks by the Puerto Rican school official.

B'NAI B'RITH URGES AFFILIATES TO CAMPAIGN FOR UN TREATY ON TERRORISM

WASHINGTON, Oct. 5 (JTA) -- A campaign of encouraging their respective governments to support a United Nations Convention against terrorism is being initiated by its affiliates throughout the world, B'nai B'rith reported. David M. Blumberg, B'nai B'rith president, in a telegram to Secretary of State William P. Rogers, expressed his organization's endorsement of the draft of an international treaty to prevent and punish terrorism which Rogers presented in his address Sept. 25 to the UN General Assembly. Blumberg commended the US effort as a "vigorous and worthy challenge" to the UN to act against terrorism. "International support is basic if the initiatives against terrorism taken by the United States are to be effective," he said. B'nai B'rith has units in 40 countries.

DEMONSTRATION AT BULGARIAN MISSION

NEW YORK, Oct. 5 (JTA).—Representatives of major Jewish organizations in the New York area demonstrated last night for almost three hours outside the Bulgarian Mission to the United Nations where top level Soviet officials were meeting at an official reception. The Greater New York Conference on Soviet Jewry coordinated the demonstration.

Other organizations represented on the picket line included the American Jewish Congress, B'nai B'rith, and the Student Struggle for Soviet

Glenn Richter, national coordinator of the SSSI, reported that Gavriel Shapitu, who was sentenced in July to one year at corrective labor, yesterday began to work in an automobile plant in Moscow. He is required to carry heavy car parts, Richter said, and has to turn over 20 percent of his income to the government.

17 SOVIET JEWS ARRIVE IN U.S.

NEW YORK, Oct. 5 (JTA).—Seventeen more Soviet Jews arrived at Kennedy Airport today to be reunited with relatives, United Hias Service reported. Eleven of them: entered under the parole authority of the US Attorney General; they included five members of the Berkovitch family, three members of the Spiegel family, two members of the Vizel family and one member of the Herskovic family. The Berkovitch, Vizel and Herskovic families were reunited with relatives of Youngstown, Ohlo, who came here today to welcome them. The Spiegel and Gross families will stay with relations in the Greater New York area. The home cities of the new arrivals were not available.

EBAN: ARABS' HOPE FOR ISRAEL'S ECONOMIC COLLAPSE HAS BEEN DENIED THEM

NEW YORK, Oct. 5 (JTA).—Foreign Minister Abba Eban told more than 200 Israel Bond leaders yesterday that the Arabs hope for an economic collapse of Israel to give them the victory that has been denied them on the military and political fronts. Addressing a luncheon meeting which produced a more than \$5 million sale of Israel Bonds for the strengthening of Israel's economy, Eban said:

"The Arabs know they cannot have military vitcory; they cannot have political victory. Therefore they are atming for economic victory over Israel, hoping that Israel's economy will fall beneath the sheer weight of the burdens she must carry." He assured his audience that "all of us together have the means of winning this battle," adding that growth is the essence of Israel and that is where "our partnership with you comes in."

LATIN AMERICAN JEWISH CONGRESS, WZO, TO HOLD CONFERENCE IN LIMA

BUENOS AIRES, Oct. 5 (JTA)--The sixth community conference convened by the Latin American Jewish Congress and the World Zionist Organization will be held in Lima, Peru Oct. 28-Nov. 2, it was announced today. About 250 delegates representing Jewish communities and Zionist federations in Latin America will attend.

The conference will be addressed by Louis A. Pincus, chairman of the World Zionist Executive, Dr. Nahum Goldmann, president of the World Jewish Congress, Gerhard Riegner, secretary general of the WJC, and Avraham Shenkar, head of the WJC/9 organization department. Yosef Kerler, the eminent Jewish poet who emigrated from the Soviet Union, and distinguished Peruvian personalities will participate in a mass meeting devoted to the problems of Soviet Jewry. The conference will also deal with such topics as Jewish community life, education, youth, the Middle East and the Zionist program.

Some 350,000 Jews have passed through Vienna since the Six-Day War on their way to relocation, mostly in Israel, according to Theodore D, Feder, associate director general of the JDC.

BEHIND THE HEADLINES

KAHANE'S FATE IN THE BALANCE

JERUSALEM, Oct. 5 (JTA)—Rabbi Meir Kahane's future hands in the balance. Strangely though, it does not lie in his hands to mould that future, to tip the scales. His future depends on the actions of the Arab terrorists on the one hand, and on the government of israel on the other. Rabbi Kahane is at present in Jail on remand, and the police have announced that he and his senior lieutenants are to be prosecuted—along with the former Irgun chief of operations, Amitai Paglix—on charges of attempting to smuggle arms out of the country. Rabbi Kahane and his Jewish Defense League have already publicly acknowledged responsibility for the arms smuggling attempt.

During the investigation, the JDL leader announced that he intended to set up his own political party, based on the JDL, for which he apparently hoped all those Israelis sympathetic towards his activities would vote. The new party would fight for the Knesset elections and Rabbi Kahane anticipated it would win "several" seats. Each Knesset seat needs some 12,000 votes.

It is the future actions of the Arab terrorists and the Israel government which will determine in the final analysis how many seats, if any, the JDL party will get. Their actions will also determine what sort trial Rabbi Kahané's will be: a regular criminal proceeding, or a full-dress political trial, with the government in effect indicted and defending its policies and the defendants in the trial in effect the prosecutors.

At the moment, some Israelis are by no means unsympathetic to what Rabbi Kahane attempted to do. And if there are more terrorist attacks abroad, more Israeli diplomats or visitors killed, or more installations subotaged, then this sympathy will inevitably grow, and the defense lawyers will be able to claim—as Paglin's lawyer, Knesseter Shmuel Tamir, has already claimed—that the accused acted out of frustration and the need to avenge Jewish blood.

The truth is that renewed terrorist attacks abroad are almost expected by Israeli officials. Ministers repeatedly warn that it will be a "long, drawn out and difficult struggle," and that every battle involves casualties. The question is whether Israel will find the means to fight back effectively, and to defeat the terrorists broad as they have been almost either destroyed or paralyzed within Israel and the occupied territories and along Jarael's borders.

Israel Does Not Need Private Armies

The question has of course a much broader significance than its effect on Rabbi Kahane's future; but for Rabbi Kahane it is crucial. If the current wave of Arab terrorism continues unchecked, and Israel does not effectively protect its citizens and installations abroad, then Rabbi Kahane and his lik will become not criminals but heros in the eyes of a great many Israelis. Already, now, there is vociferous criticism of alleged failures of the security services which heretofore had been the unimpeachable pride and glory of the whole country.

To still public disquiet, while the government thinks of ways to hit back at the terrorists, Premier Golda Meir speaks of Israel's long arm and of hitting at the terrorists wherever they are found. The appointment of Gen. Aheron Yarlv as "special advisor" was intended to fulfill both purposess to soothe public nerves and to help find effective means of combat against terrorism. Yigal Allon, Deputy Prime Minister and Minister of Education and Culture, has repeatedly ruled out the use of force on foreign soil. Others, like the military comentator

Haim Herzog, rule out nothing, but say sensibly enough that whatever is to be done must be done must be

Reprisal raids on terrorist bases across the northern borders make people feel better, but obviously do not solve the problem of terrorism in Europe. There had been a vigorous diplomatic offensive aimed at persuading foreign governments to tighten their own security, but only the US and West Germany have so far responded with similar vigor. And there is a limit to how strongly larsel can press; no European country wishes to turn its cities into armed camps and subject to turn its cities into armed camps and subject its citizens to a regime normally reserved for wartime in order to protect foreign nationals.

By the same token, no European government will contemplate with equalimity the prospect of Israel taking its own measures to protect its people, with Israell and Arab agents shooting it out on Oxford Street or the Via Veneto.

This is the measure of the Israel government's dilemma. The public here is aware of it, but is nevertheless impatient for effective action. For the present, the vast majority are ready to accept the government's position that security of Israeli citizens is the government's business, not that of private armies. But if nothing is done and the violence continues such private armies will increasingly gain sympathy or even admiration.

JEWISH FEDERATION CALLS ON NY JEWISH COMMUNITY FOR \$30 MILLION

NEW YORK, Oct. 5 (JTA)--The Federation of Jewish Philanthropies of New York is calling upon the Jewish community of Greater New York for \$30 million, it was announced by Lawrence B, Butteawleser, Federation president, as the 1972 Maintenance Campaign officially began tonight at an opening dinner at the Plaza Hotel, attended by more than 300 business and communal leaders. The Federation campaign will continue to Jan. Jl, 1973. More than 300 fund-raising and educational events will be conducted by the organization's Trades, Boroughs & Communities, Women's and New Leadership Divisions.

Alan V. Tishman, chairman of the current drive, said the campaign, which has as its theme "You Have A Right To Be Proud," seeks to raise \$5 1/2 million more than was raised by Federation last year, when it recorded the highest sum ever attained. Buttenwieser stated that the record amount requested in 1972 is needed to finance a wide variety of new and expanded services.

He explained that, in April, Federation voted an emergency grain of \$1.2 million to aid the inner-city Jewish poor and the "invitable" Jewish poor in such areas as Co-op City and West-chester, and to establish five Neighborhood Service Centers in various New York areas. For the current year's operations, Buttenwieser continued, Federation has increased its grants to member agencies by \$1 million.

Menachem Beigin will be the principal speaker at a State of Israel Bond dinner Oct. 12 in the New York Hilton, it was announced today by Samuel Neaman, chairman of the Greater New York Committee for State of Israel Bonds. The dinner, which will inaugurate the fall campaign for Israel Bonds in the New York metropolitan area, also marks Israel's 25th anniversary.

Jewish sources in New York reported that 20 Jews staged a silent vigil outside the Supreme Soviet in Moscow yesterday to protest the exit fees. There were no arrests.
