LETTER BOMBS ADDRESSED TO NIXON, ROGERS, LAIRD, FOUND IN ISRAEL P.O. Believed To Be Work Of Terrorists Who Infiltrated Into Israel From Lebanon

TEL AVIV, Oct. 25 (JTA)--Letter bombe addressed to President Nixon, to Secretary of State William P., Rogers and Defense Secretary Melvin Laird were discovered today at the post office in Kiryat Shemona, a village near the Lebanese border. The bombs containing high explosives and an activating device were safely de-fused.

Police said they believe the letters were placed in the post office's outdoor mail drop by one or more terrorists who managed to infiltrate into Israel from Lebanon. (See separate stories for letter bomb carrier in Amsterdam and warnings in London.)

According to police, postal officials at Kiryat Shemona became suspicious of a letter addressed to Nixon with no return address. The cavelope seemed to contain a hard object. It was sent to the Tiberias police station for examination but before it arrived there two more similar letters were found addressed to Rogers and Laird. Police suggested that the terrorists were trying to implicate Israel in attempts on the lives of Nixon and the two Cabinet members.

Arab Notables May Be Next Targets

Meanwhile, Israell authorities have warned Arab notables on the West Bank, including Hebron Mayor Sheikh Mohammed Ali Jaabari, of possible terrorist attempts on their lives. The authorities said they learned of plans by extremist terrorist groups to assassinate the Arab leaders of Samaria and Judaea either by direct attack or with letter bombs.

The Arab dignitaries were warned to turn over to police for inspection all mail and gift parcels reaching them, mexpected or otherwise. Police said the letter bombs addressed to the American leaders were similar to those sent to various Israeli personalities here and abroad from Amsterdam last month.

(In Washington, White House press secretary Ronald Ziegler said "No comment" when asked for reaction to the letter bombs. At the State and Defense Departments spokesmen declined to comment immediately.)

ISRAELI EMBASSY STAFF, PROMINENT JEWISH BUSINESSMEN, WARNED TO BE ON LOOKOUT FOR BOOBY-TRAPPED NEW YEAR'S PARCELS New Device Has Lethal Cyanide Gas

LONDON, Oct. 25 (JTA)--Special Branch detectives have warned the Israell Embassy staff here to be on the alert for a new wave of letter bombs and booby-trapped parcels during the coming Christmas-New Year holiday season. They have also issued a warning against a new type of lethal mail that contains powder which turns into deadly cyanide gas when exposed to the air. Inhalation of the gas can be instantly fatal.

The Special Branch detectives said letter bombs and parcels would be addressed to Embassy staff members and to Jewish men and women prominent in the business and commercial world. Security men issued a special alert for gift wropped New Year's parcels addressed to diplomats "from Friends" and said the letter bombs could also come in the form of holiday greeting cards.

It was disclosed today that investigation of earlier letter bombs revealed that every diplomat who received one figures in the publication "The Zionist Year Book," The terrorists are believed to be working through the publication alphabetically and security men have been able to predict who the next recipients will be and warn them.

Meanwhite, scientists are investigating the cyanide letters. One was reportedly received recently by the Israeli Embassy in Bonn but news of it was withheld pending investigations. Interpol headquarters in West Germany has warned all countries with Israeli diplomatic missions to be on the alert.

ISRAEL AMAZED AT RELEASE BY DUTCH AUTHORITIES OF MAN WITH LETTER BOMBS

JERUSALEM, Oct. 25 (JTA).—Israeli sources expressed astonishment today over the speedy release by Dutch authorities of a man picked up in Amsterdam Monday with letter bombs and a suitcase filled with hand grenades, explosive chemicals, firearms and amanuntition. Israeli sources said the man was an Algerian diplomat assigned to Brazil. Dutch authorities said he was a Palestinian holding a Jordanian passport and that his destination was Venezuela.

There was no official comment here today but sources said the Foreign Ministry was in contact with the Dutch government to establish exactly what happened and what was learned from the interrogation of the Algerian.

(The Israeli Embassy in The Hague asked the Netherlands government today for "clarification" of the man's release yesterday, barely 24 hours after his arrest at Amsterdam Airport, The Embassy remarked that the attitude of Dutch authorities in this instance was "exaggeratedly liberal.") Cannot Detain People On Suspicion

According to reports from Amsterdam, the man, whose name was not disclosed, told the Dutch authorities that he did not know the contents of the suitcase and that he was merely doing a favor for a Syrian colleague who had asked him to deliver it to an Algerian Embassy in South America. The suspect was permitted to board a plane for Venezuela yesterday, but his luggage

was confiscated,
(Two Dutch Cabinet ministers, Interior Minister Willem Geertaema and Justice Minister Andries Van Agt said on a television interview last night that a democratic state like Holland "cannot detain people merely on suspicion of terrorism." They said the suspect was released because the police did not have a watertight case against him.)

Sources in Jerusalem said Israel was in contact with a number of governments, including South American governments. It was assumed that Israel would ask whatever country the bomb carrier was headed for to oust him as persona non grata. Israell officials stressed that the bomb carrier's apparent diplomatic status was further proof that some Arab governments are actively collaborating with the terrorist movements and that some Arab embassies serve as bases for terrorist operations. Israelis are convinced that the incident in Amsterdam was not an isolated one but part of a widespread phenomenon.

SISCO: MIDEAST 'SUBSTANTIALLY DE'-FUSED U.S. Arms Balance, Big Power

Summitry Cited As Factors CHICAGO, Oct. 25 (JTA) -- Joseph J. Sisco, the Assistant Secretary of State for Near Eastern Affairs, said here today that the Middle East has been tors--the 'positive impact" of Big Power summitry,

"substantially de-fused" as a result of three facthe cease-fire that has lasted more than two years and the US policy of maintaining the arms balance in the area.

Sisco and two other spokesmen for the Nixon administration participated in a series of briefings held here for the Chicago Board of Rabbis. The others were Donald Rumsfeld, Counselor to the President, and Lawrence Silberman, Undersecretary of Labor.

In reply to a question, Sisco described as "incorrect" a report that appeared in the Oct. 11 JTA Daily News Bulletin of a taped television interview with him broadcast in Israel the evening of Oct. 9. Sisco said that a study of the transcript of the interview did not support the lead carried in the JTA story and claimed that Israeli newspapers that monitored the interview did not come to the same conclusions as the JTA.

The JTA dispatch from Jerusalem reported that Sisco had offered a vigorous defense of the controversial Rogers Plan in which he stressed three basic points of the plan that he said tended to be forgotten. The JTA story also noted that Sisco's remarks on the Rogers Plan were in response to questions by the interviewer.

Soviet Jewry High On Nixon's Agenda

Sisco told the Chicago rabbis that US policy in the Middle East is to get a negotiating process started so that there can be a "peaceful resolution." He also reiterated that US policy is not to impose a peace settlement but to serve a useful role to help

both parties negotiate on boundaries and other items. Referring to the situation of Soviet Jews, Sisco said the State Department shares the "abhorrence" of all Americans over the education head tax levied by Soviet authorities on persons who want to emigrate. He said the problem was high on the President's agenda and that all levels of government will be used to deal with it. He said he favored the approach of "quiet diplomacy," adding that the events of recent weeks tend to show that it is working. Sisco also said that a resolution of this problem could play a useful role in the continued improvement in relations between the US and USSR,

Silberman discussed the issue of quotas in education and employment and accused the Democratic Presidential candidate, Sen. George McGovern, of advocating quotas. He quoted McGovern as saving on Oct. 4 that "goals and time tables are a useful tool to achieve parity," According to Silberman, parity was a standard of proportional representation which comes back to quotas." Rumsfeld discussed economic matters at the briefing.

HEAD TAX WAIVER MAY BE TACTICAL MOVE, NOT CHANGE OF POLICY

JERUSALEM, Oct. 25 (JTA) -- The recent exemption of some Jews leaving the Soviet Union from paying the education head tax was described by Foreign Minister Abba Eban in the Knesset today as a "welcome event." But he cautioned against speculation that the discriminatory tax may have been abrogated. "We have to see whether the exemptions are a one-time thing or whether they are the beginning of some kind of change" in Soviet policy, Eban said. He warned that the selective exemptions could be merely a "tactical move" by the Russians to mollify world opinion.

The Knesset passed by a 55-2 vote a motion call-

ing for action to alleviate the plight of Soviet Jews, especially those in prisons. The motion was urged by Gahal leader Menachem Beigin who accused the Soviet regime of "encouraging anti-Semitism." Only the New Communist faction voted against it.

NO FIGURES GIVEN REGARDING U.S CONTRIBUTION TOWARD CANAL REOPENING

WASHINGTON, Oct. 25 (JTA) -- State Department sources denied today that any figure was ever mentioned publicly or privately as to the possible contribution the US might make toward reopening the Suez Canal. The sources were commenting on a Beirut newspaper report yesterday that the US had offered Egypt \$100 million to begin clearing the canal.

The Beirut newspaper, An Nahar, quoted President Gaafer al-Nimeiry of Sudan as saying that he was told of the offer by President Anwar Sadat of Egypt when they met last March 15, three months before Sadat ordered most Soviet personnel out of

The State Department sources said the US always held the position that were an agreement worked out on the Suez reopening, the US would be prepared to help finance the work.

INDUSTRY IN ADMINISTERED AREAS POSES ECOLOGICAL DANGERS

JERUSALEM, Oct. 25 (JTA) -- The chairman of the Knesset's ecology committee has complained that industrial development in the administered territories is threatening serious environmental damage. Yosef Tamir, expressing his concern in a letter to Defense Minister Moshe Dayan, charged that industrial development in the Golan Heights has been undertaken without expert opinion on the environmental impact in the heights and on Lake Kinneret in Upper Galilee. He also complained of air pollution by military vehicles with faulty exhaust systems.

Tamir disclosed that Dayan promised in a reply to his letter to take up the matter of vehicular pollution with the Chief of Staff but said the other problems were the responsibility of the regular government departments. Tamir had expressed concern about a huge formica plant being planned near Hebron with no study of its possible ecological impact, and about the rise in the number of stone quarries on the West Bank from 150 to 500 in the past five years.

Four engineering professors from the Haifa Technion and the Nahal Sorek atomic research laboratory agreed at a meeting of the ecology committee Monday that anti-pollution laws would never be effective until they were the responsibility of one department instead of 14 ministries.

Leon Dultzin, Treasurer of the Jewish Agency, reported in Haifa that 23,000 Jewish immigrants have arrived in Israel from the Soviet Union so far this year and that a total of between 25-30,000 13 expected by the end of the year. Dultzin said that this was double the number of Soviet Jewish emigres who arrived last year, predicted that some 50-60,000 Jews will immigrate to Israel from the USSR in 1973, and said that about 120,000 Soviet Jews have applied for emigration visas. Dultzin noted that the influx of Jews from Russia this year brought total immigration figures up to expectations by off-setting a 20 percent drop in immigration from Western countries, notably the US, Britain and France. He said there was an increase in immigration from Latin America this year. CORRECTION: The joint conference of the WZO

COURT SUIT AGAINST TAX EXEMPTIONS ON FUNDS COLLECTED BY UJA, UIA

WASHINGTON, Oct, 25 (JTA)--Treasury Secretary George P. Schultz and Internal Revaue Commissioner Johnnie M. Walters were sued in United States District Court today by a group of seven anti-Zionista to ban exemptions of US taxes on funds collected in the US by the United Jewish Appeal and the United Israel Appeal. The suit demands that Schultz and Walters "collect all sums now due and owing" as a result of tax exemptions, "plus damages and interest." The plaintiffs estimated that this totals \$2.5 billion to date and that the exemptions "cost the American public a quarter of a billion dollars a year."

The plaintiffs charged that "the US government is fostering racial discrimination in financially adding the Israel Zionist program to keep Israel a furrely Jewish State in an ethnic sense," adding that "the targets of this discrimination are the Palestinians, chiefly Arabs." Sale of Israel government bonds, foreign aid, loans, grants and transfers "currently going" to Israel are not included in the suit. The Jewish Telegraphic Agency called the UJA for a response and was told there would be no immediate official comment.

The plaintiffs include Norman F. Dacey of Southbury, Conn., author of a full-page ad last June in the New York Times condemning aid to Israel; Prof. Ibrahim Abu Lughod, assistant director of the African Studies Department of Northwestern University; Prof. Norton Meavinsky of Connecticut State College; Prof. Isham Sharabi of Georgetown University here; the Rev. L. Humphrey Waltz, Presbyterian minister of Janesville, Wis.; and Michael K. Ross, Seattle lawyer and Washington State legislator.

Abdeen M. Jabara of Detroit, who represented the plaintiffs at a news conference today, is a lawyer of Lebanese descent and is president of Arab American University Gradutes, a national organization. He dented affiliation with the feda-yeen. Although the plaintiffs and Jabara charged that UJA money was promoting "racial discrimination," the attorney refused under questioning to define to which race Jews belong. He also side-stepped questions about whether he had ever protested oppression of Jews in Arab States.

TEKOAH REFUTES JORDANIAN CHARGES ON EAST JERUSALEM

UNITED NATIONS, Oct. 28 (JTA)—Israeli Ambasador Yosef Tekoah, replying this afternoon to a Jordanian condemnation earlier in the day of Israeli practices in East Jerusalem, said that Jordan's policy in Jerusalem before 1987 had "been one of ravage and devastation." Tekoah added that Jordan "apparently still cannot bear to see that since 1987 the ruins of Jerusalem have been rebuilt, that the reunited capital is developing and flourishing anew, that the universal religious interests of Christianity, islam and Judalem are fully protected, that the rights of all communities are assured and that Jews and Arabs live and work side by side in pagace."

Jordan "will go down in history as Jerusalem's amputator and destroyer," Tekoak charged. "During its forcible and illegal occupation of part of Jerusalem, Jordan razed to the ground the entire Jewish quarter of the Old City with all its 39 synagogues and institutions of learning, uprooted and exiled its Jewish population and barred free access to Judaism's holy places!" "Jerusalem "his had a Jewish minority for more than a century." Tekoah concluded, "and its present demographic composition and growth are a normal and natural

LAW TO PUT STIFFER ARM ON CRIMINALS

JERUSALEM, Oct. 28 (JTA).—An amendment to the criminal code providing stiffer penalties for orimes of violence and other offenses passed its first reading in the Knesset yesterday. The measure, introduced by Justice Minister Yaacov Shimshon Shapiro, would make mandatory harshers sentences for criminals using firearms, criminals who operate in gangs, protection racketeers and suborners of witnessess. Shapiro said the maximum penalty for running a protection racket would be increased from one year to 3-5 years.

The need for stiffer penalties for criminals was cited recently by Police Minister Shlomo Hillel who urged capital punishment for criminals who commit murder inside jails. Hillel said there are 330 prisoners serving life sentences in Israel who feel secure in the knowledge that whatever crime they commit in jail the worst that can happen is two weeks solitary confinement.

He said a bill will soon be introduced in the Knesset allowing police to hold criminals without bail pending trial. He added that while there is no "Mafia-style" organized crime in Israel there are well organized gangs engaged in robbery and extertion.

McGOVERN RAPS SOVIET RAP

WASHINGTON, Oct. 25 (JTA).-Sen. George McGovern, the Democratic Party Presidential candidate, said that the latest attack this week against him by the Soviet weekly. Za Rubezhon, the second time this month, "underscores the Kremlin's callous disregard for fundamental human rights." The Soviet weekly adopted a derisive tone toward McGovern's concern about Soviet Jewry. Answering what he termed "the mockery of my position in support of Soviet Jewry," the Democratic Presidential hopeful stated:

"The plight of Jews who wish to emigrate and are prevented by a huge exit tax is not a matter to be treated with derision. The cruel and erratic use of a ransom charge against would-be emigrants profoundly disturbs all who love freedom." Continuing, McGovern declared: "While President Nixon remains silent, I will continue to speak out on Soviet Jewry's struggle to be free. I will not fall victim to any scheme to embarrass and to silence those who fear for the safety of the Jewish community of the Soviet Union."

POLITICAL MOTIVE IN MURDER OF ARAB?

JERUSALEM, Oct. 28 (JTA)--Police are seeking a possible political motive in the murder Monday of Aziz Ali Sherif, son of Ali Sherif, a former member of the Jordanian parliament we recently called for the establishment of a Palestinian government-in-exile. The victim was shot to death by unknown assailants who abducted him from his Hebron home. His body was found on a road on the outskirts of the West Bank town. The elder Sharif appeared on Israel's Arabic political television program two weeks ago and supported a proposal by President Sadat that the Palestinians set up a government-in-exile which Egypt would recognize.

The Israel Cabinet decision this week to retain the 40,000-limit on Arab workers from the administered territories was regarded as a setback to those who have sought closer ties between Israelis and Arabs from the territories.

7 ORTHODOX, HASIDIC LEADERS ENDORSE NIXON FOR REELECTION....

WASHINGTON, Oct. 25 (JTA)--President Nixon was endorsed for re-election yesterday by seven Orthodox and Hasidic leaders. The endorsement, released by the White House, cited Nixon's "efforts to bring about a just and lasting peace so badly needed in a troubled world."

The letter praised Nixon's "noble efforts in inspiring our ccum'ry toward a greater commitment of moral values," his "leadership in stabilizing urban communities by restoring respect for and confidence in our judicial system," and his "most positive contribution to our entire educational system" through "financial aid to private and parochial schools,"

The endorsement was signed by Rabbi Joseph Ashkenazy, secretary to Grand Rabbi Joel Tettelbaum of United Satmar Institutes; Rabbi Martin Berkowitz, executive director, Central Rabbincal Congress of the USA and Canada; Rabbi Leopold Friedman, executive vice-president, United Talmudical Academy; Rabbi Chaim M. Stauber, secretary, National Committee of Orthodox Jewish Communities; Sender Deutsch, editor-publisher, Der Yid and other publications; Rabbi H, Frankel, chairman, Beth Rachel Educational System; and Berl Friedman, chairman, Yeshiva Torah V'Yirah of Boro Park (Brooklyn, N.Y.).

....51 RABBIS, ORGANIZATION LEADERS ENDORSE MCGOVERN

WASHINGTON, Oct. 25 (JTA)—McGovern campaign headquarters today released a statement by 51 American rabbis and leaders of national and local Jewish organizations supporting the election of Sen, George McGovern, the Democratic Presidential candidate. The signatories described themselves as "active leaders in Jewish life." Their statement specifically omitted their congregational and organizational affiliations because "They have signed this statement out of personal convictions as individuals in support of Sen. McGovern."

The statement listed "crime in the streets...inflation; unemployment, education and the Supreme Court" as major concerns in the 1972 elections. It compared the records of Nixon and McGovern on the issues of Soviet Jewry and support for Israel.

The signatories included Rabbi Roland Gittelsohn, Boston; Dr. William Haber, Ann Arbor, Mich.; Rabbi Abraham Joshua Heschel, N.Y.; Philip M. Klutznick, Chicago; Rabbi Arthur J. Lelyveld, Cleveland; Robert Nathan, Washington, D.C.; Rabbi Joachim Prinz, Orange, N.J.; Dore Schary, N.Y.; Herbert Tenzer, Lawrence, N.Y.; and Louis Weinstein, Boston.

Referring to Soviet Jewry, the statement noted that "At a time of crisis for Soviet Jewry, President Nixon is proposing to grant the Kremiin most favored nation status in its trade dealings with our country. In contrast, Sen McGovern has called on the President to withhold trade concessions to the USSR until the Soviets abandon their slave tax." The statement also noted that "Richard Nixon placed a moratorium on the delivery of desperately needed Phantom jets to Israel" while Sen, McGovern "played a key role in Congressional efforts to reverse the Nixon arms ban against Israel."

AZF CONCLAVE CALLS ON GOVERNMENTS, UN, TO CONDEMN SOVIET HEAD TAX

CHICAGO, Oct. 25 (JTA) -- The American Zionist

Federation, concluding its national convention here, called on all governments and the United Nations to "reject all extortion and ransom demands and to deal resolutely with those who barter in innocent lives." The convention said it was "especially outraged" by the Soviet "education tax" on would-be emigrants, and denounced it "as an atavistic return to medieval anti-lewish ransom tactics, as the infamous practices of men who traded in human bodies and as a policy of extortion in its most transparent and vulgar form."

Applauding the "courage and wisdom" of Soviet Jews who have refused to pay the tax, and of Sen. Henry M. Jackson (D. Wash.) for trying to eliminate it through economic pressure, the AZF declared: "The world will not be misled or appeased by 'token' releases of educated Jews without the tax and calls upon the government of the USSR to immediately and unequivocally rescind its 'education tax' on exit visas."

Hails Bipartisan Support To Israel

In another resolution, the AZF declared that terrorism by Araba as a "political to rextrapolitical tooi" was an offense to humanity and civilization" perpetrated by "common criminals" it urged international action to theart terrorism and hijacking. The convention hailed "the broad bipartisan (American) support accorded to Israel," and credited this support with a major role in maintaining "the two-years'-long cease-fire, the departure of the massive Soviet presence in Egypt and the increasing peace along the Israel-Arab frontier.

Special commissions were established at the convention to consider new public affairs programs, efforts to maintain pressure on the USSR for repeal of the exit tax, efforts to combat Arab terrorism, and expansion of grassroots Zionist activity in American Jewish communtites.

NO PARDON FOR THREE WAR CRIMINALS

AMSTERDAM, Oct. 25 (JTA).—The last three German war oriminals held in Breda prison will not be pardoned, Justice Minister Andreis Van Agt has told parliament. He referred to Ferdinand Ausderfuenten, Franz Fischer and Joseph Kotaella, all serving life sentences, whose pardon was sought by some Dutch circles earlier this year. Van Agt said they would be transferred to another prison because Breda will soon be closed to long-term convicts.

The three Nazis held top posts in the deportation offices in Amsterdam and The Hague during World War II and were responsible for the deportation and murder of thousands of Jews. Originally sentenced to death after the war, their sentences were later commuted to life imprisonment.

1 DEAD, 1 WOUNDED IN SHOOTOUT

TEL AVIV, Oct. 25 (3TA).—An Israell soldier was wounded and a local resident was found dead in a shooting fray in the Shati refugee camp in Gaza last inght. The local victim is believed to have been caught in the line of fire. Israell soldiers opened fire when a suspected terrorist lurking in an alley ran when challenged. The patrol itself came under fire and the suspect escaped.

ISRAELI EMBASSY STAFF, PROMINENT JEWISH BUSINESSMEN, WARNED TO BE ON LOOKOUT FOR BOOBY-TRAPPED NEW YEAR'S PARCELS New Device Has Lethal Cyanide Gas

LONDON, Oct. 25 (JTA)--Special Branch detectives have warned the Israell Embassy staff here to be on the alert for a new wave of letter bombs and booby-trapped parcels during the coming Christmas-New Year holiday season. They have also issued a warning against a new type of lethal mail that contains powder which turns into deadly cyanide gas when exposed to the air. Inhalation of the gas can be instantly fatal.

The Special Branch detectives said letter bombs and parcels would be addressed to Embassy staff members and to Jewish men and women prominent in the business and commercial world. Security men issued a special alert for gift wropped New Year's parcels addressed to diplomats "from Friends" and said the letter bombs could also come in the form of holiday greeting cards.

It was disclosed today that investigation of earlier letter bombs revealed that every diplomat who received one figures in the publication "The Zionist Year Book," The terrorists are believed to be working through the publication alphabetically and security men have been able to predict who the next recipients will be and warn them.

Meanwhite, scientists are investigating the cyanide letters. One was reportedly received recently by the Israeli Embassy in Bonn but news of it was withheld pending investigations. Interpol headquarters in West Germany has warned all countries with Israeli diplomatic missions to be on the alert.

ISRAEL AMAZED AT RELEASE BY DUTCH AUTHORITIES OF MAN WITH LETTER BOMBS

JERUSALEM, Oct. 25 (JTA).—Israeli sources expressed astonishment today over the speedy release by Dutch authorities of a man picked up in Amsterdam Monday with letter bombs and a suitcase filled with hand grenades, explosive chemicals, firearms and amanuntition. Israeli sources said the man was an Algerian diplomat assigned to Brazil. Dutch authorities said he was a Palestinian holding a Jordanian passport and that his destination was Venezuela.

There was no official comment here today but sources said the Foreign Ministry was in contact with the Dutch government to establish exactly what happened and what was learned from the interrogation of the Algerian.

(The Israeli Embassy in The Hague asked the Netherlands government today for "clarification" of the man's release yesterday, barely 24 hours after his arrest at Amsterdam Airport, The Embassy remarked that the attitude of Dutch authorities in this instance was "exaggeratedly liberal.") Cannot Detain People On Suspicion

According to reports from Amsterdam, the man, whose name was not disclosed, told the Dutch authorities that he did not know the contents of the suitcase and that he was merely doing a favor for a Syrian colleague who had asked him to deliver it to an Algerian Embassy in South America. The suspect was permitted to board a plane for Venezuela yesterday, but his luggage

was confiscated,
(Two Dutch Cabinet ministers, Interior Minister Willem Geertaema and Justice Minister Andries Van Agt said on a television interview last night that a democratic state like Holland "cannot detain people merely on suspicion of terrorism." They said the suspect was released because the police did not have a watertight case against him.)

Sources in Jerusalem said Israel was in contact with a number of governments, including South American governments. It was assumed that Israel would ask whatever country the bomb carrier was headed for to oust him as persona non grata. Israell officials stressed that the bomb carrier's apparent diplomatic status was further proof that some Arab governments are actively collaborating with the terrorist movements and that some Arab embassies serve as bases for terrorist operations. Israelis are convinced that the incident in Amsterdam was not an isolated one but part of a widespread phenomenon.

SISCO: MIDEAST 'SUBSTANTIALLY DE'-FUSED U.S. Arms Balance, Big Power

Summitry Cited As Factors CHICAGO, Oct. 25 (JTA) -- Joseph J. Sisco, the Assistant Secretary of State for Near Eastern Affairs, said here today that the Middle East has been tors--the 'positive impact" of Big Power summitry,

"substantially de-fused" as a result of three facthe cease-fire that has lasted more than two years and the US policy of maintaining the arms balance in the area.

Sisco and two other spokesmen for the Nixon administration participated in a series of briefings held here for the Chicago Board of Rabbis. The others were Donald Rumsfeld, Counselor to the President, and Lawrence Silberman, Undersecretary of Labor.

In reply to a question, Sisco described as "incorrect" a report that appeared in the Oct. 11 JTA Daily News Bulletin of a taped television interview with him broadcast in Israel the evening of Oct. 9. Sisco said that a study of the transcript of the interview did not support the lead carried in the JTA story and claimed that Israeli newspapers that monitored the interview did not come to the same conclusions as the JTA.

The JTA dispatch from Jerusalem reported that Sisco had offered a vigorous defense of the controversial Rogers Plan in which he stressed three basic points of the plan that he said tended to be forgotten. The JTA story also noted that Sisco's remarks on the Rogers Plan were in response to questions by the interviewer.

Soviet Jewry High On Nixon's Agenda

Sisco told the Chicago rabbis that US policy in the Middle East is to get a negotiating process started so that there can be a "peaceful resolution." He also reiterated that US policy is not to impose a peace settlement but to serve a useful role to help

both parties negotiate on boundaries and other items. Referring to the situation of Soviet Jews, Sisco said the State Department shares the "abhorrence" of all Americans over the education head tax levied by Soviet authorities on persons who want to emigrate. He said the problem was high on the President's agenda and that all levels of government will be used to deal with it. He said he favored the approach of "quiet diplomacy," adding that the events of recent weeks tend to show that it is working. Sisco also said that a resolution of this problem could play a useful role in the continued improvement in relations between the US and USSR,

Silberman discussed the issue of quotas in education and employment and accused the Democratic Presidential candidate, Sen. George McGovern, of advocating quotas. He quoted McGovern as saving on Oct. 4 that "goals and time tables are a useful tool to achieve parity," According to Silberman, parity was a standard of proportional representation which comes back to quotas." Rumsfeld discussed economic matters at the briefing.

HEAD TAX WAIVER MAY BE TACTICAL MOVE, NOT CHANGE OF POLICY

JERUSALEM, Oct. 25 (JTA) -- The recent exemption of some Jews leaving the Soviet Union from paying the education head tax was described by Foreign Minister Abba Eban in the Knesset today as a "welcome event." But he cautioned against speculation that the discriminatory tax may have been abrogated. "We have to see whether the exemptions are a one-time thing or whether they are the beginning of some kind of change" in Soviet policy, Eban said. He warned that the selective exemptions could be merely a "tactical move" by the Russians to mollify world opinion.

The Knesset passed by a 55-2 vote a motion call-

ing for action to alleviate the plight of Soviet Jews, especially those in prisons. The motion was urged by Gahal leader Menachem Beigin who accused the Soviet regime of "encouraging anti-Semitism." Only the New Communist faction voted against it.

NO FIGURES GIVEN REGARDING U.S CONTRIBUTION TOWARD CANAL REOPENING

WASHINGTON, Oct. 25 (JTA) -- State Department sources denied today that any figure was ever mentioned publicly or privately as to the possible contribution the US might make toward reopening the Suez Canal. The sources were commenting on a Beirut newspaper report yesterday that the US had offered Egypt \$100 million to begin clearing the canal.

The Beirut newspaper, An Nahar, quoted President Gaafer al-Nimeiry of Sudan as saying that he was told of the offer by President Anwar Sadat of Egypt when they met last March 15, three months before Sadat ordered most Soviet personnel out of

The State Department sources said the US always held the position that were an agreement worked out on the Suez reopening, the US would be prepared to help finance the work.

INDUSTRY IN ADMINISTERED AREAS POSES ECOLOGICAL DANGERS

JERUSALEM, Oct. 25 (JTA) -- The chairman of the Knesset's ecology committee has complained that industrial development in the administered territories is threatening serious environmental damage. Yosef Tamir, expressing his concern in a letter to Defense Minister Moshe Dayan, charged that industrial development in the Golan Heights has been undertaken without expert opinion on the environmental impact in the heights and on Lake Kinneret in Upper Galilee. He also complained of air pollution by military vehicles with faulty exhaust systems.

Tamir disclosed that Dayan promised in a reply to his letter to take up the matter of vehicular pollution with the Chief of Staff but said the other problems were the responsibility of the regular government departments. Tamir had expressed concern about a huge formica plant being planned near Hebron with no study of its possible ecological impact, and about the rise in the number of stone quarries on the West Bank from 150 to 500 in the past five years.

Four engineering professors from the Haifa Technion and the Nahal Sorek atomic research laboratory agreed at a meeting of the ecology committee Monday that anti-pollution laws would never be effective until they were the responsibility of one department instead of 14 ministries.

Leon Dultzin, Treasurer of the Jewish Agency, reported in Haifa that 23,000 Jewish immigrants have arrived in Israel from the Soviet Union so far this year and that a total of between 25-30,000 13 expected by the end of the year. Dultzin said that this was double the number of Soviet Jewish emigres who arrived last year, predicted that some 50-60,000 Jews will immigrate to Israel from the USSR in 1973, and said that about 120,000 Soviet Jews have applied for emigration visas. Dultzin noted that the influx of Jews from Russia this year brought total immigration figures up to expectations by off-setting a 20 percent drop in immigration from Western countries, notably the US, Britain and France. He said there was an increase in immigration from Latin America this year. CORRECTION: The joint conference of the WZO

COURT SUIT AGAINST TAX EXEMPTIONS ON FUNDS COLLECTED BY UJA, UIA

WASHINGTON, Oct, 25 (JTA)--Treasury Secretary George P. Schultz and Internal Revaue Commissioner Johnnie M. Walters were sued in United States District Court today by a group of seven anti-Zionista to ban exemptions of US taxes on funds collected in the US by the United Jewish Appeal and the United Israel Appeal. The suit demands that Schultz and Walters "collect all sums now due and owing" as a result of tax exemptions, "plus damages and interest." The plaintiffs estimated that this totals \$2.5 billion to date and that the exemptions "cost the American public a quarter of a billion dollars a year."

The plaintiffs charged that "the US government is fostering racial discrimination in financially adding the Israel Zionist program to keep Israel a furrely Jewish State in an ethnic sense," adding that "the targets of this discrimination are the Palestinians, chiefly Arabs." Sale of Israel government bonds, foreign aid, loans, grants and transfers "currently going" to Israel are not included in the suit. The Jewish Telegraphic Agency called the UJA for a response and was told there would be no immediate official comment.

The plaintiffs include Norman F. Dacey of Southbury, Conn., author of a full-page ad last June in the New York Times condemning aid to Israel; Prof. Ibrahim Abu Lughod, assistant director of the African Studies Department of Northwestern University; Prof. Norton Meavinsky of Connecticut State College; Prof. Isham Sharabi of Georgetown University here; the Rev. L. Humphrey Waltz, Presbyterian minister of Janesville, Wis.; and Michael K. Ross, Seattle lawyer and Washington State legislator.

Abdeen M. Jabara of Detroit, who represented the plaintiffs at a news conference today, is a lawyer of Lebanese descent and is president of Arab American University Gradutes, a national organization. He dented affiliation with the feda-yeen. Although the plaintiffs and Jabara charged that UJA money was promoting "racial discrimination," the attorney refused under questioning to define to which race Jews belong. He also side-stepped questions about whether he had ever protested oppression of Jews in Arab States.

TEKOAH REFUTES JORDANIAN CHARGES ON EAST JERUSALEM

UNITED NATIONS, Oct. 28 (JTA)—Israeli Ambasador Yosef Tekoah, replying this afternoon to a Jordanian condemnation earlier in the day of Israeli practices in East Jerusalem, said that Jordan's policy in Jerusalem before 1987 had "been one of ravage and devastation." Tekoah added that Jordan "apparently still cannot bear to see that since 1987 the ruins of Jerusalem have been rebuilt, that the reunited capital is developing and flourishing anew, that the universal religious interests of Christianity, islam and Judalem are fully protected, that the rights of all communities are assured and that Jews and Arabs live and work side by side in pagace."

Jordan "will go down in history as Jerusalem's amputator and destroyer," Tekoak charged. "During its forcible and illegal occupation of part of Jerusalem, Jordan razed to the ground the entire Jewish quarter of the Old City with all its 39 synagogues and institutions of learning, uprooted and exiled its Jewish population and barred free access to Judaism's holy places!" "Jerusalem "his had a Jewish minority for more than a century." Tekoah concluded, "and its present demographic composition and growth are a normal and natural

development," The Jordanian and Israeli statements were made in letters to Secretary General Kurt Waldheim for circulation to UN members,

LAW TO PUT STIFFER ARM ON CRIMINALS

JERUSALEM, Oct. 28 (JTA).—An amendment to the criminal code providing stiffer penalties for orimes of violence and other offenses passed its first reading in the Knesset yesterday. The measure, introduced by Justice Minister Yaacov Shimshon Shapiro, would make mandatory harshers sentences for criminals using firearms, criminals who operate in gangs, protection racketeers and suborners of witnessess. Shapiro said the maximum penalty for running a protection racket would be increased from one year to 3-5 years.

The need for stiffer penalties for criminals was cited recently by Police Minister Shlomo Hillel who urged capital punishment for criminals who commit murder inside jails. Hillel said there are 330 prisoners serving life sentences in Israel who feel secure in the knowledge that whatever crime they commit in jail the worst that can happen is two weeks solitary confinement.

He said a bill will soon be introduced in the Knesset allowing police to hold criminals without bail pending trial. He added that while there is no "Mafia-style" organized crime in Israel there are well organized gangs engaged in robbery and extertion.

McGOVERN RAPS SOVIET RAP

WASHINGTON, Oct. 25 (JTA).-Sen. George McGovern, the Democratic Party Presidential candidate, said that the latest attack this week against him by the Soviet weekly. Za Rubezhon, the second time this month, "underscores the Kremlin's callous disregard for fundamental human rights." The Soviet weekly adopted a derisive tone toward McGovern's concern about Soviet Jewry. Answering what he termed "the mockery of my position in support of Soviet Jewry," the Democratic Presidential hopeful stated:

"The plight of Jews who wish to emigrate and are prevented by a huge exit tax is not a matter to be treated with derision. The cruel and erratic use of a ransom charge against would-be emigrants profoundly disturbs all who love freedom." Continuing, McGovern declared: "While President Nixon remains silent, I will continue to speak out on Soviet Jewry's struggle to be free. I will not fall victim to any scheme to embarrass and to silence those who fear for the safety of the Jewish community of the Soviet Union."

POLITICAL MOTIVE IN MURDER OF ARAB?

JERUSALEM, Oct. 28 (JTA)--Police are seeking a possible political motive in the murder Monday of Aziz Ali Sherif, son of Ali Sherif, a former member of the Jordanian parliament we recently called for the establishment of a Palestinian government-in-exile. The victim was shot to death by unknown assailants who abducted him from his Hebron home. His body was found on a road on the outskirts of the West Bank town. The elder Sharif appeared on Israel's Arabic political television program two weeks ago and supported a proposal by President Sadat that the Palestinians set up a government-in-exile which Egypt would recognize.

The Israel Cabinet decision this week to retain the 40,000-limit on Arab workers from the administered territories was regarded as a setback to those who have sought closer ties between Israelis and Arabs from the territories.

7 ORTHODOX, HASIDIC LEADERS ENDORSE NIXON FOR REELECTION....

WASHINGTON, Oct. 25 (JTA)--President Nixon was endorsed for re-election yesterday by seven Orthodox and Hasidic leaders. The endorsement, released by the White House, cited Nixon's "efforts to bring about a just and lasting peace so badly needed in a troubled world."

The letter praised Nixon's "noble efforts in inspiring our ccum'ry toward a greater commitment of moral values," his "leadership in stabilizing urban communities by restoring respect for and confidence in our judicial system," and his "most positive contribution to our entire educational system" through "financial aid to private and parochial schools,"

The endorsement was signed by Rabbi Joseph Ashkenazy, secretary to Grand Rabbi Joel Tettelbaum of United Satmar Institutes; Rabbi Martin Berkowitz, executive director, Central Rabbincal Congress of the USA and Canada; Rabbi Leopold Friedman, executive vice-president, United Talmudical Academy; Rabbi Chaim M. Stauber, secretary, National Committee of Orthodox Jewish Communities; Sender Deutsch, editor-publisher, Der Yid and other publications; Rabbi H, Frankel, chairman, Beth Rachel Educational System; and Berl Friedman, chairman, Yeshiva Torah V'Yirah of Boro Park (Brooklyn, N.Y.).

....51 RABBIS, ORGANIZATION LEADERS ENDORSE MCGOVERN

WASHINGTON, Oct. 25 (JTA)—McGovern campaign headquarters today released a statement by 51 American rabbis and leaders of national and local Jewish organizations supporting the election of Sen, George McGovern, the Democratic Presidential candidate. The signatories described themselves as "active leaders in Jewish life." Their statement specifically omitted their congregational and organizational affiliations because "They have signed this statement out of personal convictions as individuals in support of Sen. McGovern."

The statement listed "crime in the streets...inflation; unemployment, education and the Supreme Court" as major concerns in the 1972 elections. It compared the records of Nixon and McGovern on the issues of Soviet Jewry and support for Israel.

The signatories included Rabbi Roland Gittelsohn, Boston; Dr. William Haber, Ann Arbor, Mich.; Rabbi Abraham Joshua Heschel, N.Y.; Philip M. Klutznick, Chicago; Rabbi Arthur J. Lelyveld, Cleveland; Robert Nathan, Washington, D.C.; Rabbi Joachim Prinz, Orange, N.J.; Dore Schary, N.Y.; Herbert Tenzer, Lawrence, N.Y.; and Louis Weinstein, Boston.

Referring to Soviet Jewry, the statement noted that "At a time of crisis for Soviet Jewry, President Nixon is proposing to grant the Kremiin most favored nation status in its trade dealings with our country. In contrast, Sen McGovern has called on the President to withhold trade concessions to the USSR until the Soviets abandon their slave tax." The statement also noted that "Richard Nixon placed a moratorium on the delivery of desperately needed Phantom jets to Israel" while Sen, McGovern "played a key role in Congressional efforts to reverse the Nixon arms ban against Israel."

AZF CONCLAVE CALLS ON GOVERNMENTS, UN, TO CONDEMN SOVIET HEAD TAX

CHICAGO, Oct. 25 (JTA) -- The American Zionist

Federation, concluding its national convention here, called on all governments and the United Nations to "reject all extortion and ransom demands and to deal resolutely with those who barter in innocent lives." The convention said it was "especially outraged" by the Soviet "education tax" on would-be emigrants, and denounced it "as an atavistic return to medieval anti-lewish ransom tactics, as the infamous practices of men who traded in human bodies and as a policy of extortion in its most transparent and vulgar form."

Applauding the "courage and wisdom" of Soviet Jews who have refused to pay the tax, and of Sen. Henry M. Jackson (D. Wash.) for trying to eliminate it through economic pressure, the AZF declared: "The world will not be misled or appeased by 'token' releases of educated Jews without the tax and calls upon the government of the USSR to immediately and unequivocally rescind its 'education tax' on exit visas."

Hails Bipartisan Support To Israel

In another resolution, the AZF declared that terrorism by Araba as a "political to rextrapolitical tooi" was an offense to humanity and civilization" perpetrated by "common criminals" it urged international action to theart terrorism and hijacking. The convention hailed "the broad bipartisan (American) support accorded to Israel," and credited this support with a major role in maintaining "the two-years'-long cease-fire, the departure of the massive Soviet presence in Egypt and the increasing peace along the Israel-Arab frontier.

Special commissions were established at the convention to consider new public affairs programs, efforts to maintain pressure on the USSR for repeal of the exit tax, efforts to combat Arab terrorism, and expansion of grassroots Zionist activity in American Jewish communtites.

NO PARDON FOR THREE WAR CRIMINALS

AMSTERDAM, Oct. 25 (JTA).—The last three German war oriminals held in Breda prison will not be pardoned, Justice Minister Andreis Van Agt has told parliament. He referred to Ferdinand Ausderfuenten, Franz Fischer and Joseph Kotaella, all serving life sentences, whose pardon was sought by some Dutch circles earlier this year. Van Agt said they would be transferred to another prison because Breda will soon be closed to long-term convicts.

The three Nazis held top posts in the deportation offices in Amsterdam and The Hague during World War II and were responsible for the deportation and murder of thousands of Jews. Originally sentenced to death after the war, their sentences were later commuted to life imprisonment.

1 DEAD, 1 WOUNDED IN SHOOTOUT

TEL AVIV, Oct. 25 (3TA).—An Israell soldier was wounded and a local resident was found dead in a shooting fray in the Shati refugee camp in Gaza last inght. The local victim is believed to have been caught in the line of fire. Israell soldiers opened fire when a suspected terrorist lurking in an alley ran when challenged. The patrol itself came under fire and the suspect escaped.
