HOPE FOR INTERNATIONAL ACTION AGAINST TERRORISM BURIED BY UN RESOLUTION

Galili Says UN Is Bankrupt

JERUSALEM, Dec. 13 (JTA)--Israeli officials said today that any hope for international action to combat the wave of hijackings and international terrorism was effectively buried by the resolution adopted Monday by the United Nations General Assembly's Legal Committee. The resolution called for a 40-nation study group to investigate the root causes of terrorism and report back within a year.

Israell officials said that this resolution, following on the heels of another Arab-inspired resolution adopted by the Assembly last week, has "put a sad end" to prospects that the UN would contribute anything to the advancement of peace in the Middle

East.

Israelis said the large majority by which the resolution in the Legal Committee was passed was explainable in part by the efforts of the Arab states and their supporters and in part by the fear of many 'African states that effective action against terrorism might be turned against various legitimate national liberation movements.

Surrender To Terrorists Protectors

Speaking today in the Knesset, Minister-Without-Portfolio Israel Gallit said that the terrorism resolution indicated "the moral and political bankruptoy of the United Nations," was "a mackery of the hopes of so many people in the UN-ast least in the realm of protecting human life," and represented "an avoidance of responsibility...a surrender to political forces which protect the terror groups;"

Gailli also assailed the Assembly's recent proorab resolution on the Middle East as "damaging to peace" and pledged that Israeli policy would not be influenced by the UN "finores trading" but would continue to be based on "peace, action and security." He reiterated Israel's belief that an interim agreement to reopen the Suez Canal was the best

means toward an overall peace.

Speaking in place of Foreign Minister Abba Eban, who did not return to Israel until later in the day, Gallit turned back a charge by MK Haim Landau of Gahal's Herut branch that Eban had threatened Israeli dissociation from Security Council Resolution 242 should the General Assembly upset its

balanced language.

It would have been better, Landau said, for Eban to have said nothing than to have made threats and then withdrawn from them. Galili replied that Eban's threat applied only to a reinterpretation of Resolution 242, which he said was not now the case although last week's measure endorsed an advance Israeli commitment to total withdrawal and contained "4 hist of sanctions." The Knesset debate was then moved to the Foreign Affairs and Security Committee.

SCOTLAND YARD ISSUES NEW WARNING ABOUT LETTER BOMBS

LONDON, Dec. 13 (JTA) -- Scotland Yard issued a new jetter bomb warning today as the rush of Christmas mail began to build up all over the United Kingdom. The warning was directed to Jewish individuals and organizations and to non-Jews and non-Jewish organizations connected with Israel. They were advised to take extra care and to carefully examine even small letters that didn't arouse

suspicion,

Police forces in Germany, Holland, Belgium, Austria and other countries were also alerted by Scotland Yard to be especially wary of mail arriving from Singapore and Malaysia as well as from India where the last wave of letter bombs originated. According to one unconfirmed report, a post office worker in Singapore was caught slipping a letter bomb into the foreign mail after security checks were completed.

Scotland Yard has set up a special branch to coordinate the international drive against letter bombs. It has reportedly detected and de-fused numerous lethal letters since the branch went into action early Nov.

SECRET REPORT: ONLY 40% OF EGYPT'S WEAPONS READY FOR COMBAT

LONDON, Dec. 13 (ITA)--According to a secrete gyptian Air Force report, leaked in Brussels, only 40 percent of Egypt's weapons and 40-65 percent of its aircraft are in a state combat readiness despite President Anwar Sadat's repeated anti-israel belligerency. According to unconfirmed reports from Brussels, the survey, carried out earlier this year, blames poor maintenance; inadequate handling and a shortage of spare parts from the Soviet Union, the reports said.

An Egyptian military delegation to Moscow, which returned home last week, reportedly persuaded the USSR to resume shipment of spare parts, suspended in July when Soviet advisors were expelled from Egypt. The secret study, according to the Brussels reports, says that another 20 percent of Egypt's weapons can be repaired when the spare parts arrive, but that the remaining 40 percent are beyond repair.

NINE MORE SUSPECTS ARRESTED IN SPY RING ROUNDUP

TEL-AVIV, Dec. 13 (JTA) -- Nine more persons suppected of collaborating with a Syrian-directed Arab-Jewish spy ring have been arrested during the past 24 hours, it was reported today. The latest arrests brought to 46 the number of suspects selzed since Israell security authorities cracked down on the ring last week. The suspects represent all the major religious denominations in Israel--Jewish, Moslem, Marontte Christian, Catholic and Druze. One of the latest detainess was described as an Arab student of physics at Tel Aviv University.

Dublic attention has been focuseed on the four Jewish suspects, especially End Adiv, 26, and Dan Vered, 30, both native-born Israelis, who are believed to have been among the ring leaders. Adiv and Vered were identified yesterday as members of an extreme left-wing group known as the "Red Front" which preaches violent revolution.

Sources here said the two suspects show no signs of remorse and may try to turn their trial into a political and ideological forum. Vered, a school teacher, once attended the University of Miami where he was a member of the radical SDS (Students for a Democratic Society).

2 Suspects Visited Damascus

The case has already led to bitter ideological recriminations in the Knesset where many members have expressed shock that Jews were implicated in the spy network. Eliezer Shostak, of the Free Center faction, demanded a debate to "explore the roots of the incident" and assailed "these so-called progressives who mailign our national values who are more harmful than a whole division of Egyptian soldiers." His remarks appeared to have been aimed at Mapam sice Adiv was born and raised at Gan Shmuel, a kibbuts of the Hashomer Hatzair movement.

Knesseter Dov Zakin of Mapam, said "iff the Jews are found guilty we shall condemn them." The newspaper, Yedlot Achronot, reported in an exclusive story today that two of the Jewish suspects had visited Damascus separately and that each stayed there about a week. The paper did not identify the suspects. It said that they were quartered in an apartment where they were taken by Syrian intelligence agents who met them at the sirport.

The Syrians did not identify themselves and the Israelis did not sense any close supervision, the paper said. They spent most of their time in the apartment but one was taken on a sight-seeing trip of Damascus which included a visit to the synangus.

NEW USIS DIRECTOR NOT EXPECTED TO ALTER VOA BROADCASTS TO USER

WASHINGTON, Dec. 13 (JTA)—President Misses's nomination of James Keogh, a Presidential assistant, as director of the United States Information Service succeeding Frank J, Shakespears, will not alter the current programming by the Voice of America to the Soviet Union, a VOA official told the Jowish Telegraphic Agency today. Keogh, a former executive editor of Time Magazine is a native of Nebraska and a graduate of Creighton University.

SISCO SEEN TOO INVOLVED IN MIDEAST POLICY TO BE NAMED UN AMBASSADOR

UNITED NATIONS, Dec. 13 (JTA), Informed sources volced doubt today over reports that Joseph J, Sisco, said to be the leading candidate for the post of United States ambassador to the United Nations, would get the Job. They explained that as the prime mover behind the Nixon administration's Middle Sast policy, Sisco has the special conditions of Nixon, who has said that when the Vietnam war is ended the Mideast will receive top priority in foreign affairs.

The present ambassador, former Texas Congrasman George Bush, was named publicly Monday as the new chairman of the Republican National Committee, effective early next year.

DAYAN WANTS KNESSET DEBATE ON TERRITORIES

JERUSALEM, Dec. 13 (JTA)—Defense Minister Moshe Dayan called for a full-dress debate in the Knesset on policy in the territories and their future. Speaking in the Knesset yesterday he said the Government had no objection to such a debate.

Observers saw Dayan's move as an effort to gather support outside his own party for his views, since in the cngoing Lābour Party debate his hawk-ish stand seems to be in the minority. In an open Knesset debate Dayan would probably pick up verbal support from Gahal and the National Religious Party which, in a backhanded way, would strengthen his position in his party.

Reviewing his policy in administering the territories, Dayan stressed repeatedly that the Governor of the Bank of Israel, Moshe Sanbar, believed that administering the territories was not a burden on Israel's economy. Dayan said the Governor had specifically permitted him to cite his opinion to the Knesset. His repeated stressing of it was interpreted as a challenge to Finance Minister Pinhas Sapir who has recently complained that the territories were a drain on the economy.

Earlier in the same Knesset session, Dayan revealed that Israel gained IL87.5 million income from oil production in the Sinai in 1971 compared to IL 70 million the year before and IL 40 million in 1988. Dayan was replying to a question from Knesseter Mordechai Ben Porat requesting him to detail income and expenditure in the territories.

ACTION AGAINST TERRORISM URGED

NEW YORK, Dec.13 (JTA)-- The U.S. must take "funliateral action to protect our own citizens" in view of the failure of the United Nations to approve strong international legal action on terrorism, Rep. Herman Badillo (D.NY) told the American Jewish Congress last night, Badillo said he favored passage of a measure introduced by Ogden Reid (D.NY) that would close American airports to any foreign airline operating in any country which refuses to prosecute or extradite skylackers.

His call for strong unlateral action was echoed by Phil Baum, associate executive director of the AJCongress, who said the "hopeless incapacity" of the UN to act against terrorism was demonstrated Monday by the General Assembly's Legal Committee.

"The UN can and will do nothing, and if we are to protect ourselves against random political violence, we had better accept that hard fact and look elsewhere." Baum declared.

He urged the U.S. Government to "adopt legislation authorizing unliateral withholding of programs of economic assistance, as well as other privileges and benefits, to those states that endorse or harbor terrorist groups, "and called on airline managements, pilots and other elements of the business community to isolate such nations.

Capt, John Ferguson, representing the Air Line Pilots Association, told the meeting that continued acts of air terrorism could be traced to "the greed and immaturity of pilots, airline managements and governments." He asserted "some pilots oppose work stoppages because they don't want to lose money, and the U.S. Government and the airline companies don't want to spend the necessary money for security."

Capt. Ferguson called on the Government to assume the cost of the electronic gear and armed guards he said were needed to prevent air hijacks, "We're in a war with criminal elements," he said, calling it "a function of government and not business to take over law enforcement."

TEKOAH: ARAB GOVERNMENTS REPRESENT TERRORIST INTERESTS IN THE UN

UNITED NATIONS, Dec.13 (JTA)--Ambassador Yosef Tekoah of Israel charged today that
the Arab governments were representing the interests of Palestinian terrorists in the United
Nations instead of attending to the concerns of
the Palestinian refugees. He urged the General
Assembly to stop adopting "resolutions which
gave satisfaction to Arab belligerency, but in no
way advanced the settlement of the refugee problem"

Tekoah addressed the Assembly shortly before a vote was to be taken on a series of resolutions connected with the annual report of the United Nations Relief and Works Agency for Palestine Arab Refuges (UNRWA). He referred specifically to the first of eight draft resolutions which he said reflected "the usual expressions of Arab animosity toward Israel, ignoring facts, perverting truth, distorting legal precepts, injecting issues extraneous to the refugee problem, such as the positions adopted by the Palestinian terrorist organizations,"

Tekoah said the text of the resolutions were "inequitable and detrimental" and that "Israel will oppose them." He singled out sections C, D and E of the first draft resolution which were sponsored by an Afro-Asian bloc and were approved by the Political Committee by substantial matorities.

Section C would have the General Assembly declare that changes in the physical and demographic structure in the Gaza Strip, including the destruction of refugee shelters and the forcible transfer of population, contravenes the Geneva Convention; and would have the Assembly "deplore" these acts and demand that Israel "cease forthwith."

Palestinian Refugees Shortchanged

Section D expresses "grave concern" over the plight of the refugees and "calls once more upon Israel to take steps for the return of the displaced inhabitants" and to "cease forthwith" from all measures affecting changes in the administered territories. Section E of the draft affirms that the people of Palestine are entitled to equal rights and self determination in accordance with the UN Charter and calls "respect" for these rights "indispensable."

Tekoah said in his speech: "The victims of the Arab states' policy in the United Nations are first and foremost the Palestinian refugees themselves. Instead of assisting them in reconstructing their lives, the Arab Governments have been feeding them year after year with United Nations resolutions which reflect the views of notorious violators of international law and morality such as Syria, Libya and Algeria."

The Israeli diplomat observed that if the UN wished to play a constructive role in the advancement of peace in the Middle East it must replace "sterile polemical debates with serious, constructive exchanges of views;" adopt "resolutions arrived at through consultation with and consent of the parties directive concerned;" and encourage the parties "to seek agreement between theirselves through negotiations."

INTERFAITH MEETING FOR SOVIET JEWS

AMSTERDAM, Dec.13 (JTA)--The joint council of christian Churches organized here this week a Protestant-Catholic "Soldarity Assembly with Soviel Jewry." The meeting was addressed by Catholic and Protestant clerics and by Greville Janner, British MP.

WORLD JEWISH POPULATION ESTIMATED AT 14,236,420; 6,060,000 IN U.S.

NEW YORK, Dec. 13 (JTA).—The world Jewish population is estimated at 14,236,420, according to the American Jewish Year Book, whose 1972 edition has just been published. There are approximately 6,600,000 Jews in the United States, more than in any other country. These estimates were compiled by Leon Shapiro, Associate Professor of Russian-Jewish History at Rutgers University, who compiled the overseas demographic data, and Alvin Chenkin, Supervisor, Statistics Unit, Council of Jewish Federations and Welfare Funds, who assembled the figures on the U.S.

After the United States, countries with the largest Jewish populations are: Soviet Union, 2,644,000; Israel, 2,632,000 (it is estimated that 42,000 immigrants entered Israel this past year); France, 550,000; Argentina, 500,000; Great Britain, 410,000; and Canada, 300,000. Half of world Jewry is located in North, Central and South America, 29 percent in Europe, 19 percent in Asia, 1.5 percent in Africa, and 0,5 percent in Australia and New Zealand,

In the United States, the Jewish population has shown an annual growth rate of 1,07 percent over the past three years. "This figure is comparable to the annual growth rate of the total resident population of the United States from 1968 to 1971," Chenkin states, and "the proportion of the total redent population estimated to be Jewish remained at

2.94 percent,"

In Europe, according to Prof. Shapiro, there are more than 4,000,001 Jews, including 2,850,000 in the Communist area. Of these, 2,644,000 are in the Soviet Union, Figures for other European countries include: Austria, 9000; Bellgium, 40,560; Bulgaria, 7000; Czechoslovakia, 14,000; Denmark, 6000; France, 550,000; Germany, 32,000; Great Britain, 410,000; Greece, 6500; Hurgary, 80,000; Ireland, 5400; Italy, 35,000; Netherlands, 30,000; Poland, 8000; Rumania,100,000; Spain, 9000; Sweden, 15,000; Switzerland, 20,000; Turkey 37,000; and Yugoslavia, 7000.

Estimated population for major centers of Jewish concentration in the Americas, besides the United States, include: Canada, 300,000; Mexico, 35,000; Argentina, 500,000; Brazil, 150,000; Chile, 32,000; Colombia, 10,000; Peru, 5300; Uruguay, 50,000, and Venezuela, 12,000. In Asia, the only major centers of Jewish population, besides Israel, are India, 14,500; and Iran, 80,000. In Africa, there are substantial Jewish numbers only in South Africa, 117,990; Morocco, 35,000; Ethiopia, 12,000; Tunisia, 8000; and Rhodesia, 5200. There are 72,000 Jews in Australia and 5000 in New Zealand.

ZOA URGES U.S. TO CONVENE CONCLAVE OF NATIONS TO ACT ON TERRORISM

NEW YORK, Dec. 13 (JTA).—The Zionist Organization of America, deploring the United Nations General Assembly Sixth (Legal) Committee's vote sidetracking strong legal action against terrorism, today urged the United States to convene a conference of concerned nations—outside the framework of the United States.—to enact multilateral anti-terrorism treaties.

Rabbi Joseph P, Sternstein, chairman of the ZOA National Executive Committee, declared in a

statement that the Committee "abrogated a moral responsibility" by approving a resolution conderned primarily with exploring the causes of terrorist acts instead of voting on stronger resolutions which would have resulted in international conventions against terrorism.

Rabbi Sternstein commended the United States for its efforts to gain approval of the stronger anti-terrorism resolutions. But he said the Committee's vote "leaves the United States with no other viable recourse but to take the initiative in calling a conference which would seek primarily to institute joint international actions against nations that encourage, sanction or aid terrorist activities."

DR. SALO BARON HONORED BY ITALY

NEW YORK, Dec. 13 (JTA)--Salo W. Baron, called the "dean of American Jewish scholars," has been named to the rank of Knight of the Order of Merit of the Republic of Italy. The award, made by the President of Italy, Glovanni Leone, cited Dr. Baron for his "past and present contributions to the knowledge of Italian history and civilization." Dr. Baron is professor emeritus of Jewish history, literature and institutions at Columbia University, where he served for 33 years before his retirement in 1963.

He is the author of the monumental "A Social and Religious History of the Jews," 14 volumes of which have been published. A 15th volume, on the history of the Jews in Western Europe and the New World in the 16th and 17th centuries, will be published early next year. On his 75th birthday in 1970, Dr. Baron was honored by the National Foundation for Jewish Culture as the "dean of American Jewish scholars," In 1961, he was called upon to testify as a witness in the Eichmann trial in Jerusalem, at which he described the enormity of the Nazi destruction of the Jewish community in Central and Eastern Europe.

RAY CHARLES CONCERT A RIOT...ALMOST

last night where the Black American singer Ray
Charles was giving a concert. The audience at
the first show refused to leave the hall when it was

the performance had repeatedly disrupted the concert.

The audience for the second show surged into the auditorium despite efforts by the ushers to keep them out. Fist fights broke out in front of the stage but more serious trouble was averted when the management decided to allow the first audi-

ence to remain for the second show.

Members of the first audience who had paid high prices for admission were angered because the show was 45 minutes late in starting. They said that during the performance they were disturbed by lights held up by the to crew and that prop men and technicians repeatedly traversed the stage. Charles refused to give an encore when the first show ended. The blind singer arrived here yesterday to make a film, "Ray Charles in the Holy Land,"

SCOTLAND YARD ISSUES NEW WARNING ABOUT LETTER BOMBS

LONDON, Dec. 13 (JTA) -- Scotland Yard issued a new jetter bomb warning today as the rush of Christmas mail began to build up all over the United Kingdom. The warning was directed to Jewish individuals and organizations and to non-Jews and non-Jewish organizations connected with Israel. They were advised to take extra care and to carefully examine even small letters that didn't arouse

suspicion,

Police forces in Germany, Holland, Belgium, Austria and other countries were also alerted by Scotland Yard to be especially wary of mail arriving from Singapore and Malaysia as well as from India where the last wave of letter bombs originated. According to one unconfirmed report, a post office worker in Singapore was caught slipping a letter bomb into the foreign mail after security checks were completed.

Scotland Yard has set up a special branch to coordinate the international drive against letter bombs. It has reportedly detected and de-fused numerous lethal letters since the branch went into action early Nov.

SECRET REPORT: ONLY 40% OF EGYPT'S WEAPONS READY FOR COMBAT

LONDON, Dec. 13 (ITA)--According to a secrete gyptian Air Force report, leaked in Brussels, only 40 percent of Egypt's weapons and 40-65 percent of its aircraft are in a state combat readiness despite President Anwar Sadat's repeated anti-israel belligerency. According to unconfirmed reports from Brussels, the survey, carried out earlier this year, blames poor maintenance; inadequate handling and a shortage of spare parts from the Soviet Union, the reports said.

An Egyptian military delegation to Moscow, which returned home last week, reportedly persuaded the USSR to resume shipment of spare parts, suspended in July when Soviet advisors were expelled from Egypt. The secret study, according to the Brussels reports, says that another 20 percent of Egypt's weapons can be repaired when the spare parts arrive, but that the remaining 40 percent are beyond repair.

NINE MORE SUSPECTS ARRESTED IN SPY RING ROUNDUP

TEL-AVIV, Dec. 13 (JTA) -- Nine more persons suppected of collaborating with a Syrian-directed Arab-Jewish spy ring have been arrested during the past 24 hours, it was reported today. The latest arrests brought to 46 the number of suspects selzed since Israell security authorities cracked down on the ring last week. The suspects represent all the major religious denominations in Israel--Jewish, Moslem, Marontte Christian, Catholic and Druze. One of the latest detainess was described as an Arab student of physics at Tel Aviv University.

Dublic attention has been focuseed on the four Jewish suspects, especially End Adiv, 26, and Dan Vered, 30, both native-born Israelis, who are believed to have been among the ring leaders. Adiv and Vered were identified yesterday as members of an extreme left-wing group known as the "Red Front" which preaches violent revolution.

Sources here said the two suspects show no signs of remorse and may try to turn their trial into a political and ideological forum. Vered, a school teacher, once attended the University of Miami where he was a member of the radical SDS (Students for a Democratic Society).

2 Suspects Visited Damascus

The case has already led to bitter ideological recriminations in the Knesset where many members have expressed shock that Jews were implicated in the spy network. Eliezer Shostak, of the Free Center faction, demanded a debate to "explore the roots of the incident" and assailed "these so-called progressives who mailign our national values who are more harmful than a whole division of Egyptian soldiers." His remarks appeared to have been aimed at Mapam sice Adiv was born and raised at Gan Shmuel, a kibbuts of the Hashomer Hatzair movement.

Knesseter Dov Zakin of Mapam, said "iff the Jews are found guilty we shall condemn them." The newspaper, Yedlot Achronot, reported in an exclusive story today that two of the Jewish suspects had visited Damascus separately and that each stayed there about a week. The paper did not identify the suspects. It said that they were quartered in an apartment where they were taken by Syrian intelligence agents who met them at the sirport.

The Syrians did not identify themselves and the Israelis did not sense any close supervision, the paper said. They spent most of their time in the apartment but one was taken on a sight-seeing trip of Damascus which included a visit to the synangus.

WASHINGTON, Dec. 13 (JTA)—President Misses's nomination of James Keogh, a Presidential assistant, as director of the United States Information Service succeeding Frank J, Shakespears, will not alter the current programming by the Voice of America to the Soviet Union, a VOA official told the Jowish Telegraphic Agency today. Keogh, a former executive editor of Time Magazine is a native of Nebraska and a graduate of Creighton University.

SISCO SEEN TOO INVOLVED IN MIDEAST POLICY TO BE NAMED UN AMBASSADOR

UNITED NATIONS, Dec. 13 (JTA), Informed sources volced doubt today over reports that Joseph J, Sisco, said to be the leading candidate for the post of United States ambassador to the United Nations, would get the Job. They explained that as the prime mover behind the Nixon administration's Middle Sast policy, Sisco has the special conditions of Nixon, who has said that when the Vietnam war is ended the Mideast will receive top priority in foreign affairs.

The present ambassador, former Texas Congrasman George Bush, was named publicly Monday as the new chairman of the Republican National Committee, effective early next year.

DAYAN WANTS KNESSET DEBATE ON TERRITORIES

JERUSALEM, Dec. 13 (JTA)—Defense Minister Moshe Dayan called for a full-dress debate in the Knesset on policy in the territories and their future. Speaking in the Knesset yesterday he said the Government had no objection to such a debate.

Observers saw Dayan's move as an effort to gather support outside his own party for his views, since in the cngoing Lābour Party debate his hawk-ish stand seems to be in the minority. In an open Knesset debate Dayan would probably pick up verbal support from Gahal and the National Religious Party which, in a backhanded way, would strengthen his position in his party.

Reviewing his policy in administering the territories, Dayan stressed repeatedly that the Governor of the Bank of Israel, Moshe Sanbar, believed that administering the territories was not a burden on Israel's economy. Dayan said the Governor had specifically permitted him to cite his opinion to the Knesset. His repeated stressing of it was interpreted as a challenge to Finance Minister Pinhas Sapir who has recently complained that the territories were a drain on the economy.

Earlier in the same Knesset session, Dayan revealed that Israel gained IL87.5 million income from oil production in the Sinai in 1971 compared to IL 70 million the year before and IL 40 million in 1988. Dayan was replying to a question from Knesseter Mordechai Ben Porat requesting him to detail income and expenditure in the territories.

ACTION AGAINST TERRORISM URGED

NEW YORK, Dec.13 (JTA)-- The U.S. must take "funliateral action to protect our own citizens" in view of the failure of the United Nations to approve strong international legal action on terrorism, Rep. Herman Badillo (D.NY) told the American Jewish Congress last night, Badillo said he favored passage of a measure introduced by Ogden Reid (D.NY) that would close American airports to any foreign airline operating in any country which refuses to prosecute or extradite skylackers.

His call for strong unlateral action was echoed by Phil Baum, associate executive director of the AJCongress, who said the "hopeless incapacity" of the UN to act against terrorism was demonstrated Monday by the General Assembly's Legal Committee.

"The UN can and will do nothing, and if we are to protect ourselves against random political violence, we had better accept that hard fact and look elsewhere." Baum declared.

He urged the U.S. Government to "adopt legislation authorizing unliateral withholding of programs of economic assistance, as well as other privileges and benefits, to those states that endorse or harbor terrorist groups, "and called on airline managements, pilots and other elements of the business community to isolate such nations.

Capt, John Ferguson, representing the Air Line Pilots Association, told the meeting that continued acts of air terrorism could be traced to "the greed and immaturity of pilots, airline managements and governments." He asserted "some pilots oppose work stoppages because they don't want to lose money, and the U.S. Government and the airline companies don't want to spend the necessary money for security."

Capt. Ferguson called on the Government to assume the cost of the electronic gear and armed guards he said were needed to prevent air hijacks, "We're in a war with criminal elements," he said, calling it "a function of government and not business to take over law enforcement."

TEKOAH: ARAB GOVERNMENTS REPRESENT TERRORIST INTERESTS IN THE UN

UNITED NATIONS, Dec.13 (JTA)--Ambassador Yosef Tekoah of Israel charged today that
the Arab governments were representing the interests of Palestinian terrorists in the United
Nations instead of attending to the concerns of
the Palestinian refugees. He urged the General
Assembly to stop adopting "resolutions which
gave satisfaction to Arab belligerency, but in no
way advanced the settlement of the refugee problem"

Tekoah addressed the Assembly shortly before a vote was to be taken on a series of resolutions connected with the annual report of the United Nations Relief and Works Agency for Palestine Arab Refuges (UNRWA). He referred specifically to the first of eight draft resolutions which he said reflected "the usual expressions of Arab animosity toward Israel, ignoring facts, perverting truth, distorting legal precepts, injecting issues extraneous to the refugee problem, such as the positions adopted by the Palestinian terrorist organizations,"

Tekoah said the text of the resolutions were "inequitable and detrimental" and that "Israel will oppose them." He singled out sections C, D and E of the first draft resolution which were sponsored by an Afro-Asian bloc and were approved by the Political Committee by substantial matorities.

Section C would have the General Assembly declare that changes in the physical and demographic structure in the Gaza Strip, including the destruction of refugee shelters and the forcible transfer of population, contravenes the Geneva Convention; and would have the Assembly "deplore" these acts and demand that Israel "cease forthwith."

Palestinian Refugees Shortchanged

Section D expresses "grave concern" over the plight of the refugees and "calls once more upon Israel to take steps for the return of the displaced inhabitants" and to "cease forthwith" from all measures affecting changes in the administered territories. Section E of the draft affirms that the people of Palestine are entitled to equal rights and self determination in accordance with the UN Charter and calls "respect" for these rights "indispensable."

Tekoah said in his speech: "The victims of the Arab states' policy in the United Nations are first and foremost the Palestinian refugees themselves. Instead of assisting them in reconstructing their lives, the Arab Governments have been feeding them year after year with United Nations resolutions which reflect the views of notorious violators of international law and morality such as Syria, Libya and Algeria."

The Israeli diplomat observed that if the UN wished to play a constructive role in the advancement of peace in the Middle East it must replace "sterile polemical debates with serious, constructive exchanges of views;" adopt "resolutions arrived at through consultation with and consent of the parties directive concerned;" and encourage the parties "to seek agreement between theirselves through negotiations."

INTERFAITH MEETING FOR SOVIET JEWS

AMSTERDAM, Dec.13 (JTA)--The joint council of christian Churches organized here this week a Protestant-Catholic "Soldarity Assembly with Soviel Jewry." The meeting was addressed by Catholic and Protestant clerics and by Greville Janner, British MP.

WORLD JEWISH POPULATION ESTIMATED AT 14,236,420; 6,060,000 IN U.S.

NEW YORK, Dec. 13 (JTA).—The world Jewish population is estimated at 14,236,420, according to the American Jewish Year Book, whose 1972 edition has just been published. There are approximately 6,600,000 Jews in the United States, more than in any other country. These estimates were compiled by Leon Shapiro, Associate Professor of Russian-Jewish History at Rutgers University, who compiled the overseas demographic data, and Alvin Chenkin, Supervisor, Statistics Unit, Council of Jewish Federations and Welfare Funds, who assembled the figures on the U.S.

After the United States, countries with the largest Jewish populations are: Soviet Union, 2,644,000; Israel, 2,632,000 (it is estimated that 42,000 immigrants entered Israel this past year); France, 550,000; Argentina, 500,000; Great Britain, 410,000; and Canada, 300,000. Half of world Jewry is located in North, Central and South America, 29 percent in Europe, 19 percent in Asia, 1.5 percent in Africa, and 0,5 percent in Australia and New Zealand,

In the United States, the Jewish population has shown an annual growth rate of 1,07 percent over the past three years. "This figure is comparable to the annual growth rate of the total resident population of the United States from 1968 to 1971," Chenkin states, and "the proportion of the total redent population estimated to be Jewish remained at

2.94 percent,"

In Europe, according to Prof. Shapiro, there are more than 4,000,001 Jews, including 2,850,000 in the Communist area. Of these, 2,644,000 are in the Soviet Union, Figures for other European countries include: Austria, 9000; Bellgium, 40,560; Bulgaria, 7000; Czechoslovakia, 14,000; Denmark, 6000; France, 550,000; Germany, 32,000; Great Britain, 410,000; Greece, 6500; Hurgary, 80,000; Ireland, 5400; Italy, 35,000; Netherlands, 30,000; Poland, 8000; Rumania,100,000; Spain, 9000; Sweden, 15,000; Switzerland, 20,000; Turkey 37,000; and Yugoslavia, 7000.

Estimated population for major centers of Jewish concentration in the Americas, besides the United States, include: Canada, 300,000; Mexico, 35,000; Argentina, 500,000; Brazil, 150,000; Chile, 32,000; Colombia, 10,000; Peru, 5300; Uruguay, 50,000, and Venezuela, 12,000. In Asia, the only major centers of Jewish population, besides Israel, are India, 14,500; and Iran, 80,000. In Africa, there are substantial Jewish numbers only in South Africa, 117,990; Morocco, 35,000; Ethiopia, 12,000; Tunisia, 8000; and Rhodesia, 5200. There are 72,000 Jews in Australia and 5000 in New Zealand.

ZOA URGES U.S. TO CONVENE CONCLAVE OF NATIONS TO ACT ON TERRORISM

NEW YORK, Dec. 13 (JTA).—The Zionist Organization of America, deploring the United Nations General Assembly Sixth (Legal) Committee's vote sidetracking strong legal action against terrorism, today urged the United States to convene a conference of concerned nations—outside the framework of the United States.—to enact multilateral anti-terrorism treaties.

Rabbi Joseph P, Sternstein, chairman of the ZOA National Executive Committee, declared in a

statement that the Committee "abrogated a moral responsibility" by approving a resolution conderned primarily with exploring the causes of terrorist acts instead of voting on stronger resolutions which would have resulted in international conventions against terrorism.

Rabbi Sternstein commended the United States for its efforts to gain approval of the stronger anti-terrorism resolutions. But he said the Committee's vote "leaves the United States with no other viable recourse but to take the initiative in calling a conference which would seek primarily to institute joint international actions against nations that encourage, sanction or aid terrorist activities."

DR. SALO BARON HONORED BY ITALY

NEW YORK, Dec. 13 (JTA)--Salo W. Baron, called the "dean of American Jewish scholars," has been named to the rank of Knight of the Order of Merit of the Republic of Italy. The award, made by the President of Italy, Glovanni Leone, cited Dr. Baron for his "past and present contributions to the knowledge of Italian history and civilization." Dr. Baron is professor emeritus of Jewish history, literature and institutions at Columbia University, where he served for 33 years before his retirement in 1963.

He is the author of the monumental "A Social and Religious History of the Jews," 14 volumes of which have been published. A 15th volume, on the history of the Jews in Western Europe and the New World in the 16th and 17th centuries, will be published early next year. On his 75th birthday in 1970, Dr. Baron was honored by the National Foundation for Jewish Culture as the "dean of American Jewish scholars," In 1961, he was called upon to testify as a witness in the Eichmann trial in Jerusalem, at which he described the enormity of the Nazi destruction of the Jewish community in Central and Eastern Europe.

RAY CHARLES CONCERT A RIOT...ALMOST

JERUSALEM, Dec. 13 (JTA)--A riot was narrowly averted at the Binyanel Hacoma concert hall
last night where the Black American singer Ray
Charles was giving a concert. The audience at
the first show refused to leave the hall when it was
over because an American television crew filming
the performance had repeatedly disrupted the concert.

The audience for the second show surged into the auditorium despite efforts by the ushers to keep them out. Fist fights broke out in front of the stage but more serious trouble was averted when the management decided to allow the first audi-

ence to remain for the second show.

Members of the first audience who had paid high prices for admission were angered because the show was 45 minutes late in starting. They said that during the performance they were disturbed by lights held up by the to crew and that prop men and technicians repeatedly traversed the stage. Charles refused to give an encore when the first show ended. The blind singer arrived here yesterday to make a film, "Ray Charles in the Holy Land,"
