### REPORT MRS. MEM ORDERED SECURITY SERVICES TO PLACE MEMBERS OF HER CABINET UNDER SURVEILLANCE IN 1970

Tried To Halt Leaks Of Classified Information To The Nation's Press

JERUSALEM, May 23 (JTA)—The newspaper Haaretz said today that Premier Golda Meir ordered the security services in 1970 to place members of her cabinet under surveillance in order to trace the source of leaks of classified information to the press. According to Haaretz political correspondent, Dan Margalit, the order was reschaded after a protest by Gahal leader Menachem Beigin who was a member of Mrs.

Meir's coalition government at the time.

The newspaper said that the Premier was disturbed by a series of leaks to the press in 1970—which included material sent by the Cabinet secretariat to various ministers. Mrs. Meir ordered an investigation and interrogation of her ministers.

But Beigin raised the matter at a Cabinet meeting and managed to convince Justice Minister Yaacov Shimahon-Shapiro of his point of view. Beigin insisted that the security services were answerable to the Cabinet, not the other way around, and Mrs. Meir's initiative was dropped, Margalit wrote, His article alleged similarities between the 1970 incident and the current Watergate scandal in Washington. Haaretz recently accused the authorities of tapping telephone calls by its military correspondent.

### PARLIAMENT DEBATE ON RECOMMENDATION TO STRIP MSI LEADER OF HIS IMMUNITY

ROME, May 23 (JTA)--Parliament today began a debate on a recommendation to strip neo-fascist leader Giorgio Almirante of his parliamentary immunity so that he can be tried in a criminal court. Almirante faces a charge of resurrecting fascism, with his ultra-right Italian Social Movement (MSI), Italy's fourth largest political force with 2.8 million votes in the 1972 general election, 56 deputies and 26 senators.

The Italian constitution and a 1952 special law ban the resurgence of fascism under any shape or name. But Almirante says his movement is a "law and order" party and has declared he will welcome a trial in order to clear it of the fascist taint. Some political commentators said that if Almirante is acquitted, he will receive a hefty propaganda boost.

A Parliamentary committee voted 15-3 last night to recommend Almirante's trial. Those voting against included two neo-fascists and a Christian Democrat. Debate in the Parliament itself is expected to last at least two days. The Senate already has stripped immunity from two of its neo-fascist members, including Francesco (Ciccio) Franco, leader of the right-wing revolt in South-ern Reggio Calabria.

### FATHER OF SOVIET JEWISH PRISONER TOLD HE MUST LEAVE COUNTRY BY THURSDAY OR BE FORCIBLY OUSTED

TEL AVIV, May 23 (JTA):-Moshe Mendelevich, whose son, Josef, 15 serving a 12-year prison sentence imposed in the 1970 Leningrad hijack trial, may be forcibly ousted tomorrow

from the Soviet Union, Jewish sources in the Soviet Union reported today. In a telephone call to friends here the sources confirmed an earlier report that Mendelevich was told by Soviet authorities that his citizenship has been revoked and that he must be out of the country by May 24.

The Mendelevich family applied for exist visas in 1969. But following Josef's arrest and imprisonment his father declared that he would not leave the Soviet Union as long as his son was in jail. Mendelevich is permitted to visit his son four times a year.

Last month he was summoned to the visa trueau in Riga and told that his visa application had been approved and was given until May 24 to leave. He was told that if he doesn't leave he would be placed abpard a plane. The sources said he was called to the visa bureau again yesterday and told he had 48 hours to depart Russia. They said that Mendeleyich suffers from a heart condition which could prove fatal if force is used against him.

### FIRST COMMERCIAL ISRAEL-MADE . AIRCRAFT ON DISPLAY IN AIR-SHOW

PARIS, May 23 (JTA)—The first commercial aircraft manufactured in Israel—the Arava and the Jet Commodore—arrived here today to go on display at the International Air. Show. Nearly two million aviation experts, sight-seers and potential buyers are expected to attend the show. Elkana Galli, a spokesman for Israel Aircraft Industries which manufactures the planes, said its 1973 line has been sold out but it is accepting orders for 1974 models.

Galli said that over a half dozen countries have already purchased the Israeli planes and that an undisclosed number of Israeli-made missiles have been sold abroad. He refused to disclose the buyers-Israel's new "Shaffir" missile and the surface-to-surface "Gabriel" missile, a sea-borne weapon, are also on display, here.

Galli said that three-fourths of Israel Aircraft Industry production is devoted to military needs and the rest is for the civilian market. He said the company showed a \$2 million profit in 1972.

## ISRAEL IS NOT AFFECTED BY SENATE COMMITTEE'S ACTION TO TERMINATE MILITARY AID GRANTS TO COUNTRIES

WASHINGTON, May 23 (JTA).—Israel is not affected by the Senate Foreign Relations Committee's action to terminate U.S. government grants of military assistance to foreign countries, by July 1, 1977. The committee yesterday set aside the Administration's bill calling for grant aid of \$1.3 billion and adopted the proposal of its chairman, Sen. J. William Fulbright (D.Ark) to provide \$740 million for fiscal year 1974 which begins July 1.

Under the Fulbright bill, however, sales of equipment on credit are not affected. Israel has never received free military assistance, but it has purchased close to \$1 billion in supplies in the 22 years between 1950-1972, a Pentagon report has disclosed. Countries such as Jordan which received \$91 million in grant aid during

the 1950-1972 period would be deprived of such assistance under the Fulbright bill.

A Foreign Relations Committee staff specialist explained that the Fulbright bill would phase out grant assistance ever the next four years beginning July 1. At the same time, a new program of low interest rates for loans to buy equipment would be Provided to those countries with which they could purchase equipment. The original vote on the Fulbright bill was 13-3. Sens. Hugh Scott (R.Pa), Robert Griffin (R.Mich) and Gale W. McGee (D.Wyo) backing the Administration measure, voted against it. Sen. Jacob K. Javits (R.NY), who was absent when the vote was taken, was polled today and he favored the Fulbright measure.

The House Foreign Affairs Committee is holding hearings on the Administration bill. Both in the Fulbright bill and the Administration's legislation, Israel is earmarked for \$300 mailion in military credit for purchases of equipment. Foreign military aid, a standard section of U.S. government policy since the end of World War II, has been provided to dozens of countries. A Pentagon report, made available within the past week, showed that \$35,5 billion in equipment was given away in the 22-year period between 1950-1972. Europe heads the list with more than \$14 billion.

### Breakdown By Countries

By countries, Iran was given \$833 million; Iraq, over \$46 million (none since the Six-Day War); Jordan, \$91 million; Lebanon, \$10 million; Saudi Arabia, \$36 million; and Syria, \$57 million (none since 1967). Egypt and Israel, never received grant aid.

In the military sales-program, Israel bought on credit \$993 million since 1950, Iran's purchases totaled \$793 million; Saudi Arabia, \$300 million; Jordan, \$13 million; and Lebanon, \$4 million, Syria's purchases were negligible;

Unofficially, it was pointed out that Egypt. Syria and Iraq received vast quantities of military equipment since the Six-Day War. France, Britain and other countries also shipped munitions in large amounts to the Middle East in the 20-year period. In the current fiscal year ending next June 30, Israel's-purchases have been \$207 million and Iran's were \$263 million, and Saudi 'Arabia, \$14 million. Lebanon's purchases totaled only \$41,000.

Neither Israeli nor Egyptian military personnet received training from the United States under the military assistance program in the years since 1950, according to the Pentagon report. World-wide, more than 390,000 foreigners were trained by the U.S.

### INVESTMENTS OF \$1.9 BILLION SOUGHT FOR INDUSTRIAL EXPANSION, DEVELOPMENT

TEL AVIV, May 23 (JTA)—Finance Minister Pinhas Sanir said today that Israel is seeking investments totaling at least \$1.9 bittlon for industrial expansion and development in a variety of fields over the next few years. He said the country would seek part of these investments from businessmen from Israel and abroad who will be attending the Third International Economic Conference for Israel which opens Sunday in Jerusalem.

Sapir said Israel wanted about \$500 million for investment in the oil and petrochemical industry, not including the oil presently produced by the fields in Sinai. He said another \$400 million was required to expand the merchant marine and to alleviate the current shortages of cement and newsprint.

He noted that the largest single investment needed, about \$1-billion, was for the construction of conventional power plants to double Israel's output of electricity over the next eight years. He said a nuclear power plant was being planned for the early 1980s.

Sapir said that Israel is seeking technical and business know-how from abroad. He reported that of the 500 largest American corporations, 45 are already involved in Israeli industry. He said Israel is currently represented on the international trade map by some \$6.5 billion and that this figure is growing.

### HIGH COURT DISMISSES BEDOUIN APPEAL ON RAFFAH AREA OUSTER BY MILITARY

JERUSALEM, May 23 (JTA)--The Supreme Court today dismissed an appeal by nine Bedouin tribes against orders by the Military Governor evacuating them from their lands in the Raffah area near the Gaza Strip. The court ruled that the orders were legitimate and in the interests of national security.

The Bedouins, who lodged their appeal a year ago, complained about the evacuation methods and the seizure of their property by Israeli soldiers. Justice Moshe Landau held that the evacuation orders were issued in accordance with the Geneva and Hague conventions and that there was no reason to suspect the Military Governor's, motives. Justice Alfred Vitkon said that security considerations guided the Army's action, and Justice Yitzhak Kister held there were no grounds to intervene in the Military Governor's jurisdiction in the matter.

### CEMENT SHORTAGE CAUSING PROBLEMS

TEL AVIV, May 23-(JTA)--An acute cement shortage has developed in Israel causing contractors to seek supplies on the black market or suspend construction. The Nesher Cement Co., a division of Koor Industries, which has the monopoly on cement production in Israel, produces just over 1.5 million tons a year at its three plants against an estimated demand this year for 2.5 million tons.

Nesher, which is obliged to import cement to make up its shortage, appears reluctant to do so. Several shiploads of cement are waiting to unload at Israeli ports but the vessels cannot discharge their cargoes because of the scarcity of facilities to handle bulk cement.

Housing Minister Zeev Sharef, meanwhile, has blamed contractors for undertaking too many building starts. The contractors are blaming the Ports Authority for delays in unloading imported cement. The Ministry of Commerce and Industry is considering a fourth cement plant outside of the Nesher imonopoly, Two local firms and two foreign firms are bidding for a license to build and IL200 million cement factory.

### SAPIR DEFENDS 'SPECIAL PROJECTS

for some time. Sapir has had to defend his activities before the Knesset Finance Committee which. after hearing detailed reports from the Minister himself and his senior fund-raiser, Knesset member Aviad Yaffe, endorsed the fund's activities by a majority. The Cabinet, two weeks ago, also issued a statement expressing satisfaction and admiration at the Fund's successes. Sapir declared last week that in two years the

fund has raised \$280 million from foreign and local donors for educational, health and welfare projects in Israel. The contributions were solicited over and above the donors' regular United Jewish Appeal or United Israel Appeal contributions, Sapir stressed. He also reported fully on the fund at close intervals to the State Controller and to the Knesset Finance Committee.

levelled particularly at Sapir's soliciting from local entrepreneurs. It was said that there was an ethical flaw in having the same man soliciting donations and allocating loans and grants to the same donor/ manufacturer. Sapir stressed that only 10 percent of the fund's revenues were solicited locally and that even many of the so-called local donors in-fact had their businesses outside Israel, In the Knesset today, Sapir recalled that a ma-

jority of the Finance Committee, including some Gahal members, had been satisfied that all was above reproach. He repeated that all projects were proposed by relevant government ministries to potential donors. It was not as though he, Sapir, set priorities, he said. The funds themselves were channeled through the Jewish Agency whose inter-

nal comptroller supervised the transactions.

Avneri, charging that the fund was "Israel's Watergate," demanded a commission to investigate if pressures were exerted on donors and whether donors received benefits in return for gifts, and whether any of the money was passed to political parties. He charged that Gahal was in league with Sapir. This prompted Gahal leader Menachem Beigin to reply that a man like Avneri, who had "ruined a generation of Israeli youth with his magazine (Haolam Hazeh) for filthy lucre," has no right to preach to anyone. Gahal's Haim Corfu suggested Avneri's motion

be moved to committee, but this too was voted down. Corfu said his party was not satisfied with the detailed reporting of the fund to the Knesset Finance Committee. ANTI-SEMITIC GROUP BEING REVIVED

BUENOS AIRES, May 23 (JTA)-SThe notorious anti-Semitic organization, Alianza Liber tadora Nacionalista (National Liberation Alliance), which was famous in the 1940s and 1950s for anti-Jewish actions, anti-Semitic daubings on Jewish buildings, and violence. has been restructured and is ready to continue

Alfredo Storessner for the protection he extended during his years in exile.

ANARCHIST BOMBER SPENT TWO YEARS IN ISRAEL AS A KIBBUTZ MEMBER

TEL AVIV. May 23 (JTA) -- Gianfranco Bertoli, an Italian anarchist arrested in Milan last week for throwing a grenade that killed one person and injured more than 40, spent two years on an Israeli kibbutz as a volunteer, it was disclosed here. The members of Kibbutz Karmiya, a Mapam kibbutz in the Gaza Strip, had no idea that he was a fugitive from Italian police who had entered Israel under a false name with a stolen passport.

Italy, meanwhile has asked police agencies in Israel, France, Switzerland and Britain for help in finding out whether Bertoli's act was part of an international conspiracy to create disorder in Italy. A 35-year-old Arab believed to be from Yemen, was arrested in Venice Saturday on suspicion of being linked in the alleged plot. According to Israeli officials, Bertoli, 40, arrived in the country two years ago and was directed to Karmiya by a central office that directs all volunteers from abroad to kibbutzim. The kibbutzim are selected without re-

gard to their political affiliations. The officials said that Bertoli carried a valid passport and that he was never suspected or questioned because there was no Interpol bulletin out for a man of his description. He was known at Kibbutz Karmiya as Massimo Mugari. He told the members that he left home because his parents were separated and his girl friend had left him. He spoke little of the past and was apparently well-liked by many of the kibbutz members. When his

REPORT SHOWS ATTACKS ON ZIONISM, ISRAEL, CODE WORDS FOR ANTI-SEMITISM Ultra Right Groups Seen Declining

NEW YORK, May 22 (JTA)—A worldwide survey by the American Jewish Committee has established that attacks on Zionism and Israel have become code words for anti-Semitism, and that such attacks are being made by a broad range of groups, from the extreme right to the New Left. But the survey also found that "there appears to be a waning of the strength of Fascists and other ultra-Rightist movements around the world. Naked classical anti-Semitism-is increasingly rare in most Western nations."

A similar survey by the AJCommittee 10 years ago found that the ultra-Rightist movements constituted the main threat to Jews, along with Communist government policy in most of Eastern Europe. Today, in the Soviet Union, the report said, despite the easing of some restrictions on emigration and the departure of several thousands of Jews each year, conditions for the Jews there are worse than they have been in the two decades since the death of Joseph Stalin.

A comprehensive draft text-of-the report, "Anti-Semitism in the 1970's; A Survey of the Foreign Scene," produced with a grant of the Leonard and Rose Sperry International Center for the Resolution of Group Conflict, was made public here by Morris H. Bergreen, Chairman, Foreign Affairs Commission, at the AJCommittee's 67th annual meeting. A companion report on the state of anti-Semitism in the United States is currently in preparation.

The report points out that a "highly sophisticated Arab propaganda apparatus" has been developed, which "has reintroduced overt expression and occasional acts of open anti-Semitism cloaked in anti-Zionist and anti-Israel terms." The Arab attacks, the survey explains, have attacted a "broad range of individuals and groups ranging from the extreme right to the New Left, financed by vast sums of money emanating from Arab sources, including oil revenues."

The report details the extent of anti-Semitism in many parts of the world. In the Soviet Union, it says in part, overt and covert anti-Semitism abound, anti-Semitic publications are frequent, and anti-Zemitic propaganda is blatant. Jews have been pushed out of most positions of importance in the government, and though the proportion of Jews\_with higher education is still large, Jewish students are finding it more difficult to get into better schools.

#### Incidents In Europe, South America

In some moderate, pro-Western Arab countries such as Morocco and Tunisia, the security of Jews has been profected by the authorities, while in other countries, such as Syria and Iraq, persecution and murder of the tiny Jewish remnant continues.

An upsurge of anti-Semitto incidents in Italy combined with the resurgence of the neo-Fascist movement, has shaken the Jewish Community there. In France, strong Arab propaganda efforts and New Left hostility to Israel have tarnished the image of Jews among some young people. However, the country has a new, strong law against group defamation and group slander, which has already been applied against an editor who reprinted an anti-Semitte article.

In Germany, the far right anti-Semitic organizations that flourished a few years ago have disintegrated and New Left influence has also slipped, though Arab organizations are quite active. There is also an active pro-Arab—propaganda effort in Great Britain, although most British Jews feel quite secure, as do most Dutch Jews. There are frequent reminders that anti-Semitism has a longer-tradition-than-hospitality to Jews in South Africa, Jews are able to assert their Jewish identity without hindrance but they cannot, without serious risk, take an active part in the struggle against apartheid.

Jews in Argentina, Brazil, Chile and Mexico. where the bulk of the continent's Jews live, are concerned about a flood of anti-Israel propaganda, fomented by Arab League offices, that the Jews fear could stir a new wave of anti-Jewish feeling. Since 1964, there have been many synagogue bombings and other anti-Semitic acts in Argentina, coincidental with increased Arab propaganda activities. In Brazil, where there has been a remarkable economic upsurge, organized anti-Semitism is not a problem. In Chile, political unrest has led to the departure of about 20 percent of Chile's Jews in the past two years but President Salvador Allende has spoken out strongly against anti-Semitic Arab propaganda. In Mexico, an intense Arab propaganda effort has been aided by the activities of both the Soviet Union and the People's Republic of China

### WEEK OF EVENTS FOR SOVIET JEWS TO MARK VISIT OF LEONID BREZHNEV

NEW YORK. May 23 (JTA) - A Freedom Assembly for Soviet Jews will take place on the ellipse in Washington June 17 on the eve of the arrival of Soviet Communist Party Secretary Leonid I. Brezhnev, it was announced today by the National Conference on Soviet, Jewry which is the general sponsor of the assembly. A NCSJ spokesman said that the event will represent the concern of millions of Americans for Soviet Jews, and will initiate a weeklong series of events around the country.

Richard Mass, chairman of the NCSJ, explained that "Soviet Jews live in a tense and dangerous atmosphere. Arrests continue, serious harassment endangers lives, and the spectre of a major "show" trial in Minsk, are of grave concern to us. We are aware of the recent suspension of the "diploma tax," but thousands of Soviet Jews, repeatebly rebuffed, are still not permitted to be reunited with their families in Israel and elsewhere. Naturally, we welcome progress that has been made, especially in regard to increased emigration, but during the week of Brezhnev's visit we will underscore our commitment to press for the rights of Soviet Jews to emigrate freely and to live as Jews."

In coordination with the National Jewish Community Relations Advisory Council, dozens of Eastern seaboard communities will be represented at the assembly. Responsibility for coordinating the assembly in Washington has been undertaken by the Washington Jewish Community Council for the NCSJ, Other organizations involved are the Interreligious Task Porce, on Soviet Jewry and the Academic Committee on Soviet Jewry.
