#### WORKERS FACING LAYOFFS

TEL AVIV, March 4 (JTA)--Israeli workers are facing layoffs in two widely separated regions--Haifa and the Negev. The Timna Copper Mines, near-Bilat, announced today that it planned to furlough about 200 workers because of the precipitous drop in world copper prices last year--from IL 1270 to IL 51 per ton. The Haifa Port Authority said it would dismiss about 50 seasonal workers and possibly an unspecified number of permanent-workers as well.

In both instances, the impending layoffs are not linked to the controversial sales and payroll taxes imposed by the government last week which many businessmen fear may lead to widespread unemployment. The Timna mines cited high production costs which, combined with the drop in the copper market have saddled the company with heavy losses. It plans to decrease production by 20 percent, cut back on geological surveys and lease some of its heavy equipment for outside work. The layoffs at the Timna mines will have an impact on the Ellat area. The Ellat Labor Council has asked the government to investigate new job opportunities for Ellat workers.

The Haifa Labor Council's secretary, Eliezer Molk, warned the Port Authority last night to delay its layoffs until after the Passover holiday to give the workers time to find other jobs, Dismissals are also expected in several textile plants due to the financial crisis affecting israel's textile industry. Histadrut is expected to try to forestall any dismissals prior to Passover

Government spokesmen insist, meanwhile, that the government will be able to cope with what it calls "pockets" of unemployment should they develop as a result of the 4 percent payroll tax and the 7.5 percent sales tax which is expected to reduce overall consumption. Both the Finance and Labor ministries claim there is no unemployment in Israel, yet.

#### 60% HIKE IN MATZO, MATZO FLOUR PRICES FORESHADOWS EXPENSIVE PESACH

TEL AVIV, March 4 (JTA)—The Ministry of Commerce and Industry has just approved a 60 percent increase in the price of matzos and matzo flour foreshadowing a very expensive Passover for most Israelis. A 2.5 kg, package of matzos—one week's supply for one person—will cost IL 6.50 compared to IL 4 last year. A Ministry spokesman said, however, that there would be no shortage of matzos or of any of the other traditional Passover foods. The Ministry also announced that it would lower the prices of imported fish fillets and frozen liver.

Meanwhile, retailers have begun to reduce prices on a variety of products in face of a sharp slackening of consumer demand. Since the government's new 7.5 percent sales tax went into effect last week there has been a significant drop in sales of furniture, clothing and shoes. Retailers of those items have decided to absorb the sales tax instead of passing it on to their customers.

But cost-consciousness among consumers has already had a dampening effect on pre-Passover sales. Housewives are seeking out the cheapest foods, leaving the more expensive items on the market shelves.

## KATZIR URGES U.S. JEWS TO INTERPRET ISRAEL'S IDEALS TO U.S. COMMUNITY

WASHINGTON, March 4 (JTA)--Israeli President-Epiraim Katzir, making his first visit to Washington as head of the Jewish State, urged leaders of the Washington Jewish community yesterday to continue efforts to interpret Israel's ideals of democracy, morality, justice and peace to the general American community. Katzir also stressed the importance of Jewish education in improving the quality of Jewish life. Referring to Israel's socio-economic problems, Katzir said that American Jews have an opportunity for direct assistance to Israel by contributing trained manpower as well as finances.

Judge William C, Levy, president of the Jewleh Community Council of Greater Washington, headed the score of local leaders who met with Katzir at Blair House where he is the guest of President Ford. Last night Israeli Ambassador Simcha Dinitz hosted a reception for Katzir at the Israeli Embassy at which 40 Administration and Congressional leaders attended.

#### CULTURE ACCORD SIGNED WITH ITALY

JERUSALEM, March 4 (JTA)--A Hebrew language lectureship is to be instituted at the University of Venice under the terms of a outlure accord recently signed in Jerusalem between Israel and Italy. Other lectureships are planned for Naples and Rome universities--and chairs in Italian at Tel Aviv, Bar-Ilan and Beersheba Universities in Israel. Also agreed to was Israel's aid in restoration work at the Venice ghetto. Israel will send an expert to assist local officials in the restoration. There are also provisions for exchanges of orchestras, theater companies and art exhibitions.

# CONTROLS SOUGHT TO PREVENT ANYONE PARTICIPATING IN ARAB BOY COTT FROM INVESTING IN THE UNITED STATES BY JOSEPH POLSKOFF

WASHINGTON, March 4 (JTA)—Sen. Harrison A. Williams, Jr. (D.NJ) today introduced an amendment to hig-proposed law controlling foreign investment in American companies which would prevent anyone participating in the Arab boyout from investing in the United States. At the sametime, Jack F. Bennett, Undersecretary of Treasury for Monetary Affairs, opposed any new regulations and said existing laws were adequate.

Williams, chairman of the Senate Banking, Housing and Urban Affairs Subcommittee.on Securities, had earlier introduced a bill to monitor any investment of five percent or more by a foreign government, company or individual in a U.S. company. The proposed law would also give the President the authority to prohibit the investment if it was not in the national interest.

The New Jersey Democrat's new amendment would prohibit investment by anyone "who has forced or attempted to force other firms to boy-cott an American business because of its dealings with or in a foreign country with which the U.S. has diplomatic relations." Williams said

the Arab boycott "is quite clearly and very distressingly, being pursued against U.S., businesses merely because they have ties to Jews or others considered friendly to Israel or 'Zionism.'"

Bennett, testifying before Williams' subcommittee which began today three days of hearings on the boycott, said no new legislation is required because existing laws and practices 'provide extensive information with respect to foreign investment as well as safeguards to deal with particular investments,"

#### Cautions Against Oppressive Surveillance

However, Bennett said that administrative action is being taken to establish an inter-agency committee reporting to the President's Economic Policy Board which would serve as the focal point for ensuring that foreign investment in the U.S. is consistent with the national interest.

He also suggested a new office to serve the government by monitoring foreign investment and their impact, and negotiating procedures with "the principal foreign governmental investors for advance consultations with the U.S. government on prospective major direct investments in the United States.

The Treasury official contended that foreign investment is contributing to the dynamism of the American economy by stimulating competition in seeking new investment opportunities. "Let us not make the surveillance so oppressive as to drive it away," he said, "We need it," Williams noted that Bennett is a former executive of Exon.

#### Wants It Out In The Open

Former Ohio Sen, Howard M, Metzenbaum urged tightening of the Williams amendment saying that trinotice of intention by foreign interests to acquire control of a firm should not be confidential and submitted only to the Security and Exchange Commission and the President, "I would prefer to trust the pressure of public opinion if the entire nation knew that such action was contemplated." the Ohio Democraft said.

"To those who might suggest that this might have an impact on the stock market price of the company's securities," Metzenbaum said, "when the SEC, its staff, the President and his staff, know that such action is pending, it will no longer be a secret. Other countries such as Australia, Canada, France, Germany and Italy require

disclosure. Why not the U.S.?"

Metzenbaum also pointed out that if the entire matter of foreign investment is kept confidential, a stockholder would not be able to act against a foreign investor that has failed to comply with U.S. laws. He also recommended that the Williams amendment include a proviso that would enable the President to inquire into the purchaser's intent. "Iff the foreign investor seeks to compromise our independence and integrity, let that foreign investor look elsewhere, he said.

Meanwhile, James E, Smith, the U.S. Comptroller of the Currency, has warned banks against accepting the Arabs' anti-Jewish rules in dealings, and against accepting large deposits or loans by Arab Investors that require discrimination against Jews. In a letter dated Feb. 24, Smith said his office "will assure adherence of national banks to a non-discriminatory policy." Smith could issue cease-and-desist orders against bias where it is uncovered.

#### ADL ASKS FORD TO ORDER CORRECTIVE ACTION BY U.S. BANKS, STEAMSHIP LINES INVOLVED IN ARAB BOY COTT

NEW YORK, March 4 (JTA)--The Anti-Defamation League of B'nal B'rith has asked President Ford to "order immediate corrective action" by American banks and steamship lines of alleged collusion with the Arab boycott of Israel in "daily violation" of U.S. maritime laws and other federals statutes. A letter to Ford from ADL national chairman Seymour Graubard was accompanied by sample forms on steamship company letterheads attesting that a-vessel in which goods were shipped to customers in Arab countries is not on the Arab blacklist, not of Israeli origin and will not call at israeli ports,

The boycott compliance forms must be furnished by the shipper along with the regular routine documents before the banks will honor the purchaser's letter of credit, the ADL charged. The ADL named the Chemical Bank, First National Bank of Chicago, First National City Bank and the Irving Trust Co. as cooperating in this process and declared that every bank negotiating Mid-

east credits is reportedly involved,

The letter also named 14 steamship lines or steamship agents in the U.S. engaged in trade with the Middle East. Three of them, the Waterman Steamship, Corp. Lykes Bros. Steamship, Co. and American Export Lines Inc., are federally subsidized American- Tag carriers. The American Export Lines is the largest American-flag carrier of freight to and from Israel and has maintained regular sérvice to that country since 1948. But its ships calling at Israel ports do not call at Arab ports and vice versa.

#### Violation Of Law Cited

Arnold Forster, associate director and general counsel of the ADL, told the Jewish Telegraphic Agency today that the fact that a company offered service to Israel was not relevant to the fact that it violated U.S. law which prohibits any common carrier from filing a certificate of boycott. He said that ban is contained in a 1960 revision of the U.S. Shipping Act of 1916. Forster said that if the banks and shipping companies refused to accept the Arabs' demands for a boycott compliance document, the Arabs "couldn't do a dime's worth of business" with the U.S.

Graubard's letter to President Ford noted that the 1916 Shipping Acf attaches a penalty of up to \$25,000 for "refusing or threatening to refuse, space, accommodations when such are available or resort to other discriminating or unfair methods" and a fine of up to \$5000 for each instance of "fundue or unreasonable preference or advantage..." Sect. 19 of the 1916 Shipping Act was aimed primarily against rate discrimination by foreign steamship lines or their agents against American lines.

#### CHURCH SAYS ARAB BLACKLIST THREATENS DIVISIVENESS AMONG AMERICANS

PHILADELPHIA, March 4 (JTA)--Sen. Frank Church (D. Idaho) said last night that the Arab blacklist threatens "deep and lasting devisiveness" among Americans and declared that "Arab dictation as to who may or may not participate in our business transactions is too high a price to Pay."

Church, chairman of the Senate Foreign Relations Subcommittee on Multinational Corporations, spoke at a dinner at the Bellevue-Stratford Hotel at which Mrs, Leona Chanin of New York was installed as president of the National Women's Division of the American Jewish Congress. Some 500 delegates from throughout the country are attending the women's division's biennial convention.

The Idaho Democrat, who last week released the names of some 1500 American companies on the Arab blacklist, assailed what he called the "raw power of Arab money." He declared that "A political settlement in the Middle East must be judged on its own terms, and not imposed as a consequence of economic pressure."

Church said the international oil companies have received "preferential tax and anti-trust treatment in the name of national security! the "these arrangements haven't enhanced our security at all. On the contrary, by making us more dependent on Middle East sources of oil they have weakened our security."

#### Oil Prices, Mideast Settlement, Not Connected

Denying that if only there were a Middle East settlement satisfactory to the Arabs, "foil prices would come down," Church noted that "the 500 percent oil price increase imposed by the OPEC cartel was ram-rodded by Iran and Venezuela, neither of whom have a special interest in the Arab-Israeli conflict. These countries will seek to maintain the cartel price regardless of what happens to the Arabs and Israelis."

Church said that proposals to achieve peace in the Mideast should be evaluated "on their own merits and not under the false illusion that if only we accommodate the Arab pride, the Western world will be rewarded with lower international oil prices,"

The Idaho Senator also said that he had seen oil company internal memoranda and correspondence which showed that Texaco, Exxon, Mobil and Standard Oil of California had tried to convince the White House not to supply Israel with arms and ammunition during the Yom Kippur War because they feared their concessions in Saudi Arabia would be nationalized. He said fortunately the Administration did not give in to this pressure,

#### Effort To Aid Syrian Jews

During the three-day convention which ended today, Esther H, Kolatch, executive director of the Women's Division, reported that the group has launched a special effort in behalf of the 4500 Jews in Syria and said that the AJCongress women were calling on the State Department, now that diplomatic relations between Washington and Damascus had been resumed, to urge the Syrian regime to abide by the UN Declaration on Human Rights by ending the intimidation and persecution of Syrian Jews and letting those who wish to leave emigrate to a land of their own choosing.

Jacqueline Levine of West Crange, N.J., the outgoing president, called on the nation's volunteers to fill the gap in social services created by the budget cutbacks resulting from the recession, President Ford, in a message to the convention, said the group has "benefitted our society by urging women to participate more fully in our national life," He noted that "the philosophy of your organization advocates our national commitment to equal opportunity for all."

#### UOJCA RETURNS TO SCA, BUT DENIES REFORM, CONSERVATIVE LEGITIMACY

NEW YORK, March 4 (JTA) -- The board of directors of the Union of Orthodox Jewish Congregations of America voted yesterday 68-56 to end its one-year suspension from the Synagogue Council of America, Harold M, Jacobs, UOJCA

president, said the move was taken at this time "to help unify the Jewish people in this hour of grave crisis for Israel, Soviet Jewry and the world Jewish community."

At the same time, the board was unanimous in asserting that "continued participation (in the SCA) was not to be interpreted as religious recognition of other branches within Judaism or their spokesmen, "Land-that the board's decision "was not to be viewed as a rejection of the spiritual authority or religious leadership of those who had urged withdrawal from the Synagogue Council of America."

The issue centered on the question of whether UCJCA membership in the SCA implies recognition of the Reform and Conservative movements which also belong to the SCA, Jacobs affirmed, after the vote yestsfday, that there was no question so far as the UCJCA was concerned that it never has and never will recognize the religious legitimacy or authority of the Reform and Conservative movements.

"The UOJCA's participation with such groups in the SCA has, therefore, no ideological or religious significance above and beyond the Orthodox Union's desire to cooperate with all segments of the Jewish community on issues of common concern," Jacobs said, "We hope that the Orthodox Union and its members can now proceed in unity to the strengthening of the Torah values which concern us all."

#### RAA Denounces Move

The UOJCA action, however, was challenged by the Rabbinical Alliance of America which expressed its shock and dismay. Rabbi David Holiander, RAA president, denounced what he termed "the wanton violation of the halachic ban on membership in the Synagogue Council of America. This is the first time in history that rabbis who are regarded as Orthodox have urged and pleaded with the laity within the Orthodox Union to act contrary to a halachic ruling issued by outstanding halachic authorities of our time."

Rabbi Hollander called upon the organized Orthodox rabbinate and other Orthodox groups to "stand solidly behind the sanotity of the halaoha and to use every just and legitimate means to deal with those who are responsible for the defiance of the authority of the halacha."

#### BRAZIL BACKS PALESTINIANS

RIÓ DE JANEIRO, March 4 (JTA)—Brazilian President Ernesto Geisel said yesterday that Israeli withdrawal from occupied territories was a necessity for peace in the Middle East. In an address opening the National Congress in which he discussed domestic and foreign affairs, Geisel said Brazil opposes the use of violence in international relations, including the occupation of territory by force. He also declared Brazil's support for the Palestinian people's claim for self-determination and sovereignly.

JERUSALEM (JTA).—Students and professors demonstrated in front of the Knesset Monday to protest the failure to include allocations for underprivileged youths in the record IL 56 billion budget for fiscal 1975-76 that was presented to the Knesset last week. They said they would continue their protest in shifts until their demands were fulfilled.

BUENOS AIRES (JTA) -- A bomb heavily damaged the Paso Street Temple early Monday destroying 60 window panes and three stained glass windows. There were no casualities. Police are investigating the attack on the synagogue.

#### 4 HARVARD PROFS DECLARE SUPPORT FOR KISSINGER'S MIDEAST EFFORTS Express Concern Over Opposition To Secretary By Some American Jews

BOSTON, March 4 (JTA) -- Four Harvard professors today declared their support for Secretary of State Henry A. Kissinger's diplomatic efforts to achieve peace in the Middle East and declared their concern over opposition to these efforts by some segments of the American Jewish community.

The four, all Jews, are David Landes, national chairman of the American Professors for Peace in the Middle East; Martin Peretz, chairman of the editorial board of the New Republic and a member of the board of governors of Hebrew University; Henry Rosovsky, chairman of the Commission on International Affairs of the American Jewish Congress; and Michael Walzer a member of the board of trustees of the Institute of Jewish Policy, Planning and Research of the Synagogue Council of America.

The statement declared that while the four obligations "have had and continue to have various differences with Dr. Kissinger on other issues," they were "distressed by the fact that he has become the target of an unwarranted and base-less campaign questioning his fundamental mot-

ives vis-a-vis Israel,"

Citing the "common sense" understanding of 
"what is at risk in the Middle East our-ently," 
the scholars asserted that "the loose talk, the 
pseudo-psychology, the ad hominem attacks" on 
Dr. Kissinger were "particularly dangerous" 
because "they play on our worst fears and make 
rational argument increasingly difficult." They 
added that such attacks "weaken Dr. Kissinger's 
position at a time when no imaginable successor would be more concerned for Israel's security that he has been."

#### Another Interim Accord Is Vital

Declaring they were "not in complete agreement" about "the best American or Israeli strategy over the coming months," the professors said they all believed that another interim agreement between Israel and Egypt was "a vita precondition of further negotiations, at Geneva or anywhere else."

"Such an agreement necessarily entails further concessions from both Israelis and Egyptians" as the only "quid pro quo" for creation of an "organic structure of peace" they said was Kissinger's purpose. They declared that success for Kissinger's current mission would make renewal of war in the Sinai "less likely, protecting Israel from a surprise attack" like the Yom Kippur War.

They also said success "might begin to generate confidence on both sides about the possibilities of a full peace" and involve the United States "even more deeply in peace-making and peace-keeping in the Middle East; an involvement" they declared "serves America's interests and also Israel's."

## CBS, NBC SAY THEY WILL NOT PERMIT ARABS TO DICTATE THEIR NEWS POLICIES

NEW YORK, March 4 (JTA)--The two largest American broadcasting networks have responded sharply to a threat by the Arab Boycott Office in Beirut to cut off their news overage in Arab states unless "this activity is beneficial to the Arab cause and under supervision of the Arabs." Richard C., Wald-president of NBC News, told the Jewish Telegraphic Agency today that

"We do not allow anyone to diotate the content of NBC news."

In a statement issued yesterday. Richard Salant, president of CBS News, noted that "CBS News has covered news in all major Arab otties but never under supervision, nor would CBS News permit any government, including the U.S. government, to diotate the content of our news coverage." He added that "CBS News does not cover events with an eye to which group would benefit. We cover events as carefully and objectively as we can regardless of who benefits."

## KOCH ASKS KENDALL TO EXPLAIN INCIDENT INVOLVING POLAKOFF

WASHINGTON, March 4 (JTA)—Rep. Edward I, Kond (D,NY), has asked Donald M. Kendall, the American co-chairman of the U,S.-USSR Trade and Economic Council, for his "version of the facts" involving him in an incident Feb. 21 with Joseph Polakoff, the Jewish Telegraphic Agency's Washington bureau chief. Koch in a letter to Kendall enclosed a JTA report on the incident that took place at the Madison Hotel where the Council held a news conference.

Polakoff had questioned the remarks by Vladimir Alkhimov, Soviet Deputy Foreign Minister for Trade and the Soviet oc-chairman of the Council, Kendall sought to cut off Polakoff's questioning, Afterwards, when Polakoff had shaken hands with Alkhimov and sought to question him further, Kendall pushed Polakoff and put his hands on his shoul-

ders in a confrontation manner.

"I was shocked to see the enclosed report,"
Kooh wrote Kendall. "Not having been present at
the press conference, I would be interested to know
what your version of the facts is. Since this is a
matter which has received notoriety, and my constituents have inquired concerning it, your expeditlous response would be appreciated," Kooh addressed his letter to Kendall as chairman of the
board and ohief executive officer of Pepsico Inc, at
Purchase, N.Y.

#### SOME ARE LESS MARRIED THAN OTHERS

TEL AVIV, March 4 (JTA)--Some Israeli students living in the United States are paying American women to marry them temporarily so that they can qualify for work permits in order to support themselves while attending college, the Tel Avjv University student weekly "Yatoosh" (Mosquito) reported. The subterfuge is necessary because high tuttion fees and high living costs in the U.S. make it imperative for the students to seek jobs for which they need the coveted "green card," the work permit issued to altens married to American cittzens, "Yatoosh" said.

In some cases the newly-wed students get reductions in fees and rent and qualify for American citizenship. When their financial burdens are eased, the students divorce their American wives, by prearrangement and often bring over their Israeli girlifiends to get married. The American women know they are being used but cooperate for a certain sum of money. The U.S. immigration authorities are aware of the practice but can do nothing about it because it is legal, "Yatoosh" said.

LONDON (JTA) -- A Hasidic encyclopaedia is now being prepared and will be published by the Hebrew Publishing Company of New York and Weidenfeld and Nicolson in this country. The chief editor is Rabbi Dr. H. Rabinowitz, a Hasidic scholar and the author of numerous books and essays on the subject.
