GENERAL ASSEMBLY OVERWHELMINGLY APPROVES TWO PRO-PLO RESOLUTIONS Vote Is 101-8 For One Resolution and 93-18 For Second Resolution

And 93-18 For Second Resolution By Yitzhak Rabi

UNITED NATIONS, Nov. 10 (JTA)—The General Assembly today overwhelmingly approved two resolutions calling for the Palestine Liberation Organization's participation in all Mideast peace-making forums and the establishment of a special committee to implement the "inalienable rights" of the Palestinian people. Both resolutions were denounced by Israell Ambassador Chaim Herzog and Israell Premier Yitzhak Rabin, (See separate stories.)

'Meanwhile, a motion by Beiglum to delay a vote in the General Assembly on the anti-Zionist resolution today was defeated by a vote of 67-55 with 15 abstentions. Beiglum was seconded by Liberia and Uruguay in its motion. A second motion by Beiglum to vote first on the anti-Zionist measure so that it could be separated from the other resolutions dealing with apartheid and colonialism was rejected by a vote of 74-36 with 26 abstentions.

The first pro-PLO resolution, sponsored by Egypt and 40 other states, would have the United Nations invite the PLO to take part \*on an equal footing\* with other parties in any Middle East peace conference. It specifically instructed Secretary General Kurt Waldheim to inform the United 7 States and the Soviet Union, co-chairmen of this Geneva conference, to take all necessary steps to invite the PLO to participate in its work \*as well as in all other efforts for peace,

The resolution was adopted by a 101-8 vote with 25 abstentions. Israel, the United States, the United Kingdom; The Netherlands, Nicaragua, Honduras, West Germany and Costa Rica voted against the measure. The resolution was originally proposed by Egyptjan President Anwar Sadat in his address to the General Assembly earlier this month.

#### Palestinian Rights Supported

The second resolution, sponsored by 50 East European and Third World countries, was adopted by a 93-18 vote with 27 abstentions, Among those voting against this resolution were the U.S., Israel, the United Kingdom, West Germany and Canada, France and Austria abstained on this resolution as well as on the one sponsored by Egypt.

The resolution calls for the establishment of a 20-nation committee of the General Assembly to draft plans to implement the Assembly's 1974 Pales tinian resolutions. The committee was requested to report to the Security Council by June, 1976 and to provide another report to the General Assembly next year.

The latter resolution reaffirmed the 1974 resolution's support of the right of self-determination and national independence for the Palestinians. The 1974 measure also affirmed the right of the Palestinians to "return to the homes and property from which they were uprooted." Neither the resolutions of 1974 nor the two adopted here today mentioned Israel's right to exist.

The General Assembly is scheduled to vote this afternoon or tonight on the controversial draft adopted by its Third Committee on Oct. 17 which

describes Zionism as a form of racism. Despite strong opposition by the Western powers, that resolution is also expected to be adopted. Last month's vote in the Third Committee was 70-29 with 27 abstentions.

## HERZOG SAYS PRO-PLO RESOLUTIONS 'UTTERLY UNACCEPTABLE' TO ISRAEL

united Nations, Nov. 10 (JTA)--Israel deolared today that the two pro-PLO resolutions adopted by overwhelming majorities in the General-Assembly this morning "are utterly unacceptable" to the israeli government and create "an impasse" in the Middle East for which the states that voted for them bear responsibility.

Exercising his right of reply immediately after the voting, Israel's Ambassador to the United Nations, Chaim Herzog, said the two resolutions were. a tragic blow to the peace effort mechanism in our region and the members of the organization who voted for them will bear the responsibility for the dire consequences which may emerge."

He pointed out that the new resolutions do not mention Security Council Resolutions 242 and 338 "as if the General Assembly could ignore the resolutions of the Security Council as well as the existing international mechanism which has brought about in the course of the year the signature of the significant agreement between Israel and Egypt."

Herzog also observed that today's resolutions did not mention the Geneva peace conference. The resolution favoring PLO participation in any Mideast peace-making forums, however, included the Geneva conference by implication,

#### Will Not Negotiate With PLO

He reiterated that Israel will not "under any circumstances" negotiate with the PLO which, he said, is bent on the destruction of Israel, "The government of Israel, in the exercise of its rights, rejects such recommendations of the General Assembly," Herzog declared, "It will not participate in any negotiations with the so-called PLO and will not cooperate in any manner within the framework of resolutions" of last year or today's resolutions,

Last year's resolutions adopted by the General Assembly, accorded the PLO observer status and affirmed the "inationable rights" of the Palestinians. The resolutions adopted by the Assembly today were related to the earlier measures.

Herzog said Israel was ready to move toward a peaceful settlement within the framework of Resolutions 242 and 338 and \*the resultant mechanism thereby oreated in Geneva."

#### RABIN; PRO-PLO RESOLUTIONS ARE AN ASSAULT ON ISRAEL'S SOVEREIGNTY By Yitzhak Shargil

JERUSALEM, Nov. 10 (JTA)--Premier Yitzhak Rabin declared tonight that the pro-PLO resolutions overwhelmingly adopted by the United Nations General Assembly today constituted an assault on the right-of-existence of the State of Israel, disavowal of the role designated the UN\* and \*asbotage of the effort to achieve peace between Israel

and the Arab states."

He declared that "No resolution of the UN
General Assembly will bind Israel to negotiate

with the terrorist organization" and affirmed that larael's reply to the resolutions "together with the Jewish people throughout the world, will be increasing unity in the effort to reinforce the strength of the State of Israel in the fulfillment of its historic tasks." He thanked those nations that voted against the measures.

Rabin's statement said: "Eregard it-as-necessary to react without delay, on behalf of the government of israel, to the resolutions adopted today in the UN General Assembly. The majority in the Assembly today reached a nadir in two resolutions both of which, alike, have the significance of anassault on the right of existence of the State of Israel, of disavowal of the role designated the UN, and of sabotage of the effort to achieve peace between Israel and the Arab states.

The countries that supported each of these two resolutions have assumed a heavy responsibility for a step whose meaning is the granting of encouragement by the UN General Assembly to organizations whose method is terrorism and whose declared objective is to destroy a member state of the UN-the State of Israel, Any anti-Israel terrorist element seeking to thwart any effort to promote peace between Israel and its neighbors-will find justification for the criminal acts in these contemptible-resolutions of the UN General Assembly.

#### Devoid of Moral Validity

"This is not the first time that the majority of the UN General Assembly has adopted discriminatory resolutions which ignore the rights of the State of Israel, But the resolutions now adopted seek to integrate the anti-Zionist ideological aspect with a practical anti-Israel aspect. The majority of the Assembly calls for the establishment of a committee on behalf of the UN among whose tasks will be to work for the implementation of UN General Assembly resolutions contravening the rights of Israel as a sovereign and independent state,

These resolutions are devoid of any moral validity. The government of Israel will not cooperate with the committee decided upon. The government of Israel will not negotiate with terrorist organizations calling themselves the Palestine Liberation Organization.

#### Obstacle to Geneva Conference

We made it clear at an early stage to all the political factors that we reject the invitation of the PLO to the Geneva conference, it was agreed with us that only factors to whose invitation all sides would agree upon would be invited to the conference. The countries that voted for the Arab initiative in the Assembly must, therefore, be aware that the said resolutions constitute an obstacle on the road to the convening of the Geneva conference. No resolution of the UN General Assembly will bind Israel to negotiate with the terrorist organizations.

"We express our esteem to all the states that did not lend a hand to these disgraceful resolutions and did not yield to appeasement vis-a-vis Israel's enemies, Our-repty—together with the Jewish people throughout the world—will be Increasing unity in the effort to reinforce the strength of the State of Israel in the fulfillment of its historic tasks."

KISSINGER; ANTI-ZIONIST DRAFT IS AN EXAMPLE OF BLOC VOTING By Coseph Polakoff

WASHINGTON, Nov. 10 (JTA) -- Secretary of State Henry A, Kissinger said today that the inappropriate resolution" in the United Nations branding Zionism as a form of racism "is an example of bloc voting and of one-way morality that has weakthened the public support in the United States for the United Nations."

"We consider it an inappropriate resolution andwe are opposing it." Kissinger told a news conference today in response to a question. "It cannot help the attitude of the public toward the United

Nations."

The Secretary pointed out that President Ford, UN Ambassador Daniel Moynthan and he himself have spoken out against the resolution which was adopted by the UN Third Committee Oct, 17 by Arab, Communist and Third World Nations, It is being debated in the General Assembly today. Risatinger did not mention the near-unanimous opposition to the resolution by the Senate and House of Representatives.

#### Will Support British Effort

Regarding a report that Britain may seek to intercede between Syria and Israel on the Golan Heights following Egyptian President Anwar Sadat's visit to London, Kissinger-remarked that the U.S. will "strongly support," the British effort and that "the U.S. will support any pre-mising effort no matter who Conducts it." However, he did not appear to specifically affirm the report of British intercession.

He expressed confidence that "when Syria weighs the alternatives" it will decide to renew the presence of the United Nations force on the Golan Heights. Kissinger said failure to renew it would result in "escalation of tensions" and "not serve any purpose." The mandate for the UN presence expires at the end of this month. Kissinger noted that the US Ambassador to Syria, Richard Murphy, is in Washington and will return to Damascus with the U.S. considerations on the mandate's renewal.

#### Decision Due on Sinai Personnel

An inter-agency study, Kissinger said, on the establishment of the U.S. civilian technical group in Sinat between Egyptian and Israeli-lines has been completed and he expects the President will make his decision about the organization <sup>4</sup>in a week or so." The group will be in place, the Secretary added, when the Israelis withdraw from that sector of Sinat Feb. 22,

Asked if the U.S. expects a simple statement from the PLO about recognizing Israel for the U.S. to alter its position toward that organization, Kissinger replied, a don't know what more we can say until the PLO declares its intention and the manner in which they accept Israel as a fact."

Earlier in the news conference Kissinger reaffirmed the U.S. government's public position that
"We cannot make a deedsion on how to deal" with
the PLO until they accept Israel and UN Resolutions
242 and 338. In this connection, Kissinger noted that
"we agree with the proposition" that a Middle East
-settlement "must include Palestinians and a solution of the Palestinian problem."

"Questioned about reports of a U.S. supply of arms to Egypt, Kissinger reiterated that the matter was discussed in a general way with Sadat during his visit here but no specific agreements were reached. When they are, he said, "We will make a decision," He pointed out that "Congress will have a veto" over it and that the public is being told "exactly what is, taking place,"

#### FOUR TERRORISTS KILLED

TEL AVIV, Nov. 10 (JTA) -- Four Arab terrorists were killed this morning near Metuliah in the

northern part of the Galllee region, in a clash with Israell soldiers. There were no Israell onsualities, Military sources said the terrorists infiltrated Israell territory from Lebanon and had only gotten several hundred yards into Israel when Israell forces spotted them hiding in an apple plantation, The terrorists were killed in an exchange of fire, Dressed in civilian clothes, the terrorists carried Soviet-made rifles, explosives and a large amount of ammunition.

ISRAEL CONCERNED OVER COMBAT
PLANES SOLD TO SAUDI ARABIA BY U.S.
BEING LOANED BY SAUDI TO SYRIA

JERUSALEM, Nov. 10 (JTA)--Reports that Saudi Arabia has "loaned" Syria some of the combat planes sold to it by the United States have been raised by Israel with the U.S. "through diplomatic channels." officials here disclosed today, Although no formal complaint has been submitted, the Israeli Embassy in Washington expressed the government's concern over the matter, the officials said.

There is concern here as well that Saudian military aircraft and their pilots have been stationed in Jordan. They were shown on Jordanian television last night when King Hussein visited the airfield where they are stationed, inspected the planes and chatted with their pilots.

Israel has consistently contended that the sale of warplanes and other weapons by the U.S. and other Western powers to Arab states such as Saudi Arabla that were not direct participants in the Middle East wars, can and do affect the Arab-Israell arms balance because those weapons find their way to the "confrontation states" despite restrictive clauses. In the sales contracts.

Reports in foreign news media that Americanmade Saudian planes have gone to Syria were not officially confirmed here. But the acknowledgment that the issue has been raised with Washington seemed to indicate that the reports are correct. The officials also indicated that the presence of Saudian war planes in Jordan would also be taken up with the U.S. in diplomatic contacts.

#### ZIONIST LEADER WARNS ANTI-ZIONISM COULD PENETRATE GOVERNMENT RANKS

NEW YORK, Nov. 10 (JTA)--Kalman Sultanik, executive vice-president of the World Confederation of United Zionists'and member of the Jewish Agency Executive, warned today that the virus of anti-Semitism spawned by the adoption of the UN. Third Committee equating Zionism with racism would, if uncheoked, spread into the portals of governments of countries with Jewish communities, oreating the likelihood of Jew-harred percolating down to the masses of the population.

He called for a forceful reaction by the Zionist movement \*to reach out to every conscientious Jew to meet head-on the grave threat to the existence of the Jewish people\* by making them aware that under the guise of anti-Zionism the resolution seeks the destruction in a \*package deal\* of both the State of Israel and the Jewish people.

Sultanik spoke at a meeting of the national executive committee of the American Jewish League for Israel, a non-party Zionist group affiliated with the World Confederation, presided over by its president Judge Seymour R. Levine. Another principal speaker was Eleazar Lipsky. The World Confederation of United Zionists is the main coordinating body of non-party Zionist organizations in the diaspora. Its major constituents

in this country are Hadassah, Bnai Zion and the American Jewish League for Israel.

Asserting that the foul attack on Zionism has "brought out from their lairs the very sinister elements that have never relinquished their quest to complete Hitler's objective for the liquidation of the Jewish people," Sultanik warned that the current development is a replay of the events of the 1930's and early 40's which brought entire civilization to the brik of extinction."

He stressed the need for every Jew to proclaim his or her Zionist identification and asserted that "it would be appropriate to recall the example set by the King of Denmark during the Nazi occupation of that country when he publicly wore the yellow badge in solidarity with the Danish Jews who were forced by the Nazis to wear the yellow badge bearing the impents "Jews".

#### PLAN PRO-SOVIET JEWRY ACTIONS

LOS ANGELES, Nov. 10 (JTA)—In response to the current stepped-up harassment, continued repression, drasticully reduced emigration, and denial of human rights to Soviet Jews, an unprecedented assembly of Jewish leaders will convene in San Francisco, Nov. 16-17 at the Hyatt Union Square Hotel, it was announced by Robert M. Shafton, chairman of the Community Relations Committee of the Jewish Federation Council of Greater Los Angeles Commission on Soviet Jewry.

Their goal will be to formulate new plans of action to alleviate the worsening serious situation and to make the American public more aware of the need to bring an end to the harassment of Jews in the Soviet Union. The conference, chaired by California Supreme Court Justice Stanley Mosk, will include distinguished leaders, Soviet Jewish experts and leading American government and public officials, according to Shafton, It will also serve as a prejude to the international Conference on Soviet Jewry, now in the planning stages, which will take place in Brussels in February.

The conference in San Francisco is part of the "Prisoner of Conscience Month" from Nov. 15 to Dec, 15 that was announced in New York by Stanley H, Lowell, chairman of the National Conference on Soviet Jewry. Activities will include campaigns, legal symposiums and marches in communities across the United States focused on the POC plight. Highlighting the month-long activities a nationwide "Women's Plea" will be held in 51 cities on Dec. 10, Human Rights Day. According to latest reports reaching the NCSJ, close to 40 POC's are presently held in Soviet prison camps.

#### 'SHABBAT OF AFFIRMATION'

NEW YORK, Nov. 10 (JTA) -- The Central Conference of American Rabbis has sent a request to its members to stimulate attendance at services Nov. 14-15 which has been proclaimed the "Shabbat of Affirmation" in response to the UN General Assembly draft resolution on Zionism and racism.

The proclamation was issued by the Synagogue Council of America and the Conference of Presidents of Major American Jewish Organizations. The CCAR said the goal was to mass all American Jews into the synagogues all over the country to witness our affirmation that Zionism is not only not racism but is the very opposite, inasmuch as it is an expression of the finest values in Judatsm.

### 5000 IN RALLY CONDEMN ANTI-ZIONIST RESOLUTION; JACKSON WARNS HE WILL

NOT VOTE FOR U.S. AID TO THOSE COUNTRIES WHICH VOTED FOR MEASURE

BOSTON, Nov. 10 (JTA) -- Sen. Henry M. Jackson (D. Wash) declared here yesterday that he would vote against American aid to any country that endorses the Arab-inspired draft resolution equating Zionism with racism which is being debated in the United Nations General Assembly today.

Jackson said that when the Ford Administra tion's foreign aid proposals come before Congress "We will remember those countries" that voted for the anti-Zionist draft in the General Assembly's Third Committee last month, Onehalf of those countries that approved the measure are recpients of American economic assistance and "I will not aid and abet their

racism" with U.S. aid, Jackson said, (The Washington legislator was one of a number of political, civic and religious leaders of all faiths who addressed a "Rally of Reaffirmation" in support of Israel and in opposition to the anti-Zionist resolution which drew more than 5000 persons to Boston Common. The rally was co-sponsored by the New England Zionist Federation, the American Zionist Youth Foundation and the Jewish Community Council of Metropolitan Boston, It was chaired by Bernard Garber, president of the New England Zionist Federation, and coordinated by Daniel Mariashin, the Federation's executive director.

#### Governor, Cardinal Blast Draft

Gov. Michael Dukakis of Massachusetts declared at the rally that the anti-Zionist draft "is a reflection of a world turned upside down. He warned that "If this country doesn't begin to stand for something in international circles, we will be faced with this thing over and over again," Another speaker, Rep. William Cohen (R.Me.) said "This kind of resolution is not consistent with the principles of the UN Charter.
If it should pass, we would have to seriously reevaluate our participation in the UN.

Humberto Cardinal Medeiros of the Boston Archdiocese issued a statement in connection with the rally in which he described the anti-Zionist draft as "not a clear and precise expression of reality," The Cardinal's message said: "I am afraid that if adopted by the General Assembly, this resolution will be used for propaganda which will confuse rather than clarify the tangled knot of problems which mark the Middle East," Cardinal Medeiros was represented at the rally by Magr. Edward Murray.

Other speakers included Edward Redd, executive secretary of the Boston branch of the NAACP, Albert Schlossberg, president of the Jewish Community Council of Metropolitan Boston, and the Consul General of Israel in Boston, Shimshon Inbal,

#### AZF LAUNCHES DRIVE TO EXPLAIN ZIONISM TO THE AMERICAN PUBLIC

NEW YORK, Nov. 10 (JTA) -- Declaring that "Zionism is under attack," Mrs. Faye Schenck, president of the American Zionist Federation, today announced plans for a major offensive to bring the facts about Zionism to the American public, Jews and non-Jews alike, "To attack Zionism ts to besmirch one of the most noblest movements ever created;" Mrs. Schenck said at a press conference at the AZF headquarters. She said Zionism, which is the Jewish national

liberation movement," is "replete with only the most positive ideas and ideals."

Mrs. Schenck called the UN draft resolution which equates Zionism with racism an act of blasphemy and treachery." She said the attack on Zionism which is also an attack on Judaism, Jews and Israel, will result in the strengthening of Zionism and the weakening of the UN as she said already has happened to UNESCO, But she expressed the hope the General Assembly would reject the resolution.

The AZF will try to reach as large an audience as possible through the new information program, Mrs. Schenck said. Special emphasis will be given to educational and information programs in the smaller communities throughout the U.S. Plans include audiovisual programs, seminars, press briefings, movies, radio programs, advertising campaigns in newspapers and basic literature about Zionism and its philosophy. She atressed that the information campaign will go beyond the immediate emergency situation.

KAHANE PRAISES HERZOG NEW YORK, Nov. 10 (JTA) -- Rabbi Meir Kahane, the leader of the Jewish Defense League, asserted today that the Conference of Presidents of Major American Jewish Organizations would not be holding their rally tomorrow against the anti-Zionist resolution if Chaim Herzog, Israel's Ambassador to the United Nations, had not criticized the American Jewish leadership.

Kahane praised Herzog for being one of the first "respectable" Jewish leaders to say what the JDL leader has long charged—that the established Jewish leaders are not meeting the needs of the American Jewish community. Herzog who said that American Jews had not responded adequately to the anti-Zionist resolution later said that his remarks were not aimed at the Jewish leaders but the Jewish man-on-thestreet.

Kahane said JDL members will be at tomorrow's rally and pass out the petitions for the Democracy in Jewish Life movement which calls for the direct election of Jewish leaders. Kahane said the JDL will sponsor a rally at the UN Plaza the night of Nov. 15. He said following the rally the group will go to Herzog's house to thank him for his remarks and then to the Egyptian UN Mission for an cold time JDL demonstration."

#### ISRAELI INFORMATION CRITICIZED

LONDON, Nov. 10 (JTA) -- Israel's information services in London pame under fire yesterday from participants in a House of Commons press conference sponsored by the Zignist Federation. The press conference was called to condemn the anti-Zionist motion at the United Nations General Assembly.

Baroness Caitskell, widow of the late Hugh Gaitskell, the former leader of the British Labor Party, noted the highly professional manner in which Arab propaganda was conducted and termed Israelis as "bone stupid" when it comes to explaining themselves. "Why don't they get professionals?" she asked. She said that the current anti-Zionist drive was motivated by old-fashioned anti-Semitism, especially in the Soviet Union.

Mrs. Winifred Ewing, an MP, stressed that her Scottish Nationalist Party was pro-Israel, declaring "I have been called a racist myself." She deplored that Israel was allowing herself to be defeated in the information war, protesting; do not get any information was allowed to be defeated in the tion that I request from the Israel Embassy in London."

The anti-Zionist measure was attacked by Philip-Goodhart, MP, chairman of the Conservative Party defense committee, and Tom Dale, assistant to Liberal leader Jeremy Thorpe.
