PREDICT LONG IMPASSE IN NEGOTIATIONS WITH SYRIA EVEN IF DAMASCUS AGREES TO UNDOF EXTENSION BY DAVId Landau

JERUSALEM, Nov. 18 (JTA)—Top level government sources predict a prolonged impasse in negotiations with Syria even if Damasous agrees at the last minute—as is expected here—to renew the mandate of the United Nations Disengagement Observers Force (UNDOF) which expires Nov. 30,

The sources saw little hope for the negotiation of a second interim accord with Syris since largel could "offer only cosmetic" border change within the context of an interim agreement and even in the context of a final peace settlement, would never agree to a total withdrawal from the Golan Heights. Since Syria rejects both positions, there appears to be no practical value at this time for either interim negotiations or negotiations for an overall peace package, the sources

They acknowledged that the United States does not accept israel's reading of the situation and is vigorously pressing for interim negotiations on the Golan once the UNDOF mandate is renewed, Secretary of State Henry A, Kissinger has made the American position clear on more than one occasion and Washington has been pressing Premier Yitzhak Rabin to make an early visition the U.S. to explore possibilities for Golan talks. Rabin has eschewed the invitation and is not expected to go to Washington before the latter half of January at the surliest.

U.S. Committed To Israel

The government sources atressed, however, that the U.S. was committed in writing to continue its support of Israel even if no agreement can be reached on the Golan Heights. The source said the commitment was part of the American package offered Israel in return for last September's Sinal accord with Egypt-even though it does not appear among the documents "leaked" and later officially confirmed in Washington during recent Congressional hearings on the Sinal pact.

Thus, Israell sources believe the U.S. will not undertake another "reassessment" of its Middle East policy even if it is disappointed by a Golan failure. American commitments to Israel will remain firm at least until after the 1976 Presidential elections, which means that Israel is in effect assured of U.S. support for its present political positions for another 15 months, the sources said.

The sources did not discount the outbreak of another Mideast war in that period, a risk that obviously falls on Israel, But from the political-strategic viewpoint, Israel would find itself in a comfortable situation if war were to break out, the sources said. They maintained that this was one of the benefits of the Sinai accord with Egypt out of which Israel expects to receive substantial military and economic aid from the U.S.

Israeli optimism that Syria will agree to renew the UNDOF mandate was bolstered by reports that UN Secretary General Kurt Waldheim is "hopeful" that his present mission for that # purpose will succeed. Waldheim will go to Damasous this week for a meeting with President Hafez-Assad, He will visit other Mideast states and is expected in Israel Sunday. There were also reports today that the Soviet Union is trying to persuade Syria to renew the UNDOF mandate.

WALDHEIM GOING TO THE MIDEAST By Yitzhak Rabi

UNITED NATIONS, Nov. 18 (JTA)—Secretary General Kurt Waldheim, who leaves Thursday for the Middle East, will visit Syria, Israel, Lebanon, Jordan and Egypt, it was announced here today. Waldheim will meet with the heads of state and will discuss with them the Middle East situation. He is expected to try to convince Syria and Israel to extend the mandate of the UN Observer Disengagement Force, which expires Nov. 30.

During his six-day stay in the Middle East, Waldheim will also confer with the chief coordinator and the commanders of the UN-forces in the Middle East. Waldheim will be accompanied by Roberto Guyer, Under-Secretary General for Special Political Affairs, and three other assistants.

Sources here said that Waldheim will meet with PLO leader Yasir Arafat while in Damasous. But a UN spokesman said that full details of Waldheim's Mideast trip had not been completed and he could not yet say whether the Scoretary General would be meeting PLO representatives. In preparation for his trip, Waldheim conferred today with the Syrian and Lebanese ambassadors to the UN and also met late this afternoon with Secretary of State Henry A. Kissinger.

According to reports, the Soviet Union prefers that Waldheim, rather than Kissinger, should undertake the effort to work out an according between Systa and Israel. The Security Council is tentatively due to meet Nov. 28 to consider the extension of the UNDOF mandate on the Golan Heights.

STATE DEPARTMENT AFFIRMS ITS SUPPORT OF SAUNDERS' STATEMENT ON THE PLO By Joseph Polakoff.

WASHINGTON, Nov. 18 (JTA) - The State Department affirmed that it "stands on "testimony given by Deputy Assistant Secretary of State Harold Saunders to a subcommittee of the House International Relations-Committee last week which is viewed in Israel circles as indicating a possible shift of U.S. policy toward the Palestine Liberation Organization.

Department spokesman Robert Funseth told reporters yesterday that Saunders' statement "represented only a re-statement" of U.S. policy and is not a change of position. He said he could not understand why the Israelis were disturbed by it. (Bre separate stories from Israel on Saunders' statement.)

The Israeli Cabinet issued a statement at its weekly session Sunday saying that a transcript of Saunders' remarks was replete with "errorgendaming-representations" and that Israel's "reservations and qualifications" would be brought "in full" to the attention-of the U.S. government.

Saunders Indicates Co-existence Possible

According to the transcript made available here, Saunders, who is Second Deputy Assistant Secretary for Middle Eastern Affairs, told the International Relations Committee's subcommittee on investigations

that "there are some indications that co-existence between separate Palestinian and Israeli states might be considered" by the PLO.

Saudiers also said that "a particularly diffioult aspect of the problem is the question of who negotiates for the Palestinians. It has been our belief that Jordan would be a logical negotiator for the Palestinian-reliated issue" but "the Rabat (Arab) Summit, however, recognized the Palestine Liberation Organization as the 'sole legitimate representative of the Palestinian people."

Israel's view is understood to be that despite the Rabat decision, the U.S. position has not veered from having Jordan negotiate for the Palestinians. But Saunders' use of the past tense—when he said "it has been our belief that Jordan would be the logical negotiator"—und his reminder to the Congressmen of the Rabat decision—apparently indicated to the Israelis that the U.S. no longer considers Jordan in that role,

Saunders concluded his prepared statement by saying that "We are prepared to consider any reasonable proposal from any quarter and we will expect other parties to the negotiations to be equally open-minded," That was viewed in some quarters here and in Isrnel as a public call on Jerusalem to back off from its opposition to the PLO.

Saunders' remark-that "co-existence" might be considered by the PLO was also regarded as contrary to the facts. The PLO has never spoken of co-existence but has insisted on the establishment of a "socular democratic state" embracing all of Palestine, including that part which is now the State of Israel.

SAUNDERS' STATEMENT NOT SEEN AS DEPARTURE FROM U.S. POLICY By David Landau

JERUSALEM, Nov. 18 (JTA) -- High government sources-conceded today that the so-called "Saunders papers" did not represent any real departure by the U.S. from its established policy loward the Palestine Liberation Organization, The sources were referring to testimony last week by Second Deputy Assistant Secretary of State for Middle Eastern Affairs Harold Saunders

A transcript of Saunders' testimony, discussed at Sunday's Cabinet meeting, brought an angry-response from the Cabinet which issued an unusual communique charging that it contained "errors and misrepresentations," But the government sources said today that the U.S. has been saying for some time that it would favor negotiations with the PLO if the latter-met the stipulated conditions, Israel, for its part; has ruled out any contacts with the PLO under any conditions.

The sources would not formulate a position based on the "hypothetical question" of whether israel would negotiate with the PLO if it accepted Israel's sovereignty and the UN resolutions. They admitted, however, that Israel was completely isolated in its position but there was no need now for an "agonizing reappraisal" by the government.

sraeli Press, Public Termed 'Hysterical'

The sources described as "hysterical" the eaction of the Israeli press and public to the lisclosure of Saunders' remarks. They said the visest course would be to allow the furore to ubside. They said the U.S. itself had no desire of owell on the Palestinan issue at this time and hile the timing of Saunders' testimony was un-

fortunate, it was dictated by the House subcommittee's timetable and not by any intention of the Administrution to prepare American opinion for a shift in the U.S. position on the PLO, as charged by some circles in Israel,

The sources did not explain, however, why the Cabinet issued its sharp attack on the Saunders' testimony Sunday if the government's desire was to let the matter blow over. Some officials believe the answer to that question may be domestic political pressures,

CONSERVATIVE MOVEMENT IN JUDAISM MOVES TOWARD AFFILIATION WITH WZO

MAMESHA LAKE, N.Y., Nov. 18 (JTA)--The Conservative movement in Judalsm moved today toward formal affiliation with the World Zionist Organization as a repudiation of the UN resolution equating Zionism with racism," it was disclosed higher at the biennial convention of the United Synagogue of America, the congregational arm of Conservative-Judaism representing more than 1.5 million Jews in 830 affiliated synagogues in the United States and Canada;"

States and Canada;

Declaring that "Zionism is Judafam and Judafam is Zionism," Arthur J. Levine, president of the United Syangogue of America; said that affiliation would be effected through the World Council of Synagogues, the international organization of Conservative congregations which has its headquarters in Jerusalem. The Council's president, Samuel Rothstein, disclosed that its board of directors has held a policy meeting here on affiliation with the WZO and will take final action in December.

Affiliation Move Explained

Rabbi Bernard Segal, executive vice-president of the United Synagogue of America, who disclosed the plans, explained why the Conservative movement had refrained from formal affiliation with the WZO since it was founded 60 years ago and why it was taking the step at this time.

Rabbi Segal said that since its inception in 1913, Conservative Judaism has been "unequivocally committed to Zionism and there has never been any room in its ranks for anti-Zionism, As a result." he said, we have over the years, repeatedly declined to seek formal affiliation with the WZO as a way of demonstrating that Zionism is an integral part of Judaism and thus affiliation was not necessary," He continued, "The time has therefore arrived for the Conservative movement to identify itself formally with the WZO and thus reaffirm the indivisibility of the land of Israel and Judaism." A committee has been formed to negotiate affiliation with WZO officials, It consists of Dr. Gershon D. Cohen, Chancellor of the Jewish Theological Seminary of America; Levine; Rabbi Mordecal Waxman, president of the Rabbinical Assembly, the rabbinical branch of Conservative Judaism; and Rothstein, Others who will participate are Mrs. M. KAHANE DENIES CHARGES THAT HE AND JDL'S PRESENCE IN BORO PARK IS HEATING UP JEWISH-HISPANIC TENSIONS By David Friedman

Ms, Norton made her charge in a letter to Federal Judge Jack B. Weinstein, who had sentenced Kahane to serve a year in prison at a Mahattan federal detention center. She suit! This Kachane abused the privileges Weinstein gave him in allowing him to leave the detention center three times a day for meals and prayers. Last week Weinstein ordered that Kahane he accompanied by deputy federal marshalls during his trips outside.

The JDL lender said today that Ms, Norton should be told that human rights includes first the right to live in peace which he said is even more important than the right to go to school.

Kahane said that criminals prey on Jewish areas because Jews have been "putsies" for 2000 years and have not fought back, He, said criminals do not go into an area such as Brooklyn's Bay Ridge section because it has in heavy Italian and Slovak population and criminals know these people will protect themselves, For this reason, Kahane said, every Jew should purchase a legal rifle or shotgun, He also urged Jewish activists to join a civilian crime patrol that is being organized in Borough Park,

STATE DEP'T, SAYS SAUDIA MAY USE U.S. ARMS IN REGIONAL MILITARY OPERATIONS WITHOUT VIOLATING ANY U.S. LAWS By Joseph Polakoff

WASHINGTON, Nov. 18 JTA) -- The State Department acknowledged today that Saudi Arabia may use the vast quantities of military equipment it has purchased in the United States in regional military operations without violating the terms of the U.S. Military Sales Act.

Department spokesman Robert Funseth said, in reply to a question by the Jewish Telegraphic Agency, that the military "exercises" just conducted by a Saudian brigade in Syria which employed American F-5 jets based at a Jordanian airfield, was proper under the terms of the Act and of the Saudian-American mutual defense agreement signed 24 years ago.

Punseth said that under the Military Sales. Act, the recipient of American equipment can use it for internal security, "legitimate selfdefense" and to "participate in regional or collective arrangements or measures consistent with the United Nations Charter."

Asked whether American equipment supplied the Saudian brigade in Syrian was used by the Saudian brigade in Syrian forces as well, Funscin said he understood that the maneuvers have been completed and that about 15 F-5 jets in Saudianhands were used in "the annual training cycletof the brigade which has been stationed in Syria since the Yom Kippur War,

No Confirmation Of Soviet MIGS

Funseth said the aircraft were staged "through" Jordan with planes landing and taking off in Jordan. He did not know what airfield it Jordan was used and said largel was not advised of the use of U.S. planes by the Saudis in Syria.

He added. "To the best of our knowledge, the maneuver was entirely Saudi" and did not constitute a violation of the end use of the restriction imposed by U.S. law under the Military Sales Act." Jordan and Syria have established a unified command, and the use of a Jordanian base for Saudian planes maneuvering in Syria was viewed by observers here as a form of psychological warfare against Israel by the combined Saudian-Syrian-Jordanian forces."

Funseth said he had no confirmation of reports attributed to U.S. intelligence sources that he Soviet Union has sent a squadron of advanced MIG-25 jets to Syrin, He said, however, that it is "well-known Syria has received sophisticated equipment" from the Soviet Union, According to the report, the MIG-25 squadron is piloted by Russians,

CALIFORNIAN JOB PLAN TO BE PROBED

WASHINGTON, Nov. 18 (ITA)--Rep, John Heinz III (R.Pa.) cailed on Attorney General Charles Levi today for an opinion on the constitutionality of a California plan that would abet Suudi Arabian discrimination against Jews and others, Heinz told Congress yesterday that California has been put in the position of literally ignoring and possibly violating our own cityl rights laws to accede to the divisionary whims of a country that only recently had clothed itself in moralistic robes and led the fight to declare Zionism racist,

The Pennsylvania legislator was referring to a project announced by the California State Department of Transportation to help unemployed members of that department get jobs building roads in Saudi Arabia. The state officials reportedly said that such jobs would not be open to Jews, Blacks or women because they are unacceptable to the Saudi government.

Gov. Edition Brown, Jr. of California, who assatled the plan, has meanwhile ordered a halt to job negotiations with the Saudians until they promise no discrimination against Jews, Blacks or women, A spokesman for the State Transportation Department said today it was complying with the Governor's orders. He said a cable would be sent to Saudi Arabia demanding "affirmative assurance" that there will be no discrimination in hiring highway engineers and technicians, The California state agency is faced with the prospect of laying off 2800 employes by next July because of a cutback in highway construction.

Heinz said that if the Justice Department does not see the California plan as wiolating any Civil Rights Act provisions, he would offer legislation that would make such actions illegal. We must not allow the hypocrisy of other nations to soil our own hard-won civil rights gains," Heinz told Congress.

BEHIND THE HEADLINES JEWISH VIOLENCE IN-ISRAEL By GII Sedan

JERUSALEM, Nov. 18 (JTA) -- Two incidents that occurred this month reminded Israelis that Jewish violence can be just as destructive as violence by Arab terrorists, in one incident an explosive charge went off in front of the apartment of a workers committee chairman in Hadera in the other, a charge exploded at the door of Knesset member Eltan Livni's apartment. In the first case, six children were slightly injured; in the second no one was hurt,

Violence as such is not new to Israel. The times when a Jewish thisf was unheard of in the streets of Tel Aviv have long gone, During the past half year there were several cases of protection-extortion rackets, One of them, in Netanya, ended with the killing of five persons in a discotheque, A newspaper expose several years ago charged that an American-style "Mafia" was operating in Tel Aviv, Haifa and Eliat, Former Attorney-General, Meir Shamgar, investigated the charges but concluded there was no evidence to support this contention.

But nobody doubts the existence of underworld networks involved in "classical" criminal activities such as drug smuggling and distribution, the recent incidents differed from past violence in the use of explosives against targets in the political sphere or in the delicate arena of labor relations.

In the case of the explosion at Livni's home, police reportedly suspect a professional job to speed up payments of debts by the Herut movement to unknown craditors, in the case of the explosives in Hadera, the orime was committed in the wake of a two-week strike at the "Alliance" tire factory which was partly broken by scabs.

Significance of The Events

The difficult question is what significance these events have: Are they just random or do they reflect a rise in "sophisticated" violence? Statistics give no answer, Tel Aviv, which is certainly israel's crime capital, witnessed a drop of 2.2 percent in the crime rate during the first six months of this year, However, in the last three months there has been a rise, which may seem marginal compared to New York but its slarming in Tel Aviv.

Four cases of robbery were reported in the greater Tel Aviv area in August, five in September, and eight in October, Attempted robberies were committed 12 times during the first 10 months of this year, three in October alone, Thirteen purses were snatched during September; in October the number rose to 23, The number of reported burglaries rose from \$10 in September to 910 in October,

Unlike in the U.S., guns are not sold freely in Israel, One must obtain a license, a bureaucratio procedure which can last several weeks. But the Interior Ministry, which is in charge of gun licensing, relaxed its regulations since the tragic terrorist raids of last year, Self-defense is a good reason for obtaining a gun because as far as the terrorists are concerned all of Israel is a front.

It has become more difficult to prevent gins from falling into the wrong hands. However, the main sources of oriminal arms are the army's arsenals. Some soldiers steal and sell guns, ammunition and explosives: In other cases, army arsenals have been robbed, The Civil Guard in every neighborhood has guns and there have been several cases of break-ins at Civil Guard offices:

Still Safer on Israeli Streets

The expiration of the UN mandate on the Golan Heights Nov. 30 is increasing tensions along the Syrian border. However, israel generally is believed to be in a period of decreasing military tension. In the past, the orime rate went up whenever the borders were calm, and this is what is probably happening now. The police suffer from an acute shortage of manpower which makes criminals' lives easier. However, senior police officers do not believe that israel is facing a crime wave.

It is more the quality of life in the Israeli streets—quiet movie houses, safe alleys, clean public places—that they worry about, Israeli streets are still a safe haven compared to streets in New York or other big cities. There is hardly a place in Israel where a woman cannot walk safety late at hight, Jewish crime is increasing but it is a long way from the orime rate in the major cities abroad,

ZOA CLARIFIES ITS MISTAKEN REPORT ON KLUTZNICK'S STATEMENT TO PARLEY

NEW YORK, Nov. 18 (JTA) -- The Zionist Organization of America clarified a previous report in which the ZOA oreated the erroneous impression that Philip M. Klutznick, chairman of the Governing Board of the World Jowish Congress, addressed the concluding session of the recent 78th ZOA national convention in Chicago, The convention took place Oct. 2-5. The ZOA clarification was in connection with remarks attributed to Klutznick concerning the Conference of Presidents of Major American Jewish-Organizations,

Actually, the ZOA statement of clarification said Klutznick was not even present at the concluding session Oct, 5, at which time he was already in Israel, He addressed the convention on Oct, 3, when he and Jacques Torozyner, a past president of the ZOA, participated in a symposium on the subject, "Should American Jows Intervene In Israeli Affairs?"

Furthermore, the ZOA statement of clarification continued, Klutznick was misquoted in remarks he made in the course of the symposiumregarding the Conference of Presidents, While he did mention that "it was not good for Israel to have a benign Jewish community in the United States," and while he advocated a more independent stance of American Jewry on, issues concerning Israel, he did not/suggest in any way that the Conference of Presidents should be disbanded or replaced, -

JEWISH SUMMIT POSTPONED FOR ONE WEEK

JERUSALEM, Nov. 18 (JTA).—The summit of Jewish leaders to plan a pro-Zionist worldwide campaign, will now he held Dec. 3-5, not Nov. 27-29 as earlier intended. The Jewish Telegraphic Agency learned of the week's postponement today. The December date is final, according to Jewish Agency sources.

The number of Jewish leaders to be invited has also been changed—from the original 100 to 120, They will convene together with the entire Israell. Cabinet, and members of the World Zienist Organization Executive, and also the heads of the Zionist opposition parties in Israel, The summit conference will plan ways to combat the anti-Jewish, anti-Zienist attack launched in the UN General Assembly by the resolution equating Zionism with randam.
