PERES: BOMBINGS FOLLOWED INTELLIGENCE INFORMATION THAT TERRORISTS WERE PLANNING SABOTAGE, MURDER MISSIONS By Yitzhak Shargil

TEL AVIV, Dec. 3 (JTA)--Defense Minister Shimon Peres said today that Israel's air strikes against terrorist strongholds in northern and southern Lebanon yesterday were a preventive action undertaken on the basis of accurate intelligence that murder and sabotage missions against Israel were being planned at those bases.

A military communique claimed that Israeli bombers scored direct hits on the headquarters of the Syrian-sponsored Al Saika terrorist organization near Nabatiyeh in southern Lebanon killing a number of terrorists and demolishing the headquarters. Another direct hit was scored on a parking lot where a large number of vehicles belonging to terrorist organizations were destroyed or damaged, the communique said.

The air attack near Tripoli in northern Lebanon was aimed against headquarters of George Habash's Popular Front for the Liberation of Palestine and other terrorist organizations located there, Israel said. While acknowledging that a schoolhouse was demolished at Nabatiyeh, Israel claimed the building was no longer used as such but served as Al Saika headquarters.

Israel's communiques today were apparently in response to Lebanese claims that the air attacks killed up to 100 civilians in Palestinian refugee camps and wounded a similar number. Israel insisted that the action was not ordered in retaliation for the recent murder of three Israeli students by terrorist infiltrators at the Golan Heights settlement of Ramat Maghshimim or to mollify public opinion at home in view of the recent series of anti-Zionist and pro-Palestinian resolutions in the UN.

STATE DEP'T. APPEARS TO ACCEPT ISRAEL'S EXPLANATION OF RAIDS...

WASHINGTON, Dec. 3 (JTA)--State Department sources appeared today to accept Israel's contention that yesterday's air raids on sites in northern and southern Lebanon were aimed at installations from where it is well-known that terrorist groups launch attacks against Israel. The sources noted two recent terrorist attacks--the murder of three Israeli students at Ramat Maghshimim on the Golan Heights and the Zion Square bombing in Jerusalem last month which took seven lives.

The Department sources' agreement with Israel in effect that the air strikes were preventive measures aimed at thwarting terrorist assaults against Israel was expressed as Lebanese authorities claimed that the Israeli raids struck refugee camps killing and wounding large numbers of civilians. Lebanon has requested a meeting of the Security Council over the attacks.

Observers here believe that the State Department is seeking to appease Israeli anger at the U.S. over its support of Sunday night's Security Council resolution which opened the way for participation by the Palestine Liberation Organization in a Middle East debate next month.

Department spokesman John Trautner said to-

day "We are in the process of getting all the facts (about the air strikes) and we are in touch with both sides and will explain further our views in the forthcoming discussions in the Security Council." He added: "We have repeatedly deplored the cycle of violence and counter-violence in the Middle East which takes innocent victims of both sides and creates elements of bitterness not conducive to the ongoing search for peace."

...McGOVERN DENOUNCES ISRAELI RAIDS AS 'SAVAGE BOMBING ATTACKS'

WASHINGTON, Dec. 3 (JTA)--Sen. George McGovern (D,SD) today described the Israeli air raids on "Palestinian camps" in Lebanon yesterday as "savage bombing attacks by Israeli pilots flying American planes...." The Senator, who is chairman of the Senate Foreign Relations Committee's subcommittee on the Near East, declared that "neither Lebanon nor the Palestinian camps within its borders need any more punishing air raids from Israel or anywhere else. Yet these attacks over the years destroyed large numbers of innocent people, especially in southern Lebanon."

McGovern recalled that he has previously deplored terrorist attacks against civilians in Israel. However, he did not mention in his statement in the Senate today, the recent murder of three Israeli students by Arab terrorists at Ramat Maghshimim on the Golan Heights or last month's terrorist bombing in downtown Jerusalem that claimed seven lives. There is no record of his having spoken out against those terrorist assaults at the time they occurred.

McGovern characterized Israel's air raids on Lebanon yesterday as "a temper tantrum designed to punish the Palestinians because they were invited by the UN Security Council to participate in the UN debate (on the Middle East) next January."

McGovern, who was the 1972 Democratic Presidential nominee, added that "If peace is to come" in the Middle East "the Palestinians and Israelis must each accept the other's independent existence. Such acceptance will not come either through Palestinian terrorism or Israeli terrorism. It will come only at the conference table." He observed that the lessons of needless killings in Vietnam must be applied to the Mideast. (By Joseph Polakoff)

DULZIN AT JEWISH SUMMIT CONFERENCE URGES TOTAL MOBILIZATION, ACTION

JERUSALEM, Dec. 3 (JTA)--"Without greatly increased aliya there can be no security for Israel, no future, no Israel." This warning was issued by acting World Zionist Organization chairman Leon Dulzin in remarks prepared for tonight's opening session of the World Jewish "summit," attended by 170 Jewish leaders from overseas joined by scores of prominent Israelis--ministers, Jewish Agency Executive members, Knesseters, trade unionists and industrialists--in the Knesset's Chagal Hall. The two-and-a-half-day conference was called on short notice to plan world Jewish action following the anti-Zionist resolution adopted by the United Nations General Assembly.

Dulzin said "two issues stand out above all others--immigration and identification." Today

DRAFT RESOLUTION BY 19 THIRD WORLD

COUNTRIES CALLS FOR SANCTIONS

AGAINST ISRAEL, RETURN OF TERRITORY

UNITED NATIONS, Dec. 3 (JTA)--The Jewish Telegraphic Agency obtained today a copy of the draft resolution sponsored by 19 Third World countries due to be introduced into the General Assembly debate on the Middle East, probably tomorrow, which requests all states "to desist from supplying Israel with any military or economic aid as long as it continues to occupy Arab territories and denies the inalienable national rights of the Palestinian people."

The draft also requests the Security Council "to take all necessary measures for the speedy implementation, according to an appropriate timetable of all relevant resolutions of the General Assembly and the Security Council aiming at the establishment of a just and lasting peace in the region through a comprehensive settlement worked out with the participation of all parties concerned, including the Palestine Liberation Organization...."

The draft resolution also calls for the condemnation of Israel for its occupation of Arab territories and calls for reaffirmation that the acquisition of territory by force is inadmissible and must be returned.

The last part of the draft resolution requests the Secretary General to inform "all concerned, including the co-chairmen of the peace convention on the Middle East and to follow up the implementation of the present resolution and report thereon to the Security Council and to the General Assembly at its 31st session," in the fall of 1976.

Moynihan Warns Of Difficult Time

Meanwhile, Lebanon and Egypt today called for

an urgent Security Council meeting to deal with Israel's air strike yesterday at Lebanese territory. Egypt also requested that the Palestine Liberation Organization take part in the debate. The Council was expected to meet either tonight or tomorrow.

Earlier in the day, Daniel P. Moynihan, the U.S. Ambassador to the UN, said that informal consultations between Security Council members were underway on the request for a Council meeting. Addressing 75 leading members of the book publishing industry at a luncheon on behalf of the United Jewish Appeal-Federation of Jewish Philanthropies Joint Campaign in New York, Moynihan said that "a very difficult time" is ahead because the odds are in favor of the PLO being allowed to attend the Council session on Egypt's request.

"Today, we meet in a crisis atmosphere," he said, in referring to the consultations at the UN. American sources told the Jewish Telegraphic Agency that the U.S. will oppose a PLO presence at the Council meeting.

Moynihan also told the luncheon meeting that the resolution equating Zionism with racism adopted by the UN was possible because of "the distortion of language" and the decline in the meaning of language in the UN. The word "racism," he said, does not appear in the UN Declaration and Convention on Human Rights. Racism, he stated, is a doctrine, while racial discrimination is a practice.

The envoy pointed out that Zionism might be "a terrible thing," but it definitely is not racism. Whatever the practice of Israel, it is not racism by definition, he added. The meaning of the resolution is that any time racism is deplored, Israel will be deplored, Moynihan said. He added that "every time someone will call to wipe out racism" the demand will be wipe out Israel.

AFL-CIO BACKS ISRAEL

WASHINGTON, Dec. 3 (JTA)--AFL-CIO Secretary-Treasurer Lane Kirkland, addressing more than 400 trade unionists and their guests as "fellow Zionists," declared last night that no American aid should go to countries that abstained from voting on the United Nations General Assembly's anti-Zionist resolution "until they decide which side they are on."

"The AFL-CIO has taken its stand," Kirkland said. "We stand with Histadrut, Israel, democracy and freedom in the Middle East and we shall abide as long as it takes to prevail." Kirkland's remarks were given a standing ovation by AFL-CIO President George Meany and a dozen labor organization leaders attending a dinner at the Washington Hilton Hotel where Kirkland received the humanitarian award from Uzi Bloch, Histadrut representative to the U.S. and Canada.

Israeli Ambassador Simcha Dinitz, referring to the General Assembly's anti-Zionist resolution, said Jews, Zionism and Israel "do not need to draw credentials from the United Nations or any other body," because their credentials are from the Bible and the persecutions the Jewish people have endured through the centuries. "No group of Communist or autocratic states can sit in judgment on Israel," he said. "Their only common denominator is that they practice racism in one form or another." * * *

there were some three million Jews in Israel, he said: "Our goal must be to ensure, by the end of the century, a population of seven to eight million....It is a task which is not a concern only of Israel. It demands total responsibility by the entire Jewish people."

"The second issue is identification," Dulzin declared. "By identification I mean an understanding of what you are identified with. Let me remind you that only 20 percent of Jewish children get Jewish education, and that only eight percent get a full Jewish education. This situation is evidence of a most dangerous threat to Jewish survival....What is at stake is the Jewish spirit, the will to survive as Jews...."

Israel, said Dulzin, was not founded by the UN at Lake Success. It was the culmination of "an inevitable and persistent logic in Jewish thinking" over "the millennia of dispersion," he stressed. "The Mideast is full of archaeological reminders of the countries and empires that controlled the minds and hearts of ancient peoples....One people and only one people in this region continues to practice the same religion, to recite the same prayers, to speak the same language, to till the same soil....We, we are that people. This is the victory of the human spirit. This is Zionist fulfillment."

Urges Agonizing Reappraisal

Dulzin urged a "heshbon hanefesh" by Jewry, "an agonizing reappraisal of all structures, strategies and approaches. We in Israel need the advice and help of our colleagues from the diaspora in adapting our instruments of work to the new situation with which we are confronted. At the same time we want to be of help to you in developing new approaches and programs that will reflect the realities and potentials of your home communities."

The 170 Jewish leaders were urged by Dulzin to utilize their "magnificent talents" to work "in a great cooperative effort" to combat the effects of the General Assembly anti-Zionist resolution. The basic answer to this resolution, he asserted, "is in what we are and what we do as Jews in Israel and in our Jewish communities in the diaspora. The basic answer is the kind of society we build in Israel...." Dulzin added that the summit would not be just another meeting with very little "tachliss," but would "map out concrete methods of strengthening Jewish identity."

HERZOG SAYS HIS STATEMENT IN THE GENERAL ASSEMBLY DID NOT REPRESENT A SHIFT IN POLICY REGARDING THE PLO By Yitzhak Rabi

UNITED NATIONS, Dec. 3 (JTA)--Israel's Ambassador to the United Nations Chaim Herzog emphatically denied to the Jewish Telegraphic Agency today, that his statement yesterday at the General Assembly implied a change in Israel's policy towards the Palestine Liberation Organization (PLO). "My statement did not imply in any way any change in policy on the part of Israel toward the PLO," Herzog said. He repeated the words "not at all" and "no way" to emphasize that there was no Israeli shift regarding the PLO.

In Jerusalem, the Foreign Ministry insisted today that there was no change in Israel's position not to have any dealings whatsoever with the Palestine Liberation Organization. The Ministry reiterated the official policy line of the government and the Knesset in face of speculation here and at the UN that a modification of Israel's attitude

toward negotiations with the Palestinians was hinted in Herzog's speech.

Herzog's speech at the General Assembly yesterday was both tough and conciliatory. While offering unconditional negotiations, he declared; "We will not be a party to any attempt to dictate to us." He suggested that it would be "wiser" and "logical" for the Assembly to ask the PLO if it accepts the Security Council resolutions as the basis for negotiations and if it was prepared to renounce its declared policy of calling for the destruction of a UN member state. He also stated that Israel was prepared to negotiate "at any moment without any preconditions whatsoever" with its Arab neighbors.

The government's prompt move to quash any interpretation that this might include negotiations with Palestinians who recognized Israel and renounced terrorism was seen by observers here as the opening shot in an emerging struggle within Premier Yitzhak Rabin's Cabinet over basic policy toward the Palestinians. The Foreign Ministry's reaction was reportedly ordered by Rabin himself who is acting Foreign Minister while Yigal Allon is in London.

Herzog told the JTA that his speech yesterday made it clear "that the negotiating process in the Mideast falls within the broad framework of Security Council Resolutions 242 and 338." He explained that he also took up the question of "how governments who recognize Israel's sovereign rights can reconcile this fact with the recognition of an organization which denies these sovereign rights."

He added: "I posed this question to countries who urge Israel to negotiate with the PLO, with the purpose of pointing out that their policy is irreconcilable with their support of Israel's rights....I suggested to these countries to ask the PLO if their statements against Israel reflect their policy, before they (the countries) criticize Israel."

The result, Herzog said, "was that the PLO did not want these countries to ask questions but announced formally (in the General Assembly last night) that Resolution 242 is outdated."

The Israeli envoy was referring to an address by Basel Amin Aqi, head of the PLO delegation to the current Assembly session, in which he said that the ultimate aim of the Palestinian movement "lies in a non-sectarian Palestine without ethnic or religious discrimination." This was seen to imply an elimination of the State of Israel.

GERIATRIC CENTER SERVING MAINLY HANDICAPPED JEWS CAN NOW CONTINUE OPERATING AFTER ALL PLEDGES TO GIVE BETWEEN \$100,000-\$150,000 By Ben Gallob

NEW YORK, Dec. 3 (JTA)--An official of Self-Help Community Services said today that the organization expects an initial payment of \$50,000 next week from heavyweight champion Muhammad Ali on his promise to give between \$100,000 and \$150,000 to enable a geriatric center serving mainly handicapped Jews in the Washington Heights section of Manhattan to continue to operate for another year.

Prior to the champion's promise of the gift, the Hillside Aged Program Center had been scheduled to shut down on Dec. 31 because funds of the sponsoring agency had run out. Self-Help, a non-sectarian agency originally chartered to aid victims of Nazi persecution, still gets some reparations funds from the West German government.

MORTON DISCLOSES THAT THE COMMERCE DEPT. HAS FINED 4 U.S. FIRMS \$1000 EACH FOR FAILING TO REPORT DEMANDS BY ARABS FOR BOYCOTT COMPLIANCE

WASHINGTON, Dec. 3 (JTA)--Secretary of Commerce Rogers C.B. Morton disclosed yesterday that the Department of Commerce has fined four American companies \$1000 each for failing to report to the Department demands by Arab countries to comply with their boycott against Israel. Morton, in a letter to Rep. Harley Staggers (D. W. Va.), chairman of the House Commerce Committee, revealed the names of the companies fined. They are Agip U.S.A. Inc.; Inter-Equipment Co.; and the National Cash Register Co., all of New York and Continental Emsco Co. of Houston.

Morton's letter was his second overture in less than a week to Congress where he faces contempt charges for having refused to divulge information on the Arab boycott and American firms responding to it. His action followed measures taken by President Ford two weeks ago to tighten federal regulations dealing with discriminatory tactics by American companies against other American companies with respect to the Arab boycott.

Until now, the Administration has refused the demand by the House Commerce Subcommittee on Investigations to turn over to it specific materials in its study of the boycott. The refusal was on grounds of confidentiality.

Two Firms Face Charges

The full House Commerce Committee, chaired by Staggers, will deal with its subcommittee's recommendation that Morton be cited for contempt. The Commerce Secretary stated in his letter that two other companies are facing charges but did not disclose their names. He did not name any of the 212 companies that, he said, have been warned to supply the Commerce Department with the required data on the Arab boycott.

Morton cautioned that the companies did not necessarily take part in the boycott but said they should have filed reports as required by law. Morton, who will resign his post effective Jan. 1, offered last week to reveal the names of companies that have complied with Arab boycott demands but insisted that the subcommittee not make public the names of those companies. Subcommittee chairman John Moss (D. Calif.) rejected the offer. The full committee is expected to take up the contempt citation against Morton tomorrow.

AJ Congress Launches National Campaign

Meanwhile, the American Jewish Congress announced in New York yesterday that it was launching a nationwide campaign to require major U.S. corporations to tell their shareholders whether they are participating in the Arab boycott of Israel or discriminating against Jews.

Will Maslow, general counsel of the AJ Congress, said at a press conference that the organization was invoking Security and Exchange Commission regulations to seek information about "anti-Israel and anti-Jewish practices, if any" by approximately 100 publicly-owned American firms.

"Stockholders are entitled to know their companies' participation in boycotts, restrictive trade practices and religious discrimination," Maslow said. He explained that "Among other reasons, job discrimination and participation in boycotts could result in legal action for damages against the company."

Demands Report To Stockholders

Maslow reported that the AJ Congress has purchased stock in five major U.S. corporations--General Motors, Hewlett-Packard, International Harvester and World Airways--each of which has been or will be requested to include a resolution in the proxy statements they distribute prior to their annual stockholders' meetings calling for "a full written report to the shareholders...on the company's policy toward compliance, tacit or overt with the demands of the Arab boycott."

Maslow said those particular companies were selected as the first targets of the campaign "because each of them is seeking business relationships with Arab countries and corporations, companies and individuals and may be involved in illegal, restrictive and discriminatory practices."

Naomi Levine, executive director of the AJ Congress, told the press conference that "the expansion of the Arab boycott during the past year and the importation of Arab bigotry against Jews into the U.S. threatens not only Israel but also the American Jewish community." She said that "by giving the aura of business respectability to religious discrimination, the Arab boycott poses a serious challenge to the quality of citizenship of American Jews."

BRAZILIAN PRESIDENT SAYS ANTI-SEMITISM WILL NOT BE TOLERATED

RIO DE JANEIRO, Dec. 3 (JTA)--President Ernesto Geisel told a delegation of Brazil's Jewish community Monday that all Jewish organizations may continue their activities as before. This was understood to be an assurance that no restrictions will be made regarding Zionist activities, following Brazil's vote in the UN for the anti-Zionist resolution.

Dr. Benno Milnitzky, president of Brazil's Jewish Confederation, who headed the delegation, expressed the anxiety of the Jewish community that anti-Semitic groups, now busy distributing the "Protocols of the Elders of Zion," may consider the Brazilian anti-Zionist vote as a "green light" for their activities. Geisel reassured the delegation that any sign of anti-Jewish activity will be immediately halted by the government.

GREECE SAYS NO TO PLO

WASHINGTON, Dec. 3 (JTA)--Greek Ambassador Menelas D. Alexandrakis yesterday advised representatives of two major Jewish organizations that his government had decided "not to extend diplomatic recognition at this time" to the Palestine Liberation Organization.

Herman Edelsberg, director of B'nai B'rith's International Council, and Hyman Bookbinder, Washington representative of the American Jewish Committee, following a meeting with Alexandrakis, said the Ambassador had disavowed news reports that Greece was ready to give official sanction to the PLO. A PLO leader had recently met with the Greek Foreign Minister, reportedly to seek formal acceptance of his group. Alexandrakis added that his government had also rejected a PLO request to open an office in Athens.

JERUSALEM (JTA)--Mexico's Foreign Minister Emilio Rabasa has accepted an invitation to visit Israel and will arrive here early next week. Rabasa has indicated he wishes to discuss Mexico's vote at the UN General Assembly in favor of the anti-Zionist resolution. The Foreign Ministry indicated that Rabasa's visit, a "working visit," will have minimum ceremonial protocol.
