SECURITY BEEFED UP ON WEST BANK By Yitzhak Shargil

TEL AVIV. Oct. 6 (JTA) -- Israel beefed up its security forces on the West Bank today to handle continuing disturbances stemming from Sunday's events at the Machpela Cave in Hebron, where Arab rioters destroyed Sifrei Torahs and prayer books, and in anticipation of new outbreaks on the third anniversary of the Yom Kippur War.

The demonstrations that have been going on since rumors spread alleging that Jews had desecrated the Koran in Hebron, are mainly by high school students. For the third consecutive day they boycotted classes to roam the streets of towns in the Samaria district stoning passing vehicles, setting up barricades and burning piles

of tires

Whenever security forces appeared, the young sters dispersed only to regroup and demonstrate elsewhere. Many of their slogans were in praise of Egyptian and Syrian forces who launched their surprise attack on Israel three years ago today and won initial battlefield victories.

Several Yom Kippur War demonstrations were held in Nablus. In Ramallah and Jericho, students remained in their classrooms, not for lessons but as a sit-in demonstration against Israel,

Meanwhile, thousands of people from all over Israel were streaming towards Hebron this morning to take part in the burial rites there later in the day for the Torah scrolls defiled by Arab rioters. (See full story P. 3.)

INS TO INSTITUTE PROCEEDINGS AGAINST EX-NAZIS IN THE U.S. By Joseph Polakoff

WASHINGTON, Oct. 6 (JTA) -- The U.S. Immigration and Naturalization Service has announced it will institute proceedings to deport three aliens living in the United States and strip four U.S. naturalized citizens of their citizenship as a result of investigations of alleged murder and atrocities primarily against Jews in Eastern Europe, before and during World War II,

The INS declined to identify the seven pending formal start of the legal proceedings. A spokesman told the Jewish Telegraphic Agency, that the deportation actions will begin in about a month, The INS will submit documentation to the Department of Justice within 60 days for denaturaliza-

tion moves

The INS said its decision to act against the alleged Nazi war criminals followed the return from Israel of Paul Vincent, the INS chief trial attorney who interviewed 32 potential witnesses and obtained signed affidavits from all of them, In addition, all 32 indicated willingness to come to the United States to testify in person, the INS said.

Rep. Elizabeth Holtzman (D.NY) described the INS action as "a very important development," and "particularly-gratifying" since it is "apparently the direct consequence of my insistence that the INS seek witnesses and documentation in these cases from sources in the State of Israel."

She added, "Although the actions do not make up for nearly 30 years of immigration service

delay and neglect, they do offer the hope that the United States will no longer be a haven for persons accused of some of the most atrocious crimes in human history."

Six Ex-Nazis Identified

Although the INS refused to identify the seven, six of them have been named by other sources as:

Andrija Artukovic, 76, of Surfside, California. former Minister of Justice and Internal Affairs in the Nazi puppet regime of Ante Pavelic in Creatia, who was charged by the post-war Yugoslav government with the murder of thousands of Jews, Serbs and gypsies; Boleslaus Maikovskis, 72, of Mineola, N.Y., who was sentenced to death in absentia by a Riga court on murder charges.

Also, Karl Linnas, 57, of Greenlawn, N.Y.. who was sentenced to death in absentia in the Soviet Union for murders committed while he was administrator of the Nazi concentration camp at Tartu, Estonia; Edgars Laipenieks, 63, of San Diego, who is accused of killings in the central prison of Riga in 1941; Edmunds Gustaf Macs (also Match, Macz), 72, of Seattle, who has been charged with complicity in wartime murders in Lumbazu, Latvia; and Sergei Kovalchuk (also Kowalczuk), 50, of Philadelphia, accused of complicity in the killing of Jews in Lubomil, the Ukraine.

ALLON, KISSINGER HOLD 1-HOUR MEETING: DISCUSS HOW PEACE PROCESS IN MIDEAST CAN BE GIVEN NEW IMPETUS By Yitzhak Rabi

NEW YORK, Oct. 6 (JTA) -- Secretary of State Henry A. Kissinger said after an hour-long breakfast meeting with Israeli Foreign Minister Yigal Allon here today that "We discussed in general how the peace process in the Middle East can be given a new impetus. I think we agreed that it would be desirable for progress toward peace to be made as rapidly as possible." Kissinger added, however, "We did not discuss any particular method of doing this today,"

Replying to reporters' questions, Kissinger characterized the recent Soviet call in the UN General Assembly for an early resumption of the Geneva peace conference as a restatement of a familiar position. He and Allon indicated to newsmen that their talk was "general" and "preliminary." that they had discussed the situation in the Middle East, including the Lebanese conflict and a number of bilateral issues but that no decisions were reached.

Both diplomats noted that they would meet again in Washington in a few days. A source at the Israeli Mission to the UN told the Jewish Telegraphic Agency that that meeting would take place early next week.

Bilateral Issues Also Discussed

Allon told reporters he and Kissinger had enjoyed sa good kosher breakfast." He said he and the Secretary had not seen each other for a long time and their meeting today was a good opportunity to discuss the Middle East situation

"as it develops there" and a few bilateral issues:

One of the latter apparently was the dispute between israel and the U.S. over oil drilling in the eastern sector of the Gulf of Suez. Asked by reporters if any decision was reached in that controversy. Kissinger replied, "We just had today a preliminary talk about all the issues. We did not intend to settle any of them. We will meet again." Kissinger added that Allon wants to discuss "matters with his colleagues."

At noon today, Kissinger hosted a luncheon in honor of the Saudi Arabian Foreign Minister Prince Saud Ibn Falsail. Allon, who will address the General Assembly tomorrow afternoon, met today with British Foreign Minister Anthony Crosland for a discussion of bilateral matters, the Middle East situation and Israel's relations with the European Common Market, He was accompanied by Ephratim Evron, Israel's Ambassador-designate to Great Britain. Allon met this afternoon with the Rumanian Foreign Minister Jan Macovescu for a discussion of bilateral matters and the situation in the Middle East.

ADL REPORTS RECORD LEVELS OF ANTI-SEMITISM IN ARGENTINA

NEW YORK, Oct. 6 (JTA).—The B'nai B'rith's Anti-Defamation League has advised a Congressional body that its independent monitoring has revealed "record levels of anti-Semitism" in Argentina and "an organized campaign designed to discredit and intimidate the Jews" of that country. Burton S, Levinson, chairman of the ADL's Latin American affairs committee offered that testimony last week before the House International Relations Committee's subcommittee on international organizations.

Levinson said his agency felt the "responsibility to speak, even if unasked by the Jews of Argentina." He noted that there have been at least 50 incidents of violence, terror, bombings, murder and abduction during the past 18 months aimed against Jews or Jewish institutions in Argentina. He claimed that "a massive propagand affort" was launched about March, 1975 to persuade the Argentine people "that Jews are a threat to the economic, social and political life of the country."

Levinson said the campaign included reviving the notorious "Protocols of the Elders of Zion" forgery and the spurious allegation that Jews planned to establish a separate state in part of Argentina. He quoted "an inflammatory poem" published in the Argentine hate magazine, El Caudillo, which, he said, was a clear-cut call for physical violence against Jews.

Levinson told the subcommittee that the ADL had raised these matters at a regent "cordial and constructive meeting" with the Argentine Amhassador to the U.S., Arnaldo T. Musich. He noted that shortly after the meeting, the Argentine government took "a significant first step" by closing down Editorial Milicia, a publishing house that produced anti-Semitic periodicals and was the principal source of Nazi books in Argentina,

Denunciations Aired In Buenos Aires

Meanwhile, according to reports from Buence Aires, the ADL and others were angrily denounce by the morning newspaper Prensa Libre for interfering in Argentina's internal affairs and making unfounded charges that Argentine Jews suffered persecution. The newspaper, described as a small circulation daily, named Levinson and

Father James Weeks, a representative of the United States Catholic Gonference, who also testified on conditions in Argentina before the House subcommittee.

Prensa Libre demanded that the B'nai B'rith ADL be declared "non grata" in Argentina and that all of its activities in that country be suspended. "The United States, moved by who knows what interests, interferes in internal matters of a nation it considers weaker," Prensa Libre charred.

"Burton Levinson stated that 400-500,000
Jews living in Argentina are the objects of an increasing anti-Semitic campaign... Those who live here know exactly that it is not true that in Argentina anybody is persecuted for his religious ideas and even less the Jewish community, which always has received equal treatment given to all Argentines, and has received all manner of dignities and functions, like the rest of the citizenry," Prensa Libre stated. If declared that the U.S. House of Representatives "has no right to patronize any investigation against our country and even less regarding human rights."

MOSHE RIVLIN TO HEAD JNF

JERUSALEM, Oct. 6 (JTA) -- Moshe Rivlin, for the past Il years Director General of the Jewish Agency, is to become chairman of the Jewish National Fund Directorate, it was widely reported here today. The reports have not been officially confirmed, but there has been no denial. Rivlin will succeed Yaacov Tsur, the veteran diplomat and former envoy to Paris, who retired from the JNF chairmanship earlier

this year,
Rivlin's appointment was reportedly initiated
by Jewish Agency Chairman Yosef Almogi, it
represents a major step forward career-wise of rivlin. In effect, it is a leap from the "civil
service" ranks of the Jewish Agency organization to the "ministerial" level. The chairman
of the JNF Directorate is ex-officio a member
of the Jewish Agency-World Zionist Organization Executive, the "cabinet" of the overall
organization.

Rivilin, 51, a scion of one of Jerusalem's oldest-established Ashkenazi familites-his great grandfather was one of the first Jerusalem Jews to live beyond the Old City walls and became known as "the builder" of new Jewish suburbs-served as a Consul in New York in the 1950s. The appointment, which must be formally made by the JNF Directorate, is likely to go into effect coincidentally with the World Zionist Congress early in 1977.

NEW YORK (JTA) -- The Greater New York Conference on Soviet Jewry has urged Soviet authorities to comply with the last wish of Ida Salansky, mother of refusenik Naum Salansky. who is under treatment for terminal cancer in Israel. Her wish is "to see my son before I die." Mrs. Salansky emigrated to Israel last August in the belief that her son and his family would soon follow. But Salansky is still denied a visa. According to Bernard Kaplan, chairman the Staten Island Committee for Soviet Jewry. he is being harassed with false reports that his mother is not receiving medical care in Israelbecause she can't afford it. "We have forwarded copies of Mrs. Salansky's hospital records to Naum as further repudiation of the USSR's barbarous lies." Kaplan said.

SYRIA CALLS FOR THE EXPULSION OF ISRAEL FROM THE UNITED NATIONS By Yitzhak Rabi

UNITED NATIONS, Oct. 6 (JTA)—Syria called today for Israel's expulsion from the United Nations, Addressing the 3lst General Assembly, Syrian Ambassador Mowaffak Allaf urged that body "to act firmly and reconsider Israel's membership in the UN." He accused Israel of responsibility for the stalemate in the Middle East and warmed that as long as Israel continues to occupy Arab territory there would be no peace in that

Allaf also said that no settlement was possible as long as the legitimate rights of the Palestin-lans were not fulfilled. He attacked partial solutions in the Middle East which he claimed had proved to be a failure and only served to perpetuate the situation of "no war, no peace."

He said Syria was opposed to step-by-step diplomacy to resolve the conflict but would welcome any initiative based on the recognition of the rights of the Palestinians and the need for Israel's withdrawal from all occupied territories He added that the legitimate representatives of the Palestinian people should participate in all international peace efforts in the Middle East

Arabs Angry With Britain

Meanwhile, Arab diplomats here expressed displeasure over British Foreign Secretary Anthony Crosland's statement in his address to the General Assembly yesterday that an essential element in a Middle East settlement "will be land for the Palestinians, not necessarily a sovereign state but a place where they will be free to look after their own affairs."

Crosland's remarks also evoked surprise from some Western diplomats. One Ambassador said they were "similar to the Allon plan." Crosland, and his spokesman here told reporters at a press conference that the statement didn't give any blue-prints but was only a possibility to meet the Palestinians' national aspirations. They claimed it was simply a reiteration of Britain's past position. But diplomatic sources here believe it constituted a new British position in the Middle East.

Egypt Sounds War Drums

Reports from Cairo, meanwhile, quoted President Anwar Sadat as warning today that if efforts to find a political solution to the Middle East conflict failed, Egypt would resort to war. Addressing the armed forces on the third anniversary of the Yom Kippur War, Sadat reportedly declared: "There is a struggle for a peaceful solution. If it does not lead to a peace based on justice, we shall again resort to the military solution." Sadat rejected a resumption of the step-by-step diplomacy of Secretary of State Henry A. Kissinger which resulted in the Sinai interim agreements with Israel in 1974 and 1925.

3000 ATTEND RITUAL BURIAL RITES FOR ARTICLES DESTROYED BY ARABS By Gil Sedan

HEBRON, Oct. 6 (JTA)--About 3000 mourners from all over larget gathered at the ancient Jawasho emetery here today to witness ritual Burial rites for Sifrei Torahs, prayer books and other religious artifacts mutilated and descenated by Arab rioters in the Machpela Cave (Patriarchs Tomb) Sunday. Israel's two Chief Rabbis, Shlomo

Goren and Ovadia Yosef, officiated at the ceremonies which were marked by controlled emotions and passed without incident.

The attendance was far smaller than anticipated by the Orthodox residents of nearby Kiryat Arba and the Gush Emunim who had anticipated a turnout of at least 10,000. Military sources estimated the assemblage at less than a third of that number. Hebron remained under strict curfew for the fourth consecutive day. There were no restrictions in Kiryat Arba.

The funeral procession was headed by the two Chief Rabbis, Defense Minister Shimon Peres, Religious Affairs Minister Yitzhak Kaphael and Welfare Minister Zevulun Hammer. Ranking army officers, including Chief of Staff Gen. Mordechat Gur attended, as did Gen. (Res.) Ariel Sharon, the founder of Likud. Likud leader Menachem Beigin and two Likud MKs, Geula Cohen and Ehud Olmert, were also present.

Many of the dignitaries left after the burial when Rabhi Moshe Levinger, the leader of Kiryat Arba and the Gush Emunim, mounted a podium to accuse the government of responsibility for the tension between Jews and Arabs in Hebron, Levinger had not been scheduled to speak. The microphone went dead but he continued to talk on.

Cabinet Defers Detailed Discussion

Meanwhile in Jerusalem, the Cabinet met briefly to discuss the incidents at Hebron but deferred a môre detailed discussion until a future session. Premier Yitzhak Rabin said that there would be no change in the status quo in Hebron until the Cabinet thoroughly reviews the situation there. It was also reported that special police investigators would conduct an intensive and imapartial probe of the incidents "to locate the guilty ones of both sides who were responsible for the disruption of law and order."

Rabin stressed that the government's objective is to cool tempers in Hebron and Kiryat Arba. "Above all it is essential that a confrontation between the two religions be averted," he said.

The Machpela Cave, a shrine to both Jews and Moslems, remained olosed on orders of the Military Government as repairs were made to remove traces of Sunday's violence. It is expected to be reopened in a few days when, hopefully, tempers will have cooled. Security sources said they did not expect any radical changes to be made in the time-sharing arrangements whereby Jews and Moslems worship at the shrine at different hours. a Kiryat Arba leaders had demanded that the government bar Moslems from the cave until after the Succoth festival and then reconsider the issue of time-sharing.

The government was reported to be considering the permanent stationing of tough border powlice units in Hebron to replace the regular soldiers who had failed to prevent violence by Arab and Jewish extremists.

In New York today, the Rabbintoal Council of Atherica condemned the desecrations. Rabbi Walter S. Wurzburger, Council President, and Rabbi Sol Roth, chairman of its Israel Commission, cabled Rabin urging the Israeli government "to take all necessary steps to protect the rights of Jewish citizens and to safeguard their loudies of Wurzbith." They also demanded the government "demonstrate to its Arab citizens that they must obey the laws and that terrorism will not be sanctioned.")

WORLD NEWS BRIEFS

NEW YORK (JTA) -- The Conference of Presidents of Major American Jewish Organizations and B'nai B'rith have called upon President Ford and Democratic Presidential candidate Jimmy Carter to reschedule their third television debate Oct. 22 because it falls on a Friday night. The two organizations have also called on Sen. Robert Dole, Republican Vice-Presidential candidate, and Sen. Walter Mondale, Democratic Vice-Presidential candidate to reschedule their Oct. 15 television debate because it falls both on a Friday night and on the final days of Succoth The Presidents Conference and B'nai B'rith express disappointment that the two debates are scheduled at a time when a large segment of the electorate cannot tune in to watch the event.

JERUSALEM (JTA)—A small group of Orthodox and nationalist Jews gained access to the Temple Mount to pray and sound the shofar just prior to Yom Kippur Sunday. But they were blocked by a police cordon when they attempted to return Monday evening for the Neilah (closing service). Members of the group, headed by Gershon Saloman, a Likud member of the Jerusalem City Council, denounced the government for refusing to allow Jewish prayers on the site. The Temple Mount contains the El Aksa Mosque and the Dome of the Rock, shrines holy to Moslems. Jewish religious rites there are barred to avoid clashes between Jews and Araby.

BUDAPEST (JTA).-Budapest's only Jewish secondary school, the Anne Frank High School, began its academic year last week in the presence of a former student, Gyorgy Aczel, now a Deputy Minister of the Hungarian government. Aczel attended the school 40 years ago when it was known as the Budapest Jewish High School and had over 1000 pupils. Presently, the student body numbers only 32 but it maintains high standards and prepares its pupils for university entrance examinations in addition to providing them with a thorough religious education.

MONTREAL (JTA) -- A National Commission on Economic Coercion and Discrimination was established here Monday to investigate the application of the Arab boycott in Canada. Prof. Irwin Cotler, of the law faculty at McGill University. who is chairman, said the commission's purpose was to inquire into the nature and effect of the Arab boycott in Canada with the view to determine the manner in which the boycott restricts freedom of trade between Canada and any other country or between Canadian citizens in Canada He said it would assess the extent to which the boycott creates a discriminatory impact on Canadian citizens and would also inquire into remedial steps, legislative and administrative, to combat economic coercion and discrimination. Cotler established the commission in connection with the Association for Law and Public Policy, a nonprofit law group he directs.

NEW YORK (JTA)--A Torah scroll, a gift of the Brotherhood Synagogue, Congregation Beth Achim of Manhattan, has been flown to remote Ambober in Ethiopia where it will be read for the first time on Simchat Torah in the Beta Israel synagogue there. Rabbi Irving J, Biock of the Brotherhood Synagogue presented the Torah last Friday to Dr. Graenum Berger, president of the American Association for Ethiopian Jews, It is

the first full-sized Torah written in Hebrew to come into the possession of Ethiopia's 28,000 Jews. Up to now, their Biblical readings were in Geez, an ancient Ethiopic language.

TEL AVIV (JTA)—An Israeli army officer was found-guilty by a military court of responsibility for the death of Ahmed Dib Dahloul, secretary of the local Communist Party in Salfit village in Samaria last summer. Dahloul died of injuries sustained when he was beaten by Israeli soldiers following his arrest during Arabriots on the West Bank. The soldiers testified that they acted under orders from the officer, to beat up six detainees, including Dahloul, on the way to the police station. The officer's name and rank were not disclosed.

WASHINGTON (JTA)--President Ford has appointed Rabbi Hershel Schachter of New York, a former chairman of the Conference of Presidents of Major American Jewish Organizations, to the six-member U.S. Commission on Civil Rights, the White House has announced. The appointment is subject to Senate confirmation. The commission, headed by Arthur S. Fleming, former Secretary of Health, Education and Welfare, reviews government programs and advises the President and Congress on discrimination. The length of the appointment is at the President's pleasure.

BRUSSELS (JTA)--Belgian police last Saturday arrested and identified the neo-Nazis who inscribed anti-Semitic slogans on a monument here to the memory of Belgium's Jewish wardead. The outrage was carried out last week by a small neo-Nazi group known as "Wolfsangel." The group publishes a violently anti-Semitic bulletin which approves-of Hitler's extermination policy. The persons involved were released by the police because there is no legislation in Belgium barring ethnic insults or incitement to racial hatred.

NEW YORK (JTA) -- The office of National Football League Commissioner Pete Rozelle. explained that Sunday's Miami-Los Angeles game in Miami started only a few-hours before Yom Kippur because the NFL was "obligated to provide a national network telecast" beginning at 4 p.m. Eastern Daylight Time, Yom Kippur commenced at 6:45 EDT. The statement was in response to a protest by Carroll Rosenbloom, owner of the Los Angeles Rams, who charged "malice aforethought" in scheduling the contest to conflict with Yom Kippur. Rosenbloom said he made "no claim to being a religious man, but I am Jewish and this is an insensitivity that has offended many people." The NFL said "We attempt to avoid scheduling conflicts with all religious holidays" but "unfortunately it is not always possible to do so."

BUCHAREST (JTA)—The Revista Cultului Mozaic, which specializes in news and articles on Jewish life in Rumania and Jewish affairs throughout the world, marked its 20th anniversary hêre last month at ceremonies attended by leading Jewish and non-Jewish writers and journalists from Rumania and other Eastern Europeata contirties, including the Soviet Union, Revista was founded and is directed by Rumania's Chief Rabbi Moses Rosen, It appears twice monthly in Rumanian, Yiddish and Hebrew deltions. The latter is the only Hebrew language periodical in
