LIKUD REJECTS 4 POINTS IN DMC GUIDELINE; COALITION TALKS CONTINUE NEXT WEEK By Yitzhak Sharail

TEL AVIV, June 9 (JTA)--Likud flatly rejected today four of the guidelines proposed by the Democratic Movement for Change (DMC) as the basis for its joining a Likud-led coalition government. The two parties will resume their negotiations next week after Likud leader Menachem Begin returns from Geneva where he will attend the wedding of a son of Nissim Ga'on, president of the World Sephardi Federation. They agreed to set up a joint committee to work out a draft on the basis of what has been agreed to so far.

DMC leader Prof. Yigael Yadin expressed cautious optimism after today's talks that an agreement may yet be reached with Likud. But DMC circles appear to be disappointed by the slow progress. Likud refused to accept the DMC's proposals on readiness for territorial compromises, the right to veto the establishment of Jewish settlements in the administered territories and the question of

applying Israeli law to the territories.

Likud also objected to the DMC's use of the term "State of Jews" in its guidelines on grounds that this would mean limiting the area of the Jewish State to those areas where Jews are in a majority. It regards the term as another way of indicating readiness for territorial compromise. Likud insists on the term Jewish State.

Begin had a more fruitful meeting today with representatives of the National Religious Party (NRP) with which Likud has few differences. A six member Likud-NRP committee was named to draft a coalition agreement. Begin and NRP leader Yosef Burg expressed satisfaction over the decision by the Aguda Israel's Council of Sages this morning permitting the ultra-Orthodox faction to enter a parliamentary coalition with Likud. The Aguda was thus given a green light by its rabbis to cooper ate with a Likud government in the Knesset. But they ruled out participation in the Cabinet either as ministers or deputy ministers.

LABOR WILL NOT JOIN LIKUD GOVT.

TEL AVIV, June 9 (JTA)--Labor Party leader Shimon Peres told newsmen after a meeting with Menachem Begin today that Labor will not join a Likud-led national unity coalition government. He said the party's various bodies made that decision and stand by it. Begin said afterwards that he would continue to meet with Peres once a week to discuss political and defense problems pending the formation of a new government,

Begin also met with Premier Yitzhak Rabin at the latter's Tel Aviv office this morning to discuss the technical details of transferring authority from the outgoing regime to the new government. He said that only questions of a practical nature were dis-The subject of a Likud-Labor coalition partnership was not raised. Rabin said he would have further meetings with Begin to expedite the governmental transfer. Likud will appoint liaison men to each government department to ensure a smooth transition.

PERES DISCUSSES EGYPTIAN TRUCE VIOLATIONS WITH UN COMMANDER

TEL AVIV, June 9 (JTA) -- Defense Minister Shimon Peres met last night with Gen. Ensio Siilasvuo, commander of the United Nations forces, to discuss Israel's complaints that Egypt is violating the Sinai disengagement agreements. Peres said after the meeting that he had no indications that the Egyptians were reverting to a war option. But, he added, it was safer to exaggerate the situation than to under-estimate it. He said Israel wanted to let Egypt know it will not ignore violations.

Earlier in the day, Premier Yitzhak Rabin visited Israeli units in Sinai accompanied by Chief of Staff Gen. Mordechai Gur. He said that the Egyptians were generally observing the Singi agreements but there were violations that must be corrected. He said the disengagement pact entered into by Israel and Egypt in 1975 was

still useful and sound.

Nevertheless, Israel has complained three times in recent days to the United Nations Emergency Force (UNEF) in Sinai about Egyptian violations. The complaints followed reports by UNEF observers that additional Egyptian troops were deployed in the Egyptian limited forces zone. Israel said the troops were in excess of the number allowed under the agreements and that Egypt has also installed SAM-7 ground-to-air missiles in Sinai in violation of the pact.

Peres said the impression was that Israel was dealing with a moderate adversary but the fact is that Egypt is violating the agreements. He said that even the Syrians were more careful in observing the provisions of the disengagement

agreements on the Golan Heights.

Siilasvuo, who just returned from a meeting with the Egyptian War Minister in Cairo, confirmed the Israeli complaint and said "We are trying to bring the number of troops back to the agreed limitation." But Siilasvuo said there was no war atmosphere in Egypt. He noted that the town of Ismailia on the Suez Canal was making preparations for a visit by President Anwar Sadat.

ISRAELI DOCTORS PROTEST CONCESSION ON AUTOPSIES

TEL AVIV. June 9 (JTA) -- Concessions by Likud to the ultra-Orthodox Aguda Israel came under fire today. The Israel Medical Association wrote to Premier-designate Menachem Begin urging no change in the present laws governing autopsies. The Social Workers Union warned Likud that it would fight any attempt to amend the abortion law by removing the social condition of the mother as one of the grounds for approval of abortion.

The Aguda, with four Knesset seats, has agreed to join a Likud-led coalition. It made several demands in the religious and social areas including curbs on abortion and barring autopsies without family consent. Likud has acquiesced to these demands.

In a letter to Begin, Dr. Rami Yishai, chairman of the Medical Association, declared that any amendment to the law on autopsies would

rael. He said that physicians do their utmost now to comply with the wishes of the families but in certain cases autopsies must be performed in the interests of national health and family objections must not be allowed to override medical considerations. Dr. Yishai noted that the National Reliaious Party (NRP), for many years a coalition partner, nevermade such demands and that whenever controversies grose over autopsies they were generally settled to the satisfaction of the NRP and the medical profession.

Itzhak Kadman, leader of the Social Workers Union, wrote to the Likud leadership that the present abortion law was adopted in response to the needs of the underprivileged sector of society. To eliminate social conditions as a reason for abortion would place a severe burden on the poor, he said. He cited unofficial statistics that showed that about 80 percent of the abortion requests brought before professional screening committees for approval cited social conditions. (By Yitzhak Shargil)

STUDENTS URGE METROPOLITAN MUSEUM DIRECTOR INTERVENE ON BEHALF OF SHARANSKY

NEW YORK, June 9 (JTA) -- Over 700 students picketed the Metropolitan Museum yesterday de-manding that its director, Thomas Hoving, inter-cede with Soviet officials to bring about the release of Anatoly Sharansky, the Soviet Jewish activist charged with treason who faces the death penalty. The students from Manhattan's Ramaz School, ranging in age from six to 18, who were carrying signs calling for Sharansky's release and chanting Hebrew songs, filled the sidewalks in front of the museum, which is featuring an historic exhibit of Russian and Soviet art.

Rabbi Haskel Lookstein, spiritual leader of Congregation Kehilath Jeshurun and vice-chairman of the Greater New York Conference on Soviet Jewry, who led the students out of the Jewish day school, said, "We will not abide cultural exchange while the Soviet Jews are undergoing the most brutal repression since Stalin....We are demonstrating one week before the opening of the Belgrade conference to review Soviet compliance with the Helsinki accords, in which 35 nations pledged to remove human rights violations in their countries

Recent protests in New York, as well as the upcoming rally on Friday June 10 at noon at Aeroflot, the Soviet airlines, are designed to pressure the Soviets to drop charges against Sharansky as they have in the cases of at least three other Jewish activists in the last eight months.

In Chicago, the co-leaders of the National Interreligious Task Force on Soviet Jewry, a group of Catholics, Jews, Evangelicals, Orthodox and Protestants, appealed to President Carter this week to intercede with Soviet leaders at the highest level to release Sharansky. Prof. Andre Lacocque Rabbi Marc Tanenbaum and Sister Margaret Traxler urged religious, ethnic and human rights groups to join in this protest to Soviet officials, as one

sign of their compliance with the Helsinki accords. The Task Fosce statement said: "As a Jew, Sharansky can be further abused to focus the anti-Semitic strands of Soviet society, whose leaders callously employ anti-Semitism as a sociological device to distract the attention of their own peoples from internal problems or policy failures. At Belgrade, it seems, they will resort to the same ruse to attempt to divert world attention from their failure to honor the Helsinki accords.

TIES WITH BONN TO CONTINUE By Uzi Benziman

JERUSALEM, June 9 (JTA)--Menachem Begin who objected vehemently to Israeli diplo-matic relations with West Germany when he was an opposition leader, will maintain close and cordial ties with the Bonn government when he becomes Premier, informed sources said today. The sources based their views on comments by Likud leaders and foreign diplomats here,

Begin had a friendly conversation with a high ranking German diplomat recently and is expected to welcome West German Chancellor Helmut Schmidt when the latter visits Israel in December on an invitation extended by Premier

Yitzhak Rabin,

Top Likud figures have assured German diplomats that there will be no changes in Israeli-German relations under a Likud regime. When the German Ambassador, Per Fischer, telephoned Likud's number two man, Simcha Ehrlich, to congratulate him on Likud's election victory last month, Ehrlich assured the envoy that there would be no cooling off in relations. Gen. Ezer Weizman, slated to be Defense Minister in a Likud government and Dr. Eliahu Ben Elisar. Likud's information officer, have given similar assurances, the sources said.

WARNER CONFIRMED AS AMBASSADOR

WASHINGTON, June 9 (JTA) -- Marvin L Warner, a Cincinnati businessman active in the Jewish community there, has been confirmed by the Senate to be the next U.S. Ambassador to Switzerland. Warner, 58, was born in Birmingham, Ala. and was graduated from the University of Alabama and its law school. He is chairman of the board and chief executive officer of the Warner National Corp. and is a prominent developer and financies.

His Jewish activities include past presidency of the Cincinnati Jewish Community Center; chairman in 1962 of the Jewish Welfare Fund campaign; president of the Jewish Federation from 1967-1969; and former member of the boards of the Cincinnati Jewish Hospital and Hebrew Union College. He is a member of Rockdale Temple in Cincinnati.

Warner was a member of the U.S. delegation to the United Nations General Assembly in 1968 during the Johnson Administration. He is a member of the Democratic National Committee and of the Ohio Governor's Commission on Housing and Urban Development. Other business interests include part ownership of the New York Yankees baseball team and the Tampa Bay Buc= aneers, a professional football team. He is also chairman of the Ohio Board of Regents

Warner's nomination by President Carter for the Ambassadorship in Berne raised objections in some State Department circles. Dennis Kux, a State Department official who testified on behalf of the American Foreign Service Association be-fore the Senate Foreign Relations Committee this week, claimed that Warner lacked the qualifications to be an Ambassador and alleged that his, nomination was a reward for his support of the Carter campaign. White House Press Secretary Jody Powell flatly denied the allegations and said Carter selected Warner from among five possible nominees because he was best qualified for the job.

HERZOG SAYS RETURN TO PRE-67 BORDERS MEANS NEW MIDEAST WAR

NEW YORK, June 9 (JTA)—Israel's Ambassado to the United Nations, Chaim Herzog, declared last night that "whomsoever advocates a return to ther 967 lines (between Israel and her neighbors), however well meaning he may be, is enunciating a formula for a renewed war in the Middle East."

Addressing a dinner sponsored by the American Board of Overseers of Bar Ilan University at the Hilton Hotel, celebrating the election of Dr. Emanuel Rackman as the university's president, Ilerzag said that at the heart of the Arab-Israeli conflict. "lies the Arab refusal to recognize the right of the Jewish nation to self-determination and notional sovereignty."

The Israeli envoy, who received an honorary Doctorate of Law degree during last night's dinner, told the more than 700 guests that "there is no alternative to direct face to face negotiations for

peace in the Mideast.

"I emphasize direct face to face negatiations because they presuppose solving the main problem a recognition of Israel's rightful place in the Middle East. The sinister significatione of the Arab leaders' refusal to negatiate with us, or of their Ambassa' dors' refusal to talk to my colleagues and myself is that they in effect depy our right to exist," Herzog said

DOUBLE BAR MITZVAH

JERUSALEM, June 9 (17A)=Baruch Sand and Levi Roisman celebrated their bar mitzvahs today. Baruch's ceremony was held at the Western Wall. Levi marked his coming of age in Novasibirsk in the Soviet Union. The Roisman family has been trying to leave for Israel for the past five years but was repeatedly denied exit visas by the Soviet authorities.

Levi's elderly grandmother was the only member of the family finally permitted to leave. She attended Baruch's bar mitzvah today. It was the first "twin" bar mitzvah in which an Israeli youngster and one in the USSR performed the rites on the same day. There will be more, according to Ruth Bar-On, head of the information department of the Israel Public Council for Soviet Jewry. She said the idea is to strengthen ties between Israelis and Jews in the Soviet Union.

LAW PROFESSOR SAYS USSR CIRCUMVENTING HELSINKI ACCORDS By Brian Lipsitz

NEW YORK, June 9 (JTA)—The imprisonment of Soviet-Jewish activist Anatoly Sharansky, on charges of treason, epitomizes the whole issue of Soviet Jewry, including the legalistic questions involved in the Helsinki accords, Prof. Howard Green berger of the New York University Law School said at a press briefing today at the Greater New York Conference on Soviet, Jewry offices.

According to Greenberger, Article Three of the Helsinki accords, which states the concept of family reunion, is being circumvented by the Soviet Union when the Soviets claim a person is privy to state secrets and as a result may not emigrate. Sharansky's wife has been in Israel since 1974.

By using questionable interpretations of vague interpretations of vague interpretations of vague interpretations of vague 22" to claim they are not violating the Helsinki accords. As an example, he cited two provisions under the Soviet religious codes: that there he no religious practices outside of a "house of worship"; and that no funds for religious purposes may be collected outside of the house of worship. These pro-

visions, while not explicitly in violation of the accords, have been detrimental to the Jewish community, Greenberger said.

According to Dr. Steven Cohen of the Conference, "This year has been one of the worst years for Soviet Jewry. There is no doubt about it." There is uncertainty over what precipitated the apparent tougher attitude of the Soviets towards the activists, which Cohen said surfaced last October, eventually leading to the first treason charge against a Jewish activist since 1970.

An accelerated publicity campaign on behalf of Soviet Jews is being waged, with Sharansky as the facus, Cohen said, adding: "We have serious hopes that the Soviets will not want to pay the public relations price."

INVESTMENT LAW URGED

JERUSALEM, June 9 (JTA)—Amos Mar-Haim, director general of the investment centrer, urged the Cabinet today to introduce a new law aimed at encouraging investments. In memorandums to the Finance Minister and the Minister of Commerce and Industry, Mar-Haim said the present law was too complex. He urged the elimination of bureaucratic red tape whitch; he said, discouraged the kind of investors tracel's industry wanted to attract. He said the new law should be clear, concise and effective and should be enacted without delay.

FANS TEAR ISRAELI FLAGS

MEXICO CITY, June 9 (JTA)—Hundreds of basketball fans celebrated Mexico's 90-77 defeat of Israel's national basketball team here last night by tearing Israeli flags and showing open hostility to the Israeli athletes outside the arena. It was the Mexicans' manner of taking revenge for Israel's defeat of their own team in Tel Aviv several weeks ago.

STRONG ISRAEL URGED

TEL AVIV, June 9 (JTA)—Gen.(Ret.) George Keegan, former chief of intelligence of the U.S. Air Force, said here that a strong, free Israel was vital to American interests. Keegan, who ended a week-tong visit to Israel, said that if the Arab strategy in the Mediterranean succeeded, the only beneficiary would be the Soviet Union which would then be in a position to increase its threat to the free world.

According to Keegan, Israel represents the only assurance against the new Soviet imperialism, in this region. He said that the Arab strategy, after losing four wars, is to isolate Israel and to get the U.S. and the free world to exert pressure on it; This must not succeed, he said.

TEL ANN, June 9 (JTA)—Likud leader Menachem Begin cancelled plans to go to Geneva tomorrow to attend the wedding of a son of Nissim Ga'on, president of the World Sephardi Federation. He called off the trip on the advice of his doctors who thought it might be too tirring at a time when Begin is in the midst of negotiations to form a government. Begin, who suffered a heart attack in March, was hospitalized for a week last month after he complained of chest pains. He was released on May 29 and prohounced fit for his duties but was ordered by his doctors not to overwork.

DISCRIMINATION AGAINST WOMEN IN JEWISH COMMUNAL FIELD OUTLINED

WASHINGTON, June 9 (JTA)—Nine hundred delegates attending the 79th annual National Conference of Jewish Communal Service workers here, charged yesterday that employment discrimination against women was the prevalent practice in that field. A resolution adopted by the conference said that the readiness of Jewish communal agencies to employ women in top executive posts, remains

grudging, reluctant and unwilling.

The resolution called on the leaders of Jewish communal agencies to examine their hiring practices, both explicit and implicit, for discriminatory patterns and to make a conscious effort to broaden the opportunities for women to fill decision-making jobs. The charge of unequal apportunities for women despite recent advances in women's rights. stemmed from a study of 319 communal agencies employing 2200 people, 54 percent of them women less than the properties of executive director or assistant executive director, women held only 2.5 percent of the positions. Among male employes, 29 percent were executive directors, 23 percent assistant executive directors, 25 percent supervisors and 23 percent line workers.

Disparity in salaries was also revealed. The study disclosed that only 5 percent of women employes received salaries of \$20,000 or more per years in contrast to 57 percent of the male employes. Of 1200 women covered in the study, only 10 (0.8 percent) held the top executive positions in their respective; agencies and 45 were in the next highest category. 89 contrast, 71.5 percent were

line workers.

The study covered five fields of Jewish communal service: federations; community centers; hospitals; family and social service-agencies; and old aged homes. Women comprised 75 percent of the professional workers in the family and social service agencies but held only three of the top executive posts. Among 91 federations, there were only three women executive directors, in small communities. Federation staffs were 85 percent male:

Addressing over 400 delegates from 31 countries, Salgo, who was elected as chairman of the Jewish representatives at the conference, said:
"In Hungary the Jews found a new home."

PROF. SAYS ARABS FEAR JEWISH COMPENSATION DEMANDS

TEL AVIV, June 9 (1/TA)—Dr. Yaacov Meron of the Hebrew University's law faculty charged that the Arab states are trying to deflect possible claims by Israel for compensation for Jewish refugees who were forced to leave Arab countries in 1948. He told a special meeting on the situation of Jews in Arab countries Monday night that for this reason some Arab governments are urging those Jews to leave streel and return to the lands of their birth.

According to Meron, the Arabs are afraid that Israel may make the same demands at a future peace conference that the Arabs themselves made during the Rhodes armistice negotiations in 1949. At that time; the Arabs demanded compensation for the

lands and other property left behind by Arab refugees from Israel. They also asked Israel to admit a token number of Arab refugees to those territories originally assigned fo an Arab state by the UN Palestine partition plan. Israel was inclined to agree, but because of the compensation demands by the Arabs, the plan was dropped, Meron said.

He said that the ouster of Jews from Arab countries was a premeditated plan, especially in Iraq where it was initiated by Nuri A-Said. Meron quoted portions of the memoirs of a British diplomat who said that Said had suggested that trucks bring Iraqi Jews to the border between Jordan and Israel.

HIGH HOPES FOR RUMANIAN JEWS

(TEL AVIV, June 9 (JTA)—Yosef Almogi, chairman of the Jewish Agency and World Zionist Organization Executives, returned from a visit to Rumania this week and said he had high hopes that some 50,000 Rumanian Jews would be allowed to be reunited with their families in Israel,

Almogi said that Jews were treated well in Rumania; but almost every Jew had a relative in Israel and the majority of Rumanian Jews wanted to make aliya. However, he noted that the number of Pexit permits is not as high as Jews would like.

CAREY CASTIGATES BEGIN'S CRITICS

NEW YORK, June 9 (JTA)—New York Governor Hugh L. Carey last night castigated early, critics of Israeli Premier-designate Menachem Begin, charging that their "short-sightedness" in labeling the Likud leader an extremist "enhances arguments for imposed solutions to the Middle East crisis."

In an address to an Israel Bond dinner at the Essex House hete, Carey asserted "we certainly should not criticize Mr. Begin now," stating "there is no indication that the new government of Israel will swerve from the pursuit of a negotiated settlement" in the Middle East. He called for "intelligent and informed approaches to the elected leadership of Israel" and said that "we must encourage in both private and official circles in this country a clear-headed understanding and patience as Menachem Begin and the Likud Party build the parliamentary and democratic coalition necessary. To govern the country."

The Governor was guest speaker at a testimonial dinner for former New York State Assembly Majority Leader Albert H. Blumenthal that was sponsored by the Manhattan Lawyers Division of State of Israel Bonds, Attorney Louis Nizer, chairman of the dinner, announced that it produced more than \$560,000 in Israel Bond purchases, Carey soid it was "ironic" that Mr. Begin,

Carey said it was "ironic" that Mr. Begin, "whose election is evidence of the workings of democracy under pressure, should be criticized as an extremist, while the non-democratic leadership of some of the forces most threatening to Israel is described as moderate." Noting that the transition period in its government is "a crucial time for Israel," the Governor said this situation is "easy for Americans to understand since we ourselves undergo similar political transitions in our democratic system of government."

SEATTLE (JTA)—Washington Gov. Dixie Lee Ray signed an anti-boybott, bill into low Wednesday making Washington the ninth state in the country to enact anti-boycott legislation.
