WEIZMAN OPTIMISTIC UNIFIL WILL BE ABLE TO BLOCK TERRORISTS' RETURN By Gil Sedan

JERUSALEM, April 20 (JTA)—Defense Minister Ezer Weizman expressed optimism today that the United Nations Interim Force in Lebanon (UNIFIL) will be capable of preventing the return of terrorists to south Lebanon. Speaking before the Knesset's Foreign Affairs and Security Committee, he said UNIFIL contingents appear to be in control of the areas evacuated by Israel and are "beginning to feel at home" there is the said the UNI troops have already prevented a number of terrorists from penetrating the region.

Weizman confirmed that he had promised UN Secretary General Kurt Waldheim that Israel forces would make a further withdrawal shortly to a narrow security belt paralleling the Israelizebanese border. He soid he gave the undertoking only after Waldheim promised that UNIFIL would be enlarged from its originally mandated strength of 4000 men to 6000. He said half of the enlarged force would be deployed along the Litani River to block terrorist infiltration from the offth and the rest would be stationed in territory between the Litani and the Israeli border.

The Defense Minister said the new Israel I pullback would be completed by the beginning of next month-but that he gave Waldheim no commitment to a final withdrawal date. He said he assured Waldheim that Israel had no intention to extend its presence in south Lebanon and that its sole interest was to make sure that the area will not serve again as a base for terrorist operations against Israel.

Weizman soid the only unstable area in south Lebanan is the region around Tyre where some 1500 terrorists are still concentrated. He said he hoped that the French UNIFIL contragent assigned to that area would maintain tight control

No Talks With PLO Involved

Weizman rejected the view that the present efforts to secure the return of Israeli soldiers captured by terrorists, and he remains of those killed during the Lebanese operation constituted negotiations with the Relestine Liberation Organization. He soid those efforts, utilizing the services of the International Red Cross, were no different than similar contacts with the terrorists in the past when Israeli hostages were held. He disclosed that Israel provided Woldheim with a list of prisoners captured during the Lebanese operation.

He told the Knesset committee that all in all the operation appears to have been a success and that Israel anticipated political developments in Lebanon that would further hinder the return of terrorists to the south. (Lebanon's first post-civil war government resigned yesterday, following a controversy over last week's fighting in Beitut between the Christian militia and the Syrian peace-keeping force.)

Weizman disclosed that 60 Israeli soldiers had been arrested for looting during the Lebanrese operation, 40 have been tried and some have received prison sentences. But he said reports of widespread looting by Israeli troops were expagarated. STATE DEPARTMENT SAYS DAYAN WILL

WASHINGTON, April 20 (JTA)\(^1\)- The State Department announced today that Israeli Foreign Minister Mostle Dayan "will be coming here toward the end of next week" for talks with U.S. officials and that Ambassador-at-Large Alfred L. Atherton will return to Washington from the Middle East "to be present for this visit." Atherton is en route to Cairo for meetings with Egyptian leaders and had originally intended to go from there to Israel.

Asked about press reports that Israel did not want Atherfon to come there during his current trip, Reston sqid: "There's nothing to the story. The government of Israel has informed us that it would welcome a visit from Ambassador Atherton during his current Middle East visit. It makes sense for Ambassador Atherton to be back in the U.S. for Foreign Minister Dayan's visit." Obviously, Atherton is going to be very crucially involved in these negotiations."

(In Jerusalem, Foreign Ministry officials said today that a formal invitation for Dayan to visit Washington had not yet been received. Dayan, it was stated, would-return from Washington before a scheduled visit by Begin to the United States the beginning of next month to participate in celebrations of Israel's 30th-anniversary.)

NAZIS FILE FOR PERMIT TO MARCH IN SKOKIE JUNE 25; JWV CALLS ON ITS MEMBERS TO HOLD COUNTER-RALLY By Ben Gallob

NEW.YORK, April 20 (JTA)—The New York department of the Jewish War Veterans reported today that, following filing by the American Nazi Party of a request for a permit from Skokie Village to stage its march on June 25, it was coordinating a campaign to bring thousands of JWV members to the Chicago suburb for a counter-demonstration.

Marvin Morrison, the New York JWV department executive director, sold the Nazis filed their request for a permit on Monday. He said the New York department was taking, "all necessory steps" to prepare a large counter-demonstration and that travel and housing arrangements for JWV members going to Skokie, home of 7000 suryivors of the Holocaust, were being coordinated by the New York department in cooperation with the national office in Washington, D. C.

Morrison told the Jewish Telegraphic Agency that mailgrams were sent yesterday to-cell 100,000 JWV members urging them to plan to go to Skokie, in the event 'Skokie Village officials approve the requested permit. The mailgram said that Skokie. Village officials had been asked to set up a tentity in Skokie for the JWV members use June 23-27. The permit ordinance requires a 30-day waiting period before the organization receiving the permit can, implement it.

Morrison also reported that the JWV department was making plans for a moss rally in New York City to coincide with the action in Skokie. He also reported that the plans for the mobilization would be discussed at the department's convention June 1-4 in Klamesha Lake.

Issue Involved In Controversy

There are two issues in various stages of liftgation in the Skokie controversy. One is a set of
three ordinances approved by the village which ban
groups which preach hatred or wear military style
uniforms from marching in Skokie, or to pass out
hate literature, and requiring, any group planning to
demonstrate to post \$300,000 in Itability insurance.
The Chicago Nazis have said they will weer Nazi
style uniforms with swestika armbands.

The other is a bid for an injunction against the march sought by Sol Goldstein, a Skokie resident, Holocaust survivor and a leader of the Public Affairs Committee of the Jewish United Fund of

Metropolitan Chicago.

On March 17, Judge Bernárd M. Decker of the Federal District Court in Chicago, ordered a temporary ban on the proposed Nazi march to allow Skokie officials time to appeal his earlier ruling holding the three ordinances unconstitutional. Subsequently, a three-judge panel of the Seventh Circuit Court of Appeals in Chicago sustained Decker's ban.

On April 6, the full Circuit Court reversed the ponel's decision and set aide the 45-day stay ordered by Decker. The full Circuit Court held there was no need for a stay because it intended to rule promptly on the constitutionality of the ordinances.

Appeals To Supreme Court Eyed

James P. Rice, executive vice-president of the Jewish Federation of Metropolitian Chicago and of the Jewish United Fund, told the Jewish Telegraphic Agency by telephone today that it was generally understood that if the Federal Circuit Court found the ordinances unconstitutional, Skokie officials would appeal to the U.S. Supreme Court, and that, if they were found constitutional, the American Civil Liberties Union, representing the Nazis, would also appeal to the Supreme, Court.

Jerome Torshen, Goldstein's attorney; told the JTA, also in response to a telephone inqulry, that the Illinois Supreme Court; which had ordered dismissal of Goldstein's petition for an injunction against the Nazi march, had stayed that order to "allow Goldstein to petition the U.S. Supreme Court or a review of the State Supreme Court decision. He said the effect of the State Supreme Court stay was to return Goldstein's injunction bid to the jurisdiction of the Circuit Court of Cook County.

KNESSET MEMBER SAYS U.S. JEWISH LEADERS' VIEWS OF ISRAEL ARE INFLUENCED BY MEDIA PRESENTATION BY YITZHOK ROBI

NEW YORK, April 20 (JTĀ)—Joseph Rom, a Likud member, of Knesset, soid yesterday that Israel has "a problem with the American Jewish leader—ship" because "they are influenced by the image of Israel as presented by the American media." He didnot efaborate on the "problem" with the Jewish leaders, but he did note that grass roots American Jews with whom he had met during his two-week nationwide tour were less inclined to question Israel's foreign policy. As a result; he said, he felt "very comfortable with them."

Rom offered this view at a press conference sponsored by the American Jewish Congress. He was here at the conclusion of his tour during which he met with Jewish leaders, officials in Washington and addressed Jewish groups and members of the media.

Rom, who is a member of the Knesset Foreign-Affairs and Security Committee and chairman of its subcommittee on arms purchase and production, said that in Washington he found that Israel's positions were misreprespeted as a result of Israel's image as distorted by the media. "The image and the conception of Israel" is the real problem, Rom said.

According to Rom, Israel made "an error" in regard to the issues of Israel; settlements and Resolution 242 "in not presenting the settlements as a bdsic security requirement for Israel."—As for Resolution 242, he said that he encountered numerous questions in Washington regarding Israel's inferpretation of the resolution. He said the recent announcement by Jerusalem affirming its adherence to 242 as a basis for negotiations with the neighboring Arab states was a positive move in clarifying the issue.

Cites Major Distortion

Rom said that he met with Congressmen, State Department officials and White House aides and that he got the impression that there are groups saying that it is better to accept Egyptian President Anwar Sadat's approach to a settlement in the Mideast than have another war in the area.

The major distortion, he added, is that Israel is seen as responsible for the standstill in negotiations with Egypt. "It is Sadat who is not willing to resume negotiations," Rom said, pointing out that the Egyptian President did not, respond to Israel's peace plan as presented to him by Premier Menachem Begin last December in Ismailia.

"A lot of people are still under the spell of Sadat's visit to Jerusalem. It was a big step, but now we have to come down to earth and resumenegotiations in the customary, regular way,"

Rom said.

PLANE PACKAGE SALE ISSUE GOING TO CONGRESS APRIL 26

WASHINGTON, April 20 (JTA)--The State Department announced that the Carter Administration's proposed package sale of war planes to Saudi Arabia, Egypt and Israel will go before Congress April 26." Both the Administration and Congress are poised for what may be a prolonged and bitter fight over the package which has already drawn fire from many Congressmen as well as American Jewish leaders. The basic contention of those opposing the package is that it will upset the Mideast balance in favor of the Arab states and that an earlier promise by the U.S. to sell planes to Israel was not linked to any package deal.

TOP LEVEL JEWISH LEADERS SAY ISRAEL'S IMAGE IN U.S. DAMAGED BY SETTLEMENTS, INTERPRETATION OF RESOLUTION 242 By Gil Sedan

JERUSALEM, April 20 (JTA)—A group of eight top level American Jewish leaders told the Knesset Foreign Affairs and Security Committee today that the Israel government's latest interpretation of Security Council Resolution 242 and its penisfent policy of establishing settlements in the occupied Arab territories was making it increasingly difficult to reverse the deferioration of Israels image in the United States.

They reportedly said essentially the same thing to Premier Menachem Begin at two meetings with him since their arrival in Israel Sunday for

a five-day visit.

It was learned today that the group has an appointment at the White House Monday to discuss the current state of Israeli-American relations. It was not known with whom they will meet, but it is assumed that the purpose of the scheduled meeting was to inform the Carter Administration of the present mood in Israel, as they are presently informing Israeli leaders of the mood in the U.S. The group includes the leaders of four of the largest and most influential national Jewish organizations in the U.S.

They are: Howard Squadron, American Jewish Congress president; Noom Levine, AlCongress executive director; Richard Mooss, American Jewish Committee president; Bertram Gold, AlCommittee executive vice-president; Burton Joseph, Anti Defamation League of B'nail B'rith chairman; Benjamin Epstein, ADL director, Medodore Mann, National Jewish Community Relations Advisory Council chairman; and Albert Chernin, NJCRAC executive director.

They mer with Begin for one hour on Tuesday and again today for two hours. They also had meetings with Deputy Premier Yigael Yadin, Foreign Minister Moshe Dayan, Defense Minister Ezer Weizman and Leon Dulzin, chairman of the World Zionist Organization.

Difficult To Explain Israel's Positions

They told the MKs that they had always assumed that the Likud government honored the interpretation given Resolution 242 by previous goveraments and that they were at a loss to explain the change to the American public. They were, referring to Begin's insistence that Resolution 242 did not apply to Israel withdrawals from the West Bank. Previous governments acknowledged that the resolution called for territorial compromise on all.

The Jewish leaders stressed that it was impossible to explain Israel's settlements policy in a positive light. They said that while they agreed that Jews had the right to settle anywhere in their ancestral home, the matter of timing had to be considered. They said there was no room for the continuation of settlement projects as long as peace negotiations continue. They warned that the settlement policy damaged the public compaign against the U.S. Administration's proposed package sale of advanced warplanes to Israel, Egypt and Saudi Arabia.

The leaders told the MKs that they came to Israel to express the full solidarity of American Jewry but, at the same time, to convey American Jewry's concern over Israel's sagging image and its strained relations with Washington. They said issended is image in American public opinion now is of

a country that sticks to a stubborn policy in contrast to the generosity and peaceful intentions displayed by President Anwar Sadat of Egypt

The visitors also said that the American Administration is strongly influenced by Saudi Arabia's petrodollars. They noted that the Saudis are buying billions of dollars worth of American bonds, thus helping to cover the U.S. fiscal deficit.

Statement By The Delegation

The delegation published today the following

"We came to Israel with a profound belief that the historic special relationship of mutual support and confidence between Israel and the U.S. should be preserved and strengthened in the interest of both countries. In our discussions here we expressed our concern that the Israeli peace plan, which we regard as a creative response to issues that have been intractable for 30 years, has not received the attention of the American public that it deserves.

"Among other matters, we reported that the timing of new settlements and the controversy over Resolution 242 have diverted attention from the fundamental issues of peace and security. We urged that a new and higher priority be given to public information and to the inter-relationship between the formulation of policy and its public interpresentation.

"We regard these talks-os a significant step forward in the relationship between American Jewry and the leadership of Israel. Our views received the respectful attention of all those with whom we met. We are particularly grateful to the Premier for having given us so much of his time." All with mission was a part of the continuing cooperative fort on behalf of Israel by the three major Jewish community relations agencies in the U.S. and their coordinating instrumentality."

CHAMOUN SLAMS RES, 425 FOR IGNORING TERRORIST PRESENCE IN SOUTH LEBANON Praises Israel's Aid To Christian Community

PARIS, April 20 (JTA) -- Lebanese Christian leader Camille Chamoun said in an interview published in Le Figaro today that the United Nations was neglecting a serious aspect of the problem in Lebanon related to the Palestinian and temprist presence in that country. He said the internationalization of the Lebanese question, similar to the UN action in Korea more than 25 years ago was necessary.

Chamoun, a former President of Lebanon, said that UN Security Council Resolution 425 of March 19 referred only to the withdrawal of Israeli forces from south Lebanon. "The other aspects of the problem now, that is to say the presence of 20,000 armed fedayeen and 400,000 Palestinians living in Lebanon, has been avoided by the UN," he

charged.

Chamoun praised Israel's assistance to the Christian community in Lebanon, and said Israel's support "In no way prevented Lebanon from rescovering its sovereignty." He recalled that the Soviet Union and the U.S. became allies in face of the Nazi danger and "no one complained about such an alliance. Today, in face of the Polestinian danger, Lebanese Christians are seeking help from Israely" he said. He warned that "a new United Nations action is imperative, otherwise the Christians will react if nothing is done to restrict Polestinian fedayeen activity."

RABBI SLAMS LAS VEGAS NIGHTS IN N.Y. By Ben Gallob

NEW YORK, April 20 (JTA)—An official of the New York Board of Rabbis (NYBR), which waged a losing battle against approval in a referendum in 1976 by New York voters of Las Vegas nights for fund-raising by non-profit institutions, said today, many Jewish congregations were conducting such fund-raising in violation of the law. Rabbi Poul Hait, NYBR executive director, said the rabbinical group had issued a statement affirming its apposition to gambling in houses of worship, initially issued on Oct. 5, 1976.

The NYBR, which represents Orthodox, Conservative and Reform rabbis of the New York area, declared that Las Vegas games tend to involve "professional gamblers and attract criminal elements who, ultimately, will wield malevolent

power over religious organizations.

Declaring that it had consistently opposed fund-raising through gambling as "not consonant with the high standard of morality and dignity which our religious tradition sets for the general community," the NYBR-said "we cannot use questionable means to achieve even the most meritorious goals, for this would negate the ideals cherished by the Jewish tradition."

Hait said the fears of the NYBR had been confirmed by the recent action of an individual identifying himself as a rabbi, who rented a closed supermarket in Queens, astensibly to be a synagogue, but which was used to operate Las Vegas nights. Hait said the individual was not listed by any rabbinical organization and that he decided to shut down the venture after it attracted wide-

spread unfavorable attention.

Hait said the requirements of the Las Vegas law are so restrictive that two non-profit institutions which had obtained the required licenses decided not to stage Las Vegas nights. He said neither was a synagogue. In addition to a license the law bans mass advertising of such events, imposes a maximum win of \$1000 per participant per night, and the gambling events must be conducted by the sponsoring institution, with outsiders barred

Hait told the Jewish Telegraphic Agency that the NYBR had learned that many congregations were conducting to Yegas nights without licenses and with outsides operating the games. The NYBR statement said the robbinical group was aware that many hon-profit institutions and organizations have operated Las Vegas nights "to meet their financial obligations" but urged them "to develop alternate revenue producing functions."

STATE EMPLOYE HELD ON SUSPICION OF DISTRIBUTING ANTI-SEMITIC FLYERS By Rochelle Wolk

ALBANY, April 20 (JTA)—Albany police are holding a 50-year-old New York State employe suspected of distributing hundreds of anti-Semitic flyers in the heavily Jewish-populated Pine Hilfs section of the city since last fall. Police announced the arrest early yesterday morning of Haviland Willard Davis, a senior architect in the Division of Design and Construction of the Office of General Services here.

He was apprehended by Patrolman John Madison at 516 a.m. while fostening anti-Semitic messages under the windshield wipers of parked cars in the Pine Hills neighborhood only a few blocks from his home. He was charged with aggravated harassmehr, a Class A misdemeanor punishable by up to one year in jail: Davis; who is unmarried, lives with his porents and earns more than

\$20,000 a year, was sent to Albany County jail for psychiatric examination pending a hearing next Tuesday. Bail was not set.

Albany County District Attorney Sol Greenberg and Albany Police Chief Edward C. McArdle reported numerous complaints during the lost several months of anti-Semitic material affixed to car windshields. Although much of Albany's Jewish population is concentrated in Pine Hills, many of the complaints came from non-Jewish residents who were "outraged," Greenberg said. The messages, crudely printed in purple ink on pink or white paper said. "I was Beware-Look You Scoffers, Wonder and Die: Acts 13-41."

REPORT BELL TELEPHONE OF CANADA COMPLYING WITH ARAB BOYCOTT By Michael Solomon

MONTREAL, April 20 (JTA)—A \$1.1 billion contract for Bell Telephone International of Conada to modernize telephone service in Saudi Arabia could be lost if secret clauses containing provisions required by the Arab boycott are revealed, representatives of Bell told the Canadian, Radio, Television and Telphone Communication Commission (CRTC).

Bell is seeking permission from the CRTC, a regulatory agency, to raise its rates. But the National Anti-Poverty Coalition has demanded that Bell, not undertake risky operations overseas but

use its enormous profits for investments in Canada. When the CRTC asked Bell to disclose its secret clauses, in the Saudi contracts, the telephone company refused, saying the publicity might cause it to lose the deal. The Canadian government has provided Bell with a \$430 million insurance guarantee against any losses in the operation.

Under the contract, Bell will provide the Saudis with 500 technicians and Philips of The Netherlands and Erickson of Sweden will provide the equipment. Bell has stated in each contract that it has no dealings with Israel and no investment, subsidiaries or franchises in that country. Such a statement is not illegal under Canadian law as it is in the United States.

The Canada-Israel Committee, which is monitoring the CRTC hearing, is urging Canada to strengthen its anti-boycott law in line with one adopted by the United States last year.

PERMANENT EXHIBIT ON JANUSZ KORCZAK

GHETTO FIGHTERS KIBBUTZ, April 20 (JTA)—A permanent exhibit on Janusz Korczak, the Polish educator and writer who was killed at Treblinka with the Jewish children who were his pupils, was opened at the Museum of Ghetto Fighters at this kibbutz north of Acre. A representative of the Polish Ministry of Education and Culture attended the opening ceremony. If was learned that a special archive to include the writings and documents relating to Korczak—his life and death—will be established at the Kibbutz Museum of the Holocaust. Prior to the opening of the exhibit a five-day seminar on Korczak was held in Israel with a Polish delegation in attendance.
