CRISIS OVER ABORTIONS LAW AVERTED; BEGIN IMPOSES CONFIDENCE VOTE By David Landou

JERUSALEM, Dec. 6 (11A) The costitation crisis over the abortions law-has been averted for the present, and coalition leaders say they are confident it will be resolved finally soon. The turnabout came yetherday afternoon, when Premier Menachem Begin decided to impose what is known as the "Transfer Law" on the abortions amendment. This means in effect turning the vote on the amendment into a vote of confidence in the government.

Begin did this after the six to all then "rebels" who opposed the amendment at its fift reading informed him that they would wate for it. If he turned it into an issue of confidence by imposing upon it the "Transfer Law." The six are Sarah Doron, Ehud Olmert, Zalman Shuval, Avraham Katz and Yizhak Berman, all of Likud; and Akiva Nof of the Democratic Movement.

A compromise reached last Sunday between the Likud's Liberal Party, "rebeis" and the Aguida Knesset faction to re-word the abortion amendment was apparently abandoned after the Aguida "Sages" flotty rejected it. The Likud MKs who had appased the original amendment an grounds of conscience indicated that they will now working it since Begin has made the issue one of configuration of conscience in the government. The compromise would have eliminated clause five of the abortion law which allows abortions for socio-economic reasons, as demanded by the Aguida, Buy it would have transferred much of the substance of clause five, to clause four. This was unacceptable to the rebbes.

Begin's Tactic Buys Time

As a result of Begin's new tactic, Aguda Israel's: "Council of Sages;" which convened in Jerusalem, gave its Knesketers another two weeks in which to ensure that the amendment goes through. According to the Sage's decision, if, the amendment is not passed by then, the party must leave the coalition immediately and automatically. The Laborite's 'skepticism' is based among other things, upon the assumption that the two ultra-nationalist Tehiya Knesset members Geula Cohen and Moshe Shamir, who supported the amendment at the first reading will oppose it now that it has become a matter of confidence. Cohen indeed told this reporter that she would-urge the Tehiya central committee to instruct her and Shamir to vote against the government.

Furthermore, Rabbi Menahem Hacohen, of the Labor Party, who abstaired in the original vote, cdn be expected to vote with his party now that the issue is only rechnically that of confidence—and in fact that of the government's surjical. But the Aguda members and coalition leaders say they have taken these factors into account and are still confident-of their majority.

The "Transfer Law" imposition will not apply, Begin has made clear, to the Democratic Movement's six members -- since the DM is not a party to the coalition agreement with Agudation matters of religion as are Likud and the Notional Religious Party. Nevertheless, coalition leaders expect at least some DM Knesseters to vote with the government. It is not yet known when precisely the vote will be taken.

BRITISH MINISTER, PLO OFFICIAL MEET IN: 'UNSCHEDULED' ENCOUNTER By Maurice Samuelson

LONDON, Dec. 6 (JTA) -- Britain's Deputy Foreign Minister Sir Ian Gilmour and Farouk Kaddoumi, He Tureign minister of the Palestine Liberation Organization, met briefly yesterday in what the Foreign Office soid was an "mecheduled" encounter at the Syrian Embossy. Jhis is the first acknowledged meeting to take place in London between such a senior, PLO efficial and a British Cabinet Minister.

The Foreign Office sold that Their talks were without substance and that the meeting did not mark any shift in Britain's Middle East policy. However, it has caused deep concern among Israeli circles here and Israel Ambassador Shlomo Argov will raise it today when the accompaniter Visiting Knesset Speak er Yitzhak Shamir on a courtesy call to Gilmour's boss, Foreign Secretary Lord Carrington. Despite the British disclaimers; Israeli suspicions are deepened by the known pro Arab sympathy of \$1 ton.

The meeting also follows persistent calls by the pro-Arab lobby here for Britain to end its "Isolation" from Western Europe by becoming more amenable to the PLO.

The Gilmour-Kaddoumi meeting took place at a reception given by Syrian Ambassador Mohammed Omrane for delegates to a conference on Jeruselem erganized by the Islamic Council for Europe and the Saudi Arabian Information Ministry. Als present at the reception was Foreign Office Minister of State Douglas Hurd who next week starts a visit to Israel; Egypt and the Sudan.

ALLEGED WAR CRIMINAL SOOBZOKOV SERVED WITH DENATURALIZATION PAPERS By Rochelle Sgidel Wolk

NEW YORK, Dec. 6 (JTA) - Alleged Nazi war criminal Ischerim Soobzokov was served yesterday with denaturalization papers by the U.S. Attorney's Office of Special Investigations: A resident of Paterson, N.J., Soobzokov, 61, is chief inspector of the Purchasing, Department of Passalcaunty, in the County. He is accused of having committed war crimes during the years 1942-45 after he went over to the Nazis when they invaded his home region of Krasnadar in the Trans-Caucausus region of Russia-

DULZIN SAYS NYC JEWISH COMMUNITY LEADERS ARE MAIN OBSTACLE TO BEGIN'S PROPOSAL ON ISSUE OF DROP-OUTS By David Landau

JERUSALEM, Dec. 6 (JTA) -- Leon Dulzin, chafman of the World Zionist Organization and Jewish Agency Executives, charged that the leaders of the New York Jewish community were the main obstacle to Premier Menachem Begin's "compromise proposal" on "drop-outs" --Sovier Yeevs who choose to go to the United States

rather than Israel after they leave the Soviet Union. Dutzinaclaimed that other American Jewish communities were prepared to go along with Begin's ideas. If New York would respond towardby, the

If New York would respond favorably, the boint Distribution Committee and HIAS, the two agencies assisting the emigrants, would also agree, Duizin told the WZO Executive this week. Begin proposed that assistance should be limited to those Soviet Jewish immigrants who have close relatives in the United States to that the rest would either have to go to Israel or fend for themselves. DuIzin said the WZO must be prepared to fight for the Begin plan.

(The JDC and HIAS has said repeatedly that they do not initiate contact with Soviet Jews in Vienna to discuss resettlement with them. The two-agencies only discuss resettlement after the Jewish Agency in Vienna, which handles transmigrant Sovie Jews, recommends to the JDC and HIAS those who insist that they do not want to emigrate to Israel. Rafael Kotlowitz, head of the Jewish Agency's immigration department, reported a slight decline in the drop-out rate. He said it is now down to 55 percent of the Jews leaving the USSR from a high of nearly 70 percent earlier this year. He attributed this to a reduction in the number of exit visas granted by the Soviet authorities and a reduction in the number of emigrants from specific Soviet to 18. Jews from the larger Russian cities have tended to 90 to the U.S. instead of Israel.

DAYAN; ISRAEL WILLING TO AID U.S. IN IRAN HOSTAGE SITUATION By Yitzhak Rabi

NEW YORK, Dec. 6 (JTA) — Former Israeli Foreign Minister Moshe Dayan, said today that if the United States, after exhausting all diplomatic means to free its hostages in Iran, decides to resort to military action, Israel will be willing to make the Haifa part and military attitudes—"but not Israeli soldiers"— available to the Americans.

But Dayan, speaking at a press conference of the Hillon-Hotel here sponsored by the United Devish Appeal, made it clear he is not advising the United States as to whether to use the military option in order to resolve the current frantan crisis:

Dayan said he thinks the U.S. "did not read correctly the situation in the Mideast."" HOLTZMAN URGES DISMISSAL OF NSC STAFFER SCORNEUL OF PROTESTS OVER RFE BROADCAST OF TRIFA INTERVIEW By JOSEPH POLOKOF

WASHINGTON, Dec. 6 (JTA) Rep. Radio Free Europe, on May 1, 1979, broadcast a 45-mjaute interview with Itila, a raturalized American citizen, who, holtzman points of out in her letter, is "alleged to have incited atmalities against Jews in Bucharest during World War It-" She pointed out further that "no mention was made during the broadcast that, the Department of Wastice had initiated praceedings against Trifa in May, 1975 to strip him of his citizenship, because of his alleged participation in war crimes and that the case was expected to go to trial in Federal Court in Detroit in the near future."

Holtzman's letter reported that "Despite strenous protests from several Board members, Mr. Henze continued in the following vein: "Let me state the White House position on this issue: Bishop Trifo, as an American citizen, represents an important ethnic group." Similar statements were made by Mr. Henze at a Radio Free Europe-Radio Liberty Board of Directors meeting. Not only does Mr. Henze evidently find nothing seriously wrong in Radio Free Europe providing a platform for an alleged Nazi war origin joi under charges by the Dapparment of Justice, but he im

plies that the propriety of the interview should be judged solely on whether Trifa's Athnic group' would approve of or be placated by the broadcast." Holtzman wrote.

Would Call Others To Account

ANTI-SEMITIC A GITATION REPORTED ON DECLINE IN ARGENTINA

BUENOS AIRES, Dec. 6-(JTA) av- "A significent decline of anti-Semific agilation can be observed." In Argentina, according to Nehemias Resnizky, outgoing president of the DAIA, the central representative body of Argentine Jewry. Resnizky made that observation recently in the course of a review of events during the past decade when he served the DAIA first as secretary general and later as its president. He said it demonstrated the understanding of the (Argentine) authorities of the anxieties expressed by the Jewish community."

Addressing Jewish community leaders, Resnizky recalled the years 1973-75 when Penonism made its comeback in Argentina. There are still isolated anti-Semitic incidents, however, Resnizky noted, the most recent being the bombing of a rabbinical seminary, several months ago. Resnizky reminded his audience that the DAIA has been fighting against the "Moral and Clvic Formations" which has a "Iclear (Catholic) confessional connotation." He said it was not possible to predict the outcome.

Meanwhile, the DAIA itself is having difficity finding a new president to succeed Resnizky. According to DAIA sources the most likely candidate is lose Kestelman who is willing to assume the post but has been uhable to put together a leadership, teams.

FIRST STUDY OF CONVERTS TO JUDAISM CALLS FOR RE-EXAMINING TRADITIONAL JEWISH RESPONSE, UAHC REPORTS

TORONTO, Dec. 6 (JTA) -- The majority of converts -- 86 percent -- taking part in a scientific study of conversions, were reported here today to feel that it is important to give their children a serious continuing Jewish education and almost all of them reported they intended to give their children such an education.

This was one of the findings of what was described as the first scientific effort to assess the impact of the conversion experience on the converts, on his or her born-Jewish spouse and on their non-Jewish and Jewish families. A report on the study, titled "New Jews: The Dynamics of Religious Conversion, "was released at the 55th General Assembly of the Union of American Hebrew Congregations (UAHC), Nearly 3000 leaders of Reform Judaism in the United States and Canada are attending the Assembly through Dec. It.

The study also found that converts had/a socio-economic profile and education level comparable to that of born lews and that only 15 percent came from homes in which religion was "very important." Many reported viewing their childhood religious backgrounds as

"oppressive.

The study found converts become more active Jews as the length of their lives as converts increased. Parents of converts in the study, while generally resenting their children's decision to convert to Judaism, at first, "ultimately become reconciled," especially if the marriage is successful.

Positive Signs Noted

Rabbi Sanford Seltzer, director of Reform Judaism's "Task Force on Outreach," said there were many "positive signs" for Jewish life in the on-going conversion process which were being overlooked. He told the delegates that these no luded -

"The generally positive attitudes toward Jews and Judaism as evidenced by the choice of Jewish mates by non-Jews; the tendency of converts to actively embrace synagogue life and become practicing, observant Jews; the infusion of new blood into a Jewish community experiencing a decreasing birthrate; the proclivity of those tities after marriage to Jews to forge ties with the Jewish community, nevertheless.

Data for the study were obtained through statistical records on 389 converts and response to questionnaires from 181 converts, plus personal interviews in 1978 and meetings with participants in a 15-week "Introduction to Judaism" course sponsored by the UAHC in Boston. The data showed that 48 percent of the Boston area converts in the sample were brought up as Catholics and 39 percent as Protestants, reflecting the heavily-Catholic make-up of the Boston area

The study found that the converts reported feelings of being on "permanent probation" as Jews, rejection by their parents; and worry about having a Yule tree in their homes. More than 80 percent of the respondents said they had no regrets about their conversion, but some reported identity confusion, in-law troubles, nonacceptance by born-Jews, isolation, guilt feelings and negative parental reactions.

Dr. Steven Huberman, who directed the

study, said that action should be taken to help can verty with such problems. He said for a convert to become meaningfully Jewish requires "the help of family and community. It is the belief of the major ity of the respondents that although conversion involves tremendous stresses and strains, becoming and being Jewish is worth the struggle.

The study made a number of recommendations. One was that conversion courses should deal with the emotional aspects of conversion. Another was that robbis should stay in contact with their converts after the conversion ceremony. The typical convert developed strong bonds of trust with his or her rabbi and sonyerts reported that inability to maintain contact with the rabbi after conversion was felt as a real loss.

Another recommendation was to encourage converts to join synagogues. Converts see synaogues as the most important link to their new Yew-ish identify, next to their Jewish spouses and famil-tes, the study noted. The study found that while 57 percent of the converts belonged to a synagogue. only 18 percent had joined any other Jewish organization. The study said educational efforts are needed to explain the status of converts to born Jews

CHURCH WARNS A GAINST VICTIMIZATION 'ARABIZED STATE DEPARTMENT!

NEW YORK, Dec. 6 (JTA) -- Sen. Frank Church (D. Idaho), chairman of the Senate Foreign Relations Committee, warned here that America must not become victim to the "Arabized State Department" and called for bold, firm action to reassure Israel that "the United States stands solidly behind Israel in its efforts to implement the Camp David accord with Egypt, which remains the only sound basis for peace in the Middle East."

Church made his remarks before more than 500" leaders of the furniture industry at a nationwide Israel Bond dinner of tribute to Nathan Ancell. chairman of the board of Ethan Allen, Inc. at the Sheraton Centre. Ancell received the Israel Prime Minister's Medal. The event produced more than \$3 million in investment capital for Israel's econ omic development.

The Senator said that he was worried about 'a new doctrine of appeasement" which calls for "a grand design" for energy sufficiency which is aimed at weakening Israel's position in the world.

"Some candidates are saying that the energy. crisis can only be solved by changing our policy in the Middle East, "Church said. "They want us to trade Israel's sovereignty for Araboil. You and I know that our fuel shortage cannot be solved that way. The Arab states and the other OPEC nations are running a business based on good engineering principles and the highest price that the market will bear -- and this has absolutely nothing to do with fsrael."

Church also assessed the struction in Iran. which he compared to Israel's experiences in the past, and declared that, like Israel, "we Americans above all else must never, never bend to blackmail." The events in Iran and in the Islamic world "have driven home a lesson to American offic ials, "he declared. "Never before was it clearer. that we have no stronger, more steady and steadfast ally than Israel. We can always depend on Israel in moments of crisis and need.

The Camp David accords represent a reversal of U.S. -policy which previously was the seeking of a "comprehensive settlement -- the all or no thing concept -- which was an illusion, one which some of our Arabist'experts' are still obsessed with, " Church asserted.
