BEGIN BANS 'ARAB CONGRESS' SCHEDULED FOR NAZARETH: ORGANIZERS PLAN TO APPEAL By David Londou

ERUSALEM, Dec. 1 (JTA) -- Premier Menachem Begin today banked a political-gathering of. Israeli Arabi that was to be held in Nazareth next Saturday. Acting on his authority as Defense Minister, Begin maintained that the purpose of, the planned meeting, Kowan as the "Arab Congress", was to identify with the Palestine Liberation Organization which is an illegal body under Israeli law.

The organizers of the Congress flatly denied the charge and said baday that they would consider "all legal means" to fight the ban. This could include an appeal to the Supreme Court and regional gatherings in all Arab centers in Israel. Begin octed under the emergency regulations dating from the British Mandate which are still applicable under Israel law.

Reactions in the political community were. mixed. Right-wingers welcomed the ban while leftists expressed fears that it would only harden Arab hostility and further damage Israel's relations with its Arab population. The "Arab Congress" was widely viewed as a tool of the Commu nist Party which was heavily represented among its organizers. Some Knessel moderates agreed. with the view in government circles that the Congress was undesirable. But they opposed a legal ban, suggesting instead that the authorities quietly persuade moderate Arabs to boycott the event. As a purely Communist gathering it would lose much of its influence, they said, whereas to ban it would only create hostility in Israel's Arab circles.

U.S. CONSIDERING ARMS FOR JORDAN By Helen Silver

WASHINGTON, Dec. I (JTA) — The U.S. is considering the delivery of additional spare parts and ammunition to Jordan as a result of the current tension along the Syrian-Jordanian border but no decisions have been made yet, the State Department said today.

State Department spokesman John Trattner mode clear that the deliveries would be in addition to "What already is in the pipeline," observing that "Jordan is a friend whose security is important to us." He noted also that "We have a long-time military supply relationship with Jordan." He mentioned that "after consultation with Congress we have controcted with Jordan for the sole of 100 M-60 A-3 tanks, delivery to start in 1982."

Tratter's remarks were in effect a reiteration of what State Department sources said fast Friday with respect to the build-up of Syrian troops on the Jardanian boarder. The State Department confirmed on Friday that Jardan, Syria and Israel were among the countries contacted on this situation.

Tratmer said, "Actions which raise tensions in that region of the world create additional tensions. SHAMIR STRESSES CAMP DAVID ACCORDS By Edwin Eytan

PARIS, Dec. 1 (JTA) — Israel's Foreign Minister Yitzhak Shamir said here today that Israel continues to rely on the Comp David agreements for a settlement of the Middle East dispute and is prepared "to make further concessions and socrifices within this framework." In an interview published in Le Monde, the Israeli diplamat, also stressed tight his country "does not occept the premises of the Venice declaration" issued last June by the nine member states of the Letropean Economic Community (EEC).

The Venice document calls for Israel to withdraw to pre-1967 borders and stipulates that the Palestine. Liberation Organization must be associated with the Middle East peace process.

Shamit arrived here yesterday on a five day private visit at the invitation of the French United Jewish Appeal. It was interupted today when he flew back to Israel to attend a Knesset session this afternoon where a controversial low severely restricting autopsies will be debated priorite its second and final readings. MINISTER TO BE CHARGED WITH TAKING BRIBES By David Landou

JERUSALEM, Dec. I (JTA) - Attorney General Yitzhak Zamir announced today that he will bring charges against Minister of Religious Affairs
Aharon Abu Hatzeiro an account of taking
bribes from three religious institutions in Braic
Brak. Zamir informed Premier Menachem Begin
and Knesset speaker Yitzhak Berman of his decision which was taken ofter weeks of careful study
of eight separate police files against the Religious Affairs Minister.

The next stage in the legal process will transpire in the Knesset's House Committee, where Zamir will ask that Abu Hatzeira be

stripped of his immunity.

House Committee chairman Mashe Meron of Likud's Liberal Party said tonight that he hoped to keep the Committee's deliberations short to avoid further protraction of the case.

Knesset Speaker Berman said his own view, based on past experience of immunity hearings involving Knesset members was that the House Committee should consider solely whether the government was in some way persecuting the suspected MK or otherwise interfering with his role as an MK or with the work of the Knesset as such. The House Committee should not, said Berman, enter into the merits of the case in question.

But that is not a universally accepted view.

National Religious Party fection chairman Yehude
Ben-Meir, said tonight that he believed the
committee must "examine the basis of the Attorney General's request for removal of immunity"

to see "it there is a prima facie case."

Ben-Meir urged the public to "learn a lesson" from the fact that Hatzeira would be charged on only one bribery, count although the press over the past months has "accused him of practically every crime under the sun."

Ben-Meir said he was not minimizing the growiny of the alleged offense. He was merely pointing out that many other issues cited during Hatzein's "high by press" had not been considered by the Attorney General to be worthy of charges.

Zamir called a press conference where he distributed the charge sheet, signed by State Attorney Gobriel Boch, and explained his decision. A sixth file, involving suspected election bribes in Ramle in 1978, was also found lacking after long consideration.

The two remaining files concerned suspicious of legations that Hatzeira had received bribes in 1978 and 1979 from three separate Briel Brak Torah institutions in return for inflating his Ministry's allocations to them.

Charged along with Hatzeira are his senior aide, Moshe Gabbai. Both men are to be arraigned for taking bribes. Shmuel Daskal of Vishnitz Yeshiva and Amram Daskal of the "Yeminite Heritage Institute," are charged with aivina the bribes.

A third institution involved is the Spirika Veshiva in B not Brak, whose director, Herman Fruchter, is apparently to be a State witness with Gottlells. According to the charge sheet, Gottlells arranged the deals and transmitted file monies to the aide, Gabbai, after having reached the various agreements in conversations with the Minister. Moreover, Gottlells reported directly to the Minister on the completion of the various deals.

JAVITS PREDICTS REAGAN WILL BETTER SERVE ISRAEL'S INTERESTS THAN CARTER

BOSTON, Dec. I (JTA) -- Sen. Jocob K. Javits (R. NY) predicted to delegates at a convention here that Israel's interest would be better served, at least in the short run, by the policies of the incoming administration of President-elect Ronald Reagan than if President Carter had been reelected.

Speaking at the final session of the 82nd anniversary national biennial convention of the Union of Orthodox Jewish Congregations of America, Javits also told the 500 delegates that "the difference between Reagan and Carter is that Reagan will put a greater emphasis on security, improving Israel's ability to defend itself, thus making Israel more useful to the United States and its allies in the area. Carter would have tried to effectuate a general peace in the area through the Camp David process," which Javits described as "now a dead end.

Javits, who was defeated for reelection last month, said that Carter would probably have tried to force Israel into new concessions to push the Comp David process further. The Senator said a wiser course would be to allow the parties concerned more time, up to the five years envisioned in the Camp David agreement, before proceeding with U.S. efforts.

Reagan's Policy Called 'More Realistic'

Javits asserted that Reagan's "likely emphasis on Israel's security is more realistic in light of Iraq-Iran and Jordan-Syria tensions," adding that Egypt also needed more time to deal with its serious internal problems.

The Senator predicted that despite the proability that progress toward peace would be in-ially slow when the Reagan administration takes over, Israel is likely to have a high priority on the Reagan administration agenda "and properly so." He also said that "a somber view is not justified" on Israel's prospects for support in Congress. He said "two-thirds of the House and Senate is still on Israel's side" and that this support was Israel's most valuable political asset. The Senator was honored by the delegates for "more than 30 years of outstanding and dedicated service."

PLO OPENS UN PALESTINE DEBATE

UNITED NATIONS, Dec. 1 (JTA) -- A debate on the Palestinian question, a regular feature on the General Assembly's agenda in recent years, opened here today but drew little attention from diplomats or the media. The first speaker at this morning's session was Farouk Kaddoumi, representative of the Palestine Liberation Organization. who speaks for it on foreign policy matters.

In a sharply worded speech, Kaddoumi attacked Israel and the United States and called for sanctions against Israel for its failure to comply with UN resolutions. He urged that efforts be made for a Middle East settlement that would result in the establishment of an independent Palestinian state.

Kaddoumi also charged that the U.S. veto of Security Council resolutions and its continued military support for Israel helped the "Zionist entity" maintain its "arrogant and aggressive"

positions. Referring to President-elect Ronald Reagan's characterization of the PLO as a terrorist organization, Kaddoumi said the next American President had forgotten the history of the organization and its accepted role on behalf of the Palestinians. He called on the Western European countries to recognize the PLÖ, contending that this would "help restrain the modness in the Israeli position!"

The Palestine debate is scheduled to last until the end of this week. Israel's Ambassador to the UN, Ye huda Blum/ will address it tomorrow. The General. Assembly is expected to adopt the recommendations of the Palestinian Rights Committee, as it has in previous years. They call for Israel's withdrawal from the occupied Arab territories, the return of the displaced Palestinians to the homes they left as a result of the 1948 And 1967 wars and for the establishment of an independent Palestinian state.

In another development here, a three-member UN inquiry group has recommended that the Security Council adopt effective measure "to prevail on Israel to cease forthwith its settlement policy in all its aspects in the occupied Arab territories, including Jerusalem. The group consists of the representatives of Portugal, Bolivia and Zambia. (By Yitzhak Rabi)

FORMER COLLEAGUE CALLS BRAILOVSKY ARREST BY SOVIETS 'TEST CASE'

JERUSALEM, Dec. ! (JJA) -- The case of Viktor Brailovsky, the renowned Soviet cyberneticist and Jewish activist and refushik arrested in Moscow on November 13, is a "test case for the entire future of Soviet Jewry, " according to Brailovsky's former collegage. Prof. Mark Azbel. Azbel is now a professor of physics at Tel Aviv University, having himself struggled long and hard before being allowed to leave the Soviet

He told newsmen here today that Brailovsky's case. was unique and therefore fateful for the whole Jewish activist and aliya movement, because he was the first scientist-refusnik whom the Soviets had arrested specifically for Jewish activities.

Currently held at the notorious Butyerki prison, Brailovsky has been told he was arrested and will be charged for "anti-Soviet slander" on the basis of his activity as editor of the publication "Jews in the USSR." This is a typewritten journal, first published in 1972. Since then, 20 issues have been published all dealing exclusively with Jewish culture, history and religion. It is strictly nonpolitical.

Other refusnik-scientists-are usually barred from emigrating on the grounds -- more often than not spurious -- that they have acquired sensitive scientific information in the course of their work. Thermajority of those arrested are charged with "parasitism" or anti-Soviet activities deriving from their involvement with the "Helsinki Group" or other human rights activities.

Azbel said the Soviets have deliberately moved against Brailovsky during the period of the Modrid Conference and the U.S. Presidential "interregnum" in order to establish a precedent. If world opinion failed to pressure the Kremlin to drop the charges Soviet Jewry would become "The Jews of Silence" again within a year, and all activism would cease, the scientist warned.

He appeared at a news conference arranged by the Israel public Council for Soviet Jewry. Also present were Knesset member Micha Harish and Israeli scientist

Arye Dvoretzky. Azbel and his colleagues on the Public Council appealed to Israeli, Jewish and other enlightened opinion to fight for Brailovsky.

I (JTA) -- Eighteen persons have been named for induction into the newly-created International Jewish Sports Hall of Fame, it was announced here today by Joseph Siegman, of Los Angeles, chairman of the executive board. The induction center will take place at the Wingate School of Physical Education in Netanya, Israel, on July 7, 1981 during the International Maccabiah Games

Siegman, who conceived of the US-Jewish Sports Hall of Fame, said that the 28 Americans enshrined in the first two years, when electors considered only American citizens, will also be inducted into the International Hall located at Wingate. It was agreed by the Selection Committee that the designees for 1981 would not include any Americans.

LUBAVITCHER REBBE'S TV ADDRESS REACHES OVER A MILLION HOMES

NEW YORK, Dec. I (JTA) -- The public address (farbrengen) by the Lubavitcher Rebbe, Rabbi Menache M. Schneerson, on the Hasidic festival known as "Yud-Tes, Kisley," was transmitted live via satellite to hundreds of cable television networks across the United

For several years the Rebbe's public addresses de livered on weekday were broadcast by oudio communications hookup weekday were broadcast by oudio communications hookup weekday were broadcast by oudio communications hookup. But now, by means of a newly equipped communica-tions system at Lubavitch World Headquarters in Brooklyn, the addresses of the Rebbe will now also be transmitted throughout the United States to homes and centers on cable television networks via satellite.

According to a spokesman for the new communications center the cable networks hooked up to the Rebbe's Yud-Tes Kisley address have several million subscribers. "The response from individuals from New York to Los Angeles, from Maine to Texas, has been overwhelming," he said. "Our estimate, based on the accumulative subscriber capacity, and on the response from individuals and feedback from Lubavitch Centers across the United States, leads us to believe that well over a million homes viewed at least part of the Rebbe's address, " the spokesman said.

Aside from the thousands assembled at the Lubavitch World Center last Thursday night, thousands also gathered at Lubavitch Centers in communities throughout the U.S. to see and hear the Rebbe for the entire fourhour public appearance, on monitors and large screens.

Introductory Discussion

The Rebbe's address was prefaced with an introductory 30-minute discussion - Participating were Rabbi Zalman Posner, of Nashville, Tenn.; Rabbi Manes Friedman, Minneapolis, Minn. and Professor Yemiyahu Branover, Beersheva, Israel. The moderator was Barry Farber.

The spokesman said that the next nationally televised address by the Rebbe will be at 9 p.m. Thursday, January 15, commemorating the Tenth of Shevat, the 31st yahrzeit of the late Lubavitcher Rebbe, Rabbi Yosef Yitzchok Schneersohn.

JEWISH NEWS PROGRAM SET FOR TV

NEW YORK, Dec. 1 (JTA) -- The first regularly scheduled national television program on Jewish news and cultural affairs will be broadcast by satellite starting Sunday, December 7, it was announced today by the program's executive producer, Joel A. Levitch. The program, entitled "Jewish Spectrum" will be prepared in New York and offered initially on a monthly basis to public television stations and cable systems nationwide. According to Levitch, the program will be switched to a weekly schedule when sufficient financing can be arranged.

The first edition of "Jewish Spectrum", to be carried on the RCA Satcom I satellite from 10:30 to 11:30 AM (EST), will be hosted by David Schoenbrun, noted author, lecturer and former CBS correspondent, and by Laurel Vlock, Connecticut television personality, who is also associate producer of the series. The broadcast will focus on the recent national elections as well as foreign policy developments in the Middle East.

Levitch emphasized that the first program would be transmitted primarily via cable to approximately 20 communities on an experimental basis. Thereafter plans are to form a "mini-network" comprising all the major Jewish communities in the U.S. and Canada.
