HAIG WARNS ISRAEL NOT TO TAKE ACTION AGAINST PLO IN SOUTH LEBANON By Hugh Orgel

TEL AVIV, Feb. 8 (JTA) — A senior israeli official sent to Washington last week to impress the U.S. with the seriousness of cease-fire violations on the Lebanese border, returned to Jerusalem with a stern warning from Secretary of State Alexander Haig that Israel take no action or initiative against the Palestine Liberation Organization in Lebanon.

This exchange of views was reported boday. The identity of the Isroeli official sent to Washington was not disclosed. But he reportedly received personal briefings from Premier Menachem Begin, Foreign Minister Yitzhak Shamir and Defense Minist ter Ariel Sharon before he left and was to emphasize to the American Administration finds the cessefire on the Lebanese border was in imminent danger of breakdown.

The envoy was dispatched after Israel expressed grave concern over the attempted infiltration of the West Bank by a band of Palestinian terrorists from Jordan a week ago. Although three of the terrorists were captured before they could infilt casualties or damage, the vehemence of Israel's reaction raised speculation that the ground-work was being laid to prepare public opinion for a new Israeli strike against the Palestinians in south Lebanon.

Top Isroeli officials insisted that the infiltration attempt, though made via Jordan, was a major violation of the cease-fire which ended fighting on the Lebanese border last July I. The army and other information sources flooded the media with a long list of alleged violations of the cease-fire by the PLO in recent months, and made it clear that Isroel would not tolerate the situation.

Concern About Arms Supplies To Palestinians

Haig was quoted as telling reporters in Washington last Friday that the recent upsurge of arms supplies to the Palestinians in south Lebanon was an "aggravation" that could strain the cease-fire. He was commenting on press reports that the Soviet Union was supplying the Palestinians with weapons. Israel has been complaining for some time of a military build-up by the PLO in south Lebanon.

No Comment On Magazine Report

Officials here refused to comment on a report in the latest issue of Time magazine that Sharon met last month with the Lebanese Christian Phalangist ledder Bashir Gemayel aboard an Israeli missile boat in the harbor of Juniori, north of Beirut. Junio is the chief port of supply for Christian armed forces in northern Lebanon. According to the report, Sharon and Gemayel discussed Phalangist support for Israeli amed action inside Lebanon, including the possible take-over of part of south Lebanon by Israeli. Forces.

The report in Time magazine also stated that an expected Israeli assault against PLO strongholds in south Lebanon "was narowly averted last week" when Begin, "in a last-minute decision," rejected a plan by Sharon and Chief of Staff Rafael Eitan to mount a "modest" attack on the PLO bases.

Senior Israeli officials have also reportedly discussed the situation in Lebanon with Brian Urquhart, the Under Secretary General of the United Nations, who is an an inspection tour of UN forces in the Middle East, He has appealed for restraint by all sides.

MUBARAK TOLD THAT GERMANY SUPPORTS MIDEAST PEACE EFFORT BASED ON LEGITIMATE RIGHTS OF PALESTINIANS By David Kantor

BONN, Feb. 8 (JTA) — President Karl Carstens of West Germany assured Egyptian President Hosni Mubarak here last night of Bonn's support for a Middle East peace effort based on the principle that the Palestinian people be allowed to exercise their legitimate rights.

The right of Palestinian self-ëtermination was also referred to in a joint statement by Mubarak and Chancellor Helmut Schmidt at a press conference today. They said: "It is our joint view that an agreed settlement of the Arab Israeli conflict for a full, just and lasting peace is conditional on mutual recognition of the right of all states in the region to live in peace and security, including Israel, and that the right of the Palestinian people to self-determination is also recognized."

Mubarak, who visited Washington last week on a six-nation tour of Western countries, was in Britain over the weekend and flew to Austria today.

Mubarak Promotes Fahd's Plan

Diplomats here said Mubarak used his visit to promote the eight-point plan proposed by Sauk Arabia's Crown Prince Fald as a fair and realistic way toward settlement of the Middle East conflict. His German hasts apparently refrained from stressing the European Economic Community's (EEC) initiative and its Venice declaration of June, 1980, which included a yote for the Palestine Liberation Organization. Bonn appears to have given up hope for a united European policy on the Middle East after France rebuked previous EEC steps and Greece complained that the EEC attitude was not sufficiently pro-Arab.

Mubarak is believed to have asked for German help to exploit old coal mines in northern Sinal which will be evacuated by Israel next April. According to Egyption officials, this and other projects in Sinai will have a political as well as

WEST BERLIN. CONSIDERING WAYS TO CHECK FLOW OF ARAB TERRORISTS INTO THAT CITY FROM EAST BERLIN. By David Kantor

BONN, Feb. 8 (JTA) — The West Berlin Senate is considering means to check the flow of Arab terrorists into the city from East Berlin. According to the police, hundreds of Arab extremists have infiltrated West Berlin after receiving training in terrorist tactics in East Germany as part of that country's program of militarry assistance to the Polestine Liberation Organization.

ABC DENIES PLANS TO PRODUCE FILM TO GIVE 'ISRAELI VIEWPOINT'

NEW YORK, Feb. 8 (JTA) — ABC News denied bady that it has plans to produce a new television film on the West Bank giving the "Israeli viewpoint." The denial was issued following reports from Israel that an ABC production crew was due there shortly.

It is a segment on the West Bank fitted "Underthe Israeli Thumb," which appeared on the ABC-TV
"20-20" program last Thursday night, was strongly
criticized for pro-Arab blas by Israeli officials and
friends here and abroad. It reportedly drew expressions of intense displeasure from Premier
Menachem Begin in Jenusalem and the Israeli Embassy in Washington. Shmuel Moyal, press attache
at the Israel Consulate in New York, called the
segment "entirely unbalanced" and a "gross distortion of history."

According to the reports from Israel today, the network proposed to produce a new film on the subject and the Prime Minister's Office offered it "every facility and aid." ABC News, in issuing its denial, noted that during the preparation of the segment for last week's "20-20" program, repeated requests were made for a responsible Israeliofficial to address the issue raised in the report.

ABC News said it stands by this broadcast and invites the questions and comments of the Israeli government or any other concerned party.

Meanwhile, I van Novick, president of the Zionist Organization of America, urged the American public today to join in protesting the "20-20" segment on the West Bank broadcast February 4. In a letter to 'Roore Arledge, 'president of ABC News, Novick urged that I'l immediately schedule another segment showing "the positive side of the Issue and the point of view of the government of Israel."

Richard O'Brien who is being replaced in April because he does not see eye to eye with the government.

In defending Young's appointment, which has sparked off a political row, Norman Tebbitt, Employment Secretary, referred to his involvement with ORT.

Young hot aroused the lostfility of the opposition Labor Party because of his rightwing political associations. He is a director of the Center for Policy Studies, set up several years ago by Sir Keith Joseph, Education Sceretary.

Young, a lawyer, has been an assistant of Sir Isaac Wolfson, head of Great Universal Stores, and chairman of a real estate company. His brother, Stuart, who is deeply involved in fund-raising for Israel, was recently appointed a governor of the British Broadcasting Corporation.

PERCY SAYS U.S. CANNOT DAMAGE ITS GLOBAL INTERESTS BY DEFENDING 'OBJECTIONABLE' ISRAELI POLICIES By David Friedman

WASHINGTON, Feb. 8 (JTA) — Sen. Charles Percy (R. III.), chairman of the Senate Foreign Relations Committee, warned Israel today that it cannot expect the United States to damage its global interests by defending "questionable or objectionable" Israeli actions or policies.

U.S. global interests and responsibilities "include the security of Israel," Percy told a National Press Club luncheon in a report on his recent 38-day visit to Israel and 13 Arab countries. He said he did not meet with any leaders of the Palestine Liberation Organization.

"Israel has seen U.S. willingness to fully support them against overwhelming opposi-tion when we believe they are right, "Percy said." "But Israel cannot expect the United States to continue isolating itself from the world community to defend questionable and or objectionable actions in policies. The Israelis must stop 'surprising' the international community and the United States with preemptive acts that are viewed by the community of nations as violations of international norms, harmful to U.S. interests and damaging to the peace process that must now proceed in the Middle East.

Decries Lack Of Communication

At the same time, Percy decried a lackar communication between Israel and the United States, noting that the Israelis "have been honest ly surprised by the harsh response of the Reagan Administration's response to some of their actions He said: "The Israelis should have been aware in advance to what extent the U.S. would react and we should have been aware of the imminence of Israeli intention to apply their law to the Golan Heights.

Percy revealed that while in Israel he got Premier Menachem Begin, Defense Minister Ariel Sharon and other leading Israelis to agree "to reduce the level of critical rhetoric," an "informal agreement" that has been "faithfully observed" by the U.S. and Israel since midnight December 29.

Perceptions Among The Arabs

As for the Arab states, Percy said the main reason for the "lukewarm response" to the Reagan Administration's efforts to achieve a strategic consensus against the Soviet Union in the Middle East is not that the moderate Arab lead ers are not necessarily concerned about the USSR but they are more concerned about the response from their people if they form too close a relation ship with the U.S.

"The single issue which created the greatest strain in our bilateral relationships and which is allowing the Soviets to make advances is a widely held perception in the Arab world that the United States government is not committed to a just and equitable settlement of the Arab-Israeli dispute, including a settlement of those grievance that are reasonable and just," Percy said. He added that Arab leaders all said they

would accept Israel behind secure and recognized borders if Israel withdrew to the pre-1967 lines. He said their perception is that Israel does not want to withdraw but wants to maintain settlements on the West Bank. He said Israeli leaders denied this and said everything is open to negotic tions.

But Percy declared that "the premise" that the U.S. has operated under since 1967 is that Israel would "essentially withdraw" from the occupied territory "in exchange for a genuine negotiated peace, secure borders and normal relations with its neighbors especially including recognition of their right to exist."

Percy charged that "many Israeli policies today continued settlement in occupied territories and the quasi-annexation of those territories -- raise questions about whether Israeli policy is raised on the same premise.

ALLEGED WAR CRIMINAL IDENTIFIED

NEW YORK, Feb. 8 (JTA) — A noted expert on Nazi war criminals said here today that the federal government "has an open and shit denaturalization-deportation case" against an alleged Nazi war criminal who has been identified by the Justice Department's Office of Special Investigations (OSI) as Vladimir Sokolov but whose real name, according to Charles Allen, Jri, is Vladimir D. Samarin.

Allen, who for some 20 years has been

Alfen, who for some 20 years has been investigating war criminals living in the United States, said that the press reported a week ago that the Justice Department had filed a complaint in the U.S. District Court in New Haven, Conn. against a former 'Yale University faculty member named Vladimir Sokolay.

But while the man, Allen told the Jewish

Telegraphic Agency, "entered the United States in 1951 under the name Sokolov, his wife's name his birth-date registry at Ortel in the USSR shows D. Samarin as his father." The Justice Department filed technically under the name he used to enter the U.S. -- Sokolov.

Background Of The Research

In research for the first American indepth article on Samarin, which appeared in the progressive monthly magazine, "Jewish Currents," in November, 1976, Allen discovered that Samarin listed his ame in the Yale University Directory as Sokolov-Samarin, and used various combinations of those two names for other public listings.

Samarin's name and alleged Nazi past were first mentioned in a February, 1976 official Soyiet Communist Youth Journal, then in the April, 1976 Moscow Yiddish monthly, "Soviets ish Heimland," Allen said. In May, 1976, the New York-based leftwing Yiddish "Morning Freiheit" carried an article on Samarin.

Freiheit" carried an article on Johnson In some press reports January 28, Samarin (Sokolov) was described as a former "Instructor" of Russian at Yale from 1959 to 1966, and quoted Yale officials that "they did not know the circumstances under which he left." These officials "must have very short memories," Allen told the JTA.

"Samon'n was, in fact, à Yale lector and senior lector in Slavic languages and literature from 1945 to 1976. He was allowed to elect early retirement in 1976 at the age of 63, when his Nazi past was exposed. He was then given what was in effect 18 months of paid leave, through 1978."

Allen said "Yale has never publicly faced up to the issue, nor fired nor dismissed him, despite media exposure in 1976. I even gave an ex-tremely well-attended lecture about Samarin at Yale that year."

According to some press reports last month the government charged Samarin (Sokolov) with being a Nazi propagandist, writer and editor from December, 1942 to August, 1944. These reports, including one in the J1A Dail y New? Bulletin January 29, referred to the Justice Department's charges that Samarin (Sokolov) "advocated the annihilation of all Jews and called for the conquest of the United States and imposition of Nazi rule throughout the world."

Allen fleshed out these charges as follows:
"Samarin was a Nazi propagandist and collaborato
as deputy editor-in-chief of the Nazi publication

"Rech" — Russian for 'word' — (not Reich, as was erroneously reported) in the city of Oriel, Russia During the Nazi occupation of that city, he wrote signed articles and editorials under his real name, Vladimir D, Samarin, calling for genocidal murder of the city, Lews.

of the alty's Jews.
"But his editorship was not his only talk. He also made frequent trips to Germany, as the guest of Joseph Goebbels' Ministry of Propaganda, and returned to Oriel to sing the praises of Hiller's over Union 'volunteer' for work' in greater Germany—actually a campaign to dragoon them into slave labor confingents. For his service to the Hinte Reich, he was owarded gold and silver medals, as well as commemorations personally inscribed by Hilter.

Continuing, Allen said: "Samarin also valuntarily joined the so-called All-Union Anti-Bolshevik League On his application for membership, he swore under outh that no one in his family was of Lewish origin, and that he believed in racial purity."

The Justice Department's complaint was a move to revoke Samarin's (Sokolov) citizenship because of his alleged Nazi post and because he withheld his Nazi background from American authorities when he entered the U.S. in 1951 and when he obtained his citizenship in 1957. "It will be interesting to see whether the government honors our commitment to the Nuremberg war trials processes, and sends Samarin back to standitial in Oriel where he committed his crimes," Allen said.

CONVICTED WAR CRIMINAL LOSES HIS APPEAL AGAINST A PRISON SENTENCE By Henriette Bogs

AMSTERDAM, Feb. 8 (JTA) — Pieter Menten, a convicted Nazi war, criminal, has lost his appeal to the European Human Rights Commission in Strasbourg to intervene against the ID-year prison sentence given him by a Rotterdam district court in July, 1980. The court also fined him 100,000 Guilders.

Menten, 82, was found guilty of complicity in the murders of 30 persons, mostly Jews, in the village of Podhorodze in eastern Galicia in June, 1941 where he served with the SS. He appealed to the Strosbourg court on grounds that his trial was conducted in contravention of the United Nations Declaration on Human Rights. The panel ruled that if was not authorized to hear his complaint and in effect rejected it.

That decision ended the appeal process for the Dutch-born Nazi collaborator who was once an at dealgr and was described as a multi-millionaire. His arrest in-197 marked the beginning of one of the longest and most domplicated war crimes prosecutions ever held in Holland. In December, 1977, Menten was sentenced to 15 years imprisonment by an Amsterdam district court. He claimed immunity, however, on grounds that Netherlands Justice Minister had promised in 1952 that Menten would not be prosecuted for his wartime activities.

Although the minister, long since deceased, could not confirm this, The Hague district court quashed the sentence. The public prosecutor appealed that decision and Menten was brought to trial a second time in Rotterdam and ponvicted again.

TEL AVIV (JFA) — In a ceremony uninatched in Its 26-year history, Bar-llan University last month wared 409 scholarships valued at \$300,000 through the Lady Edith Wolfson Memorial Scholarship Fund.
