U.S. SAYS DECISION TO REBUILD OLD JEWISH QUARTER OF HEBRON IS NOT 'HELPFUL' TO THE PEACE PROCESS By David Friedman

WASHINGTON, July II (JTA) — The Reagan Administration asserted today that the Israeli govern ment's decision to rebuild the old Jewish quarter of Hebron was not "helpful" to the peace process.

"We do not consider plans to build settlements in Hebron to be helpful in achieving an atmosphere on the West Bank conductive to the peace process," State Department deputy spokesman Alan Romberg said.

The decision on Hebron was made by the Israel
Cabinet yesterday in the wake of the murder by
Arabs last week in central Hebron of a 19-year-old
American-born yestiva student, Aharon Gross, The
State Department on Friday condemned the murder
as well as the apparent retalitatory buming of the
Hebron central market, reportedly by Jewish militants.

Romberg, in his remarks boday, repeated President Reagan's statement in his September I pace initiative in which Reagan said "further settlement activity is in no way necessary for the security of Israel and only diminishes the confidence of the Arabs that a final outcome can be freely and fairly negotiated."

Romberg did not appear to see any difference in rebuilding what had once been the Jewish quarter of Hebron until the 1929 massacres and the new settlements being created on the West Bank.

PARENTS OF SLAIN YESHIVA STUDENT SAY GOVERNMENT MEMBERS ARE MAKING POLITICAL CAPITAL OF BOY'S DEATH BY David Lendau

JERUSALEM, July II (JTA) — The parents of slain yeshive student Aharon Gross have accursed members of Fremier Menachem Begin's government of making political capital of the youth's death by stabbling in the Hebron market place lost Thursday. They also complained that no representative of the government has visited or called them to express condulences in their grief or to explain the circumstances of their son's death.

The family, Orthodox Jews, emigrated from the United States in 1974 and live in the Kiryat Itri quarter, a religious neighborhood with a large American immigrant population.

Yehudit Gross, mother of the 19-year-old victim, singled out Science Minister Yuval Neeman, leader of the ultra-nationalist Tehiya party for criticism, according to an interview published in the Jerusalem Post today, Neeman spoke at the youth's funeral, held in Jerusalem at midnight Thursday, According to Mrs. Gross he came uninvited and mad misstatements about her son.

She said the family wanted a private service but agreed to have Defense Minister Moshe Arens speak five minutes, "But ... Neeman came instead," Mrs. Grass said, "I wanted to stop him but didn't because of the place, He said Aharan had been among the anti-withdrawal protesters at Ophira (in Sinai in 1982) but that wasn't true. Neeman didn't know the facts and he didn't know Aharan," she said.

The young man's grandfather, Rabbi Yehuda Ginsberg, was also bitter. "The government has been so thoughtless," he said. "I am so astamed. We came here because we belong in Eretz Israel and we are willing to pay the price Now every political group is trying to use this tragedy for its own advantage."

Aharon's mother added, "We don't want revenge. We only want to know what really happened," The family has sent telegrams to Begin and to Interior Minister Yosef Burg demanding to know why their son, stabbed by unidentified assailants, did not receive immediate medical treatment and why, although he wore ritual fringes as is the custom of Orthodox

Jews, he was mistaken for an Arab.

The young man lay bleeding in the gutter for some time before he was taken by local Arabs to the Hebron hospital where he was pronounced dead by Arab doctors who believed him to be an Arab. According to some reports, fellow yeshive students did not minister to him after the stabbing but engaged in a running sun battle with his attackers who field in a car. Some accounts said Ahnon was mistaken for one of the fleeling Arabs who was reported, remoneausly, to have been wounded in the gun fight.

Mrs. Gross told the Post, "The American Vice Consul in Jerusalem came to our house immediately on Friday moming. He had recognized our name from a passport request ... But no one from our own government has come," she said.

Wanted To Practice His Faith

According to Mrs., Gross, her son simply wanted to particle his faith and was not ideological, But politicions, such as Neeman, have made it appear that he was a militant. She said she selected the Hebron yeshiva for her son not for ideological reasons but because she wanted a school with a close rabbi-student relationship. The Hebron yeshiva is linked to the Gush Emunim zealots, Aharon was not active in the Gush Emunim, bits mother said.

the Gust Emunin, his mother sold.

She sold that before Israel returned Sinal to Egypt in April, 1982, many of his classnates went there to demonstrate against the withdrawal. But her son stayed in school and studied, He was studious, talented and helpful to all, she sold. The young man's father, Alexander Gross, is a lawyer and amy reservist. He was wounded in Lebanon last summer. The family has five other children.

SOME KIRYAT ARBA JEWS WANT HEBRON AREA TO BECOME JEWISH SETTLEMENT By David Landau

JERUSALEM, July II (JTA) — Kiryat Arba Jews who ransacked and burned the Arab market place in thebran following the stabbing of o yeshiva student there last Thursday, are demonding that the area be turned over to them for Jewish settlement.

The militants are supported in the Cabinet by fomer Defense Minister Ariel Sharon and Science Minister Yuval Neeman, leader of the ultra-nationalist Tehiya faction. Sharon, now a Minister-Without-Portfoliop proposed at yesterday's Cabinet meeting that much of the market and the central bus station be made into a Jewish settlement because, he claimed, the land had been Jewish sproperty before the 1929 Arob riots.

Sharon also proposed building a wide road through the center of Hebron to link Kiryar Arba with the Machpela cave, the Patriarchs' tomb sacred to Moslems and Orthodox Jews, While the Cabinet endorsed plans to greatly expand the Jewish presence in Hebron, there was little support among the milisters for Sharon's far-eaching proposals, Sources here said that while the Kiryar Arba demands appear to have been blocked, Sharon and Neeman will continue to press them on the government.

The curfav (lamped on Hebran after the stabbing last Thursday was lifted this moming but tension between Arabs and Jews ran high. Violence almost erupted at the Machpela cave where Jews who claimed to have been 'threatened' by Arabs cocked their rifles. They amy moved in quickly to end the confrontation.

PRO-PLO GROUP HOLDS CONCLAVE.

DETROIT, July II (JTA) — An erganization calling itself the American Federation of Ranallah, Palestine, which claims a membership of 20,000, held a convention in Dearbour at which it pledged continued support for embattled Palestine Liberation Organization chief Yasir Arafat.

During its four-day convention at the Hyatt Regency Hotel in the Detroit suburb, the conventionleard the PLO's deputy observer at the United Nations, Dr. Haten Hussaini, claim that Arafat "is not on the ropes. He is getting stronger." The reference was to the flighting between PLO elements in Lebanon, and Arafat's leadership being threatened by Syrian-backed factions,

The convention received a message from Ara fat calling for "revolution until victory" and a letter from President Reagan calling for the organ ization to join in the Middle East peace effort,

Meanwhile, last Friday, several hundred "Islamic" demonstrators marched in downtown Detroit carrying photographs and placards bearing the picture of Iran's Ayatollah Khomeini. They chanted slagans and carried signs calling for "death to American imperialism" and "cancer of the Middle East, Israel must not exist."

The Detroit area has one of the largest concer

The Detroit area has one of the largest concentrations of Arab residents in the U.S., estimated at 125,000-200,000. The American Federation of Ramallah claims to be the largest Palestinian organization outside the Middle East, with 20,000 members in the U.S., 5,000 in the Detroit area. The group announced at its convention that it plans to build a \$1 million cultural center in the Detroit area.

SHAMIR IS CONFIDENT LEBANON WILL LIVE UP TO ITS MAY I7 AGREEMENT By Gil Sedon

JERUSALEM, July II (JTA) -- Foreign Minister Yitzhak Shamir said today that Israel is confident that Lebanon will live up to the agreement it signed with Israel last May 17, despite the long history of broken agreements in the Middle East.

Shamir spoke before the Knesset's Foreign Affairs and Security Committee in reply to Loba Mix Yossi Sarid's assertion that President Amin Ge mayel of Lebanon is moving toward annulment of the agreement, Gemayel was reported to have warned Secretary of State George Shultz a week warned Secretary of State George Shultz a week age that Lebanon might reconsider its agreement with Israel if the Israelis redeployed their troops in Lebanon without offering a timetable for complete withdrawal from that country.

Shamir said he was satisfied with the Israel-Lebanon agreement even though it has not been implemented because of Syria's refusal to pull its own forces out of Lebanon. He said there was considerable weight to words in relations between neighboring countries and noted that there are important elements in Lebanon who do not want their territory used again as a base for terrorist activity against Israel. Shamir said it was in Israel's interest that Lebanon

remains independent and that Gemayel proves to be a stronger President than his predecessors.

RUMORS NOTWITHSTANDING, BEGIN AND REAGAN WILL MEET AS SCHEDULED By David Landau

JERUSALEM, July II (JTA) — Premier Menachem Begin's visit to Washington at the end of this month is on, despite rumors to the contrary here and in Washington. Officials close to Begin said this weekend that the July 27 meeting with President Reagan at the White House will take place as scheduled.

They said Begin's visit was likely to comprise mainly political talks, and few if any public appearances before Jewish or other groups. They said the visit would last four days — the extent of the official sojoum in Washington.

Reports from Washington at the end of last week, citing American sources, said Begin wanted to defer the trip for health reasons. This was denied by sources close to the Premier here. But some of the sources do not hide Begin's lack of enthusiasm over the visit at the present time.

They indicate that the Premier feels the visit may not contribute positively to the relationship between the two countries if he is required to enter into a direct argument with Reagan over Israel's plan — to which the U.S. objects — for a partial redeployment of the Israel Defense Force in Lebanon,

Unlikely To Meet With Jewish Groups

Despite the insistence by sources close to Begin that his physical condition is not a problem in connection with the imminent trip, observers cannot help noting that unlike on previous occasions, Begin this time apparently plans to forego public appearances before Jewish groups,

groups.

If this turns out to be the case, it will dovetail into the pattern of few and brief public appearances that the Premier has established here at home over the past several months. The conventional wisdom among political and media pundits to explain this behavior is that Begin is still depressed by the death of his wife, Aliza, last November and depressed, too, by the complicated and unsatisfactory outcome of the Lebanon war.

At a long-deferred meeting of the Herut Central Committee that finally convened in Tel Aviv last Thursday night, Begin made one of the briefest addresses he has ever made to his party. This inevitably added to the speculation that he is not at the peak of his form at this time.

RACIST GROUP PLANS TO APPEAL COURT DECISION DENYING IT TAX EXEMPT STATUS By Ben Gallob

NEW YORK, July II (JTA) — The National Alliance, described by the American Jewish Congress on openly racist group, plans to appeal a federal an openly racist group, plans to appeal a federal appeals court decision denying it tax exempt status, the AJCongress sold it learned bady.

A ruling which overturned a lower court decision upholding tax exemption for the Alliance was hailed by an AJCongress official as a major step in closing a tax loophole used by such organizations as the Alliance to finance virulent anti-Semitic and recist propagnada.

Norman Redlich, co-chairman of the AJCon-gress commission on law and social action, said thi was the first known decision denying a federal tax exemption to a group whose program consists

of issuing racist propaganda.

The Alliance, a Virginia corporation with its office in Arlington, had argued that it was entitled to tax exemption because it served an "educational function." The federal district court for the District of Columbia, had ordered the Internal Revenue Service, on May 27, 1981, to grant the exemption. The IRS appealed the lower court decision.

The Seventh Circuit Court of Appeals for the District of Columbia overturned last June 28 the lower court order, ruling that the Alliance did not meet requirements set up by Congress for tax exemption because Alliance materials were not "edu cational" under "any reasonable interpretation" of

that tem.

The stated purpose of the Alliance is "arousing in white Americans of European ancestry on understanding of and a pride in their racial and cultural heritage and an awareness of the present dangers to that heritage.

Sees No Danger To First Amendment

Redlich said that decision, if upheld on any further appeals, would insure that American taxpavers would not be forced to subsidize the publication and distribution, under the guise of educa-tional activities, of crude anti-Semitic and other racist materials. Redlich, who is dean of the New York University law school, said the appeals court decision did not in any way endanger First Amendment rights. The AJCongress filed a friendof-the-court brief in support of the IRS position.
Redlich said the Alliance's principal publica-

"Attack!" published in newspaper format, that "non-whites" — principally Blacks — are in-ferior to white Americans of European ancestry, and are aggressively hamful and dangerous, and that "Jewish control" of United States government policy is harmful to the interests of white Americans of

European ancestry.

The appeals court decision declared that "ever under the most minimal requirement of a rational development of a point of view, National Alliance's materials fall short. The material may express emotions felt by a number of people, but it cannot reasonably be considered intellectual exposition."

If the Alliance implements plans to appeal, the Jewish Telegraphic Agency was told, it has two options. It may ask for a re-hearing of the case by the Court of Appeals or it may seek a Supreme Court review of the appeals court ruling. The JTA also was told AJCongress officials do not have information on when the Alliance will appeal the circuit court ruling or which option it plans to choose.

PLIGHT OF ETHIOPIAN JEWS By David Friedman

WASHINGTON, July II (JTA) -- Fact-finding missions to Ethiopia from the U.S. have a difficult time learning of the plight of the Falashas because the Ethiopian Jews are intimidated by the government, a Jew who escaped from Ethiopia last Novem ber asserted here today.

Simcha Desta, in a Capital Hill briefing for Congressional staff members, said that any meeting of Ethiopian Jews with foreign visitors are always infiltrated by government spies. In addition, he

noted that if foreign visitors complain to the Ethiopian government about the treatment of Falashas. Ethiopian Jews are arrested after the foreigners leave.

Desta said Jews in Ethiopia are persecuted be-

cause of their religion. He said that while Christians are arrested for political reasons, Jews are arrested

only for practicing their religion.

He said the Ethiopian government has closed synagog ues and Jewish schools and has forbidden the teaching of Hebrew and the practice of Jewish religious tenets. He said that when a foreign group comes to Ethiopia, the synagogues are reopened and then closed as soon as the foreigners leave.

Desta was accompanied to the briefing by David Makovsky, president of the North American Jewish Students Network, and Seth Vogelman, chairperson of the Network's National Ethiopian Jewry Task Force.

Makovsky, who was recently in Ethiopia with a aroup that included two Israelis, said they were able to have intimate conversations with the Falashas because all spoke Hebrew. But, he said, wherever he went he was accompanied by a guard carrying a Soviet-made Kalachnikov rifle.

Urges Americans To Speak Up

The briefing was scheduled today by Rep. Tom Lantos (D. Calif.) to arouse Congressional awareness of the plight of the Falashas, Lantos and Sen. Paul Tsongas (D. Mass.) have introduced concurrent resolutions in the House and Senate in support of Ethiopian Jewry.

Desta, who now lives in California with his wife and young daughter, said he was imprisoned and tortured for nine months for trying to escape with his family from Ethiopia. He said that when a Jew escapes from Ethiopia, his family and friends are tortured in

reprisal.

The young Ethiopian Jew, who plans to immigrate to Israel soon, called on Americans to speak up for the rights of Ethiopian Jews. He also urged that U.S. Consular offices in Ethiopia and neighboring countries assist Ethiopian Jews in getting to the U.S., Israel or other "safe" countries. He noted that President Reggan has authorized

3,000 refugee immigrants from Africa for 1983 and only 1,000 such visas have been used so far. He said many of these entry visas could be given to Ethiopian Jews.

PROTEST AGAINST CITY OF DAVID DIG

JERUSALEM, July II (JTA) -- About 2,000 ultra-Orthodox Jews caused a mammoth traffic jam in downtown Jerusalem this evening in a protest demon-stration against the resumption of archaeological excavations in the City of David just outside the Old City walls. Several policemen were injured in clashes with religious zealots. Twenty-five protestors were arrested.

The Education Ministry last month licensed Heb-rew University archaeologist Yigal Shilo to continue with the digging after it was suspended because of claims by Orthodox Jews that ancient Jewish cometeries were being desecrated. The area where digging is permitted, known as Area G, was delineated in an agreement reached between the Ministry and the Chief Rabbinate.

The Orthodox demonstrators said they did not seek a license from the "Zionist police" for their prayer and psalm-singing session in what is known as "Shabbes Square," a traditional Jerusalem site for Orthodox rallies. Cordons of police prevented attempts by the demonstrators to move toward the digging site. But a melee developed in which a policewoman was knocked unconscious and several regular and border policemen sustained injuries.

In his book, "A Journey for Our Times" (Harper & Row), an autobiographical account of his experiences in the Soviet capital, Salisbury reveals that the Israel Embassy was the envy of

"The quality of the Moscow diplomatic corps was not high. Expertise at the American Embassy after (George) Kennan's forced withdrawal was thin ... The extraordinary skills of the Israelis would any be last. "Salthers we

would soon be lost, "Sollibury writes,
"They had staffed their mission with Russianbom, Russian-speaking diplanats, They had unrivaled access to friends, relatives, coreligionists one reason, I thought why Stalin developed such paranola about them."

Salisbury says that when Golda Meir took up her position as Israel's Ambassador in the Soviet capital in 1948 long lines of Jews queued up outside the Metropol Hotel in order to shake hands

"That exhibition in central Mossow within sight of the Lubyanka (prison) hit Stalin's anti-Semitic nerve and may have touched off the cosmopolitanism drive. In an indirect way, it may have caused Stalin to decree the deaths of the members of the Jewish anti-Fascist Committee," Salisbury says.

Cites Other Developments

He also writes about other developments that led to attacks against Jews and Israel at the time. Salisbury says that during the halcyon days of Israeli-Soviet relations Jaffa oranges were being sold in Moscow for the equivalent of \$5 each in local stores.

Moscovites attributed the availability of the Israeli citrus to Anastas Mikoyan, the Soviet minister responsible for food imports. Rumor had it, says Sallsbury, that the Russians had paid Israel a penny-and-a-half for each orange, the resulting profit going directly into Kremlin coffers.

Salisbury recounts that on his arrival in the South capital in 1949 he found the city under a siege mentality. Westem diplomats were virtually under house arrest in their Embassy compounds. Soviet citizens, with rare exception, were petrified to be seen talking to Westemers.

Anti-Semitic Jokes Abound

While he was not aware at that time what had happened to the Jewish intelligentsia, Salisbury reports that a major staple of Moscow talk consisted of anti-Semitic jakes, In his memoir, Salisbury records some of those anti-Jewish stories and recalls that on a number of occasions he chieded his Russian friends for engaging in such anti-Semitic banter.

banter.

The response was always the same, says Salisbury. After telling the most nauseating anti-Lewish stories, they would, upon being challenged by him insist that there was no such thing as anti-Sentits in the Soviet Union because it had been officially bonned in the Soviet Constitution.

By referring to notes he made during his almost six-year stint in Moscow, Salisbury is able to reconstruct the almosphere of hysteria which was circulating in Russia in the years before Stallin's death. One of the elements in that hysteria was the report of economic crimes found in Soviet newspapers.

The perpetrators were identifiably Jewish in each

case. He cites one newspaper account of the summary execution of three Jews reported in the Soviet press in 1950. Their names gave them away. The death penalty was the talk of the town because it was unprecedented,

Salibury says that Stalin's wild accusations against Jewish physicians (later retracted under Khrushchev) were widely accepted as true by the Saviet people. During the early 1950's Salisbury had accession to visit friends in a Moscow hospital and he recalls the vicious conversations he heard in that institution about the wickedness of Jewish physicians.

'NEW DE-NAZIFICATION' PROCESS IN GERMANY SPARKS POLITICAL BATTLE By David Kantor

BONN_g July II (JTA) — Demands for the resignation of a prominent radio executive because of his Nazi past has touched off a political battle between the apposition Social Demacratic Party (SPD) and the ruling Christian Democratic Union (CDU).

Richard Becker, 57, director general of Deutschlandfunk (DLF) a major West German radio station, admits that he joined the Waffen SS as a tean—ager but his rejected calls for his resignation because of "the politing and personal property of a 17 or 18-year-old man," Becker is a member of the SPD and a longtime trade union activist.

Sut only two weeks ago, Theo Loch, a member of the CDU, was forced to resign as director of WDR television in Cologne because of his past membership in the Waffen SS.

Brandt Attacks The Process

Fomer Chancellor Willy Brandt, leader of the SPD, spake out yesterday, apparently in support of Becker. He issued a statement attacking attempts to start a "new de-Nazification" process like the one introduced by the occupying powers after World War II. He condemned "the practice of choosing at random people who are playing a role in public life" and disqualifying them for their former membership in Nazi organizations.

Brandt recalled that the SPD had decided as early as its 1946 convention that young persons "seduced by Nazi propaganda" were not responsible for Nazi crimes unless they were personally involved in them,

Becker said that at age 17 he was taken in by the slogans of the Waffen SS and volunteered. But, he added, "I have totally broken with my youthful mischief and did not make known my membership in the

Waffen SS" when he was appointed to head the DLF.
CDU Bundestag member Will! Weisskirch complained
that while his party's activists, such as Loch, are
being removed from their jobs because of past membership in Nazi organizations, SPD supporters have been
excused, He accused the SPD of opening a campaign
against CDU members who once belonged to Nazi forma-

tions,

Becker, in his remarks, did not comment on Loch's
resignation but insisted that since the end of World
War II he has proven his dedication to democracy. Loch
went through the de-Nazification process after the war
and was labeled a "fellow traveller" rather than a
Nazi. His past was known when he was employed by
WDR but it was not raised again when he was promoted,
