ANTI-JEWISH SILIR ADDS TO BITTERNESS OVER JEWISH EFFORTS TO HAVE BANK HONOR A REPARATIONS AGREEMENT By David Kantor

BONN, Jan. 7 (JTA) -- An anti-Semitic canard by a ranking member of the Christian Social Union (CSU), the Bavarian sister-party of Chancellor Helmut Kohl's ruling Christian Democratic Union (CDU), has added to the bitterness surrounding Jew ish efforts to get the Deutsche Bank to honor a repara tions agreement reached last year with a company the bank recently took over.

Hermann Fellner, who heads the Home Affairs Committee of the CSU's Bundestag faction, made clear that he thinks there is neither legal nor moral obligation for Deutsche Bank, West Germany's largest bank, to pay reparations to former Jewish slave laborers used by major German industries during World War II. (Related story, P. 3.)

#### Assailed For The Remark

He added in an interview this week that the claim on the Deutsche Bank "creates the impression that Jews are quick to show up whenever money jingles in German cashboxes.

His remarks infuriated the Jewish community

and drew the ire of other Bundestag factions.

The Free Democratic Party (FDP), a junior partner in Kohl's coalition demanded that CSU leader Franz-Josef Strauss denounce Fellner's remarks. The opposition Social Democratic Party (SPD) accused the Bavarian rightwinger of appealing to anti-Sem itic prejudice that sullied the memory of slave labor-

ers who died during the Nazi regime.

The influential Frankfurter Rundschau charged in an editorial that Fellner was creating anti-Semitic stereotypes for the younger generation of Germans. But Fellner stood by his remarks, insisting it was "per missible for a politician of my generation to speak

out on such issues."

He exhorted Jews to be "more sensitive" to the feelings of Germans and warned that if reparations were to be paid by firms perceived to be successors to those that used slave labor in World War II it would trigger a wave of such claims.

### **Background Of The Conflict**

The Deutsche Bank became involved when it recently purchased the Friedrich Flick group of companies. The Flick group's holdings included Dynamit-Nobel, whose munitions and explosives factories employed large numbers of Jewish concentration camp inmates who worked under brutal and dangerous conditions.

The Conference of Jewish Material Claims Against Germany, after prolonged negotiations, reached an agreement with Flick to provide 5-8 million Marks in a one-time payment to the surviving claimants. The commitment was not honored and Deutsche Bank has refused even to open negotiations. According to its board chairman, if there is a prob-lem "it is not ours but that of Mr. Flick," the former owner of the private holding company.

Last month Rabbi Israel Miller, president of the Claims Conference, called on Deutsche Bank to "follow the example of several leading German firms such as Krupp, I.G. Farben, Siemens, and others who some years ago reached settlements with the Claims Conference acting on behalf of surviving claimants."

RADIO LIBERTY DISMISSES AS 'NONSENSE' ALLEGATIONS THAT IT BROADCASTS ANTI-SEMITIC MATERIAL But Jewish Groups Express Concern By Kevin Freeman

NEW YORK, Jan. 7 (JTA) - Radio Liberty, one of three radio stations broadcasting programs into the Soviet Union, today dismissed as nonsense al-legations that it broadcasts anti-Semitic material, including accusations that Jews were responsible for the murder of Christ.

"This is total nonsense," said Steven Miller, a programming director with Radio Liberty and Radio Free Europe. In a telephone interview, he asserted, however, that similar charges have been raised in the past, but that Radio Liberty had been cleared of the allega-

Nonetheless, the World Jewish Congress today urged Charles Wicks, director of the United States Information Agency, to begin a probe of the allegations, contained in an article published in the Winter issue of Foreign Policy, the quarterly published by the Carnegie Endowment for International Peace.

"We are outraged to learn that Radio Liberty continues to air patently anti-Semitic material, typically authored by East European emigres," wrote Frieda Lewis, chairman of the WJC's American Section. She added that "it takes little imagination to predict the terrible consequences that such incitement to hatred may well have for Jews who remain trapped within Radio Liberty's target area.

The Anti-Defamation League of B'nai B'rith is monitoring the situation, according to Steven Freeman of the ADL legal department. He indicated that the situation that has developed at the radio appears to focus on station management and not on broadcast content or discrimination.

### Article Points To Rightwing Soviet Emigres

The article in Foreign Policy, "Anti-Semitism and the Airwaves," is authored by Lars-Erik Nelson, the Washington bureau chief of the New York Daily News and a former Reuters correspondent in Moscow. Radio Liberty, which broadcasts 24 hours a day, is a semiautonomous U.S. agency administered by the USIA.

The radio employs numerous Soviet emigres and, according to Nelson, "under the Reagan Administration, rightwing emigres have set the tone for many important broadcasts." He said many employes are concerned with "fighting obscure ideological battles, promoting antidemocratic views, or vindicating themselves in the eyes of their former compatriots (rather) than in serving U.S. interests.

He added: "The arcane ideological warfare and, on occasion, religious bigotry found on Radio Liberty undermine the very idea that an American-managed semiindependent station can serve both a Soviet audience

American foreign policy interests." Nelson said there are three groups of Soviet emigres at Radio Liberty: those or their families who left at the time of the Bolshevik revolution, those who emigrated at the end of World War II, and others who were permitted to leave the Soviet Union in the 1970's. The latter group includes numerous Jews.

"Russians and Ukrainians who left immediately after WW II have protested, sometimes in crude, hand distributed cartoons, that 'non-Russians' newly arrived Jews -- have too big a role in determining the station's content, "Nelson wrote. The emigres at the station also, according to Nelson, accuse the Soviet Jewish emigrants as being "down

right pro-Soviet."

## A Focus Of The Controversy

One focus of controversy cited by Nelson involv ed a broadcast dealing with publication of the revised edition of Aleksandr Solzhenitsyn's "August 1914" which was described in a General Accounting Office report as "anti-Semitic and the most offensive program aired by the Russian service in 10 years.

Though the book has not been published in English, it has already generated considerable controve sy over whether Solzhenitsyn was anti-Semitic. Elie Wiesel rejects the charges. "He is too intelligent, too honest, too courageous, too great a writer. For Solzhenitsyn to be an anti-Semite would be wholly

out of character," he said.

The controversy generated over the broadcast of the "August 1914" the "August 1914" program resulted in the firing of a Jewish editor, Vadim Belotserkovsky, for protesting to James Buckley, then head of Radio Liberty, over the broadcast, which he said was in line with

Soviet anti-Semitic propaganda.

Nelson noted other broadcasts, including an Easter message by Archbishop Anthony of Geneva in which he accused the Jews "even after 2,000 years" of trying to steal the body of Christ, Buck-ley, attempting to defend the broadcast, denied that the word "iudei" the prelate used meant "Jews! But Nelson, in his article, said that it means "one who practices Judaism."

SPECIAL TO THE JTA GUILTY VERDICT IN TRIAL OF 10 MEMBERS OF NEO-NAZI ORGANIZATION MAY HAVE DEALT IT A DEATH BLOW By Ellen Marks

SEATTLE, Jan. 7 (JTA) -- The trial which concluded last month with the jury finding 10 members of The Order -- a neo-Nazi white supemacist and violent anti-Semitic group based in the Northwest guilty of racketeering has broken the organization, a prosecutor said here.

"I hope (the verdict) has a dampening effect on anybody, right and left, who considers committing crimes like this for political reasons," added Assistant U.S. Attorney Gene Wilson, one of a team of six prosecutors in the three-and-a-half-month

The defendants were tried under the 1970 Racketeer Influenced and Corrupt Organizations Act (RICO), which requires the jury to find a defend-ant guilty of committing two crimes to advance the goals of a criminal organization in order to be found guilty of the charge of racketeering.

Each defendant from The Order was charged with carrying out two or more crimes out of an overall

list of 67 -- which included two murders, three armored-car robberies, and counterfeiting as part of The Order's plot to overthrow the government,

kill Jews, and deport non-whites.

The jury of eight women and four men found each of the defendants guilty of racketeering after deliberating for nearly 55 hours. Each of the group of nine men and one woman faces a maximum 40year prison term and a \$50,000 fine. Several members of The Order were also found guilty of additional charges, such as robbery and weapons violations. Attorneys for three of the defendants said they would appeal the verdict.

Sentencing is scheduled for February 6 and 7. "Stiff sentences are appropriate, but that's totally up to the judge, " said Wilson after the verdict was handed down. The jurist is U.S. District Judge Walter McGovern,

who presided over the trial.

#### Group Will Try To Continue Its Mission

At the same time, several defendants and other rightwingers asserted that the movement against Jews and Blacks will continue despite the outcome of the trial. Gary Lee Yarbrough, convicted of racketeering and robbery, said within hours of the verdict that the organization will continue its mission of spreading the propaganda of the Christian Identity movement, which preaches that Jews are descendants of the devil.

"There are thousands and thousands of people out there who believe as I believe," the 20-year-old Sand-point, Idaho, man told a local newspaper. "They are afraid because when you speak out on these beliefs the government comes down on you. But for every one that has left because their faith wasn't strong enough, three

more came.

Thomas Metzger, leader of the the Californiabased White American Resistance, denounced the verdict. In a printed statement released at the courthouse in the waning days of the trial, he likened his convicted colleagues to martyrs for their cause.

Despite the openly racist and anti-Semitic beliefs of The Order which prosecution witnesses described, jurors ignored the defendants' beliefs and convicted them solely on the evidence, said jury foreman Mary

Jurors heard evidence from 370 witnesses and examined more than 1,500 pieces of evidence in the course of the trial. Former members of The Order testified that the group planned to overthrow the government, and assassinate prominent Jews and other "white traitors" who stood in the way of their scheme to establish an Aryan nation.

#### Berg Murder Was On List Of Crimes

... those in power who went along with the destruction of the white race." Ball said that the jurars found defendant Jean Craig guilty of surveiling Berg before he was murdered. This charge and that of dealing in stolen properly were the only crimes on Craig's list.

Colorado authorities who attended the trial said they are considering filing murder charges against Pierce. FBI agents testified at the trial that they linked Pierce to the machine-gun murder of Berg by matching bullets found at the murder scene with spent cartridges found at a home Pierce rented in Troy. Montana.

#### Only One Leader Remains At Large

Wilson said at the end of the trial that only one leader of The Order remains at large. He is Richard Scutari, who is on the FBI's Most Wanted List, described at the trial as head of security and a dangerous man who discussed killing members believ

ed to be leaking information.

Fears that Scutari might launch an escape effort for his colleagues prompted the U.S. Marshall's office to spend more than \$500,000 to station more than 30 marshalls in the courtroom and throughout the downtown federal courthouse where the trial took place. Convoys of police cars escorted the prisoners' vans daily to the trial from a jail in nearby Tacoma, Washington.

### WIESENTHAL CENTER SAYS GERMAN BANK BENEFITTED FROM SLAVE LABOR IN WW II

LOS ANGELES, Jan. 7 (JTA) — The Simon Wiesenthal Center accused West Germany's largest bank today of having benefitted from slave labor used by leading German industries during World War II, and now refuses to pay reparations to surviving Jewish claimants.

According to the Wiesenthal Center, the Deutsche Bank, whose chairman, Wilhelm Christian has stated flatly it will not help compensate Naziera slave laborers, played a prominent role in advancing the economic policies and goals of the Third Reich. The bank recently acquired the Flick group of companies which include Dynamit-Nobel, a major user of Jewish concentration camp inmates

during World War II.

In a related development, Rabbis Marvin
Hier and Abraham Cooper, dean and associate
dean, respectively, of the Wiesenthal Center, sent
a cable to Franz-Josef Strauss, leader of the
Bavarian Christian Social Union (CSU), a partner
in the West German coalition government, demanding the "unequivocal censure of Hermann Fellner
by you and the leadership of all political parties in
Germany."

Féliner, a spokesman on home affairs for the CSU's Bundestag faction, created a furor, this week When he remarked that the claims on Deutsche Bank "create the impression that Jews are quick to show up when money lingles in German cash—

boxes.

The Wiesenthal Center officials told Strauss that Fellner's comments were "typical of the language heard in the streets of Germany in the '30s and '40s and more in keeping with the tactics perfected by the Nazi propaganda minister (Joseph) Goebbels and ... more appropriate for an official of the Nazi Party in 1936 than of a democratically elected one in 1986."

Hier and Cooper urged Strauss to use his influence to get the Flick companies and the Deutsche Bank to respond to requests made by former slave laborers. They said the Wiesenthal Center joined the Central Council of Jews in West Germany and other Jewish organizations in urging the payment of compensation to surviving wartime slave laborers by Flick and Deutsche Bank.

The Center pointed out that the Flick corporation collaborated with Hitler and acquired Jewish companies confiscated by the Nazis in their "aryanization" program. It employed tens of thousands of Jews and other concentration camp inmates as slave laborers

during the war.

Flick's new parent company, Deutsche Bank, has been characterized by experts as the World War II economic equivalent of the Wehrmacht. In 1941 it was the principal executor of a \$250 million loan that helped build the 1, G. Farben rubber complex near the Auschwitz death camp and itself benefitted from the use of slave labor, the Wissenthal Center charaed.

### JDL CONDEMNS BOMBING ATTEMPT

BOSTON, Jan. 7 (JTA) — The head of the Boston chapter of the Jewish Defense League condemned the placement of a small pipe bomb-type device that was found in a trash borrel at Boston Garden here last night just prior to the beginning of an exhibition game between the Boston Bruins and a touring Soviet team, the Moscow Dynamo. The Moscow team beat the Bruins 6-4.

Last month, the JDL official, Kenneth Sidman, distributed a letter to several metropolitan area newspapers asking that the exhibition game be cancelled. Sidman warned in the letter of the "potential for massive violence inside and outside (Boston) Garden."

About 75 persons, including members of the Jewish Defense League, the local Jewish Community Relations Council Soviet Jewry Committee, and representatives from other Jewish organizations picketed outside the Garden last night protesting the exhibition match because of the Soviet Union's harsh treatment of its Jewish population,

#### RECORD \$505 MILLION IN ISRAEL BOND SALES IN 1985

NEW YORK, Jan. 7 (JTA) — A total of \$505,030,000 in cash proceeds were mobilized in 1985 for Israel's economic development by the State of Israel Bond Organization from sales of its various Israel securities, it has been announced by David Hermelin, national campaign chairman. The increase of more than \$91 million over the Bond Organization's results for the previous year, he said, represents the best Israel Bond campaign achievement in the 35-year history of Israel Bonds with the exception of the Yom Kippur War year of 1973.

In his statement, Hermelin declared that the outstanding response was an outcome of the "favorable atmosphere created by Israel's austerity program which reduced inflation this past year and which restored the confidence of individual and institutional purchasers of our securities in Israel's economic future."

He continued: "These record results reflect the continuing unity of Jewish communities abroad with the people of Israel who have willingly accepted budget cuts and are making many sacrifices in order to help the government of Israel stabilize the economy and achieve a speedy economic recovery."

## MAYOR BRADLEY OF L.A. SAYS THAT FARRAKHAN'S MESSAGE OF HATE HAS REVIVED BLACK-JEWISH DIALOGUE

PALM SPRINGS, Calif., Jan. 7 (JTA) -- Conservative and Reform rabbis were told by Mayor Tom Bradley of Los Angeles that the message of hate and bigotry spread across the nation by the Rev. Louis Farrakhan has revived the Black-Jewish dialogue, reporting that in his city a two-day meeting was scheduled between 20 Black and Jewish clergy men and that some individual rabbis and ministers had again started regular discussions.

Bradley addressed a joint session of the Rabbinical Assembly Western States Region and the Pacific Association of Reform Rabbis last night at Temple Isaiah. Both groups are meeting at separate conven

tions here.

"We must never permit a message of hate to split us apart, we have so much in common historically," Bradley said. He stated that rabbis have always been in the forefront of the civil rights struggle, saying, "This must continue and go further.

### Refuses To Link Jackson To Farrakhan

Bradley refused to link the Rev. Jesse Jackson to the "vile tongue" of Farrakhan, saying that Jackson had apologized to the Jewish community at the Democratic National Convention for his remarks. "I am against any individual or group that supports and believes in bigotry, anti-Semitism or racial hatred no matter who says it," he added.

Asked how the renewed Black-Jewish dialogue should handle the thorny question of affirmative action, Bradley replied, "I am aware of the strong reaction quota systems represent to members of the Jewish community. In Los Angeles, we sat together and developed a consensus to right historical inequities in achieving jobs without imposing hard, fast figures. We succeeded in developing goals and timetables acceptable to all.

The national presidents of the Conservative and Reform rabbis, here to address their respective conventions, strongly supported national and local Black-Jewish exchanges and common efforts.

## First Things First

Rabbi Alexander Shapiro, president of the Rabbin ical Assembly, said he felt that the renewed dialogue must first "overcome the existing hurt and suspicion within the Jewish community resulting from the bigotry of a Farrakban, the slur of a Jackson, and the anti-Israel and pro-PLO posture of some members of the Black community

"As spiritual leaders we must lead the way in helping to heal the wounds and returning Blacks and Jews to addressing the major issues, to a larger social agenda that demands our attention," Shap-

iro added.

Rabbi Jack Stern, Jr., president of the Central Conference of American Rabbis (CCAR), said he believes that Jews and Blacks have a mutual obligation to creating better understanding within both groups and thus eliminating any existing vestiges of anti-Black bias and anti-Semitism that may exist. "These prejudices can be overcome with dialogue understanding and face-to-face contact," he said. NO TRAVEL BAN TO ISRAEL

WASHINGTON, Jan. 7 (JTA) -- The State Department said today that it was not warning Am-

ericans not to travel to Israel. "No travel advisory for Israel has been issued as a result of the recent incidents and no such travel advisory is being contemplated," Department spokesman Bernard Kalb said.

FBI director William Webster recently urged Amer icans to be careful about travelling in the Middle East because of a recent rash of terrorist incidents. Kalb said that Webster was probably urging that everybody keep in mind the possibilities of danger in the area.

### RAS BURKA KILLER FOUND DEAD

JERUSALEM, Jan. 7 (JTA) -- Reports from Cairo today said the Egyptian soldier recently sentenced to life imprisonment for murdering seven Israeli tourists at Ras Burka in eastern Sinai last October 5 . was found dead by hanging this morning in his room at the military hospital in Abbassiya, near Cairo.

The reports said a military investigation has begun into what appeared to be the suicide of 25 year-old Suleiman Khater. The former law student, doing his required military service, machinegunned a group of Israelis on the Sinai beach. The seven dead included

four children.

He was sentenced by a military court on December 28 but was sent to the hospital for treatment of what was described as a blood ailment. He had 60 days to file an appeal for a reduced sentence. Family members who visited him at the hospital Sunday were quoted as saying he was in good spirits and not suicidal.

## AHRNE THORNE DEAD AT 81

NEW YORK, Jan. 7 (JTA) -- Ahrne Thorne, a Yiddish writer and editor long associated with the Jewish anarchist movement, died here December 13 just 13 days short of his 81st birthday.
Thorne's 40-year involvement with the Freie

Arbeiter Stimme (Free Voice of Labor), the Jewish anarchist journal, began with his contribution of articles in the 1930's, continued with his assumption of the position of assistant editor in 1952 and editor in 1975, and ended when the paper closed in 1977 after 87 years of publication.

Born to a Hasidic family in Lodz, Poland, Thorne became involved with anarchism in Paris and then emigrated to Toronto, where he became a comrade of anarchist Emma Goldman.

After moving to New York in 1940, he worked as a printer for Yiddish publications before assuming editorial positions at the Freie Arbeiter Stimme. He also wrote for the Jewish Daily Forward and several Yiddish and English-language periodicals here and abroad, including Dos Freie Vort, an anarchist paper in Buenos Aires, and Problemen, its counterpart in Tel Aviv.

JERUSALEM (JTA) -- An annual award of two grants for Jewish and Arab educators has been established by the Jewish-Arab Council for Peace Education. The Jewish-Arab Council for Peace Education, which comprises 1,500 Jewish and Arab educators, trains teachers and youth movement leaders. The award was announced last month at the annual meeting of the Trustees of the International Center for Peace in the Middle East. Chairman of the Board of Trustees is former Justice Minister Haim Zadok.
